Stirpe Nostra

CATHEDRAL

Delving into word origins can be quite fascinating, but combining those origins with historical fact can really open up new worlds of understanding. In the last two issues, we examined the word "basilica," learned of its Greek origin, and followed it through the development of the Roman Catholic basilica as we know it today.

Our word for today is "cathedral," and its loose definition is "a large imposing church." More definitive would be, "the main church of a diocese and the seat of the bishop." Delving into the word "bishop" we come up with its Greek root "episkopos," meaning overseer, and we also find that in some historical sketches the overseers were not only called bishops, but presbyters as well. It follows then, that from the word bishop we went to overseer, episkopos (or Episcopal), and presbyter (or Presbyterian). Now, going full circle, we find that the seat of the bishop is properly called "cathedra."

Any Latin-English dictionary tells us that cathedra is a chair. cushioned seat, litter, sedan, or professional chair. History tells us that the word cathedra of seat was in common use during pre-Christian times. The back of the chair usually had a deep recession which curved around and sloped downward at the sides, forming a kind of arm support.

The ancients also used a "cathedra longa" which was a luxurious easy chair, and a "cathedra supine" which looked like our modern steamer or deck chair. These last two cathedras were mostly used by women or boys, and it was considered to be quite effeminate for men to stretch out on them. There are records of some cathedra being used at the dining tables, but the "triclinia" (dining couches) seemed to be preferred, as their use was considered to be a mark of greater distinction.

The seats of the cathedra were not padded, but comfortable cushions and back pads were often used. Another style of cathedra was what we know as a sedan chair (enclosed on all sides and provided with doors). This kind of conveyance was equipped with long poles for the porters.

As you passed through the towns and cities of the Commonwealth this December, I'm sure you noticed how many, in this secular land, found some place to display a crèche, a public display acknowledging the majority Christian faith of our people. Usually, nearby, stood the menorah, a civic statement of the importance of Jews and of the Jewish faith in our common life. This is as it should be.

It was not always so. In Puritan Boston, Christmas was not generally celebrated at all until the middle of the 19th century. In the mid-17th century, when Puritans held political power, the celebration of Christmas was banned. The Puritans, you see, did not subscribe to our secular doctrine of separation of church and state. They did not consider Christmas permissible in their sect and had no qualms about using the power of the state to deny the joys of Christmas to anyone else, be it Anglican, Catholic, Lutheran or even the non-believers who simply enjoyed a bit of merriment during the shortest days of the year. Imagine what Puritan preacher Cotton Mather would have said from his pulpit in North Square if he knew that a menorah would be part of public displays 200 years later! He would have probably condemned as witches any Jews he could find in the Bay Colony. A state-run church, especially one organized around very narrow beliefs, is not likely to deal gently with other faiths or persons of no faith.

Now we have freedom! Under our 1787 Federal Constitution, the United States may not establish a state church. The Fourteenth Amendment, added in 1868, extended that prohibition to the States. Recognition of the universal right of freedom to practice religion is part of the fundamental charter of our nation. Sadly, some today are attempting to change that fundamental understanding of the place of religion in our secular republic. From some liberal politicians we are increasingly hearing the phrase "freedom of worship" in place of the traditional American doctrine of "freedom of religion." "Freedom of worship" merely guarantees the right to gather in church, synagogue, or other place of worship for the liturgies or services of our denominations. Freedom to practice one's religion goes beyond that, and recognizes the civic aspects of faith. That includes the public display of nativity scenes and menorah (yes, that is the correct plural of menorah; my two years of Hebrew in college finally comes in handy). Those public displays of faith are important reminders that not only do we have no state religion but that the state itself is not our religion. It is






Arthur J. "Artie" Puopolo

(We will never forget his disco dancing with Thelma Hawkins, Annette Luongo, and Marie D'Eramo!) He was honored by the First Corps of Cadets for his service in the U.S. Army in Korea.

Ringing in the New Year

Christmas does not end once the page marked "December 25th" flies off the calendar. True, radio stations stop playing carols like "Have Yourself a Merry Little Christmas" and "Sleigh Ride" on permanent rotation. Yes, the presents under the tree have been unwrapped, revealing the delights hidden inside. However, the celebrations of Christmas continue for a while after the holiday proper has come to a close. According to old tradition and that famous song about five golden rings, there are actually twelve days of Christmas. These days begin on the 25th and do not end until January 6th, which is the feast of the Epiphany. In Italy, each of the Twelve Days is imbued with a special significance. December 26th, for example, is St. Stephen's Day, la Festa di San Stefano in Italian. During this day, Italians visit family or go skiing in mountain resorts. Indeed, the Twelve Days of Christmas all contain a magical and mystical quality, a unique sense of being removed from the daily bustle and grind of the rest of the year. I spend the Twelve Days of Christmas in a jolly haze, taking advantage of my vacation from school. I catch up on grading, eat Christmas leftovers, shop in blissfully uncrowded stores, and see family members who are visiting from overseas. However, I also spend these days preparing for one of my favorite holidays and what I believe to be the most mysterious date of the Twelve Days of Christmas: New Year's Eve. Filled with folklore and tradition, the twinned holidays of New Year's Eve and New Year's Day ring in a fresh new beginning with luck and

good fortune.

New Year's Eve feels different than all the other days of year, carrying with it a palpable aura of anticipation and hope. I see people going about their daily business — walking a dog, shopping at a supermarket, driving home for work yet overlapping these scenes of everyday life is the electric buzz of nostalgia and optimism, the profound knowledge that the old year is giving way to a new and exciting start. I believe that even the twilight sky looks special on New Year's Eve. glowing with a gem-toned dark blue shade indicative of the slowly lengthening days. The marked uniqueness of New Year's Eve is what has led a number of luck-bringing folk traditions to surround this holiday. Since New Year's Eve is laden with so much insecurity - will the new year be worse or better than the last? — a smattering of superstitions seek to increase people's good fortune in the next twelve months. The most famous New Year's Eve superstition involves creating a lot of noise at the stroke of midnight, reflected in the noisemakers and party horns of today. In ancient times, people believed that supernatural beings wandered the Earth during times of transition, and that loud noises were especially adept at chasing evil spirits away. Certain foods also bestow good fortune in the upcoming year. In Italy, the main lucky New Year's food are lentils, which are thought to resemble coins, and as such bring prosperity. They are usually eaten with a spicy pork sausage known as cotechino. My grandmother fondly remembers a quirky luck ritual enacted in

Naples on la Notte di San Silvestro ("St. Sylvester's Night" - this is the Italian term for New Year's Eve, since December 31st is also the feast day of Saint Sylvester). As a boarding school student in this city during the 1940s, my grandmother had to exercise great caution walking down the street on New Year's Eve, for people threw old or unused or broken items from their windows, all in the name of making a fresh start in the New Year!

While I do not throw things out my window, I do celebrate New Year's Eve in a traditional and folksy manner with my family. We gather at my aunt's house and enjoy a special meal that ends with my chocolateand-vanilla marbled ring cake for dessert. Ring cakes are another lucky food for New Year's Eve, since their shape symbolizes the cycle of the year. I love to listen to my grandmother's stories of ancient New Year's traditions in the small Italian town of her youth, such as the practice of sweeping out the door with a broom in order to chase the old year away. My family plays Bingo together, which is known as tombola in Italian. Games of chance are popular parts of New Year's celebrations around the world, for they symbolize the unexpected thrill of good luck. We watch the televised New Year's festivities in New York, and when the famed Times Square ball finally drops all the way down at midnight, we hug and kiss and wish each other a happy New Year. This is my favorite part, hands down, of New Year's Eve, since the love of family and friends is what I most want to be surrounded by every year. New Year's Day is more relaxing. Known as Capodanno, or "head of the year," in Italian, this is traditionally a day spent recuperating from the festivities of the night before. Superstition decrees that the way you start the year is the way you will end it, so I like to spend New Year's Day doing a little bit of the things that I love, such as writing, reading, baking and watching a movie. Last year, I woke up late on New Year's Day and walked to the gym on the other side of my townhouse complex. As I walked down the quiet street, I noticed that the sun seemed brighter and that the snow twinkled like it was made of diamonds. Even the bird songs sounded happier! It was such a wonderful feeling,

Simple *TIMES* . . .

With the New Year set to begin next Friday, I want to share a story about friends of my parents that reflects these difficult days of conflict abroad and how ensuing events are pulling America towards monetary, military, and human aid to a new generation of immigrants.

Horst was a young man attending the University of Munich in Germany when the call to duty arrived at his city dwelling. That one telephone call he feared more than any other changed his plans and his life as he left to serve in the German Luftwaffe in Nazi-occupied Europe in 1938.

At a spirited conversation in my childhood home during dinner on a warm Sunday in August of 1982, I needed to understand why he enlisted to go to a war he disdained. So I

asked 'Why did you go?' Horst leaned his large upper body forward, his thick German baritone accent dropping to an eerie whisper from another era: "Because Hitler needed soldiers, not lawyers."

Nearly 400,000 German soldiers staved in Prisoner of War (POW) camps in several communities scattered across the rural reaches of America's heartland, South, Southwest, and Upstate New York. My understanding is that Horst stayed at a POW camp in Oswego, near the Pennsylvania border. Because of labor shortages created by the war, America desperately required laborers at farms, plants, and factories. Over 500 POW camps were built.

The POWs returned to Germany after the end of WWII, but many feared going back

because they faced death by unforgiving nationalist citizens. Horst returned to Germany to marry his wonderful wife Waltraud ("Wally" as she was affectionately called) in 1948.

They raised four children: Dieter, Hans, Barbara and Gisela. Both sons were born in Germany; their daughters were born in America after Horst and Wally settled into their new life. Dieter, the eldest child, answered his call to action in the Vietnam War in 1968. The Marine Corps Corporal died two years after the Fall of Saigon, in 1977, as a result of wounds suffered in action.

Horst's iron-clad rules kept his children from leaving the family property. He feared neighbors would learn his military past as a pilot in the Nazi Luftwaffe (air force). Wally was a secretary in a local hospital's billing office in my hometown. She had been a teacher in her Germany hometown prior to and during the war. For more than 30 years, Horst worked as a mechanic at a Ford Motor plant.

At that family dinner in 1982, I boasted that my dad flew 47 sorties over Germany. Horst paused from finishing his meal. "Your father flew forty-seven sorties. I flew four-hundred seventy," he shouted.

Horst's smile widened while







SFINGI "sfeen-gee" Fried Dough Treats

3 yeast packets (1/4 oz. each) 2-1/2 cups lukewarm water (105 to 115°F) 2/3 cup vegetable oil 3-1/2 cups flour

2 tablespoons sugar 1 teaspoon salt A sprinkle of cinnamon (optional)

FOR FRYING:

1 quart vegetable oil - 1 four-quart saucepan or deep fryer

In a ten-inch bowl, mix yeast with lukewarm water. Stir to dissolve yeast. Add oil. Gradually add flour, cinnamon (optional), and salt, blending all ingredients to form a SOFT dough. Cover and let rise to double its size.

Punch down and let rise again. Repeat two more times.

FRYING: Heat oil in small deep fryer or saucepan until hot. With teaspoon, drop portions of mixture into hot oil. They will fall to bottom and rise slowly. Remove with slotted spoon when golden brown all over. Place in large bowl. Sprinkle with granulated sugar.

NOTE: I remember waiting to see Mama mix her dough at Christmas time. Zio Nino and Zia Marianna's (Papa's uncle and aunt) top-floor apartment became a gathering place for relatives and friends on many holidays. What I remember most was seeing Zia Marianna, Mama and other women help to fry the Sfingi. The odor of frying dough was evident in the apartment and throughout the corridors of 39 Charter Street. My cousins and I served the hot, fried, sugared dough to guests arriving for supper.

The youngsters who had not fallen asleep after supper were welcomed to joined our parents in the games of Lotto (Bingo) with the other guests. A display of fruit, nuts, Cannalicchi, Cassattedi, Sfingi, or Strufoli remained available for all to enjoy until we departed for home.

A Nostalgic Remembrance



Christmas this year is a bit different than in years past. Since my kids were grade school age, my cousin Ralph Pepe and I had combined our families on holidays to resemble and honor the extended family we came from. On my end, it was the Christoforo and Contini side, and on his side, it was the Cerluolo and Pepe branches. His maternal grandfather and my Nanna were brother and sister. Plus, Zi'Antonio, his grandfather, and Babbononno were best friends.

This year things changed a bit. I noticed at last year's holiday get-togethers, that there were more people who were related to Ralph's children: parents of daughters-in-law, their siblings and their sibling's children. It was time to branch off. Son John and our daughter-in-law Beth now have a home of their own, and the decision was made that we would spend Christmas at their house. After this decision, we had to back it up a bit and consider Christmas Eve. The 24th of December is just as important to us as Christmas Day itself, and Loretta and I decided to host the evening in a traditional Italian celebration with a dinner party that centered around seven fish courses.

Son Michael couldn't make it home for the 24th, but arrived early Christmas morning. John and Beth came to our house as did Loretta's brother, Mike, and my sister-in-law, Lin. The rest of the guests were friends (none with Italian last names) who wanted to celebrate Italian style. The hit of the evening was my wife's fettuccine Alfredo with jumbo shrimp. Once everyone left, and Loretta was in bed, I watched midnight Mass from the Vatican and fell asleep on the couch in the den.

The next morning, after opening up presents and wishing each other Buon Natale, Loretta and I got things ready to bring to John and Beth's. We were joined by my brother-in-law, my sister-in-law, Beth's parents and a couple of John's friends who normally spend holidays with them. Oh yeah, we picked up son Michael en route. He left New York early in the morning.

A couple of generations ago, things were a bit different. There were three generations of us at the dinner table on the holidays, and we were all Italian. At the start of Christmas Eve, the family would come together. Uncles Paul and Nick, as well as my father, would have musician friends who were Jewish cover them on their respective jobs. They would reciprocate when Jewish holidays rolled around and their friends wanted to experience their traditions. As a result, the entire family sat around the table for Christmas Eve.

set up with antipasti ingredients. Sliced bread in a basket was the first thing to be picked up and placed on a saucersized plate. Next would be the cheeses, marinated mushrooms, artichoke hearts, olives, peppers and possibly fried smelts (no meat, remember?). An assortment of Italian homemade wines, each in different shaped bottles, were also on the table and would accompany what might be classified these days as finger food.

When all of the fish courses were ready, the family would sit at Nanna's table. Before dinner started, Babbononno always had a few words to say, none of them religious, but all of them sacred. And so it would be until midnight, when everyone would wish the rest of the family a Merry Christmas in both English and Italian.

The next day started early, especially when my cousins and I were young. Santa would have stopped by the night before and left presents for us under the tree. I didn't know how he got into our house. We lived on the third floor of an East Boston 3-decker, and there was no fire place. As I said, I didn't know how he got in, but I didn't question anything because the toys I wanted were always there and the cookies and glass of wine I left for him were always gone.

We would head to the Sacred Heart Church in East Boston for the family Christmas Mass, or at times, I would have attended the children's Mass in uniform with my Cub Scout friends. Seeing as we all received Communion and hadn't eaten since the night before, if it was the children's Mass, I would stop by Nanna and Babbononno's on the way home. Nanna would always have me sample her gravy by dunking a piece of bread in it and then sprinkling a bit of grated cheese on top. Then she would say, see if the meatballs are cooked. A split second later, one would wind up on my dish, next to the gravy covered bread. This was, more often than naught, my usual Sunday morning ritual. Babbononno would then give me 17 cents. This was Christmas Day and before I left, he gave me a dollar.

The entire family would show up at Nanna and Babbononno's around 1:00 pm, and within the hour, we would all be seated at the dinner table. Back in the day, Uncle Nick played for the kids at the Fernald School in Waltham on Christmas morning. Dad and his band played on the U.S.S. Vulcan, a Bostonbased aircraft repair ship. As I said, it was somewhere between 1:00 and 2:00 pm and it was time to eat. Oh yeah, the kitchen table would have been set for antipasti, only this time with Italian cold cuts and the rest of the offerings left over from Christmas Eve.

When we finally sat down, again, Babbononno would have a few words to say, and my cousin Ellie would say a prayer. After that, the feasting would begin and not end for many hours. Escarole soup with tiny meatballs began the

feast, followed by homemade ravioli, followed by meatballs, sausages, gravy meats, stuffed mushrooms, stuffed artichokes, green beans cooked in garlic and olive oil, and ending with a garden salad. This was followed by Italian and American coffee with fruit and nuts placed in the center of the table. Desserts like pizza dolce or canoli would be served a couple of hours later after the men of the family woke up. They would have adjourned to the living room and fallen asleep with stomachs filled with good food and wine.

Let me end by wishing you Buon Natale ... A Merry Christmas from the descendents of Mike and Jenny Contini, Nanna and Babbononno.

Books written about German POWs show they learned of American democracy and freedom from the families they worked for on farms. Families harbored affection for the POWs. After returning to Germany, the soldiers wrote letters that allowed their American friends to remain connected for

many years.

Horst and Wally cultivated friendships with certain families they grew to trust from Horst's weekly visits to a family-owned neighborhood pub, and Wally's kind and gentle personality at her job. They always warmly welcomed my parents, me and my six siblings to summer cookouts, and Christmas gatherings at their cozy home.

Though our parents were all brought together by a bitter world war, and despite the distance of nations between a vast ocean and differing cultures, life for all of us took on new meaning. The results became rewards lasting a lifetime.

Pete Rose Strikes Out Again

MLB Commissioner Rob Manfred announced on December 14th that Pete Rose's lifetime ban from baseball will remain in place. Explained Manfred, "Mr. Rose's public and private comments provide me with little confidence that he has a mature understanding of his wrongful conduct." Rose agreed to a lifetime ban in 1989 after an investigation ordered by Major League Baseball concluded that Rose placed bets on the Reds to win while managing the team from 1985-87. MLB also obtained evidence beyond the 1989 report findings of betting records in 1986 kept by Rose's associate Michael Bertolini. Manfred also stated on December 14th that, "In short, Mr. Rose has not presented

credible evidence of a reconfigured life, either by an honest acceptance by him of his wrongdoing, so clearly established [in the 1989 report], or by a rigorous, self-aware and sustained program of avoidance by him of all circumstances that led to his permanent ineligibility in 1989." Cueto Signs \$130M Deal with Giants

The San Francisco Giants' upgraded their starting rotation for 2016 by signing up Johnny Cueto, 29, for a 6-year, \$130-million deal. He now joins Madison Bumgarner and Jeff Samardzija who the Giants just signed days before Cueto for a 5-year, \$90-million deal.

Cueto went 11-13 with a 3.44 ERA in 32 starts for the Reds and Royals who signed him in a July 26th trade. He was 4-7 for the Royals in the regular season and 2-1 postseason.

Zack Greinke has said goodbye to the Dodgers and hello to the Arizona Diamondbacks with a 6-year, \$206.5 million deal. The 32-year-old led the majors with a 1.66 ERA, finishing with a 19-3 record, second in N.L. Cy Young voting. His \$34.4 million salary tops that of Red Sox newbie David Price (\$31M).

Lackey Chooses Cubs

Former Red Sox pitcher John Lackey, 37, has signed a 2-year, \$32 million contract and will be joining a starting rotation that includes NL CY Young winner Jake Arieta and former Sox teammate Jon Lester.

Gridiron Audibles

Ok Patriots fans, this past Sunday is a prime example of why the rest of the NFL hates us. For some reason, that league memo on parity never arrived at One Patriot Place. 2015 will mark the 6th straight season that New England has clinched a first round playoff bye. You guessed it, the longest such streak in NFL history. The runners-up on the list are the 1990s San Francisco 49ers and Dallas Cowboys who accomplished the feat in four straight seasons from 1992-1995. Results we have come to expect: the Patriots doing things right, other teams not so much. Following a run of the mill 33-16 victory over the Tennessee Titans, Patriots fans tuned in to watch the inevitable implosion of the Denver Broncos in Pittsburgh. That result, of course, guaranteed that the Patriots would not be playing on wild card weekend. See you in the divisional round in Foxboro.

The more things change ... Belichick's friend and rock singer Jon Bon Jovi dedicated an entire song to it. And despite the mounting injuries, things just keep falling into place for the 2015 New England Patriots. The 3-10 Titans confirmed what we kind of knew going into the game. The Titans are what we thought they were, sub-par competition for the Patriots. If Tennessee had any chance in this game, it went by the wayside once rookie starting quarterback Marcus Mariota went down with a knee injury in the first half. And while his replacement Zack Mettenberger admirably led the Titans on two touchdown drives, he also came undone, throwing two interceptions. "I felt like I did a lot of good today," said Mettenberger. "But at the same time, I made too many mistakes for us to get back in the game." No need to explain Zack, we've heard this all before.

His counterpart, Tom Brady, 15-years his senior, also threw two touchdown passes. But unlike Mettenberger, he was successful in all facets of Sunday's game, completing 23-of-35 passes for 267-yards. With running back LeGarette Blount shelved until the 2016 season, head coach Bill Belichick made his GM alter-ego look brilliant yet again by bringing in little-known running back Joey Iosefa. In his first game with the team, Iosefa led all backs in yardage with 51 on 14 carries. Where does he find these guys? However, continuing an astonishing trend, the walking wounded continued to mount for the Patriots. Linebacker Dont'a Hightower and wide receiver Danny Amendola appeared to have re-injured their knees, while safety Patrick Chung went down with a hip injury. None of these are considered to be of the season-ending variety, but for Hightower and Amendola represent an on-going issue that may sideline them until January. With a bye wrapped up, the Patriots only need to win one of their final two games (at New York Jets, at Miami Dolphins) to clinch home-field throughout the AFC playoffs. Is it plausible that the Patriots fail to accomplish this? Absolutely. But don't bet on it.





HOOPS and HOCKEY in the HUB

At this time of year, when almost everyone slows down and takes a break, let's take a look at a man who is always on the go for the great game of hockey - Hockey East Commissioner Joe Bertagna. Joe, who has been involved in the game just about all his life, is now in his 34th year as a college hockey administrator. Add to that the years he played in goal for Arlington High and then performed in the crease for Harvard, and you have someone who has spent the majority of his life around the game — from the colleges, to the amateurs, to the pros and even the Olympics.

Now 64, Joe refuses to retire – not only as an administrator, but from the on-ice game itself. You see, twice a week during the winter months, the commissioner once again dons pads and a mask and makes his way out to the crease for competition in an adult league.

How did all this happen? Joe made it happen by marrying two of his main talents — playing hockey and writing well. He has written throughout his life, including several books on goaltending as well as a pictorial history of Harvard University athletics. The latest — *The* Hockey Coaching Bible — has just been released. It features numerous instructional pieces and includes chapters by the Commissioner as well as several Hockey East coaches.

However, since Joe has been in hockey administration for so long, that's the role that most people identify him with. After working as the primary hockey administrator for the Eastern College Athletic Conference for 15 years, Joe became the fourth Commissioner for Hockey East on July 1, 1997.

Let's just say the ensuing years have been grand. The Conference has expanded numerous times and now includes 11 men's teams as well as nine women's teams.

His lifelong interest in media has meant unparalleled growth and exposure for Hockey East. In this area, Comcast delivers regional coverage of regular season and postseason games while partnerships with the American Sports Network and NBC Sports Network carry Hockey East action to homes

throughout the nation. The NBC deal includes national coverage of the Hockey East Championship Weekend in March.

Then, of course, there are the special events that everyone remembers — the games in unique settings.

Those would be the outdoor games played at fabled Fenway Park. In January, 2010, Hockey East staged a doubleheader at the famous field, an event that sold out the first day tickets went on sale in the fall of 2009. Another doubleheader followed in 2010 and was such a marketing success that a third game was added. Back for a third round in 2014, the conference presented two doubleheaders featuring eight of the conference's 11 men's teams, including Notre Dame. The two twin bills attracted 57,000 fans to Fenway for a night of fun.

Move on to annual tournaments, and Hockey East is a fixture there as well. Just last year Hockey East sent three teams to the NCAA Tournament, an almost regular occurrence since three HE squads have made the tournament field of 16 in 11 of the past 12 seasons.

Two of last year's teams, Boston University and Providence College, met in the national championship game at the Garden, with PC winning the title for the first time in school history.

One characteristic of Joe that some people are not aware of is the time he takes to encourage young people as they begin their careers. He instituted an internship program at Hockey East headquarters for those interested in pursuing a career in media relations. He has also taken time from his busy schedule to speak to a sports public relations class at Suffolk University on an annual basis. It is just one of his many activities that often go unheralded but are valuable for those who are able to meet the commissioner in a smaller setting.

Joe would tell you that in addition to being the Commissioner of Hockey East, there are at least two additional experiences that were special to him. One is the time he spent as a member of the coaching staff of the Boston Bruins. Joe joined the staff in 1985 and remained with the team as goaltender coach until 1991. He later rejoined the team for the 1994-1995 season.


In addition, he was a member of the coaching staff for the U.S. Olympic Men's Hockey team at the 1994 Winter Olympics held in Lillehammer, Norway. That was the last Winter Olympics that featured amateur hockey

Before that, Joe served as the men's junior varsity coach at Harvard during the 1976-1977 season. He also launched the women's hockey program at Harvard, serving as the team's head coach for two years in the late 1970s.

Under Joe's leadership, the women's game gained a big boost with the establishment of the Women's Hockey East Association. Now in its 14th season, the women's conference consists of nine teams from across New England. In recognition of his support for the women's game, the Bertagna Trophy is presented each year to the winner of the Hockey East Tournament.


And while his duties as an administrator have come to define him in the present day, Joe really never stopped being a goalie coach. Last year, he observed his 42nd season as a mentor of those who patrol the crease. He's operated his own goalie clinics that are open to all netminders, regardless of age. Over the decades his program boasts thousands of proud alumni.

Much like the saying of the former British Empire, the sun never sets on hockey season in Joe Bertagna's sphere of influence. It's an influence that's led to Hockey East being acknowledged as one of the top college hockey conferences in America — a lasting legacy to one of the best people in sports.
