


#### FOCCP Brings New Year's Eve Midnight Fireworks to Boston Harbor!

# THE ROMAN TOMBS

**Mausoleum of Augustus** 

The pre-Christian Romans practiced two forms of death rites: cremation and interment. Sarcophagi (stone coffins) for the interred body and urns for the cremated remains were sometimes found side-by-side in the same tomb.

During the latter part of the Roman Empire, the body of nearly every emperor was burned on a magnificent funeral pyre while at the same time an eagle was released to symbolize his escaping soul. Many of the wealthy deceased citizens, however, were embalmed and placed in huge, costly sarcophagi.

These early Romans also developed a custom of internment outside of the walled city. Later, the laws made it compulsory that no body (I have the strongest compulsion at this time to add "dead or otherwise") could be buried within the walls of Rome.

Dead slaves and the lowest grade of Romans were placed either in common burial places or just put into the ground anywhere outside of the walls. Beautiful family mausoleums were built by those who could afford the cost. The custom at the time was to build the tomb at the side of the various roads leading away from the city. The tombs were conspicuous by their owner's desire for this location, as it made them easily accessible and reasonably secure. The older tombs were located nearest to the city gates and, as the roadside spaces became filled, the line of tombs extended for more than ten miles.

Tomb lots with frontage directly on the roadside were highly priced while those lots located back in the fields were less expensive. A major clearing project extending for five or six miles along the Appian



Way was undertaken by Pope Pius IX (1846-1878). This effort returned to the world about 30,000 mausoleums, which had been obscured, by grass and brush for centuries.

Gravestone or tomb inscriptions seemed to be quite common. History records the inscription on the tomb of Eurysaces, a wealthy baker, which translates into "Atistia was my wife; she was the best woman alive; of whose body the remains which are left are in this bread basket." Another inscription reads "To Adeodata, Meritorious Virgin, Who Rests Here in Peace, Her Christ Having Willed It So."

Up to the time of Augustus, the Romans seemed to be mostly concerned about the tombs of their ancestors, altars for ancestor worship, and the safekeeping of the family relics. After visiting the great tombs of Egypt, Augustus, then about 35 years old, set about the task of building a beautiful mausoleum for himself. As an afterthought, he provided some extra space for the other members of his family, which were to follow. The tomb was completed and remained empty for about five years. The fickle finger of fate then pointed to young Marcellus, who became the tomb's first tenant. He was the one whose death was least expected and greatly lamented. Eleven years later, Marcus Agrippa became the second occupant. Octavia, the sister of Augustus was next, and then came Lucius, the young son of Agrippa.

Caius, another young son of Agrippa, soon followed and Augustus himself, who died an old and lonely man, became the tomb's last tenant.

Homeownership feels so far away to me and so many people in all three communities and across Boston. Additional topics she intends to focus on in her campaign include creating and maintaining equitable access to an excellent education for all children across the district, prioritizing excellent city services by reforming Boston's 311 for better transparency and accountability, and pushing the City of Boston for greater investments in coastline resiliency to protect the district from the dangers of flooding due to climate change. Coletta has already garnered enthusiastic and broad support from Charlestown, East Boston, and the North End.

# Start Seeds Outdoors with Winter Sowing

Save money and indoor space used for starting seeds indoors with winter sowing. This easy technique allows you to start transplants from seeds outdoors without a greenhouse or cold frame.

Growing your own transplants from seeds can save you money and is often the only option for new, unique, and other hard to find plants. Not everyone has the time, equipment, and dedication to watering that's needed to start plants indoors.

All you need are flower and vegetable seeds, milk jugs or two-liter soda bottles, duct tape and a quality potting mix. Check the seed packet for information on planting details and timing. Winter sowing dates vary with the growing climate, individual gardener, and seed variety you are planting.

Try starting hardy perennials and self-seeding annuals sometime winter through early spring. Other flowers and vegetables seeds are typically winter sown about the same time you would plant them indoors or a month or two before the transplants get moved into the garden. Keep a record of your planting dates and results to help you fine tune your planting schedule and increase future success. Drill four to 12 small holes in the bottom of the jug for drainage. One winter sower fills the container with water and pops it into the freezer or outside in below freezing temperatures. Once frozen solid, he drills the holes into the container. The ice prevents the plastic container from collapsing during the process.

cut about three to four inches jug, fills with potting mix, tops above the bottom, leaving the them off with about half an inch area by the handle attached so of seed starting mix and then it forms a hinge. The bottom of plants her seeds. the milk jug handle is usually a good guide. Fill the bottom with moist potting mix. Plant seeds according to the package directions. Gently water until the excess runs out the bottom of the container. Fellow gardener, Patricia, uses rolled newspaper or the cardboard tubes from toilet paper to help space and eventually transplant her winter sown seedlings. She makes newspaper pots by wrapping 22<sup>1</sup>/<sub>2</sub>" x 5" strips of newspaper around a  $2\frac{1}{2}$ " diameter x 4" tall jar. She folds the end to create the bottom for a  $3\frac{1}{2}$ " tall pot. Secured with staples, she sets the pots or toilet paper rolls in the milk

Label the inside and outside of the jug with a permanent marker. Close the lid and seal it shut with duct tape. Remove the cap before setting your milk jugs in a sunny location outdoors where rain and snow can reach it. Keep them handy to prevent waterlogged soil during extremely wet weather.

Water your outdoor seed starting chambers during snowfree and dry weather. This will be much less often than those seedlings growing indoors under artificial lights.

Your plants will be ready to move into the garden at the normal planting time. Just open the lids harden off the plants and move them into the garden.

# L'Anno Bello: A Year in Italian Folklore Welcome, New Year!

Sometimes, it appears as if the bulk of our Christmas festivities end the moment we flip over the December 25<sup>th</sup> calendar page. Gone are "Jingle Bells" and "All I Want for Christmas is You" from the radio, replaced by the steady rotation of everyday hits and standards. Gone are the tantalizing unwrapped presents from beneath the tree, having now been revealed of the surprises within. However, contrary to popular perception, the season of Christmas actually lasts for a much longer time. As the old carol about the three French hens can attest, Christmas continues for twelve days after the proper feast ends. The real close of the Christmas season occurs on January 6th, or the holiday of the Epiphany. Italians afford each of the Twelve Days of Christmas a special significance. December 26<sup>th</sup>, for example, is the feast day of St. Stephen, and Italians celebrate la festa di San Stefano by visiting family or going skiing in mountain resorts. For me, the Twelve Days of Christmas contain a magical and enchanted quality, laden with the sensation of being far removed from the bustle and grind of ordinary days. I spend the Twelve Days of Christmas in a haze, taking advantage of the vacation to catch up on grading, eat leftovers from the Christmas dinner, shop in blissfully uncrowded stores, and visit family members who have arrived from overseas. However, I also prepare for the most mysterious feasts of the Twelve Days of Christmas: the twinned holidays of New Year's Eve and New Year's Day. Bursting with folklore and tradition, these holidays seek to welcome a new beginning with hope and luck.

New Year's Eve carries a distinct and unique feeling from where she was a boarding school other days of the year, a strong student in the 1940s, during this our own good fortune. day on New Year's Eve - walking the dog, going to the grocery store, visiting the hair salonwith a captivating patina of both nostalgia and enthusiasm, propelled by the knowledge that old year will soon give way to a new and exciting chapter. Even the twilight sky seems different on New Year's Eve, glowing with a jewel-like blue tone indicative of the unhurriedly lengthening days. The tangible peculiarity of New Year's Eve gave birth to a plethora of luck-themed folk traditions related to the holiday. New Year's Eve is a time inherently rife with insecurity, as we ponder whether the upcoming year will be worse or better than the last, sundry superstitions seek to improve good fortune within the next twelve months. The practice of making a lot of noise at the stroke of midnight, reflected in the abundant party horns and noisemakers of today, derives from the ancient belief that supernatural creatures wandered the Earth during times of transition. Loud noises could effectively scare these evil spirits away. Certain foods also possess lucky qualities for the New Year. In Italy, lentils are considered an auspicious food for New Year's Eve, since they are thought to resemble small coins and as such attract prosperity. They are usually paired in a dish containing a spicy pork sausage known as cotecchino. My grandmother fondly remembered a more unusual luck ritual practiced in the olden days in Italy on la Notte di San Silvestro ("St. Sylvester's Night" — this is what Italians call New Year's Eve, since December 31<sup>st</sup> is also the feast day of the fourth century Pope Sylvester I). She had to exercise great caution walking through the streets of Naples,

I am not throwing anything out of my windows, but I do love to celebrate the New Year in a folksy and traditional manner with my family. We gather together and enjoy a special meal that ends with my chocolate-vanilla marble ring cake for dessert. Ring cakes are yet another lucky food for this feast, since their shape symbolizes the cycle of the year. I enjoy hearing my grandmother tell stories about the quirky traditions that characterized New Year's Eve in her small Italian hometown, such as sweeping out the door with a broom at midnight in order to chase away the old year. Sometimes my family plays Bingo together, known as tombola in Italian. Games of chance are popular components of New Year's festivities around the world, for they mimic the unpredictable thrill of good fortune. We watch the televised New Year's celebration in New York, and when the famed Times Square ball finally drops at midnight, we hug and kiss and wish each other a happy New Year. This is my favorite tradition, as it reminds me that being surrounded by the love of family and friends is the best wish I can ask for all year! New Year's Day is far more low-key. Known as Capodanno, or "head of the year," in Italian, this is a day devoted to recuperating from the previous night's parties. Superstition advises that the way you start the New Year is the way you will end it, so I like to spend New Year's Day doing a little bit of all the things I love, such as writing, reading, baking and watching a movie. New Year's Day is also laden with a unique and pleasant feeling. The sky seems bluer, the birds sing loudly, and snow sparkles like diamonds on the ground. # Saint Giuseppe Maria Tomasi

Tomasi was born at Licata, in the Kingdom of Sicily, to Giulio Tomasi, the first Prince of Lampedusa and his wife, Rosalia Traina. Tomasi from his earliest years showed signs of a life oriented toward God. He secretly cultivated his desire to enter religious life until he obtained the consent of his father.

After having renounced the principality, which belonged to him by birth, in favor of his younger brother, as well as his very large inheritance, Tomasi was admitted into the Theatines, a religious Order founded by St. Cajetan of Tiene in 1524. They were noted for the simplicity of life followed by its members. He joined the Order on March 24, 1665, and made his religious profession in the Theatine house of St. Joseph, at Palermo, on March 25<sup>th</sup>, one year later.

Tomasi then studied philosophy, first at Messina, and later, owing to poor health, at Ferrara and Modena, and theology in Rome and Palermo. He was ordained a priest on Christmas Day 1673. He had



a wide knowledge of Greek, and many of the mid-Eastern languages including, Aramaic and Hebrew. He devoted himself to the study of Scripture and the Fathers of the Church. Searching the chief libraries, archives, and monuments, he retraced the ancient ecclesiastical discipline and liturgy. Tomasi considered that a good part of his own religious perfection lay in dedicating himself, with the spirit of faith, to the publication of rare liturgical books and of the ancient texts of sacred Liturgy, and so bringing to light many ancient sacred

scriptures which until then had been hidden in libraries.

Tomasi's efforts at reform were directed not to the introduction of the new, but to the restoration and maintenance of the old. He held high office in the Church under Pope Innocent XII Pope Clement XI, for whom he served as confessor, appointed him consultor of the Theatine Order, theologian of the Sacred Congregation for Consultations about Regulars and other offices of the Holy See. Tomasi was made Cardinal Priest and taught catechism to the children of the poor in his titular church, also introducing its congregants to the use Gregorian Chant, He passed away in 1713, mourned by all, especially by Pope Clement, who so admired his sanctity that he had consulted him before accepting the papacy. He was buried in his titular church.

Tomasi was Canonized by Pope John Paul II on October 12, 1986.

The Feast Day of Saint Giuseppe Maria Tomasi is January 1<sup>st</sup>.





A Nostalgic Remembrance

New Year's Eve had always been a bit different in the Contini and Christoforo households back in the day. Babbononno, two of my uncles, Nick and Paul, and my father were musicians. When I became of age, I joined the family business and became the  $3^{rd}$  generation to play an instrument or two in my family. Babbononno played guitar in Italian dance bands and drums in marching and concert bands, like the North End's Roma Band. My two uncles played sax, clarinet and flute. Dad played bass violin, Sousaphone and tuba (bass with the dance bands), and later, bass guitar. I started out playing bass violin and added the bass guitar in the 1960s. New Year's Eve for us was not a time to celebrate, but a time to entertain (and make money).

Around 1947, a saxophone student of Uncle Paul's, named Ray DiGiovanni, put a dance band together which became rather popular in the years after WWII, especially due to its constant appearance at the Oceanview Ballroom, which was located at the beginning of Revere Beach. (It was originally called the Coral Gables) Of course, my uncles were in the sax section and Dad was the bass player and behind the scenes, Ray DiGiovanni's business partner. The band was called Ray Digg and his Orchestra, and as I said, they were quite popular back in the day.

You may ask why there was a name change. Years ago, people with ethnic sounding names found it easier to "make it in America" with more Anglo sounding names. Raymond DiGiovanni became Ray Digg. Another example ... a bandleader Uncle Nick and I worked for, George Swartz, became George Graham, My uncles shortened Contini to Conti (Paul Conti and Nick Conti. Dad became Johnny Christie. As I said, it was easier back then with a more American sounding name. When I became professional, I became Johnny Christy Jr., changing Christie to Christy.

It was the tail end of 1958. I

corner of Marion in the Eagle Hill section of East Boston. This was just around the corner from where we lived on Eutaw Street, and not yet having my own car wasn't a problem. I could walk to work with my bass violin tucked under my arm and be there within five minutes.

Babbononno supervised as I dressed for work. By this point in his life, he was retired from both music and his daytime job, but knew what nuances were necessary for a properly attired professional musician. He made sure my tux pants were properly creased, my jacket was without a wrinkle, my formal shirt starched with each pleat falling in place without a problem, my bow tie tied correctly (no clipons or ready-made bows) and my formal shoes spit-shined reflecting upward. After passing inspection, I headed out to play my first ever, New Year's Eve dance.

We were to start at 8:30 and I arrived at 8:00 to set up and look over the music. Ray Digg had a great library of music and I wanted to make sure I could handle the bass parts. All the other musicians also arrived at around 8:00 pm to setup and we conversed while getting ready. I had known most of the band members since I was a child. I actually grew up in the business accompanying Dad to the union every Monday. Monday was the day most of the active musicians congregated at the union hall to meet with the band leaders to book in future work

Ray gave the downbeat at exactly 8:30. There were a few people there and they kept coming in as time went on. This was a dinner dance and we were booked until 12:30. We played various types of music, starting with fox trots, and then heading to the jitterbugs popularized by the big bands during WWII. After that, it was waltz time and then Latin music time with a couple of rumbas and a new dance craze, the cha cha cha. At some point, we would get a request for Italian music and Ray was prepared with favorites that were mostly Italian-American.

This was back in the day

I said, I had to slam away to get the volume I wanted.

Even though I was the kid in the band, I held my own. The only problem was that I wasn't used to working with such a large band. To maintain the necessary volume, was taking its toll on my fingertips. I started to develop blisters. Of course, anticipating this problem, I was ready with Band Aides and a roll of adhesive tape. I began using both by 11:30. Well, midnight rolled around and we played the traditional songs to welcome in the New Year. Just before 12:30, Ray announced last call for the bar and told the partygoers that we were going to play our last set.

Someone walked to the stage, spoke to Ray who nodded to the man and as we finished our last tune, were told by Ray that we were going a half hour overtime. The man who hired the band and Ray had just agreed on a price for us to continue. The musicians were happy about this except a young bass player. I looked under by bandaged fingers and saw only blood blisters and then realized how much my fingers hurt. I continued playing even though blood began running down a couple of strings due to a blister or two breaking. I had no alternative, I just smiled in pain and played. At 1:00 am, Ray told us we were going to play another half hour overtime. And so, we played on. About 1:15, I thought I had had it, but couldn't give in. If I did, it would be an admission of defeat and prove I wasn't ready to play at their professional level.

Just then, the cavalry arrived to save the day, Dad walked in the door. His job had ended on time and when he saw my fingers all bandaged, he, without saying anything, walked on the stage, threw off his coat, winked at me and without skipping a beat, took the bass and finished the half hour. I was saved. All this happened 63 years ago and that entire generation of musicians is long-gone. The music has changed over the years, but to me, that great American songbook which is what we call that type of dance music from the past is still the best. The songs of Cole Porter, George Gershwin, Duke Ellington, etc. ... will never be surpassed by anything that's out there today. Maybe it's just me, but a lot of people do agree with me. Maybe I'm just an old timer, but time itself will be the judge. Rod Stewart and some of the early rock and rollers are now singing and playing music from the Great American Song Book. The list also includes Johnny Mathis, Lady Gaga, John Pizzarelli, Harry Connick Jr., and many more. Tony Bennett sang those old favorites until he retired in his mid-nineties.



Even customs, such as throwing your old things out of the window at midnight, representing "out with the old and in with the new," still exist in Southern Italy. On New Year's Day, traditional cotechino con lenticchie, a spicy pork sausage and lentil soup, is typically served. It is believed to bring good luck to all that consume it. The lentils represent good fortune, and the pork, prosperity and wealth.

In the hopes of a better year ahead, my family always honored this tradition. Each New Year's Day, "Lentil Soup" and homemade Italian bread was served. The following recipe is my absolute favorite and though it doesn't include spicy pork sausage, feel free to add it, if you wish.

Auguri di Buon Anno!

LENTIL SOUP Zuppa di Lenticchie



1/4 cup olive oil 1 large onion, finely chopped 3 carrots, peeled and chopped 3 celery stalks, chopped 3 garlic cloves, finely chopped 1 (14 1/2-ounce) can diced tomatoes

- 1 pound lentils, soaked and washed
- 12 cups chicken stock/broth 1 cup uncooked ditallini pasta
  - 1 cup shredded parmigiano
  - reggiano cheese

Salt and pepper

In a large stockpot, heat oil over medium heat. Add onion, carrots, and celery. Sauté until tender, about 5 to 10 minutes. Add the garlic, salt and pepper; cook an additional 3 to 4 minutes. Add the entire can of tomatoes with juice. Simmer stirring occasionally, about 10 minutes. Add the lentils, mix well. Add the broth, stir and raise heat. Allow to come to a boil, lower heat, cover and simmer until lentils are cooked, about a half hour. Add pasta and simmer, until al dente. Season with salt and pepper, to taste. Ladle the soup into bowls, sprinkle with grated cheese, and serve.

I knew as a baseball fan that the Red Sox under Tom Yawkey lagged behind most teams when it came to opening up the game to black prospects. I was 10 years old when the Sox broke the color barrier bringing up Pumpsie Green to play second base. What pressure must have been on him, now looking back! Later, in summer of 1959, the Sox also brought up Earl Wilson, another bruising big guy as a pitcher who was in the mode of Grant. Wilson also was a great hitter starting off in the minors as a catcher. He too would become a 20-game winner down the line for the Tigers.

Now getting back to Mudcat. The piece in the *Times Magazine* by Rowan Ricardo Phillips really did a good job on telling readers who Grant was and what he meant to both baseball and America.

Grant wrote his own book in 2006, *The Black Aces: Baseball's Only African-American Twenty-Game Winners*. He was not only one of them, he was the first. He was a 20-game winner for the Twins in 1965, when he went 21-7. Over his career, he won 145 games in 14 Major League seasons. At the same time, he also formed a band, "Mudcat and the Kittens," and often sang out against racism in baseball.

In the book, he wrote, "you always had to watch where you were, what you were going to do, because something was going to happen to you every day. You knew of the lynchings. You would hear it in the night, and if you didn't, word came through the next town."

Grant grew up in an area of Florida where the Klan was still a terrorizing force and he never forgot how his mother would hide him and his siblings when the Klan came through.

The life of Jim "Mudcat" Grant before, during, and after his career ended was full of challenges. Today's African American pitchers owe so much to pioneers like Grant and Earl Wilson. Their courage to withstand the ire of so many actually made them stronger. The American dream belongs to everyone. Today, I believe, are much better due to past fights resisting racism. Sometimes change can come through major events and sometimes by just everyday living and the courage to stand up for yourself.

Grant, however, showed a good sense of humor, too. He never made much money playing baseball in his day and once said, "I made more money in music than I did in baseball."

He lived a good 85 years of life, saw lots of ugliness and lots of joy. I am sure that his joy was seeing America become a better country than the one he was born in. Personally, I have seen lots of life too and I like to think the only thing that really matters is the present moment because we only have that and hope for tomorrow to come.



# Let's Make 2022 the Year We Knock Out This Virus



**HE WAS THE MOST** — Yes, he was, the longtime radio playby-play broadcaster Johnny Most who was so popular calling Boston Celtics games that some fans turned down the sound on their televisions so they could hear his verbal description of the action.

And what a call it was as he was on hand for 16 of the 17 Boston Celtics NBA Championship seasons during a 37-year career with the storied franchise. He first took up the microphone for the Celtics in 1953 and didn't put it down until 1990, bookending a career that saw him call Bob Cousy, Bill Russell, Tom Heinsohn, and John Havlicek followed later by the heyday of the original Big Three of Larry Bird, Kevin McHale, and Robert Parish

Those who heard him will never forget his voice or his animated delivery. He had names for many players from opposing teams and did not hesitate to use them during his broadcast.

But the moment that gained him broadcasting immortality was his call of John Havlicek stealing the ball on an inbounds play with five seconds to go in game 7 of the 1965 Eastern Division Finals against Philadelphia. Havlicek's action preserved a 110-109 Celtics victory and enabled the Green and White to continue down the path towards capturing their seventh consecutive NBA Championship later that spring.

Most's description of that play has been called "the most famous radio call in basketball history" by the NBA. Be sure to check it out on the internet where one can find a video of the play accompanied by Most's famous radio call as the decisive moment unfolds.

Like many adults from his era, Johnny was a member of the

years during the 1960s. He also had a television show following Red Sox games and once - just once - served as the analyst for a Bruins game. It happened in 1965 when regular play-by-play man Fred Cusick was out sick and Bob Wilson took over Fred's duties with Johnny filling in as the commentator. Oh, how we would love to hear Johnny offering his thoughts on the hockey action as the game actually took place in front of him.

And talk about a varied career in media: Johnny actually has a published book of poetry to his credit.

His famous voice was silenced forever on January 3, 1993 some 29 years ago - when he suffered a fatal heart attack at age 69. A heavy smoker most of his adult life, Johnny began having health problems in the early 1980s, problems that took their toll as time went on.

Johnny announced his retirement on October 10, 1990. Two months later, on December 3, 1990, his microphone was installed on the exterior facade of a broadcast booth "high above courtside," near the location where many of his broadcasts originated. The ceremony featured team president Red Auerbach plus Larry Bird, Tom "Satch" Sanders, KC Jones, and broadcaster Tom Gorman all paying tribute to Johnny and his loquacious ways.

In a way, the Celtics honored Johnny as if he had actually been a member of the team. And in a very real way, he was. Since he was not a player, his number could not be retired. By "retiring" his microphone and displaying it within the Garden, the Celtics were, in a sense, including him within that pantheon of legends whose uniform numbers adorn the rafters.

Just 25 months to the day after that noteworthy ceremony, Johnny Most died in Hyannis. He may have been gone but he certainly was not forgotten. Shortly after his passing the trustees of the Basketball Hall of Fame in Springfield honored him with the Curt Gowdy Media Award for his on-air contributions to basketball.

In Johnny's case, the award carried a dual significance. Way back in 1953, he was the man who replaced Curt Gowdy as the radio voice of the Celtics. Gowdy would go on to call Red Sox games on radio and television for 15 years before embarking on a national sports broadcasting career that saw him call 13 World Series, 14 Rose Bowl games, 24 NCAA Final Four basketball events plus eight Olympics and nine Super Bowls. In contrast, for all of his 37-year career with the Celtics, Johnny Most was ours, as New Englanders would say. That was especially true during those 16 Celtics championship seasons that Johnny covered, since the extended postseasons often lasted a number of weeks into spring. Fans certainly got the most from Johnny Most who gave his all for the team. He was absolutely an original. There will never be another broadcaster like him.

Greatest Generation that served in the U.S. Armed Forces during World War II. Born and raised in New York City, he flew 28 combat missions with the 15<sup>th</sup> Air Force, earning seven medals. Returning home after the

war, he began his broadcasting career in NYC while working with Marty Glickman, the 1930s track star turned New York Knicks and New York Giants football announcer. He took the Celtics job with the dual blessings of team owner Walter Brown and coach Red Auerbach.

And, although he is mostly closely identified with the Celtics, he also worked in a number of other settings in the region. For example, he called Greyhound races at a track in Connecticut and was the announcer at Norwood Speedway (a NASCAR sanctioned racing site) for three
