

# Stirpe Nostra

## CHARON

During the past weeks we have examined the legends about Hades, the god of the Underworld, and also Hades, the land of the Underworld itself. This week the spotlight falls upon Charon, the mythological ferryman from antiquity, who conducted the souls of the dead in a boat, across the River Acheron, in the infernal regions.

At the moment of death the eyes of the deceased were closed by one of those present, an "obolus" (coin of low value) was placed in the corpse's mouth and then the mouth was closed. This coin was intended, symbolically, to be used as payment for Charon's fare. The body of the dead person was then washed, anointed with perfumes, and clothed in rich white garments. A wreath of flowers was also placed upon the head of the corpse. The body was laid out on an ordinary bed with a pillow that supported the head and back, and the feet were turned toward the door. Special vases containing perfumes were placed beside the body, and were usually buried with the coffin. A honey cake was also placed in the casket, and intended, symbolically to be used as a reward for "Cerberus," the three-headed dog that guarded the gates of Hades. Any ghosts that had not been honored with a

proper burial were not permitted to enter the infernal regions without previously wandering on the shore for a hundred years.

Ancient poets have represented Charon as a stern and robust old man, with eyes glowing like flame, white bushy hair, dingy clothes that were stained with the muck of the river, and holding a long pole which he used to propel the boat.

Probably the most interesting portrayal of this subject is in the lower right hand corner of Michelangelo's "Last Judgment" on the wall of the Sistine Chapel in Vatican City. This painting (fresco) is considered to be the largest and most comprehensive fresco in the world. It shows that terrifying moment at the end of the world when the remorseful condemned are being drawn down to the depths of the lower world by taloned demons. Then there is Charon the boatman, forcing

the reluctant souls to disembark, while other demons are pulling them off the boat with grappling irons. Finally, Hades, the ruler of the infernal regions is standing in the extreme lower right hand corner with a serpent coiled around his waist.

Many persons are familiar with the story that tells how Michelangelo painted the Sistine Wall showing all the

characters in the nude except the Virgin Mother. "Scandaloso," cried Cardinal Biagio DeCesena when he first inspected the masterpiece and caused clothing to be painted over certain critical areas. The furious Michelangelo claimed that the Cardinal was a fool and was completely devoid of artistic feeling. Revenge came to the master when he painted the Cardinal's likeness onto the face of Hades, but with the ears of a jackass. The Cardinal immediately complained to the Pope, who replied, "If you had been painted up above in the heavenly scenes, I could have used my influence to have you removed, but I have no power in Hell so you'll just have to remain there." Finally, if you'd like to know where the serpent's head is located, and what it is doing — well, you will just have to take a trip to Rome.

### The Gospel According to Barack

# L'Anno Bello: A Year in Italian Folklore

## Christmas, A Time of Tradition

We now find ourselves in that unique and mysterious season known as midwinter. December 21<sup>st</sup> marks the winter solstice, the shortest night of the year. As this date approaches, I can definitely feel the darkness closing in like a worn blanket, shrouding the Earth in its dusky glow. I do not bemoan this darkness, however, because it forms a necessary and beautiful component of the year's cycle. On frosty nights, the stars appear brighter and sharper in the inky black mantel of the sky — my husband and I even witnessed a huge shooting star the other night! The short nights are also significant because they enhance the meaning of the winter solstice; after this date, the sun will gradually stay longer in the sky, bringing hope and light in its path. It is no coincidence that Christmas, with its emphasis on candles, burning yule logs and light decorations, occurs during the darkest time of the year. Religiously, the Christmas story represents light coming to the world in the form of Jesus, while symbolically the many sources of luminous decorations represent the return of the sun after the solstice. Because of the holiday's profound meaning and symbolism, I relish traditional Christmas celebrations that highlight these elements. From food to gifts, I enjoy Christmas most when surrounded by tradition and the love of family.

One way in which I honor the holiday customs passed down in my family is through food. Food forms an integral part of the Christmas Eve feast in my home, which is known as *la Vigilia di Natale*, or "the Christmas vigil" in Italian. According to Italian lore, *la Vigilia* is traditionally a meatless meal, stemming from the days when Christmas Eve was considered a fast period in preparation for the birth of Jesus the next day. As such, many Italian families may prepare seafood-based dishes for *la Vigilia*. I am always excited to see what fish plate will be served each year at *la Vigilia*; last year, my mother cooked a tender sole with shrimp stuffing. This



year, she plans on making a smoked salmon quiche, while my uncle will be preparing a variety of seafood. However, my favorite part of holiday cooking involves desserts. Several traditional Italian desserts have become inextricably associated with the Christmas season, and form an indispensable part of my holiday celebrations. I remember my father always bringing home a cylindrical box of *panettone* right before Christmas. *Panettone* is sweet bread studded with dried fruits and candied peel, and its name literally means "great bread." I actually do not really like the taste of *panettone*, but I appreciate its inclusion in my holiday dinner as an indicator of a time-honored tradition. I have great love and passion for *struffoli*, a dessert my grandmother has been making since I was little. *Struffoli* are deep-fried dough balls soaked in honey, arranged into a wreath or tree shape, and sprinkled with colored nonpareils. They are a fun and whimsical way to revel in the brightness of the holiday season. I have also made a lemon tart every Christmas Eve for several years now, to showcase the citrus fruits now in season. So on the dark nights leading to Christmas, you will most likely find me in the kitchen, preparing recipes of yore.

However, I believe that the most important part of my Christmas celebrations is family. The holiday derives so much of its meaning from the love and comfort that surrounds a person, emanating from the company of loved ones. I cannot imagine celebrating Christmas without my family. All of our Christmas Eve traditions — *la Vigilia*, playing board games, opening presents at midnight — reinforce the bonds of family.

When we play a silly board game, our shared laughter and merriment forms a barrier against the darkness and the chill air outside, filling the room with the special kind of warmth that can only be felt when sharing special moments with those you love. Opening gifts, which

my family does at midnight huddled under the honeyed glow of the Christmas tree, provides me with yet another opportunity to relish my family. I love the looks of delight when family members and friends unwrap a gift selected or crafted with thoughtfulness and love. Truly, that is what gift-giving is all about, not material gain. No matter what your Christmas traditions are, it is important to approach them with love, compassion and a sense of wonder. In fact, midwinter celebrations like Christmas developed their traditions as a response to the dark, cold days of the winter solstice. At a time when all seems frosty and barren, the convivial feasting and merriment not only honors the abundance of the past harvest but demonstrates the resilience of community and familial bonds, offering hope that life will continue its vibrant path as surely as the sun is reborn on the solstice. An old Italian dictum states that no one should be left alone on Christmas, which is why we should do good deeds for those who are lonely or separated from their families during the holidays, such as the sick, the poor and those in the military. The Christmas spirit of generosity, kindness and family — and "family" is not necessarily synonymous with "blood relations," as friends and the larger community definitely form part of your family—is too joyful to keep hidden away.

This Christmas, I will continue to honor the family traditions woven into the fabric of holidays past. Whether they involve eating *struffoli* or exchanging gifts at midnight, these traditions provide me with an indelible link to my ancestors and their values, spirituality and wisdom. However, I will also pay special attention to the meaning behind the traditions. Lurking behind all of these customs — and, indeed, all customs of Christmas, no matter what the culture — is the sense of love. Love shared within a family, love for the traditions of our forbearers, acts of love toward the community, the love of Jesus and the Nativity, the love for the sun which rises again — all of this love comprises the complex and special holiday of Christmas. So on Christmas, as you honor your own traditions, take note of the bonds of love which surround you, or which you can pro-

## WAS A YEAR ROUND CHRISTMAS GIFT



Usually around Christmas time folks start anticipating things like getting and giving Christmas presents. The North End community recently lost a great gift to the community going back to 1937 when Dominic Campochiaro was born. Dominic was one of those pillars most communities today remain in need of for its own well being. For his family, friends and neighbors his loss will be greatly felt. There's an old saying, "When someone you love becomes a memory, that memory becomes a treasure."

Like so many who loved Dom over his lifetime, for me his dedication to the community that nurtured him was an overwhelming example of someone who doesn't just reside somewhere, but truly lives in it and for it.

I was at his wake and funeral Mass and I saw him resting their silently, which was so un-Dom. He was always on the move. Always with that infectious smile of his. One always felt better after coming into contact with him if just for a few minutes. He was my friend and someone I highly respected. I remember seeing him driving all over the neighborhood with that "D&S electrical truck of his. Once, a long time ago, I mentioned to him what the "S" stood for and he told me, it was his deceased brother's name, which was Sal. I remember telling him my deceased brother's name was Dom. I guess if I could do anything electrical, my truck could have been "D&S" too. However, he told me he owned the "D&S" not me.

Dominic was a great baseball person. Loved the game his whole life. In high school across the High Bridge in Charlestown, he played the infield and enjoyed himself. When he joined the U.S.

Army, they sent him to Germany to join up with the Army's baseball team. Talk about serving your country, huh?

His baseball mentor was little Dominic DiMaggio who played at Fenway for the Red Sox. He was nick-named many things over the years. He was "Coach Dom" to generations of North End kids. When they dedicated the field at Langone Park in his honor, I remember taking a photo of a little kid, his father and grandfather, he had touched all three generations with his very being there.

A few years back, I helped Dominic on Saturday mornings with the smallest of kids just learning baseball by trying, and I say trying, to knock a plastic ball over a tee and running to first. He had the patience of Job in the Bible. Nothing bothered him when he was coaching them. Always a smile and lots of encouragement. I enjoyed that summer with him at the baseball field and trying to learn from him about how to make learning baseball not a chore but just lots of fun. Whether he was teaching tee ball players or older little leaguers over the years with the North End Athletic Association, his job seemed to develop not just baseball skills but skills to live life too.

During the Mass for him, the homily from the altar spoke to everyone present in the pews. All of us end up dead but many of us unfortunately lived our whole lives dead. We contribute little, help few and live this world unfulfilled. That wasn't Dominic; he left this world, his North End world so much better than when he found it at birth.

None of us are saints. We all leave our impact but some of us are less imperfect like Dom. He was a good player in life. St. Paul before he died said that for him, he had finished the race and did the best he could. Dom's marathon to use another sports term has been finished. He did the best he could which is all that can be asked of all.

Someone once said, "Finally, God, if fate seems to uppercut me with both hands and I'm laid on the shelf in sickness or old age

Saint Adelaide of Italy

Kingdom of Italy for himself. He forced Hugh to abdicate in favor of Lothaire, and is believed to have afterwards put Lothaire to death by poison. He then proposed to unite Adelaide in marriage with his son, Adalbert. Refusing the offer, Adelaide was placed in almost solitary captivity, in a Castle on Lake Garda.

Adelaide was rescued by a priest named Martin, who dug a tunnel, by which she escaped, and remained concealed in the woods. Soon however, the Duke of Canossa, Alberto Uzzo, who had been advised of the rescue carried her off to his castle.

While this was taking place, the Italian nobles, weary of Berengarius, had invited King Otto of Germany to invade Italy. He met with little resistance. Otto then went to Canossa where he met Adelaide, and married her on Christmas day, 951, at Pavia. The marriage was greeted with the enthusiasm of the people for Adelaide, whose romantic life had appealed to them, making Otto's work of subjugating the peninsula easier.

In Germany she was the idol of her subjects, while her husband lived. After Otto's death, during the reign of her son Otho II, her troubles began, chiefly owing to the jealousy of her daughter-in-law, Theophano, and possibly also because of her generosity in her works of charity. It resulted in her withdrawing from court and taking up residence at Pavia, but reconciliation was effected by the Abbot of Cluny, St. Mayeul. The same troubles broke out when her grandson came to the throne, the jealous daughter-in-law being yet unreconciled, and Adelaide was again forced into seclusion. After Theophano's death, Adelaide was recalled to assume the burden of a Regency. Her administration was characterized by wisdom. She took no revenge upon her enemies; her court was said to be like a religious house. Adelaide passed away in the year 999 at Seitz in Alsace on a journey to Burgundy to reconcile her nephew Rudolph with his subjects.

Saint Adelaide was canonized in 1097 by Pope Urban II. Her Feast day is December 16.

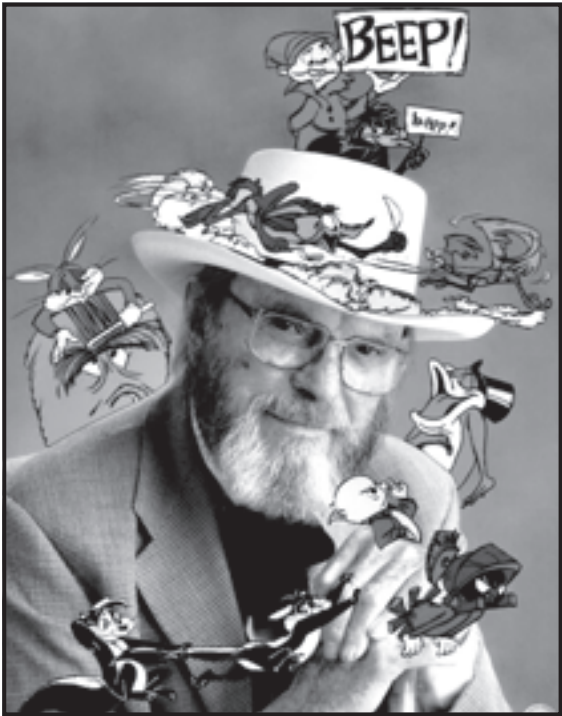
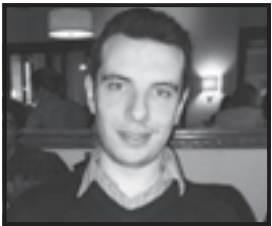

The History of Animation:  
The Looney Best



Chuck Jones

Warner Bros. had their most glorious year's right after WWII, which each of the stars evolving into the icons we know today and, like Disney's cast, often finding specific directors to fit their style. Some of these directors are legends in their own right. A few greats established their name at Disney, most notably Jack Hannah who directed some of the funniest Donald Duck shorts and even pushed the Disney mold into Tex Avery territory, but the auteurs of animations golden age propped up mostly at Warner Bros.

Bob Clampett was the first true discovery there, not counting Tex Avery who, despite being considered the father of Bugs Bunny, is really immortalized by his later work at M-G-M. After sending off Porky Pig, his first established creation, Clampett unleashed his wacky genius to the fullest, even his elasticity character designs were a novelty, and a case could be made that there was never a more creative animator than Bob Clampett with the exception of his former colleague Tex Avery. With Bugs Bunny he did wonderful things, taking the rabbit through new locations and enemies in *Bugs Bunny Gets the Boid*, *Falling Hare*, *What's Cookin' Doc?*, *Hare Ribbin'*, and *Buckaroo Bugs*. The two cartoons in which he paired Bugs with his arch enemy Elmer Fudd are considered to be masterpieces of the genre, *The Old Grey Hare* (1944) and, his last cartoon at Warner Bros., *The Big Snooze* (1946). Clampett also did more to develop Daffy Duck than any other director, molding the duck from a zany lunatic to a hot-headed sort of everyman. *Draftee Daffy* and *Book Revue* are delights, but *The Great Piggy Bank Robbery*, his spoof of Dick Tracy with the use of Daffy

("Duck Tracy"), is a milestone in cartoon history.

While Clampett pushed the boundaries of cartoon physics, Robert McKimson preferred a softer less gag-driven approach and domesticated several established characters, giving Sylvester a son and a new rival in Hoppety Hopper the kangaroo (who the lispng cat always mistakes for a giant mouse), and created others like Foghorn Leghorn and the Tasmanian Devil. Friz Freleng, by then a veteran animator, followed along the same lines and, arguably, fathered more Warner Bros. characters than anyone else including the explosive Yosemite Sam (he thought Elmer was an inefficient nemesis for Bugs, a more aggressive foe was needed), Tweety and Sylvester in the academy award winning short from 1947 *Tweetie Pie*, and Speedy Gonzalez, as well as a number of limited appearance wonders such as the jiving version of the Three Little Pigs. When Warner closed its animation studio in the late 50s, Freleng found a new niche as the animator of the *Pink Panther* cartoon shorts.

The most prolific cartoonist, however, to come out of Warner Bros, was Chuck Jones, who has become something of a patron saint to animators and cartoon buffs alike. It's impossible to over emphasize his legacy at Warner Bros. alone (which started with 1938's *The Night Watchman*) and continued well into the TV era. He created his own characters, Pepe Le Pew and the most famous team in cartoon history Road Runner and Wile E. Coyote, who were created as a spoof of the predator vs. prey mold loved by the early cartoonists and ended up becoming golden age pillars themselves. The cartoons follow a simple formula. In the American Southwest, a scrawny and scruffy looking coyote tries various attempts to catch the only apparently available food source, the Road Runner that is seemingly indestructible not for his own cunningness (like Bugs) but by the coyote's overconfidence in his own genius and ignorance of how complicated gadgets work. What's unique to Jones's approach of the formula is the sympathy he always mustered for poor Wile E. Coyote, a starved soul whose sole existence revolved around failure at his one aim. The end of Warner animation studio was not the end for Chuck Jones, so high was his reputation. He gave Tom & Jerry a new lease on life with a short-lived revival series at M-G-M and then moved onto television where he would revisit the Looney characters he helped make famous years ago at Warner Bros. in several retrospective TV specials featuring the gang. Jones career was long and expansive, but reached its zenith at Warner, birthplace not only to some of the most enduring cartoon stars ever, but the starting point of some of the greatest animators ever.

FRANK SINATRA - SINATRA: LONDON  
UMe/Frank Sinatra Ent.



In June 1962, Frank Sinatra traveled to the U.K. to record *Sinatra Sings Great Songs from Great Britain*. Recorded over three consecutive nights at London's CTS Studios, *Great Songs from Great Britain* would be the only album Sinatra would ever record outside of the United States. On November 25<sup>th</sup>, Universal Music Enterprises & Frank Sinatra Enterprises released *Sinatra: LONDON*, a deluxe 3-CD/DVD and digital audio collection presenting the remastered original studio album with a treasure trove of other London highlights from Sinatra's career. The expansive set's more than 50 previously unreleased recordings include session material from the album, a 1962 BBC *Light Programme* radio special with introductions to each song by Sinatra himself, a 1953 live session for BBC Radio's *The Show Band Show*, and a Royal Albert Hall concert from 1984. The collection's DVD features a previously unreleased filmed 1962 concert from Royal Festival Hall, plus a 1970 concert appearance from the same venue with a never before released performance of the classic song *A Foggy Day*. The sleek book-style set includes a 60-page booklet with the album's original liner notes, newly-written track notes, details about Sinatra's many visits to the U.K., and several photos of Sinatra in London: onstage, in the studio, and about town. The collection also has two exclusive art print reproductions of original London concert posters, and a unique studio panorama from the 1962 recording sessions for *Great Songs From Great Britain*.

THE WHO - QUADROPHENIA: LIVE IN LONDON

In 2012/2013, The Who embarked on the *Quadrophenia* and *More Tour*, performing their landmark rock opera in its entirety, marking the fortieth anniversary of the original 1973 release of this double-album masterpiece. The critically acclaimed and highly successful tour closed at London's Wembley Arena, with the cameras rolling, to record the closing night of this historic anniversary tour. MASSHEALTH  
\$35 MILLION IN VIOLATION

According to a an audit by the State Auditor's Office, MassHealth reportedly provided millions of dollars worth of coverage to both legal and illegal immigrants that violated state and federal guidelines. The audit uncovered that the state's Medicaid agency paid some \$35 million in claims over 18 months that did not fit the scope of its "Limited Program," which covers emergency care for non-citizens who met specific income requirements, including illegals who make up 89 percent of the 45,000 Limited Program members.

Mayor Marty Walsh recently announced that City Hall plans to spur construction of moderate priced housing on underused land along the MBTA's Orange and Red Lines in Jamaica Plain and South Boston by allowing developers to think about building larger residential buildings with fewer parking spots. In his speech to the Greater Boston Chamber of Commerce, he proposed that sections near the MBTA rapid transit lines be designed transit-oriented growth zones.

*Achtung!* A German trade association proposed making it illegal for bosses to call or email employees outside of working hours. Contacting workers after hours, said Labor Minister Andrea Nahles, “crosses a sacrosanct line in Germany between work and leisure.”

A New Hampshire woman, 21, was arrested on assault charges after she slapped her boyfriend during an argument over a game of Monopoly. She did not collect \$200.

Ex-mayor in Mafia probe: Gianni Alemanno, the former mayor of Rome, was placed under formal investigation for corruption and alleged ties to the Mafia. His house was searched and some of his associates were among dozens of people arrested in a big anti-corruption sweep. Alemanno, who was mayor from 2008 until 2013 and is an ally of former Prime Minister Silvio Berlusconi's, said he was “completely unconnected with any wrongdoing!” Authorities said they had uncovered a citywide network of corruption that linked Mafia members, politicians, managers of public companies, and even neo-fascist groups. Rome's criminal underworld operates separately from traditional southern Italian Mafias such as the Cosa Nostra, and it has been connected with far-right groups since the 1970s.

*What a stinking mess!* A woman was booted from a U.S. Airways flight in Hartford, Connecticut, after her pig stunk up the cabin. Rachel Boerner, 29, was allowed to board the craft with the 70-pound pig because she had it classified as an “emotional support animal,” that is owner needs to cope with stress. But as the flight prepared to take off from Bradley International Airport, the pig squirmed in the aisle and then pooped. The plane smelled “like a barnyard,” said an irate passenger. The woman and her hog were escorted off the plane. “I guess pigs didn't fly today,” said another passenger.

*Meow, meow.* The residents of New Castle, Pennsylvania, are struggling to figure out why their city suddenly reeks of cat pee. The mysterious stench was first detected in late October and has spread. “[it smells] like cat urine and potatoes, really putrid,” said Mike Kobbe, assistant city fire chief. “It burns the mucus membranes.” Investigators are trying to sniff out the source of the odor. “All trails,” said Kobbe, “lead back to the sewer system.”

In the past five years, law enforcement officers in Utah have killed 45 people — more than the number killed by gang members, drug dealers or child abuse. All the killings have been deemed legally justifiable.

Police in the U.S. make about 12 million arrests a year, and up to 80 percent are for misdemeanors such as loitering, public drunkenness and petty theft. Defenders rarely have lawyers and are usually found guilty or plead guilty, leaving them with a permanent entry in the FBI's criminal database.

## CASSATTEDI “ka-sat-ed-dee”

### A Sicilian Christmas Ricotta Cheese Turnover

- |                                  |                              |
|----------------------------------|------------------------------|
| 1 pound container ricotta cheese | 1/2 teaspoon sugar           |
| 2 cups flour                     | Pinch of salt                |
| 1 tablespoon orange rind         | Pinch of cinnamon (optional) |
| 3/4 cups water                   | 2 cups cooking oil           |
| 1 tablespoons red wine           | Additional granulated sugar  |
| 1/4 cup shortening or margarine  | 10-inch Teflon skillet       |

Place ricotta cheese in a colander to drain. Put flour in ten-inch bowl. Cut in shortening with knife and fork. Add sugar and salt. Mix while adding water slowly. Before using all water, work red wine into mixture. (Wine causes dough to bubble when fried). Continue mixing dough until it holds together and all flour is used. Knead dough to a smooth consistency. Separate into three portions. Roll each into a long piece. Cut roll into smaller portions approximately one-inch thick. Place in bowl and cover.

Transfer drained ricotta into bowl. Add orange rind, cinnamon and mix thoroughly by hand. With rolling pin, roll each piece of dough into paper-thin rounds. Place a tablespoon of ricotta in center of dough. Fold over (like turnovers). Press lightly around filling to allow inside air to escape. Then seal edges with crinkled pastry cutter or press edge with fork. Set aside on pastry cloth or a flour-dusted tablecloth. Makes about twenty-four Cassattedi.

Pour enough oil in a ten-inch Teflon skillet to cover bottom. Prick top of 6 Cassattedi at a time (with a pin) before placing in hot oil *top down*. When frying, turn each one with spatula until golden brown on both sides.

When any ricotta or fluid escapes into the hot oil, the liquid will splatter and burn. Remove Cassattedi from oil. Clean skillet. Add and heat new oil and continue frying remaining Cassattedi.

Place fried Cassattedi in a serving platter layered with granulated sugar. Sprinkle additional sugar on each one. Serve hot or cooled.

Leftover Cassattedi must be refrigerated.  
*Note: While I fry my Cassattedi each year with my daughters, my mind wanders back to the many times I stood with my cousins at Zia Marianna's black Glenwood stove on Charter Street. We waited patiently to sprinkle granulated sugar over our favorite Christmas treats. Then we served them to the relatives who gathered at the round kitchen table where we later enjoyed our Christmas Eve supper.*

# Nanna & Babbononno

A Nostalgic Remembrance



Christmas was for us kids. This meant a visit to Santa Claus and there was only one true Santa Claus and he could be found in the toy department of Jordan Marsh. New York had its Macy's and Gimbels located on 34<sup>th</sup> Street, but we had our own version of these two rivals on Washington and Summer Streets: Filene's and Jordan Marsh. At Christmastime they both went overboard preparing for December 25<sup>th</sup>. Filene's had the best window displays I had ever seen, mechanical mannequins with moving parts dressed for holiday cheer, American Flyer trains chugging away at their feet and lots of toys for kids of all ages. But, there was only one place to go to visit with Santa, the toy department at Jordan Marsh.

At one point in my life the toy department was located on the 4<sup>th</sup> floor and then it was moved up to the 5<sup>th</sup> floor. I don't remember the sequence or the years when this took place, but I do remember the toy department and that's what is important. Mom and Grace Manfredonia would plan to bundle me and the then three Manfredonia kids up, take the MBTA from Maverick Station in East Boston and exit at Park Street Under. Once upstairs and outside, we could see the trees of Boston Common all decorated with colored lights. A short walk across Tremont Street and a peek at the goodies in the window of S.S. Pierce, a specialty market back in the day, and then a short walk down Winter Street to the corner of Washington and Summer Streets and there they were, Filene's and Jordan's. John Manfredonia and I would push our ways through the people lined up in front of Filene's windows to see their displays. His sister, Adelaide and brother, Fred, were younger and stuck closer to Grace and my mother. Our observations were brief, as this was only the antipasto preparing the way for the delights that were forth coming.

The elevators were always crowded with waiting lines, and once inside, the operators would call out, "Floors, please." In unison, we kids would yell out, "The toy department."

Once outside the elevator, we were in one of America's largest toy departments and we kids would drag our parents to the biggest electric train display ever created to hypnotize a bunch of pre-teens. A display table that was about 50 feet by 50 feet would be in set up like a small suburban town, complete with down town buildings, small colonial homes, a pond with ice skaters, a waterfall at the head of a river, the local church and especially the local train station with a nearby freight yard. In constant movement

around the perimeter of the display table would be the local trolley and several trains all passing each other, heading through tunnels, going up and down hills, and as they passed one another, they sounded their horns, whistles and bells. We would spend almost a half hour with our eyes glued to the movements of the Lionel passenger and freight trains that came our way. When the freight trains stopped at the freight yard, many of them had mechanical parts that were operated to allow them to be loaded or unloaded and as the passenger train pulled into the open air stop in the middle of the town, we heard the constant clang of the bell that informed the tiny warmly dressed toy people that it was pulling in. What I also loved were the cars that were parked in the lot adjacent to the station. I loved cars even then. There were examples of cars from the '30s and the newest cars that arrived after WWII.

When we had enough of the trains, I would head to an area where they sold model airplanes, most of which were examples of the fighters and bombers we flew during the war. Models made by Strombecker were of hard wood and had to be sanded, assembled and finished. Other manufacturers made their models out of balsam, a soft wood that required some carving before the assembly process. I was a model-maker and would point out to my mother the planes I didn't have.

From there I would head to the Gilbert display. Gilbert made the Erector Set. These were pieces of metal in all forms and shapes that were screwed together to represent machines. All came with an electric motor that would cause an assembled design to function. I already had one of these from Christmas a year or two earlier, but needed things added to it to make it more advanced. The second to last stop was to the display of chemicals that accompanied a youth version of a microscope. I loved looking at things through Dad's microscope and this might be my version of Dad's if I asked for it.

The last step of the annual pilgrimage was the visit with Santa. Grace and my mother would round us up and get us squared away in the line that awaited the visit. Once it was my turn, I would stand next to Santa; answer the usual question, "Have you been a good boy this year?" and then begin to list the things I wanted him to bring for Christmas. I always had quite a list: more cars for my trains, a few model planes, additions to my Erector Set, an array of chemicals, slides for my microscope and maybe a Daisy Red Rider lever action

BB gun and/or a set of Roy Rogers cap guns, western revolvers housed in real leather holsters. I always received the same response regarding the BB gun, "I don't know about the BB gun, if you're not careful, you could shoot your eye out."

When I heard this dialogue in the film, *A Christmas Story*, years later, I knew that response must have been universal.

After the Manfredonia kids and I had visited with St. Nick, our mothers would tell us that it was time for lunch. We could have gone to several different places on Washington Street near where the movie theaters were located or we could have walked back toward the North End and indulged in Italian food that we could identify with, but this was a special occasion. The visit to Santa happened only once a year, so our mothers would march us back to Tremont Street and we would have lunch at the Thompson Spa, a rather upscale restaurant back in the day. Once seated, I prided myself on being the little proper Bostonian. Uncle Nick's first wife, Aunt Ada, made sure I had the social graces that she felt I would need in my life. As a result I knew how to order without anyone's help and, when the food arrived, which utensils to use as I ate.

Once we arrived at home, Nanna and Babbononno would ask me what I said to Santa. I was always a storyteller and would comment in detail on my conversation with the man. Babbononno would memorize what I wanted and later tell my father and uncles. I was the first born male in the family and this meant that whatever I wanted, I would probably get. Babbononno would instruct me to leave Santa a glass of wine before I went to bed on Christmas Eve. He intimated that most little kids would leave Santa cookies, but the ride in an open sleigh would have made him very cold, and a glass of wine would do the trick. I guess Babbononno's suggestions always worked. I would leave a glass of wine and a note for Santa, and lo and behold, on Christmas morning, just about everything I had asked for would be under the tree. Gotta go ...

**EXPO 2015 – MILANO, ITALY. SPECIAL INVITATION EXTENDED TO PAPA FRANCESCO.** The general manager of the Expo, Giuseppe Sala, has personally extended a solemn invitation to Papa Francesco to attend the forthcoming world event officially set to start on May 1, 2015. The Pontiff recently received a delegation led by the Archbishop of Milano, Angelo Scala, also present at the meeting with the Pope was the director of the Italian pavilion Diana Bracco. Cardinal Scala met the Pope first personally handing the Pope the special invitation along with director Bracco. The Pope quickly went over the invitation and was pleased to find on the invitation the theme of the Expo: “Expo Laboratory,” which emphasized “food,” a topic so dear to the Pontiff. The Pope also underlined the participation of the State of the Vatican at the Expo with a special “corner,” the Holy See’s pavilion. **A NEW ITALIAN PHENOMENON: LESS MARRIAGES ARE BEING CELEBRATED.** As males continue to live with their parents, people in Italy are getting increasingly reluctant to tie the knot, unless it is late in life, and after age 30. The data has been made public by the statistical Italian agency ISTAT, which has also made known the fact that males seem to act very prudently: they want to keep their assets “for themselves,” which in the South has a long tradition! They are less eager to leave Mom and Dad to have a family of their own.

The present trend began in 2012 when late marriages, about 15% of the total, were 30,724, or less than 4,000 than the previous years, more so in 2008. The mixed marriages, with a foreign-born partner, were 20,764 (2012), while marriages with an Italian spouse diminished (2012: 153,311), a trend that began in 1972. For the sixth straight season, and 12<sup>th</sup> in 14 years, the New England Patriots secured yet another division title in their 41-13 conquest of the Miami Dolphins at Gillette Stadium.

The Patriots used all three phases of their team in the win. With the offense once again struggling in the first half, for the second consecutive week it was the special teams unit that jumpstarted the team. The Dolphins were looking to culminate a success-

without allowing a touchdown. The unit got an added boost with the return of Chandler Jones, who picked up right where he left off. Jones registered 1.5 sacks, 7 tackles while forcing a fumble in his first game since injuring his hip versus the New York Jets on October 16<sup>th</sup>.

ful opening drive with three points, when Jamie Collins blocked Caleb Sturgis’ 41-yard field goal attempt and Kyle Arrington returned the ball 62 yards for a touchdown. “Jamie was able to shoot the gap with his athleticism and length and was able to time the kick and get his hand on the ball. It was really well executed all across the board.” Said Head Coach Bill Belichick.

Aside from a sputtering first half offense, a low point of the game for the Patriots was clock management at the end of the first half. Leading 14-6, the Patriots had the ball with 40 seconds on the clock. But Belichick and Coordinator Josh McDaniels seemed more concerned with having Miami use its three timeouts rather than pick up a first down or push for a quick score before the half. “Well, I’d say you can just put the whole sequence on me — bad coaching,” Belichick said. The Patriots did have the ball deep in their own territory, but the sequence of uninspired play calls, three runs totaling 2 yards were executed terribly by an underwhelmed group. When Miami got the ball with 17 seconds left, Quarterback Ryan Tannehill and Wide Receiver Jarvis Landry made the Patriots pay by connecting on a 32-yard touchdown pass that cut the Patriots lead to one at the half.

The offense got going in the second half, exploding for 27 unanswered points. The spark seemed to be the integration of Tight End Rob Gronkowski into the passing game, as he was used primarily as a run blocker in the first half, and a 17-yard run by Quarterback Tom Brady to setup a first and goal on the opening drive of the half. With a chance to avoid contact and slide after picking up a first down, Brady attempted to go for the touchdown. He lost that battle being slammed to the turf by Miami rookie Safety Walt Aikens, but would prove victorious by invigorating his team. “I could have slid, but I wasn’t in the best mood at that time,” said Brady, who isn’t exactly the most graceful runner in the NFL.

Dodgers Reportedly Get Rollins

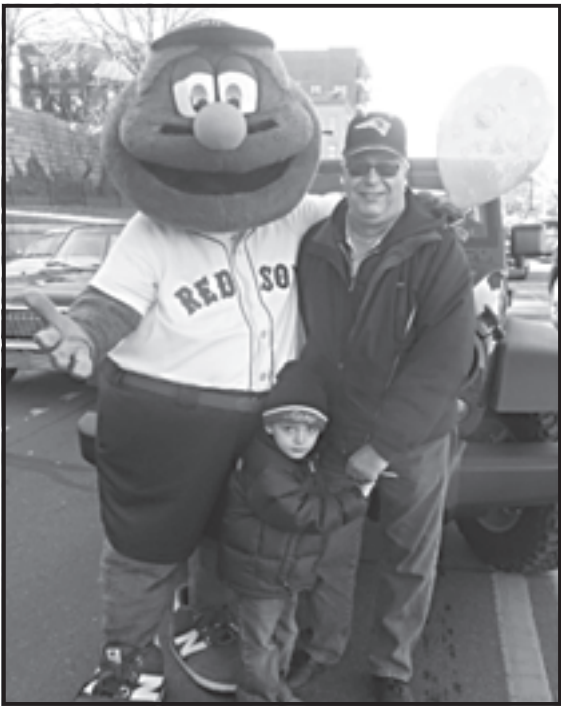

## Reflections Over the Past Year

I have been writing this column for a little over a year now. When Pam Donnaruma asked me to step in and take over the boxing column at the *Post-Gazette* I wasn't sure I would be able to handle it. After all, I had never done something like this before. I told her I would give it a shot. Well, over 50 columns later I am still here. It has been a wonderful experience writing about the sport I love and having my words seen by so many. While it is no secret to those who follow this column that I don't think much about what has happened to the sport in recent years, I do still watch it, though it can be painful at times to do so. I prefer to revisit fights of the past and to do my best to keep the history of this once great sport alive.

Another important subject for me has been the welfare of those who step into the ring. Earlier this year many of us saw a terrible tragedy unfold on live television as heavyweight Magomed Abdusalamov took a terrible beating in a fight that should have been stopped by the fourth round. With six doctors at ringside, commissioners in attendance, a referee, and Mago's cornermen attending to him, it was criminal that no one watched out for the fighter. Today, he is still in a nursing care facility. This is the dark side of boxing. A human being ruined for life so fans can have less than an hour's entertainment.

When I have written about the brutality of boxing, and make no mistake, it is a brutal sport, I have gotten a lot of positive reaction from people who have suggested ways to make it safer. I have also gotten blow back from so called experts who tell me I do not know what I am talking about, that I am a bigot (odd epithet considering mine is a concern for the wellbeing of all boxers), and that since I hate boxing (not true) I should not be writing about it.

Boxing has been a part of my life since I was a little kid. There has always been a fascination for me in seeing two well-trained and skilled athletes square off in competition against each other. There is no bench for them to rely on. When that bell rings they are on their own. It takes incredible courage to climb between those ropes. I was thinking about this courage as I listened to an internet commentary during

the recent Manny Pacquiao/Chris Algieri bout. During this broadcast a former world champion boxer was strongly implying that Algieri lacked guts. Now I know that quite often fans will yell out that the guys in the ring are bums. One of my favorites is when some fan who has had a belly full of beer yells out, "He doesn't like to get hit!" as if that is some type of a human

weakness. But in this case it was a former boxer making these remarks. I can't remember another instance where a former champ has impugned the courage of a fighter while that fighter was

look back in time and view many of the great fights and fighters of the past. Being able to sit back and watch these bouts carefully has allowed me to truly appreciate how great so many of these boxers were. Make no mistake about it; boxing was an art form. Watching champions like Robinson, Louis, Conn, DeMarco and so many others is like going to an art museum and seeing the works of the great artists of the past. Also, getting to see those who never won a world title, men such as Gaspar Ortega, Joey Archer, and George Benton reminds me of how many talented fighters were competing in that Golden Era. Each time I watch one of these fights I see and learn something new. That is the very definition of great art; the fact that it is timeless and always filled with something undiscovered.

I would like to close by thanking two people who have had such an influence on my view of boxing. First I would like to mention Mike Silver, the author of the finest book written on boxing "The Arc of Boxing." I have spoken with Mike countless times about a particular boxer or fight. Often I will call him up with some thought I have about a long ago bout, and he is always there with incredible insight. I have learned so much from Mike.

The other is Dan Cuoco. Dan is the leading boxing historian in the world. He is also the Director of the International Boxing Research Organization (IBRO). Dan meticu-

lously researches and updates the records not only of just former champions, but of any boxer who has ever stepped into the ring. The boxing world can never repay the debt owed to Dan. Without his work I would not be able to write many of my columns.

## HOOPS and HOCKEY in the HUB

Perhaps it was just another game in a very historic series. One view might be that it was just another game between two teams that have fallen on hard times. Perhaps for many across America, it was just a game to overlook.

But when you stop to pause and think about it there always is something special about the only two original NBA teams still playing in their original franchise cities that has a ring to it.

Yes, pro basketball has changed a lot since the NBA came into existence in the late 1940s. But one thing you could count on over the span of all those years was that the Boston Celtics would play the New York Knicks several times during each and every one of those seasons.

And thus it was that the New York Knicks paid their first visit of the season to the Garden on the second weekend of December. It was the 456th game in the historic series that saw the Celtics enter the contest holding a commanding 278-177 lead in the head-to-head matchups. That translates into a .611 winning percentage in favor of the Green.

Last year the teams split the four games between them with Boston winning the first two and the Knicks taking the second pair. The meeting was the first since March 12 when the Knicks dominated the Celtics to a tune of 116-92 at the Garden. That win extended the Knicks winning streak to five at the time.

Fast forward nine months later and both teams came into the game in somewhat of a desperation mode. Although both franchises are both remembered for their glory years, this season is not shaping up to be one of them for either squad.

New York came to Causeway Street in the throes of a 10-game losing streak and the possessors of a very weak 4-20 record. The Celtics came out of the tunnel and onto the floor at 7-13, fresh off a three-game win streak that had ended four days earlier in a double overtime loss at Washington.

It was a game that both teams sorely needed to win. For the Celtics, it would be evidence that the ship was beginning to come around and starting to head in the right direction. Plus, it would also nudge the Celtics upward a bit for — believe it or not — they (as well as several other teams with less than outstanding records) are still in contention for a playoff berth in the very weak Eastern Conference.

But it was not to be for the C's as the Knicks came away with a 101-95 victory. It was only New York's second win of the season on the road to go with a previous 11 setbacks away from Manhattan.

This one was a little different in that the Celtics came back from an 11-point defi-

cit in the middle of the third quarter to come within two points at 75-73 with 11:15 remaining in the fourth.

But then the Knicks took off — like so many other visiting clubs this season — and poured in nine consecutive points and the Green found themselves trailing by 11. It soon became 15 with just under six minutes remaining.

Jeff Green tried his best to get the Celtics back into it by scoring 14 points of his game-high 28 points as the final minutes ran down but in the end the scoreboard told the tale of another sad Celtics setback.

Indeed, the Celtics led the Knicks in several categories, including points in the paint (48-36), second chance points (20-11), assists (28-26) and fast break points (16-15), but it is the big numbers on the Jumbotron that count the most and those are the ones where the Celtics came up short.

Part of the reason that occurred in this particular contest was that the Knicks took big-time advantage of the Celtics 18 turnovers — by scoring 19 points on such opportunities. Another was the fact that two key Celtics players — Jared Sullinger and Rajon Rondo — were held down by the Knicks. Rondo had only two points while Sullinger didn't score at all.

So, when it all was said and done, it was time to leave the parquet in silence once again.

"First of all, I always want to recognize that the other team played well," said Celtics Head Coach Brad Stevens in his postgame press conference. "We all know they are going to be better than their record when all is said and done because they've got good players. Plus, they were playing very urgent tonight."

And Stevens indicated that is the way the Celtics must play from here on.

"We have to play that way," he explained. "In basketball at this level or any level, the minute you feel sorry for yourself it is going to snowball on you. You have to earn things, you have to go out and do them. The next game is an opportunity and we have to go out and seize that. But if we don't play well, we won't. If we don't play well, we don't win."

Three nights later the Celtics went out and did seize the opportunity. It came on the road against the lowly Philadelphia 76ers, but it sure felt good as the C's posted a 105-87 victory on the strength of Kelly Olynyk's career-high 30 point performance.

It was the C's eighth win of the season putting Boston in 10<sup>th</sup> place in the conference standings — only a game and a half behind Brooklyn. Maybe, just maybe, there's more to this season than we thought.
