

MORE ABOUT THE VESTALS

Evidence of the luxurious lifestyle of the Vestal Virgins has been gained from the remains of the "Atrium Vestae" (House of the Vestal Virgins), with its spacious court, splendid decorations, baths, and hot air flues. They were granted the privilege of keeping horses and carriages, and when in

public they were preceded by a lector who cleared their way. Their presence was expected where no other women, as a rule, might go; such as places of public amusement, the Circus, the theatre, and even the amphitheater where the best seats were permanently at their command. The only superior whom they acknowledged was the "Pontifex Maximus" who representing the kind of the ancient village, had a parental authority over them and who alone was responsible to administer corporal chastisement if any Vestal neglected her duties.

There were only two offenses which could normally be brought against them, and these were most rare. The first offense was to neglect the sacred fire, so that it became extinguished. For this kind of carelessness, the Vestal was scourged by the Pontifex. The second

offense was to violate her vow of chastity. Those found guilty of this act were carried on a bier to the Campus Sceleratus, near the Collins Gate, beaten with rods, and buried alive. Her seducer was also rewarded by being scourged to death.

Vacancies in the ranks of the Vestals were always filled by girls under ten years of age, and each in turn retired at the age of forty.

Every girl possessing the qualifications necessary was liable to be called on to undertake the duty, and no exception was granted, except upon very strict conditions. The age limit to qualify for selection was not less than six and not more than ten years of age, without personal blemish, of free, respectable family whose parents were still alive and residing in Italy. Twenty girls were nominated by the Pontifex, and the final selection was made by lot.

The selected candidate was immediately taken to the Atrium Vestai, her new home, properly attired, and shorn of her hair. Her time of service was set by law at thirty years; ten for learning, ten for performing and ten for teaching.

There was always a variety of ages in the household of

the Vestals. There was the little girl with close-cropped head, running around the garden or up and down stairs, learning her duties in bits and pieces, for she had a long time to learn them. Then there were those in their twenties, by now well acquainted with all of this luxury, social consequence, political influence, and freedom of action. Lastly of course, there was the oldest of the group, with all of the years of accumulated honor and the distinctive title of "Vestalis Maxima". At the end of their thirty years of service, leave was granted to lay aside their priesthood, return to private life, and marry if they desired. What else can be said, other than "Figlio maschile e cento anni" (May you have lots of male children and live to be a hundred years old).

Judge Obama by the Company He Keeps

In this State of the Union Address, President Obama called on Congress to give him Trade Promotion Authority in order to complete his ambitious negotiations toward a free trade agreement with several Asian nations. The deal, which will grant special privileges to the beneficiary countries, is called the **Trans-Pacific Partnership** ("TPP"). You probably haven't seen or read much in the news (outside of this column) about TPP because, the elite in Washington and in the media know that if Americans knew about this deal they would overwhelmingly oppose it.

Let's look at three of the nations that Obama has picked out for special favorable treatment in TPP.

Malaysia, an Islamic state, where earlier this month the highest court in the land affirmed a ban on a Catholic publication using the word "Allah." Christian Bibles have been confiscated, also due to the use of the word Allah. Allah, is the common word in the Malay language for God, and has been used by Christians and other non-Muslim groups for centuries.

Brunei, which has been under martial law since 1962, is an Islamic state where most criminal activity is defined and punished according to draconian Islamic sharia law. According to the U.S. Department of State—

The [Brunei] Ministry of Education requires courses on Islam and prohibits the teaching of other religions. Private Christian schools were not allowed to give Christian instruction to Christian or Muslim students but could offer voluntary, Islamic instruction to Muslim students. During the year the government warned Christian schools that they or their personnel could be fined or imprisoned for teaching non-Muslim religious subjects That same State Department report says of **Vietnam**

The Socialist Republic of Vietnam is an authoritarian state ruled by the Communist Party of Vietna. During the year the

government increased its suppression of dissent, arresting several political activists. Several editors and reporters from prominent newspapers were fired for reporting on official corruption. Police commonly mistreated suspects during arrest or detention. Individuals were arbitrarily detained for political activities and denied the right to fair and expeditious trials. The government continued to limit citizens' privacy rights and tightened controls over the press and freedom of speech, assembly, movement, and association. Violence and discrimination against women as well as trafficking in persons continued to be significant problems ...

There are nearly 200 nations in the world. The U.S. currently has free trade agreements in effect with 20 of them. Of all the places in the world the President could pick for a new free trade agreement, wouldn't you know he would pick a repressive communist regime and two intolerant Islamic states. 

St. Jeanne de Lestonnac

Saint Jeanne de Lestonnac was born in Bordeaux, France on December 27, 1556 to a well-to-do family. Her father, Richard de Lestonnac, was a member of the French Parliament while her mother, Jeanne Eyquem, was the sister of the philosopher and humanist, Michel de Montaigne. She received a very good education growing up in a Renaissance atmosphere.

During this time, Calvinism was spreading through France, which adversely affected the unity of the

country. Jeanne's mother chose Calvinism and tried to convince her daughter to also join the Reformation. Nevertheless, Jeanne rejected her mother's pleas, remaining true to her Catholic Faith, with the support of her father and

Jeanne married Gaston de Montferrant at the age of seventeen and had 3 children, but all three died shortly after they were born. Later she had 5 more children, 2 boys and 3 girls. She was married for 24 years before her husband died. This marked a painful time in her life where not only her husband but her father, uncle and eldest son also died.

After her children were raised, at the age of 46, she entered the Cistercian Monastery in Toulouse, where her name was changed to Jeanne of Saint Bernard. She desired this life of prayer, finding great peace in it. She spent six months at the Monastery, but had to leave due to the fact that her health could not bear the austerity of that lifestyle.

At this time, Jeanne experienced an inner vision advising her what to do next: it was about a response to many young souls in danger of being lost. Jeanne knew that Our Lady was also helping her. She formed a group of women to perform acts of charity; they served those individuals suffering from the ravages of plaque.

Two Jesuit priests, Fathers de Bordes and Raymond, ssisted Jeanne in founding an order to counteract the heresies spreading through France. Thus was formed the Congregation of the Sisters of the Company of Mary Our Lady. The rule and constitution of the Order were founded on those of St. Ignatius and the first house was opened in the Holy Ghost priory at Bordeaux In 1608. Jeanne and her companions received the religious habit from the Archbishop of Bordeaux. Jeanne was elected superior in 1610.

Jeanne passed away on. February 2, 1640, many miracles occurred at her tomb. Jeanne de Lestonnac was beatified in 1900 by Pope Leo XIII and was canonized on May 15, 1949 by Pope Pius XII. Today her religious order is found in 17 countries throughout Europe, Africa, North America and South America. Saint Jeanne's Feast Day is celebrated on February 2nd. She is the patroness of widows, and those who have been physically abused.

L'Anno Bello: A Year in Italian Folklore

Lighting the Way Towards Spring

As I sit to write this article, the infamous blizzard of 2015 is raging outside. Snowflakes fall furiously, like the inside of a snow globe shaken by an overenthusiastic child. Snow drifts on my windows, bathing the rooms in an eerie blue-gray light. Outside, I can hear the distant hum of the plows working steadily to clear the roads. On a day like this, spring seems years — make that light years — away. However, as hard as it may be to believe, spring is certainly coming! Stores brim with sparkly hearts for Valentine's Day and lush green aisles of shamrocks for St. Patrick's Day. Winter coats, though we will still need to wear them for quite a while, get pushed to the clearance bins, and brightly colored skirts and bathing suits take their place. Four o'clock in the evening no longer means darkness, but rather the hazy beams of sunset. Even holidays are now heralding the beginning of spring. As we enter into the month of February, it is important to remember that the month begins with a holiday, prevalent in ancient Europe, which marks the commencement of the season. Known as Candlemas in modern day and Imbolc in the land of its Celtic origin, this feast welcomes spring with light, fire and celebrations.

Candlemas, which occurs on February 2nd, honors the event of Jesus' Presentation in the temple by the Virgin Mary, which occurred Forty Days after his birth. The term Candlemas derives from the prevalent use of candles in the religious ceremonies marking this feast, symbolizing the metaphorical "light" that Jesus brings to the world. The folkloristic origins of Candlemas, however, predate Christianity. The pagan Celts knew this holiday as Imbolc, a date which also functioned as the first day of spring. Some scholars theorize that the name Imbolc translates to "in the belly," and observed the lactation of cattle and the birthing of lambs which occurs this time of the year. Indeed, according to traditional European customs, decidedly spring holiday, laden with superstitions and folklore that set the tone for the season to come. Many



of these superstitions, hailing from agricultural societies, call upon spectators to observe the weather in order to glean clues about the nature of the year's springtime. A sunny Candlemas, it was said, presaged more winter weather to come, while a cloudy and chill day proclaimed an early spring. This is the root of Groundhog Day, the American holiday also celebrated on February 2nd, whose traditions were brought over by European settlers in the nineteenth century. These weather prognostications are further echoed in an Italian rhyme which declares: "Candelora col sole, tarde primavera," meaning "sunny Candlemas, late spring." As such, Candlemas traditions inspire us to look forward to the signs of the upcoming season as our ancestors did, cherishing the sight of newborn lambs or delicate flower shoots peeking out from under the snow.

Throughout Europe, modern visitors will find spring like celebrations on Candlemas, many of which honor the ever-growing sun. In France, the tradition food of the day is the crepe, whose round shape and yellow hue resembles the sun. In Italy, various Candlemas, or Candelora, festivities dot the peninsula, often absorbing other religious holidays as well. Despite their differences, these feasts share the common elements of welcoming spring with characteristic light and hope. Residents of Catania in Sicily follow their Candelora porate fire symbolism while fetes into the celebration Candlemas functions as a of their patron saint, St. Agatha, whose feast day falls on February 5th. Light displays illuminate the city streets, people parade

candles, statues and relics of Sant'Agata, and chefs display blessed loaves of bread and pastries in honor of the saint's status as protector of bakers. In Montevergine, Campania, candlelit processions commemorate gay rights and offer prayers for tolerance. Candelora in Naples, on the other hand, means huge street parties replete with bonfires and colorful fireworks that blossom against the dark latewinter sky, symbolizing the more prevalent sunshine to come. The day after Candelora is important in Italy as well. It is the feast day of St. Blaise, or San Biagio, an Armenian bishop who became the patron saint of throat and neck-related illnesses after he saved a boy who was choking on a fish bone. My father still remembers walking to the small church on the outskirts of Sulmona on blustery February evenings, when, after a service aglow with candlelight, the priest pressed two blessed candles against congregants' throats to ward off illnesses. These early February holidays, therefore, all feature light as a means of hope and a reminder of spring sunshine to come. This theme of light is so important that it maintains a huge role in the feast days of San Biagio and Sant'Agata, where the promise of spring is blended with healing powers (just as San Biagio protects against illnesses of the throat, Sant'Agata protects against maladies of the breast) to symbolize the seasonal purification of winter into spring.

Folk customs and holidays in Europe welcome spring around this time of the year. They know that though a bitter chill still seeps through the air and crunchy snow blankets the ground, spring will soon arrive in its brilliant, sunny glory. Candlemas constantly looks forward to the springtime and heralds the triumphant return of the season with its emphasis on newborn animals and the warmth of candles. St. Blaise's Day and St. Agatha's Day also incorencompassing rituals of purification — a spiritual spring cleaning, if you will. Whenever we feel blue about the wintry weather outside, and whenever we feel that the cycle of cold will never end, we should look to the message of these holidays and behold the promise of spring. For when we are confident in our hearts that better days will come, our cheer and our hope will turn into forces so strong that no snowstorms can blow them away.

Back then, in the Seventies, I was 20-something. Today, I am the age of the old guy, but even now I would never leave the crowd for a side road and a dinky shack.

In a great sense this was a movie about human beings acting like ants fleeing danger with little idea how to win. In the end, it is always instinct and good reason that

In this movie, if it wasn't for Bob Lansing, there would have been no movie or rescue.

When push comes to shove, when faced with danger, most of us turn on our ant-size brains and panic. This week's storm was Exhibit A. We live in Boston. It snows in Boston. Sometimes it snows a lot in Boston. However, the snow always ends and we survive until the next epic storm.

We are much bigger than ants but we run to supermarkets in a flurry of activity and act so much like a bunch of ants carrying off broken potato chips from a picnic basket at the beach.

The real ants down there looking up at us think we are so dangerous to them but in the end, most of the time we can't get out of our own way.

I can tell you this, after seeing this movie, I will never look at real ants again in the same way and nor will I so easily stomp on them either.

After-all, all of us live on the same ant hill and never know it. Even real ants don't fear the snow, only we do that ant-like thing.





did to the Colts. The New England offensive line will need to be stellar. Lynch's 1,306 rushing yards and 13 touchdowns during the regular season are further proof that the Seahawks offense is no slouch to their defense.





LO SAPEVATE CHE ...

Una vera rivoluzione chirurgica e' avvenuta di recente a Torino, all'ospedale "Le Molinette" nella citta' piemontese. Un nuovo tipo di pacemaker, di ultima generazione, e' stato impiantato direttamente nel cuore di un paziente di 83 anni seguendo una procedura non intensiva, usando un catetere guida attraverso una vena della gamba. Il nuovo dospositivo si chiama 'nanostin, non ha fili e dura oltre otto anni. Una equipe del dipartimento di cardiologia chirurgica della locale universita', e diretta dal professore Fiorenzo Gaita. Il nuovo miniaturizzato pacemaker e' grande quanto una caramella e rappresenta una significativa innovazione nel campo della cardiologia poiche' consente di evitare le principali complicazioni legate all'impianto dei pacemaker, piu' esattamente il danneggiamento e l'infezione degli elettrocateteri. Nonostante queste complicazioni e' stato possible salvare milioni di vite umane.

Lo sviluppo delle nanotecnologie ha ridotto le dimensioni del pacemaker, dai 100 grammi ai 20 - 30 grammi di quelli attuali dando inizio ad una nuova era nella terapia dell'elettro-stimolazione del cuore. Il pacemaker 'nanostin' e' talmente piccolo da poter essere posizionato direttamente nell'interno del cuore senza l'uso di fili di connessione con l'apparecchio esterno. Con tale procedura non e' necessaria alcuna incisione chirurgica della cute ne' ulterior cicatrici. Il professore Gaita ha spiegato che quando la batteria esaurisce la carica il pacemaker puo' essere recuperate con un apposite catetere, e sostituito.


dDID YOU KNOW THAT ...

A true revolutionary surgery has recently taken place in the city of Torino (Italy) in the "Molinette" hospital of the Piedmont city. A new kind of generation of the pacemaker has been implanted right inside the heart of an 83-yearold patient in a non-invasive procedure using a catheter inserted in a vein in the leg. The new device, called 'Nanostin,' is wireless and can last more than eight years.

A group of specialists in the cardio-surgery department of the local University, headed by Professor Fiorenzo Gaita, conducted the procedure. The miniaturized pacemaker is as small as a candy, and it signifies an innovation in the field of cardiology, for it makes it possible to avoid major complications during the installation of the pacemaker, and more so the damaging effects on the electro-catheters. Despite such complications (in earlier procedures) it has been possible to save millions of human lives. The development of nano-technologies has reduced the sizes of the pacemaker, from the old 100 grams to the 20-30 grams of the new ones, starting a new era of therapy in the heart's electrostimulation. The 'nanostin' is so tiny that can be positioned right inside the heart, without connecting wires into an outside machine. With such a procedure there is no need of any surgical incision in the skin or any lasting scar. Prof. Gaita has explained that whenever the battery is about dead, the pacemaker can be retrieved using a special catheter, and replaced.





GARTH BROOKS Hosts 'Garden Party'



Seventeen years have passed since Garth Brooks made his last visit to the TD Garden, which back then was named the FleetCenter. The name of the venue has changed, but the artist and the crowd remained the same, as Garth started off his six-show stay in Boston by coming close to blowing the roof off the Garden. The sold-out crowds came to celebrate his return, and he matched their enthusiasm with a top-shelf show. Earlier in the day at his press conference he was asked a

question about how his music had evolved. His answer was about the effect that the late country music singer/ songwriter, Chris LeDoux, had on his music, and how other artists evolved by each being inspired by an earlier artist.

In Brooks' case, he stated LeDoux was his inspiration, a country artist and a former Rodeo Champion whom Garth mentioned in his 1989 debut single, "Much Too Young (To Feel This Damn Old)," LeDoux was signed to Capitol Records in 1992, on the strength of Garth's recommendation. This particular song brought a standing ovation from a crowd that could've stayed all-night and listen to Garth sing. LeDoux passed away in 2005 at 56 years old.

Brooks continues to be a bundle of energy as he tours the country in support of his album, "Man Against Machine." Released in November, it is his first album of all original material in over a dozen years. His record-breaking 'World Tour' also allowed him the chance to perform a couple of songs from his new album, and to shower his fans with the songs they wanted to hear — his multitude of hits, and their favorites!

A thundering explosion and a one-minute countdown clock signaled the start of 'A night to remember,' as Brooks opened with the title song from his new album, moving quickly into his hit list. The first note of each song brought gasps and sing-along sounds from the crowd. Culling songs from his albums, he began with those from 'Ropin' The Wind' — delivering "Rodeo," "Shameless," "Papa Loved Mama,' and the moving "The River" — from his self-titled debut album. From his album 'No Fences' #1 hits dropped in the form of, "Two of a Kind, Workin' on a Full House" and "The Thunder Rolls." Brooks reacted strongly during his performance, often eliciting a look of surprise to the loud and constant applause that followed each song, taking much pleasure in engaging with the audience.

The love flowed easily between performer and his adoring audience when Brooks countered with, "The Beaches of Cheyenne," turning it up a notch for the first drinking anthem "Two Pina Coladas." The mood swings were like a roller-coaster as Garth mixed it up with "Ain't Goin' Down ('Til the Sun Comes Up)," then lowering the decibels for the thankfulness of "Unanswered Prayers."

Following the coming-of-age #1 winner, "That Summer," and "People Loving People," entering stage left was the woman Garth called 'his best friend,' his lovely and talented wife — Trisha Yearwood, wearing a T-shirt that boasted 'Late Night, Loud Music, and Backstage Passes.' Together they delivered the heartwarming "In Another's Eyes," as Yearwood took over the stage. Trisha proceeded to serve up a set that included, "XXX's and OOO's (An American Girl)," from her new album 'Never Giving Up.' She knocked out the crowd via "Prizefighter," followed by the emotional "How Do I Live," and ended her set with the upbeat "She's in Love With the Boy."

Brooks returned to the stage and resumed the festivities by dialing up the infectious "Callin' Baton Rouge," and then threw all caution to the wind by unveiling the ultimate drinking song — "Friends in Low Places," with the entire audience joining in on the vocals throughout the song. This led to two encores that featured. "The Fever" from his 1995 album 'Fresh Horses,' plus the tender "If Tomorrow Never Comes," also from his debut album. Brooks put the finishing touches on his diamond performance with the sizzling "Standing Outside the Fire," taken from his 1993 album titled "In Pieces."

A Nostalgic Remembrance

The minute the snow falls, the plows begin to roam the streets in Boston and all of the surrounding suburbs, clearing the main streets and most of the side streets. When I was a young kid living on Eutaw Street, Dad was one of the few people who owned a car. As time went on, there was a problem that developed. Everyone began buying cars, and at night, they were parked bumper to bumper, as close as possible to those East Boston threedeckers we lived in. During the snow storms, the plows were indiscriminate. They cleaned the streets with the snow both covering and blocking the parked cars. As a result, we had to dig ourselves out. When we did, we created spaces that had to be protected from poachers, invaders and interlopers. Your shoveled parking space had to be declared yours, your private property.

There were a couple of ways to protect your parking space. The most common method was to leave an old chair or two in the middle. If that wasn't possible, an ash barrel would do, or maybe two barrels with a two by four sitting horizontally from one to the other. Everyone in the neighborhood knew whose barrels or chairs were out there to protect the spots and they respected the unwritten rule, "You don't take someone's shoveled parking space."

Dad had to drive to work both day and night and when he, or we, dug his car out, an old barrel and a broken chair was placed in the spot and everyone knew that you didn't park in that spot. Dad would leave the shoveled out spot each weekday morning and head for the Sumner Tunnel. I would put the chair and barrel in the open space before I went to school. When he returned in the afternoon, his spot would be waiting for him. A short nap, dinner and a change of clothes later, Dad would lug his bass violin down the three flights of steps, situate the instrument in his car, pull out of the spot and I would, once again, place his markers out.

If anyone not knowing the routine tried to park in Dad's dug out location, neighborhood spotters would inform the rogue that they couldn't park there. Everyone respected this unwritten rule of winter parking, that is, until a new family moved in next door. They weren't from the neighborhood and were told about the parking situation. This didn't phase the man who headed up the family. He, finding a parking space with identifying chairs or barrels protecting them, would remove them and take the parking space. He was told not to continue this practice in a nice way, not once but three times. He claimed that if the spaces were vacated, they were up for grabs. After the third time, the men in the neighborhood told him that he had been warned. He laughed it off

A couple of times, anticipating Dad's return home, Babbononno would stand in the spot puffing on a stogie. If this renegade tried to park there, my grandfather didn't move. I heard Babbononno yelling at the guy in Italian one afternoon and ran outside to see what was going on. I had to explain to my grandfather that the man wasn't Italian and had no idea what he was saying. He switched to fractured English and yelled, "Dissa spot she reserva foh mi genero, my son-a-law. You no canna parka la machina, you carra in dissa place." The neighbor started to give my diminutive grandfather an argument, but he stood his ground and the man pulled awav.

Well, the spot was saved for my father and he was told of the incident when he returned home later that afternoon. A couple of hours later, he was dressed in his tuxedo and headed on his way to play with his band. I put the barriers out, as usual, and headed back upstairs. Later that night, when Dad arrived home, that neighbor's car was in Dad's spot and he had to drive around the neighborhood for an hour or so until he found a spot to park in that was not reserved. I heard him coming up the stairs as did everyone else in the house as he was swearing in several languages.

The next morning, the neighbor got in his car, pulled out of the spot and never made it to the middle of the street. The car's engine started clanking, made a large popping sound and stalled. The man tried to restart it but to no avail. No one would help him and he had to call a tow truck. By the time the truck arrived, all of the men in the neighborhood were standing on the sidewalk watching the car being towed away. No one said a word. After the car was out of the way, two of the neighbors put Dad's barrel and chair back in the empty

We learned, a day or two later, that somehow, the man's car was drained of all of its engine oil and the gasoline had become contaminated with sugar and sand. That was the last time we saw the car. No one ever said anything but, one night, the man got into an argument with his wife and you could hear her yelling at him telling him he deserved what he got. No one ever took credit for the happening and nothing was ever said about a car that leaked all of its oil, and somehow, received a supply of gasoline that contained sugar and sand.

For the remaining years that we lived in East Boston, everyone respected the unwritten rule about parking spaces that were reserved for the people who dug their cars out of the snow. When we moved, it was to a one family house in Belmont with a driveway that could handle our cars. By this point in time, I had a car, too. I was teaching in Boston, going to grad school and playing music at night. There was no problem parking, but something was missing, the thrill of living in an East Boston threedecker with parking adventures every time there was a snow storm.

Well, that's the way it was. Every time I'm back in either Eastie or the North End during the winter and see a parking space in a snow bank with an old chair or a barrel in it, it brings back memories of the old days.

Before I go, I would like to answer a question. Several people who have seen me since my hair has turned white ask me where I get my hair cuts. Well, I go to a shop in Arlington at 824 Mass Ave. Charlene Smith, the owner of Charlene's Barber Shop near Arlington Center has been cutting my hair now for a couple of years. So, if you like the way I look, give her a call and tell her I recommended you. In the mean time,

THE HISTORY OF ANIMATION:

Disney's New Direction

Animation was becoming less and less of a priority for Walt Disney after the war years. In part this was due to cost, as it would take the studio some time to regain revenue lost during the war (and many of the package features produced from the mid to late 40s failed to garner much of a box-office reward). Live-action was cheaper and Disney found he could still make rivet-

ing pictures with it such as Treasure Island (1950) and 20,000 Leagues Under the Sea (1954). His early experiments with considerable use of live-action footage (Song of the South, So Dear to My Heart, e.g.), proved to be good practice.

For a man who built his name, fortune, and never stopped reminding the world that it was all started by a mouse, Walt transitioned to live-action with relative ease. If there is one word. after all, that best describes Disney the man it's his ambition and desire to grow, which preceded any sentimental attachment to the art form that built his company. True, cartoons made him a household name, but they simply weren't enough to keep his studio afloat, especially as he was considering expanding.

In truth, Disney's live-action features reached neither the critical or blockbuster stature of the animated features, but because they were made at a considerably lower cost than the cartoons, they did return a profit, some, such as 20,000 Leagues Under the Sea and The Parent Trap (1961), having become family favorites.

Besides financial considerations, Disney also had ambitions beyond the animated

drawing or even film for that matter. The first was, in hindsight, a natural step forward: nature films.

Documentary shorts were already well established by the time Disney made Seal Island in 1948, a short capturing the life of seals in Alaska's Pribilof Islands. It was the result of a 1947 partnership between Disney and wildlife photographers Alfred and Elma Milotte, which won the Academy Award for Best Short Subject and launched the True-Life Adventure series, which brought wild footage to audiences in a way the movies had never done before. The most impressive of titles in the series, The Living Desert, The Vanishing Prairie, Secrets of Life, The African Lion, and White Wilderness, have stood the test of time. The cuddling presentation of some of nature's less pleasant aspects (predation, most of all) caused pause even then, but in terms of pure primal awe, the series was a trail-blazer.

But Disney had two bigger things brewing beyond the big screen. Ostensibly, one sounded smaller, moving to the small screen. But the Disneyland TV show captivated millions in the way Disney hadn't since the release of his first animated features. Starting in 1950,

studio's glory years alive. Disneyland's claim to television history was pioneering color TV with Walt Disney's Wonderful World of Color, but Disney solidified a strong television audience with The Mickey Mouse Club, Davy Crockett, and Zorro.

What no one saw coming was Walt's venture into the amusement park arena, and Disneyland changed the nature of parks forever. Anaheim, California, once a sleepy industrial town, was never the same as, indeed, was the concept of theme parks. Disneyland, I think, more than anything, is the true shrine to Walt Disney's mind, imagination, and ambition, the four lands in which the park is divided each encompassing a part of Walt's psyche. Fantasyland, distinguished by the iconic Cinderella's castle, is a tribute to his beginnings as the founder of an animation empire and work with fairytales. Adventureland to his fascination with nature. Frontierland to his most popular TV series (Davy Crockett) and love for classic Americana. And Tomorrow-land, a testament to his dreams and foresight for the future.

Of course, Disney never fully let go of animation. How could he after being immortalized as the creator of Mickey Mouse? Interestingly, his animated features from the early 50s were a return to fantasy but, after Cinderella, he demonstrated a particular attachment to British literature (Alice in Wonderland and Peter Pan). Only with Lady and the Tramp in 1956 did he return to the American small town. His cartoon shorts were coming to a close but even then he was trying new things and in shorts such as Melody and the Donald Duck vehicle Working for Peanuts, he cashed in on 3D animation. He was experimenting with these shorts as a warm-up for Sleeping Beauty, which he envisioned as his ultimate animated opus.

When Sleeping Beauty was finally released in 1959 it won plenty of praise for its use of Cinemascope and innovations but, as his costliest animated film thus far, it proved a box-office bomb, forcing Walt to once again reconsider the time and money devoted to animated films, partly explaining the slump in animation in the decade to follow.



Carnera vs. Baer



At first, it looked like Max Baer was on his way to a quick and easy win over the Italian giant. With knockdowns in the first and second rounds it appeared there was no way Carnera could last very long, never mind retain the title. But, things tightend up in the middle rounds. I know most people wrote Primo off as a manufactured champion, one who rose through the ranks as the beneficiary of fixed fights and handpicked opponents, and that now that he was finally in there with a real fighter who was not handcuffed he was being exposed as the bum he really was.

I would argue this fight did not prove Primo to be a bum at all. Instead, I believe it showed him to have the qualities of a very decent and courageous fighter. First off, if this fight is scored on a rounds basis, which it would have been back then, it was very close going into the final round with some saying the champion was even slightly ahead. Yes, the rounds Baer won he won big, but the other rounds were a different story. As I mentioned in part 1 of this column, Carnera was landing an effective jab on Baer and even hurt him a couple of times with jarring uppercuts. Was this because Baer was tired and catching a second wind for his final assault on Carnera? Possibly, but I think Primo earned Max's respect by absorbing his best shots and still carrying the fight to him. The right hand that Baer landed flush on Carnera's jaw in the first round would have left most men out cold on the canvas. Primo not only took it, but also showed more hurt was down to his pride then his physical being.

It also should be noted that there is credible evidence, as I cited in my previous installment, that the champion was fighting with a broken ankle and torn ligaments in his right leg. As I watched the clips of this fight I did notice that Carnera was unsteady on his feet at times, but it was not the unsteadiness of a fighter that was hurt from being hit. His movements were consistent with a person suffering from an injured ankle. If this is taken into consideration, it is not only amazing that he was able to continue as far as he did, but that he was also able to make a fight of it. A man that size with a damaged ankle in against a power puncher such as Baer had to have incredible courage and pride to carry on the way he did.

As the fight moved into the tenth round it was getting interesting. If it was true, as Commissioner Brown had charged, that Baer had not properly trained for the fight, then it could just be possible that Max would not have the endurance to last the final six rounds against his much larger opponent? Well, no, even though Primo started off the tenth round in winning fashion, Max had gotten his second wind and launched another furious assault on the champion, decking him three times in the last half of the round. The end was now near. Going into the eleventh round Max sensed victory and unloaded on Primo. He dropped Carnera twice and when Primo rose from the second knockdown, referee Arthur Donovan stopped the bout. Some people say that the champion signaled to the referee that he had had enough because of the way he gestured towards him, but I believe Primo did not cede the fight, and instead was complaining about Max hitting him on the back of the head.

It is often reported that Max Baer dropped Carnera a total of eleven times during the bout, but that number is in question as that would include the times the two boxers went down together while grappling. In those days there was no mandatory eight count, so there is no signal from the referee calling these knockdowns. I will say that at no time did Carnera think about not getting up. As a matter of fact, he let his pride get the better of him by not staying down and taking a count in order to more fully recover.

Whatever you may think of Primo Carnera's ability as a boxer, and I would argue that while he certainly does not rank up there as a great fighter, he has not been given the credit he deserves, he certainly had the heart of a great champion. He deserves much more respect then he has been given. He never quit in a fight, was always in great shape, and always came to win, and while he is often mocked for later going on to become a professional wrestler, I have been told by wrestling experts that he was a world class grappler. Again, he gave his all when he committed to doing

Primo is the only undisputed heavyweight champion not in the International Boxing Hall of Fame. I have been told this is because of the shady circumstances surrounding some of his fights and because of the characters that handled him. Well, if being around questionable characters disqualifies a champion from the Hall of Fame, then they better start removing people from it. After all, Don King is an inductee. Need I say

Primo Carnera was not a great champion, but he was a man who, despite the people around him, carried the championship with dignity. He is also the only title holder between Tunney and Louis to have defended the title more than once. Schmeling lost it in his second defense, Sharkey in his first, Baer in his first, and Braddock in his first. So, for those of you who judge fighters by the numbers, Primo, with two defenses before losing it, had the best record out of the whole gang. He was also the first and only native Italian to hold the crown. He deserves to be in the Hall of Fame.
