Supreme Logic Was Illogical

Back in 1978, the U.S. Supreme Court took up the issue of affirmative action in the case of California vs. Bakke, in which a court majority upheld admission policy at the University of California, Davis School of Medicine that they set aside 16 seats out of 100 for only minorities.

Justice Harry Blackmun ruled, "In order to get beyond racism, we must first take account of race. There is no other way. And in order to treat some persons equally, we must treat them differently."

Anti "Anti-Racist" Site Set Up for Parents

A Cornell Law School professor has launched a new website concerning the Critical Race Theory curriculum in hopes of educating parents about this ideology that focuses on race and this theory's impact on education. *CriticalRace.org*, created by William Jacobson set up a list of institutions of higher learning promoting CRT, which he describes as "a radical ideology that focuses on race as the key to understanding society and objectifies people based on race." This website was a six-month project by Legal Insurrection, a conservative blog run by Jacobson.

Community COVID-19 Vaccination Program in the North End and Charlestown with NEW Health

Boston's Historic Old North Church Will Serve As Clinic Site

NEW Health, a federally qualified health center and an affiliate of Massachusetts General Hospital and Boston Medical Center, is pleased to announce they started there Community Vaccination Program on Tuesday, Feb. 9th.

As part of Phase 2 of the Commonwealth's COVID-19 vaccination rollout, the health center is providing vaccines to eligible patients and residents of the North End and Charlestown ages 75 and older. Vaccination clinics have been established at the Old North Church in the North End and at NEW Health's Charlestown site.

Appointments are required and individuals must be registered with Mass General Brigham; individuals interested in making an appointment can reach the dedicated phone lines by calling 617-724-8725 for the North End location and 857-238-1141 for the Charlestown location, where they will be prompted to leave a message with their information and a patient service representative will call them back to schedule. Individuals who are not yet registered with Mass

General Brigham should call 866-211-6588 to register.

North End: Tuesdays 2:00 p.m. to 6:00 p.m., Thursdays 2:00 p.m. to 6:00 p.m. and Saturdays 9:00 a.m. to 4:00 p.m.

Charlestown site: Scheduled based on need and vaccine availability





THE TEMPLE OF VESTA

(The Best Little Virgin House in Old Rome)



Remains of the Temple of Vesta

Last week, we discussed the origin of the sacrificial fire, the candle-lit vigil, and the eternal flame. This week, we continue with a reminder that the sacred fire, the source of all life and power in ancient Rome, was kept alive in a structure known as the Temple of Vesta. It was constantly tended on by a group of virgin priestesses that were called Vestals (Latin, Virgines Vestales). They resided near the temple in the Forum Romanum. The whole concept goes back into antiquity when the Vestals represented the daughters of the primitive tribal chief, and they kept alive the State-fire in their father's hut. The public worship of this goddess was maintained in the Temple of Vesta during later years, but her private worship was preserved in every domestic hearth. After she was recognized as a personal deity, it then became fice with a domed roof that was necessary to have her attendants live in guarded seclusion in a structure that we now call "The House of the Vestal sky. The interior contained a

Virgins" or "Atrium Vestae."

The temple was a round structure, probably reminiscent of the tribal chief's hut. This edifice was the most venerated of all temples in Rome. Tradition tells us that the first temple to Vesta was built by Numa Pompilius, the successor to Romulus, and the first of the Sabine kings of Rome. He introduced the worship of this goddess, and devoted to her a space of ground just in front of his own house. It is also interesting to note that at this time in history, about 700 B.C., the king was the high priest, and in this office, he was known as "Pontifex Maximus" or "Pontiff."

There were at least five successive temples that were built in Rome to honor the goddess Vesta. They all adhered to the same style of architecture. It was always a small circular edisupported on columns. This design was thought to typify the round earth and the vaulted low circular altar, upon which burned the perpetual fire. The maintenance of this fire was the chief duty of six vestals.

Numa's temple stood for about three centuries until the Gauls burned Rome in 390 B.C. It was soon rebuilt and the second edifice stood for about 50 years. The third temple to Vesta stood until the great fire under Nero, and the fourth lasted for about 100 years. The remains, which now mark the consecrated site, belong to the last rebuilding by Septimius Severus (about 200 A.D.) and this work is contemporary with the great arch of Septimius Severus at the opposite end of the Forum from Vesta's temple.

RMV Launches New Safety & Educational Tools for First Time Drivers

Online Portal Provides Educational Resources. Materials and Safety Videos to Help Prepare For Passenger (Class D) Learner's Permit and Driver's License

New Practice Exams for Learner's Permit are Now Available; Massachusetts Drivers Manuals Can be Purchased Online

The Massachusetts Registry of Motor Vehicles (RMV) is announcing the availability of new resources and tools that individuals can use as they begin the critical process of learning how to drive safely and responsibly. A new informational online portal has been created to provide easy access to a variety of educational resources and materials that can be used to help guide first-time drivers, and parents and guardians of Junior Operators, through the detailed step-by-step process of securing a Massachusetts driving credential. The portal can be found at https:// www.mass.gov/quides/ first-time-driver-start-here.

The RMV is also for the first time offering online practice learner's permit exams, which can be accessed by customers through Mass.Gov/RMV or by logging into their myRMV account. Customers now can also purchase a copy of the Massachusetts Class D (Passenger) Drivers Manual and Commercial Driver's License Manual online using their myRMV accounts, instead of visiting a Service Center. Ordered manuals will be mailed to customers within 7-10 days of purchase.

"The RMV continues to look for ways in which we can support first-time drivers to ensure that the safety and educational tools they need are accessible and readily available," said Acting Secretary and CEO of Transportation Jamey Tesler. "Learning to drive is a serious and thoughtful process, and we are pleased to provide a great deal of materials and resources which will help ensure that new drivers are safe, successful and ready for the road."

"The RMV is pleased to offer these new valuable features and tools that can be used to help individuals learn how to drive safely and responsibly," said Acting Registrar of Motor Vehicles Colleen Ogilvie. "There are many critical steps included in this sensitive learning process, and the new portal and other resources, including the new learner's permit practice exams, will help ensure that individuals have access to key materials to support their understanding of the rules of the road, become fully prepared to drive and keep themselves and others safe."

Highlights of the key features of the new online portal are as

- 1. Steps to Getting a Driver's License - Information regarding the requirements for RMV learner's permits and road tests, and links that can be used to schedule appointments.
- 2. Parent/Guardian $\textbf{Information} \, - \, \text{Information}$ regarding Driver's Education Programs, the Parent Supervised Driving Program that provides a methodical approach to teaching requisite driving skills, and

Junior Operator License (JOL) requirements including details on certain motor vehicle citation penalties, which are imposed by the Junior Operator and the Safe Operator Law.

- 3. **Safe Driving Tips** Links to educational YouTube videos that highlight MassDOT's "Scan the Street for Wheels and Feet" campaign which addresses specific roadway safety topics such as being cognizant of pedestrians and bicyclists, mirrors and blind spots, and a "double threat" when pedestrians are crossing multiple lanes of traffic that are heading in the same direction.
- 4. Studying for Learning's Permits and Road Tests -Links to helpful practice exams for learner's permit exams and the option to download the Massachusetts Driver's Manual at no cost or purchase a hard copy of the manual which will be mailed to the customer, informational videos to become familiar with maneuvers that are evaluated during road tests, and links to specific requirements for applicants and sponsors.
- 5. Time to Take Your Permit - Links to the learner's permit application process, detailed instructions for taking the exam online, and alternative options that are available to take the exam.

I always carry a tune in my head thinking about these guys who were fated to die so prematurely, which went like this, "The sun was out, the sky was blue, but my heart was blue. It's raining, raining in my heart."

If you haven't found the new WMEX Boston on the same old 1510 spot on the AM dial, you are missing out on some great old music that never gets too old to hear.

L'Anno Bello: A Year in Italian Folklore From Cupid to Carnevale

Obviously, advice on gatherings and reunions contained within are not applicable to this current time when social distancing (and mask wearing!) is the best practice. Please read these articles as a testament to the joy and love that imbues Italian celebrations — and as suggestions for ways to spend time in the future once this pandemic is finally over.



When winter snow blankets the ground like an overstuffed duvet, it is hard to believe that spring is on its way. However, the signs of the approaching season unexpectedly fill the corners and nooks of our world, waiting like unwrapped presents for those who search for them. Bathing suits and T-shirts and pastel summer skirts wink at me from the store aisles. The sun remains for a longer time in the sky, spreading its golden light from between the trees in my backyard. And of course, you cannot step into a shop without seeing walls of red and pink hearts for Valentine's Day. Indeed, I like to call this upcoming week an introduction to spring due to the presence of two spring holidays within its days. St. Valentine's Day occurs on February 14th, with Mardi Gras, the great feast of abandon that signals the end of the Carnival season, quickly following on Tuesday, February 16th. Collectively, these holidays celebrate the beginning of spring by emphasizing the love and brightness that will carry us through the cold winter evenings into the days of bright sunshine. The ancient folklore and customs associated with these feasts, from Italy and around the world, honor the unique celebrations that define these holidays while also placing them in the more general category of welcoming spring.

St. Valentine's Day is one of my favorite spring holidays, because it is a chance to indulge in chocolate and whimsical decorations of bright red hearts and pudgy Cupids. I always eschew fanciness on St. Valentine's Day, instead preferring to focus on homey touches that create a cozy and sweet holiday atmosphere. I bake my red velvet brownies, replete with a scrumptious cream cheese swirl, for this day, and decorate my door with a wooden heart wreath. I not only celebrate with my husband, but make sure to pass along Valentine's Day greetings to my family and friends as well. For Valentine's Day is a holiday honoring love in all its shivering, splendid forms — by only limiting the celebrations to romantic love, we miss out on such activities as homemade cards to your parents or sharing conversation hearts with your best friend. In

addition to commemorating all angles of love, St. Valentine's Day also functions as a herald of spring. All the flowers prominent throughout the festival, from scarlet roses to delicate white snowdrops, remind us of the vegetation that blooms throughout the Earth as spring approaches. In fact, Valentine's Day may have its origins in the ancient Roman feast of Lupercalia, a festival of purifi-

cation and fertility celebrated on February 15th. The other origin of St. Valentine's Day also stems from Italy - Saint Valentine, or San Valentino in Italian, performed secret weddings after the Roman army forbade its soldiers to marry, thus cementing his reputation as a romantic. Other Valentine's Day folklore further emphasizes the connection with spring. A famous superstition advised unmarried girls to look for the first winged creature seen upon waking, as it offered a clue to the profession of her future spouse - a bat meant that she would marry a baseball player, while a robin heralded a sailor. According to medieval calendars, birds began choosing their mates on February 14th, a harbinger of the rebirth of the natural world to come!



Mardi Gras is another holiday which has always excited me for the upcoming spring. Literally translated to "Fat Tuesday" in French, Mardi Gras serves as the last day for riotous feasting and overindulgence before the austere period of Lent begins the next morning, Ash Wednesday. I remember childhood Mardi Gras parties held at my local church, where we would wear beads and masks in the traditional New Orleans colors of purple, green and yellow, and play a number of crazy games the sillier, the better! In truth, Mardi Gras is simply the last day which culminates the whole period of Carnival, the raucous preparation for Lent that begins on the Epiphany. In Italy, this period is known as Carnevale, which some scholars speculate derives from the Latin words "carne vale"; that is, "farewell to meat," since that was customarily a forbidden food during Lent. The foremost Italian proverb for this season states that: "A Carnevale, ogni scherzo vale,"

or that every joke is fair game

Italy is known for its gleeful abandon and its age-old celebrations that vary from city to city. In Venice, Carnevale is classy and mysterious, with participants floating gracefully in famous masks depicting characters from the olden style of Italian theater known as commedia dell'arte. The people of Viareggio in Tuscany hold a parade with floats poking fun at politicians and celebrities, a throwback to the times when dissent was only permitted through the veil of jest. In the city of Ivrea, Carnevale is celebrated with a huge orange fight that mimics an event in the town's history! My grandmother grew up in the countryside of southern Italy and remembers quaint Carnevale festivities where disguised neighbors would travel from house to house entertaining the residents with songs and jokes. She would also bake cenci — deep-fried ribbons of dough also known by appropriately whimsical names such as bugie (lies) and chiacchiere (gossip)! Carnival feasts may have started as spring festivals to chase away the darkness of winter. Indeed, a traditional Mardi Gras food, the pancake, honors the sun with its golden color and round shape. That is why this holiday holds such a special place in my heart. It reminds me that fun and laughter is effective enough

to melt even the most stubborn of winters! This week, we

have two great opportunities to welcome spring with joy, love and open hearts. On St. Valentine's Day, we can give thanks for the love which has sustained us

throughout the dark winter, while staying optimistic about the arrival of spring as we glance at the flowers and hearts and birds that surround us. Meanwhile, we can chase away the winter blues on Mardi Gras, letting an eternal spring bloom inside us as we lift our spirits with laughter and a zest for living. There are many small ways to honor these holidays, whether it is taking a bite of King Cake on Mardi Gras or exchanging a card with a loved one on St. Valentine's Day. What matters the most is that we stay attuned to the wider message of the holidays, that of accepting both the literal and metaphorical spring inside us, and welcoming each new, brighter day with unlimited hope, love, optimism, and, of course, laughter.



The Memorial Shrine to golf caddies that attended Maplewood Golf Course in New Hampshire has been listed on the New Hampshire's register of historic places. This shrine is a tribute to all the North End young adults that attended Caddie Camp at Maplewood.

This August 2020 photo shows The Our Lady of the Fairways shrine along Route 302 near the Maplewood Country Club in Bethlehem, N.H. The shrine is eligible for placement on the New Hampshire State Register of Historic Places. A new listing on the New Hampshire State Register of Historic Places commemorates generations of golf caddies who attended camps in New England.

The Lady of the Fairways Shrine in Bethlehem, near the Maplewood Golf Course, was built in 1958 to memorialize the caddies. The shrine's design includes a marble Madonna statue set in a brick grotto.

The shrine "is both a symbol and a cultural expression of the importance the camps had in the state," the division said in a news release Thursday.

The *Caledonian-Record* reported that in 2015, a caddie camp alumni reunion committee installed a plaque at the site, reading, "To the traveler along this way ... to the weary who would pause along the way to rest ... to the family or group or party that would linger to rest and pray ... to any and all ... this roadside haven is dedicated with the hope that its beauty and serenity shall be as a warm handclasp of a friend to a friend."

Testing Leftover Seeds for Viability

The beginning of a new year finds many gardeners preparing for the growing season ahead. Clearing space to start seeds indoors, inventorying seeds and supplies, and ordering seeds, plants, and more are usually part of the process.

While organizing, you may uncover seeds from past seasons. Do not discard these just yet. When seeds are stored properly, many can last from one to five years or more.

Seeds stored in a cool location like the refrigerator in an airtight container maintain their viability best. But even those stored in less-thanideal conditions may surprise you. Older seeds may still sprout once they pass their average life expectancy, but you are likely to see a reduction in the success rate.

The type of seed also influences how long seeds can be stored and remain viable. Start by checking the expiration date on the seed packet. Onions, parsley, and parsnip seeds usually last one year. Corn, okra, and peppers two years; beans and peas for three years; tomatoes, turnips, beets, chard, and watermelon four years; and Brussels sprouts, cabbage, muskmelons, radishes, and spinach last for five years.


The same principles apply to saved flower seeds. Marigold and zinnia seeds can maintain good viability for two to five years; ageratum, nasturtium, sunflowers, and yarrow for three to five years; monarda four years, and calendula for four to six years.

But the longer you grow plants, the more likely you are to push the limits. This often results in unexpected success or valuable insight for future gardening endeavors.

When in doubt use this quick-and-easy test to see if your seeds will sprout. Place ten seeds on a damp paper towel. Roll up the towel with seeds inside, place in a plastic bag and store in a warm location.

After a week or so, unwrap the paper towel and check the seeds for sprouting. If nothing has happened, rewrap the seeds and wait a few more days.

If all the seeds have sprouted, you have 100% germination and can plant the seeds as recommended on the package. If only half the seeds

sprout, for example, you will need to plant the seeds twice as close together to compensate for the lower germination rate.

The sprouted seeds can be planted indoors or out depending on the time of year, available space, and your climate.

If none of the seeds sprout, consider breaking out the glue and getting the family involved in turning these leftover seeds into works of art. Select a variety of sizes, shapes, and colors to create your masterpiece on wood or heavyweight card stock. Large seeds like beans, peas and corn are easy for crafters of all ages to handle. Use tweezers for finer seeds that add detail and texture to your creation.

Testing seeds now can help you save money when placing your seed order. You can focus your planting budget on new seeds and supplement with your existing inventory.

Michael Iwene Tansi was born in 1903. His parents were poor farmers; they were not Christian. After the death of his mother, his father, Tabansi, married again. He and his second wife had four boys and one girl.

When Iwene was a young child, he became permanently blinded in one eye as a result of a mud-fight with other children

His father sent Iwene to Holy Trinity School in Onitsha, which was run by the Holy Ghost Fathers. Tabansi meant for his son through education, to lead the family out of poverty. Iwene was baptized on July 7, 1913 with the Christian name of Michael. Upon graduating, he became a teacher from 1919-1925. Later, he became headmaster at St. Joseph's school in Aguleri.

Michael, feeling a call to religious life, attended the seminary at Igbariam from 1925-1937, there he developed a particular devotion to the Sacred Heart of Jesus and to the Blessed Virgin Mary. His family objected to his decision but he felt he wanted



rather than choose some other vocation.

Michael was ordained a priest of the Archdiocese of Onitsha on December 19, 1937. He lived a very austere life in comparison to the other priests around him. He built his own home using adobe, mud brick or other traditional materials. He would eat even poorer food than what the local people ate, surviving on tiny portions of yam. He sometimes had a motorbike provided to continue in the seminary to him, but he often preferred

to use a bicycle or even just to walk.

His belief in the value for the whole Church of the hidden life of prayer in a contemplative Order, led Fr Tansi in 1950 to join Mount Saint Bernard Abbey in England.

On becoming a Cistercian monk, he took the name Cyprian. Fr Cyprian worked in the refectory and bookbindery. The transition to Mount Saint Bernard and the Cistercian life must have been difficult for him, but what always made him remarkable was the iron strength and tenacity of his will which was, from boyhood, directed entirely towards God. No tragedy or trial could weaken his complete trust in God's providence. He used to say, "if you are going to be a Christian at all, you might as well live entirely for God". Fr Cyprian died in the Leicester Royal Infirmary as a result of arteriosclerosis and a ruptured aneurysm. He was beatified by Pope John Paul II on March 22, 1998, in Nigeria. The Feast Day of Blessed Cyprian Iwene Tansi is January 20th.

Nanna & Babbononno

A Nostalgic Remembrance



Easter Sunday is on April 4th this year and I pray that the coronavirus is history by then, we'll see. I have always loved Easter for many reasons. First of all, I grew up Catholic, and went through the teachings of the Catholic Church like most Italian Americans, and was proud of my faith and my family that always attended Mass together when holidays like Easter and Christmas brought them all together.

For the members of my family, Easter Sunday was the holy day, when you dressed in your newest clothing when you attended Mass. I don't know if dressing for Easter is as important these days as it was, let's say, when I was a kid. When I attend Mass now, I see people dressed in clothing I wouldn't wear unless I was going to work underneath one of my antique cars. I guess times have changed.

Back when Nanna and Babbononno were young parents and my mother and uncles were kids, you dressed for Mass every Sunday. Just prior to Easter, it was time to outfit the kids with something new. If there was money left over, Nanna and Babbononno might be seen taking the kids to Easter Sunday Mass wearing their new clothes, also.

It was 1925, and Easter was going to fall on April 12th that year. Nanna and Babbononno decided that the kids were all going to be fitted with new clothing around the beginning of March and led the way walking from Eutaw Street to Central Square. Central Square in East Boston has always been a mecca for retail stores. The department store Babbononno liked was Goldenberg's. He had bought clothing from the Goldenberg's for Nanna and the kids in the past and liked the quality they sold and also liked the fact that they employed people who spoke Italian. (My mother would someday work at Goldenberg's as a saleslady.)

First would be my mother who was sixteen years old. She was fitted for a new dress, stockings, and a cloche hat that was popular with the young ladies in the mid-twenties. Next came Uncles Paul, Nick, and Gino ... they would need new suits. Uncle Paul was almost an adult, but still in school. Uncle Nick was about eleven and Uncle Gino, seven. One of the Goldenberg brothers waited on them helping the Contini boys try on new suits. Each tried on a suit that was a different color, but the same style as the rest,

three-button, single-breasted, worsted wool. Once all three of my uncles were examining their new clothing in the three-way mirror in the men's department, Mr. Goldenberg, with a smile on his face spoke to Babbononno, "Just think, your sons can walk to church on Easter Sunday with these magnificent suits that only cost fifteen dollars each." Babbononno smiled with a look of semi-approval on his face. He discussed the price with Nanna in Italian with the salesperson looking on. The salesman, one of the Goldenberg's, called out to his brother who was helping another customer, "Just look at how well these suits fit the boys in this family." The brother looked at my uncles and my grandparents and then at his brother who was trying to make the sale. He yelled back, "The suits look custom-made on those boys. You would never know that they only cost twenty dollars each." Nanna turned to Babbononno and said in Italian, "Ecco il discorso di vendita;" (Here comes the sales pitch), he will yell back to his brother that he made a mistake on the price he gave us, and couldn't retract it." Then Goldenberg told Babbononno what a bargain the family was getting." Then, he yelled back to his brother, "I made a mistake on the price. I told these nice people the suits were fifteen dollars each and can't go back on my word. We will have to take the loss." Babbononno thanked Mr. Goldenberg, but added (in broken English), "Thank you for the bargain and being so honest. I will definitely take the suits if you add in a white shirt, a celluloid collar, and a new necktie for each of my boys. Mr. Goldenberg yelled something to his brother in a language neither of my grandparents understood. A customer who walked by them evidently understood Yiddish, the language the brothers were speaking, and whispered to Nanna, "They just said yes to one another in my language. You are definitely getting a bargain."

So, at the beginning of March in 1925, the Contini kids were outfitted for new clothing for Easter Sunday and beyond. A corollary to this part of the story ... about a year later, my mother would go to work at Goldenberg's as a saleslady. They actually paid her extra because she spoke several dialects of Italian and could serve their customers who couldn't speak English, a feat no one on their payroll could do.

The one negative part of this

story is that Babbononno made my mother quit school to go to work. She wanted to finish high school, but my grandfather didn't think women needed education. He agreed that they should know how to read, write, and count, but beyond this, it would be a waste of time. (He was born in 1875, and thought his sons should go to school and learn whatever trade they liked, but his daughter; she should go to work to help support the family, and save some money for when she would get married. Actually, my mother was quite good with math. She could look at an addition column with about seven or eight numbers across and ten or twelve down and immediately give you the answer. When Babbononno wanted her to quit school, she pointed out that his paesano, Mr. Jannini, let his youngest daughter, Rose, go to college and medical school. Babbononno's out was that Mr. Jannini didn't have any sons, so daughter, Rose, would take the place of a son. He would add that his oldest daughter, Laura, would take care of her doctor/sister in her career ... and it would happen that way. (Rose Jannini was either the first or the second Italian American female doctor in the United States.) [If someone knows more than I on this subject, please let me know by writing me at the newspaper


office.] One more thing happened that Easter of 1925. Early in the fall of 1924, Babbononno bought a lamb to be raised and fattened for Easter Sunday dinner. Where my grandfather came from, lamb was the traditional meat that was found in the center of the dinner table on Easter Sunday.

Babbononno fed the lamb every day that fall and winter. It lived in the shed in the backyard of their home at 70 Eutaw Street in East Boston. When it was too cold, it slept in the cellar. All but Uncle Gino, who was seven years old, knew that the lamb was the main course for Easter dinner. To my youngest uncle, the lamb was a pet. He played with it, fed it, and talked to the lamb as if it were a dog Toward the end of Holy Week, in 1925, Uncle Gino came home from school and found the lamb missing from the shed. He searched the house for his pet without any luck. On Easter Sunday, he looked at the center of the Contini dinner table, and with horror written on his face, ran to his bedroom screaming and crying. Louis Contini (Uncle Gino) passed away a couple of years ago, at the age of 101, and throughout his entire adult life, he would never-ever eat lamb.

Perfect when drizzled with crema parigina and after one bite, I guarantee you are going to think you're in heaven. If that's not amore, I don't know what is! Buon San Valentino xoxo

CHOCOLATE HEART SEMIFREDDO'S Semifreddo Cuore al Cioccolato



Semifreddo

- 1 can sweetened condensed milk or 1 1/3 cups homemade
- 2/3 cup pure unsweetened
- 2 tablespoons of rum (alcohol not extract)
- 2 cups heavy cream, chilled 2 tablespoons confectioners'

Pinch of salt

Crema Parigina (Italian Ganache)

½ cup heavy cream ½ cup semisweet chocolate, chopped

Semifreddo

Generously grease 2 silicone heart shaped mold pans (or you can use a 8.5(L) x 4.5(W) x 4.75 (H) silicone loaf pan) with butter and set aside. In a medium bowl, combine sweetened condensed milk, cocoa, rum and salt, mix together well. In a large chilled mixing bowl, add heavy cream and confectionary sugar and with a hand or stand mixer, beat cream on low speed until bubbles form. Increase speed to medium, beat until it begins to thicken, then increase to high and beat until doubled in volume and whipped cream forms soft peaks. Take 1/3 of the whipped cream and whisk into chocolate mixture. Take small portions at a time and using a rubber spatula, gently fold remaining whipped cream into chocolate mixture until combined. No streaks of whipped cream should be visible. Pour mixture into prepared loaf or individual mold pan and spread evenly with rubber spatula. Cover tightly with plastic wrap, making sure no air can get in and freeze (overnight is best) until completely firm.

When ready to serve, remove from freezer and invert pan or individual molds onto serving plate. Drizzle with crema paragina and serve immediately, wrap and freeze leftovers.

Crema Parigina (Italian Ganache)

Place cream and chocolate in saucepan and cook until melted together. Set aside to slightly cool before drizzling over semifreddo.

Ngo Dinh Diem Assassinated

Like so many wars to different extent, there is some debate about when the Vietnam War really began; even the Second Indochina War had its roots in the unresolved ends of the First. Generally, however, November of 1955 is given as the official start date of the Vietnam War (the Second one anyway).

Both Presidents Truman and Eisenhower kept the South East Asian conflicts on peripheral view and Kennedy, when taking office in 1961 intended to do the same. Our rapidly deteriorating relationships with both the Soviet Union and Cuba were given greater priority. On this front, however, Kennedy was finding the road to peace paved with obstacles, the Bay of Pigs Invasion a failure and a conference with Soviet President Khrushchev resulting in a stale mate. In short, Kennedy trusted South Vietnam's President Ngo Dinh Diem to ward off the communist threat from North Vietnam on his own.

What Kennedy did not know was that Diem was losing a lot of support in South Vietnam. His brutal retributions toward dissenters and the nation's Buddhist population. Diem, a devout Catholic, had banned the display of the Buddhist flag. In May of 1963, his forces executed nine monks who were leading a protest against the ban; a move that alienated not only the Buddhist population but also the South Vietnamese at large. Morals were low in South Vietnam and the Viet-Cong won decisive victories against South Vietnamese forces, despite the latter boasting a larger and more technologically advanced army.

Adding to the dismay of the populace as well as to the concern of the United States government, Diem was appointing

military commanders based on religion and political loyalty rather than experience or skill. A particularly egregious example was the appointing of devout Catholic Huynh Văn Cao who, in charge of the IV Corps, could barely manage to fight off coups.

In the eyes of both the U.S. and South Vietnam, if the Communist threat from North Vietnam was to be defeated, Diem had to go. It was clear that through paranoia (two coups had been attempted on him in the last three years), aggression, and sheer incompetence, he was tilting the advantage to Ho Chi Minh.

By the summer of 1963, talks were already on the way to remove the leader. The CIA contacted South Vietnamese generals and tactfully expressed their support for Diem's removal and promised not to penalize the nation for the act. On November 2, 1963, South Vietnamese soldiers captured and executed not only President Diem but also his brother Ngo, who led the secret police on many of their brutal raids against the Buddhist community.

Kennedy was surprised by the execution, though he was aware of the growing resentment. His initial reaction was to push for pacification, but the CIA and military advisors warned him to be prepared for a full-scale escalation, one which now the U.S. would play a big part in. As the CIA warned, "The Viet Cong by and large retain de facto control of much of the countryside and have steadily increased the overall intensity of the effort."

The following day, Kennedy would be president no more and our nation mourned. President Johnson now not only had a big job to fill but a growing turmoil far away.

Dear EarthTalk:

What's the latest on efforts to reintroduce Grizzly bears back to the Lower 48?

Grizzly bears, once a common sight in the Lower 48, were hunted and killed to near extinction over the century that followed colonialism. Today, these majestic, lumbering creatures are the focus of many restoration efforts in the United States.

Grizzlies are an important part of the ecosystems they typically inhabit. They aerate soils in the meadows where they dig, distribute plant seeds across the forest floor after eating fruits and nuts, and are a keystone species given their position at the top of the food chain — i.e., if Grizzly populations are suffering, so must be other wildlife populations in the region. In addition to their ecological importance, Grizzly bears also hold a great cultural value for many Native American tribes and Canadian First Nations.

Before colonizers came into the Americas from abroad, scientists think some 50,000 Grizzly bears lived between the Pacific coast and the Great Plains. According to the non-profit Western Wildlife Outreach, Grizzlies were eliminated from 98 percent of their original range in the contiguous U.S. between 1850 and 1970. Sport hunting, fur trading, farming, and the fact that until the mid-20th century, most of these bears would be shot on sight, nearly eradicating them entirely. Today, fewer than 1,400 Grizzlies remain in the Lower 48, most of them in and around Yellowstone National Park. Trace DNA evidence shows a small number (less than five) live in and around North Cascades National Park in Washington State.

All of these populations are seeing positive growth trends in recent years due to restoration efforts by environmental groups, indigenous activists and wildlife biologists. But it's an uphill battle managing existing protected habitat for ideal Grizzly conditions while keeping livestock ranchers around the periphery of Yellowstone from unloading their rifles at their first sight of a Grizzly's signature hump.

And like many other animal species, Grizzlies now face a new threat: climate change. Their populations have been migrating farther north, and have been encountering another competitor: Polar bears, which have had viable offspring in areas where the two species have population overlap. Unfortunately, the rapid changes that are accompanying climate change will be difficult to overcome for even a Grizzly bear.

"There are only a couple Grizzly bear populations that are viable in the United States. Says Wendy Keefover from the Humane Society of the United States: "There are just these tiny islands of Grizzly bear populations left. They need far more protection, not less."

Active work in restoration continues to be extremely important to American ecosystems for these cornerstone populations. HOOPS and HOCKEY in the HUB by Richard Preiss

It was not the second Monday night in February, but the first weekend of the second month of 2021 was close enough in these times where so many contests have been postponed, rescheduled, or canceled entirely.

So the two-game series between perennial Beanpot contenders Boston College and Boston University provided a most worthy alternative for this year's Beanpot that was not held. Instead, a pair of regular in-season meetings of the two college hockey powers proved to be a worthy alternative.

Boston College came into the weekend ranked number 1 in the USA — the first time in five years that the Eagles had achieved that lofty spot. Their Boston University neighbors — headquartered just a bit further down the hill on Commonwealth Avenue — were a respectable 15th across that portion of America that plays host to the great game that is college hockey.

It was a shame that Northeastern, the current Beanpot champion that is also playing a Hockey East schedule, could not be a part of these festivities on this symbolic weekend that normally leads into the culmination of one of the Hub's most cherished traditions — the Beanpot Championship game.

But such a possibility was not to be for any of the teams that comprise the tournament field. Even if the Harvard athletic administrators had given the nod for the Crimson to go forward with a season on the ice, it is doubtful that the Beanpot would have been played this year at the Garden, if at all.

So, while the tournament itself was among the missing, college hockey in the Boston area has still had a fairly significant profile on the local athletic scene since Hockey East has proceeded with a conference schedule.

The first meeting of the season between the two arch-rivals proved to be worthy of any Beanpot championship game in history. The teams had gone 342 days without facing off against one another. The last time was February 29, 2020 when BC defeated BU 4-1 to clinch its 17th Hockey East regular season championship.

Nearly a year later, as the teams met for the 283rd time in the storied history of the series, the Eagles scored in the final moments of regulation to come away with a 4-3 triumph at Conte Forum on the BC campus.

After BU failed to score on a power play late in the third period, the game went into overtime. It looked as though there would be a second extra session but BC's Drew Helleson got possession of the puck and proceeded to go on an end-to-end rush, getting around a BU defender and then scoring with just a tick left in the first OT.

It was the 45th time in the historic series that a contest had gone into overtime. BU now owns a 15-11-19 advantage in those extra

The joyous gathering of teammates near the bench was worthy of a Beanpot championship final. But unlike the Beanpot final there was more to come.

Just one night later the two teams met again — this time at historic Walter Brown Arena on the BU campus. The last time the two teams played at Walter Brown was on Dec. 3, 2004 when the Terriers came away with a 4-2 victory, a triumph that gave legendary coach Jack Parker his 700th career victory.

Playing a second game against the same opponent with just a day or two of separation is one of the nice aspects of a college hockey schedule. If things don't work out your way in the first game, the next opportunity to produce a positive outcome comes very soon often on a second night of the same weekend. And if you were the victor in the first game, you will be facing a team ready and willing to test your mettle in the second.

And so it came to be that the outcome was different as BU atoned for the previous evening's setback with a 3-1 victory over the Eagles.

A pair of freshmen played outstanding roles with Luke Tuch leading the way with two goals while goaltender Vinny Duplessis turned away 40 shots as BU upped its record to 6-2-0. With the weekend split veteran BC coach Jerry York now owns a 49-45-10 record in "The Battle of Commonwealth Avenue" series against BU. A former player at BC in the 1960s, he had previously coached at Clarkson and Bowling Green before coming to BC. The series actually began way back in 1918, the first year of a varsity hockey program at The Heights.

Current BU coach Albie O'Connell is a relative newcomer to the series as a head coach, although he did play for the Terriers and later was an assistant with them. He took over the head job in 2018 when David Quinn left to coach the New York Rangers.

BU's victory was impressive since it was the first time in nearly six years that the Terriers had defeated a number one ranked team. The last time they achieved the feat came in the memorable NCAA Frozen Four national semifinal game in April, 2015 when they defeated college hockey powerhouse North Dakota at the TD Garden. Although BU would lose to Providence in the national championship game two nights later, many would leave the building feeling that the two best teams in the field had actually faced each other in that semifinal clash.

As of early February the remainder of the Hockey East schedule had yet to be announced. More information will probably come on a weekly basis since a number of games have to be rescheduled. The annual Hockey East tournament is still on the docket to be played sometime in March.

Whenever it is held, the odds are fairly good that either BU or BC may make it to the championship weekend. Between them, the two institutions have won 22 of the 36 Hockey East Tournament championships.

When Tom Brady and his victorious Tampa Bay teammates walked off the field after defeating the Kansas City Chiefs in the Super Bowl it had been exactly 6,944 days since Brady and the Patriots had beaten the St. Louis Rams 20-17 in the first of his 10 Super Bowl appearances.
