



"Here Let US Stop"

— George Washington, 1796



"The great rule of conduct for us in regard to foreign nations is in extending our commercial relations, to have with them as little political connection as possible. So far as we have already formed engagements, let them be fulfilled with perfect good faith. Here let us stop.

- George Washington's Farewell Address, 1796

Poor George both revered and kicked around by us. He was born February 11th, but when he was 20, Britain and her colonies finally caught up with Catholic Europe by switching to the Gregorian calendar, moving his birthday to the 22nd of the month. Then, starting in 1971, the Uniform Monday Holiday Act of 1968, moved the official celebration of his birth to the third Monday in February. In popular parlance we slight our first President by neglecting



the legal name of the holiday, WASHINGTON'S BIRTHDAY and refer to it as a generic "Presidents' Day."

We likewise neglect Washington's sage warning against entangling foreign alliances. Even in our commercial relations our leaders, not content merely to trade with the rest of the world, have entered into binding agreements restricting our ability to control our own commerce, to encourage domestic manufacturing, or even to protect our citizens from unsafe products. Our legal obligations to the World Trade Organization and our bilateral and multilateral trade agreements entangle us in a network of supra-national laws that can, effectively, overturn the actions of our elected

Congress and President.

On November 8, 2016, the American people finally said, "Enough," and elected a President who promised to put the interest of the American people first. President Donald J. Trump has fulfilled that promise. As President his first major action was withdrawing the U.S. from the Trans-Pacific Partnership, a monstrosity of a trade deal, calculated to destroy hundreds of thousands of American jobs. In his statement upon exiting the TPP, Trump said:

"It is the policy of my Administration to represent the American people and their financial well-being in all negotiations, particularly the American worker, and to create fair and economically beneficial trade deals that serve their interests."

During the campaign, Barack Obama, who pushed for the TPP, which would have given preferred access to the U.S. market to Islamofascist Brunei and totalitarian Communist Vietnam, said that Trump would need a "magic wand" to fulfill his promises to restore the U.S. economy to health. Well, President Trump found that wand. The President has brought record low unemployment, record high employment, and rising wages, by going back to the wisdom of George Washington.


City Commission Votes to Take up Study to **Consider Nazzaro Center as a Boston Landmark**

The Nazzaro Center building took a big step toward becoming a Boston Landmark, protecting its exterior and surrounding open space from future change. After a stirring hearing, the Boston Landmarks Commission (BLC) voted unanimously on Tuesday night to take up a study that will likely recommend guidelines for the property to be protected as a landmark. The building, located at 30-32 North Bennet Street, also in-

cludes the outside open space of the Polcari Playground.

The hearing began with the BLC reading of the full application for the North Bennet Street Bathhouse and Gymnasium, now known as the Nazzaro Community Center. The build-

ing was built under Mayor Fitzgerald in 1906, completed in 1910, and served as a bathing facility for North End residents until 1976. The exterior represents Renaissance style architecture, designed by Mc-Guinness, Walsh and Sullivan.

District One City Councilor

Lydia Edwards spoke in support of making the Nazzaro Center a Boston Landmark as did State Representative Aaron Michlewitz. The latter spoke of his personal experience using the Nazzaro when it reopened in 1985 as a community center.

Proponent Ellen Hume presented the petition by the "Save the Nazzaro" group that launched the landmark application to the BLC. Hume spoke of the neighborhood support

that has emerged to preserve the exterior of the building and the surrounding open space. Using photos and maps, she highlighted how the Nazzaro sits at the center of the com-

MESOS POTAMOS, AN OVERVIEW



A Clay Tablet

Mesopotamia is the name given to the earliest civilization of Western Asia. It was an area of fertile plains between the Tigris and Euphrates Rivers. The name Mesopotamia is derived from "mesos" meaning middle and "potamos" meaning river, the Greek name for middle river or the area between two rivers. History marks this as the location of the Garden of Eden, Noah's Ark, the great walled city of Babylon with its Hanging Gardens and the Tower of Babel. It is the area, which is now occupied by the country of Iraq. Many of the bricks of Babylon were used in the buildings of Baghdad.

The area between the two rivers, being originally of rich alluvial soil, was capable of supporting lush vegetation. The destruction of their irrigation system by Mongol invaders was the major factor in transforming Mesopotamia to a barren area of thick mud and clay. There were no convenient hills to furnish building stone, nor were there any convenient forests to furnish lumber. The only mineral wealth was clay and mud. This was also a region of floods, swamps, and abundant rainfall. Modern day temperatures during July and August run as high as 120 degrees in the shade.

The religion of the ancient Mesopotamians was based upon superstition and symbolism, which prevailed everywhere. Palaces and public places were protected from evil spirits by beneficent genie set in pairs to guard the entrances. These genies were usually in the form of man-headed bulls.

The Mesopotamian culture developed the art of cuneiform writing (using wedge shaped characters). Their writing was normally done on clay tablets or cylinders, which were more permanent than the Egyptian records on papyrus. The history of this West Asiatic culture tells of a code of laws as far back as 2250 B.C., the family idea prevailed, women were free and were respected and cities had rights and charters. Their code gives evidence of an elaborate legal system, complete commercial life, property owner's responsibilities and city dues. They even had a police system and a postal service.

Saint Stanislaus Kostka

Stanislaus was born at Rostkovo near Prasnysz, Poland, on October 28, 1550. His father, John Kostka, was a senator of the Kingdom of Poland, his mother was Margaret de Drobniy Kryska, the sister and niece of the Dukes Palatine of Masovia and the aunt of the Chancellor of Poland, Felix Kryski. Stanislaus was the second of seven children. His piety irritated his brother, who bullied and beat him. Stanislaus warned him, "This will end in my running away and not coming back. Then you will have to explain to our father and mother."

The two brothers were first taught at home, the main feature of their early education being the firmness, even severity,

In 1564, the brothers attended the Jesuit college at Vienna, Austria. After two years, Stanislaus fell seriously ill and he thought he was going

He wanted to receive Holy Communion, but his Lutheran landlord would not allow it in his house. However, Stanislaus reported that two angels appeared and communicated to him. He also said that the Blessed Mother came to him in a vision, encouraging him to become a Jesuit.

On his recovery, Stanislaus decided to become a Jesuit, but the Austrian provincial did not receive him. Stanislaus set out on a 500-mile walk to Rome to put his case before the Jesuit General. He first went to Dillingen where he met the provincial for Germany, St Peter Canisius, with whom he stayed for a month. Canisius employed Stanislaus in a boarding school and tested him by assigning him menial tasks. He then encouraged him to continue his journey to Rome.

Stanislaus continued his journey to Rome and there he met the Jesuit General St. Francis Borgia who accepted

Stanislaus did not complete his training. Nine months into his novitiate, he again became very sick. Early in the morning on the feast of the Assumption, 1568, he told a priest that he saw Mary surrounded by many angels. And shortly afterward,



he passed away. Stanislaus was only seventeen years old. Many in the city proclaimed him a saint and came to venerate his remains and to obtain, if possible, some relics.

His older brother Paul survived him long enough to be present at the celebration of the beatification of Stanislaus in 1605. Stanislaus was canonized on December 31, 1726, by Pope Benedict XIII. His Feast Day is November 13th. He is regarded as the patron saint of novices. He is invoked for palpitations of the heart and for dangerous cases of illness.

Italian American Alliance **Continues to Grow**

Alliance Gets Huge Boost

Thanks to Many Metro West Residents Who Have Joined Us

Before the night was out at Ken's Steak House in Framingham last Wednesday, February 6th, the Italian American Alliance had gained some 150 new Members who will surely be an active force in defending Italian Heritage in general while promoting Columbus Day.

Thanks to the wonderful generosity of Tim Hanna and the Hanna Family, attendees were treated to a complimentary buffet and an open bar. The event gave the Italian American Alliance Board of Directors a chance to mingle with the new Alliance members. At this point, there are some 320 Metro West area residents currently enrolled in the Framingham Chapter of the Alliance. And we are just beginning!!!!

John C. Magri, recently elected to the Alliance Board, will also lead the Framingham Council of the Framingham ALLIANCE Chapter whose purpose it will be to develop a Christopher Columbus Program in Framingham while extending its membership in both Framingham and Ashland. As membership continues to grow, Italian Americans as well as friends of Italian Americans will know who the adversaries of our heritage are at the polls



when Election Day comes just a few weeks after Columbus Day.

Dr. Frank Mazzaglia, Chairman of the Board announced that the Framingham Chapter of the Alliance was particularly critical since Representative Jack Patrick Lewis (Ashland/ Framingham) filed House Bill 3746 — An Act establishing an Indigenous People's Day. He was joined in that filing by Representative Denise Provost of Somerville.

While the Alliance has no objection to any holiday that would honor Native Americans, it is clear that the intent of the proposed bill is to replace Columbus Day. With that in mind, the Alliance will now focus on developing a strong membership group in Ashland as well as in Somerville.

"For too long," said Mazzaglia, "Italian Americans have been passive about attacks on their Heritage of which Christopher Columbus plays a central role. Those silent days are now over. In our experience, we find that Columbus is just a convenient

code word used to discriminate against Italian Americans. In fact, we will not allow that to happen. For several decades, revisionists have distorted history and we are prepared to correct that," PEOPLE NEED TO KNOW.

Rep. Jack Patrick Lewis attended the University of Utah and received a Master of Education degree from Eden Theological Seminary in Webster Groves, Missouri, near St. Louis, Missouri. The seminary was established in 1850, and has a total enrollment of 148 students. He worked for Howard Dean's presidential campaign and has taught English in Ghana and Egypt.

Lewis represents Ashland and several parts of Framingham.

Rep. Denise Provost is a lawyer who went to Bennington College and B.U. Law School.

Currently, the Alliance is in the process of opening a Chapter in Somerville.

munity and forms an integral part of its history.

Efforts to preserve the Nazzaro Center building gained steam after city consultants recommended the site as one of three final options for redevelopment in the search to locate a new community center. The other two recommended sites include Sargent's Wharf and the Mirabella Pool bathhouse. Chair of the BLC emphasized, however, that the city commission only considers historical elements as part of its decision making process rather than the potential for other uses.

First to comment in the public session was past NEWRA President, Mary McGee, who highlighted that the neighborhood maintains several colonial properties, such as the Old North Church and Paul Revere House, but has failed to protect sites related to the immigrant experience such as the North Bennet Street Bathhouse that is now known at the Nazzaro Center.

Longtime North End / Waterfront Neighborhood Council (NEWNC) member and lifelong resident, Marie Simboli, had a letter read aloud at the hearing in support of preserving the Nazzaro Center.

An extended series of public comments continued at the hearing, all in support of protecting the Nazzaro Center and Polcari Playground. Carla Nazzaro DiOrio, niece of the building namesake Michael Nazzaro, Jr., spoke about her father's legacy in the neighborhood and in support of the building's preservation. Nazzaro was a local politician

credited with saving the North End from urban renewal after the West End was redeveloped.

A notable element of the public comments was a series of new, young residents that live near and use the Nazzaro Center, speaking in support to protect the building and open space. BLC Commissioner and North End resident, Kirstin Hoffman also spoke during the comment period regarding the building's historic integrity.

Mayor Walsh has recently clarified that the City does not intend to tear down the Nazzaro Center as part of building a new community center. If and when the BLC recommends the Nazzaro Center as a Boston Landmark, the final approval will be made by the Mayor.

L'Anno Bello: A Year in Italian Folklore

The Sweet World of Italian Desserts

I recently noticed that the culinary world is at war, a drawn-out conflict between cooks and bakers. If one believes the Internet, cooks deride bakers for their supposed lack of spontaneity and creativity; bakers prefer the comfort of following a recipe. This conflict never manifested in my childhood — my mother cooked up a hearty meal of orecchiette with broccoli rabe as easily as she baked my scrumptious birthday cakes. However, as I grew older and developed my own identity in the kitchen, I realized that I am definitely more of a baker. I love the magic of turning the basic essentials of human life, flour and water, into substantial treats. I adore the way the oven warms my kitchen and embraces me with tantalizing scents. Finally, I do see the creativity in baking, in the way one simple recipe can be adapted, tweaked and altered to yield a myriad of delectable results.

A lot of praised has been heaped — justifiably! — On how wonderful Italian entrees are, but oftentimes traditional Italian desserts go unnoticed. So, in honor of my love for baking, I have compiled a list of desserts from the Old Country that stir passion and nostalgia through my veins. Since Italian desserts are plentiful, I will try to focus on desserts that pertain to the month of February, a very sweet month indeed due to St. Valentine's Day and Carnival! I hope you enjoy this trip down memory lane as much as my stomach does!

Cannoli: Arguably the most famous Italian dessert, cannoli are a staple in cookbooks and supermarket aisles everywhere. To find an authentic cannolo, however, your best bet is a small family-run bakery or restaurant, of which Boston's

Italian neighborhoods have plenty! The traditional filling for cannoli is ricotta, and the shells must be freshly filled with it to order. Leaving a cannolo languishing with cream inside will make the shell turn from a decadent crisp to a mushy mess. Interesting facts about cannoli: they originated in Sicily, specifically the Palermo region, but they are now enjoyed all over Italy and around the world. Cannoli were originally treats for the Carnival season, when dishes made of rich ingredients were eagerly consumed before the austere period of Lent. The name "cannolo" means "little tube" in Italian, speaking to their distinctive shape!

Cenci: Known as "angel wings" in English, these fried strips of dough covered in powdered sugar are a real Carnival delicacy in Italy. I loved making them with my grandmother on an early-spring day, when the joyous sensation of Carnival penetrates my bones and the promise of Easter seems just a few hops away. My grandmother has always called these little goodies Cenci, but they are known by different names according to the region of Italy. Many of the names reflect the whimsical nature of Carnival, as you will also find them called bugie (lies) or chiacchiere (chatter)!

Crostata: A crostata is an Italian tart or pie, whose name derives from the word "crust." Crostatas are rustic, free-form pastries, and the beauty of this treat is that the filling can change according to the season. February can call for crostatas stuffed with orange marmalade or a fresh pear compote. Why not celebrate Valentine's Day by making a romantic crostata with ruby-red strawberry or raspberry preserves, or — my favorite! — Nutella?



Pizzelle: Hard or soft? Vanilla, anise or lemon extract? No one can agree on what makes perfect pizzelle or the waffled cookies so popular among Italians and Italian-Americans. When there is this much debate about a dessert, it must mean that it has permeated deep into the culture. I am partial to soft pizzelle, but honestly all forms are so good that I'd rather eat them than fight about them. Pizzelle are often associated with holidays, like Christmas or Easter, or special events like weddings and baby showers, so much so that I cannot think of pizzelle without imaging some kind of party in my mind. Fun fact: pizzelle originate from Abruzzi, the part of Italy my father hailed from!

Tiramisu: I always thought tiramisu was an old Italian dessert, but quick research tells me it is a mid-twentieth century invention. That could be why tiramisu, in its modern incarnation, never appeared in any of my grandmother's childhood cookbooks. One would think that because it is a more contemporary dessert its origins would be easily investigated, but the creation of tiramisu is actually shrouded in legends and myths. Some say the earliest tiramisu was prepared in 17th century Siena for Cosimo de Medici. Others say it was created in the 1960s in the Veneto city of Treviso. All that is certain is that the name of this mascarpone-and-ladyfinger layered dessert means "pick me up," which its servings of espresso will certainly do! Tiramisu is a romantic pick for Valentine's Day.

What is your favorite Italian dessert? Let me know what makes your stomach grumble and your heart melt like a chocolate zabaglione. Until then, keep cooking!

Botticelli: Heroines and Heroes

at the Isabella Stewart Gardner Museum

For the forthcoming *Botticelli*: Heroines and Heroes exhibition in early 2019, the Isabella Stewart Gardner Museum will be the sole venue in the United States to reunite Renaissance master Sandro Botticelli's The Story of Lucretia from the Gardner Museum collection with the painter's Story of Virginia, on loan from Italy for the first time. This presentation explores Botticelli's revolutionary narrative paintings and brings them into dialogue with contemporary responses. The exhibition opens February 14, 2019 and runs through May 19, 2019.

Painted around 1500, eight monumental works — including important loans from museums in Europe and the U.S. — demonstrate Botticelli's extraordinary talent as a master storyteller. He reinvented ancient Roman and early Christian heroines and heroes as role models, transforming their stories of lust, betrayal, and violence into parables for a new era of political and religious turmoil.

Considered one of the most renowned artists of the Renaissance, Botticelli (about 1445-1510) was sought after by popes, princes, and prelates for paintings to decorate Italian churches. His Medici-era madonnas elevated Botticelli to a household name in Gilded Age Boston. Yet the painter achieved iconic status through his secular paintings — like the *Primavera* — for the Renaissance home. All of the works in the Gardner's exhibition originally filled the palaces of Florence, adorning patrician bedrooms with sophisticated modern spins on ancient tales.

Botticelli: Heroines and Heroes is the first-ever exhibition dedicated to Botticelli's spalliera, a new genre of domestic painting. Deriving from the Italian word spalla or shoulder, the name indicated the height at which Renaissance viewers experienced these captivating images. As the leading painter of Florence, Botticelli looked to the city's legendary past for heroines and heroes whose lives he reimagined to deliver political, patriotic and moralizing messages into the residences of the Florentine elite.

Unprecedented loans for this exhibition include *The* Story of Virginia from the Accademia Carrara, Bergamo, never before seen in the United States. Thanks to the exceptional generosity of the National Gallery, London and the Metropolitan Museum of Art, New York, the Gardner exhibition also reunites three of four panels from another spalliera depicting the story of the early Christian saint Zenobius, celebrated in Florence as the city's first native bishop. Botticelli's unique, unfinished Adoration of the Magi, on loan from the Gallerie degli Uffizi, Florence offers a rare insight into his working methods while two large scale drawings of the same composition from the Fitzwilliam Museum, Cambridge illuminate how he reworked figure groups for multiple compositions of diverse functions.

Botticelli, like a modern graphic novelist, envisioned episodic stories with multiple scenes featuring the same protagonist. In that spirit, the Gardner Museum commissioned New Yorker magazine cartoonist Karl Stevens to respond to Botticelli's seminal works for this exhibition. Just as Botticelli offered a modern vision of ancient stories, Stevens created up-to-date interpretations of the painter's Renaissance masterworks. His dramatic pen and ink drawings provide frank commentary on these complex tales for the #MeToo moment, interrogating the legacy of Botticelli's stories and honoring Isabella Stewart Gardner's commitment to contemporary

In 1894, Isabella Stewart Gardner acquired The Story of Lucretia and brought this masterpiece to Boston. It was the first Botticelli in America and the first major Renaissance painting in her collection. With never-before-exhibited photographs, books, and letters from the Gardner Museum archives, a special section of the exhibition explores this landmark episode in the history of American collecting and traces the painting's fortunes from Renaissance Florence to the Gilded Age Boston.

"Reuniting Botticelli's iconic paintings, *The Story of Virginia* and *The Story of Lucretia*, is a historic moment. For the first time, we bear witness to Botticelli's masterful storytelling ability as it creates an engaging artistic conversation in a contemporary setting and with a contemporary artist," said Dr. Nathaniel Silver, the Gardner Museum's *Interim Curator of the Collection*.

Peggy Fogelman, the Gardner Museum's Norma Jean Calderwood Director, said the Museum is always eager to create cross-cultural experiences that span generations and continue to intrigue artists of today. "It's exactly how Isabella Stewart Gardner envisioned her Museum through the ages," she said. "We always seek to explore the intersection of historic art and its resonances today in new works and new forms of artistic expression."

The accompanying exhibition catalogue is edited by Dr. Silver. Essays investigate Botticelli's radical approach to antiquity and explore the early taste for his work in America. Contributors Nathaniel Silver (Gardner Museum), Elsa Filosa (Vanderbilt University), Scott Nethersole (Courtauld Institute of Art), and Patricia Lee Rubin (Institute of Fine Arts, NYU) address Botticelli's spalliera, their violence, his textual sources, and rediscovery in Gilded Age America. Extended catalogue entries offer fresh insights and up-todate bibliography for each of the painter's late career masterpieces featured in this

Dahlias

Brings Diverse Shapes, Sizes, and Colors to the Garden

Dahlias have been a fixture in summer flower gardens for generations. But it may be time to update your idea of dahlias! With hundreds of varieties to choose from in a fabulous array of colors, shapes and flower sizes, it is no surprise the National Garden Bureau has declared 2019 the Year of the Dahlia. Join the celebration and brighten your garden with dahlias this year.

Not only are dahlias beautiful, but they're also easy to grow. Just plant the tuberous roots in a sunny, well-drained

location, once the soil has warmed to about 60 degrees — or around the same time as you would plant tomatoes. It takes a week or two for the first shoots to emerge, but the plants grow quickly and will be blooming by midsummer.

Grow dahlias in containers to brighten your balcony, deck or front steps. They combine nicely with other plants in containers as well as in the garden. Mix them with bold, leafy elephant ears, Lacinato kale and Swiss chard; finely textured ornamental grasses and gaura; upright salvias and gladiolus; and trailing plants like calibrachoa, verbena and ivy. Dahlias will add pizzazz to your gardens and landscape, especially in the second half of the summer when many other flowers are starting to wane.

Dinnerplate dahlias are bodacious beauties that command your attention. They include any variety of dahlias with flowers that are at least eight inches in diameter. These extra-large blossoms are produced on bushy plants that grow 3 to 6 feet tall. Favorites include Café au Lait, Vancouver and Thomas Edison. Use stakes to help support the flowers and keep the plants standing upright.

Decorative dahlias offer the widest array of colors and styles. Their petals are flat to slightly rolled and flower sizes vary from 4 to 8 inches. Growing an assortment of several different varieties, like the Spice Mix Decorative Dahlia Collection (longfield-gardens.com), lets you enjoy a colorcoordinated blend of hues that combine well in both the garden and in a vase.

For dahlias with a completely different look, grow cactus and semi-cactus types. Their rolled or partially rolled petals give the flowers a spiky texture. Varieties such as Yellow Star and burgundymaroon Nuit d'Ete will add style and sophistication to your garden.

Make sure your flower garden also includes a few ball and pompon dahlias. These perfectly round swirls of tightly rolled petals come in vivid colors, and their long vase life makes them a favorite with floral de-

signers. Use coppery-orange Mirella or vivid Boom Boom Red to weave shots of color throughout an arrangement.

For contrast, incorporate some single, peonyflowered, anemone and collarette types. Dahlias such as HS Date, Bishop of Dover and Fascination have fewer petals and slightly smaller blooms, which makes them good companions for annuals as well as perennials. Plus, their daisy-like centers are magnets for bees and butterflies.

Bring your dahlias up close with dwarf varieties, commonly known as border dahlias. These plants grow just 12 to 24 inches tall, yet most have big, 4 to 5" blooms. Popular varieties include Gallery Pablo, Melody Swing and Gallery Art Nouveau. They are ideal for small spaces, lining a walkway and are a perfect addition to containers.

With so many colors and flowers styles to choose from, growing dahlias can become a life-long adventure. Make room in your garden for some of these easy-to-grow, easy-to-love, summer-flowering bulbs. You'll discover why so many gardeners have fallen under their spell!



A Play with Original Songs by the Author of Silent Sky, I and You, Miss Bennet: Christmas at Pemberley



George Judy is the Gresdna A. A Nostalgic Remembrance



I guess I've never been much for winter sports. As a matter of fact, as a young single man, I only vacationed north of Boston once during a winter break. My preference was to head to winter climates where I could see palm trees, coconut trees and skis ... water skis. The one exception happened when I was in my early twenties. I was in graduate school at the time and living back with my folks which helped me pay my own way through. Babbononno was living with my folks and would often ask me questions about what I was studying. I know down deep, he regretted not having gone beyond the 6th grade. He was quite inquisitive and intuitive especially when it came to the history courses I was taking, and we had many an in depth conversation about how the world would be if history had led us in other directions.

I was home studying one night and Babbononno answered the phone when it rang, and yelled, "Jenny, dissa cawla foh you. Penso che e una ragazza giovena e possiblemente bella! (Johnny this call is for you. I think it is a young girl and possibly a pretty one.) It turned out to be one of the teachers on the faculty of Hyde Park High School, a young single teacher who was attractive, just like Babbononno imagined. We talked for a bit, and in the conversation, she mentioned that she belonged to a ski club in New Hampshire. They were having an open house that coming weekend to interest new prospective members. The weekend was the one just before the February school vacation and my band wasn't booked anywhere, nor was I working with any other group. On a whim, I agreed to take her up on her invitation. She then informed me that I could invite a friend along to the open house weekend.

Just as soon as I hung up, I called Sal Meli, one of my closest friends and a person who was ready, willing, and able to take off at a moment's notice. He didn't have any plans either, and that Friday, as soon as school let out, I headed from Hyde Park to Polaroid on Route 128, and picked him up. Both of us had suitcases filled with warm clothing because it was winter and we were heading for a ski lodge at the foot of Cannon Mountain in central New Hampshire. The only thing I knew about the area was that during February, it was damn cold. A few hours later we arrived in ski country. Boston had a bit of residual snow on the ground from a snow storm earlier that week. Cannon Mountain and its environs had several feet of snow hard packed on the ground, and I thought I was in another world when we

I found the young teacher who invited us sitting in the lobby of the lodge just waiting for us. She helped us check in and we then headed to the dining room for a late dinner. After dinner, we were given a ski lesson by a tall blond German ski instructor. The lesson was basically how to put our skis on, how to push off and how to stop. After that, it was cocktail time, and the instruction area became

The next morning Sal and I sat at a breakfast table next to a window that faced the novice slope of the mountain. I could see beginner skiers falling all over the place and became nervous about my own future on skis. When we headed out of the lodge, I knew that we were north, way north of Boston. It was a clear day with the sun shining on Cannon Mountain and the temperature was about five degrees below zero ... ouch!

Sal headed off on his own as he was a journeyman skier. I headed for the novice slope but couldn't get on, due to the number of people falling all over the place as they tried to ski, possibly for the first time, just like me.

I got on a T-bar and headed for the middle of the mountain. I figured it wouldn't be as crowded and I would have a better chance with my first attempt if I had a little room in which to maneuver. Well, the middle of the mountain was just as crowded as the novice slope with the exception of the falling skiers. I then climbed into a gondola and headed for the top of the mountain. There were less people up there, and when arriving, I understood why. The angle of the slope was about 75 degrees (that's a steep angle) and the temperature was 10 to 20 below zero. I watched the expert skiers for several minutes and then did what they did: check the laces on my boots, snap on my skis, get myself into a position where I could push off and head down the mountain. The only difference between me and the other skiers was that I was praying in Italian and English at the same time as I picked up speed heading down on Cannon Mountain.

Well, I made it to the middle of the mountain without falling and continued toward the novice slope. When I got there, I zigzagged around all of the beginners who were still falling down. I somehow made it past them all without any collisions. The outside wall of the lodge kept coming closer, and I snow plowed (pointed my skis toward each other) to help me stop. I then twisted my body so that my skis were parallel to the wall and dug my poles into the hardened snow. I stopped without falling even once. The next step was to no longer temp fate. I immediately removed my skis, stood at attention and saluted Cannon Mountain. The young teacher who had invited me, happened to witness my events of the morning, walked over and whispered in my ear, "Beginner's luck."

At that point, I promised the Good Lord that I would never attempt to ski again. I didn't want to tempt fate again. I returned the skis and other rented or borrowed accessories to the rental office of the club and headed to the lounge and a large hot chocolate. At that point I discovered several parts of my body were numb from the cold and realized immediately that my ancestors were from the southern part of the Italian peninsula where palm trees grow even in winter. I made a pledge never to try to defy my ancestry or insult my ancestors ever again, and swore that if ever I was to don another pair of skis, they would be the type that could be used on a lake, pond or body of water that was near or in the tropics. I have kept my word on this subject throughout my

I did return to ski areas many times after this point. Each time, I enjoyed the friendship of others who I came in contact with (inside the resort buildings). Loretta and I have taken our sons on ski trips and they are quite good at it. When son John was living in Zurich, Switzerland, we brought the boys skiing in St. Moritz every time we visited him. He and Michael skied, I stayed indoors. If Babbononno was still here, he would probably tell me to stay away from the mountains during the winter months, but if I had to go near them, I should have a shot of good cognac just in case ...

POLLO SPEZZATO ALLA SICILIANA

Cut-up Chicken - Sicilian Style

A three-pound cut-up chicken

1/4 cup olive oil 1 large onion cut in quarters

5 cloves garlic

3 carrots cut into two-inch pieces

2 medium potatoes cut in

auarters

1 large green pepper cut into two-inch wedges*

1 cup green peas (canned or

1 fresh tomato chopped (optional)

2 tablespoons wine or cider

1 tablespoon dried oregano

1 cup mushrooms (optional)

Salt *Two or three slices of prepared vinegar peppers can be used in place

Heat oil in a saucepan and slightly brown chicken portions in the pan. Add onion and chopped garlic cloves to saucepan and simmer for a short time before adding chopped tomato (optional) and half a cup of water. Cover and continue simmering slowly until broth boils. Add carrots, potatoes, oregano and additional water. Cover and cook slowly for about fifteen minutes. Add prepared vinegar peppers or wine or cider vinegar. Stir and add mushrooms and peas. Stir and cook until chicken and vegetables are fork tender (about thirty to forty-five minutes, depending on size of chicken pieces). Salt to taste.

This recipe does not require a lot of broth but enough to serve some with the chicken and vegetables. Add additional water if

NOTE: This recipe can also be prepared in a baking dish in the oven, or on a grill. Each method of preparation allows for a different flavor. When I prepare this, I remember when my maternal grandmother cooked this dish on our outdoor fireplace in Wilmington. I walked with her around the area, picking up small broken limbs and adding them to the fire. She told me that this made her feel like she was back in Salemi, Italy. During the harvesting days she accompanied her husband to "la mucarta" (a lot of land a distance from their home where they planted and harvested their vegetables for the year). At "la mucarta," she prepared their meals on the outdoor fireplace.

The Homes of Our Past

I write a lot about the places I remember, so there was no excuse for me taking this long to realize how many homes were part of my life and development, homes I've lived in, homes I used to visit my relatives in, homes of friends, and all others. A home is, after all, where you bring the memories you build elsewhere back to stay with you at the end of the day, where you build the life that will harbor those memories, and where you build a museum to yourself.

I have written quite a bit about my first home on Wrentham Street and how, no matter where I roam, it will always be the first home I loved. But now, though it's not even been four years since my mother left it, I miss the home in Stoughton where my sister and I spent our adolescence, the home that saw us both through high school, college, long lasting relationships, friendships, marriage, traditions, joyous moments, sad moments, and, mostly, building moments in which I discovered who I am, truly. If Dorchester planted the answer in me, I found it in Stoughton. I still drive by that split-level ranch once a month or so. Despite some new developments it remains much the same as it did when I last saw it in the fall of 2015. The old basketball hoop my Dad installed for my in the driveway back in 1993 still stands tall as does the crumpling old shed in the back, and the swing set we set up in 1995. My family has many fond memories of the house in Stoughton, too many to list, but what that house created in us since my parents bought it in 1992 (their first home purchase) is hardly a memory. It lives with me everyday through tears and laughter.

Yes, I remember my paternal grandparents' apartment on Wrentham Street in the tripledecker next to ours. We would take a staircase to get up to their apartment; a staircase made with craftsmanship you don't see anymore, real strong wood and meticulous detail, a testament to the solid carpentry of the early 20th century. My favorite time to visit was Thanksgiving, when my parents, my sister, and I would join my grandmother and my grandfather and my grand Uncle Benny in the dinning room that stood separated from the small living room by an open archway. We would be joined by our cousins and aunts and uncles from the South Shore and the Thanksgivings of my youth will never be forgotten. In time, as relatives began to pass on and people moved away my grandmother and my grand uncle relocated to a smaller condo in Quincy where my grandmother spent the rest of her life. The holiday celebrations and continued and the family gatherings kept on and, much like the "other house" in Stoughton did for my home in Dorchester, so did this apartment carve its own place in my heart.

At the other end of Wrentham Street lived my other set of grandparents and my uncle (after living briefly, in the mid-80s, on King Street in an apartment I have only the vaguest memories of. This house was a duplex and my grandparents and uncle lived on the second level. It was large enough with two bedrooms, a front and back

I surprise myself for even missing the condo my aunt and uncle leased along with their two kids in Quincy while living briefly in the States.

When we remember the homes of our past, those we lived in or otherwise, they form a collective force in tracing the line illustrating the path that brought us where we are today. For what places have more of an impact and our dearer to our hearts than the places we call home?

Remembering Bob Friend And the Pittsburgh Pirates



Recently, the former Pittsburgh Pirates ace pitcher passed away at 88 years old from a sudden cardiac event. During the '50s, the team looked like the twin of the Boston Red Sox. Friend started 568 games and was the mainstay of the pitching rotation. He had great control and was durable, never had a sore arm and never made the disabled list either.

One of the best pitchers in baseball for most of his 15 years in Pittsburgh. The team's best year was 1960 when the Pirates stunned the Yankees in Game 7 of that year's World Series. He broke into Major League Baseball with the Pirates on April 28, 1951. Over his hard luck career, he went 197-230 with 1,734 strikeouts and a 3.58 ERA. Friend was 22-14 throwing 274 innings and was his own season as a 20 game winner. During their World Series Championship season, he was 18-12 with a 3.00 ERA. He played 15 seasons with the Pirates and his final season



Robinson entered the big leagues as a 20 year old in 1956. He hit 38 homers for the Reds and won the NL Rookie of the Year Award. He was a one of a kind and a big part of my baseball memories growing up in the '50s and '60s.

I am sharing photos of just a few of the many local fighters who fought on those cards. I hope these pictures bring back memories.







They crashed the net, the entire roster, all of them. Piling on and pushing it back, with force, against the boards. A realistic force but also a symbolic one - eradicating the last bastion of nonbelievers.

Yes, this was the Northeastern hockey team in the initial moments of elation following its second consecutive victory in the Beanpot championship game at the Garden on February 11th, the night before the 210th anniversary of the birth of President Abraham Lincoln.

And there they were those Huskies-dispelling those doubters. Those who had called their triumph in the 2018 title game - their first in 30 years — a fluke. Sure, anyone can win once over the course of three decades they would say.

But now, as the net, bathed in the swarm of those lost in elation, came to rest, so too were those who doubted silenced, stopped and brought to a halt by the impressive play of Coach Jim Madigan's team.

For this was the first time in 39 years that Northeastern had defeated Boston College in the championship game of the Beanpot — and on the exact night, no less. That's right. One had to go all the way back to February 11, 1980, to find the last time the Huskies had outhustled the Eagles by a 5-4 score in overtime to earn the right to bring the trophy back to Huntington Avenue.

It was also the first time that Northeastern had claimed two consecutive Beanpot championships since those in 1984 and 1985. Coach Madigan played on both those teams and was an assistant coach with the 1988 squad that also claimed a Beanpot title.

And yes, it was payback, of sorts — for the three times in the relatively recent past (2011, 2013, and 2014) that BC had defeated NU in the finals, thereby denying the Huskies a long sought after title victory in one of the Hub's most cherished athletic traditions.

It was the 17th victory of the season for Northeastern, placing the Huskies in a good position to finish strong in the Hockey East Conference and be in contention for a berth in the NCAA playoffs.

In a way it also was a good night for Boston College. Prior to the game it was announced that veteran Head Coach Jerry York, who has been behind the bench since 1994, had been given a three-year contract extension by the school. That means he will be leading the Eagles through at least the 2022-2023 season.

During the 67-year span of the Beanpot, BC has made the championship game 36 times, winning the title on 20 occasions and finishing second on 16 others. In the York era alone BC has won the Beanpot nine times, including seven in the last 12 years.

This year hasn't been one of the better ones for York since the Eagles are currently playing at an under .500 clip overall. But one should never count a York-coached team out of the proceedings.

BC showed up big-time in this year's event. First, the Eagles advanced to the title game for the first time since 2016, with a 2-1 victory over Harvard on opening night, courtesy of a pair of goals by freshmen Patrick Giles and Jack McBain.

Then in the championship clash with Northeastern, BC looked as if it might be left for dead after the Huskies took a 3-0 lead with about 15 minutes remaining in the third period. Instead, the Eagles came back with a pair of tallies of their own to make the final eight minutes very interesting. The outcome was in doubt until NU scored an empty netter with five seconds remaining.

BC could still wind up with an over .500 regular season finish provided it wins the bulk of its seven remaining games including a home and home series with Northeastern in early March.

Then there was a bright side in the stands as some 15,015 fans attended the championship game, serving notice once again that the Beanpot Tournament is alive, well, and thriving in Boston.

AND THEN THEY WERE **GONE** — After playing eight of their last 10 games at home, the Bruins left for a lengthy five-game road trip that will see them play all Western Conference foes over the course of a nine-day span. First up will be Anaheim followed by Los Angeles, San Jose, Vegas, and St. Louis.

'I think our guys are looking forward to it," said Bruins Head Coach Bruce Cassidy. "I think it's time to get out on the road and bond a little bit there."

Goalie Tuukka Rask was also positive about the trip. "It's always good to go on the road and kind of bond with the team. Hopefully we'll get some wins under our belts and also have fun. I think our team has played great (12 in a row without a loss in regulation). I think we've played great hockey as a

Veteran forward Brad Marchand stressed the importance of the road trip: "We have to continue to play well. We want to continue to move up in the standings. So it's a big road trip. Especially with the traveling and everything, it can get tiresome. So we want to make the most of it."

The B's won't return to the Garden until February 26th when they'll face San Jose once again. That game will be the opening of a six-game home stand with the game against Tampa Bay — the NHL's best team by record — being the feature match on February 28th.

Coach Cassidy on his team killing a five on three penalty: "When you kill a five on three, your whole bench gets perked up. The skaters want to get right out there and reward the players that did it."
