Celebrating Boston's Affordable Housing Funding Grants at North End's Knights of Columbus Site

It was a good day for affordable housing efforts in the City of Boston as hundreds of new units were funded throughout the city in a celebratory event held in the North End. Mayor Walsh and representatives from the Department of Neighborhood Development, Neighborhood Housing Trust Fund and the Community Preservation Committee gathered at the Knights of Columbus building at 41 North Margin Street, the future site of 23 new senior affordable housing units. The North End project is receiving of \$1.96 million from Community Preservation Act

In addition to Mayor Walsh, speaking at the event were Al Caldarelli of the East Boston CDC, Victor Brogna from the North End / Waterfront Residents' Association (NEWRA) and Sheila Dillon, Boston's Chief of Housing and Director of the Department of Neighborhood Development (DND). Attending were local officials, including City Councilor Lydia Edwards and State Rep. Aaron Michlewitz. In total, 10 affordable housing developments were awarded funding throughout the city as part of Community Preservation grants.

North End K of C members were on hand from the Ausonia Council #1513 for the celebration, along with their non-profit partner, the East Boston Community Development Corp. that will have a 99-year lease to develop and manage the prop-

erty. At the N. Margin St. location, there will be 23 units in total as part of the 5-story building. General affordability requirements would be for those with incomes up to \$45,000 while the "senior" notation means those at least 62 years old.

Public financing dictates that tenants will be selected via lottery.

The Knights will also have just over 1,500 square feet of ground floor space to house a new council headquarters. Plans also call for a community room and 15 parking spaces.

The citywide projects announced Wednesday total \$26 million toward 515 affordable housing units and deed-restricted homes in Brighton, East Boston, Dorchester, Mattapan, Mission Hill, North End and Roxbury. The North End project is receiving of \$1.96 million from Community Preservation Act funding. Mayor Walsh has targeted 16,000 new affordable housing units by 2030 with 5,500 affordable housing units permitted to date.

2019 City Scholarship Applications

Available to Boston Residents

Mayor Martin J. Walsh announced applications are now available for the 2019 City of Boston Scholarship Program. The City of Boston Scholarship Program is designed to support higher education, and is available to Boston residents interested in pursuing an undergraduate degree or continuing education in Massachusetts.

"The City of Boston Scholarship Fund helps students achieve their dream of attending college, and I'm proud that through this program, we're able to give our residents the support they need," said Mayor Walsh. "I encourage residents throughout our city's neighborhoods to apply to this program, and look forward to our city's leaders gaining the opportunities they deserve to succeed."

The City of Boston Scholarship fund is a need-based scholarship that provides up to \$10,000 over four years towards tuition, and relies primarily on generous contributions from individuals, organizations and corporations to further the goal of having more Boston residents complete a post-secondary education. During the 2018-2019 academic year, the scholarship program awarded a total of \$290,000 to over 115 students representing almost every neighborhood of Boston,

who went on to attend 30 local colleges and universities. This year, the Fund will award 30 new recipients.

This year's scholarships were supported by generous donations from Arbella Insurance Foundation, Harvard Pilgrim Health Care Foundation, Herb Chambers Foundation, Pinnacle Leadership Foundation, and Rapid7 as part of their commitment to students of Boston.


Stirpe Nostra

THE BIBLE LANDS



The history of ancient Mesopotamia, also called the West Asiatic or the Tigris-Euphrates country, was actually composed of three major periods. These were known as the Babylon Period, the Assyrian Period, and the Persian Period. They all occupied the territory that was part of the "Bible Lands." Mountains in the northern portion of the country reach heights of 7,000-feet, but further south, the country slopes downward to form a broad central alluvial plain, which occupies the valley between the Tigris and Euphrates Rivers. The previous column noted that history marks this as the location of the "Garden of Eden." The name "Garden of Eden" implies, an area where climate, soil, and rainfall were ideal. The Old Testament calls this area "Shinar, Babel, and The Land of the Chaldees." It was one of the richest and most fertile

districts, and supplied one third of the grain produced in all of western Asia. A magnificent system of artificial irrigation was introduced by a network of canals. The greatest of these canals was called the "Nar Malka." It connected the Tigris with the Euphrates and was still in use as late as 700 A.D.

During the Babylonian period, the people maintained a civilization, which has not been properly appreciated until fairly modern times. The discovery and deciphering of many thousands of inscribed tablets from some of the oldest cities of Babylonia give a very accurate account of their ancient life in details, which are clearer than most other nations except Egypt.

Their laws were administered by judges and supreme judges. Punishment was handed out in the form of fines, loss of civil rights, imprisonment. and

at times even death. Appeals could be made to the king. They used a form of silver currency, with denominations named "talents, maneus, shekels, and paras." Taxes were levied for the improvement of their roads and canals. They were also required to pay a "king's tax" (property tax), and an "army tax."

All Chaldeans of free birth were educated. Slaves were protected by law against harsh treatment from their masters; they could own property; and in fact were often taught trades by their owners. Women occupied a favorable position in their society, especially after marriage. They could own property and engage in business ventures. Motherhood was especially respected and offences against any mother were severely punished, sometimes even by mutilation.

Saint Frances of Rome


Frances was born in Rome to a wealthy and aristocratic couple, Paolo Bussa and Iacobella dei Roffredeschi in 1384. She was christened in the Church of St. Agnes on the famed Piazza Navona. When she was eleven years old, she wanted to be a nun, but, at about the age of twelve, her parents arranged for her to marry Lorenzo Ponziani, commander of the papal troops of Rome and member of an extremely wealthy family.

Among her children we know of Battista, Evangelista, a child of great gifts, and Agnes.

The family flourished under Frances' care, but within a few years a great plague known as the Black Death, began to sweep across Italy. It struck Rome with devastating cruelty and left Frances' second son dead. In an effort to help alleviate some of the suffering, Frances used all her wealth and sold her possessions to buy whatever the sick might possibly need. When all her resources had been exhausted, Frances and Vannozza went door to door begging. Later, Frances' daughter died, Frances opened a section of her house as a hospital.

Frances united many Roman ladies in an association of oblates attached to the White Benedictine monastery of Santa Maria Nuova; later they became the Benedictine Oblate Congregation of Tor di Specchi which was approved by Pope Eugene IV on July 4, 1433. Its members led the life of religious, but without the strict cloister or formal vows, and gave themselves up to prayer and good works. They offered themselves to God and to the service of the poor. The community later became known simply as the Oblates of St. Frances of Rome.

Once the society was established, Frances chose not to live at the community residence, but rather at home with her husband, nursing him for the last seven years of his life from wounds he had received in battle. When he died in 1436, she moved into the monastery and became the superior continuing to serve the poor. Frances passed away on March 9, 1440, and was buried in Santa Maria Nova. Frances was canonized in 1608 by Pope Paul V. The Feast of Saint Frances of Rome is celebrated on March 9th.





Though one of her old-fashioned relatives put an end to this, the story speaks to the splendor of Italian cinema and its ability to inspire dreams in young people just like the fictionalized Hollywood of legend. In honor of Italian contributions to movies, I often serve star-worthy Italian dishes for my Oscar-watching events. A few years ago, I made a delectable mascarpone cheesecake drizzled with chocolate sauce. It was such a decadent and creamy hit that I plan to make it again on Sunday, an appropriately stylish plate for the most glamorous night of the year.

Films are a roadmap of our hopes, dreams and values. I encourage everyone to watch at least a few of the Best Picture nominees before the Oscar ceremony on Sunday in order to find one that resonates on an emotional level. Good movies enrich our lives, as they provide us with visions of another world or new perspectives or characters so strongly written that they remain inside our mind long after the projector has stopped running. This month, I will revel in the Oscars in order to pay tribute to the films that have enhanced my life journey, and I will also pause to honor the Italian movies that have become milestones in my culture and heritage. After all, the ability to view films as more than just entertainment but as significant social art and artifacts is an achievement worthy of an Academy Award in itself.

Recently, I read a news story on the upcoming Lt. Michael Quinn Scholarship Banquet and can't believe this is the 50th anniversary of this annual banquet which was established back on September 8, 1969. Three Townies got this banquet going who were friends of Quinn. They were Steve Driscoll, the late Eddie Johnson, and Ronan Fitzpatrick.

Michael Quinn was a Townie's Townie. He was born in 1946, two years before me. He graduated from both Boston Latin School and Holy Cross in Worcester. He is enshrined at both schools in the Hall of Fame in both football and hockey.

Quinn had his whole life in front of him upon graduation, he enlisted with the United States Marines to serve and defend his country. Quinn was deployed to Vietnam as a young $2^{\rm nd}$ Lieutenant and made the ultimate sacrifice. He was given both the Purple Heart and Bronze Star for saving many of his fellow Marines on that long ago August day while on Patrol near DeNang in Quang Nam province.

As a member of the Abraham Lincoln Post 11, GAR on Green Street I often stop by that monument dedicated to our fallen Vietnam War heroes including the forever young Lt. Michael Quinn whose generation which was also mine died in defense of the country oh so young. Gone but never forgotten. Heroes to all forever!





Nanna & Babbononno

A Nostalgic Remembrance



On a snowy weekday morning, when I was about ten years old, the radio announcer bellowed forth with: "No school, all schools, all day, in Boston." It was February and it was snowing. Now, you might think that with a public announcement like I just mentioned, that I would go back to bed and sleep the morning away ... just the opposite. My only thought was to get bundled up, head out to the top of Brooks Street hill and coast my way to the bottom, racing against the other kids of the neighborhood who dusted off their sleds after discovering that there was no school.

Most of the kids owned Flexible Flyers or Sears, Roebuck & Company sleds. I had a Snowbird. It was shorter than the average sled, made for only one person, but was it fast. Babbononno had given me a bar of paraffin wax to keep the blades friction free, and I used it every time I went coasting.

Nanna made me a cup of cocoa, which she insisted, would keep me from freezing. I loved cocoa, but I considered what she made as brown antifreeze and thought it would just slow me down once I got to the top of the hill. Mom, at the same time, whipped up some oatmeal. After one spoonful, I was dressing for a day at the races, sled races, Brooks Street hill sled races, East Boston-style.

Carrying my sled under my left arm, I ran to the corner of Brooks and Eutaw Streets and looked to my left up the hill. The starting point was the top of the hill where White and Monmouth Streets came together. When I arrived, there were already several neighborhood kids there, and more showing up every minute. A few parents (almost all fathers) were lolling around waiting to see if there kids were going to participate, before they headed off to work. They would eventually walk down the hill a couple of blocks and take the bus, which stopped at the corner of Brooks and Lexington Streets, and would bring them to Maverick Station.

The racetrack was as follows: we kids would pair off into twos, threes, or at most fours, and at a signal from a starter who would yell out, "Go," and shoot off a cap gun as he yelled. We racers would run a few steps, and then belly-flop onto our sleds and coast down Brooks Street from the White/ Monmouth Street beginning point, down the hill passing my street, Eutaw, continuing past Trenton, then Lexington, Princeton, Saratoga, and ending at the corner of Brooks and

Bennington Streets. Our side of the Brooks and Bennington Streets was the finish line. Bennington was a main thoroughfare and no one would dare try to sled across to the other side; it was too dangerous. (As you can see, the streets running across Brooks were named after battles in the American Revolution.)

When it was my turn, I went up against three other neighborhood kids, a boy named Walsh, who was called Squeeky, Walter Day from down the street, and my next door neighbor, Bobby Romano. They were the competitors I had to go up against. The only one I was worried about was Squeeky. He was skinny and had a fast sled, but at the sound of the cap gun and the word, go, I ran about five steps and then belly-flopped onto my Snowbird and coasted down the Brooks Street hill in search of glory.

We were somewhere between Trenton and Lexington Streets, and I was in the lead. Just then, a mutt ran out toward us racers and began chasing us, nipping at one of my boots as he ran parallel to our direction. I wiggled my leg, trying to shoo the dog away, but when all three of the other sledders passed me, I yelled to the owner, whom I happened to have known, "Ralphie, get your f_ away from me." Just then, I spotted Nanna and two of her lady friends coming out of a store that was within earshot of the worse expletive a kid could have used in public back then.

I continued coasting down the hill as my friend Ralphie scooped up his dog, but I had lost my momentum and came in fourth, or dead last, if you want to put it that way. Once the race was over, I began to think back to the point where I bellowed out the F-word and hoped that Nanna didn't hear me. In reality, I know she did hear me and spoke enough English to understand what I said. I was hoping that her lady friends didn't speak English, but that was too much to ask the gods of dirty words for.

Well, you can't coast up a hill, so I and the other three sledders from my race began dragging our sleds back up the Brooks Street hill. I had no problems until I reached the location where I yelled out the F-word. Many of the old ladies of the neighborhood were in their windows as I walked by, and I knew that most were friendly with Nanna. I also knew by the looks on their faces that they had heard me scream at the dog nipping at my boot. Regardless

Johnny Christy Orchestra of the reason for my tirade, I had yelled the one word that was offensive to everyone in town.

When I passed a few of the houses, the first floor windows facing Brooks Street opened and the ladies sitting inside had things to say, like, "Tu maiale sporco," (You dirty pig) or, "Aspetta di vedere tua mamma e tua nonna." (Wait until I see your mother and your grandmother) And, of course, I heard, "Guaglione, vai alla confessione." (Boy, go to confession.) By the time I reached the corner of Brooks and Eutaw (my street), the owner of the corner store spotted me and came out in the cold with his stained apron on and told me to go home immediately.

When I arrived, I knew I would have to suffer the wrath of Nanna, Babbononno, and my mother and I was right. Nanna chewed me out for embarrassing her in front of her friends. Mom chewed me out for sounding like what she called a gutter tramp. Babbononno's method was more simplified, succinct and to the point. I got a slap to the side of my head with the comments, "Schevozzo," (disgusting person) "Sfacchema," bad person, and "Stunada," (moron).

I was abandoned in the kitchen with another cup of cocoa, and the promise of, "Just wait until your father gets home." When Dad did arrive, he heard the story of my usage of the worse word in the English language. Dad, to my surprise, didn't get mad at me, but explained that there were alternatives to profanity and only common sense and a command of the language might diminish my anxieties. It took me a while, but I learned what he meant, and did things his way as I got older.

CALAMARI (SQUID) IN TOMATO SAUCE Over Linguine

14 ounces crushed tomatoes

- 1 medium chopped onion 1 large chopped garlic clove
- (optional)

 '4 cup olive, canola or vegetable oil
- 1 teaspoon dried basil or two fresh basil leaves

2 pounds already cleaned calamari (squid)

3 tablespoons white or red wine of choice

1 pound of linguine Grated Romano or Parmesan

cheese

Heat oil in skillet, add chopped onion, garlic (optional), and basil. Simmer until onion is opaque. Garlic should not brown. Add crushed tomatoes and stir thoroughly. Cover and simmer sauce until it comes to a slow boil. Lower heat and simmer for about twenty minutes. Stir occasionally to prevent sauce from sticking to the bottom of skillet. If mixture appears to be too thick, add a

half-cup of water and stir.

Cut tentacles from calamari if not already separated. Wash and cut each calamari into approximately one-inch widths. Do not cut lengthwise. A small calamari should give about three portions. Wash both thoroughly. Set aside in a bowl.

When sauce has simmered about twenty minutes, add calamari and tentacles. Then stir and cover. Simmer calamari in sauce for about five minutes. Do not overcook. calamari will become tough if cooked too long. Cover and remove skillet from heat until you are ready to cook pasta.

Cook linguine, or pasta of your choice, according to the directions on the package.

While pasta is cooking, return calamari sauce mixture to burner to reheat slowly. Add three tablespoons of red or white wine of choice. Bring to a slow boil. Turn off burner and remove from heat. Place cooked and strained pasta onto a serving platter and top with tomato sauce, calamari, and grated cheese of choice.

NOTE: In the 1930s, I remember my mother standing at the sink removing the thin layer of outer skin and the inner portions of the squid. She removed the tentacles and placed them in a separate bowl. When I asked if she was throwing the tentacles away she quickly replied. "No! Sono buoni!" (They are good!) Mama was right. I always include them in the sauce.



Conn, Zale, Louis,

And What Happened When a War Broke Out in the Middle of a Fight



Billy Conn

On June 18, 1941 Billy Conn and Joe Louis engaged in one of the greatest and most dramatic fights in heavyweight boxing history. Conn, outweighed by 25 pounds, gave the great Louis all that he could handle before he was kayoed in the 13th round. The fight almost immediately became the stuff of legend with many people believing Conn would have won the fight had he been able to last the distance. Joe Louis' performance and the scorecards tell a different story, but a rematch is what the public wanted to see.

There was talk of the two meeting again that September, but it didn't materialize. Promoter Mike Jacobs may have made the biggest mistake of his life by playing games when negotiating with Conn's management people. When Uncle Mike made them an offer they didn't consider fair, instead of trying to compromise he gave them an ultimatum; they could either take it or he would match Louis with Lou Nova. Johnny Ray, Conn's manager, called Mike's bluff and told him to go right ahead and make the Nova fight, which Jacobs ended up doing.

In the meantime, Conn signed on for a series of fights while he was biding his time waiting for the inevitable rematch with Louis. But then something happened that would change history. On December 7, 1941 the Japanese attacked Pearl Harbor and the United States was plunged into war. Young men weren't waiting to be drafted, they were signing up to join the fight to preserve freedom.

Conn had plans to enlist in the Navy but he still had time to fight three more times and it was planned for him to face Louis again on June 24, 1942. This would to be the last great fight before things would be put aside and all focus would be on the war effort.

In January of 1942 Conn defeated Henry Cooper and then Jay D Turner. He would have one more fight before his rematch with Louis. In that fight he took on reigning middleweight champion Tony Zale. It may seem odd today that he would be fighting a middleweight right before challenging for the heavyweight title, but remember that Conn was a light heavyweight and he would have less of a weight advantage on Zale than Louis had on Conn himself.

In the fight which took place at Madison Square Garden on February 13, 1942, Billy outweighed Tony by nearly ten pounds. Newspaper accounts of the fight state that Conn won the 12 round decision by a comfortable margin, but that many of the rounds were close. Tony Zale was a rough customer and Conn knew he had been in a fight. In fact years later he said that he took one shot to the body from Zale and decided to spend the rest of the fight backing away from him.

After the fight Conn joined the Navy. Tony Zale also signed up for the military. As for Conn's rematch with Louis? Well, that would take place in June; however, it was until June of 1946.

The fight was still set to go on in 1942, but something else had come up. Conn had an argument with his father in law, the baseball player Greenfield Jimmy Smith. They were both hardheaded and hot tempered and often got into confrontations that would lead to blows. This occasion was no different, only in this brawl Billy came out with a fractured left hand. The injury put an end to the planned fight with Louis and a million dollar gate.

Conn, Louis, Zale, and many others would put their careers on hold until after the war. These men all lost the prime years of their careers and a huge amounts of money because they put their country ahead of their own self interest. They all were great fighters, but they knew the fight to defeat the evil that was infecting the world was the most important battle they could engage in.

This was also true with those in Hollywood and in many other fields. It was an amazing time. The country which had been stuck in the Great Depression for nearly a decade was now faced with a war that would engulf the entire planet. Millions of lives would be lost, but because of the unity and fortitude of the American people the Axis was defeated and freedom was preserved.

I wonder how people would respond to such a challenge today. Would they defend the values this country has stood for? Would they fight to defend freedom? Or, would they take a knee? I'm not sure I want to know the answer.

They are the ones that are always there but that you never see. They attend games and practices, enter the locker rooms, give advice to players. Some are actually behind the bench and thus may briefly glimpsed on television.

But no matter what, they are "the others" to most fans. Always there but rarely speaking up.

They are the assistant coaches of the Boston Bruins, a necessary and vital part of A fine-tuned team that was, as of this writing, having an exemplary road trip as the fight for the highest playoff berth possible assumes more importance with each passing day.

Local fans may know Joe Sacco the best since he is a native of Medford and played for Boston University before embarking on an NHL career that covered a span of 13 seasons. During that time Sacco played in 738 regular season games while seeing action with Toronto, Anaheim, the New York Islanders, Washington and Philadelphia.

Before he skated onto the ice as a mentor for the B's, Sacco had already put in 10 years as a coach, including four as the head coach of the Colorado Avalanche from 2009 to 2013. While living out every hockey coach's dream (to become an NHL head coach) in the Rockies, Joe went 130-134-40.

Another season followed an assistant with the Sabres (2013-2014) before then Bruins coach Claude Julien called with a job offer in Boston. So Joe came home to the area where it all began. He's now in his fifth season with the B's, one that has the possibility of being the best since he came to Causeway Street.

Jay Pandolfo is another assistant coach who grew up within commuting distance of the TD Garden — in his case the town of Burlington. He was drafted high by New Jersey, the Devils selected him with their second pick (32nd overall) in the 1993 NHL Draft.

There was a time when the best players never left college early — they played all four years for their respective alma maters and graduated on time. Jay was one of those quality players from that era, electing to remain with legendary coach Jack Parker for all four collegiate campaigns. He reigned supreme on Commonwealth Avenue from 1992-1996, scoring 79 goals from his left wing position plus adding 90 assists for 169 points. In his junior year the Terriers captured the NCAA Division1 Frozen Four National Championship. In his senior year, while serving as captain, he scored 38 goals and had 29 helpers for 67 points across 40 games while being named a Hobey Baker Award finalist.

Now you know why staying in college is the best decision. What are those experiences worth? They are priceless.

Then it was on to the NHL where he won two Stanley Cups with the Devils — in 2000 and in 2002. He also played with the Devils and in the twilight of his career spent a season with the B's, the latter being a foretaste of experiences on the horizon.

Within a year after his active playing days had concluded Pandolfo was named a player development coach by the Bruins and was promoted to Director of Player Development one year later.

During the 2016 off-season, when the team needed an assistant coach, coach Julien didn't have to look far. Pandolfo got the job on May 24, 2016 and has been in that position since then.

As you know, every head coach gets the opportunity to appoint assistants. Head coach Bruce Cassidy is no different. When Cassidy was the head coach in Providence prior to his joining the parent B's, one of his assistants was Kevin Dean. Dean was behind the bench with Cassidy for five seasons.

Then, when Cassidy became an assistant in Boston, Dean was promoted to the head job in Providence. A year later, when Cassidy permanently assumed the head job on Causeway Street, Kevin was moved up the ladder to an assistant's position on Causeway Street.

A native of Madison, Wisconsin, Dean played four years of college hockey at the University of New Hampshire before embarking on an 11-year pro career that started in the minors and later included stints with Chicago, Dallas, Atlanta and New Jersey in the NHL.

He then coached five seasons with the minor league affiliates of the New Jersey Devils before joining the Bruins organization in Providence.

Football has many specific position coaches. Hockey at the collegiate and pro levels has one — goalie coach. The man who is the mentor to the netminders in both Boston and Providence is Bob Essensa.

Like coaches Pandolfo and Dean, Bob also played four years of college hockey — at Michigan State University from 1983 to 1987, earning first team All-League honors in 1985.

Drafted by Winnipeg, Essensa first played five seasons with the minor league affiliates of the Jets. Later promoted to the big club in Winnipeg, he also was a netminder for Detroit, Edmonton, Phoenix, Vancouver and Buffalo before retiring at the end of the 2001-2002. He had a 173-176-47 record to go with 18 shutouts and a 3.15 goals against average in 446 career NHL regular season games.

Within a year of his retirement as a player he was named the Bruins goaltending coach on September 9, 2003. Hard to see by the fans since he almost always sits in a ninth floor booth at the Garden during home games, he gets a bird's eye view of how the action develops (or in curtailed by the defense) in front of his goaltenders.

Current frontline goalie Tuukka Rask joined the Bruins organization in 2006 and put in his years in Providence. Between those years and the ones in Boston, Bob Essensa is the only goalie coach Rask ever had while performing in net for the Bruins organization.

In Memoriam — Remember-ing *Boston Herald* sportswriter Stephen Harris, whose funeral was one year ago on Presidents Day (February 19, 2018) in Sudbury. Steve worked for the Herald for over four decades. His main beat was the Bruins but he also covered seven Olympics as well as numerous Boston Marathons. His mother was Patricia Donnelly — the Miss America of 1939.
