

hold what is called a "hybrid primary" for both parties. This means that independents can choose which primary they vote in, but have to temporarily register with that party. In an "open primary," you can vote in either party's race, regardless of your affiliation (but only one!) In a "closed primary," you can only vote in your own party's election and independents can't vote. Some states may hold a primary or caucus for only one party on March 1st. In a caucus, unlike a primary, individual votes are not secret and don't count. A caucus requires groups across the state to meet and decide as a group which candidate to support, often by a show of hands. Consensus is required and, in the case of ties, coins are often flipped to break the tie!

Alabama, Arkansas, Georgia, Massachusetts, Minnesota, Oklahoma, Tennessee, Texas, Vermont and Virginia will hold primaries for both parties. Alaska will hold its Republican caucus, while American Samoa will

caucus for Democrats. Colorado will caucus for both parties but only the Democrats are choosing a candidate. Republicans in Colorado have opted to select delegates only and then let those delegates choose which candidate to support at the national convention. (Hmmm, maybe that legal marijuana is loosening their collars a bit?) The big prize on Super Tuesday is Texas, which has 155 Republican and 252 Democratic delegates to assign. Like most states voting next week, Texas' delegates will be awarded proportionate to the primary vote.

This year, Super Tuesday is also being referred to as the "SEC Primary." You college football fans will notice how many Southeastern Conference team states are voting on March 1st! Alabama, Arkansas, Oklahoma and Texas all moved their primaries, giving our 2016 Super Tuesday a decidedly southern flavor. It remains to be seen how this will impact the overall



# Stirpe Nostra



#### VITRUM (Continued)

Lucretius is the first Roman writer to use the term "vitrum." However, Cicero had long before spoken of a substance similar to our glass that was used as a common item of merchandise. During ancient times, glass was chiefly used to make bottles, vases, cups, urns for cremated remains, and all in many different shapes and colors. Glass was also very skillfully used in making counterfeit sapphires, amethysts, carbuncles, and emeralds.

One decorative method employed by these ancients was to enclose gold leaf designs between two layers of transparent glass. They also used thick sheets of colored glass for paving floors or for wall and ceiling finishes. The excavations at Pompeii have revealed evidence of the use of flat glass for windows or for lattice-work screens. Mirrors were also known in antiquity, and were made from a heavy glass, covered with a thin leaf of metal at the back.

Glass was available in a variety of colors, but it was the clear, colorless variety that was most valuable at this time, and it is also noted that the art

of etching upon glass was unknown to the ancients.

It is claimed that malleable glass was discovered during the reign of the Emperor Tiberius (about 25 A.D.). A story is told about a man who showed a glass vase to the emperor and then threw it to the stone floor. The vase did not break or crack, but instead was only dented like a piece of metal. The man then proceeded to hammer it back into its original shape. After numerous inquiries, the emperor was satisfied that no one else was acquainted with the secret, and the man was beheaded so that all of the precious metals would not lose their value when this new composition became generally known.

For those who haven't guessed it by this time, the punch line and moral of this story is "never lose your head over a piece of

## **Chris Nobile**

## Announces Candidacy for the North Andover Board of Selectmen

Finance Committee member Chris Nobile announced his candidacy for the North Andover Board of Selectmen. Nobile, a former School Committee member, said he hopes to add a fresh voice and unique perspective to the Board. "We have a real opportunity right now to engage our residents and bring our town to the next level," said Nobile. "We've weathered the deep recession, and now is the time build our Master Plan, revitalize our Main Street, and plan for our future. I know my perspective will be an asset to the Board and our community."



As a member of the Finance and the School Committees, Nobile developed a reputation for utilizing his business background to dive into municipal budgets, showing respect for taxpayers, while also working to maintain town services. His hope is to apply these experiences to the Board. "I've spoken with many people in our town who share my desire to see more on our Main Street," Nobile said. "It's been almost 20 years since the town set out to build a Master Plan and lay out goals for this neighborhood."

Although not with a master plan, Main Street has started a transformation in recent years. The former Bradstreet School building was sold and will soon be apartments and businesses. And as part of the Facilities Master Plan, the old Fire Department will soon be filled with town employees as the newly renovated, doubled-in-size Town Hall opens in the fall ... which may add foot traffic to downtown.

"Our current plan for Main Street is from a time when both a supermarket and kindergarten called our Main Street home ... a lot has changed since then, but we've not responded to these changes," Nobile said.

Before being appointed to the Finance Committee by Town Moderator Mark DiSalvo in 2014, Nobile served on the School Committee and has coached youth sports. He and his wife Suzanne have two sons



Dear Editor,

As an Italian-American, I remember my sense of ethnic pride when Antonin Scalia was nominated by President Reagan and confirmed by the Senate in 1986 by a 98-0 vote. He was the first Italian-American jurist named to the High Court in our nation's history.

Over his tenure on the bench, he always supported the U.S. Constitution and its Bill of Rights. He was called an originalist, meaning he preferred to rely upon the judgment of the wise men who constructed our system and "the people who approved it, and the two centuries of history that have shown it to be sound," said Scalia.

Scalia believed the Constitution is what it says it is. Words had meaning to him. He was neither a liberal nor a conservative jurist, he was a constitutionalist and proud of it.

During a debate on the 14th amendment, when discussions turned to who was covered by that amendment, some said it was meant only for free slaves when it was written. However, Justice Scalia stated the 14th amendment was clear, if it said equal justice under the law was for all, it meant for ALL.

We will probably never see another great mind like his again on the U.S. Supreme Court and his clarity of law will be solely missed.

## Ice Seals Arrive in Massachusetts

Aquarium Encourages Public to Enjoy but Keep a Safe Distance

The record frigid weather was not the only thing to arrive from Canada last week; the "ice seals" also arrived on the mainland Massachusetts coast from Cape Ann to the South Shore, fresh off of a long swim from Nova Scotia. Each winter over the last two decades, young harp seals and the occasional adult hooded seal take a mid-winter vacation from the ice fields of the Canadian Maritime Provinces and bask in the relative balminess of a New England winter.

This past week, Aquarium marine animal rescue staff and volunteers responded to calls from Marblehead, Nahant and Norwell for juvenile harp seals with their spotted, creamy white and brown-colored coats. Weighing anywhere from 40-70 pounds, these 3-4 foot-long seals often haul out in high profile locations. In the attached images, one can be seen lounging in a very nice neighborhood in Marblehead last week. It is also not uncommon for these seals to spend a couple of days out of the water in the same location.

In fact, for hardy beach walkers, the winter may be the best time to see a seal in the wild along the Massachusetts coast. But there are some rules that the Aquarium would like to remind people of:

- 1. SEALS BELONG ON THE BEACH They are not stranded. They haul out of the water regularly to rest.
- 2. SEALS NEED SPACE Federal law requires people to stay at least 50 yards away. Too close a human presence interrupts their rest and will cause them major stress and a possible decline in their health.

- 3. LEASH YOUR DOG Dogs are likely the first to find a seal, and their excited behavior will likely disturb it.
- **4. WHAT CAN YOU DO?** Take pictures from a safe distance. Tell others approaching about the rules. If on the North or South Shores and the animal is visibly injured or ill, call the Aquarium's marine animal hotline at 617-973-5247.

They're cute, furry and have a face that could melt your heart, but don't get too close. When most people see a seal, they are excited, curious and concerned, which is great. Unfortunately, people sometimes do things which, although well-intentioned, can actually do more harm than good. Share the shore with seals to keep everyone safe and to create a lifelong memory.

#### With the Advice, Consent and Affirmation of the Senate, Too

## **REP. JAY LIVINGSTONE**

Announces Campaign for State Senate

in Massachusetts' First Suffolk & Middlesex District

State Representative Jav Livingstone, of Boston's 8th Suffolk District, announced his candidacy for the upcoming special election to fill the State Senate seat vacated by Anthony Petruccelli, which includes parts of Boston and Cambridge, the city of Revere and town of Winthrop. Livingstone said that such a diverse district needs a proven effective leader with a broad vision, and he will emphasize his accomplishments as a legislator, both for his district and for families across the Commonwealth, in the campaign.

"I know from my time as a legislator how to deliver for diverse communities," Livingstone explained, "and that's what this district needs. Senator Petruccelli was able to deliver for all the communities in the district and it is critical to maintain that standard. I'm proud of what I've accomplished for my constituents in Boston and Cambridge, and I look forward to reaching out further and getting to know the people in every neighborhood of the Senate district.

Livingstone has been endorsed by leaders from across the district, including Cambridge Mayor Denise Simmons, State Senator Will Brownsberger, Boston City Councilor Josh Zakim, Winthrop Town Councilor Rich Boyajian, and former Revere City Councilor John Correggio. 'That's what I've been able to do in the House, and that's why I am running for State Senate. I look forward to campaigning throughout the district, discussing my record, listening to the voters' concerns, and working to earn their support."

## Saint Brendan the Navigator

Saint Brendan of Ardfert and Clonfert, known also as Brendan the Vovager, was born in Ciarraighe Luachra, near the present city of Tralee, County Kerry, Ireland, in 484. He was born among the Altraige, a tribe originally centered around Tralee Bay. His parents were Finnlug and Cara.

He was baptized at Tubrid, near Ardfert, by Bishop Erc. For five years he was educated under Saint Ita, "the Brigid of Munster."

When he was six, he was sent to Saint Jarlath's monastery school

at Tuam to further his education. Brendan is one of the "Twelve Apostles of Ireland," one of those said to have been tutored by the great teacher, Finnian of Clonard. He completed his studies under Saint Erc, who ordained him a priest in 512.

Between the years 512 and 530, Saint Brendan built monastic cells at Ardfert, and at Shanakeel ... at the foot of Brandon Hill. It was from here that legend tells us that he set out on his famous voyage in his quest of the "Land of Promise." The story of the seven years' voyage was carried about, and soon crowds of pilgrims and students flocked to Ardfert. Thus, in a few years, many religious houses were formed at Gallerus, Kilmalchedor, Brandon Hill, and the Blasquet Islands, in order to meet the wants of those who came for spiritual guidance to Saint Brendan.

Brendan travelled to Wales and the holy island of Iona, off the west coast of Scotland; returning to Ireland, he founded a monastery at Annaghdown, where he spent the rest of his days. He also founded a convent at Annaghdown for his sister Briga. Having established the bishopric of Ardfert, Saint Brendan proceeded to Thomond, and founded a monastery at what is today County Clare, about the year 550.

He died in 577 at Annaghdown, while visiting his sister Briga. Brendan had arranged before dying to have his body secretly carried back to the monastery he founded at Clonfert. He was buried in Clonfert Cathedral. The Feast of Saint Brendan is celebrated on May 16th.

#### Queen Elizabeth II and Princess Diana:

A Tale of Tragedy and Mystery

Queen Elizabeth II has had her share of trying moments ever since she took the crown in 1952, but the death of Princess Diana, for which the world mourned in August of 1997, was the first to strike emotive chords with a global public. What the world didn't like about her response was that there wasn't very much of one, and her relationship with her deceased daughter-in-law continues to be a subject of tense debate.

Her message, delivered on September 5, 1997, from Buckingham Palace, seemed to share in the world's grief over the loss of the Princess of Wales.

"She was an exceptional and gifted human being. In good times and bad, she never lost her capacity to smile and laugh, nor to inspire others with her warmth and kindness. I admired and respected her ... for her energy and commitment to others, and especially for her devotion to her two boys," she said. "No one who knew Diana will ever forget her. Millions of others who never met her, but felt they knew her, will remember her. I for one believe there are lessons to be drawn from her life and from the extraordinary and moving reaction to her death. I share in your determination to cherish her memory."

But what kept her away from London upon hearing the news of the tragedy? As a new book by Ingrid Seward points out, the relationship between the Queen and the Princess was a strange and often turbulent one.

Queen Elizabeth II first met Diana when the 19-year-old accompanied her future husband Prince Charles to the Royal Family's summer residence in Balmoral.

"She is one of us. I am very fond of all three of the Spencer girls," was the Queen's initial reaction.

From there, however, the relationship became complicated and somewhat enigmatic. Diana often seemed ill-at-ease with the ways of life under the Royal Family, especially so after marrying the Prince in 1981.

Known for her love of privacy, it's difficult to understand the Queen's ostensibly aloof disposition during Diana and Charles's wedding. Perhaps she was uncomfortable with the media attention or maybe she indeed had reservations about Diana. Be that as it may, the Queen soon after began drawing attention to her doings rather than her son and his wife. Her Christmas broadcast. for instance, focused more on a Palace garden party and the christening of their first child, Prince William Arthur Phillip Louis, became more of a celebration for the Queen's 82nd birthday.

In hindsight it seemed inevitable to the world, but within the confines of Buckingham Palace, the marriage of Prince Charles must have seemed doomed early on and when the Prince and Princess separated in 1992, there was little hope for reconciliation.

Seward describes this turbulent time, "Like her own mother, the Queen has always coped with troublesome emotions by keeping the various difficulties of her reign in airtight compartments and never confronting the unpalatable. But the marriage breakdown could not be ignored forever."

In 1996, the couple officially divorced, and in August of the following year the world cried for a woman known for her charity and compassion. Once tears began to dry, however, the world began to ask why the Queen had remained in



Balmoral until the fifth of September with her two grandsons William and Harry?

"She was castigated for staying up at Balmoral with the two little boys," remarked the Queen's cousin Margaret Rhodes. "She was being a proper granny. What was the point of bringing the boys down to sit in London with nothing to do but sit there feeling sad about Mum. Personally, I think I would have behaved in exactly the same way."

Not surprisingly, Queen Elizabeth's own mother, Lady Elizabeth Angela (also known as the Queen Mum), came to her defense stating, "The Queen was criticized for two things. One was taking the boys to church. But they wanted to go to church. If you are a Christian and your mother has been killed, it is a comfort going to church. The other thing was that people expected the Queen to abandon her two grandsons .. whose mother had just been killed ... and go to London to mourn with people who had never even met the Princess. If vou stand back and think about it, it is an extraordinarily selfish attitude. Lady Elizabeth was hugely upset by the criticism of her daughter because she has always admired her so much. It was such a cruel criticism and it was unfair."

What is more surprising about Lady Angela's defense was the following statement, "There was a very close bond between Queen Elizabeth II and the Princess of Wales. She was of a generation that felt that anything that went on in a marriage was private between the couple. So it is certainly fair to say that she would have been deeply shocked when private feelings and thoughts were broadcast worldwide."

What was in the heart of the Queen? The death of Princess Diana has created too much speculation, too much anger, and too much emotive discussion for the matter to be finally settled and Queen Elizabeth's relative silence further seals the matter. Surely, her emotions were complicated ones and continue to be almost 20 years after the deadly car crash in Paris. In 1997, however, newly-elected Prime Minister Tony Blair may have saved her reputation by persuading her to return to London and speaking to the mourning crowds beforehand. But how much of the Queen's speech was genuine? Maybe it matters less than we think, for few disagreed with her words about Princess Diana, "She was an exceptional and gifted human being. In good times and bad, she never lost her capacity to smile and laugh, nor to inspire others with her warmth and kindness. I admired her and respected her ... especially for her devotion to her two boys."

## A Captivating Romeo and Juliet

at the Hartford Stage

"O Romeo, Romeo! ... wherefore art thou Romeo?'

In answer to that question, Romeo, Juliet, and all of the Capulets and Montagues are on the Hartford Stage under the very fine direction of Darko Tresnjak.

This Romeo and Juliet is nothing short of superb. Written over 400 years ago, the Hartford's production of Shakespeare's work is fresh and alive. The beautifully talented Kaliswa Brewster in her "dream role" as Juliet couldn't be more perfect as the young Ms. Capulet who is taken with the handsome Romeo, played by the equally talented Chris Ghaffari. The two are lovely to watch as their forbidden love blossoms. They perform their parts with much playful humor (the famous balcony scene is among the best and most original I have ever seen) on a versatile set inspired by the work of Italian neorealist cinema — think Rossellini and Visconti.

The first half of this beauti-

makes the audience relax and share in the excitement of the title characters as they become more and more enthralled with each other. We laugh and share in their joy. Of course, we are made well aware of the tension that exists between the two families, but some how we feel things will work out just fine. Yes, even knowing the story, our emotions follow that arc. It is the magic that director Tresnjak is able to make happen on stage. It is not the first time I have seen him do this.

Mercutio (Wyatt Fenner) is unlike any you have seen before. He is intense and, well, mercurial. And it is when he meets his end, that our joyful mood takes a sudden and very real turn. "A plague on both your houses!" Again, it is that Darko magic at work. I observed laughter turn to tears in the audience as things descended into darkness because of the petty hatreds of the two families.

Charles Janasz brings wisdom and warmth to the part of Friar Laurence, and Kandis Chappell as Juliet's nurse joins him in the failed and finally tragic attempt to recon-

cile things for the lovers and families. Our hearts break for them as well.

Everyone in the large cast is terrific. The set, with a balcony that extends and recedes from a wall designed after an Italian cemetery wall, and lighting are to the usual high standards of the Hartford. This production is a joy for all of the senses. Within minutes of the opening, the theatergoers feel they are a part of all that is happening on the stage.

Even if you have seen Romeo and Juliet, before, do not miss this one as it is unlike any before. If you have never experienced it, there is no better time than now to see it for the first time, though I must warn you it may spoil you for future productions.

I have now attended enough Shakespeare productions directed by Darko Tresnjak at the Hartford to say his are by far the best in New England.

I urge you to take the short run down to Hartford to see this play. You'll be sorry if you miss it.

The Egyptian Association for Rights and Freedoms documented 314 cases of forced disappearances in 2014; five of the disappeared later turned up at the morgue.

## MUSTARD GREENS FRITTATA (Omelet)

20 ounces frozen chopped mustard greens \* 1 cup flavored bread crumbs 3 tablespoons grated Romano or preferred cheese 2 medium minced garlic cloves ½ cup canola, vegetable or olive oil 2 beaten eggs


Defrost chopped mustard greens in the microwave according to directions on the package or in a saucepan on your stove. Drain liquid and place mustard greens in a bowl. Add bread crumbs, cheese, minced garlic and two slightly beaten eggs. Salt to taste and mix thoroughly.

Salt

Add oil to a skillet and heat. Test a teaspoon of mixture in heated oil. When mixture sizzles, place the remaining mixture into the skillet. Oil should remain hot so that the mixture will brown but not burn. Add more oil as needed. With a spatula or fork, turn small portions at a time, careful not to burn. Continue frying and turning until the contents have mostly browned, about fifteen minutes. Then carefully slide contents onto a platter. Return the mixture face down into the skillet. Lower heat slightly and allow mixture to brown on that side. Then slide the contents back onto a serving platter. To remove excess oil, slide frittata carefully from platter onto two paper dishes. Repeat for the other side. Wipe oil from platter before returning frittata to a serving platter.

\*FOR FRESH MUSTARD GREENS: Clean, cut, and steam them. What is not used that day can be frozen in a container for the next frittata.

*OPTIONAL*: Because of the tartness of the mustard greens, try substituting ten ounces of chopped spinach for ten ounces of mustard greens, equaling the twenty ounces needed for this recipe. Try it both ways.

# Nanna & Babbononno

A Nostalgic Remembrance



Easter Sunday is on March 27th this year, a bit earlier than usual. But, that's OK. I have always loved Easter for many reasons. First of all, I grew up a Catholic, and went through the teachings of the Catholic Church like most Italian-Americans. I was proud of my faith and my family that always gathered together when holidays like Easter, Christmas or secular holidays like Thanksgiving brought the generations of them together.

For the members of my family, Easter Sunday was a holy day, a holy day when you showed off your newest clothing when you went to Mass. I don't know if dressing for Easter is as important today as it was when I was a kid. When I attend Mass now, I see people dressed in clothing I wouldn't wear unless I was going to work under one of my cars. I guess times have changed.

Back when Nanna and Babbononno were young parents and my mother and uncles were kids, you dressed for Mass every Sunday. Just prior to Easter. it was time to outfit the kids with something new. If there was money left over, Nanna and Babbononno might be seen taking the kids to Easter Sunday Mass wearing their new clothes, also.

It was 1925 and Easter was going to fall on April 12th. Nanna and Babbononno decided that the kids were all going to be fitted with new clothing around the beginning of March and led the way for them from Eutaw Street to Central Square. Central Square in East Boston has always been a Mecca for retail stores. The department store Babbononno liked was Goldenberg's. He had bought clothing from them in the past and trusted the quality they sold and liked the fact that they employed people who spoke Italian. (My mother would someday work at Goldenberg's as a saleslady.)

First would be my mother who was sixteen years old. She was fitted for a new dress, stockings and some type of a headband that was popular with the ladies in the mid-twenties. Next came Uncles Paul, Nick and Gino ... they would need new suits. Uncle Paul was almost an story is that Babbononno made adult, but still in school. Uncle my mother quit school to go Nick was about eleven and uncle Gino, seven. One of the Goldenberg brothers waited on them, helping the Contini boys try on new suits. Each tried on a suit that was a different color, but the same style as the rest, three-button single-breasted worsted wool. Once all three of my uncles were examining their new clothing in the three-way

mirror in the men's department, Mr. Goldenberg, with a smile on his face spoke to Babbononno, "Just think, your sons can walk to church on Easter Sunday with these magnificent suits for only fifteen dollars each. Babbononno smiled with a look of semi-approval on his face. He discussed the price with Nanna in Italian with the salesperson looking on. The man called out to his brother who was helping another customer, "Just look at how well these suits fit the boys in this family." The brother looked at my uncles. my grandparents, and then at his brother who was trying to make the sale. He yelled back, "The suits look custom-made for the boys. You would never know that they only cost twenty dollars each." Nanna turned to Babbononno and said in Italian, "Here comes the sales pitch. He will tell his brother he made a mistake on the price he gave us, and can't retract it. Then he will tell us what a bargain we're getting." Sure enough, the salesman yelled back, "I made a mistake on the price. I told these nice people the suits were fifteen dollars each and can't go back on my word. We will have to take the loss." Babbononno thanked Mr. Goldberg but added (in broken English), Thank you for the bargain and being so honest, and I will definitely take the suits if you add in a white shirt, a celluloid collar and a new necktie for each of my boys." Mr. Goldenberg yelled something to his brother in a language neither of my grandparents understood. A customer who walked by them evidently understood Yiddish, the language they were speaking, and whispered to Nanna, "They just said yes to one another in my language. You are getting a bargain." So, at the beginning of March in 1925, the Contini kids were outfitted for new clothing for Easter Sunday and beyond. A corollary to this part of the story...about a year later, my mother would go to work at Goldenberg's as a saleslady. They actually paid her extra because she spoke several dialects of Italian, a feat no one on their payroll could do.

The one negative part of this to work. She wanted to finish high school, but my grandfather didn't think women needed education. He agreed that they should know how to read, write and count, but beyond this, it would be a waste of time. (Don't forget, he was born in 1875 Italy.) He thought his sons should go to school and learn whatever trade they liked, but

his daughter, she should go to work, help support the family and save some money for when she would get married. Actually, my mother was quite good with math. She could look at an addition column with about seven or eight numbers across and ten or twelve down and immediately give you the answer. When Babbononno wanted her to guit school, she pointed out his paesano, Mr. Jannini, who let his youngest daughter, Rose, go to college and medical school. Babbononno's out was that Mr. Jannini didn't have any sons, so daughter Rose would take the place of a son. He would add that his oldest daughter, Laura, would take care of her doctor/sister in her career ... and it would happen that way. (Rose Jannini was either the first or second Italian-American female doctor in the United States. If someone knows more than this on this subject, please let me know by calling or writing me at the newspaper office.)

One more thing happened that Easter of 1925. Early in the winter months, Babbononno bought a lamb to be raised and fattened for Easter Sunday dinner. Where my grandfather came from, lamb was the traditional meat that was found in the center of the dinner table on Easter Sunday.

Babbononno fed the lamb every day that winter. It lived in the shed in the back yard of their home at 70 Eutaw Street in East Boston. When it was too cold, it slept in the cellar. All but Uncle Gino, who was seven years old, knew that the lamb was part of their dinner menu on Easter. To my youngest uncle, the lamb became a pet. He played with the lamb, fed the lamb and talked to the lamb as if it was a dog. Toward the end of Holy Week that year, Uncle Gino came home from school and found the lamb missing from the shed. He searched the house for his pet without any luck. On Easter Sunday, he looked at the center of the Contini dinner table, and with horror written on his face, ran to his bedroom and cried. To this day (he will be 98 in June), he still doesn't eat lamb.

Tony Phillips, who made a great final defensive play that led the Athletics to a World Series victory over crosstown rivals the Giants in the earthquake-interrupted 1989 World Series, recently passed away at age 59.

#### ALI: A Great Fighter Who Stayed on Too Long



Ali vs. Bonavena.

When boxing fans think back on the career of Muhammad Ali, they remember a fighter so fast it was nearly impossible to hit him. The image a lot of people have is of Ali stopping Cleveland Williams. He looked incredible that night, dancing and moving with unmatched speed, his hands by his sides, using the Ali Shuffle while dropping the hard-hitting Williams repeatedly before finishing him off in the 3<sup>rd</sup> round. Many have called this Ali's greatest night. He certainly did look unbeatable against the aging Williams. More importantly, I don't think the champion got hit with a single solid punch.

Muhammad cemented his reputation as a boxer who was nearly impossible to hit during the first half of his career. Masterful performances against Sonny Liston, Floyd Patterson, Ernie Terrell, and Brian London certainly gave validity to him calling himself "The Greatest." His blinding speed and uncanny reflexes made him look like poetry in motion when the bell rang. Sure, he had been dropped in earlier bouts, but as he matured he continued to improve immensely.

In 1967, Ali was exiled from boxing for refusing to be inducted into the military. At the height of his career, he was no longer permitted to practice his profession. For three years he was idle and did not enter the ring again until 1970, when he took on Jerry Quarry in Atlanta, Georgia. In that fight, the public looked forward to seeing if the champion still retained his great skills. The Quarry fight did not answer the question, as it lasted only three rounds with Quarry losing because of a cut eye.

Next up for Ali was Oscar Bonavena. This fight would tell us more about Ali. Bonavena was a tough and awkward opponent who had twice fought Joe Frazier, dropping Joe twice in their first bout and taking the champion fifteen rounds in a rematch. Oscar was no fancy boxer, but he was tough and very strong.

In this fight, Ali was dancing and his hands were fast, but his South American opponent was able to connect on him. Had something changed with Muhammad, or was he now facing an opponent who was younger and faster than those he dealt with before his exile? As great as he looked against Cleveland Williams, it has to be remembered that Williams' best days were long past when they met.

Looking at the Bonavena fight, I see a still fine athlete in Ali. He is still fast with great reflexes. However, it has to be noted his foot speed has slowed up just a bit. This, coupled with the fact he is in there with a young and confident opponent, made this Ali's most difficult fight in years. He did show solid punching power in decking Oscar three times in the fifteenth and final round, winning the fight by a TKO. I do have to mention here that Ali was given an assist by the referee who did not enforce the rules by making Muhammad go to a neutral corner and by not giving Bonavena an eight count after the knockdowns.

Ali would go on from here to fight Joe Frazier in the epic Fight of the Century, where we would see him for the first time employ his Rope-a-Dope. This would be the beginning of a new tactic used by The Greatest, where he would lean on the ropes with his hands by his face while his opponent would just pound on him. He would appear

impervious to pain while this was going on. He would lose a decision to Frazier after being floored by a tremendous left hook in the last round.

In his fights with Bonavena and Frazier, Ali got hit by more punches than in all of his pre-exile fights combined. Was it because his skills had eroded over the three-year layoff, or was he just meeting a higher caliber of opponent now? In the time he was off, a young crop of heavyweights had matured to replace the old guard. But it has to be noted that the Ali of 1970 and after was not the same man as earlier in his career. He was still fast and agile, but his speed had slowed just enough that it was now possible to catch him with shots that never would have landed in the past. Also, even though still a young man, Ali's legs had aged a bit. He no longer could sustain the constant foot movement round after round. In order to compensate, he would lie on the ropes. He called this a tactic, but in reality he had no choice.

In his fight against George Foreman it was insanity to do this. Ali realized early on in that bout he was not going to be able to outrun Big George, who was a master at cutting off the ring. I believe Muhammad had gone into that fight planning on repeating his performance in the first Liston fight, but soon found he could not keep up the pace against George. So instead, he did the only thing he could do. He allowed the champion to punish him on the ropes in the hope he would tire himself out, which is exactly what happened. While fight fans have come to think of this as an ingenious tactic, it was actually the beginning of the end for Ali. By this I don't mean the end of his career, but rather the end of his career as a great boxer. From here on out, Ali would absorb tremendous punishment in many of his fights. This punishment would lead to his being a physical wreck by the end of his career.

The fact is, Ali was never a great technical boxer along the lines of a Jersey Joe Walcott or Archie Moore. His greatness during the first half of his career was because of his amazing physical attributes. He had the uncanny ability to see punches with almost a sixth sense. He was a heavyweight who could move like a middleweight. He did many things wrong in the ring, but because of these abilities he got away with those mistakes. He had invented his own unique style that was almost totally dependent on his physical gifts. Once he lost his speed, he was not able to compensate with shrewd boxing ability. Look at his bouts with Shavers, Frazier, Spinks, and Norton and you will see him taking tremendous punishment. Even in training, he would let sparring partners pound on him. It was almost as if he thought he could toughen himself up by being hit. It is ironic that one of the most artful and beautiful boxers of all time would end up proving he could also absorb more punishment than almost any of his predecessors.

He would go on to participate in many exciting fights, but it came at a cost to him both physically and mentally. He did something he had vowed as a young man never to do. He stayed on too long. By the time he stepped into the ring against Larry Holmes, he was already slurring his speech. It was a sad end to a great athlete.

## HOOPS and HOCKEY in the HUB

WRITING ON THE WALL, WOES ON THE HOME ICE — Just like in the Bible, there's writing on the wall in the Bruins' locker room at the Garden. The actual location is an important distinction, because the B's this year often have not played as well in front of the home folks as they have on the road.

In fact, one gets the feeling that the team would rather play on the road this year than be in the building where they face the displeasure of the fans who seem to be vocal about the team's underwhelming performances on Causeway Street this winter.

Where the players gather before games, between periods and after games with Head Coach Claude Julien and his assistants, there are these words adorning one wall: PASSION. MOTIVATION. VISION. PARTNERSHIP. PER-SERVERANCE. With all due respect, we feel that there have been a number of nights on Causeway Street where the B's have fallen short of the words written on that wall. How else to describe the latest of those occasions (as of press time) when the Black and Gold lost a home contest against Columbus, the second worst team in the Eastern Conference, by a 6-4 score. It was an encounter that featured many of the polar opposites of the characteristics expressed in those five words written over the wall.

The setback was the 15<sup>th</sup> loss at home for the Bruins with their supposed home ice advantage to go with only a dozen victories. By contrast, the B's have won 20 games on the road with only seven setbacks coming in other buildings.

"It's tough," said B's winger Loui Eriksson after the loss to Columbus. "We definitely want to win when we come home and play in front of the fans. But we're not playing like we should. I think we play a much better game style when we're on the road. We just keep it simple and we're playing hard and not giving up that many chances to other teams. I think no one is happy about how we're playing at home. That's just something we need to address and get better as we go along here. We need to make our fans proud. We need to come out and play hard."

"It's hard to understand why it's happening," chimed in Bruins forward Matt Beleskey concerning the team's lack of success at home in the Hub. "I think we're playing hard in front of the fans here. Maybe we're just not as focused. It's no excuse. We need to be better at home for our fans. I don't feel less confident coming in here [the Garden]. It just seems to be the way things are going. I think we just have to bear down. We have to stay there mentally. You know as a professional this is where you want to play — at home. I just think we need to get that groove going and start rolling with it."

Even hard-playing forward

Brad Marchand has trouble putting his finger on the remedy.

"If we could pinpoint it, then we could fix it," he stated. "We seem to play our system and really stick to our script on the road," he noted. "At home, we kind of deviate from that and it ends up costing us."

Defenseman Joe Morrow had another take. Asked by media members if there is a mental block to playing at home this season, he feels there isn't. "I don't think that has anything to do with it. We have a lot of mentally strong players here really mature guys — that have been playing here a long time. I don't feel that anyone thinks 'we're playing at home, we're going to be at a disadvantage." I think we've just got to focus a little more, bear down a little more. It's not turning around as fast as we want it to. That has to change."

And substitute goalie Jonas Gustavsson, who got pinned with the loss against Columbus, had this comment about the team's subpar performance at home: "If I had the answer, then obviously we would fix that. I think it's about small details. We have it [the winning way] in this group. We show it especially on the road. Obviously we want to figure it out and be a strong team at home."

And despite it all, the Bruins are still in active contention for a playoff berth, just a point out of third place in the Atlantic Division (the top three teams in each division gain automatic berths) in late February and clinging to seventh place in the conference as a whole.

After coming back from an extensive road trip, the B's are in the midst of a fortnight that sees them play six home games with only one on the road. Then there's another stretch featuring a flock of road games.

After a home game against the Washington Capitals on March 5<sup>th</sup>, the Bruins face a 12-game stretch that will see them play 10 games on the road and only two at home. While in many years one would see this closing aspect (mostly road games) of the season as a possible negative, that might not be so for this year's Bruins.

Given the way the B's have played this year, that might just be the proper way to set them up for the playoffs. With so few games on Causeway Street down the stretch, that could be the B's best path to the playoffs this year.

And just think — if they manage to qualify for one of the lower berths in the Eastern Conference — then their first two games in the opening round will be on the road. That might be just another thing to consider in one strange season both on Causeway Street and away from it.

The Bruins look like a playoff team this season. Right now, that's the team you see on television when they're on the road. The team that has been playing at home writes a different tale.
