In the days leading up to the February 25th casino vote in Revere, it was considered a close election by all sides. However, following the 2-to-1 landslide victory, supporters of the casino were overjoyed at the margin of victory supporting the Suffolk Downs/Mohegan Sun casino proposal

The heated campaign drew out almost 45 percent of eligible voters as both sides spent lots of money to woo voters to the polls. In the end, supporters won the day in hopes a casino in the City of Revere will benefit Revere taxpayers and save the ailing racetrack.

John Ribeiro who chairs "Repeal the Casino Deal" was quite disappointed with the election's result but



Stirpe Nostra

JULIUS CAESAR

"De Bello Gallico" can probably be best translated as "From the Gallic Wars" and this expression is universally understood to identify the commentaries of Julius Caesar on those wars. They were campaigns which were conducted by Caesar from 58 B.C. to 51 B.C., and by which he conquered an area for Rome, approximately the size of France as we know it today. The commentaries seem to be a compilation of the dispatches which were sent by Caesar to the Senate at the end of each year of operations and these in turn were prepared from the information that he received from his staff officers. Critics have considered the literary style of these dispatches to be simple, straightforward and unadorned, with occasional touches of rhetoric. Present day reports claim that the original dispatches were presented in the form of note- Nicolas Coustou's Julius Julius to Nero constitute

six or seven thousand words in each book. This is the literary work which is claimed to have given Caesar a prominent position among the scholars in the Golden Age and also placed him among the world's greatest

Any attempt to report on the "commentaries of Caesar" at this time would be meaningless due to the lack of other background information on the Gallic Wars. I shall, instead, seize upon this opportunity to present an introduction to Julius Caesar in the next five weeks which should be interesting, even though it merely scratches the surface. I don't know any other way to do justice to the memory of the greatest Roman Emperors." that the world has ever known.

The name "Caesar" probably was derived from ancient Roman legends. Some say it came directly from the word "Caedo" meaning that the first bearer of the name was cut from his mother by Caesarean operation. Others derive the name from

> 'Caesaries" because the first Caesar was born with a full head of hair. Still others attach the name to "Caesius" as applied to the color of the skin and eves.

Caesar was the family name of Gaius Julius Caesar and after his death the title of Caesar was given to many succeeding emperors. However, the term 'Twelve Caesars" seems to refer specifically to Julius Caesar, Augustus, Tiberius, Caligula, Claudius, Nero,

Vespasian, Titus, Domitian, Nerva, Trajan and Hadrian.

> dictator but not an emperor; therefore, of the "Twelve Caesars" only eleven were emperors. It also might be of interest to note that in later years, the names Czar and Kaiser (absolute rulers) were derived from the Latin name Caesar.

> The Julio-Claudian line was followed by "The Flavian Emperors" who were Vespasian, Titus and Domitian. These are the emperors who were responsible for the construction of the "Flavian Amphitheater" which we now call the "Coliseum." The next three Caesars: Nerva, Trajan and Hadrian are part of a line of emperors which were called the "Antonines" or "The Good

Revere Says Yes!

In three short months, on Saturday, June 1st, live thoroughbred horse racing is scheduled to return to Suffolk **Downs** in **East Boston**. The grand old track, which next year will be 80 years old, has been in the news lately as part of the efforts to bring casino gambling to Massachusetts.

I'm a fan of Suffolk Downs and I appreciate the number of jobs the track provides right here in the City of Boston. The proposal, accepted by a two-to-one margin by the voters of Revere this past Tuesday, presented by Mohegan Sun, promises the creation of over 4,000 new jobs as well as the $\boldsymbol{preservation}$ of 800~jobs at "The Track." I believe it is unfortunate that the voters of East Boston did not seize the opportunity to approve the plan. However should the Mohegan Sun/Suffolk Downs proposal become reality there are still other hurdles to clear — East Boston and the surrounding areas will benefit from Revere's gamble that gaming, in the greater Boston area, will, on net, be good for our communities.

Nearly everyone agrees that there can be a downside to gambling. We've all heard the stories of badly implemented casino schemes in some cities that, rather than bringing the promised jobs and tourists, end up blighting the area. Suffolk Downs, which for eight decades has been allowed to offer pari-mutuel betting, has demonstrated that they can handle responsibly the management of a gambling operation.

Can I Carnival, Please?

Lately, it seems as if everyone around me is participating in some sort of exuberant jailbreak. How else can I explain my insistence on wearing the brightest pink-and-purple shirt I own on the first fifty-degree day we had in weeks? Or the impromptu film festival I had with my best friend where we decided to follow Star Trek Into Darkness with an episode of Ghost Adventures and then Downton Abbey ... but not before impulsively luxuriating on a green tea Frappuccino from Starbucks? How about today's sudden desire to belt out every word of Katy Perry's "Hot and Cold" — a song typically not on my indie-rock repertoire — in the car, much to my husband's horror? I blame spring fever for these outbursts of whimsy, and I can indeed feel the world pulsing with change as the winter snow melts away into delicate green fields. The evening skies look brighter, roads bustle with people aching to escape the confines of their home, and every day I count more robins hopping around on the lawn. This is an extremely exciting part of the year, when the promise of spring is so palpable one can taste it, minty and lovely, on the tip of the tongue. During this time, everything hums with a new energy, waiting to start again. Appropriately, this is the Carnival season, that pre-Lenten time of indulgence and celebration that welcomes spring with the right amount of tomfoolery.

With exception of New Orleans, Carnival is not a well-known holiday in the United States, a fact that has always puzzled me. Carnival coincides with the arrival of springtime, a period full of such hope and excitement that it seems tailor-made for dancing in the streets and wearing mysterious disguises. Even the name of this holiday hints at its decadent history. According to some scholars, the word "Carnival" derives from the Latin expression carne vale, or "goodbye to meat,"

Christian significance combined with pagan festivities that sought to chase away the spirits of winter and welcome in spring. Hence the predilection for golden, fried pastries in many parts of the world during Carnival, such as the jelly donuts popular in Germany and Poland and the pancakes of $Great\ Britain\ -\ these\ treats$ not only used up the butter and fat that in olden times was prohibited during Lent, but also resembled the spring sun with their round shape and yellow hue. In Italy, the preferred desserts during the Carnival season are cenci, or fried strips of dough also known by such whimsical monikers as bugie (lies) or chiacchere (chatter). These little delicacies always remind me of brisk, early spring days in my grandmother's kitchen, when I would excitedly wait for her to finish them with a dusting of powdered sugar. Yum!

In addition to food, Carnival is known for its exuberant feasts and parties, which open the festive season on the holiday of the Epiphany, January 6th. The events come to a lively culmination on Mardi Gras or Fat Tuesday, the last day before Lent begins on Ash Wednesday (this year, Mardi Gras occurs on March 4th). The traditional colors of Carnival are gold, green and purple, signifying power, faith and justice, respectively. These colors adorn the plentiful beads and masks that symbolize Carnival, adding to the thrilling feeling of surprise, spontaneity and mystery. Italy is a land where Carnival festivities, in all their multifaceted and diverse incarnations, reign supreme. The most famous Carnival manifestation in Italy definitely belongs to Venice, or il Carnavale di Venezia. This ancient feast features people dressing up in costumes of the 18th century and wearing masks that once graced the actors of Italian commedia dell'arte a type of improvised performance where each broadly archetypal character sported a corresponding mask. The referring to the moments of Carnevale di Venezia has extravagant self-indulgence become such an icon of the before food restrictions were city that visitors to Venice imposed during Lent. This will find the eerie, mystical

masks on display all year long. Other famous Italian Carnival celebrations occur in Acireale, Sicily and Viareggio, Tuscany, where elaborate floats poke fun at local events and politics. These floats are a reminder of the olden times when dissent was only permitted through sublime satire and whimsy, unleashed full-blast at only one time of the year. In the northern Italian city of Ivrea. Carnival is celebrated with an orange battle, a citrusy recreation of the town's revolutionary past. No matter what sorts of celebrations ensue, Italian Carnivals wholeheartedly embrace joy and abandon.

Indeed, I believe that these very traits of joy and abandon are what is missing from our everyday lives. When was the last time that you laughed so loudly that tears poured from your eyes or spun around in the rain? Carnival celebrations remind us that it is not only okay to indulge in our silly side, but that it is healthy to do so in order to combat the stress and the monotony that latched on to us throughout the winter. I see the lack of attention that Carnival receives in our society as a warning sign that we are much too serious — it is time to loosen up and embrace the wonders of life! Following the example of Carnival and letting ourselves be temporarily swayed by indulgences and extravagance, silliness and laughter, enriches our optimism and helps us become better people by instilling in us a joy that simply must be shared with others. This Carnival season, let yourself be carried away by whimsy, into a warm spring full of laughter and fun.



The History of **Saint Leonard Church**

A Neighborhood Church with a Global Impact **PART III**

Scuola Parrocchiale Di S. Leonardo, Boston, MA

In 1904, Saint Leonard's parish welcomed Father Valerian Pianigiani. It was under Father Pianigiani's tenure as Pastor that various Church groups still in formation today came to be, the most prevalent of these groups being the Third Order of Saint Francis and the Knights of Columbus. The Third Order is a group of lay men and women who wish to carry on the traditions of the Franciscans while living secular lives. The group counts among its most famous past members, Dante Alighieri, Michelangelo Buonarroti and Christopher Columbus. By 1920, Saint Leonard's chapter of the Third Order had over four thousand members.

The new century brought with it the idea of a parish school. Under the supervision of the Missionary Franciscan Sisters, Saint Anthony's School became the first Italian-American school in the United States. First located on North Bennet Street, it was built to surpass the public schools in terms of quality of education in the city of Boston. Saint Anthony's and the Franciscan Sisters opened their doors to Italian immigrant children on February 10, 1907 and it quickly became a North End icon and a relationship between the immigrant children, in mod-Franciscans and the Italian ern times children of varipopulation. Bennet Street location. Saint Anthony's found a more suitable site on Prince Street by the mid-1950s. The new building was the previous Paul Revere School and became the new home of the Franciscan sisters and the students of Saint Anthony's School up to its unfortunate closure in 1982.

The next Franciscan achievement in the city was the Saint Anthony Orphanage, founded to cope with the growing orphan population due in large part to the influenza epidemics of 1917-1919. Built in Jamaica Plain in large part to the work of Saint Leonard Pastor Father Antonio Sousa, the founder of the orphanage, it opened on February 10, 1921, fourteen years to the day that the parish school opened. In his interaction with the Italian immigrants, Father Sousa had always made the plight of orphaned children in the community a central topic.

In its early years, the institution was home to young girls, however within a few years, boys were being admitted. Hundreds of Italian immigrant children called the orphanage home. Eventually taken over by the Archdiocese of Boston, it is today known as the Italian Home for Children. ITALIAN CLASSES

Italian Classes will be the University offered starting March 6th, 2014 using the Sheltered Foreign Language Approach. Sheltered Foreign Language approach is a customized program tailored in teaching a foreign language specifically to adults. The program is based on the research conducted by Cummins and Krashen, who indicated that adults learners need visual materials as well as auditory materials to be able to grasp a second language. The research indicates that visual materials constitute an easier way to grasp language and that when auditory language is introduced concepts become more difficult to grasp. The uniqueness of this approach is that it is specifically geared for adults. Generally, lessons are fun and entertaining, allowing the students to feel free to communicate. Making adults comfortable is critical to their learning.

The program incorporates modules and testing materials developed by Mr. Robert Trifiletti. To assist adult populations, Mr. Trifiletti has developed lessons which are utilized in teaching Italian to adults. Teaching foreign languages via the computer and through PowerPoint presentations allows students frequent opportunities to practice the languages at home. The exercises are based on communicative competence, helping the students to speak almost immediately. Mr. Trifiletti also has developed modules and drills using the Sheltered Foreign Language Program. Much of the materials that do exist include many commercial books and audiovisuals and do not even relate to the adults who are learning a foreign language. Instructional materials hardly exist for adults wanting to learn a foreign language.

The instructor is Mr. Robert Trifiletti, born in Italy and has taught in Florence, Italy and Madrid, Spain for the Mangol Institute. He completed his graduate work at

of the Americas in Mexico City. He graduated from Ohio State University and completed his Master's Degree at Kent State University. He worked at the White House for two and half years during the Nixon Administration and was employed by the U.S. Department of Education for 34 years where he administered Foreign Language Grants, Foreign Federal Contracts to school districts, colleges and Universities. He was also the Director of the U.S. Department of Education Foreign Language Visitors center. At the same time, he also was employed as a second job with the Washington Post Newspaper Company for 29 years. Mr. Trifiletti received the 2005 President's Award for his volunteer work in teaching Italian and Spanish for the U.S. Department of Education Combined Federal Charity Program where funds would go to My Sisters Place a homeless shelter for Women.

The language course is nine week long and will start Thursday, March 6th from 1:00 to 2:00 o'clock in the heart of the North End. The class is held on the second floor at the Italian Center of New York City Boston Office at 317 Hanover Street, Boston.

If you are interested, please register in person on Thursday, March 6th at 1:00 pm at the Italian Center. Mr. Robert Trifiletti would like the interested students to attend the demonstration to appreciate the requirements for the class and to explain the sheltered approach to foreign language teaching.

Cady Huffman Comes to New England in Her New Show Hungry and Horny

Cady Huffman, Iron Chef America judge and Tony Award winning actress for her role as Ulla in the Producers will be appearing in her show Hungry and Horny at the Ocean State Theatre in Warwick, RI on Sunday, March 9th at 7:30 pm. 401-921-6800.

Cady spoke to me by phone from her home in NYC about the show, cooking and acting.

When I asked how she came up with the idea for the show and title, Cady told me three people inside of a week's time had come up to her suggesting she do a foodie cabaret act.

"I thought it was maybe time to do it. At the time I also got a call that space was available at 54 Below in NYC, so the timing was right and I went ahead with the idea. The working title was She Can Cook Too after the song from On the Town, but after talking it over I decided to go with Hungry and Horny as that is what it is all about, a show for people to have fun with and not take too seriously. I did run the title by my octogenarian mother who, when she heard, laughed out loud and said she loved it. It is about, food, sex and relationships with others. I also interact with the audience and want them to have a good time.'

The show features Cady performing a number of food related songs such as Life is Just a Bowl of Cherries (a favorite that she has been performing for years), Jambalaya, A Spoonful Of Sugar and I'm Just a Lonely Petunia in an Onion Patch as well as, on the love side, the very sexy Ann-Margaret song Thirteen Men and the show stopping If You Got It Flaunt It from The Producers.

With the show's emphasis on food and given her Italian background, (she has fond memories of her maternal grandmother Dede Capasiella's cooking), I assumed Cady must be a great cook. "I am a good cook. It is hard for me to say I am a great cook seeing I spend so much time around some of the greatest chefs in the world," a reference to her role as a judge on Iron Chef America. "I am a terrific sous chef. I also make a great brunch, waffles and eggs and enjoy getting together with friends to cook. I love to eat." What's her favorite Italian dish? "My grandmother's pasta fagioli."

Cady remembers deciding to be an actress at a very early age. "Having made my mind up when so young, I found it hard to believe other people had trouble figuring out what they wanted to be when they grew up." She

was also greatly influenced by Mary Grace Canfield who is best remembered for her role as Ralph the carpenter in Green Acres and who passed away recently. The young Ms. Huffman took Canfield's acting course, "It was Mary who taught me how to cross over that line from pretending to be someone while on stage to becoming the person in the role. Acting is about being the character as opposed to just putting something on. Expressing yourself through art makes you feel quite vulnerable. One

day when I was about 17, Mary gave me a monologue to read about being a wallflower. It was difficult to get through, but I found it very empowering being able to do it. She connected me with my confidence as an actor and taught me how to do it with joy. It is great to break through that fourth wall that gets in the way on stage. I want to connect with people and being on stage is very personal to me."

Does she have a dream role she would one day like to play? "I enjoy creating new roles, but I would love to play Anna in The King and I. That would be a treat for all of us.

Cady gave me some great news. She was recently in The Nance with Nathan Lane in NYC. It got fabulous reviews, but having played solely on Broadway, most people haven't had a chance to enjoy it. "PBS filmed a live performance, and I believe it will be aired sometime in the fall. I am happy they did as so few people are able to see these performances. Having it filmed on stage and then shown on television enables millions to see it."

We talked about her time in Boston when she appeared in Pirates in 2009. I mentioned how it was the only time I can recall a critic putting a show down because the audience was having too much fun. "I heard about that and thought it was funny. I don't usually pay a lot of attention to reviews, but I saw quite a few people got involved in that discussion." The audience can look forward to having a lot more fun watching Cady perform in Hungry and Horny. I think the only one who would be disappointed is a certain cranky critic.

Any chance you will be performing in Boston again? "There is always a chance and I would love to. I love Boston." For now I would advise people to make the short trip down to Warwick to see the very talented Ms. Huffman.



Shares with us a delightful recollection of her memories as a child growing up in Boston's "Little Italy" and a collection of Italian family recipes from the homeland.

Great as Gifts

Symphony Special Presentation ... The Boston Symphony Orchestra will welcome back Andris Nelson for a one night only performance on March 6th.

BSO Music Director Designate Andris Nelsons returns to the Symphony Hall stage for a performance of Richard Strauss's salacious and searing masterpiece Salome which caused scan-

dal at its 1905 premiere. It still provokes heated discussion today with its stark, graphic portrayal of Herod's court as well as its expressionistic and harmonically adventurous music in a performance to mark the 150th anniversary of the composer's birth. This concert performance of Salome is Mr. Nelsons' last appearance of the BSO's 2013-14 season and headlined by soprano Gun-Brit Barkman, who makes her BSO debut in the title role. The distinguished cast also features mezzo-soprano Jane Henschel as Herodias, tenor Gerhard Siegel (BSO debut) as Herod and bass-baritone Evgeny Nikitin (BSO debut) as Jochanaan.

The groundbreaking 1905 opera Salome was Richard Strauss's leap into modernism. The libretto is a nearly exact German translation of Oscar Wilde's lurid amplification of the well-known Biblical story of Herodias' young, seductive daughter Salome. Salome, at her mother Herodias' behest, performs the Dance of Seven Veils for her lecherous stepfather, King Herod (ending up naked and exhausted at his feet), and in return demands the head of the prophet John the Baptist. Charged with eroticism, depravity and an electric sense of inexorably approaching horror, the opera concludes with one of opera's most unforgettable and viscerally shocking scenes: the deranged anti-heroine's crazed professions of love for the executed prophet and her exultant, passionate embrace with his newly severed head.

In this concert performance, the spotlight will be on the opera's captivating and highly innovative music, which matches the intensity and psychological depth of the plot. Saturated with adventurous harmonies that stretch the boundaries of the tonal system, Salome was as revered a touchstone for the most important avant-garde composers of the ensuing decades. Strauss also displays his mastery of orchestration and its creative and communicative abilities, using different instrumental textures to identify characters and themes from the text. And though the score bristles at times with dissonance, the composer also

incorporates plentiful passages of soaring lyricism, the beauty of the sound often forming a jarring disconnect with the perversity of the action on stage to create a musico-dramatic window into the characters' perceptions of the world.

Andris Nelsons is the newlyappointed Music Director of the Boston Symphony Orchestra, starting from the 2014-15 season, and is acting as Music Director Designate for the 2013-14 seasons. Nelsons is one of the most sought-after conductors on the international scene today, earning distinction on both the opera and concert podiums, including those of the Berlin Philharmonic, Vienna Philharmonic, Royal Concertgebouw Orchestra, and Bavarian Radio Symphony Orchestra, as well as the Royal Opera House-Covent Garden, Metropolitan Opera, and Vienna State Opera.

Death of a Salesman ... By Arthur Miller and directed by Spiro Veloudos has been lighting up the Lyric stage and will continue through March 16th.

Ever since it was first performed in 1949, Death of a Salesman has been recognized as a milestone of the American theater. In the person of Willy Loman — the aging, failing salesman who makes his living riding on a smile and a shoeshine. Arthur Miller redefined the tragic hero as a man whose dreams are at once insupportably vast and dangerously insubstantial. Death of a Salesman compresses epic extremes of Willy Loman returns home exhausted after a cancelled business trip. Worried over Willy's state of mind and recent car accident, his wife Linda suggests that he ask his boss Howard Wagner to allow him to work in his home city so he will not have to travel. Willy complains to Linda that their son, Biff, has yet to make good on his life. Despite Biff's promise as an athlete in high school, he flunked senior-year math and never went to college.

The plot of this intense and tragic classic follows Biff and his brother, Happy, who are temporarily staying with Willy and Linda after Biff's unexpected return from the West. Reminisce about their childhood together. They discuss their father's mental degeneration, which they have witnessed in the form of his constant vacillations and talking to himself. Willy walks in, angry that the two boys have never amounted to anything. In an effort to pacify their father. Biff and Happy tell Willy that Biff

And Liberace was born Władziu Valentino Liberace, son of an Italian born father and a Polish mother. His father. Salvatore, was a musician who played the French horn, taught Wladziu and his older brother George to play musical instruments.

Recipes from the Homeland

BROILED LAMB CHOPS

- 4 lamb chops
- 2 garlic cloves chopped or crushed
- 3 tablespoon olive oil
- 1 teaspoon oregano
- 1 large onion sliced (optional)

(optional) Chopped mushrooms (optional) Salt and black pepper

2 fresh tomatoes sliced

In a bowl, mix chopped or crushed garlic with oil and oregano. Using pastry brush, spread the mixture onto both sides of each lamb chop. Marinate lamb chops in extra marinating mixture in a dish for at least thirty minutes.

TO BROIL: Lightly spray broiling tray with oil before placing chops on the tray. Place tray with chops in oven at least two inches under the broiling coils to broil fifteen to twenty minutes, depending on thickness of chops. Turn chops occasionally in order to cook on both sides. Broil chops until they reach the consistency desired. Before serving, brush extra marinating mixture over chops. Salt and pepper to

OPTIONAL: Place tomato slices over marinated lamb chops in broiling tray. Then spread onion slices over tomato slices. Sprinkle a little oregano and oil over the onions. Chopped mushrooms can also be added. Cover broiling tray with aluminum foil before placing in the oven at least two inches under the broiling coils. Broil about twenty to thirty minutes depending on thickness of chops. Check for desired tenderness. Remove cover to allow browning. Salt and pepper to taste.

Serves two.

NOTE: I have grilled marinated lamb chops many times on our charcoal gas grill following this recipe. When I add tomato and onion slices, I arrange everything in a throwaway broiling tray, cover it with aluminum foil and cook over the grill. Then uncover them and brown slightly on the grill.

Nanna & Babbononno

A Nostalgic Remembrance

I've had people ask how come I decided to go to college. I've thought about this question many times and came up with a few practical answers. First of all, formal education wasn't part of the culture of the old-timers, like Babbononno. His concept of a man was based on how hard the person worked to survive, how calloused his hands were, how talented he was at his craft and how committed he was to his trade. To this extent, in the old neighborhood, many men were referred to by their first names and their professions: Pete the Shoemaker, Joe the Barber, Mario the Baker, Young Tony the Bricklayer, Fat Tony the Cook, Pat the Bookie, Charlie Numbers ... you get my drift. Babbononno's nickname was Mike the Carpenter or Mike the Musician, depending who was making the reference. Dad was Christie the Bass Player

This all went back to the way things were in the old country before that first generation got here. The outsiders who controlled the government, the people from the north, the clergy (who sometimes were considered the enemy), these were the people who were educated. The peasantry emphasized the opposite of what they did, hence the stress on the crafts and trades. Expressed in this country a generation later, it meant that your sons learned a trade in school or got enough schooling to learn how to read, write and count. They then might quit school before they finish and become an apprentice in some trade.

Babbononno taught me how to use hand tools to work wood into pieces of furniture. He thought it might be a good idea if I became a woodworker during the day and play music at night. Laboring in two professions is what he opted for and what his sons and son-in-law all did. My father had hoped I would follow the American dream and think about higher eduhe got off the road with the big bands and played locally. He also began teaching machine shop at East Boston High School. The prerequisite for this was to have worked for seven years in the trade, not a college degree as is necessary today for the same job. As a result of associating with other school teachers, all with one or

more degrees, he learned what higher education was all about, the doors it could open and the legacy it could help pass on to the next generation.

What mainly convinced me that my father was right when he lectured me about finishing high school and going on to college, was what I experienced in the street. To use slang, I "hung out" on a street corner from the time I was 13 years old. First, there were the neighborhood kids who took up residence on the corner of Brooks and Eutaw Streets, a half block from where I lived. When I was about 15, several of us headed down the Brooks Street hill and began hanging out on the corner of Bennington and Brooks ... this was the big time.

Socializing at both locations were young men who were on the corner every night after dinner, dressed in the styles of the day, speaking with the slang of the day, admiring anyone who drove by in a new car, and of course watching all the girls walk by. Everyone smoked Camels, Luckies, Old Gold, Paul Mall, Chesterfield and a couple of other brands of the day and a cloud of used smoke floated over each of the four corners of the Brooks/Bennington intersection.

Most of these guys, teens and men in their twenties, had quit school and gone to work. There was a lot of factory work around Boston back in the day. Some of the guys worked as long shoremen, others as day laborers in the construction trades and others worked at the fish pier. Some just did odd jobs because that's all they could get. A few were apprenticed in trades because someone they were related to was in the trade and the opportunity was there. For the most part, the salaries weren't great and advancements were few. I thought about what most of these friends and acquaintances made and questioned if I wanted to be in the same cation. When WWII began, professional and financial situation when I was a few years older.

What convinced me that I was heading in the wrong direction was my observation of some of the guys who straddled the fence between things legal and illegal. Periodically, a police car would stop at the corner, a detective would question one or two of the corner people


and chances are, they would be taken away in handcuffs. I witnessed one or two of the guys arguing back and paying the penalty for their resistance. One night, a friend asked me to walk with him to Station Seven, the local police station in East Boston. It seems that he had gotten himself into some kind of trouble and wanted to try to talk himself out of it. If I accompanied him, the police might let him go. An hour later, after my friend had been questioned by the police, one of the officers came out of the interrogation room and told me that they were not going to release my friend and asked what my involvement was with his dealings. I explained that I only walked with him to the police station at his request and nothing more. The officer then told me go home and walked me to the door. On the way out, I ran into another officer, a man I knew due to the fact that his beat was Central Square and he had stopped in at the Seville Theater on several of the nights I was working. We said hello to each other and I heard him say to the officer that escorted me out, "What's that kid doing here, he works at the Seville and is one of the

good kids."

One of the things I admired about many of my street corner associates was their toughness. Several who got in trouble went up in front of the local judges and were given options, join the service or go to jail. Most of those tough guys who opted for the service flunked out of boot camp. They didn't have what was necessary to make it. Those who didn't join the service served time in jail. With these observations under my belt and a recognition of the fact that most of my friends were making very low wages due to the lack of a trade or education, I began to think that my father might be right. When I began my senior year in high school, representatives from different colleges began arriving at English High to tell us about the schools they represented. I spoke to Babbononno and my father illustrating the words of the college reps about the doors that could open for me if I decided on higher education. My father was happy that I was coming over to his way of thinking. Babbononno was skeptical but agreed that I should follow a path that would lead to success. Of course Nanna and my mother agreed with their husbands and when the second half of my senior year rolled around, I was all set to head to Boston State College after graduation.

I'm out of space and will pick it up from this point next week. GOD BLESS **AMERICA**



The Spanish are telling everyone the most unknown aspects of the sailor's life in order to ascertain his Catalonian origins which would contradict the Genoese's claim and underline the crucial role of Barcelona in the preparation of the navigator's second voyage, denying the official story that described the departure of the caravels from Cadiz rather than from Barcelona.






Boxing by the Book




A short while ago I was having a conversation with former New England Middleweight Champion Danny Long. While we were talking Danny said he wanted to show me something. He brought out a copy of an old book entitled *The Ring's Training for Boxers* by Nat Fleischer, the original publisher of *Ring Magazine*. Seeing that book immediately brought back memories as I had both the training book as well as Fleischer's *How to Box* when I was a kid.

Danny related to me how he also bought both books at an early age, and he, like me, read them from cover to cover and would then practice the moves on a makeshift punching bag. I looked through my library and discovered that I still had my original copies of these books that so influenced my life. While it may seem odd to learn how to box by reading about it in a book, I found both volumes to be very informative. The books have sketches as well as photos of some of the great fighters demonstrating different moves. Perusing them now, I am very impressed with the amount of boxing knowledge they contain. It was by reading these books that young aspiring boxers such as Danny and myself learned the terms: parry, feinting, infighting, side stepping and many more. Not only do the books make you familiar with these terms, they also go into detail on how to execute these moves.



A great portion of *How to Box* deals with defensive moves, something that is becoming a lost art today. The first chapter contains a short interview with Jack Dempsey where he talks about the value of the pivot. He also goes on to discuss how important it is to become a complete boxer by learning all the moves so the fighter can deliver blows while still being able to protect himself. There are nine pages of photographs of the great Benny Leonard demonstrating many defensive and offensive techniques such as making the opening and the art of getting away.

Looking through the table of contents at some of the chapter headings gives you a real picture of how well thought through the sport was back then. Chapters entitled: The Proper Stance, Useful Hints in Sparring, Infighting, and Methods of Footwork give you a sense of why boxing is called The Sweet Science. I think any young person who has an interest in taking up boxing would still be well served by these books today. For one thing, by reading these texts and studying the photos, you get an understanding of how much thinking is involved in being a good boxer. It is really a game of physical chess, and while it still takes great conditioning and muscle memory to succeed at the sport, a boxing match can also be a battle of the minds. It is what makes the Manly Art of Self Defense so interesting. It would be great if both boxers and fans would learn more about the finer points of this art as we would have much more interesting bouts and the fans would be able to appreciate the finer details while watching two fighters compete. It would no longer be a matter of just sitting and waiting for the knockout, but would become an appreciation of two skilled athletes using all of their talents in trying to outsmart each other in order to come out victorious. Though everyone in these books has passed on, they still speak to us through the printed word. As with learning from all great teachers from the past, they have left us the knowledge, we just have to listen to them. - - - - -

In other boxing news, the Ring 4 Banquet scheduled for April 6, 2014 is sold out. Tickets went fast this year thanks to the hard work of President Mickey Finn. This year's Hall of Fame inductees are former contender Johnny Rafuse and former Golden Glove Champ Jack Morrell who also had a great pro career. Mickey Finn will be given the rare and well deserved designation of Lifetime Honorary Member. I was proud to nominate Mickey for all the work and dedication he has devoted to the club. Without him there would be no Ring 4.

HOOPS and HOCKEY in the HUB

It wasn't a miracle on ice because the two teams were pretty much evenly matched but it certainly was memorable in that it harkened back to that epic game that occurred 34 years ago this winter.

The Miracle on Ice, of course, was the men's hockey game at the 1980 Olympics in Lake Placid, N.Y. where Team USA, with a roster made up mostly of collegians, defeated the Soviet Union, considered by many to be the best team in the world.

The huge victory electrified the hockey fan base in Greater Boston since four of the players — Mike Eruzione, Jack O'Callahan, Dave Silk and goalie Jim Craig had played for Boston University. It was the ultimate local angle story for sportswriters based in the Hub.

Fast forward to another Olympics, this one in contemporary times featuring another big game. It was Team USA versus Team Canada in the women's gold medal game, a matchup that had been widely predicted.

Just like in 1980 the game would come down to a thrilling conclusion and feature four players from Boston University. Yes, you see, when Team Canada came from behind in the final three and a half minutes to tie the contest and eventually win 3-2 in overtime, it did so with a roster that had four BU players — just like Team USA some 34 years

The victory also recalled the men's victory in the 2009 NCAA Division I National Championship game when the Terriers came from two goals down with less than a minute left in regulation to tie things up before going on to beat Miami of Ohio for the title in overtime.

At Sochi the proceedings also were dramatic and certainly provided excitement as the team from north of our border also came back from being two goals behind in the final minutes to tie before also winning in OT.

For Marie-Philip Poulin, Jenn Wakefield, Catherine Ward and Tara Watchorn it was the most memorable moment of their young lives, winning the gold for their country and perhaps in the back of their minds, for their university as well as for BU head coach Brian Durocher. Their success served as another validation of his program, one that has advanced to the NCAA title game in two out of the last three years.

The fact that these players accomplished their gold medal feat by defeating Team USA should take nothing away from their victory in this area of high hockey interest. For several years they walked the streets of Boston and lived among us. They could have played any-

where. They chose to play in Boston.

As for Marie-Philip Poulin, she did something that even Mike Eruzione, who scored the winning goal against the Soviets all those years ago, did not do. She gave an encore performance.

You see, four years ago she scored both goals as Team Canada defeated Team USA 2-0 to win the gold medal at the 2010 Vancouver Olympics. Then at Sochi, she scored both the tying and winning goals to defeat Team USA once again.

And for all of you who want to see a true Olympic hero, you won't have to go far. Marie has stated that she'll be returning to BU for her senior season next fall, ready to compete in Hockey East where she was a First Team All-Star in the 2012-2013

Back then the 5-6 forward from Quebec set a BU school record for assists with 36 en route to a personal career high 55 points. This time around she's indicated that she will have another goal in mind — to win an NCAA Championship.

The other three Terriers have since moved on from their days on Commonwealth Avenue — but not without leaving their marks on the BU program.

Jenn Wakefield, a forward from Ontario who transferred in after two years at UNH, served as team captain during her senior season (2011-2012) while playing in 36 games. She is the only player in Hockey East history to score at least 100 career goals (she finished with 120). In addition, she's only the second player in the history of the conference to have gone over the 200 career point mark by amassing 206.

For teammate Catherine Ward, who hails from Montreal, it was also her second trip to the top of the medal podium since she was a member of the 2010 gold medal winning squad. She played three years of college hockey for McGill University in Montreal, helping to lead the team to consecutive Canadian college championships in 2008 and 2009.

As a graduate student at BU during the 2010-2011 season she was named a Hockey East First Team All-Star and selected as the best defense-man in the conference. She also made her presence known on offense, piling up 31 assists.

Rather than concentrating on a single sport, Tara Watchorn was something of a throwback from another era as she excelled in multiple athletic endeavors while growing up in Ontario. She didn't just participate in basketball, volleyball, soccer and hockey — she earned high school MVP honors in all of them. Plus, in the classroom she was an honor
