#### **COVID Kin RIP** NY Gov. Over Victim Fund

Family members who lost loved ones in nursing homes during the pandemic slammed Gov. Hochul for failing to include a \$4 billion victim compensation fund within her \$216.3 billion budget.

"We believe the victim's compensation fund should be included in the state budget as a final admission of guilt. That will give the families closure and some sense of accountability," said Vivan Zayas, who lost her mom at a nursing home in April 2020.

This fund was proposed last year by State Assemblyman Ron Kim, D-Queens, the 9/11-style Nursing Home Victims Compensation Fund would allot \$4 billion to families whose relatives died amid the nursing home debacle at the start of the pandemic.

More recently, Gov. Hochul offered a formal apology to the victims' families for the pain caused by former

# **MBTA Plan Reallocates \$500 Million to Support Critical Capital Investments**

These One-time Funds Allow the T to Accelerate Safety Investments, Advance Importance Workforce and Retention Opportunities, Promote Major Bus Initiatives, and More

Board supported reallocating up to \$500 million in operating funds to support critical and timely capital investments, allowing the MBTA to accelerate key capital projects in safety, advance key employee recruitment and retention initiatives, advance key investments in bus, and more. This one-time reallocation plan was presented to the full Board at today's meeting. This funding is unrelated to the Bipartisan Infrastructure Law funds.

"Last fiscal year, we spent a record \$1.9 billion in capital investments and addressed

The Audit and Finance some of the state of good service levels and balance Subcommittee of the MBTA repair backlog. But we still its operating budget despite have important investments to make," said MBTA General Manager Steve Poftak. "This \$500-million one-time transfer of funds will allow us to expedite crucial safety investments like the Green Line Train Protection Project, to continue supporting our workforce with pandemic pay for front-line employees, to further major investments that upgrade and modernize our bus system, and more."

During the COVID-19 pandemic, the MBTA received nearly \$2 billion in one-time Federal relief funds, which allowed the MBTA to maintain

significant reductions in fare revenues. Federal relief funds continue to be applied to eligible operating expenses, freeing up other revenues on a one-time

With the support of the Board, the MBTA plans to reallocate up to \$500 million in operating funds to support critical onetime capital investments while still ensuring a balanced budget through FY23:

• Safety Investments: \$67 million will go toward accelerating key capital investments in



#### TRIUMPHAL ARCHES



Huge free-standing arched structures placed over roadways were called triumphal arches. During Roman times, this type of arch was erected to honor emperors or generals. They had either one or three openings, and the sides had columns, statuary, and reliefs, which told a story about the person or the battle which the arches commemorated. They usually had stairs leading to the upper portion, or attic.

At one time, there were about 38 of these triumphal arches erected in Rome, but most have been destroyed. Probably the most famous and best preserved of these ancient structures is the Arch of Constantine, which was built in 312 A.D. It was erected on the Via Triumphalis, near the Colosseum, and it was dedicated to Constantine's victory over Maxentius.

The Arch was dedicated to Constantine by the Roman Senate, "because by the will of God and by his own virtues, he liberated the country from the tyranny of Maxentius." It is mostly constructed with materials taken from other buildings, very skillfully assembled, but is considered to be overpowering, and over-adorned. Exterior reliefs tell of Constantine's achievements in war and in peace.

the three opening styles is that connected at the base. of Septimius Severus, which was built in 204 A.D. adjacent to the Forum Romanum Magnum.

It was dedicated to the emperor and his two sons, Caracella and Geta, to commemorate their victories over the Parthians. The arch originally had a bronze chariot mounted on the summit, which contained statues of the emperor seated between his two sons. The exterior surfaces of the arch were covered with the usual story-telling reliefs.

A third well-known arch, which is of the one openingstyle, is that of Titus. It was constructed in the year 81 A.D. This arch was erected to commemorate the victories of Titus and Vespasian in the Judean War in the year 70 A.D. The arch was completed after the death of Titus, and dedicated by the Emperor Domitian. It is entirely faced with pentelic marble, and is considered to be one of the gems of the first century. (Pentelic marble is an exceptionally high-quality and fine-grained marble, which comes from Mt. Pentelicus in Greece.) References to "reliefs" should also be explained at this time. "Relief" is carving wherein the figures stand out beyond the stone they were carved from. There are three kinds of relief: low or bas (pronounced bah), like the figures on a coin; high relief, where the figures stand out more fully; and full relief, where the figures fully stand Another well-known arch of out from the stone, but are still

safety, including \$45 million in the Green Line Train Protection Project and accelerating the project's schedule by a year to be completed next year instead of 2024; providing additional funds to support increased inspections at MBTA stations and facilities; and providing funds to address identified safety and non-code compliant concerns at the Lynn Parking Garage.

- Workforce Investments: \$20 million will go toward advancing key employee recruitment and retention initiatives, including supporting employee-focused initiatives like pandemic pay for front-line employees and the expansion of the human resources staffing program as well as establishing an employee recruitment and retention program with opportunities to extend hiring bonuses and referral bonuses for key positions at the MBTA.
- Bus Investments: \$109 million will go toward advancing key investments in bus, including funding for the

Arborway Bus Facility (design), the Blue Hill Avenue Transit Priority Corridor, and the North Cambridge Bus Facility as well as additional funds needed to support the Quincy Bus Maintenance Facility and the procurement of 60 New Flyer buses as part of the New Flyer Bus Overhaul Project.

- Shovel-ready Investments: \$70 million will go toward advancing key shovel-ready and shovel-worthy projects, including advancing the Newton Commuter Rail Station project to 100% design, expanding the Codman Yard Expansion and Improvements project to include building and power infrastructure improvements, and programing funds for potential near-term real estate opportunities and advance infrastructure planning for future electrification of the Commuter Rail network.
- Additional Federal Formula Funding Preparation: \$145 million will go toward preparing for additional Federal

formula funding. Funds identified provide the 20% match needed to program anticipated new Federal formula funds as identified in the Bipartisan Infrastructure Law (BIL). New funds, including matching funds, will be programmed through the FY23-27 Capital Investment Plan development

 Preserving the Existing Capital Program: \$89 million will go toward preserving the existing capital program, including additional funds needed to support the Franklin Double Track and Signal and ATC Implementation projects, replenishing the surplus/contingency fund to support any future COVID related (materials and labor) cost increases, and advancing the full scope of the Tower 1 Interlocking Early Action project.

### **DEFINE THE WORD "VACANT"** OR "VACANCY" THEN PROCEED

I was stunned by the news concerning Lydia Edwards and her decision about staying on as District 1 City Councilor until April 30th. I am, however, not bothered about whether she would be collecting two salaries for the first four months of 2022 since she is now also a State Senator.

However, to me, the biggest question is with the City Charter's timelines (if any) for calling a special preliminary election to fill a District Council seat. Edwards seemingly believes the clock started ticking when she announced her intention to give up her Council seat, followed by a preliminary election two months from that notice of vacating the seat and the general election 28 days later. Sounds simple, right? Edwards has announced she will be vacating her Council seat on April 30th. Shouldn't that date officially start the election timeline for both the preliminary and general election for District 1 voters to pick a new District

She dropped this news with a late Friday dump to the media and also asserts case law allowing her to resign at a future date but that the election timeline should start with that Friday notification, and not the date she will actually be leaving her elected city post! She also says case law is on her side. I believe just the opposite. No election timeline for a vacant seat should begin until the seat is actually vacated.

The assertion that by hanging in an extra four months that she's doing the voters in District 1 a big favor seems questionable. Remember, during the period that Kim Janey was acting Mayor, her council duties continued on with her staff members finishing out the final months of her District 7 term as councilor. Edwards could do likewise. Is her decision really about good government or not?

Eventually, it seems likely that the City Corporation Counsel office may have to figure this all out using plenty of lawyer talk in the process.

Is a city council seat really vacant if the officeholder hasn't vacated the office yet? I guess we await a good lawyer answer from the city's corporate attorneys on this one.

## L'Anno Bello: A Year in Italian Folklore

A Fresh Start for Fabulous February

All around me, nature shifts and pulsates with a renewed energy. I see this energy reflected in the increased number of birds hopping and singing around the bare branches of my backyard trees. I see it in the pinkish-orange sunset hue peeking through the clouds on a windy evening. The rushing sound of melting snow seems to sing the newness of the season, while the scent of damp soil brims with the promise of new life. The calendar has now turned to February, a month of transition, a month filled with the crackling air and delicate reminders of early spring. Above all, February functions as a month devoted to purification, to dusting out the metaphorical cobwebs of a stagnant past and ushering in a hopeful future. The Italian roots of the word "February" reveal the month's cleansing power, as it derives from Februa, an ancient Roman purification festival. Indeed, I love February precisely because it offers a new beginning, a chance to spring-clean the literal and figurative clutter in my life. This desire arises from seasonal cues and has been felt since ancient times, as evident by a plethora of February traditions held dear by our ancestors in Italy. Italian holidays and customs fully embrace the restorative nature of February, paving the way to an exciting spring.

As a child growing up in the mountainous Abruzzi region of central Italy, my father participated in a quaint ritual that introduced the changeable days of February. On the evening of February 3<sup>rd</sup>, he would walk through the crisp, windswent air to his local church,

would hold two crossed candles against the throat of each worshiper and say a blessing. This was la Festa di San Biagio, or the feast day of St. Blaise, the patron saint of illnesses of the throat and neck. St. Blaise, a fourth-century Armenian bishop, reportedly saved a choking boy's life by dislodging the fish bone that was stuck in his throat. The ritual which my father fondly remembered from his boyhood sought to prevent congregants from acquiring any sort of malady or injury to the throat in the future. In her inimitable book Festa, author Helen Barolini mentions that Italians eat special hard biscuits on la Festa di San Biagio as yet another means to protect the throat. These curative customs practiced on St. Blaise's Day strongly remind me of the purification rites so prevalent in February. Just as a physical illness can be purged from a body, so too can the emotional drain of negativity be expelled. Similar to the way that candles and biscuits are inscribed with therapeutic powers on St. Blaise's Day, our sense of hope and positive thinking can cleanse us of the distractions, bad habits and despair that may have plagued us during the winter. La Festa di San Biagio, therefore, reminds us that the time is ripe for reevaluating the small improvements we can make in our lives.

The people of Catania, Sicily, get another chance at a purification festival with la festa di Sant' Agata, or St. Agatha's Day. Bright lights and raucous revelries mark these celebrations, which culminate on February 5th, the saint's feast day. Huge candles and intricate beautifully aglow with candle- light displays illuminate the city light. There, the parish priest as people march in processions

third-century Sicilian martyr. These luminous lights mimic the sun, which is now appearing for a longer time in the sky, scattering the darkness of winter and welcoming the restorative days of spring. Like St. Blaise, St. Agatha also presides over the protection against certain illnesses, in her case diseases of the breast. However, St. Agatha further serves as the patron saint of bakers, and as such Sicilian bakers bring their breads and pastries to church for a blessing on her feast day. Now imbued with healing powers, these blessed treats will bring luck and renewal to those who eat them. I recently discovered the celebrations in honor of St. Agatha, and this holiday fascinates me with its themes of light and darkness, feminine power, and symbolic foods. It seamlessly captures the purifying mood of February with its desire to rid people of both literal and figurative maladies, as well as greeting spring in a blaze of warmth. In fact, even after St. Agatha's Day ends, Italians look forward to a whole season of festivities that metaphorically dispel the dark winter days and hail the spring, from the flowers of St. Valentine's Day to the mischief of Carnival.

This February, I am eager to jump into a fresh start. The pastel hues adorning the latest spring fashions, the birds chirping in the bushes, and the delectable Valentine's Day chocolates fill me with an irresistible energy and enthusiasm. I realize that I am certainly not alone in looking forward to the spring, while still enjoying the unpredictable nature of a season in transition. February is a liminal month, where folk customs around the world gleefully greet a new cycle in the year with traditions that emphasize cleansing and healing. In order to fully delight in the spring, after all, we must make good on our promises of the New Year and purge ourselves of the negativity left over from our metaphorical winters. It is our time to let bad habits, self-doubt and worries melt away like the snow during a thaw. Taking an example from the celebrations of St. Blaise and St. Agatha, we can realize that the power for change comes from within and that with love and hope, our hearts will forever blossom like a spring garden.

#### When Life Gets Lived in an Alternative Universe (Part I)

I grew up in the South End/ Lower Roxbury communities. The two split on Massachusetts Avenue. Even numbered side of that wide divide was the South End, and the odd numbered side, Lower Roxbury. No one from the area needed a signpost to tell them that. We just knew.

Over the summer, I thought of that very fact as I kept reading about the metastasizing of the homeless encampment that began at Mass and Cass by the highway ramps where vehicles travel going to and from work. At the traffic lights as you waited for the green light, you scanned the area filled with an assortment, a sad assortment of human beings living in the shadows of life but in plain sight of all who passed them by as a daily routine.

By the end of July as this homeless encampment grew and grew, it started getting newspaper headlines and calls by advocates for the homeless demanding action from those in elected office to do something, fix the situation, like there was an easy fix, which there wasn't at the time. It took years for the magnitude of the situation to catch the attention of those in power. They almost had to be shamed before they could recognize it was their responsibility.

I started noticing this huddled mass of humanity sometime in July and watched as July moved into August and before I even noticed it, we were into the month of October and the approaching cold, which surely was coming sooner than later.

Back in August, I strolled through all the tent areas. Tried to keep walking without staring into someone just to keep safe. Folks in this tent city were probably more nervous of me than I was of them. Then a 20-something female started yelling at me wondering what I was doing there. I told her I was a reporter doing a story and then she asked me for some money, I gave her a buck and she started talking to me about her life. then it was time for another dollar. I ended up buying her lunch while interviewing her, then she smiled and said good-bye to me.

Up to that moment, I only noticed lots of people walking around like zombies. After our chat, I saw her as a sad human being trapped in her little hell. I guess that is the story of many of those out on the streets.

Five weeks later, I returned, this time over in the Newmarket area where tents were relocated. This time I met a 50-ish guy pushing a shopping cart with all of his belongings. This guy wouldn't talk without some money, too, so I gave him some and then he started talking about his life. When I asked where he slept, he told me

wherever he can find a safe spot. Could be anywhere. I asked him for a photo shot, he said sure go ahead. Then he was on his way.

Through all this time from July to almost November, things weren't changing down there. A few moved on but most just moved over to the Newmarket area. The more things didn't change except politicians talking the same old useless talk about helping.

Eventually, I was shocked that the City was able to clean this mess up and move people out of their alternate universe at least for the cold winter. I always say people maybe stubborn, but no one is stupid.

I am thinking come late March or early April, those roving bands of homeless will return to the streets. This is why no one should be waving a victory flag yet, because there are few victories when you're living out in the mean streets of Boston.

I don't know if there is a real solution for these wandering souls, who seemingly want to be left alone to do what they want to do. Politicians and advocates for the homeless too often just don't get it. Things never change.

Which is why, come next July, the images I saw last July will re-appear once again along with the homeless advocates and politicians throwing around sound-bites for the TV cameras.

The answer isn't just finding beds for these folks, the answer is offering them realistic solutions for their plight. We will never be able to reach all, but little by little, we can move closer to where real help might be found.

Homeless people are homeless for many reasons. There is no prototype homeless person either. I admired what Suffolk Sheriff Steve Tompkins was trying to do last summer. Thinking out of the box is always a better solution than repetitive oneliners, pretty words doing the same old thing over and over again with the same old no results.

I really wonder what happened to that young lady I spoke with over at the encampment. Did she suffer? Is she still out on the street, or is she some place inside better cared for than when I last saw her. The same thing for that older man with his shopping cart. Worst thing in the world is to be both homeless and hopeless.

The homeless out on the streets we see every day are real human beings and turning away from their sight or pretending there is nothing we can do is not the answer, never has been, never will be.

We have a responsibility to do so much better for those living in the shadows of life, don't we?



At the end of August, Mom would always take the three of us to Gilchrist department store to buy clothes for the upcoming school year. Starting at the beginning of summer, Dad would put money aside for this annual event. It took about \$100 to clothe the three of us. After deciding on the hand-me-downs that would work, separating them from the clothes that were not wearable or no longer fit any of us, Mom would march the three of us up to Gilchrist to see Miss Rooney, who made her career stationed in the boy's department. Gilchrist was located on the corner of Winter and Washington Streets in downtown Boston. There were three department stores that faced each other at that location: Jordan Marsh, Filene's and Gilchrist, Gilchrist was the smallest and least expensive of the three. Entering Gilchrist, you would pass through a small cosmetic department leading to a short flight of stairs, taking you to the boy's department. The moment we entered the department, Miss Rooney would greet Mom and then each of us by name. Miss Rooney was a short woman, well proportioned, in her mid-fifties. Once we got



through our annual greetings, she sized up Charlie, and as usual, would say he had to go to the husky boy's department. It never bothered Charlie, because the free lollipops offered to children were kept in that department, prompting him to fill his pockets before they were offered to the rest of us.

Mom had a thing for brown pants and green sweaters. The sweaters would invariably have animals on them, bears and reindeer, the animals most commonly offered. Our shopping spree never got beyond \$85. Mom always planned to hold \$15 aside, from the \$100 Dad provided, for what she referred to as our good time money. It was always the same. We would go to the Adams House for lunch, where we would invariably have chicken croquettes. The croquettes were shaped pointy, a thick yellow cream sauce covering each of them. They served two to a plate along with mashed potatoes and peas. We called this American food, and enjoyed the taste, which was very different from our everyday fare. They were delicious, helping to make this annual event into a special treat. Following lunch, we would go to a movie. Movie Houses were located up and down Washington Street. Our favorite was the RKO Keith's. Not only did it have the best movies in town, it was also the most beautiful of the Movie Houses. It looked like a palace.

This year, things were different, Mom invited Pietro to come along with us. Pietro didn't need any clothes for he arrived from Italy with lots of fine things, far finer than our own. He looked forward to our little shopping spree and the distraction it would provide him. As soon as purchases were completed at Gilchrist, we were off to the Adams House with our bags in hand. Pietro, who had barely strayed out of the North End and our Italian world since he



# Always Room for Strawberries

As you plan this year's garden, be sure to include some strawberries. They are low in calories, high in vitamin C and antioxidants, and provide seasonal interest in gardens and containers.

Best of all, you don't need much space to grow this delicious fruit. There are three types of strawberries: June or spring bearing, everbearing, and day neutral. Select the best type of strawberry for your space and harvest needs.

June-bearing strawberries produce one crop of berries in late spring to early summer, depending on where you garden. They produce the largest harvest but in the shortest span of time. Plant now and enjoy an abundant harvest next year. Everbearing strawberries usually produce two crops of berries each year. You'll enjoy fresh strawberries early and late in the season, while dayneutral plants produce berries throughout the growing season. Delizz®, a day-neutral strawberry, was the first ever strawberry to be selected as an All-America Selections Winner. Just like the flower and vegetable winners, it was tested nationally and selected for its performance for the home garden. This 2016 winner is a compact plant perfect for hanging baskets, containers or garden beds. It can be started from seed or transplants and will produce sweet fruit the first year and all season long, even during hot weather.

Up the ornamental appeal of traditional in-ground plantings with a star shaped or tiered bed. The elevated beds make for easier planting, weeding, and harvesting. You'll find a variety of tiered shaped beds to purchase or plans to make your own.

Use strawberries as a ground-cover in sunny well-drained locations for an abundant harvest. Their attractive leaves, white flowers, red fruit and brilliant red fall color add sparkle to the landscape and provide fresh fruit for your meals.

Or grow them in a container, window box or hanging basket on your porch, balcony, or deck. They'll be close at hand and easy to harvest.

Mix a few everbearing or dayneutral strawberries in with flowers to create an edible and ornamental planter. The harvest will be smaller when grown in a mixed container, but the flowers, fruit and fall color add ornamental appeal and the fruit will be a welcome treat.

Boost the harvest by growing strawberries in their own container. Fill a hanging basket and watch as the runners cascade over the edge for added ornamental appeal.

Try filling a traditional strawberry pot — container with planting hole openings on the top and sides — with plants that produce several harvests and remove the runners as needed. Keep all the plants from top to bottom looking their best with this DIY watering device. Place soil on the bottom of the container. Set a couple of perforated PVC down through the planter. Slide the plants through the hole from the inside of the pot. Fill the remaining space with soil. Gently tamp and water thoroughly to eliminate air pockets. As you water, the water travels through the pipe and out the holes, providing moisture to all plants from top to bottom.

Check containers daily and water thoroughly and often enough to keep the soil slightly moist. Reduce maintenance and increase success by incorporating a low nitrogen slow-release fertilizer into the soil at planting or sprinkle over the soil surface as needed. This type of fertilizer promotes growth without interfering with flowering and fruit production.

Start now identifying spaces to add strawberries to your landscape, deck and balcony. Then order seeds or plants early for the greatest selection. Before you know it, you'll be enjoying garden fresh strawberries in your morning cereal, salads or as a snack at the end of the day.

## Blessed Fra Angelico

Fra Angelico was born Guido di Pietro at Rupecanina in the Tuscan area of Mugello near Fiesole in 1387. Nothing is known of his parents. He became a Dominican friar and resided in the priory of San Domenico at Fiesole, there taking the name of Fra Giovanni (Brother John). At Fiesole he was probably influenced by the teachings of Giovanni Dominici, the militant leader of the reformed Dominicans; the writings of Dominici defended traditional spirituality against the onslaught of humanism.

Fra Angelico probably received part of his artistic training in the workshop of Lorenzo Monaco (ca. 1370-1425), a Camaldolese monk and the leading painter and *manuscript* illuminator in Florence. Angelico knew and followed closely the



new artistic trends of his time, above all the representation of space by means of perspective. In the 1430s, Angelico painted one of the most inspired works of the Florentine Renaissance, The Annunciation. Every day before he began to paint, Fra Angelico prayed that God would

guide his hand and help him to create a painting that would inspire people to grow closer to God.

Fra Angelico became very famous. He painted holy figures and angels and was even called to Rome to paint portraits of the saints on the walls of the chapel of Pope Eugenius IV and Pope Nicholas V. His work can be found in museums, churches and holy buildings throughout the world.

He died in Rome in 1455 and was beatified on October 3. 1982 by Pope John Paul II. The pope declared him the patron of Catholic artists in 1984.

Fra Angelico's life helps us to understand that we are called to use the gifts we have been given to serve others and to give glory and praise to God. The Feast Day of Blessed Fra Angelico is February 18th.

# Nanna & Babbononno

A Nostalgic Remembrance



I've mentioned in my columns that I was a musician before I was anything else in life.

This is true and is the result of the generations that preceded me. Babbononno came to America as a musician. His three sons became musicians. His daughter married a musician. I didn't stand a chance with a grandfather, father, and several uncles who were professional musicians. When I came along, it was just assumed that I too would be a musician.

At about the age of six, I was handed over to Babbononno to learn how to read music. His method of teaching me this art was by using Solfeggio, an Italian design on rhythmic articulation that, today, is used at most music colleges around the world. Babbononno sat me down in front of a music stand with the Solfeggio book in front of me. He would open it to a page and I had to sing the notes of the exercise and beat them out with my right hand while he conducted the lesson with a baton, or in his case, a ruler in his hand. If I made a mistake, I got the ruler off my knuckles. By the time I was ten, I had knuckles like a prizefighter.

Once Babbononno gave the OK, it was time for me to learn an instrument. I tried every practical instrument imaginable but didn't take to any of them. I took piano lessons, accordion lessons, trumpet lessons, clarinet lessons, drum lessons but never practiced and the family was told by the teachers not to waste their money. I joined the drum and bugle corps when I attended the Joseph H. Barnes Junior High School. This was part of a military drill program that existed in all of the middle and high schools in Boston back in the day. I enjoyed being in uniform and marching with the other kids in dressed like soldiers, but knew that playing a bugle was limited. I think that this was my psychological compromise. It was assumed that the son, grandson, and nephew of professional musicians would follow in the family

Actually, if I came along a generation earlier, I could have made a living playing music. bands dominated pop music, Benny Goodman, Glenn Miller, the Dorsey Brothers, Duke Ellington, Count Basie, Vaughn Monroe, etc. After WWII ended,

the bands began to break up. The trend slanted toward small groups with a vocalist out front singing the latest pop tunes. After the early 1950s, rock and roll entered the equation, but even before this phenomenon came about, most musicians in cities like Boston, New York, Philadelphia, and Chicago were down to playing one-nighters if they free lanced or just weekends if they played nightclubs or restaurants. A small percentage played steady after the '50s began. For the rest of the musicians, they had to find day jobs and hope they could get booked for a wedding, party, christening, dance, or bar mitzvah on a weekend. Before World War II, Uncle

Nick and Dad were on the road with big bands. But by the time I was old enough to be part of the business, those days were gone. But, now you are going to ask, "What instrument did I learn how to play?" Well, it happened this way: I was sitting on my front steps one warm spring day in 1957. I was just finishing my first year in college at that point in time and working at the Seville Theater on Meridian Street. This was my 5th year at the Seville, and I had put studying music on a back burner. As I sat on the steps, a friend who played bass walked past me on the opposite side of the street with his bass violin under his left arm. I yelled a hello and he stopped to talk. He told me that he had been drafted and was selling his bass to someone in the neighborhood. He also mentioned that the local band he was with would be minus a bass player. He knew that my father played bass and thought I might play the instrument too. If I wanted to take his place with the local band, he would make sure I had the job. I had taken lessons on the bass from Dad, but like my concentration with other instruments, it was minimal. The idea of playing bass with a band seemed interesting and I told my friend that I might give it a shot. I did and that was the beginning.

I began to study the instrument on a serious note and practiced as much as I could. At times, this was difficult. I worked at the Seville, at school During the '30s, the swing I was on the swim team, played a couple of other intermural sports and in the spring and summer, baseball for the CYO league and the American Legion. But, I squeezed in practice time on Dad's bass. When I needed an instrument of my own, I rented one for a few bucks a month.

After a couple of weeks rehearsing with the local band, we obtained a job at a pizza place in East Boston. I think it was on Bennington Street. The owner wanted us there on Thursday and Friday nights which fit into my schedule, as I didn't have to work at the Seville on those nights. Well, working with that local band led to me becoming acquainted with musicians who dropped by to hear us. As a result, I started playing with other groups and eventually left the original band. The leader only wanted to play locally and didn't have aspirations of going beyond. When I discussed things with Dad and Babbononno, they agreed that it was time for me to move forward

on my own. At Dad's suggestion, I called the office of bandleader Ken Reeves. He and his many bands played society music throughout the state and he had as many as 10 to 20 bands out on a weekend night. I called and spoke to a Mr. Cahn and asked for an audition. At a given point in time, I reported to their Boylston Street office and auditioned with Mr. Cahn playing piano and me setting the rhythm with my bass. When I finished, Cahn told me that they really didn't need any more bass players, but thanked me for coming in. When I told Babbononno the events of the day, Nanna, who was listening in, offered, "Nothing ventured, nothing gained." She had a point and the next day, I received a post card from Mr. Cahn offering me a list of dates (mostly Saturdays) for the next couple of months. I was thrilled and accepted them all. I bought my first car as none of the dates were local and I didn't know who I would be working with. When I reported to the first job, I was apprehensive as the rest of the band was composed of the top men in the Reeves' office. Mr. Cahn was the pianist and told me he was either going to break or make me. Dad and Babbononno had taught me well and I held my own. Later, during intermission, I discovered that Dave Cahn knew my uncles and Dad. They all lived in the same neighborhood as young musicians. He even confessed that he bounced me on his knee when I was still in diapers. After he volunteered that information, the rest of the band sort of welcomed me as a new member. I stayed with the Ken Reeves office for the next few years and paid my own way through college as a result. I continued to play for the next 60, and when asked what I played, I replied, "Everything from symphony to soul. I wasn't

In this country, Italian Wedding Soup or Minestra Maritata "minestra" translates to soup, and maritata is actually "maritare or maritati" meaning marry or married) was typically believed to be a soup that was served at weddings in Italy. However, that is completely inaccurate. In fact, this soup's origin is more than likely to be Southern Italy, where the "marriage" they were referring to was one between meat and vegetables, definitely not people! Allegedly, it was immigrants that brought this minestra to the states, and it became Americanized with the addition of "little meatballs' and in some cases, even pasta. Today, Italian Wedding Soup is served at weddings, on holidays, or even at home as a balanced one course

When I was young, one of my favorite things to make with my Nonna was what she referred to as her "Sicilian Chicken Soup". Though the ingredients may have been similar, this was never referred to as "Wedding Soup" in my home. I remember how Nonna would place a whole chicken (neck and gizzards, too) along with her cleaned vegetables into a huge stockpot filled with water. She'd then let this mixture cook for several hours while she cooked escarole and Acini di Pepe in separate pans. After everything was cooked and cooled, she always let me help take the chicken meat off of the bones, chop up the carrots and celery, and then mix and roll lots and lots of "little meatballs". Oh, how I loved this and though it's a process, it's definitely worth the end result. Few foods can compare to the comforting and calming effects of this soup. With the cold months upon us, it's the perfect time to warm up with a bowl of my "Nonna's Sicilian Chicken Soup". Mangia Bene!

#### NONNA'S SICILIAN CHICKEN SOUP Zuppa di Pollo alla Siciliana della Nonna




- 1 whole chicken (about 4 pounds)
- 8 quarts cold water or enough to completely cover chicken and vegetables
- 2 onions, skinned
- 4-5 large carrots, peeled
- 4-5 stalks celery
- 2-3 large potatoes, peeled Salt and Pepper
- $1\ rac{1}{2}$  large heads of fresh  $escarole,\,cooked\,\&\,chopped$
- 1 pound Acini di Pepe, cooked
- al dente and drained
- $1\frac{1}{2}$  2 pounds lean hamburger
- 2 cups parmesan cheese,
- grated 2 cups seasoned breadcrumbs, additional if needed (I use
- homemade) 1/4 cup fresh chopped parsley

To make soup, in a large stock pot, place chicken, onions, carrots, celery and potatoes. Add water to about 3-4 inches above all ingredients. Salt and pepper, to taste, cook on medium-high heat until boiling. Lower heat to medium, simmer 3-4 hours or until chicken is completely cooked, and stock is flavorful. When done, let cool. When ready, strain ingredients, reserving stock and placing it back into pot. Squeeze onions over stock, adding the juice of the onions to flavor, discard remains. Take chicken, discard skin and then remove all meat from the bones, set meat aside. Take about 2 cups of meat (more or less, if desired) and chop/shred finely, add to stock pot (remaining meat can be reserved for another dish). Chop carrots, 3 stalks of celery and the potatoes, into bite sized pieces. Add to stock pot along with chopped escarole. Turn heat to a simmer.

To make meatballs, place hamburger in medium bowl, add breadcrumbs, 1-1 ½ cups parmesan cheese, parsley and eggs, then mix together well. Roll meat mixture into small, bite sized meatballs. Drop a few at a time into the stock pot. Turn heat up to medium, allowing soup to come to a boil. Boil for 5-6 minutes, reduce heat and cook for an additional 30-35 minutes. When cooked, add pasta and stir well. Serve in bowls with additional grated parmesan cheese, if desired.

## HOOPS and HOCKEY in the HUB

#### THE BEANPOT IS BACK

— Yes, it is and right on time for those first two Mondays in February.

In fact, because of the 2022 calendar, It will be a "late" Beanpot with things getting under way with a pair of games on Opening Night (February 7<sup>th</sup>) followed by the exciting Championship Night on February 14<sup>th</sup>.

Last year, for the first time since the early 1950s, the Beanpot was not played because of COVID-19 conditions. It would have been impossible to play because administrators at one of the four schools (Harvard) chose not to field collegiate athletic teams last year. The other three schools (Boston College, Boston University, and Northeastern University) all played a modified Hockey East regular season.

As the Beanpot resumes this year at the TD Garden, Harvard will take on Boston University in the first game starting at 5:00 p.m. while Boston College will face Northeastern University in the nightcap starting at 8:00 p.m.

The two winners will tangled for the title the following Monday at 7:30 p.m. And yes, there still is a consolation game and it can be important for the teams involved. The two losing teams from opening night will meet in the consolation at 4:30 p.m. on Championship Night.

That game can be important because not only does it count in the won-lost records of the two teams involved, it could go part of the way in determining seeding and selection for the an NCAA Regional Tournament berth in March—especially if one or more teams are on the bubble for one of the 16 spots available in the NCAA event.

And also let's remember that there is an added incentive for teams in this area to make the NCAA field. That's because the NCAA National Championship Frozen Four event will be played at the Garden this year (April 7<sup>th</sup>-April 9<sup>th</sup>)

A special treat on Championship Night this year will be the induction of Northeastern's Jim Madigan into the Beanpot Hall of Fame.

Madigan, who presently is the Director of Athletic and Recreation at Northeastern, has had a long and distinguished career at the Huntington Avenue school, having been involved in six of NU's seven Beanpot title runs. He won two Beanpot titles as a player (1984 and 1985) and another as an assistant coach in 1988.

More recently, the Huskies ended a 30-year experience without a title when Madigan, as Northeastern head coach, led the Huskies to three consecutive Beanpot championships in 2018, 2019, and 2020. He is just one of three individuals to win the Beanpot as a player, assistant coach and head coach. Boston University's Jack Parker and David Quinn are the others.

"I have had the unique opportunity to participate in the

Beanpot in a variety of roles at Northeastern University over the past 35 years," stated Madigan in a press release. "All the while I have been fortunate enough to be surrounded by talented teammates, coaches, and support staff. This honor recognizes all of their accomplishments as well."

Madigan added: "To be part of such an exclusive group is a privilege. I would like to thank the Beanpot Committee for this recognition. I look forward to an exciting tournament as we return to the TD Garden for the first two Mondays in February."

#### **BROTHERS IN BIG CHAIRS**

— There's a saying that it is a small world and one example came as Joe Schoen took over the reins as the new general manager of the New York Giants football team.

Steve Serby of the New York Post, who often writes extensive and revealing question and answer columns with the various sports personalities in the Greater New York region, asked Schoen what executive outside of football he most admired. The Elkhart, Indiana native didn't skip a beat.

Brad Stevens. Yes, the former head coach and current president of basketball operations for the Boston Celtics is right at the top of his list in that category. And it turns out that they also go way back — to their college days when they were fraternity brothers at DePauw University, Stevens, of course, played basketball while Schoen was on the football team.

"Brad is someone that I can call upon for advice all the time just because he's been through it," Schoen told Serby. "He went from (coaching) Butler University to the NBA. There are different types of athletes you are dealing with at Butler versus the NBA It is how he dealt with it and how he had so much success."

Schoen also brought up another person with ties to Boston: Theo Epstein.

"He went from the Red Sox to the Cubs and the elusive World Series Championship in Chicago. He was able to return that to Chicago — which was really cool to see."

Schoen's elevation to one of the most coveted front office jobs in the NFL marks the culmination of journey that began when he was a hired as intern in the ticket office of the Carolina Panthers back in 2000. He wound up spending seven seasons with the Panthers as he advanced to scouting assistant and then regional scout

He moved on to the Dolphins as a national scout and later became their assistant director of college scouting. He became the assistant GM of the Buffalo Bills in 2017.

So now those two fraternity brothers — Brad Stevens and Joe Schoen — seek their respective national titles — the NBA Championship and the Super Bowl crown. It's anyone's guess as to which one will cross that finish line first.
