

Exterior Lights for Boston City Hall?

A City Hall press release announces that exterior lights will be installed to enhance Boston City Hall and liven up City Hall Plaza, while increasing public safety.

Mayor Marty Walsh announced that architectural lighting will be installed at City Hall to highlight and enhance the building's original design, building on the Walsh Administration's goals to enhance City Hall Plaza and create a safer environment for

pedestrian traffic in the Government Center area.

Stirpe Nostra

STAINED GLASS

The age of every historical style of architecture, in pursuit of its own particular brand of expression, found the material which best suited its wishes, therefore, an appropriate architecture will immediately arise when use is made of the means which the new industrial techniques offer. These are the words of the master architects of our day. Reduce all of this to terms which we can easily understand, it simply states that when technology develops a new product, architects and builders will bust their britches to use that product in any way, shape or form.

During the development of the Gothic system, the use of rib vaulting concentrated the weight and thrusts from the roof to the piers. The need for counterthrust, therefore, was only at the piers. Exterior walls between the piers no longer carried any appreciable weight and could therefore be opened up. The next question was, of course, exactly what to put into that space. Just about this time in history, it became more widely known that the districts in France traversed by the Loire River contained a particularly fine river sand, suitable for making an excellent grade of stained glass. This glass was, of course, the ideal solution to the problem of occupying the space

There were many fables about stained glass. It was said that



the blue color was obtained by grinding down sapphires, and that deep reds were obtained by adding pure gold to the mix. The actual secrets came from an old manuscript which was written by a monk named Theophilus.

The formula called for one part river sand, two parts beech wood ash, plus a coarse fern called "bracken." A little salt was added as a flux, and the mixture was kept hot for several hours. Glass from this simple mixture was light green in color. Prolonged fusion changed the color slightly, but red was obtained by adding copper, and cobalt provided various shades of blue. The intensity of the colors varied with the

thickness of the pieces of glass, and air bubbles or sand grains produced sparkling refractions of light.

Glass makers usually worked near the edge of the forests, but the window fabricators always worked in the vicinity of the structure in order to avoid the transportation difficulties associated with the huge finished product. Windows in these medieval churches and cathedrals were never standardized in size. Each window was tailor-made to fit the masonry opening; therefore working at the job site facilitated the fabrication and installation.

Stained glass windows were fabricated by first sketching the desired design on a heavy wooden work bench. Pieces of colored glass were then laid over the cartoon in overlapping fashion, and then adjusted for size, color, and position. The individual pieces were then cut to size with a red hot iron, and held firmly in position by pouring hot lead into the joints. These leaded glass sections were then joined into vast compositions which were secured within an iron or stone framework called a tracery.

The period of highest perfection in French stained glass is reflected in the Abbey of St. Denis, near Paris, and in the Sainte Chapelle in Paris. Both date back to about 1200 A.D.

The Primary Concern

Well, the Iowa caucuses are behind us and the New Hampshire primary election will be this coming Tuesday.

My friend Jesse L. asked on Facebook, "Why do we let two very white, conservative states, Iowa and New Hampshire, pick our presidential candidates? This seems wholly unfair and antiquated in a country as large and diverse as ours." I expect he's not the only one asking that.

The short answer is that the Republican Party and the Democratic Party each want to nominate someone who can win in November, and each has found that the current system yields a nominee who can win. Even in elections such as the re-election's of Reagan, Clinton, and Obama, when the incumbent president was popular and the economy was good, the losing party nominated someone who might have won in another year. So we keep the current system because it works.

But, back to Jesse's question, Why?

I don't know enough about Iowa to address that State's role in choosing presidential nominees. I do know New Hampshire. I even campaigned there in the 1992 primary for President Bush, who was challenged by Pat Buchanan for the Republican nomination.

1. Is New Hampshire too conservative to have such an important early role in choosing the nominees? No. New Hampshire is not conservative. Nor is it liberal. It is neither Republican or Democrat. New Hampshire is a swing state. In 17 presidential elections since WW II, the winner in New Hampshire was the national winner 13 times. Of the times when New Hampshire did not follow the national trend, three were extremely close elections, some of the closest in American history: 1948 (remember the "Dewey Defeats Truman") newspaper headline, 1960 (nationally it was 49.7% Kennedy and 49.6% Nixon), and 2004 (Bush's margin of victory in the popular vote was the smallest ever for a reelected incumbent president). New Hampshire went against the national trend one other time that, in 1976, when it joined with Connecticut, Maine, and Vermont — "Yankee" States — in rejecting Southerner Jimmy Carter. New Hampshire is average.

2. Is New Hampshire too white to have such an important early role in choosing the nominees? No. New Hampshire is white. But so is the voting population. If I am managing the campaign of a presidential candidate of either party, New Hampshire voters are a good proxy for the voting population as a whole. According to the U.S. Census Bureau, 70% of eligible voters are white and 73% of voters are white, meaning whites have a higher than average tendency to vote. Blacks are 12% of the eligible voters and 12% of actual voters. Hispanics are 11% of eligible voters, but only 7% of actual voters. In other words, not only are Hispanics a small percentage of eligible voters, the also are less likely to vote. Whites, blacks, and Hispanics account for 92% of all voters. Whites account for almost three-quarters of the voters. So, while the American voting population is diverse, it is not as diverse as Jesse's Los Angeles neighborhood. If you take Los Angeles, Boston, and New Hampshire and ask, which is the better predictor of a presidential election? The answer is clearly New Hampshire.

The answer to Jesse's question is that the parties' primary concern is not to nominate someone who represents the diversity of (Continued on Page 13)

Offers Tips to Avoid Tax Identity Theft

underway, Better Business Bureau (BBB) is encouraging taxpayers to take their time finding and selecting a tax preparer they can trust to avoid mistakes that could result in additional fees or even tax identity theft.

In 2015, BBB received more than 3,300 complaints against tax return preparation businesses across the United States and Canada. Common complaints state that the tax preparer-made errors in returns which resulted in fines and fees. Other complaints allege customer service, billing and contract issues.

BBB's Scam Tracker has also reported over 14,800 scams,

With another tax season with tax collection and IRS scams being the most commonly reported.

> Most victims of tax identity theft are unaware their identity has been stolen until they file their return and discover that a return has already been filed using their Social Security Number (SSN). In some cases, the Internal Revenue Service (IRS) may send the victim a letter informing the victim that it has identified a suspicious return using their SSN.

Signs that you may be a victim of tax theft include:

- More than one tax return filed using your SSN.
- You owe additional tax, refund offset or have had collection actions taken against

you for a year you did not file a tax return.

• IRS records indicate you received wages or other income from an employer for whom you did not work.

BBB offers the following tips to prevent becoming a victim of a tax scam:

File now if you can. This is not always possible for everyone, because many are waiting for their W2 paperwork; however, the sooner you file the better. The IRS began accepting tax returns on January 19th, with a filing deadline of April 18, 2016, rather than the traditional April 15th date.

Use a business you trust. Find tax professionals with **BBB's Accredited Business** Directory.

File electronically. If a refund is due, you can get your refund in less than a month by filing electronically and requesting that your refund be deposited directly into your account.

Use ID theft prevention measures. Do not carry your Social Security card and don't provide the number to a business or organization just because they ask for it. In addition, don't carry your Medicare card unless you're going to a doctor for the first time.

Check your credit report. Request your free credit report



MAYOR WALSH ANNOUNCES RECOMMENDATIONS OF LATE NIGHT TASK FORCE

Mayor Martin J. Walsh announced a set of recommendations made by his Late Night Task Force to help foster and grow a safe and vibrant late night culture in the City of Boston. The task force, which formally concluded its work in 2015, was comprised of a diverse group of students, restaurants and bar owners, law enforcement, and business leaders from across the city.

"In the City of Boston we have an opportunity to create the kind of nightlife that visitors expect in a world-class city," said Mayor Walsh. "I thank all the members of the task force who came together over the course of several months to help us think about how to make Boston a more exciting and engaging place to live, work and play. I look forward to further exploring these recommendations to make Boston even more enjoyable for everyone."

"The MRA applauds the efforts of the Mayor and the City of Boston in moving forward these initiatives," said Bob Luz, President and Chief Executive Officer of the Massachusetts Restaurant Association, "Common sense approaches, such as allowing small operators to serve food after 10 pm and removing unnecessary regulations on downtown operators will continue to make Boston flourish. All neighborhoods of Boston benefit from increased restaurant vibrancy and occupancy. When the Mayor was first elected, he pledged to streamline the regulatory process and he has delivered on that promise."

Recommendations include: Extended Hours

Extend liquor license hours within designated downtown areas with the proper hearing; allow

restaurants that have 10 pm or 11 pm licenses citywide to extend to midnight with proper hearing and community process; and activate pilot areas throughout downtown Boston to extend liquor license hours. This option requires legislative action.

Establishments should be allowed to serve drinks on a patio or deck without the requirement to serve food, unless otherwise stipulated at hearing; in an effort to make it easier for operators to renew their Certificate of Inspection (CI), inspections should be automatically scheduled by the proper departments once their invoice is paid for the new CI; and streamline all licensing requirements to eliminate redundant licenses and requirements.

Entertainment

Live entertainment and music played on patios should be able to extend later in the evening if local residents are not disturbed.

The Late Night Task Force was established in May 2014 with the goal of examining business districts and neighborhoods that are favorable for later closing hours; public safety requirements of expanded late night hours; existing liquor license restrictions; entertainment license expansion; late night transportation access; and how to effectively launch the expanded services. Rory Cuddyer, former Advisor to the Mayor's Chief of Staff and current startup manager, and John Fitzgerald, Deputy Director of Imagine Boston 2030, served as co-chairs of the task force, leading 24 individuals who were appointed by the Mayor.

L'Anno Bello: A Year in Italian Folklore

Carnival Joys

My best friend and I follow a curious ritual. On certain Friday nights, we meet for a movie marathon, interrupted perhaps by a trip to grab organic tamales at Trader Joe's or fresh swirls of frozen yogurt at Pinkberry. We do not just watch these films, however. We celebrate them by poking fun at clichéd scenes. adding our own lines of dialogue and debating the personalities and motivations of our favorite characters. Mostly, we laugh. My friend and I have proudly honed the skill of identifying the absurd in nearly every situation. Sometimes I think that merry people, those prone to laughter and joie de vivre, are crudely stereotyped in life. They are called silly, slight, goofy and, most hurtful of all, unappreciative of life. I believe, though, that it is actually far easier to be serious than to be cheerful. Modern life gives us a lot to be serious about, from stalled trains to long work hours to midterm papers. The ability to find the laughter in the everyday idiosyncrasies of life not only requires an effort on our part, but reaps the rewards of less stress and more sanity. So important is the role of laughter and joyfulness for our being that one February holiday, Carnival, embraces this sense of complete and utter

With exception of New Orleans, Carnival is not a well-known holiday in the United States, a fact that has always puzzled me. Carnival coincides with the arrival of springtime, a period full of such hope and excitement that it seems tailormade for dancing in the streets and wearing mysterious disguises. Even the name of this holiday hints at its decadent history. According to some scholars, the word "Carnival" derives from the Latin expression *carne vale*,

or "goodbye to meat," referring to the moments of extravagant self-indulgence before food restrictions were imposed during Lent. This Christian significance combined with pagan festivities that sought to chase away the spirits of winter and welcome in spring. Hence the predilection for golden, fried pastries in many parts of the world during Carnival, such as the jelly donuts popular in Germany and Poland and the pancakes of Great Britain. These treats not only used up the butter and fat that in olden times was prohibited during Lent, but also resembled the spring sun with their round shape and yellow hue. In Italy, the preferred desserts during the Carnival season are cenci, or fried strips of dough also known by such whimsical monikers as bugie (lies) or chiacchere (chatter). These little delicacies always remind me of brisk, late winter days in my grandmother's kitchen, when I would excitedly wait for her to finish them with a dusting of powdered sugar.

In addition to food, Carnival is known for its exuberant feasts and parties, which open the festive season on the holiday of the Epiphany, January 6th. The events come to a lively culmination on Mardi Gras, or Fat Tuesday, the last day before Lent begins on Ash Wednesday (this year, Mardi Gras occurs on February 9th). The traditional colors of Carnival are gold, green and purple, signifying power, faith and justice, respectively. These colors adorn the plentiful beads and masks that symbolize Carnival, adding to the thrilling feeling of surprise, spontaneity, and mystery. Italy is a land where Carnival festivities, in all their multifaceted and diverse incarnations, reign supreme. The most famous Carnival manifestation in Italy definitely

belongs to Venice, or il Carnavale di Venezia. This ancient feast features people dressing up in costumes of the 18th century and wearing masks that once graced the actors of Italian commedia dell'arte — a type of improvised performance where each broadly archetypal character sported a corresponding mask. The Carnevale di Venezia has become such an icon of the city that visitors to Venice will find the eerie, mystical masks on display all year long. Other famous Italian Carnival celebrations occur in Acireale, Sicily, and Viareggio, Tuscany, where elaborate floats poke fun at local events and politics. These floats are a reminder of the olden times when dissent was only permitted through sublime satire and whimsy, unleashed full-blast at only one time of the year. In the northern Italian city of Ivrea, Carnival is celebrated with an orange battle, a citrusy recreation of the town's revolutionary past. No matter what sorts of celebrations ensue, Italian Carnivals wholeheartedly embrace joy and abandon.

Indeed, I believe that these very traits of joy and abandon are what is missing from our everyday lives. When was the last time that you laughed so hard that tears poured from your eyes, or spun around in the rain? The other evening while channel flipping, I came across a rather awkward looking movie I never heard of before on MeTV. It appeared to be about 10 years old with unknown actors and actresses. The major role in the movie turns out to be a mannequin which rides around town in a wheelchair pushed by a troubled young man who ordered her from a mail order company.

It was hard to understand it as it began, but the more I watched it, I began to see where the movie was going. Perhaps because I worked 40 years in the mental health field, I began to see all the metaphors at work.

The mannequin's co-star is a young man who seemingly has escaped from his hurtful reality into a calmer place where he can connect with an inanimate object because real people cause him so much pain. When others get too close and touch him, he feels physical pain; therefore, he escapes into his pain-free fantasy.

Funny thing though, his family, co-workers and townspeople love him too much to let him disappear into himself. They accept him as he is and accept his mannequin named Bianca, too. She becomes accepted as reality, their reality, and he is just another person in town.

While everyone knows Bianca is pure fantasy, they love Lars so much that they buy into his fantasy for his own sake. Talk about loving someone, this is the ultimate love-giving.

At some point, as he deals with his fantasy, he starts very slowly exiting his fantasy. At one point, Bianca is rushed by ambulance because Lars believes she has stopped breathing. She is rushed into the ER and Lars is told she is very sick. After coming back home with Lars, Bianca gets "better," but everything Lars imagined is now being called into question.

At one point, his older brother and sister-in-law who he lives with asked to take him and Bianca out for a picnic of four. He accepts, and while Lars and Bianca are along, Lars kisses her good-bye and starts screaming she has passed.

The townsfolk all go to her funeral and then to the cemetery. After everyone goes back to his place, he is left standing alone saying goodbye to Bianca when a young girl about his age comes up to him to comfort him on his loss, During the movie, you saw these two several times in gentle moments of real friendship. While standing at the gravesite, she is able to touch him and there is no pain for him. Eventually, she says they should get back to the house to join the rest of the mourners, but he asks her if she would like to go for a walk together first. They both smile as the credits come on the screen.

The audience traveled with him on his road to recovery, a long and painful journey for him and us watching this movie. He struggles, questions and decides the footsteps of this journey. His life gets restored at a cemetery where we bury the dead. In this case, both Bianca and the need for Bianca.

If you have never seen this movie, you should. Our lives are never easy. It comes with plenty of rocks to fall on sometimes. It comes often with pain. Sometimes it is difficult to deal with directly. In this movie, the cure came from within Lars as cures often must. However, Lars was never alone in his agony and slowly comes to realize that truth.

I wonder how folks at the Alliance for the Mentally Ill liked this movie when it was released. In this movie, the one thing never seen was "stigma." Lars was accepted as part of a wider community and always loved for who he truly was.

No one should ever be "born to be blue" as Dinah Shore once sang. We all deserve better than that, and need to believe that, too.



Avoid a Food Safety Penalty This Super Bowl Sunday

The Super Bowl is already the most-watched television program in the United States, and this year's 50th game is sure to take the experience to a whole new level. The game (or the ads) may be the main event, but the food usually steals the show. With more than 1.3 billon chicken wings and 4 million pizzas expected to be eaten during the big game, there are plenty of opportunities for a food safety penalty to occur.

"This Super Bowl Sunday, sports fans across the U.S. will have a great time watching the game with friends and family, while sharing some of our favorite foods that we are fortunate in this country to enjoy," said Deputy Under Secretary for Food Safety Al Almanza. "A long game and a big crowd means more opportunities for food poisoning, but some easy precautions can go far in preventing illness."

To keep you and your guest food safe this Super Bowl, USDA's Food Safety and Inspection Service has pulled together the following key food safety plays:

• To escape a delay of game, use effective clock management with your food. Perishable foods should not be kept at room temperature for more than two hours. Switch out these items during half-time to prevent the same foods from sitting out the whole game.

 Avoid a holding call by keeping hot food, hot, and cold food, cold. Food should remain at a safe temperature and out of the "Danger Zone." The Danger Zone is the temperature range between 40°F and 140°F where bacteria multiply rapidly.

• Avoid a false start by using a food thermometer to ensure that meat and poultry are cooked to a safe internal temperature.

- Raw beef, pork, lamb and veal should be cooked to 145°F with a three-minute rest time.
- Raw ground beef, pork, lamb, and veal should be cooked
- All cuts of poultry should reach at least 165°F.
- · Many cooks think they can finish their cooking play in the kitchen by checking the color and texture of meat or poultry. The only way to safely know if cooking is over and food is ready to eat is by using a food thermometer.
- Prevent an illegal use of the hands by making sure to thoroughly wash your hands before starting to prepare food, after handling any raw meat or poultry and trash, and after finishing cooking. Thoroughly wash hands by using hot water and soap for at least 20 seconds. "Splashing and dashing" doesn't count.

Don't let food borne illness intercept your plans for the biggest Super Bowl ever celebrated.

The front of City Hall Plaza once housed an amphitheater of seats for folks to watch concerts on the plaza. That setup is gone, which makes no sense given all the concerts there still. Finally. the need for a water fountain on a brick and mortar plaza was meant to both soften and

give life to a lifeless area. That water fountain is now a distant memory as well.

I find it curious that LED exterior lighting is the first priority to bring life back to this urban wasteland. Where is the imagi-

Playing around with stupid ideas will not bring the plaza back to the vision the builders and planners had for that area.

Where are today's visionaries? Did they all die in the '60s when folks weren't afraid to think outside the box?

City Hall Plaza had so much promise, but everyone seemed to watch that promise die without a fight.

worked for the Brazilian Workers Center, providing legal services for immigrant workers, and opened the nation's first legal clinic dedicated to domestic workers. She also worked for the National Domestic Workers Alliance. In 2015, Edwards was twice profiled in the Boston Globe's business section for her advocacy on behalf of domestic workers. Edwards is also a proud member of the UAW (United Auto Workers) Union, Local 2320.

Edwards lives with her husband, Rogerio Mauriz, in East Boston. She is passionate about helping all workers, and is a board member of the Boston Independent Living Center (BCIL). She was named a Super Lawyer 2015 for Legal Services, and one of the 2015 National Law Journal Rising Star committee's top 40 attorneys under 40 in the Boston region. Edwards is

a Sustainable Economies Law Center Fellow, and recently received a Racial Justice Fellowship to provide legal services for low income individuals interested in forming cooperative businesses. She is a graduate of the American University School of Law, and received an LLM from the Boston University School of Law.

Edwards said, "I'm passionate about my work, and helping workers from all walks of life. Being a homeowner in East Boston, and attending dozens of community meetings across the city, I see every week the struggles of thousands of citizens of Boston, Cambridge, Revere and Winthrop. Saint Colman of Lindisfarne

The collapse of the Roman Empire ushered in the period known as the Middle Ages, a period of time stretching roughly from 500 to 1000 A.D. It was a time marked by frequent warfare and the virtual disappearance of urban life and learning. Notable exceptions were the monasteries where the light of learning was kept burning through the efforts of the monks, and that light burned brightest in Britain and Ireland.

Saint Colman was born in Ireland in the year 605. He was educated on Iona, a small island off the western coast of Scotland, which was a center of Gaelic monasticism and learning for four centuries and is today renowned for its tranquility and natural beauty.

Colman succeeded Aidan and Finan as bishop of Lindisfarne, which was an island off the Northumberland coast of England and considered the holiest site of Anglo-Saxon England. Colman wholly favored Celtic custom in such matters as the dating of Easter and the tonsure of monks. He had the support of Oswy, king of Northumbria, but Oswy's queen, Enfleda, came from Essex and favored the Roman Church's practices. In 664, Oswy summoned the Synod of Whitby to decide the issues of dispute. Colman was defeated in debate by Saint Wilfrid of Ripon and resigned the Bishopric.

Colman returned to Iona, then, accompanied by his Irish monks and thirty English monks, decided to settle in Ireland. Divisions soon appeared at the new monastery located on an island off the coast of Galway. The English monks complained that the Irish monks



visited the mainland in summer, leaving them to bring in the harvest alone. Colman solved the problem by establishing a new foundation for the English monks on the mainland, at Innisboffin, County Mayo, which became known as "Mayo, of the Saxons." He died on Inishbofin in 676.

When Colman came to Mayo, he brought with him half the relics of Lindisfarne, including bones of St. Aidan, and a part of the true cross which was reputed to be in Mayo Abbey till the Reformation in 1537, when it vanished. Saint Colman's feast day is celebrated on August 8th.

Voter Registration Deadline Reminder in Preparation for the March 1st Presidential Primary

Residents are Reminded that Wednesday, February 10th, is the last day to register or make changes for March 1st Presidential Primary

In preparation for the March 1st Presidential Primary Election, the City of Boston Election Department is reminding residents that February 10, 2016, is the last day to register to vote and update voting addresses or party affiliations.

It is important to note that primary elections are centered on party nominations. In the primary, a registered voter may only vote on the ballot of the party that they are affiliated with if they are enrolled in one of the four major political parties (Democrat, Republican, Green-Rainbow, and United Independent Party). Voters whose party status is "UNENROLLED" (often referred to as Independent) may choose one party's ballot to vote on in the primary. Voters who are members of Political Designations (not political parties) can choose which party's ballot they would like to receive. Only the Democrat, Republican and Green-Rainbow parties have candidates on the March 1, 2016, ballot. The United Independent Party (UIP) will have ballots available, but with no candidates printed on them. Voters registered in UIP will not be eligible to take a Democratic, Republican, or Green-Rainbow ballot.

To make changes to voter registration, residents are encouraged to visit www.cityofboston. gov/elections, the Election Department in room 241 of City Hall, or the City Hall To Go Truck. Additionally, these changes can be made by downloading a mail-in registration form. All mailed registrations must be postmarked by the February 10, 2016, deadline.

For registered voters who will be unable to vote in person on March 1, 2016, absentee ballots are now available in the Election Department from 8:30 am - 4:30 pm. The deadline for an absentee ballot application and/or to vote in person via absentee status is February 29, 2016 at noon. The absentee process is designed for registered voters who will be absent from the city on election day, have physical disabilities preventing them from getting to the polling location, or are unable to get to a polling place for religious reasons. Absentee ballot options are also available to non-registered voters who are Massachusetts citizens who will be absent from the state on March 1, 2016, such as an active member of the armed forces; their spouse or dependent; and if one is confined in a correctional facility or jail except by reason of felony conviction. All absentee ballots must be in the possession of the Election Department by 8:00 pm on March 1, 2016, not postmarked by March 1, 2016.

Oil rubbed bronze is popular in bathroom fixtures. Very striking, a nice mix of old world and modern.




Patina is a thin layer that variously forms (a small amount of surface rust, without pitting) on the surface of stone, as well as copper, bronze and similar metals.

Gobble this up! The crew on a flight from Seattle to Salt Lake City got a surprise when a passenger boarded with a live turkey. Jodi Smalley takes Easter, the "emotional support" turkey, with her everywhere she goes, and says the fowl has helped her cope with depression and the anxiety of flying. The dogs spent much more time looking at an image when the expression they saw matched the emotional state of the audio clip they heard. This suggests that they integrate information from different senses, including what they see and hear, to read the emotions of people and other canines. Researchers believe humans conveyed the powerful survival trait throughout generations of domestication.



The publication tells its 25 million readers, "One Judge stubbornly and doggedly pursuing the truth in his courtroom, regardless of political implications, forced Watergate into the light of investigative day...One Judge brought the White House tapes out of hiding."

Doctors often tout regular exercise and a sensible diet as key to good health, but new research suggests that forming social bonds is just as important. The results indicate that the number and quality of a person's social connections affect specific measures of health over the course of a lifetime. Older adults who feel socially isolated are more than twice as likely to develop high blood pressure, making loneliness a more significant risk factor for the condition than diabetes. Social ties are also crucial early in life. Lonely teens, for example, are as likely to develop inflammation as young people who are sedentary, the study shows. For all age groups, researchers theorize, social connections mitigate the harmful effects of daily stress. "Do have a good and healthy diet, and exercise," advises study author Yang Claire Yang, "but also try to have a good social life."

Benvenuti! Nothing says Carnevale like Venezia. This stunning city prepares to welcome this ancient Winter Festival with great anticipation and excitement each year. The many tourists are delighted to be surrounded by traditional masks and colorful costumes in the beautiful frame of Piazza San Marco with the stunning Basilica di San Marco and the majestic Palazzo Ducale (Doge's Palace) in the background evoking memories of the former glories of the Serenissima Repubblica (Most Serene Republic). On Martedi Grasso (Fat Tuesday) and Giovedi Grasso (Shrove Thursday), Venetians celebrate Carnevale in great style by opening the doors of their noble palaces, throwing elaborate dinner parties and glamourous masquerade balls where opulent costumes and mysterious masks are worn to recreate the aristocratic allure of the past. The lights of Venice reflecting on the tranquil waters of its canals paced by the gondolas at night create a very suggestive scene. As in the time of Giacomo Casanova, the locals dress up in costumes and stroll the busy afternoon streets of the city gathering in the many elegant cafés decorated with a wide array of brocade, damask and golden leaf stucco ceilings under the enchanting light of the gorgeous Murano glass chandeliers. A cup of steamy hot chocolate and some fragrant fritole, a type of local doughnuts, are a very popular pairing during Carnevale. At the time of the Doge, the Leader of the Venetian Republic, fritole was sold in the streets and grappa or anise was added to the basic ingredients. A savory variety of fritole was made with rice or fish like baccalà. In the 18th century the makers of fritole, called fritoler, having achieved such an economic importance, formed a guild called "Corporazione dei fritoler". Indulgence and abundance of food is what Carnevale is about after all, before the beginning of the rigorous observance of Lent. Wear your mask and costume and bring some fritole to your next festa di Carnevale (Carnival party) this year, it will be a sweet success.

Buon Carnevale a tutti!

Fritole

1/2 cup golden raisins
1 2/3 cup flour (plus a little extra)

Salt
1/3 oz fresh yeast (if using active dry yeast follow maker's instructions)
3/4 cup milk (not too cold)
1/3 cup sugar
1 egg
1/4 cup powdered sugar

Preparation: Soak the raisins in lukewarm water, then drain and toss them in a little flour to coat. Sift the flour into a mixing bowl and add a pinch of salt, sugar, the egg and the raisins. Mix the yeast with half the milk. Pour into the bowl with the other ingredients and stir together. Then knead into a smooth dough, gradually adding the remaining milk. Cover and leave in a warm place to rise for about 1 hour. Heat the oil (about 1 inch deep in a deep pan) and fry the dough a small spoonful at a time until lightly browned on both sides. Drain on paper towel. Let cool and sprinkle with powdered sugar to serve. Buon appetito!

50 g di uvetta 200 g di farina (piu extra farina) Sale 60 g di zucchero 1 uovo 10 g di lievito di birra fresco (per

Aggiungilo agli altri ingredienti nella terrina mescolando bene. Impasta il tutto fino a formare una pasta liscia ed uniforme aggiungendo il resto del latte un po' alla volta. Copri e fai riposare in luogo caldo per circa 1 ora. Riscalda l'olio (versane circa un paio di cm in una pentola capiente)e friggi un cucchiaio di pasta alla volta fino al raggiungimento di una bella doratura uniforme. Fai scolare su carta assorbente. Fai raffreddare e cospargi di zucchero a velo prima di servire. Buon appetito!



Nanna & Babbononno

A Nostalgic Remembrance



The new immigrants were mostly from the rural south of Italia. About 97% were illiterate in Italian, never mind English ... a language virtually none of them spoke. Almost all arrived traveling in the holds of ships. That means that they occupied a bit of space in the bottoms of those steamers where the belongings and luggage of the 1st and 2nd class passengers and the cargo being delivered to the New World were kept. There was little air to breathe. Toilets were often buckets (good luck), and they had to wash with sea water. If, perhaps, the seas were rough, add sea sickness to the mix. Fortunately, those late 19th-century voyages only lasted around two weeks. I wonder how many of you have heard stories from family members about your relatives arriving back in the day after having endured these circumstances. Add to this a few lire which, when converted to American dollars, amounted to almost nothing. But they came anyway. Why? Because there was a better future here than where they came from. It was just that simple.

Don't get me wrong. These Mediterranean immigrants weren't actually welcome. They had several things that might make them targets for discrimination: they looked different than the Anglo or Celtic populations that preceded them; they were uneducated and, as I've mentioned, largely illiterate; and they were Roman Catholic, not the most popular religion in the U.S. at that time. In spite of all of this and the lack of prospects for employment, they came anyway. Back in the old country, the generations of southerners that existed right after the unification of Italy had to deal with discrimination, prejudice and lack of opportunity as a consequent result.

The groups with the political power and their church allies, were in power. Most of them were educated, but they were perceived as the enemy. The general population, and the next, emphasized directions that were opposite to where those in control were coming from. A man might show his worth by coming home with calloused hands and a sore back. If he was lucky enough, he could learn a trade. He could become a barber, cobbler, brick layer, baker, cook, fisherman, a groom at a stable, or someone who swept the streets of the town. If these occupations were not within his reach, he could be a tenant farmer, what we called share-cropping in this country. These facts and a few more negative reasons led millions to emigrate to all parts of the Americas.

Their values followed them here and when they raised their sons, the main work ethic was passed on. Almost all of it dealt with learning a craft or trade. None of it included education. Just as an example, my mother was good with math. She could look at a column of numbers about 10 numbers across and 20 down, and immediately give you the correct answer. Yet, Babbononno made her quit school in the 10th grade to go to work to help support the family, and to put money away that might be needed once she was married. Mom complained to Babbononno when her distant cousin, Rose Jannini, went off to college and then medical school (she would become either the first or second Italian-American female doctor in the U.S.). Babbononno's answer explained the Italian mentality toward education and female children at the same time. He told my mother that Dr. Jannini's father had no sons and she was to be trained like the ones that didn't exist.

Babbononno was lucky. He had two trades when he decided to stay in the U.S. He was a musician and had been trained to build and finish furniture, two vocations he was able to find work in right after deciding to stay in Boston. Many, like Grandpa Christoforo, had no trade and went to work using a pick or shovel. Rain or shine, summer and winter, they were out in the open, helping to build the roads that would connect most parts of America - a necessity once automobiles proved to be a practical replacement for the horse. The way for advancement in America was another generation away. This meant education and political power. This is where my

father's generation came in, and with new directions to head in, the American dream started to come true.

One thing I've observed all my life, Italians or Italian-Americans, why I don't know, have a pension for organization, an ability to put businesses together and direct them to all levels of success. It became a bit easier when education became an important factor to "make it in America," and here we are today.

The U.S. wasn't the only country in the new world that southern Italians headed for. I knew this, but became aware of my own family's immigration due to my son, John, finding family when he was living in Zurich, Switzerland. Due to an accidental meeting, I now have a second cousin also living in Zurich who has given me the story of the DeCristoforo family departure from Avellino beginning in the late 1800s.

It seems that in spite of the Resorgimento, or Unification, of Italy in the 1860s, the southerners were still just as disenfranchised as when foreign governments controlled. Most of my grandfather's generation, the second to live in unified Italy, was without hope and began to head to the new world. Most went to Latin America, taking up residence in Argentina and Uruguay. A few headed for Brazil, Venezuela, and a couple to Cuba and Puerto Rico. Only one headed to the United States. They told me his name was Nunzio and he arrived in 1896, and two years later fought in the Spanish-American war. Following the war, he worked as a laborer, saved his money and eventually married Antoinette Paglia. They raised two children, Giovanni and Maria. They also had a third child that died during the influenza epidemic around 1916 or 1917.

Well that was my father, aunt, grandmother and paternal grandfather, in reverse order. My father understood the American way, became educated bit by bit, became politically active, and made sure I headed to college when I was of age. I've tried to pass this all on to my sons, hoping that they will reach the greatest heights of success. One of the pieces of advice I have given them for success: Dress British, think Yiddish, but let them know, first and foremost, vou're Italian. GOD BLESS **AMERICA**

will be asked for your Social Security number and date of birth for authentication purposes.

BBB offers tips when searching for a trustworthy tax preparer:

Look for credentials. Ideally, your tax preparer should either be a certified public accountant, a tax attorney or an enrolled agent. All three can represent you before the IRS in all matters, including an audit.

Don't fall for the promise of a big refund. Be wary of any tax preparation service promising larger refunds than the competition. Avoid any tax preparer who bases their fee on a percentage of the refund.

Think about accessibility. Many tax preparation services only set up shop for the months

at annualcreditreport.com. You leading up to April 18th. In case the IRS finds errors, or in case of an audit, make sure you are able to contact you tax preparer at any time of the year.

Read the contract carefully. Read tax preparation service contracts closely to ensure you understand issues such as how much it is going to cost for the service, how the cost will be affected if preparation is more complicated and time consuming than expected, and whether the tax preparer will represent you in the case of an audit.

Ask around. Find BBB Accredited tax preparation businesses in your local area.

America. Their primary concern is to nominate someone who can win. Winning the presidency is about winning undecided white voters. Blacks are 12% of the vote and they vote overwhelmingly for the Democratic nominee, so it doesn't matter who either party nominates, the black vote is not, in any significant numbers, in question. The media makes much of the Hispanic vote, but the political reality that a campaign manager deals with dictates that the Hispanic vote, outside of Florida, is irrelevant. There is the rare Republican like George Bush who got about 40% of the Hispanic vote. More typically there is something in the range of 30% of the Hispanic vote that is not already locked into the Democratic Party. That means that both parties have a chance at persuading about a third of the Hispanic vote, but that's only one-third of 7% of the total vote, that's under 2.5% of the vote. Now that 2.5% could make the difference in a close election, that is it could in the popular vote. But not in the Electoral College where, other than Florida, the Hispanic population is largely in states such as California, which will go Democratic no matter how much Republicans court the Hispanic vote, and Texas which will go Republican no matter how much Democrats court the Hispanic vote.

Each party has "safe" states that its presidential nominee will carry, but they are not enough to win. They have to appeal to undecided voters in swing states, and the math tells us that the overwhelming majority of those undecided voters are white.





What Really Killed Duk Koo Kim?

Would Headgear Have Made a Difference?



Duk Koo Kim

On November 13, 1982, Duk Koo Kim from Korea challenged Ray "Boom Boom" Mancini for the World Lightweight Championship. The nationally televised fight was seen by millions of boxing fans and was an explosive slugfest with the lightly regarded Kim giving Mancini all he could handle. It was a toe-totoe affair with the tide shifting back and forth.

In the fourteenth round, Mancini connected with a right hand, dropping Kim who hit his head on the canvas when he went down. He grabbed the ropes


I have been at ringside at both boxing matches and in the gym, and seen fighters go down flat on their backs. Sometimes the punch that dropped the boxer wasn't all that hard, but the force of falling flat on his back caused his head to hit the canvas with quite a bit of force. It doesn't take a punch to cause a lot of damage in this case. Think about the stories of people falling backwards on ice and slamming their heads on the hard ground, causing serious brain injuries and death, and I think you get the picture.

When you witness something like this up close, you know a terrible injury has occurred. There is the sound of a dull thud and a sudden limpness that comes over the fallen fighter. The sound is sickening in that you know something bad has happened.

I believe Duk Koo Kim's head snapping off the rope and slamming against the canvas caused his fatal injury. He most likely would have had a serious injury without the situation involving the rope, but that split second



One thing's for sure: the Beanpot trophy definitely will be residing on Commonwealth Avenue for the next twelve months since the two tournament finalists-Boston University and Boston College—both have home addresses on the historic street, although some distance apart.

And if that sounds familiar, well it should. You see, since 1993, only the Eagles and the Terriers have skated off with the Beanpot, which opens the portion of the collegiate hockey year that Boston College head coach Jerry York likes to call "trophy season." The Hockey East playoffs and the NCAA postseason are yet to come, with each bringing its own awards, but first there's the Hub's homegrown event with a sparkling piece of hardware all its own.

The last time the two Hub neighbors met in the championship tilt came back in 2012 when the Eagles topped the Terriers 3-2 in overtime. The OT win came in the middle of a streak that saw Boston College capture five Pot titles between 2010 and 2014, a school record for the Eagles.

But Boston University—led by heralded freshman star Jack Eichel (who now plays for the Buffalo Sabres)—came back to the top last year with an overtime title win of its own, downing Northeastern 4-3 in the extra session. It was BU's first Beanpot title since 2008, ending a seven-year draught in an event that previously had come to be known informally as "the BU Invitational" because the Terriers had dominated the mid-winter event so often.

Indeed, when the Terriers take to the ice in the title game against BC, it will be BU's 28th appearance in the finals in the last 33 years. They've also made the finals in 45 of the last 53 years and 51 times in the 64-year history of the storied tournament. The Terriers have won the title a record 30 times and have lost in the finals on 20 other occasions, the last time being in the 2012 game mentioned earlier.

By contrast, Boston College has won the Beanpot 19 times, including eight occasions under head coach Jerry York, who recently captured the 1,000th victory in his lengthy college coaching career. The Eagles have finished as the runner-up 15 times. While BC has finished last in the Beanpot six times, they have never done so in the 22 years that York has been behind the bench.

Thus, it is BC that has been the dominant force in the recent history of the Beanpot, winning the title six out of the last eight years. It's as if the "BU Invitational" has assumed another informal name—the "BC Classic."

Northeastern, which hasn't won the event since 1988, did lose to BU by a 3-1 count on opening night this year. However, the Huskies have been knocking on the door, earning a berth in the finals five

times in the last nine events including playing in three title games in a row from 2013-2015. Although it's been almost 30 years since the Huskies have hoisted the 'pot, they have been legitimate contenders in recent years.

When one studies the stats, one comes to the realization that it's really Harvard that is having a hard time in the Beanpot. The Crimson's last appearance in the championship game was in 2008 (lost 6-5 to BC in OT). And before that, you have to squint and look as far back as 1998 to find another Crimson squad facing off in the final tilt (beaten by BU 2-1 in OT). Glance back still further and you'll find Harvard's last championship victory, a 4-2 triumph over the Terriers in 1993 that enabled the Crimson to tote the trophy over the Charles River to Cambridge. The Crimson gave it another go this year but came up short, losing to BC on opening night by a 3-2 count.

We thought a quote that appeared on BU's student radio web site indicated the predicament this Harvard is placed in when competing in the Beanpot. The other three schools are all members of Hockey East and thus have played in the Garden numerous times over the years, since the Hockey East Tournament's semifinal and championship games are played at the Causeway Street facility on an annual basis every March. They also play each other much more frequently because they are in the same league.

Not so with the Crimson since Harvard is a member of the ECAC which holds its championships at Lake Placid, NY. Thus Harvard only gets two games at the Garden per season—its two games in the Beanpot Tournament. The Crimson also usually only play one game against the other three schools during the regular season.

"We haven't played at the TD Garden like the other teams do in their playoffs," said head coach Ted Donato in a piece that appeared on the WTBU web site. "There's a little more familiarity between the other teams. The reality is that it's a one-game series times two, and you have to beat the team that you're playing."

So, regardless of the reason, Harvard will once again be relegated to the consolation contest in a matchup against Northeastern that virtually no one will watch since it starts at 4:30 p.m. on a weekday.

Then it's on to the real deal-BU against BC in the latest faceoff in the battle of Commonwealth Avenue. BU leads the Beanpot series 27-15 over BC, but you can throw that stat out. Things are much more even in contemporary times given the Eagle's success on Causeway Street in recent years. It will hopefully be a gem, a game to brighten the darkness of a long winter's night.

I have watched the film of the knockdown many times and, while it is a bit hard to see clearly, not only does it appear that Kim's head hits the canvas, there is something else that I believe contributed to his injury being so serious.

When Duk Koo Kim was hit with the right hand by Ray Mancini, he went down backwards landing on his back with the back of his head hitting the canvas. But something occurred just before his head made contact with the ring floor. If you watch the film carefully, you will see that as he went down his head caught for just a fraction of a second on the bottom rope. It then snapped off the rope and the back of Kim's head hit the canvas with tremendous force. The lower back of the skull is the head's most vulnerable point, and that point of Kim's head received extreme trauma from the impact.

when his head paused while caught on the lower strand accelerated the force going through his body causing the back of his head to hit with tremendous force, sealing his fate.

After the tragedy, there was much public outcry to make changes in the rules governing the sport in order to make it safer. The most notable change to come from this was the reduction of rounds in a world title fight from 15 to 12. While it is true that if the Kim-Mancini bout had ended at the end of the twelfth round, Kim would have survived, it is also equally true that had he hit his head against the canvas in the same manner earlier in the fight, he most likely would have suffered as severe an injury.

No contact sport can be made completely safe any more than driving a car or crossing the street can. That does not mean we should do nothing. Cars are much safer than they used to be with the added safety equipment and mandatory use of seat belts, and I don't hear people saying they enjoy driving any less because of these changes. The same is true in sports. Let's get serious about making these activities safer and just maybe we can prevent the next tragedy, such as what happened to Duk Koo Kim and Bill Masterson, from happening.
