Monday, February 1st Press Briefing

Thanking Commissioner William Gross

The Mayor began his remarks by recognizing and thanking Commissioner William Gross for his leadership, and for his 37 years of service to the people of Boston. He said one of his proudest moments as Mayor was appointing him police commissioner in 2018.

He said that Commissioner Gross led the department with passion and purpose, and embodied a strong spirit of community policing. He made our neighborhoods safer and took Boston's national leadership to a new level.

And as a leader, he never shied away from taking on the most difficult challenges. That is how he navigated the Boston Police Department through monumental changes, as our City battled COVID-19 and worked together to produce the *most ambitious set of police reforms* in the department's history.

Mayor Walsh said that Commissioner Gross leaves behind an inspiring legacy, which includes making history as Boston's first black commissioner; appointing the most diverse command staff in the department's history; reducing crime and getting guns off our streets; creating the firstever **Bureau of Community Engagement** at BPD; and serving as a role model.

He said it's always been clear how much he loves his job and his community, and that he wishes him the best in his next chapter.

Introduction and Swearing in of Commissioner Dennis White:

The Mayor said he was excited to name Dennis White as the 43rd Commissioner of the Boston Police Department.


He said that he's a seasoned and well-respected veteran of the police force, having served the community for 32 years. He's had extensive experience, in both investigative and patrol positions, and has played many roles in serving our neighborhoods.

The Mayor gave an overview of his career:

- Dennis White began his career in District 6, South Boston as a Police Officer.
- He went on to become a Sergeant Patrol Supervisor in District 2 and a Sergeant Detective in District 4, South End and Internal Affairs.
- Before he joined the Command Staff in 2014, he was a Lieutenant and Duty Supervisor in District 2, Roxbury; District 3, Mattapan; and District 13, Jamaica Plain.
- He served as Deputy Superintendent in the Office of the Superintendent-in-Chief and in the Bureau of Field Services Night Command.
- He was then promoted to Chief of Staff to Commissioner Gross and to the rank of Superintendent.
- He is also a member of our City's **Police Reform Task Force**, and helped shape the community-led recommendations for police reform this summer.

The Mayor said he is confident that he will continue the BPD's reputation as a national leader in community policing; advance the department's commitment to accountability and transparency; and help lead the BPD into a new era. He said he's also proud that he will serve as our nation's next great local leader in public safety — continuing to represent the great diversity of our police department and our City.

The Commonwealth of Massachusetts today reported 2,270 new confirmed cases, bringing the total to 500,415 cases. The state reported 30 new deaths, for a total of 14,317 people who have passed away due to COVID-19.

Superintendent. The average number of positive tests each day was about City's **Police Reform Task** 375, also down from the week **Force**, and helped shape the before.

Our current community positivity rate was 6.8%. That is lower than the week before, and down 1.6 percentage points over the last two weeks.

The Mayor said we continue to see improvement in our neighborhood numbers.

Staying Vigilant:

The Mayor said that, throughout the pandemic, Boston has taken a cautious approach to reopening, and we only move forward with reopening if public health experts say it's safe.

In recent weeks, we've seen some improvement in our

COVID numbers. That is why we are moving into Phase 3 Step 1 today. You can go to: *Boston. gov/Reopening* to find the list of businesses allowed to reopen.

The Mayor also mentioned that, last week, the State moved Boston from "high risk" to "moderate risk" on their map, which is encouraging news.

But, he said, we must stay vigilant. The numbers could change any time. Every single person has a role to play in keeping these numbers down.

Everyone can take actions on a daily basis to protect themselves and their loved ones. He reminded everyone to wear a mask; social distance; wash your hands with soap and warm water; disinfect surfaces; and avoid gatherings.

With **Super Bowl Sunday** coming up next weekend, he asked everyone to refrain from gathering with people outside your household.

He also reminded everyone to make testing a part of your routine. We have over 30 testing sites including mobile sites that are free and open to all, regardless of symptoms. Visit: *Boston. gov* or call 3-1-1 for more details.

He said if everyone does their part, we'll be able to keep moving forward with reopening, faster. We'll be able to safely bring back more of the activities we love and miss, and help our businesses recover.

Vaccine Update:

The Mayor said we continue to collaborate with the State on the COVID-19 vaccine rollout, working with them to expand

Sen. Rand Paul's Procedural Vote Shot Down 55-45

Last week, U.S. Senator Rand Paul, R-KY, had his procedural vote declaring a Senate trial of a public citizen as unconstitutional. His motion lost 55-45 with all Democrats in lockstep and 5 Republican senators voting with them.

Sen. Paul noted this vote count ensures that the Senate trial of the former president arrives in the Senate chamber dead on arrival.

Mayor of Chicago Takes on Teachers Union

On Monday, February 2nd, the Mayor of Chicago Lori Lightfoot put her foot down on the Chicago Teachers Union, which seemingly doesn't want to have its members returning to the classroom any time soon. Mayor Lightfoot, one of the most leftist big city mayors in America, says it is time to go back to the classroom, but union leaders are resistant. The mayor says the science and CDC are on her side, but union leaders don't seem to be going along with the program.

She has ordered the teachers back to the classrooms in the Chicago Public School system and was threatening to shut out those teachers who want to continue virtual classrooms online with students by shutting down their Google sites preventing them from any online teaching.

Mayor Lori Lightfoot and CPS Director Dr. Janice Jackson said in a statement Monday. "We have secured agreement on one other open issue and made substantial progress on a framework that we hope will address the remaining issues. We are calling for a 48-hour cooling off period that will hopefully lead to a final resolution on all open issues.

VESTA

Vesta was the Roman goddess of the hearth, similar to the Greek goddess Hestia, but she was worshipped by the Romans during ancient times independently of any connection with Greece.

The worship of Vesta goes back to the time when it was difficult but necessary to obtain fire. Then, as well as even now among some primitive tribes, they developed the custom of always keeping a fire alive for the use of the community, and even to carry it to new settlements. This custom was preserved in the religion of later Greeks and Romans even after more modern technologies had been developed.

The sacred fire, the source of all Roman life and power, was kept alive in a structure known as the Temple of Vesta, and it was constantly tended by a group of virgin priestesses that were known as the Vestals. They resided near the temple in the Forum Romanum. The whole concept goes back into antiquity where the Vestals represented the daughters of the primitive tribal chief, and they kept alive the State fire in their father's hut. The public worship of this goddess was maintained in the temple of Vesta, but her private worship was preserved in every domestic hearth. After she was recognized as a personal deity, it then became necessary to have her attendants live in guarded seclusion in a structure we now call "The House of the Vestal Virgins" or "Atrium Vestae"

The temple was a round structure, probably reminiscent of the tribal chief's hut, and this edifice was the most venerated of all temples in Rome.

Tradition tells us that the first temple to Vesta was built by Numa Pompilius, the successor to Romulus, and the first of the Sabine kings of Rome. He introduced the worship of this goddess, and devoted to her a space of ground just in front of his own dwelling house. It is also interesting to note that at this time in history; about 700 B.C, the king was the high priest, and in this office, he was known as "Pontifex Maximus" or "Pontiff."

There were at least five successive temples here in Rome that were built in honor of this goddess, and all adhered to the same style of architecture. It was always a small circular edifice with a domed roof that was supported on columns. This was thought to typify the round earth and the vaulted sky. The interior contained a low circular altar upon which burned the perpetual fire. The maintenance of this fire was the chief duty of the six vestals.

Numa's temple stood for about three centuries until the Gauls burned Rome in 390 B.C. It was soon rebuilt and the second edifice stood for about fifty years. The third temple to Vesta stood until the great fire under Nero, and the fourth lasted for about one hundred vears. The remains, which now mark the consecrated site, belong to the last rebuilding by Septimius Severus and this work is contemporary with the great arch of Septimius Severus at the opposite end of

Ordinary people do extraordinary things. St. John Bosco never knew monetary wealth. His true reward came from seeing problems and creating solutions. You see, our faith is a timeless interruption of blessings that offer strength and courage amid life's inevitable challenges. The enormous events we're all confronting nowadays don't require much to adjust to a pandemic not seen or lived through in a century.

While limitations do exist despite our earnest efforts to ensure safety, be well, and remain vigilant, we can plow through the pandemic even as the specter of grave illness and overwhelming deaths surround our great nation. My wonderful Mom, who passed away ten years ago at age 90, reminded me and my six siblings during times of family crisis or national calamity: "If I didn't have my faith, I'd be sunk." So do not lose faith though darkness lurks around every corner. Hope abounds as we also see vaccines crushing COVID-19. Tap your inner resolve and you'll know the light of hope, promise and salvation are ever with you.

L'Anno Bello: A Year in Italian Folklore

Fun, Fresh February

Note: L'Anno Bello is reprinting articles that were written before the Coronavirus pandemic. Obviously, advice on gatherings and reunions contained within are not applicable to this current time when social distancing (and mask wearing!) is the best practice. Please read these articles as a testament to the joy and love that imbues Italian celebrations — and as suggestions for ways to spend time in the future once this pandemic is finally over.



All around me, nature shifts and pulsates with a renewed energy. I see this energy reflected in the increased number of birds hopping and singing around the bare branches of my backyard trees. I see it in the pinkish-orange sunset hue peeking through the clouds on a windy evening. The rushing sound of melting snow seems to sing the newness of the season, while the scent of damp soil brims with the promise of new life. The calendar has now turned to February, a month of transition, a month filled with the crackling air and delicate reminders of early spring. Above all, February functions a month devoted to purification, to dusting out the metaphorical cobwebs of a stagnant past and ushering in a hopeful future. The Italian roots of the word "February" reveal the month's cleansing power, as it derives from Februa, an ancient Roman purification festival. Indeed, I love February precisely because it offers a new beginning, a chance to spring-clean the literal and figurative clutter in my life. This desire arises from seasonal cues and has been felt since ancient times, as evident by a plethora of February traditions held dear by our ancestors in Italy. Italian holidays and customs fully embrace the restorative nature of February, paving the way to an exciting

of February. On the evening of February 3rd, he would walk through the crisp, windswept air to his local church, beautifully aglow with candlelight. There, the parish priest would hold two crossed candles against the throat of each worshipper and say a blessing. This was la Festa di San Biagio, or the feast day of St. Blaise, the patron saint of illnesses of the throat and neck. St. Blaise, a fourth-century Armenian bishop, reportedly saved a choking boy's life by dislodging the fish bone that was stuck in his throat. The ritual which my father fondly remembered from his boyhood sought to prevent congregants from acquiring any sort of malady or injury to the throat in the future. In her inimitable book Festa, author Helen Barolini mentions that Italians eat special hard biscuits on la Festa di San Biagio as yet another means to protect the throat. These curative customs practiced on St. Blaise's Day strongly remind me of the purification rites so prevalent in February. Just as a physical illness can be purged from a body, so too can the emotional drain of negativity — similar to the way candles and biscuits are inscribed with therapeutic powers on St. Blaise's Day, so too can our sense of hope and positive thinking cleanse us of the distractions, bad habits and despair that may have plagued us during the winter. La Festa di San Biagio, therefore, reminds of central Italy, my father par- us that the time is ripe for ticipated in a quaint ritual that reevaluating the small improveintroduced the changeable days ments we can make in our lives.

The people of Catania, Sicily, get another chance at a purification festival with la festa di Sant'Agata, or St. Agatha's Day. Bright lights and raucous revelries mark these celebrations, which culminate on February 5th, the saint's feast day. Huge candles and intricate light displays illuminate the city as people march in processions bearing relics of St. Agatha, a third-century Sicilian martyr. These luminous lights mimic the sun, which is now appearing for a longer time in the sky, scattering the darkness of winter and welcoming the restorative days of spring. Like St. Blaise, St. Agatha also presides over the protection against certain illnesses, in her case diseases of the breast. However, St. Agatha further serves as the patron saint of bakers, and as such Sicilian bakers bring their breads and pastries to church for a blessing on her feast day. Now imbued with healing powers, these blessed treats will bring luck and renewal to those who eat them. I recently discovered the celebrations in honor of St. Agatha, and this holiday fascinates me with its themes of light and darkness, feminine power, and symbolic foods. It seamlessly captures the purifying mood of February with its desire to rid people of both literal and figurative maladies, as well as greeting spring in a blaze of warmth. In fact, even after St. Agatha's Day ends, Italians look forward to a whole season of festivities that metaphorically dispel the dark winter days and hail the spring, from the flowers of St. Valentine's Day to the mischief of Carnival.

This February, I am eager to jump into a fresh start. The pastel hues adorning the latest spring fashions, the birds chirping in the bushes, and the delectable Valentine's Day chocolates fill me with an irresistible energy and enthusiasm. I realize that I am certainly not alone in looking forward to the spring, while still enjoying the unpredictable nature of a season in transition. February is a liminal month, where folk customs around the world gleefully greet a new cycle in the year with traditions that emphasize cleansing and healing. In order to fully delight in the spring, after all, we must make good on our promises of the New Year and purge ourselves of the negativity left over from our metaphorical winters. It is our time to let bad habits, self-doubt and worries melt away like the snow during a thaw. Taking an example from the celebrations of St. Blaise and St. Agatha, we can realize that the power for change comes from within, and that with love and hope, our hearts will forever blossom like a spring garden.





Boston EMS Celebrate New EMT Graduates

On Monday, February 1, 2021, Boston Mayor Martin J. Walsh and Boston Emergency Medical Services Chief James Hooley celebrated the graduation of 14 Emergency Medical Technician (EMT) recruits in a small virtual ceremony. This graduating class will be assigned to 911 ambulances, strengthening the City of Boston's Emergency Medical Services (EMS).

"During this unprecedented crisis, our EMTs and paramedics have been working selflessly on the frontlines every day to help lead the City's response and save lives," said Mayor Walsh, who participated in today's ceremony with a recorded video message for

the graduates. "They've done so with passion and dedication, and today's recruits are ready to join the efforts as we continue to battle COVID-19. I want to thank this class for their service and congratulate them as they join the best EMS department in the country.'

This academy class has been on the frontlines of the City's COVID-19 response efforts during the pandemic. Boston EMS EMTs and paramedics have provided care to more than 4,300 patients with confirmed cases of COVID-19. One-hundredsixty-seven of those patients were treated by this class of EMS recruits. Today marks the second EMS graduation since the pandemic began last year.

for Boston residents during some of the most difficult months of the pandemic. They've seen firsthand that putting on this uniform every day is not a job; it is a calling that takes precision and compassion. I am proud to be here today to officially welcome these men and women into our Boston EMS family. I know they'll serve this city well," said Boston EMS Chief James Hooley.

Today's ceremony formally acknowledges the 14 recruits' (11 men, 3 women) successful completion of a rigorous post-hire training program for EMTs at Boston EMS. Already state certified EMTs prior to their hire, this graduating





class completed an additional six months of classroom and field training while complying with COVID-19 safety protocols. In total during three months of field training in ambulances, these recruits responded to 2,298 emergency incidents including strokes, stabbings, traumatic injuries,

> seizures, carbon monoxide illness, overdoses and more. With guidance from seasoned EMT field training officers, recruits are not only prepared to care for patients, regardless of the circumstances, they also now understand the level of care, clinical excellence and professionalism expected of Boston EMS EMTs.

Boston EMS is one of the busiest municipal EMS providers in New "This recruit class has courageously cared England, responding to more than 125,000 emergency medical incidents per year. As a bureau of the Boston Public Health Commission (BPHC), Boston EMS is committed to serving Boston's residents through clinical excellence, emergency planning and preparedness, and community outreach.

> In his FY20 budget, Mayor Walsh added four EMTs to promote diversity and recruitment as well as resources to expand the capacity of Boston EMS's Community Assistance Team, also known as Squad 80. Squad 80 is a twoperson team that travels in a non-transport vehicle and answers calls where patients have

a low frequency of being transported to the emergency room, making more ambulances available for priority calls that need to get patients to the hospital. It also connects people to our recovery and homeless support services and other city programs. In FY21, Mayor Walsh and the City of Boston are investing in seven new ambulances, as well as new portable radios to support coordination and communication, new body armor to protect EMTs and Paramedics and new automated external defibrillators (AEDs) for patient




Saint Abel of Reims

It is believed that Abel was born in Ireland, sometime in the early eight century, the exact date is unknown. Abel was a noted churchman, accompanying St. Boniface, known as the Apostle to the Germans, on his missions to the European Continent. Abel was chosen as archbishop of Reims by Pope Saint Zachary, a nomination ratified by the Council of Soissons in 744 presided over by Boniface.

Boniface had "suspended from their sacred functions certain false priests as unworthy of their office" and instead promoted Abel to the metropolitan See of Reims on March 3, 744, with the support of King Carloman. The event has been interpreted as a return to the provincial system of Gaul, by



interpreted as a return to the which Boniface intended to provincial system of Gaul, by prevent powerful laymen from

obtaining the office of archbishop for their own, secular ends. Milo for instance, who probably was a layman rather than a consecrated bishop, had held the sees of Trier and Reims since 722 and would not give it up. He drove Abel from Reims and remained in office until his death in 763.

Milo had driven Abel from the See in favour of Tilpin, Abel's successor. The date given is 748, but it now appears that Tilpin succeeded in 762 or 763, when Milo died. Abel retired to a monastery at Lobbes Belgium and was installed as abbot. He passed away on August 5, 764.

Saint Abel is commemorated as patron saint of the blind and lame. The feast of Saint Abel of Reims is August 5th.



BRIAN ENO – FILM MUSIC 1976-2020 (2LP Vinyl) UMe

Brian Eno released Film Music 1976-2020, his first-ever collection of music from his film and television soundtrack, spanning five decades. Eno's long-standing affair with film goes back to 1970 with his soundtrack to Malcolm Le Grice's short experimental film Berlin Horse. In 1976, he followed with Sebastiane and a long-forgotten Greek b-horror film, Land Of The Minotaur aka The Devil's Men. This initiated the release of Music For Films. Early classic Eno film moments include "Prophecy Them" from David Lynch's Dune, "From The Beginning" from Dario Argento's *Opera*, "Force Marker" and "Late Evening In Jersey" from Michael Mann's Heat, "Under" from Ralph Bakshi's Cool World and his moving cover of William Bell's soul classic, "You Don't Miss Your Water," in Jonathan Demme's Married to The Mob. His 1978 studio album, Music For Films was a loose compilation of material recorded between 1975~1978. It proved to be a fruitful project with nearly every piece on the album going on to be used in future films, including several of Derek Jarman's, the remake of Jean-Luc Goddard's Breathless, John Woo's A Better Tomorrow, Rock 'n' Roll High School and Todd Hayes' Safe. Eno again explored this approach with U2 as Passengers on their collaboration album, Original Soundtracks 1. Four of the tracks from the album were used in films prior to release: "Beach Sequence" and "Your Blue Room" in Michelangelo Antonioni's Beyond the Clouds, "Miss Sarajevo" in a documentary about a beauty pageant held in the midst of besieged '93 Sarajevo, and "One Minute Warning" in Mamoru Oshii's Japanese animation classic, Ghost in the Shell. The track, "Always Forever Now" later appeared in *Heat*. In the mid-seventies, Eno began a collaboration with British filmmaker Derek Jarman, who commissioned Eno to record "Final Sunset" for the closing scene to his first feature film, Sebastiane. Including the several tracks in Sebastiane, this collaboration resulted in Eno's music in four of Jarman's films, including "Still Water" and "Dover Beach" in Jubilee, "Blue" and the entire score of Glitterbug — his final film. "An Ending (Ascent)" and "Deep Blue Day" are taken from Apollo: Atmosphere & Soundtracks, Eno's collaboration with his brother Roger and Daniel Lanois. The music was written for Al Reinert's landmark documentary of the Apollo moon landing, For All Mankind, since then, "An Ending (Ascent)" has taken on a life of its own and is now remembered just as much from Steven Soderbergh's Traffic, Danny Boyle's 28 Days Later and Miguel Arteta's Beatriz at Dinner. "Deep Blue Day," will forever be identified with Ewan McGregor's legendary toilet dive in Trainspotting.

Nanna & Babbononno

A Nostalgic Remembrance



The current generation of Italian Americans has finally come into its own. The answer for this is education. The first generation of our people started coming here en mass beginning around 1885, and the flow of immigrants continued until about 1929, almost stopping with the arrival of the Great Depression. My grandparents, and I would guess, yours too, (if you around my age and third generation), came here from all parts of Italy south of Rome. They were Baresi, Calabrese, Abruzzesi, Napolitani, Avillinese, Foggiani, and Siciliani. If you add in a few immigrants from Rome itself, you might have an idea of the volume included in the exodus to Americas: the U.S., Argentina, Uruguay, Brazil, Venezuela, and Canada.

There new immigrants were from the rural south of Italia. About 97% were illiterate in Italian, never mind English ... a language virtually none of them spoke. Almost all arrived traveling in the holds of ships. That means that, for around \$50.00, they occupied a bit of space in the bottom compartments of those transoceanic steamers where they kept the belongings and luggage of the 1st and 2nd class passengers, and the cargo being delivered to the New World. There was little air to breathe. Toilets were often buckets (good luck), and they had to wash with sea water. If, perhaps, the seas were rough, add in sea sickness to the mix. Fortunately, those late 19th century voyages only lasted around 2 weeks. I wonder how many of you have heard stories from family members about your relatives arriving back in the day after having endured these circumstances. Add to this were the few lire they had, which when converted to American dollars, amounted to almost nothing. But, they came anyway. Why, because, there was a better promise here than where they came from. It was just that simple. Grandpa Christoforo once told me that he had heard the streets in American were paved with gold. He also added that once he arrived and looked for work, he was handed a pick and shovel and told to do the paving, in asphalt, not gold.

Don't get me wrong. These Mediterranean immigrants weren't actually welcome. They had several things that might make them targets for discrimination: they looked different than the Anglo or northern European populations that preceded them; they were uneducated, and as I've mentioned, largely illiterate; and they were

Roman Catholic, not the most popular religion in the U.S. at that time. In spite of all of this and the lack of prospects for employment, they came anyway. There was another problem they didn't realize they were involved in. Back in the old country, the generations of southerners that existed right after the unification of Italy, had to deal with discrimination, prejudice, and lack of opportunity. The groups with the political power, and their church allies, controlled in the Italian south. Most of them were educated, and were perceived as the enemy. The general population, and the next generation, emphasized directions that were opposite from where those in control were coming from. A man might show his worth by coming home with calloused hands and a sore back. If he was lucky enough, he could learn a trade. He could become a barber, cobbler, a brick layer, baker, cook, fisherman, a groom at a stable, or someone who swept the streets of the town. If these occupations were not within his reach, he could be a tenant farmer, what we called share cropping in this country. These facts and a few more negative reasons led millions to immigrate to all parts of the Americas.

Their work ethics followed them here and when they raised their sons, the main work ethic was passed on. Almost all of it dealt with learning a craft or trade. None of it included education. Just as an example, my mother was good with math. She could look at a column of numbers about 10 numbers across and 20 down, and immediately give you the correct answer. Yet, Babbononno made her quit school in the 10th grade to go to work to 1, help support the family, and 2, to put money away that might be needed once she was married. Mom complained to Babbononno when her distant cousin, Rose Jannini went off to college and then medical school (she would become either the first or second Italian American female doctor in the U.S.). Babbononno's answer explained the Italian mentality toward education and female children at the same time. He told my mother that Dr. Jannini's father had no sons and she was to be trained like the ones that didn't exist.

Babbononno was lucky. He had two trades when he decided to stay in the U.S. He was a musician and had been trained to build and finish furniture, vocations he was able to find work in right after deciding to stay in Boston. Many, like

Grandpa Christoforo, had no trade and went to work using a pick or shovel. Rain or shine, summer and winter, they were out in the open helping to build the roads that would connect most parts of America, a necessity once automobiles proved to be a practical replacement for the horse and carriage. The way for advancement in America was another generation away. This meant education and political power. This is where my father's generation came in, and with new directions to head in, the American dream started to come true.

One thing I've observed all my life, our people have a pension for organization, an ability to put businesses together and direct them to all levels of success. It became a bit easier when education became an important factor to "making it in America," and here we are today.

The U.S. wasn't the only country in the new world that southern Italians headed for. I knew this, but became aware of my own family's immigration due to my son, John, finding family when he was living in Zurich, Switzerland. Due to an accidental meeting, I now have a second cousin living also in Zurich who has given me the story of the DeCristoforo family departure from Avellino beginning in the late 1800s.

It seems that, in spite of the Risorgimento, or Unification of Italy in the 1860s, the southerners were still just as disenfranchised as when foreign governments controlled them. Most of my grandfather's generation, the second to live in unified Italy, was without hope and began to head to the new world. Most went to Latin America, taking up residence in Argentina and Uruguay. A few headed for Brazil, Venezuela, and a couple to Cuba and Puerto Rico. Only one headed to the United States. They told me his name was Nunzio and he arrived in 1896, and two years later fought in the Spanish American War. Following the war, he worked as a laborer, saved his money and eventually married Antoinette Paglia. They raised two children, Giovanni and Maria. They also had a third child that died during the Spanish influenza epidemic around 1917 or 1918.

My father understood the American way, became educated piecemeal, became politically active, and made sure I headed to college when I was of age. I've tried to pass this all on to my sons hoping that they will reach the greatest heights of success. One of the pieces of advice I've given them for success: Dress British, think Yiddish, but let them know first and foremost, you're Italian.

In Italy, Spezzatino di Manzo or Stufato di manzo is a hearty and comforting second course that here in America is called "beef stew." This classic Italian cuisine involves the slow cooking or "stewing" (cooking ingredients slowly in a flavorful simmering liquid) of meat with vegetables, herbs, broth and wine. As a home recipe, Spezzatino di Manzo is part of the tradition of each region and each family has their own special formula they follow. In most homes, stufato is made as a Sunday dish. In the Northern parts of Italy, it is common to find stufato served with polenta, and in the southern regions, it's typically accompanied by Italian bread!

My Nonna told me the secret to making a delicious *Spezzatino di Manzo*, is to use a good piece of whole beef, never use packaged "stew meat," fresh vegetables and a little bit of homemade red wine. Cook this all together, nice and slow and you'll have an excellent meal! Nonna made a veal stew with peas, carrots and potatoes, and she made a beef stew that was absolutely fabulous. Hailing from Southern Italy her stew was never served without homemade warm, crusty Italian bread. It's really amazing how a few simple ingredients cooked long and slow can result in such a delicious meal. On a cold winter day, my "Nonna's Beef Stew" is absolutely the perfect way to warm your heart and soothe your soul!

NONNA'S BEEF STEW Stufato di Manzo Nonna's



- 3 pounds beef (I used beef round), chopped into bite sized (2-3 inch) pieces 1 large Vidalia onion, finely
- chopped
 4 cloves garlic, minced
 4 to ½ cup (more if needed)
- extra virgin olive oil ½ to 1 cup 00 flour 1 to 1 ½ cups red wine
- 4 stalks celery, cleaned and chopped into bite sized (2-inch) pieces
- 1 ½ pounds carrots, cleaned and chopped into bite sized (2-inch) pieces
- 4 pounds potatoes (I prefer russet), peeled and chopped into 3-inch chunks
- 4 cups beef stock Salt and pepper to taste

Cover the bottom of a large electric skillet or cast-iron pan with a generous amount of extra virgin olive oil. Turn heat to medium low, place chopped onions and garlic in pan, and cook until tender.

In a large freezer bag, add the beef then sprinkle the flour and shake well. Make sure each piece of meat is evenly coated with flour. Add the floured beef to the pan with the cooked onions, increase the heat slightly and sear the meat on both sides. Once seared, add the wine and scrape and stir the bits from the bottom of the pan, allowing all of the cooking residues to melt together.

Reduce the heat to low, add the celery and carrots, and cook for about 20 minutes. Add the potatoes and beef broth, cook for another hour or so. Stir gently, season with salt and pepper, and continue cooking on low for another 50 to 75 minutes, or until meat is tender. Once cooked, let sit for about 10 minutes. Ladle into bowls and serve with fresh Italian bread.

vaccination sites, and make sure every community has equitable access to the vaccines.

The Reggie Lewis Center in Roxbury was scheduled to open on Monday, February 1st as a vaccination site. But due to the weather, all appointments were rescheduled for the same times, February 8th.

The Mayor reminded everyone that the City is helping to get the Reggie Lewis Center vaccine site up and running, and the clinic will be vaccinating over 1,000 appointments per week as we ramp up this site to become a mass vaccination

This is in addition to **Fenway** Park, a state-run site, which began its vaccinations on February 1st. The Mayor noted there are adjustments to its schedule due to the weather, and they are asking people with scheduled appointments to arrive early if they can.

The Mayor said he wanted to make people aware that, as the vaccine rollout gets off the ground, supplies are initially limited. He says he knows people are concerned, especially those who are eligible in the next round of vaccines - including residents 75 and older. The rollout has caused frustration, and it's been a confusing and inefficient process — especially for those who do not have access to the Internet.

He said he knows that the State is working hard to remedy these issues, and that he expects things to speed up and that more slots will become available.

He noted that some people will be receiving calls from their doctors about their vaccine eligibility, and he encourages them to keep an eye out for that. He also encourages eligible groups to keep checking the State's website at: Mass.gov/ CovidVaccine and register as soon as they are able.

Seniors can also call **3-1-1** to get connected to the City's Age Strong Commission, which can help answer questions and navigate their options.

The City of Boston and the Boston Public Health Commission will continue to monitor the data, and help the State direct resources where they're needed most. The Mayor said as soon as the vaccine becomes available to people, he urges them to take it.

Remembering Dodgers' Don "Steady" Sutton



Don Sutton, a Hall of Fame starting pitcher for the Los Angeles Dodgers' rotation from the days of Sandy Koufax to Fernando Velenzuelas passed away recently at 75. He passed away after a long battle with cancer. According to the Atlanta Braves, for whom he was a long-time broadcaster, he died in his sleep.

Sutton was a four-time All-Star and had a career record of 324-256 and an ERA of 3.26 while pitching for the Dodgers, Astros, Brewers, Athletics, Angels, and Dodgers again in his final 1988 season. For any other team, he would have been the team ace, but with the Dodgers he was the Number 3 starter behind Sandy Koufax and Don Drysdale.

Sutton never missed his turn in the rotation in 756 starts. Only Cy Young and Nolan Ryan made more starts than Sutton, who never landed on the injured list in his 23-year career.

He was a master of changing speeds and pitch locations, he only had one 20-game season, but earned 10 or more wins in every season excluding 1983 and 1988. He threw 58 shutouts, five were one-hitters and 10 two-hitters, and he worked at least 200 innings in 20 of his first 21 seasons, excluding the shortened 1981 season. He is also seventh on the career strikeout list with 3,574.

After going 23-7 during one minor league season, he was added to the Dodgers' rotation in 1966 during Koufax's last season before he retired, going out winning 27 games. He made his big league debut on April 14, 1966.

After retirement, Sutton started his broadcasting career largely with the Atlanta Braves through the 2018 season.



HOOPS and HOCKEY in the HUB

If you feel that something is missing on the local sports calendar as we enter February you are not alone.

For the TD Garden will be not be the center of attention on the proverbial first two Mondays in February this year. The Beanpot, a beacon of brightness in winter, will not be held, marking the first time in its history that the event has not been played.

Thus, Northeastern, which has won three Beanpots in a row, will have to wait until next year to be given the opportunity to extend its championship run to four consecutive titles.

Last year's event proved to be exciting as Northeastern and Boston University battled to a 4-4 tie in regulation. BU freshman Trevor Zegras scored with a scant 1.2 seconds remaining to force overtime. Then Northeastern defenseman Jordan Harris achieved Beanpot immortality by sending home the winning goal in double OT.

It was the Huskies' seventh title in the storied history of the event and extended Northeastern's stay at the top after enduring a long three-decade interval without winning a championship.

This year three of the tournament's four teams are one the ice competing in a regular collegiate season. Northeastern, Boston University, and Boston College are all members of Hockey East, which elected to proceed with a regular season. Harvard belongs to the Ivy League — whose officials chose not to have any fall or winter varsity sports for the 2020-2021 academic year with the fate of spring sports still to be decided.

The Ivy League does not have its own conference setup. Rather the six Ivy League schools that play Division 1 hockey belong to the Eastern College Athletic Conference (ECAC), a 12-team league that has been decimated since its Ivy League member schools (Harvard, Yale, Brown, Dartmouth, Cornell, and Princeton) are not playing this year. In addition, Union and RPI also chose not to compete in hockey this year.

The remaining schools decided to soldier on with the remaining four schools (Clarkson, Saint Lawrence, Quinnipiac, and Colgate) playing a modified league schedule augmented by a number of non-league games.

Yes, it has been a challenging time, even for Hockey East, with some games postponed and some schools having to "pause" athletic activity for various intervals. But it is better than no season at all.

Through games of February 1^{st} Boston College was second in the 11-team conference with a 9-2-1 mark (27 points) while Northeastern was fifth with a 6-3-2 record (21 points) and Boston University was sixth at 5-3-1 (13 points).

According to the conference's internet site, the 2021 Hockey East Tournament is still slated to be played with a format and schedule to be announced. The "Final Four" teams traditionally convene at the Garden in mid-March to determine the conference champion. The winner earns an automatic berth into college hockey's version of the NCAA "March Madness" Tournament that concludes in mid-April with the crowning of a national champion.

The 2021 Frozen Four Tournament will be held in Pittsburgh with a pair of semifinal games set for April 8th, and the national championship game scheduled for April 10th. The TD Garden will host the Frozen Four event in 2022 (April 7th and April 9th).

That will be the third time the national championship has been determined in the present Garden. The first came in 2004 when Denver defeated Maine 1-0 in the famous "six on three finish" with Denver holding on despite Maine's three-man advantage over the course of the final two minutes.

The second took place in 2015 when Providence earned its first hockey national championship in school history by defeating highly regarded Boston University, 4-3. However, many observers felt that the best game of that Frozen Four was the semifinal between BU and North Dakota, a team that featured 14 NHL draft picks.

BU won that tightly fought game 5-3 and both head coaches went on to sign lucrative NHL contracts. North Dakota mentor Dave Hakstol became the head coach of the Philadelphia Flyers just months after the 2015 Frozen Four. He was the first college coach to go directly to the NHL since 1982 when University of Wisconsin head coach Bob Johnson left the Badgers to coach the Calgary Flames.

Quinn would become the bench boss of the New York Rangers in May, 2018. The move took Boston University fans by surprise since it was assumed he would follow the same path as legendary coach Jack Parker who had played at BU in the 1960s and then later coached there for 40 years.

Indeed, Quinn seemed to have started down a similar path, having played for the Terriers under Parker, and then later returning to serve as an assistant coach on his staff.

He was named head coach in 2013 following Parker's retirement and proceeded to lead the Terriers to four consecutive NCAA Tournament berths (2015, 2016, 2017, and 2018). During the 2014-2015 campaign, the Terriers won the Beanpot, both the Hockey East regular season and Hockey East Tournament titles and went all the way to the Frozen Four championship game. He also was named the 2015 New England Coach of the Year and Hockey East Coach of the Year.

But he signed with the Rangers in 2018, like Hakstol, leaving a top college coaching position behind. North Dakota made seven NCAA Frozen Four appearances during Hakstol's 11 years behind the UND bench. But he lasted less than four seasons with Philadelphia before being let go in December, 2018. He is now an assistant with Toronto.

The Rangers finished seventh in the Metropolitan Division during Quinn's first two years behind the bench, losing to Carolina in the qualifying round last summer. This season New York was in last place in the East Division through February 1st, having only played eight games of the condensed 56-game regular season schedule. So there are numerous opportunities to improve. Whether that will take place is anyone's guess.
