

"Already this year, Boston Police have taken more than 40 illegal handguns off our streets; we can do better to stop them from getting there in the first place. In the month of January 2014, Boston saw 13 shootings with eight gun fatalities. During the same time period in 2013, the city saw 15 shootings with two gun fatalities. the front lines, community, faith and political leaders regarding actions the City can take to treat trauma, get illegal guns off the street, and address underlying causes of violence.

Members of Mayors Against Illegal Guns include Democrats, Republicans, and Independents in big cities and small towns alike. While their backgrounds may differ, on the issue of gun violence they are united for the sake of public safety. The coalition recently announced that it has joined forces with Moms Demand Action for Gun Sense in America — solidifying a nationwide movement of Americans working together to end gun violence.

Every day 33 Americans are killed by guns — Mayor Walsh and his fellow coalition members are not willing to stand idly by. Mayors Against Illegal Guns has advocated for stronger gun laws in states and localities



that are already keeping guns from dangerous hands. For example, in Colorado a new background check requirement has already blocked 100 sales to prohibited purchasers since the law went into effect last July.

The coalition has also called on Washington to take meaningful action to address the issue of gun violence in America, and they will continue to do so until

REGISTRY's 857-DOT-8000 CUSTOMERS OFFERED NEW AMENITIES

Call Center Customers May Now Speak Their Needs; Opt to Skip Lengthy Stretches on Hold

This week MassDOT's Registry of Motor Vehicles Division, under the guidance of Registrar-Designate Celia J. Blue, began offering a 'virtual hold' service for its call center customers to pair with the newly introduced allows customers to conduct RMV business in their own

"Customers choosing to conduct business through the RMV's call center are looking for helpful, concise service," said Registrar-Designate Blue. "With the introduction of these new amenities, we are able to hear the customer's needs and save them time by returning their call when a customer service agent is free."

The virtual hold technology gives customers the choice of receiving a call back from the RMV instead of holding the line in a call

queue. When a caller selects or speaks their business they need help with, an estimated wait time is given to the caller. The caller may then choose to wait or opt to be placed into an outbound queue to receive a call back voice command menu which from the RMV. To do so, customers punch their phone number into the system. The amenity was introduced at the call center on Monday, January 27th where 80 percent of 857-DOT-8000 customers selected the call back option and offered positive reviews once their transaction was complete.

Due to staffing levels and service hours, there will be periods of time throughout the day when the virtual hold service is not available, but an estimated wait time is still provided to the customer. The system's algorithm takes into account hours of operation, staffing levels, the average call time, and the number of call back requests already in the queue. This ensures only calls that can be returned the same day are given the call back option.

Since mid-December and the introduction of the voice command menu, or natural language, the RMV has been monitoring how customers interact with the new system and finding areas to make improvements. Metrics for measuring the success of these new amenities will analyze how many customers selected virtual hold, if customers were routed properly based on their inquiry, the overall call abandonment rate and customer feedback.

Stirpe Nostra

CICERO PART II

One of Cicero's bitter enemies was a rabble rousing demagogue named Clodius (not to be confused with the Emperor Claudius). This man caused the enactment of a law which declared a person guilty of treason if he executed any Roman citizen before that person had been condemned by the people. This of course was aimed at Cicero because of past deeds which were performed in the line of duty; consequently, he went into voluntary exile in Greece. He wandered around that country, full of remorse and self pity, even to the point where he avoided all public honors.

A favorable turn of events took place through the intervention of friends and Cicero was recalled to Rome with great honors. The senate met him at the city gate and he was returned in triumphal fashion.

Five years later he was placed in control of the government of Cilicia (Armenia) and waged a successful war against plundering mountain tribes. His soldiers conferred upon him the title of imperator for that region. He resigned his command with intentions of returning to Rome in great triumph, but trouble between Caesar and Pompey put a damper on that idea. His vacillation between the members of the First Triumvirate was not a great period in history and neither was his divorce of Terentia, his wife of 33 years. During

their married life she had become a woman possessed of a violent temper in addition to her extravagance in the management of his private affairs. They had two children; a son and a daughter. He was very fond of his daughter Tullia, but when her death brought joy to Terentia, he quickly divorced her. At the age of 62, he married a very wealthy and very young girl. From that moment he became known as 'Smiling Cicero."

After the death of Julius Caesar the "Second Triumvirate" was formed. This was a coalition between Octavian (later called Augustus), Mark Antony (Marcus Antonius), and a famous general named Lepidus. This Second Triumvirate was sealed by a proscription (publishing the names of persons condemned to death) in which each member permitted the execution of any friend who might be named by either of the other two members. By this method at least 2,000 of the middle-class (equestrian order) and 300 senators were executed and their property confiscated.

After the assassination of Julius Caesar, it was Cicero who had composed vigorous orations against Mark Antony. It follows then, that it was Mark Antony who submitted the name of Cicero to be added to the list of those to be proscribed.

From Slave to Legislator

Americans of every ethnic heritage can use African-American History Month as a time to meditate on America's greatness, her failings and her promises. "ALL MEN ARE CREATED EQUAL," proclaims our nation's birth certificate, the Declaration of Independence, yet under our first general government, the Articles of Confederation and under our Constitution, until the 13th, 14th and 15th amendments (ratified from 1865 to 1870) States treated part of their population as less than equal. In the case of the 14th Amendment (citizenship and equal rights) and 15th Amendment (voting rights), we know that full implementation did not take place until the 1960s and another amendment, the 24th (abolition of the poll tax) and other civil rights legislation.

For too many years, America failed to live up to the promise made in the Declaration of Independence. However, that promise, once made, set America on a course that would surely, although not swiftly, lead to true equality. Black History Month reminds us of our national failure, but also of how far we have come, and should move us all to recommit to the struggle for freedom and equality.

One example of how far we came, and how relatively quickly, in the lifetime of one man, I direct you to the life of Boston resident Lewis Hayden.

According to information on the website of the National Park Service:

"Lewis Hayden was one of Boston's most visible and militant African American abolitionists. He was born enslaved in Lexington, Kentucky in 1812. His first wife, Esther Harvey, and a son were sold to U.S. Senator Henry Clay, who in turn sold them into the deep south. Hayden was never able to discover their ultimate whereabouts. Eventually, Hayden was remarried to a woman named Harriet Bell and they escaped with their son Joseph to Canada in 1844, and then to Detroit in 1845.'

Before the American Civil War, he and his wife aided numerous fugitive slaves on the Underground Railroad, often sheltering them at their Beacon Hill house. The Lewis and Harriet Hayden House has been designated a National Historic Site on the Black Heritage Trail in Boston.

A Republican, Hayden, in 1873 was elected as a representative from Boston to the Massachusetts legislature. He supported the movement to erect a statue in honor of Crispus Attucks, an American black who was the first person killed in the Boston Massacre, at the beginning of the American Revolution.

Hayden was not the first African-American elected to the Massachusetts legislature. In 1866 Charles Lewis Mitchell and Edward Garrison Walker were the first. They had been born free, as was John J. Smith, who was elected in 1868 and George Lewis Ruffin (1870). That 1873 that put Hayden in office also saw the election of Joshua Bowen Smith.

Slavery, the condition of Hayden's birth, reminds us of America's failure, but his rise to respected Bostonian and representative of the people in the legislature proclaims America's greatness as a land that, belatedly, kept its promise of equality.

Early American Instrument Making in New England

Darcy Kuronen, curator of musical instruments at the Museum of Fine Arts Boston visits North Bennet Street School, a school that teaches instrument making, on February 20 to talk about musical instrument making in Massachusetts. The event will be held at 6:00 pm, February 20, at Windgate Gallery, North Bennet Street School, 150 North Street, Boston. Admission is free.

Musical instrument making has a long tradition in New England and instruments made by New England

craftsman are among the greatest strengths of the musical instrument collection at the Museum of Fine Arts Boston. In his talk at North Bennet Street School, Darcy Kuronen, curator of musical instruments at the Museum of Fine Arts, Boston presents a survey of early American instruments, with stories about the craftsmen who made them and how they were used during the eighteenth and nineteenth centuries. Mr. Kuronen and a violinist will demonstrate two early violins, a guitar, a flageolet and a melodeon from the Museum's collection.

Darcy Kuronen has worked since 1986 at the Museum of Fine Arts, Boston, where he is the Pappalardo Curator of Musical Instruments. In 2000, he organized the critically acclaimed exhibition, Dangerous Curves: Art of the Guitar, celebrating the diversity of guitar design over the past four centuries. Kuronen also serves as volunteer curator to the collection of historical instruments owned by the Boston

Symphony Orchestra. A specialist in early American instruments, he has written several articles and lectured widely on the subject.



Saint Jerome Emiliani, Patron of Orphans



Jerome was born in Venice, the son of Angelo Emiliani and Eleonore Mauroceni. His father died when he was a teenager prompting him to join the Army at the age of 15. Jerome participated in the defense of Castlenuovo in 1508 against the League of Cambray.

Jerome was taken prisoner while stationed at the mountain fortress of Treviso. He escaped attributing his liberation to the intercession of the Blessed Virgin. After his return to Venice, he decided to begin a new life entirely devoted to the poor and especially orphans. He was ordained in 1518 at the age of 37; with his ordination, he plunged into his life's work of tending to the sick and impoverished. There was a break out of plague in 1528 prompting Jerome to care for the sick and hungry at his own expense. He rented a house near the church of Saint Rose enlisting laymen to aid him in ministering to the sick.

He was also placed in charge of the hospital for incurables founded by St. Cajetan. In 1531, he went to Verona and persuaded the citizens to build hospitals in Brescia, Bergamo, Milan and other places in northern Italy, he also erected orphanages for boys and for girls. At Bergamo, he also founded a hostel for repentant prostitutes. Jerome is attributed with having founded the first known orphanage of modern times.

In 1532, Saint Jerome established the congregation of Clerks Regular of Somasca. The motherhouse was at Somasca in the Comune of Vercurago between Milan and Bergamo, the members became known as Somaschi. In the Rule of this Society, Jerome stated the principal work of the community was the care of orphans, poor and



sick. They also attended to the education of college students, academics and seminarians. He was the first to teach children the Faith by using questions and answers. The Congregation was approved in 1540 by Pope Paul III and spread throughout Italy.

Jerome, passed away at Somasca, a victim of an epidemic, on February 8, 1537 while attending plague victims.

He was beatified by Pope Benedict XIV in 1747 and canonized by Pope Clement XIII in 1767. Saint Jerome's feast day is celebrated on February 8th. He is the Patron of Orphans.

L'Anno Bello: A Year in Italian Folklore

Just Desserts, Italian Style

I recently noticed that the culinary world is at war, a drawn-out conflict between cooks and bakers. If one believes the Internet, cooks deride bakers for their supposed lack of spontaneity and creativity; bakers prefer the comfort of following a recipe. This conflict never manifested in my childhood — my mother cooked up a hearty meal of orecchiette with broccoli rabe as easily as she baked my scrumptious birthday cakes. However, as I grew older and developed my own identity in the kitchen, I realized that I am definitely more of a baker. I love the magic of turning the basic essentials of human life, flour and water, into substantial treats. I adore the way the oven warms my kitchen and embraces me with tantalizing scents. Finally, I do see the creativity in baking, in the way one simple recipe can be adapted, tweaked and altered to yield a myriad of delectable results.

A lot of praise has been heaped — justifiably! on how wonderful Italian entrees are, but oftentimes traditional Italian desserts go unnoticed. So in honor of my love for baking, I have compiled a list of desserts from the Old Country that stir passion and nostalgia through my veins. Since Italian desserts are plentiful, I will try to focus on desserts that pertain to the month of February, a very sweet month indeed due to St. Valentine's Day! I hope you enjoy this trip down memory lane as much as my stomach does!

Cannoli: Arguably the most famous Italian dessert, cannoli are a staple in cookbooks and supermarket aisles everywhere. To find an authentic cannolo, however, your best bet is a small family-run bakery or restaurant, of which Boston's Italian neighborhoods have plenty! The traditional filling for cannoli is ricotta and the shells must be freshly filled with it to order. Leaving a cannolo languishing with cream inside will make the shell turn from a decadent crisp to a mushy mess.

Palermo region, but they are now enjoyed all over Italy and around the world. Cannoli were originally treats for the Carnival season, when dishes made of rich ingredients were eagerly consumed before the austere period of Lent. The name "cannolo" means "little tube" in Italian, speaking to their distinctive shape!

Cenci: Known as "angel wings" in English, these fried strips of dough covered in powdered sugar are a real Carnival delicacy in Italy. I love making them with my grandmother on an earlyspring day, when the joyous sensation of Carnival penetrates my bones and the promise of Easter seems just a few hops away. My grandmother has always called these little goodies cenci, but they are known by different names according to the region of Italy. Many of the names reflect the whimsical nature of Carnival, as you will also find them called bugie (lies) or chiacchiere (chatter)!

Crostata: A crostata is an Italian tart or pie, whose name derives from the word "crust." Crostatas are rustic, free-form pastries, and the beauty of this treat is that the filling can change according to the season. February can call for crostatas with orange marmalade inside or a fresh pear compote. Why not celebrate Valentine's Day by making a romantic crostata with ruby-red strawberry or raspberry preserves or — my favorite! — Nutella?

Pizzelle: Hard or soft? Vanilla, anise or lemon extract? No one can agree on what makes perfect pizzelle, or the waffled cookies so popular among Italians and Italian-Americans. When there is this much debate about a dessert, it must mean that it has permeated deep into the culture. I am partial to soft pizzelle, but honestly all forms are so good that I'd rather eat them than fight about them. Pizzelle are often associated with holidays, like Christmas or Easter or special events like weddings and baby showers, so much Interesting facts about so that I cannot think of cannoli: they originated in pizzelle without imagining specifically the some kind of party in my

Tiramisu: I always thought tiramisu was an old Italian dessert, but quick research tells me it is a midtwentieth century invention. That could be why tiramisu, in its modern incarnation, never appeared in any of my grandmother's childhood cookbooks. One would think that because it is a more contemporary dessert its origins would be easily investigated, but the creation of tiramisu is actually shrouded in legends and myths. Some say the earliest tiramisu was prepared in 17th century Siena for Cosimo de Medici. Others say it was created in the 1960s in the Veneto city of Treviso. All that is certain is that the name of this mascarpone-and-ladyfinger layered dessert means "pick me up," which its servings of espresso will certainly do! Tiramisu is a romantic pick for Valentine's Day.

The Pioneer, Perfectionist & Patriot

PART 3 of 4

On November 6, 1964, the now indispensible Cappelletti told me he had his most memorable game of his career. Playing the Houston Oilers at Fenway Park, the Patriots were losing 24-22. Parilli threw a 22 yard pass to Cappelletti with one minute to play. Parilli ran for another 10 yards out of bounds on the next play stopping the clock. With one second remaining, Cappelletti checked his footing and calmly booted the game winning 41 yard field goal to secure the 25-24 win in a thrilling finish. A perfectionist he was indeed. "He was such a clutch kicker for us," said Parilli.

To sum up his heroics, Cappelletti was the first AFL player to score points in a game. He also kicked 342 extra points, 170 field goals and led the AFL with 4 two point conversions during his 10 year career in the AFL. He is one of only 3 players to play in every game in the history of the AFL. He caught a TD pass, kicked 4 field goals and 12 extra points in his 5 AFL All-Star appearances. He was an AFL All-Star wide receiver

in 1961, 1963, 1964, 1966 and 1968 and an AFL All-Star Kicker in 1964, 1966 & 1968. Cappelletti was the runner up to George Blanda of the Houston Oilers for the AFL MVP in 1961 and was the AFL Player of the Year and MVP in 1964. He also caught 292 passes for 4,589 yards and 42 touchdowns, many of them from Babe Parilli. He is still the only Patriots player to have 3 interceptions in a game on 10-16-60 and have 3 touchdown receptions in a game on 11-15-64. Cappelletti led both the AFL and the NFL in scoring 5 times and holds the NFL record of averaging 7.5 points per game 1964 Fenway Park snow being removed over a career of more than 10 years. In 1961

and 1964 he scored more than 10 points per game and averaged 9.6 points per game over a period of 80 games. In 1964 he scored the game winning points in 4 of their 10 wins that season. Not surprisingly, Cappelletti ended his career scoring more points than any other player in the AFL. My brother was right. All he did was score points. As Cappelletti tells it, "scoring became my identity." The Patriots later named him, "Mr. Patriot" but for many, he was "Mr. Clutch."

As successful as those years were for Cappelletti, he was savvy enough to understand that it would eventually come to an end. Falling back on his bartending experience, he opened up a popular restaurant in Boston's Back Bay called "The Point After" in 1967. "Football was not a full time job in those days as it is now." Mimicking Patsy's Steak House in L.A with "Steak Sinatra" Cappelletti invented his own favorite dish called "Steak Gino" which was a topquality boneless sirloin made to order and smothered with mushrooms and peppers. Prominent and famous figures in sports and the entertainment frequented the restaurant on their visits to Boston. Cappelletti told me, "My greatest thrill was shaking the hand of Brockton's Rocky Marciano and spending time with Ted Williams."

By 1970, the Patriots organization seemed to be losing stability. The original fraternity of players with whom Cappelletti had begun his career had gradually departed. Parilli left for the Jets the year before to be a backup for Joe Namath. Nick Buonconti had been traded two years earlier to the Miami Dolphins. The head coaching staff was turning over all too often. The team was chalking up losing records and the tough Boston press mocked them as "The Patsies." Playoff berths were a perpetual distant memory. Cappelletti had also been relegated to kicking duties once

"I knew it was time to leave. You look at where you are in life, family wise, mentally, physically and spiritually. I was 27 years old when I played my first professional football game. I accomplished quite a bit with a late start." At that time the average playing span of a football player was only 6 years. Cappelletti played 11.

He reflected, "we had a special team back then. All the players bonded. We were involved in each other's lives off the field as much as we were teammates on the field. We all knew by then we were the pioneers of the league and it was something unique." By 1970 it was all but gone.

The Nazzaro Center has represented Boston twice, including the very first year, 2008, that the city began competing.



second medical opinion. In fact, the vet may even recommend the option, especially for a particularly difficult or unusual problem. Your vet may refer you to a local specialist or to a veterinary teaching hospital (if there is one in your area) because these resources offer a great deal of additional expertise in specialized areas (example: neurology, cardiology, oncology, etc.) Such expert consultation may involve significant added cost but is often the most effective way to get to the bottom of an unusual problem and obtain the best treatment.

Print resources, Web sites and online pet-friendly forums can often provide you with general background information. 

I was blown away with the beauty of the event and loved all the detail to compliment it. I had an amazing time and recommend that Boston hop on that band wagon. Recipes from the Homeland

NONNA MARY'S FRITTEDI

1 1/4 pounds ground beef

2 eggs

3 tablespoons grated Romano cheese

1 large chopped garlic

1/2 cup flavored bread crumbs

2 tablespoons olive, canola or vegetable oil

Salt

Combine ground beef, grated cheese, chopped garlic and bread crumbs in a bowl. Add slightly beaten eggs and mix thoroughly. To shape Frittedi, take about two tablespoons of prepared ground beef in your hands, roll and then flatten it to the shape and size of a hamburger. Continue shaping portions and set aside on a platter. This should make about eight Frittedi.

Heat oil in a skillet. Then carefully place Frittedi in the skillet to fry until thoroughly cooked and browned on both sides. To drain excess oil, place the cooked Frittedi on a paper plate for a few minutes. Then move them to the serving platter. The Frittedi can be cooked over charcoal or gas grill in place of a skillet.


Serve with your choice of vegetable or salad.

The remaining Frittedi can be added to a tomato sauce or stored in the refrigerator.

NOTE: My children called their paternal grandmother "Nonna Mary." This is one of her recipes the family enjoyed. She called them "Frittedi" because "fritta means fried" in Italian. She always fried them until they were well browned on each side.

I became familiar with them soon after my husband and I married in 1949. I recall her telling me that when her four boys were young and she had leftover Frittedi, she served each of them one between two slices of Italian bread for their noontime lunch. Some liked a slice of pickle with it while others added some mayonnaise. Though they are similar to meatballs, the garlic and extra grated cheese gives them added flavor when

Nanna & Babbononno

A Nostalgic Remembrance

I've mentioned in my columns that I was a musician before I was anything else in life.

This is true and is the result of the generations that preceded me. Babbononno came to America as a musician. His three sons became musicians. His daughter married a musician. I didn't stand a chance with a grandfather, father and several uncles who were professional musicians. When I came along, it was just assumed that I too would be a musician.

At about the age of six, I was handed over to Babbononno to learn how to read music. His method of teaching me this art was by using Solfeggio, an Italian design on rhythmic articulation that has been used at most music colleges around the world. Babbononno sat me down in front of a music stand with the Solfeggio book in front of me. He would open it to a page and I had to sing the notes of the exercise and beat them out with my right hand while he conducted the lesson with a baton, or in his case, a ruler in his hand. If I made a mistake, I got the ruler off my knuckles. By the time I was ten, I had hands light a prize fighter.

Once Babbononno gave the OK, it was time for me to learn an instrument. I tried every practical instrument imaginable but didn't take to any of them. I took piano lessons, accordion lessons, trumpet lessons, clarinet lessons, drum lessons but never practiced and the family was told by the teachers not to waste their money. I joined the drum and bugle corps when I attended the Joseph H. Barnes Junior High School. This was part of a military drill program that existed in all of the middle and high schools in Boston back in the day. I enjoyed being in uniform and marching with the other kids in uniform but knew that playing a bugle was limited. I think that this was a psychological compromise. Actually, if I came along a generation earlier, I could have made a living playing music. During the '30s, the swing bands dominated pop music, Benny Goodman. Glenn Miller, the Dorsey Brothers. Duke Ellington. Count Basie, Vaughn Monroe, etc ... After World War II ended, the bands began to break up. The trend slanted toward small groups with a vocalist out front singing the latest pop tunes. After the early 1950s, rock and roll entered the equation, but even before this phenomenon came about, most musicians in cities like Boston, New York, Philadelphia and Chicago were down to playing one nighters if they freelanced or just weekends if they played nightclubs or restaurants. A small percentage played steady after the 50s began. For the rest of the musicians, they had to find day jobs and hope they could get booked for a wedding, party, christening, dance or bar mitzvah on a weekend.

Before World War II, Uncle Nick and Dad were on the road with big bands. But by the time I was old enough to be part of the business, those days were gone. But, now you are going to ask, "What instrument did I learn how to play?" Well, it happened this way: I was sitting on my front steps one warm spring day in 1957. I was just finishing my first year in college at this point in time and working at the Seville Theater on Meridian Street. This was my 5th year at the movie house and I had put playing music on a back burner. As I sat on the steps a friend who played bass walked past me on the opposite side of the street with his bass violin under his left arm. I yelled a hello and he stopped to talk. He told me that he had been drafted and was selling his bass to someone in the neighborhood. He also mentioned that the local band he was with would be minus a bass player. He knew that my father played bass and thought I might play the instrument too. If I wanted to take his place with the local band he would make sure I had the job. I had taken lessons on the bass from Dad, but like my concentration with other instruments, it was miniwas assumed that the son, mal. The idea of playing bass with a band seemed interestfessional musicians would ing and I told my friend that I might give it a shot. I did and that was the beginning.

I began to study the instrument on a serious note and practiced as much as I could. At times this was difficult. I worked at the Seville, at school I was on the swim team, played a couple of other intramural sports and

baseball for the CYO league and the American Legion. But, I squeezed in practice time on Dad's bass. When I needed an instrument of my own, I rented one for a few bucks a month.

After a couple of weeks rehearsing with the local band, we obtained a job at a pizza place in East Boston. I think it was on Bennington Street. The owner wanted us there on Thursday and Friday nights which fit into my schedule as I didn't have to work at the Seville on those nights. Well, working with that local band led to me becoming acquainted with musicians who dropped by to hear us. As a result, I started playing with other groups and eventually left the original band. The leader only wanted to play locally and didn't have aspirations of going beyond. When I discussed things with Dad and Babbononno, they agreed that it was time for me to

move forward on my own. At Dad's suggestion, I called the office of band leader Ken Reeves. He and his many bands played societv music throughout the state and he had as many as 10 to 20 bands out on a weekend night. I called and spoke to a Mr. Cahn and asked for an audition. At a given point in time, I reported to their Boylston Street office and auditioned with Mr. Cahn playing piano and me setting the rhythm with my bass. When I finished, Cahn told me that they really didn't need any more bass players, but thanked me for coming in. When I told Babbononno the events of the day, Nanna, who was listening in offered, "Nothing ventured, nothing gained." She had a point and the next day, I received a post card from Mr. Cahn offering me a list of dates (mostly Saturdays) for the next couple of months. I was thrilled and accepted them all. I bought my first car as none of the dates were local and I didn't know who I would be working with. When I reported to the first local, I was apprehensive and the rest of the band was composed of the top men in the Reeves office. Mr. Cahn was the pianist and told me he was either going to break or make me. Dad and Babbononno had taught me well and I held my own. Later, during intermission, I discovered that Dave Cahn knew my uncles and Dad. They all lived in the same neighborhood as young musicians. He even confessed that he bounced me on his knee when I was still in diapers. After he volunteered that information, the rest of the band sort of welcomed me as a new member. I stayed with the Ken Reeves office for the next few years and paid my

Manning and Broncos Left Prey to the Foraging Seahawks in Lopsided Super Bowl

In one of the most lopsided games in history, the Seattle Seahawks defeated the Denver Broncos 43-8 in Super Bowl XLVIII. The 35 point margin in last Sunday's game is tied for third all-time for a Super Bowl game. To put the magnitude of this defeat into perspective, in the 6 previous Super Bowls the combined margin of victory was 34 points.

From the opening snap of the football, the Seattle defense, the "Legion of Boom" sent a message that they were not going to be intimidated by the Broncos. An errant release by Center Manny Ramirez (no, not the former Red Sox outfielder) and the ball sailed over Manning's head and ended up resulting in a safety, two points, for the Seahawks. The fastest score in Super Bowl history, just 12 seconds into the game, and Denver was in trouble. Two Manning interceptions, one returned for a thundering 69 yard touchdown by eventual game MVP Malcom Smith and at halftime, the Seahawks were ahead 22-0. What Happened to that Mini-green Monstah in Quincy?

It seems forever when I was living across the Neponset River in Quincy that I learned of plans for a mini-Fenway Park in Quincy pushed by folks in the nonprofit Kids Replica Ballpark Inc. Plans included a mini-Green Monstah, a mini-Citgo sign and the facade of Fenway Park circa 1912. Oh. and three thousand seats

This worthy project got stalled years ago and it might be dead today. Organizers are blaming the Red Sox and John Henry. "They (Red Sox) want to pull the plug on the whole damn thing," says Ron Iacobucci, CEO of the proposed park. "If they rolled up their sleeves and got active again instead of being a roadblock, we could have got it done. But they didn't.

The latest issue according to a recent Boston Globe news item are the special 'Fenway Park" license plates that were issued and have been renewed since 2007. Proceeds from the plates made possible by an agreement between Major League Baseball, the Boston Red Sox and Iacobucci's group were earmarked for the Mini-Fenway project. This gave the nonprofit behind the project a steady stream of revenue to help operate and maintain the ballpark. However, now the Red Sox and MLB officials have decided to end the agreement reached in 2007. There are 2,000 special "Fenway" licenses issued by the Registry of Motor Vehicles and now they can't be renewed. The Red Sox are blaming Major League Baseball and the RMV for this renewal problem.

He was the fifth Red Sox All-Star to end up in Japan. The others being Mike Greenwell, Scott Cooper, Reggie Smith and Mike Andrews.

Scott Cooper was a great first baseman and slugger who in his prime became a great player to watch with the Brewers. At 28 in 1996, he ended up in Japan with the Seibu Lions. He returned to US and played for Royals in 1997, then retired after the season ended.

Another guy I liked was Reggie Smith. He ended up in Japan with the Yomiuri

John Henry, Babe Ruth's Giants. He batted .285 with daughter Julia Ruth Stevens 28 homers in 1983 but his time with the team was marred by racial hostility with fans and battles with umpires. He retired following the 1984 season.

Remembering Paul Blair

Paul Blair, an eight-time Golden Glove centerfielder passed away a few months back. He helped the Baltimore Orioles win two World Series titles in 1966 and 1970. Blair also played for the NY Yankees winning two more World Series titles in 1977 and 1978. He ended his career in Cincinnati with the Reds.

In 17 seasons, he hit .250 with 134 homers, 620 RBI and 171 stolen bases. He appeared in six World Series, two All-Star games and won Golden Gloves in 1967 and 1969-75. He was elected into the Orioles Hall of Fame in 1984.

When thinking of his baseball abilities, I put him up there with Scott Cooper, Reggie Smith and Tommy Harper. Good company to be

Why Don't They Just Roll With the Punches? A Lost Art

Last week while researching my column about the Buchanan Duran fight, I took the time to watch a tape of the entire bout. It was pretty much a one sided affair with the fierce punching Duran landing heavily on the champion. I was watching and thinking, why didn't Ken go down from the punishment he received? Considering the amount of blows he took it is surprising he wasn't more busted up. His face was puffy at the end, but Buchanan had just gone thirteen rounds with one of the hardest punching fighters of all time and didn't look too bad considering the type of fight he had been in. It dawned on me as I again watched some of the rounds why he was able to absorb this terrible punishment; he was rolling with the punches.

In a November 2012 interview with Esquire Magazine, former Middleweight Champion Jake LaMotta talked about how he would move (roll) with the punches and that is why he still had his faculties at the age of 90. Jake described it this way: "Lots of guys can take punches. The idea is not to take unnecessary punishment. I explain taking a punch this way: In baseball, when someone throws a hardball at you and you don't have a glove, if you want to catch it, your palm moves back with the ball at the last second. That slight movement saves you from taking a hard blow. If you move the same way when a fist comes punches in order to please at you, it takes away more the crowd. While boxers tothan 50 percent of the day are having fewer bouts

power. The secret is to move with the punch."

That's what Buchanan was doing and it saved him from taking a much worse beating than he did. His head movement was taking away a lot of Duran's power. That is also why Duran was getting so frustrated.

Recently, I was talking with good friend and worldrenowned boxing writer Mike Silver, author of "The Arc of Boxing." Mike pointed out to me how badly beaten up boxers are today after their matches. He said it seems like after every fight you watch, the participants are coming out of the ring with their faces very swollen and battered. We both agreed it wasn't anywhere near as common to see so much damage years back. We talked about the lost art of slipping punches, which certainly is a contributing factor, but I really think a lot of it has to do with the fact that today's fighters haven't a clue about how to roll with the punches. You don't even hear the term mentioned anymore.

For years, boxing was known as "The Manly Art of Self-Defense," now it is more commonly called the "Pain Game." I'm not trying to imply that somehow boxing was once a sport where no one got hurt and boxers just politely tapped each other on the head. But what was very different is fighters were taught how to protect themselves. Today it is all about offense, about trading

in their careers than their forbearers, they are taking much more abuse. You don't see the fine defensive skills of a George Benton or Joey Maxim on display today. I suppose the fans, who are not as well versed in the sport as they used to be, would be bored watching one of the great boxing masters at work. Many define boxing by what they have seen in the "Rocky" movies and aren't familiar with the great masters. Would they be able to appreciate the fine defensive skills of a Billy Conn or Jersey Joe Walcott? The sport is quite different today.

In light of a number of recent ring deaths and serious injuries, there has been much talk of how to make boxing safer. Shorter fights, bigger gloves, standing eight counts and many other changes have been made to the sport, but the problem only seems to be getting worse. Yes, there should be better medical supervision during all boxing matches. Fighters should have tests to see if they are beginning to show damage from being hit too much, and, if so, banned from fighting. There are many steps that can be taken, but the most important one is teaching boxers how to defend themselves. Tony Shucco, the great heavyweight contender in the 1930s, once told me boxing is all about hitting your opponent without getting hit back. That was great advice. Today's fighters instead seem to be learning to show how much punishment they can withstand and are paying the price for it. It is time to bring back "The Manly Art of Self-Defense."

In addition to the Buchnan v Duran bout, here are some suggestions for boxers and bouts to watch on Youtube. In the Joe Louis v Jack Sharkey fight you will see Jack putting on an excellent display of rolling with the punches. Any bouts involving George Benton, Joey Maxim, Billy Conn, Willie Pastrano are all terrific ways to see defensives masters at work. Learn to appreciate the fine skills these great fighters are displaying, and I guarantee you will find boxing much more interesting than just watching the rock'em sock'em robots of


