Congratulations New England Patriots Super Bowl LIII Champions





Stirpe Nostra

A weekly column highlighting some of the more interesting aspects of our ancestry . . . our lineage . . . our roots.



AURUM

Gold, because of its workability and the manner that it is found lying in lumps in the ground, was one of the earliest metals used by man and it was one of the most primitive sources of civilization. It has been claimed that the ancients actually made the earliest age of the world's history an age of gold. Homer speaks of Menelaus, King of Sparta and husband of Helen of Troy, whose house was full of gold. Also, the decoration on the shield of Achilles contained much gold.

The forerunners of the Greek civilization known as the Mycenaeans date back to at least 1600 B.C. Great quantities of gold cups, jugs, death masks, ornaments of hammered gold and sword blade decorations have been excavated from their ancient gravesites. The graves of the Crimea have yielded corpses covered from head to foot with

Aurum is the Latin word for gold. The early Romans obtained their main supply from Spain. The rivers of that country contained rich deposits of the precious metal, which yielded nuggets after the simplest system of washing. Gold is the most malleable of all metals. It can easily be hammered to a thinness of two hundred thousandths of an inch. A single ounce of gold can be formed into a wire sixty miles long or beaten into more than seven hundred fifty sheets of gold leaf four inches square. It can be spun into thread and woven into fabric like wool. Gold is not affected by air, heat, moisture, or ordinary solvents and shows remarkable little wear with use. It loses no substance by the action of fire; even in conflagrations and on funeral pyres it receives no damage. Its quality is actually improved the more often it is fired.

to the smiths of early times, gold must have been the metal most suited for artistic expression. Its extreme softness and malleability enabled even workmen who had no more elaborate tools than a hammer and nails to work it into any given shape. All the vessels of Mycenae are hammered out and joined into shape by nails and the earliest statues of the gods were produced by the same method. In the preparation of gold, the ancients used only the simplest processes of melting and refining. When gold occurred mixed with silver they frequently did not separate the silver, but treated it as a combined metal.

Asia was also a source of gold from the days when Alexander and his captains seized the enormous hoards laid up during many generations by the Babylonian kings and their Persian successors. In the city of Persepolis alone, Alexander captured a treasure in gold and silver of 120,000 talents. The weight of a talent varied but was somewhere around sixty pounds making the captured treasure worth about fifty seven billion dollars at today's market price. Not bad for a day of labor including overtime. Croesus, the fabulously rich Lydian king, presented a gift to Delphi of more than one hundred solid bricks of gold. The richest source of all, in the opinion of the ancients, was There can be no question that in the country of the Arimaspi

(a legendary race of one-eyed men from the Black Sea area called Scythia), where the gold was guarded by griffins (eagle headed winged lions). An interesting story is told or invented regarding the gold of ancient India — namely, that it was found in a country infested by huge ants from whose pursuit men could only escape when riding on swift camels. This story was effective for many years in keeping away those tourists and souvenir hunters.

The worst crime against man is said to have been committed when a person first put gold on his fingers. The early Roman name for a ring was "symbolum" meaning mark or token. It was the custom to bestow gold rings officially on men who were about to go as envoys to foreign nations in order that they might be recognized as highly honored foreigners. The gift of a ring being a mark of high honor is said to be the reason that it was sent to a woman when betrothed. This was called "anulus pronubus" (the gift of a ring to the patroness of marriage) and was sent by the bridegroom.

The first gold coin in Rome was struck about 217 B.C. and was stamped with the head of an ox or sheep "pecus" which is probably the origin of the term pieces of gold or silver. Many people have done many things to or with the precious metal. King Phillip slept with a gold goblet under his pillow. A Prefect of Alexander the Great had his sandals soled with gold nails. We are told that gold was never so cheapened, defiled or debased as it was by the Roman Triumvir whose name was Antony. He used vessels of gold for his "daily dooties." "Che cafone!"



Saint Vincent Pallotti

Vincent Pallotti was born in Rome on April 21, 1795, to Pietro Rossi



and the De Rossi of Rome. At the age of sixteen, he resolved to become a priest,

Pallotti was ordained a priest for the Diocese of Rome on May 16, 1818. Shortly thereafter, he earned a doctorate degree in theology. He believed the clergy, religious and laity had a responsibility to proclaim the Good News. As a priest, he was a reformer. Pallotti worked selflessly, looking after the poor in the urban areas of Rome for most of his life. He organized schools for shoemakers, tailors, coachmen, carpenters, and gardeners so that they could better work at their trade, as well as evening classes for young farmers and unskilled workers. He soon became known as a "second St. Philip Neri

He served as Spiritual Director of several Roman colleges, served as Pastor of Holy Spirit, the Neapolitan

National Church, and promoted the apostolate of the press. He was given an assistant professorship at the Sapienza University but resigned it soon after to devote himself to pastoral work." Pallotti founded the Pious Society of Missions (Pallottines) for urban mission work. Started the special observance of the Octave of Epiphany for the reunion of the Eastern and Roman Churches, and the return of the Church in England.

Pallotti passed away on January 22, 1850, at the age of 55. He was Canonized on January 20, 1963, by Pope John XXIII. His Feast Day is celebrated on January 22nd.

Boston Ballet Presents George Balanchine's Coppélia

Boston Ballet presents George Balanchine's Coppélia, a fulllength comedic story ballet about love, mistaken identity, and foolhardy fun. Coppélia, set to music by Léo Delibes, runs March 21-31, 2019, at the Boston Opera House.

"Coppélia, considered one of the greatest comedic ballets, comes alive through Balanchine's classic choreography and Delibes' symphonic score. It is a wonderful and rare opportunity for audiences of all ages to experience the charm and beauty of Balanchine's delightful ballet," said Boston Ballet Artistic Director Mikko

Coppélia was originally choreographed by Arthur St. Léon in 1870. The work was later restaged by Marius Petipa in 1884 and revised by Enrico Cecchetti in 1894. In 1974. George Balanchine and Alexandra Danilova re-staged the production, retaining the storyline of Acts I and II with new choreography and creating an entirely new Act III where the village festivities are presented as a series of divertissements, culminating in an all-encompassing grand finale. Ballet premiered Balanchine's Coppélia in 2010 and last performed it in 2013. Boston Ballet's upcoming production will also feature students from Boston Ballet School.

The story, based upon the book by Charles Nuitter, after Der Sandmann by E.T.A. Hoffman, is a lighthearted comedy set in a country village about a life-size dancing doll created by Doctor Coppélius. The life-like doll becomes the source of love troubles for a village couple, Swanilda and Frantz, when Frantz mistakes the doll for a real girl and becomes infatuated with it.

Mayhem and hilarity ensue.

The music of Coppélia by Léo Delibes showcases his gift of composing for dance as well as inspiring movement within his music. It is considered by some as the first symphonic ballet score and connects two great historical periods of ballet—the French Romantic style and the Russian Classical style. Boston Ballet's Music Director Mischa Santora will conduct the Boston Ballet Orchestra, the second largest musical organization in New England.

roses. Though I always enjoyed the chocolate, this unchecked commercialism frequently annoyed me back in my single days, as it seemed that the idea of romantic love was constantly being shoved down my unattached throat! However, I now realize that the real spirit of St. Valentine's Day includes not only celebrating romantic love, but indeed love in all of manifestations, including the bond between friends and the affection for family members. I also became fascinated by the joint pagan and Christian roots of St. Valentine's Day, which stretch all the way back to our ancestors in Italy. This holiday bears the name of the mysterious St. Valentine, or San Valentino in Italian, about whom many romantic legends arose. One tale claims that St. Valentine secretly performed forbidden marriages for Roman soldiers, while another proclaims that he fell in love with the blind daughter of his jailer and restored her vision, then addressed himself as her "Valentine" in a letter written prior to his execution. Meanwhile, some scholars believe that the feast of St. Valentine's Day was inspired by the ancient Roman celebration of Lupercalia, a festival dedicated to purification and fertility. Though there is no evidence of a direct correlation between St. Valentine's Day and Lupercalia, both holidays symbolically indicate that the spring is a ripe time for love and regeneration.

Indeed, love across all of animals and fresh bouquets of nature is inescapable on St.

author Geoffrey Chaucer, stated that birds chose their mates on St. Valentine's Day, a quaint piece of folklore that recalls not only the romantic overtones of the holiday but also its connections to fertility and the rebirth of nature. Other avian-related superstitions stated that the first bird a girl saw on St. Valentine's Day presaged the career of her future spouse — a robin meant a sailor, a goldfinch meant a millionaire, a bat meant a baseball player, etc. In Italy, people celebrate St. Valentine's Day, or la Festa di San Valentino, in much the same way as their American counterparts, replete with romantic dinners, cards and gifts of flowers. The truly love-struck Italians may journey to beautiful city of Verona, where they will gather under the small, stone Juliet's balcony and ponder the fate of the star-crossed lovers from William Shakespeare's famous play. Contemporary lovebirds scribble their initials on the walls of a tunnel adjacent to the balcony, creating a living testimony to passions past and present. Meanwhile, the heartsick write their own letters to Juliet, or Giulietta as she is known in Italy, asking for romantic advice. These superstitions and folk customs epitomize the intense and capricious power love has over our lives. As such, it is exciting and comforting to have a holiday, balanced on the equally unpredictable precipice between winter and spring, devoted to love in all of its shapes.

I plan to celebrate this St. Valentine's Day by eating chocolate in some manner, most likely in the form of the red velvet cupcakes I make each year for my husband. However, I also will express my thanks for all of those whom I love in my life my family, my friends, even my cat! After all, nothing can melt the metaphorical winter snows faster than the warmth that radiated from the laughter and company of loved ones. In fact, we should honor the abundant love that we can give to others not only on St. Valentine's Day, but during every day of the year. As spring slowly inches her way into our lives, let us notice and love — the signs of rebirth plentiful in the nature around us: a crocus bud shyly peeking out from the snow and dirt, the first robin proudly chirping from an icy tree, the pale sunlight of a late evening. For just as we recognize the importance of love on St. Valentine's Day, so should we recognize this love reflected in the natural world around us, bright as the resplendent spring sunshine.

it caused such a stir. Long ago, at the opening of the Boston Symphony Orchestra, Isabella Stewart Gardner notoriously wore a headband that read "Oh you Red Sox." The fuddyduddies had a fit, such a bunch of hoity-toity wet blankets! If the headband still exists today, I bet it is a valuable piece of someone's sports memorabilia. Let's hope the owner is doing a better job protecting this artifact than the Gardner Museum did protecting its creator's art collection.

If you were a stick in the mud, Mrs. Gardner was easy to dislike. Descending from early Scottish royalty, she was born to a wealthy New York family. After years of studying art, music and dance she married a wealthy Bostonian, John Lowell Gardner, the offspring of old money, and a true Boston blue blood. The clannish upper crust did not instantly warm to the woman they called "Mrs. Jack." Some of her antics, like walking her pet lion down the street on a leash, caused her to be branded cuckoo for cocoa puffs. She took it all in stride and gave her adopted city a wonderful gift. She created the museum from her Italian Palazzo home and huge collection of priceless art. It's open to everyone including pimply faced teenagers doing projects for Mrs. Parz's art class. The Wicked Smart Investor was one of the students, acne and all.

By sending us to the museum, Mrs. Parz was simply doing what great teachers do. She opened up our world. Our assignment was to write a fivepage paper about our visit. At a security guard's suggestion, I wrote a paper on the painting The Storm on the Sea of Galilee. It's the only seascape of Dutch artist Rembrandt. The painting depicts Christ and his apostles crossing the sea in a sailboat during a violent storm. You can see the panic on some faces, determination on others, and one face getting ready to vomit. The brush strokes in the painting were incredible. Business

It was a simple headband but caused such a stir. Long ago, t the opening of the Boston ymphony Orchestra, Isabella I almost felt sea spray on my face from the life like seascape. Sadly, this was the last time I would see this painting.

In the early morning of March 18, 1990, thieves dressed as policemen infiltrated the museum, tied up the guards and stole 13 works of art including Rembrandt's seascape. A lax security system and improper training of the security guards contributed to this travesty. While it is hard to believe, the museum only had a couple of locked doors and one silent alarm securing the collection. Since the artwork was priceless, it was uninsurable.

Let's be clear; the thieves did not just steal the paintings from the museum, they stole them from humankind.

I hope such a travesty does not happen to your sport memorabilia collection. It is up to you to take preventative measures. You should certainly buy insurance coverage, but it is prudent to physically safeguard the items as well. Helmets, baseballs, hockey pucks, baseball bats, etc., should be displayed in a case with UV protection. Jerseys should be framed. If you have paper items, protective sleeves are a good idea. Overall, keep your collection away from sun, water, food, and small children. While you're at it, keep an eye on the pimply-faced teenagers, too. With proper protection, your memorabilia can be enjoyed for vears to come.

Mrs. Jack's missing artwork is represented by empty frames on the museum walls. I say those empty frames represent an open wound on the soul of the great City of Boston. If you have any information on the missing art, please contact the FBI immediately.

Renovating the North Washington Street Bridge

When Bostonians were told that it would take about three years to complete the reconstruction of Longfellow Bridge, connecting the Charles Street/MGH area of Boston to Cambridge, we grumbled, but we understood. With the contract awarded in 2013, the project was scheduled to be complete in the summer of 2016, after which life would return to normal and we could again get to Kendall Square and beyond without incident. We figured that three years of ongoing construction was the price we'd pay for a job well done.

We all know what really happened. Three years became four, and eventually five. Construction made both ends of the bridge chaotic and noisy. Constant delays were the norm. Other arteries were negatively affected as commuters and others — like anyone who uses now ubiquitous traffic apps like Waze — found alternate routes to avoid the Longfellow. Traffic along Storrow Drive worsened as West End residents were forced to use it to find another way to cross the Charles. A community that had prepared for a three-year, \$255 million project instead found the timeline nearly doubled and the budget ballooning to \$306.6 million- more even than the \$303 million the state had set aside for a worst-case scenario.

This is why I am so concerned about the city's plan to renovate the North Washington Street Bridge. Yes, anyone who crosses it knows the bridge is in need of repair or replacement. But we're being told that this project will take five years so should we assume that this will take seven or eight years to finish? What, exactly, are the state and the city prepared to do to address the tremendous impacts on residents' quality of life and businesses' losses related to access that come with bridge reconstruction like this? It is vital that residents

tell City Hall, MassDOT and the Governor that we cannot afford a repeat of the Longfellow Bridge boondoggle here in Charlestown and the North End.

The North Washington Street Bridge is not just the primary connection between the North End and Charlestown — it's the only connection. More people, more small businesses, and more homes sit on either end of this single connection, and all of us stand to lose more from at least five years of noise and construction. The disruption to peoples' lives, businesses, and quality of life will be as bad as the worst these neighborhoods experienced during the Big Dig. This means we need to see a renewed effort from the state, the city and the contractor to keep the scope of construction focused, speedy, and minimally disruptive.

What would such an effort look like? Here are some important things that should be done to prevent a repeat of Longfellow Bridge:

Project managers were surprised that the condition of the Longfellow Bridge was worse than they expected, but they didn't learn of the deterioration until after construction had commenced.

How do we know that this complex replacement project won't encounter similar difficulty? Building a temporary span, removing and then replacing bridge abutments in contaminated underwater soils where underground conditions really can't be known until the digging begins presents any number of challenging variables. Can local residents and businesses rely on current planning and design? Based on the Longfellow, our confidence is low.

MassDOT, the Walsh Administration and J.F. White must make it clear who has responsibility for the North Washington Street Bridge reconstruction. Who are the foremen on duty? Who can residents and local businesses talk to about construction impacts, noise complaints, or construction taking place beyond allowable hours? And will our concerns be met with action, or indifference and apathy?


MassDOT and the City need to better explain to us how they are anticipating possible challenges, what the workarounds will be, and why we can take confidence in their promises.

The concern of folks getting to work on time in this area is crucial for local commerce. MassDOT should strongly consider the contractor push their proposed work start time back to 9am. This will ensure traffic flow can smoothly function in the morning hours to allow commuters from all directions to be able to arrive to work on time. It is consensus in the Navy Yard business community that this will behoove all who traverse through the corridor in the morning hours.

Bridge replacement in an old and congested urban environment is difficult. We know that not everything will proceed exactly as planned. That said, residents on either end of the bridge should be able to expect some basic things from their government and the entities hired with their tax dollars: responsiveness, transparency, timeliness and professionalism. The North End and Charlestown lived through the Big Dig and the Longfellow replacement. Both took their toll, and both provided benefit once complete. We need to have a strong and unified voice if we expect the state, the city and the contractor to treat us with respect.

TIMOTHY WENZEL – RUNNING AWAY (CD) Coyote Floe Music

For keyboardist, composer, arranger, producer, Timothy Wenzel, this is his seventh album - and a dozen tracks of beautiful music. Incorporating soft and Celtic music to more energetic themes. Music that opens the mind and spirit to different feelings and visions with each of the songs. Wenzel features his piano and synthesizer playing, surrounding himself with Josie Quick on violin, Jill Haley on English horn and oboe and Jeff Haynes on percussion. The opening slice "Dream of Summer" creates an image of a warm wind blowing, trailed by the flowing "Dancing in the Darkness," the explanatory "A Bit About You," the fantasy title track "Running Away," the curiosity of "Makes You Wonder," and hits the halfway mark with magical "Traveling Light." SOLO: A STAR WARS: ORIGINAL MOTION PICTURE SOUNDTRACK (CD) Walt Disney Records + Lucasfilm

Solo: A Star Wars Story — is the 20-track collection of music that comprised the Original Motion Picture Soundtrack,

and the adventures of Han Solo. For the opening track, composer John Powell puts the baton in the hands of John Williams who delivers the goods with "The Adventures of Han." Powell takes back the composer role and delivers 19 more tracks of excitement, with intriguing music, along with a choir and a healthy blend of percussion sounds. The excitement begins with "Meet Han," and it's no-holds-barred from there on, following with the raucous 'Corellia Chase," the soaring "Flying With Chewie," the smooth flow of "Train Heist," the track "Chicken in the Pot" is a vocal rendition jazzflavored gem, the lengthy highenergy pair of "Break Out" and "Reminiscence Therapy," the strings and powerful drum beat of "Good Thing You Were Listening," and letting the chips fall where they may with the last track "Dice & Roll."

EHUD ASHERIE TRIO – WILD MAN BLUES (CD) Capri Records

Jazz pianist Ehud Asherie's trio consists of bassist Peter Washington and drummer Rodney Green. This strong lineup allows Asherie to explore early New Orleans jazz, swing, bebop, and the Great American Songbook. Asherie wastes little time jumping right in with his excellent version of Louis Armstrong's "Wild Man Blues," which is the title track, diverting the mood with the 360-degree turn to "Parker's Mood" which legendary bebop saxophonist Charlie Parker recorded in 1948. Asherie's love for the music of the people of Brazil leads him into the fastpaced "Flying Down to Rio," followed by the ballad "Autumn Nocturne," then reaching back to serve up another Parker gem, the 1947 gem titled "Chasin' the Bird." Asherie continues his affection for Brazilian culture, with a heartfelt interpretation of composer Ary Barroso's tasty "Na Baixa Do Sapateiro," winding down his album with a great version of George and Ira Gershwin's standard "Oh, Lady Be Good," and puts the finishing touches on his masterpiece with Dizzy Gillespie's Latin-flavored treat, "And Then She Stopped."

GREG MURPHY TRIO – BRIGHT IDEA (CD) Whaling City Sound

Greg Murphy is described as 'an inventive and versatile twohanded jazz pianist with an epic sense of the pure and beautiful. His album, Bright Idea, is a baker's dozen of songs, mainly originals, with few exceptions. Trio mates, Jeff "Tain" Watts on drums and Eric Wheeler on bass, get right to work with, "Softly, as in a Morning Sunrise," followed by a sizzling rendition of Pharrell Williams' "Happy," lighting the light with the title cut "Bright Idea," tickling the ivories with Joe Ford's pretty "Earthlings," and the shining "24K Magic." One of the many highlights has Murphy discovering John Coltrane's composition "Untitled Original 11383," tagging our ears with the rhythmic, lengthy "Moving Violation," and the creative Juneteenth Notes."

A Nostalgic Remembrance



It was January of 1961, and I was anticipating the week off in the middle of February that is now called Presidents Week. Back then, we called it Washington's Birthday week and, seeing I was teaching in the Boston School Department, I had the week off. Mom and Dad were heading to Maine, but I wanted to vacation where it was warm and declined the offer to join them.

I called Uncle Nick and Aunt Dorothy and they filled me in on several hotels on Miami Beach. With Havana becoming more and more off limits, Miami, San Juan, and Puerto Rico were the places to head for a winter's vacation. Uncle Nick put me in touch with a friend at Colpitts Travel Service, then located in downtown Boston, and I headed there to book in a travel package to Miami Beach. They could take care of the airfare and car rental, but there wasn't a hotel room to be had during the week of February 22nd.

I booked the flight and car rental through them, and when I got home, called a pianist I had worked with who left Boston and now lived in Coral Gables, a suburb of Miami. He offered me the second bedroom at his home for the week, and I accepted.

My Eastern Airlines flight was uneventful and not long after we landed, I picked up a Chevy convertible from Hertz, and headed to my friend's location, following the directions he had given me. When I arrived, several musician friends who worked in Miami during the tourist season were there to greet me and I felt very happy and comfortable.

The next day, my host told me that he had a problem. His sister was coming down unexpectedly, and he was going to have to put her up for the week. I packed up and headed for Miami Beach, and tried to book the rest of the week at several hotels, but each was without any vacancies.

Driving north on Collins sign out front, "One room left, with references, only." I parked and entered. En route to the front desk, I asked a bellhop the name of the manager. He told me and as I approached the front desk, I asked the clerk if I could speak to Mr. Levine. Seeing I was dressed with a suit and tie, the clerk immediately called the manager's office. An older man appeared within a couple of minutes and I introduced myself telling him Jack Kramer, a mutual friend had suggested I stop by if I needed a place to stay.

Mr. Levine asked how Jack was and I told him he still lived in Boston and was very busy. He then ordered the desk clerk to give me the one room available, and headed back to his office. I was satisfied with the accommodations and unpacked, hoping to try the

beach across the street. Winter had broken and it was sunny and in the 80s. I soon began working on a Florida tan. (My game worked. I had never heard of Jack Kramer, but Mr. Levine wasn't taking any chances and gave me the room).

From that point on, I began to explore Miami Beach. I tried Wolfie's Delicatessen, famed for their Kosher-style sandwiches, and later checked out the famous hotels, including the Fontainebleau, which would become my favorite hangout for entertainment. That night, I had a steak at the Embers, which was the number one steakhouse on Miami Beach back then. Wouldn't you know it, I ran into a few friends I knew from taking graduate courses at Boston State. Like me, they were all young teachers just starting out. All taught in Revere. We made plans to get together later in the week, and after dinner, I headed to a nightclub recommended by one of them, Murray Franklin's.

The first act was an attractive female ventriloquist who had a dummy that spoke with a thick Jewish accent. She was very funny and when she thanked the audience for their applause, I could hear an Italian accent. I asked the waiter for a pen and a piece of paper and wrote, Signorina, vorresti unirti a mio tavolo?" (Miss, would you like to join me at my table?) I then gave the waiter the note and asked him to give it to the ventriloquist.

Just as the next act started, she showed up, sat down and whispered, "How did you know I was Italian?" I answered that I was Italian from Boston and heard her New York Italian accent as she thanked the audience.

Just then, the next act began. It was famed Boston comedian, Freddy Ross. He was booked in for the week, spotted me and introduced me to the audience, "Ladies and gentlemen, a musician friend from Boston, Avenue, the main street in Johnny Christy Junior." I took Miami Beach, I looked to my a bow and must have impressed left and saw a building with a the Italian ventriloquist because she kept smiling at me non-stop.

My next stop was the Boom Boom Room on the lower level of the Fontainebleau Hotel. It was a place to dance if you liked Latin American music, and I did. At home, I plied my Latin steps at the Cave nightclub on Boylston Street quite often and they worked out just as well in Miami Beach. I had asked the ventriloquist to join me, but she had another show to do and told me to pick her up later for coffee (which I did).

Between making arrangements with my teacher friends from Revere and spending time with Maria, who left her dummy at home, it was a filled week. For sunning myself, I joined the Revere crowd on South Beach, then a haven for old-time Jewish vacationers mostly from New York. Today, South Beach is an in-place for the younger crowd and the young at heart.

One of those old-timers saved my butt one afternoon. I was in the water up to my waist and facing the shore. The old man was standing near me in the water began yelling at me in Yiddish and pointing. I didn't know what he was saying, but I turned around and saw a giant sized Portuguese man of war with a blue head and tentacles that were about ten-feet long and just a couple of feet away. I got out of the water in a hurry, yelling thank you to the old man as I headed back to shore.

I flew back home on the following Sunday with a tan and empty pockets. Once back in the house, I had to tell Babbononno all about Miami Beach, as he had never been there.

That was one of the first times I was away from home on my own and handled myself without a problem. I called my musician friend before I left and he offered me a job playing with him at a New Hampshire resort that following summer. I accepted.

BREADED EGGPLANT

Baked or Fried

1 medium size eggplant 2 cups prepared breadcrumbs 2 beaten eggs

3/4 cup olive, vegetable or

Remove dark eggplant skin with paring knife or potato peeler. Slice eggplant into one-quarter inch thick rounds. Layer slices on a flat dish and salt lightly. Beads of liquid will appear on the slices as they rest one on top of the other. Cover eggplant with wax paper or plastic and place in the refrigerator for at least a half-hour.

FOR FRYING: With paper towels, wipe beads of liquid from each eggplant slice before dipping into beaten eggs. Then coat with prepared breadcrumbs and set aside in a platter.

Heat one-quarter cup of oil in a skillet. Place breaded slices in heated oil and fry until brown on both sides. Place fried eggplant slices on paper towels to absorb oil. Then set aside on a clean platter. Because eggplant slices absorb oil while frying, additional oil may be needed in the skillet as you fry.

FOR BAKING: Place breaded eggplant slices on a lightly sprayed baking tray. Drip small amount of oil on top of each eggplant slice in the tray. Bake in a preheated 350°F oven for fifteen minutes. Turn over all slices that have browned. Return to oven and bake another ten to fifteen minutes. Check often in order not to burn. Remove from oven when browned and tender to your liking. Continue baking remaining breaded eggplant slices in this

Serve hot or cooled. Remaining cooked eggplant slices can be refrigerated. Reheat in microwave oven for a later serving.

NOTE: Some North End neighbors planted eggplant seeds in large containers on their fire escapes or on the roof. Some grew them in their rented garden lots in Revere or Woburn. Others waited to purchase eggplants in produce stores on Salem, Cross and Blackstone Streets. Today they are available throughout the year.

When baked, they are a tasty and nutritious snack that can also be served as a hors d'oeuvre.



Happy Birthday Jackie Robinson On the Centennial of His Birth and for all He Did




Jackie Robinson

As a baby boomer growing up in the fifties and sixties, I understood the role Jackie Robinson played in both Major League Baseball, and in the changing face of America. I was just a bit too young to actually remember him play baseball, but I always knew who Number 42 on the Dodgers was and why he is remembered to this day. He would have turned 100 this past January 31st, but he barely made it to 50 let alone 100. He passed away at home on October 24, 1972.

Recently, Mike Vaccaro, a NY Post sportswriter and one of the best in the country, did a great piece on him back on his 100th birthday. It was so good I clipped it out and saved it. regardless of race, but back in his day on the diamond, he was also sadly hated by so many. As one of his old teammates Ralph Branca stated, "Jackie was one of the most beloved Americans who ever lived, but he was also one of the most hated."

Another one of his teammates, Pee Wee Reese, always stood up against the hatred expressed toward Robinson once said, "To do what he did has got to be the most tremendous thing I've ever seen in sports."

Robinson lived a hard life growing up, he lived in abject poverty. He was the grandson of slaves and the son of sharecroppers who worked 60-hours a week working on a plantation in Cairo, Georgia. He lived virtually unknown until Branch Rickey, who owned the Brooklyn Dodgers, decided to bring him to New York from his Triple A team, the Montreal Royals, and broke the Color Line in the segregated major leagues. Robinson made history and was never unknown again.

When I think of Jackie Robinson, I think of Pumpsie Green, who Tom Yawkey brought up to the Red Sox, becoming the team's first Black player. It happened in 1959, something I am quite old enough to remember. The Sox up till then was the only all white major league team. Later in the season, they brought up Earl Wilson, who turned out to be a great pitcher and hitter, too.

When I think of Robinson, I also remember the likes of Willie Mays, Hank Aaron, Orlando Cepeda, Satchel Paige, Minnie


The Red Sox obviously are still trying to firm up its bullpen. Hopefully, he works out.



BRADDOCK vs. BAER

Was it on the Level?

On June 6, 1934, Max Baer won the Heavyweight Championship of the World by defeating Primo Carnera in the 11th round. He had floored the courageous champion 11 times on his way to winning the crown. Baer, who had preciously scored a brutal kayo over Max Schmeling, looked like a man who would be champion for quite some time. He was a brutal puncher in the ring while possessing the charm of a Hollywood leading man outside of it. In fact, he had made himself a bit of a reputation acting in movies. He was a man sitting on top of the world.

Just a few days over a year later that would all change when Baer put the title on the line against the lightly regarded James J. Braddock. Braddock had been a leading light heavyweight contender a few years earlier, but injuries and a number of losses had derailed his career. He had managed to string together a number of wins over heavyweights and position himself for a shot at Baer. Nobody gave him a |chance, and many thought he was risking his life to step in the ring with the murderous punching Baer.

In fact, earlier in his career Baer had killed Frankie Campbell in the ring, and many also believed he was the one responsible for the death of Ernie Schaaf who collapsed and died in his fight with Primo Carnera after being hit with a left jab. In an earlier fight with Baer Schaaf had taken some terrible shots and was knocked unconscious as the final round ended. He was saved by the bell and lost a decision to Baer. It is believed the blows from Baer had caused an injury to Schaaf from which he never recovered, resulting in his death in the Carnera fight.

It seemed unbelievable Braddock would have any chance against Baer. While he was certainly a very capable boxer, he just would not have the strength to hold off the dynamite that was in Max's two fists. He went into the fight a ten to one underdog. However, he did go on to win the title that night, and along with that win he became known as the Cinderella Man.

Most people are now familiar with the Braddock story from the 2005 movie Cinderella Man directed by Ron Howard. In the movie Braddock's fight with Baer is depicted as a life and death struggle with Braddock hanging on to win a close and exciting fight. Actual footage of the fight tells a different story.

When I was a kid my father and I watched an 8mm film of the Braddock/Baer match on a home movie projector. It was the only time I had seen the fight until I viewed it again the other day. I do remember when watching it with my father how surprised he was at what he saw. He was a teenager when the bout took place but had never seen it. He was a great admirer of Braddock, particularly because after winning the title Braddock had repaid the money he had collected while on relief (welfare) when things were bad for him and his family. I admired that about him as well.

What surprised my father while watching the film was how the two men were fighting? He had always believed Braddock had won in the manner depicted in the Ron Howard movie. After viewing the film for a short while my father exclaimed "Max threw the fight!" He was disappointed to see that, as it took the glow off of Braddock's win. My father also liked Baer very much so that added to his disappointment. He justified it all by saying Baer probably did it because he liked and felt sorry for Braddock and his family.

I decided to take another look at the fight to see what I would think after all of these years. After viewing highlights from each of the 15 rounds, I have no doubt at all that Baer threw the fight. I even think it is possible Braddock was in on it as well. For most of the fight it looks like two guys trying not to hurt each other. It is nothing like the all out battle seen in the Howard

The fight, which took place on June 13, 1935, at the Madison Square Garden Bowl on Long Island, was one of the most boring in history. With the exception of one round, the 7th, Baer didn't through any serious punches, and in that round he only opened up because the crowd was booing and he felt he had to look like he wasn't dogging it. When he did land a decent right hand he hurt Braddock but immediately backed off.

At the opening bell you would think it was Braddock who had the tremendous power in his hands as Baer began the fight by backpedaling. As the fight progressed Baer did some clowning that brought laughter from the crowd and which was more exciting than fight itself. He also was talking to Braddock quite a bit, and if you watch closely it appears the two men are speaking to each other in the clinches. It would be interesting to know what they said to one another.

Going into the fifteenth round Braddock appeared ahead in the scoring. Baer had to know this, yet he did nothing to try and save the title. In fact, the two men spent most of the round at close quarters exchanging light punches. They seemed to be afraid of hurting one another. The fact that Braddock was also not throwing hard punches gives me reason to believe he was aware of the fix.

In the end James J. Braddock was award the decision. The scoring on one judge's card and the referee's was pretty one sided. The other judge had it scored evenly by rounds at 7-7 with 1 even. However, he gave the fight to Braddock based on points which is the rule in New York when a judge's card comes up even.

Neither fighter made a particularly good payday out of this fight as it didn't draw big money. Ironically, both would make the biggest purses of their careers in their next fight against the same opponent. They both took on Joe Louis.

I have not gotten into the reasons Max Baer would have thrown this fight, but after watching it closely I have no doubt that my father was correct when he said "Max threw the fight!"

HOOPS and HOCKEY in the HUB

TINY STILL STANDS TALL EVEN THOUGH TUUKKA TOPS **THEM ALL** — The day and evening hours of February 5 brought moments of primacy and pride throughout the New England region.

As the sun shone down on a warmish winter day, the Patriots paraded through the streets of the Hub in triumph, celebrating their sixth Super Bowl victory in the last 18 years.

Then as evening came, events moved indoors where the Patriots were honored once again just prior to the Bruins game against the New York Islanders at the Garden.

It was also veteran Patrice Bergeron's 1,000th game of his storied career — all played with the spoked B proudly displayed across his chest. His two goals, one coming during the closing moments via an empty net tally, brought a most satisfying close to a day filled with enthusiasm, energy and excitement.

In addition, goalie Tuukka Rask was a stalwart in net, only allowing one goal in the 3-1 victory. Earlier, the B's had shown a video of Rask winning his 253rd victory as a Bruin netminder, thus becoming the goalie with the most victories in the history of the franchise.

That win came on the road the previous Saturday against Washington. Overheard on the jumbotron was the comment that the netminder from Finland had surpassed Tiny Thompson to claim the paramount position among Bruins goaltenders throughout history.

Ah, but who was Tiny Thompson and how did he come to amass his remarkable record?

Cecil Ralph "Tiny" Thompson was born in a small town in British Columbia in 1903. While the Wright brothers were busy preparing for their first airplane flight at Kill Devil Hills in North Carolina later that year, the man who would weave his way into Bruins lore was beginning to taxi down the runway of life.

And no, he wasn't tiny. When he went out for sports as a teen he happened to be taller than any of the other kids. Tiny was a reverse nickname for the tallest among them. His adult height topped out at 5-10.

But while that was average his play in net was way above the norm. In three seasons in the minors with Minneapolis he appeared in 118 games, posting 33 shutouts with a stellar 1.37 goals against average.

It was, of course, an age of little video but that didn't matter to Boston GM and head coach Art Ross. Those numbers were all he needed to see. Come the 1928-29 season Tiny Thompson was stopping shots in Boston — just about all that came his way.

And he didn't waste any time putting his skills on display. In his first game for the B's he earned a shutout. It was a sterling accomplishment. Even today, some 90 years later, he is the only Hall of Fame goaltender to have accomplished this feat. He finished the season with a superb 1.15 goals against average and posted a perfect 5-0 record in the two-round Stanley Cup Playoffs.

The next year the B's went 38-5-1 with Thompson leading the way in net. Although they were stopped in the playoffs by Montreal, Thompson did win the first of his four Vezina Trophies.

To the modern eye, Thompson's appearances per season don't seem to stand out. They were in the mid to high 40s — somewhat less than a starting NHL netminder might have today.

But there is a big difference. For three of his first four years in the Hub, Thompson would have "perfect attendance" in the crease. That's right: for three of the first four years he played in every single game — all 44 of them each season.

And in the one year he didn't he still played in 43 of the thenlengthened 48-game regular season. In fact, those five missed games would be the only ones he would not play in during his time in the Hub. And also remember this: he played in all those games without wearing a mask. That is iron man duty.

Nearly every night in the NHL there is a reminder of Tiny Thompson, who died 38 years ago (February 9, 1981). You see, back in the 1932 Stanley Cup Playoffs, Thompson became the first goalie in the history of the league to be pulled in favor of a sixth skater by a team trailing late in a game. The so-called "open net" tactic, first thought of by Art Ross, quickly spread around the NHL.

And then there was this. During the 1935-1936 season Thompson became the first goalie in NHL history to be credited with an assist by passing the puck with his stick. He also popularized catching the puck — the glove save.

Yes, in this era of extended 82-game regular seasons and bestof-seven rounds in the Stanley Cup Playoffs, during a time of super intense coverage across a variety of media platforms, Tuukka Rask has won more games than any other goalie in Boston Bruins history. That is an accomplishment that should be extensively proclaimed.

But back before all of that, before television, before the internet, before six-month regular seasons and before large contracts, there was another man in the Boston crease for 10 plus seasons. Nearly forgotten now since he played his last game as a Bruin on November 16, 1938, he stands head and shoulders above others - not in games won but in stellar performances completed.

His won-lost percentage during the 1929-1930 season (.875) still stands as an NHL record. His 38 victories in that campaign stood as a Bruins team record until Pete Peters posted 40 during the 1982-1983 season. Even today, 89 years later, he still is second.

Over the course of his career, which included two years with Detroit at the end, he amassed 81 shutouts and had a career goals against average of 2.08, good enough for fifth all-time in the NHL. He still is the Bruins leader in shutouts (74) and goals against average (1.99). He had five seasons with a goals against average under 2.00 — while playing in each and every game across those campaigns without a mask or significant injury.

That's why, across the numerous decades since he last played in the Hub, we say Tiny Still Stands Tall Even Though Tuukka Tops Them All.
