

#### "Empire" Actor Jussie Smollett a Faker

Jussie Smollett from the TV's *Empire* reported last month that he was assaulted by two men in Chicago and they allegedly yelled anti-gay and racist slurs and had a chemical poured on him. He also claimed that the two yelled he was in MAGA country. Oh, it was also one of the coldest nights ever in Chicago minus 30 wind chill factor. Many had questioned him from the get-go whether or not this attack ever took place. His lawyers now say the actor feels "victimized" by reports he may have played a role in the assault.

Street so those who have prescriptions can now go to CVS. All prescriptions have been transferred over.



#### **BABILU**



The most famous and important city in Mesopotamia, as previously noted, was Babylon. Its name is derived from "Bab" meaning gate and "Ilu" meaning God, thus the name Babilu (gate of God). Later the city was called Babylon. Many accounts tell of this area being subjected to rainy seasons. These seasonal rains, in addition to the many irrigation canals and the 120 degree temperatures in June and July, caused the formation of many swampy sections. The terrible stench from these swamps and marshes was thought to contain disease and pestilence, which in turn caused the cities to be constructed on high platforms in order to stay above the miasma (noxious fumes). These city platforms were actually constructed of millions of sun dried clay bricks, as were all of their buildings, causing whole cities to take on a dull reddish color.

The Greek historian "Herodotus" tells of Babylon being a vast crowded city of sixty to seventy miles in circumference and about two hundred square miles in area. The city layout contained twenty-five broad, principal streets in two directions and intersecting each other at right angles, forming 625 squares or

large city blocks. Each of these principal streets began or terminated at huge gates in a great protecting city wall.

The wall around Babylon was built of sunbaked brick, cemented with bitumen instead of mortar. A deep brick-lined ditch also encompassed the city outside of the walls. Records indicate that the wall was two hundred cubits (320 feet) high, fifty cubits (80 feet) thick, with two hundred fifty towers and one hundred bronze gates.

A cubit, as you know, was a unit of measure during these ancient times and is the length of a forearm from the elbow to the tip of the index finger, a length of about twenty-one inches. The term "cubit" has often been used in conjunction with Bible descriptions. Noah, as one example, received his instructions to build the Ark in terms of cubits. So, dear friends, the next time you cut someone off while driving in traffic, try to notice if that finger he's waving has an elbow attached to it. If so, don't get excited because he probably likes you and is just making some sort of religious gesture.

### Saint Vincent Ferrer

Vincent was born on January 23, 1357 in Valencia, Spain. He was the fourth child of the nobleman Guillem Ferrer, a notary who came from Palamós, and his wife, Constança Miquel. He began his classical studies at the age of eight, his study of theology and philosophy at fourteen.

In 1374, at the age of nineteen, Vincent entered the Dominican Order, often called the Order of Preachers; he entered near Valencia. For a period of three years, he read solely Sacred Scripture committing much to memory. He published a treatise on Dialectic Suppositions after his solemn profession, and in 1379 was ordained a Catholic priest at Barcelona.

Soon after his profession, he was commissioned to deliver lectures on philosophy. On being sent to Barcelona, he continued his scholastic duties and at the same time devoted himself to preaching. At Lerida, the famous university city of Catalonia, he received his doctorate. After this he labored six years in Valencia. In 1390, he was obliged to accompany Cardinal Pedro de Luna to France, but he soon returned to Spain.

In 1394, de Luna declares himself Pope Benedict XIII, at Avignon as part of the Western Schism that divided the Church for the next thirty six years.

Now began those labors that made Vincent Ferrer the famous missionary of the fourteenth century. He evangelized nearly every province of Spain, and preached in France, Italy, Germany, Flanders, England, Scotland, and Ireland. Numerous conversions followed his preaching.

Vincent tried unsuccessfully,



in 1408 and 1415, to persuade his former friend, now Benedict XIII, to resign as Pope. He finally concluded that Benedict was not the true pope. Though very ill, he mounted the pulpit before an assembly over which Benedict himself was presiding, and thundered his denunciation of the man who had ordained him a priest. Benedict fled for his life, abandoned by those who had formerly supported him.

The Council of Constance summoned by the Church in the Bishopric of Constance, Germany, under the protection of the Holy Roman Emperor Sigismund, between 1414-1418 finally ended the Great Schism. and the two claimants to the Papacy abdicating with the election of Pope Martin V confirming the Roman Papacy.

Ferrer passed away on April 5, 1419. His feast day is April 5th. Saint Vincent Ferrer was Canonized on June 3, 1455 by Pope Calixtus III.

### L'Anno Bello: A Year in Italian Folklore

Carnival's Joyful Welcome to Spring

Lately, I appear to have acquired a massive bout of spring fever. That has to be the reason why I insist on wearing brightly patterned dresses every day, admiring the way they shine against newly fallen snow. What else but spring fever can explain the desire to open my classroom windows, letting the earthy scent of fresh soil waft through the air on the first sixty-plus degree day in a long while? Certainly, spring fever *must* be behind my recent quirky tendencies towards the absurd, such as my proclivity to randomly watch reruns of Friends at eleven o'clock at night or impulsively gather a small collection of macarons from Whole Foods in order to admire their pastel hues. Yes, the anticipation of spring drives me towards acts of whimsy, and I am sure that I am hardly the only one affected by this excitement, as I feel the world pulsating with change. The evening sun glows brighter, robins hop in the bushes, and the drip of melting snow sounds like the second hand on nature's clock, denoting each turn of the season. This is one of the most exhilarating times of the year, humming with transition and liminality. Not surprisingly, folk holidays latch on to this thrilling sensation, celebrating the joyous leap from winter to spring. The most magical and spontaneous of these festivals is Carnival, the feast of masks and indulgence that precedes somber Lent. With its myriad of rustic customs and traditional foods, Carnival practices in Italy and around the world herald the joyous arrival of spring with tomfoolery and magic galore.

Except for the celebrations in New Orleans, Carnival is not as well-known in the United

States as it in Europe, a fact with often baffles me. Carnival overlaps with the vibrant onset of spring, a period whose hope and promise practically encourage the revelry of street dancing and fanciful masquerades. The very name of Carnival conjures imagery of indulgence and decadence. Many scholars theorize that the word "Carnival" derives from the Latin term carne vale, or "goodbye to meat," a reference to the extravagant consumption of foods that would later be forbidden during austere Lent. The Christian significance of pre-Lent combined with old pagan rites devoted to chasing away winter and welcoming in spring in order to create the festivities we know as Carnival. The masks and costumes that characterize the holiday may originate in the disguises worn by the ancient Europeans in order to scare off the winter demons. Similarly, cultures throughout the world emphasize golden fried pastries as traditional Carnival food, from the jelly donuts popular in Germany and Poland to the pancakes eaten in Great Britain. These delectable treats not only served as a way to use up butter and eggs, which were prohibited during Lent in olden times, but they also resemble the spring sun with their sunny color and round shape. Classic Italian Carnival desserts include cenci, or strips of fried dough that also go by whimsical monikers such as chiacchiere (gossip) and bugie (lies). These treats remind me of windy, brisk late winter days when I would cook up a batch with my grandmother, then watch her sprinkle powdered sugar over the cenci. Delicious!

Along with food, Carnival famously boasts energetic par-

the Carnival season on the holiday of the Epiphany, which occurs on January 6th, and come to a frenzied culmination on Mardi Gras, or Fat Tuesday, the last day before the beginning of Lent on Ash Wednesday. This year, Mardi Gras falls on March 5th. Around that day, expect to see the traditional colors of Carnival everywhere: green for faith, purple for justice, gold for power. These hues brighten the ubiquitous beads and masks emblematic of Carnival, adding an aura of playfulness and mystery to the air. In Italy, Carnival festivities, though extremely diverse across the country, all take on a primeval, raucous tone. The most renowned of such celebrations is the Carnevale di Venezia, or Venetian Carnival. Participants in this feast wear elegant 18th-century costumes and sport masks like the ones that once adorned the actors of the Italian commedia dell'arte a type of improvised performance where character archetypes each boasted their own mask. The Carnevale di Venezia has become such a symbol of this mysterious city that visitors will now find the eerie, beautiful masks on display year-round. Other famous Italian Carnivals take place in Acireale, Sicily and Viareggio, Tuscany, where gigantic floats satirize local events and politicians. These floats hearken back to the topsy-turvy nature of Carnival, since in olden times dissent was only permitted in the form of satire and slapstick unleashed once a year. The northern Italian city of Ivrea recreates a historic battle every Carnival with oranges, emphasizing the absurdity of the season. Indeed, no matter how Italy celebrates Carnival, it is always imbued with glee and mischievous abandon. Whenever I think of Carnival,



Welcome Home wartime bonuses are awarded to servicemembers who lived in Massachusetts for at least six months immediately prior to entering the military and served on or after September 11, 2001. Qualified applicants can receive bonuses for their active service and deployments in support of the Global War on Terrorism. In 2018, \$1.2 million in bonuses were awarded to Massachusetts veterans.

"Veterans and military families face unique challenges when it comes to planning for their financial future," said Treasurer Deborah Goldberg. "Providing the Welcome Home bonus online platform will get money into the hands of veterans more quickly and efficiently, and ensure that every Massachusetts servicemember has the opportunity to achieve economic security."

By visiting VetsBonusMA. com servicemembers and veterans can apply and upload their required supporting documents from wherever they are. The online application will also increase the ability to analyze collected data to optimize outreach to veterans within local organizations and communities.

"The online submission process was developed with the veteran or servicemember in mind", said Steve Croteau, Manager of the Veterans' Bonus Program. "This capability makes it easier and faster for the veteran to submit their application which will improve our ability to get the bonus payment to the veteran quicker.'

"As the Chair of the Veterans and Federal Affairs Committee, I fully support any effort that eases the process for heroic veterans to receive the benefits that they so richly deserve", said Senator Walter F. Timilty, Chair of the Veterans and Federal Affairs Committee. What Are We Without the Memories?

#### THE HEATH

In *The Heath*, author Lauren Gunderson tells the story of her Paw Paw's (grandfather) withdrawal from life due to the ravages of Alzheimer's disease. It is also the story about the regrets she has in not having gotten to know him better. Using scenes from *King Lear* as well as playing the banjo and singing, we are presented with an original and fascinating look at life and aging.

Miranda Barnett plays Lauren and does so with complexity and depth. Lauren is filled with regret for not having had more conversations with her Paw Paw whose name is KD, and struggles to understand what has happened by reading *King Lear*. The set is split between a home and a heath. George Judge in the role of KD as well as Lear is touching, warm, and powerful. His voice shifts from a Southern accent to a naturalistic Shakespearean delivery seamlessly as the scenes move from the dialog between Lauren and KD to out on the heath as we watch Lear's descent into madness.

While we often think of Lear as having gone mad, in The Heath we see it as being much more than that. Ms Gunderson shows how the diseases of an aging mind are not madness but a loss of self. She tells us, "They are lost before they are gone". It is heart wrenching to witness a man who led a full life, who fought in Europe in WWII, raised a family, loved and was loved go to that place where he no longer knows anyone, even himself.

While at times Lauren comes across as self centered, she also does her best to reach out to KD. She learns to play the banjo because she remembered how he loved to listen to the music of Flatt and Scruggs. In addition to portions of some Gospel tunes, Ms Gunderson has also written a number of touching songs for the play. In *Let It* 

Be Me she asks "Who are we without the story?" It is the stories, the memories that are stolen from those suffering from dementia.

This is all pretty heavy stuff, and the realities are not glossed over here. Having said that, the play is not a downer. There is much to smile and laugh about as KD's life is recounted through conversations with Lauren as well as projections onto the back of the set. She learns from going through old letters that her Paw Paw called her grandmother Sugar Babe. She remembers watching Atlanta Braves baseball games together and the fun they had. They also had some interesting conversations about religion, a topic they didn't exactly see eye to eye on. Those differences lead to some funny exchanges between the pair.

The scenes where Mr. Judge assumes the role of Lear are stunning. He steps onto the heath and recites his lines which have been framed by KD's story. In the final storm scene from *Lear*, Lauren takes on the part of the Fool, and in creating the last scene with Lear and Cordelia, she is the King's youngest though she worries she may have been more like Goneril. The sound, the lighting, and the emotions are a theatre experience to remember. Ms Barnett and Mr. Judge deliver amazing performances on the MRT stage.

The Heath will touch everyone. It is a reminder that none of us gets out of life without suffering. That no matter how hard we try we will have regrets. It also tells us that our lives are filled with meaning and love, and it is up to us to strive to understand the gift we are given.

Don't be afraid of the subject matter. You will be enriched by this story. Our lives are our memories. Throughout the play texts are displayed on the backdrop. One is, "You have to begin to lose your memory, if only in bits and pieces, to realize that memory is what makes our lives. Our memory is our coherence, our reason, our feeling, even our action. Without it, we are nothing. — Luis Bunuel, My Last Sigh"

Ask them to talk about how she or he feels. They might feel especially lonely since they no longer have anyone to talk to at dinner or snuggle up with on the couch. Make a point to call or stop by regularly to check in.

Encourage seniors to keep a regular schedule and let them know about community events that might get them out of the house everyday (in the same way walking a dog would bring them social contact).

Can they stay in contact with a neighbor's pet? Simple contact with animals have been shown to lower blood pressure. If they are looking for a new pet, help them think about any physical limitations.

For instance, if seniors are exploring the idea of moving into assisted living, it's important to be aware that most senior centers do not accept pets. On the other and, many senior citizens are perfectly capable of walking, feeding and caring for the right pet for them. Encourage them to consider adopting a mature pet that would fit better with a more sedentary life style.

The loss of a pet is beyond words for those of you that don't understand the concept of loving an animal. He or she not only becomes your best friend, your loving companion but the only friend that you give you UNCONDITIONAL LOVE.

#### **CAPONATA** Eggplant

- 1 medium eggplant diced 6 or 7 tablespoons olive oil
- 1 sliced onion
- *3 tablespoons prepared tomato* sauce
- 2 stalks celery diced
- 2 tablespoon wine vinegar
- 1 tablespoon sugar
- 1 tablespoon capers 4 green pimento olives
- 1/4 teaspoon salt
- 1/8 tablespoon ground pepper
- A sprinkle of cayenne pepper (optional)

Wash whole eggplant (without removing outer skin), and dice. Heat five tablespoons of olive oil in a skillet and add diced eggplant to simmer until it softens. Add sliced onion to skillet and one or two teaspoons of additional olive oil, and fry until onion is lightly browned. Add tomato sauce and diced celery. Simmer mixture until celery is tender. If needed, add a tablespoon of water before adding capers and chopped green pimento olives. Stir frequently to prevent sticking.

Slightly heat wine vinegar separately. Add sugar and stir. Then pour vinegar gently over eggplant mixture in skillet. Simmer for ten to fifteen minutes. (Optional) Add a sprinkle of cayenne pepper.

Serve this hot or cooled as a side dish with broiled lamb chops, breaded fried cutlets or roast beef. It is also delicious on crackers or toasted bread to serve as hors d'oeuvres.

Caponata can be refrigerated for future servings. It can also be frozen and reheated.





are intrigued by the character etched in each of the faces you show them.



### HOOPS and HOCKEY in the HUB

The car was moving now and its occupant was just settling in for the now familiar drive from Providence to the Hub.

Yet, was it ever really supposed to be this way? Wasn't it supposed to be the big time team, the bright lights and the interviews with representatives of major media?

Well, in another hockey life of just a few months ago it was but now that really felt like a long time ago.

Yes, things had changed. So here he was on the section of Route 95 that takes one north away from one state capital and towards the other.

He was on that segment of the road that just might be known in hockey circles as the Jordan Caron Memorial Highway — so designated by some in honor of the former Bruins player who logged numerous trips on it between assignments in Boston and Providence.

In fact, it was stated, perhaps facetiously and jokingly, that Jordan's apartment was located near the midpoint of the trip so that no change of residence would be required.

The right winger was a yo-yo man personified, lasting on the Bruins roster for only one complete season while dividing his time between Providence and the Hub for five additional campaigns.

Yet his best day in hockey had come early on in his career - in June of 2011 — when he climbed aboard a duck boat that proceeded to parade through the streets of Boston in celebration of the B's Stanley Cup Championship season.

But now there was another making the drive. This particular trip wasn't supposed to be one for business - and don't forget, pro hockey is a business — but an occasion more

Ryan Donato was coming up to the Boston area to have dinner with both his girlfriend and his father — Ted Donato — the head hockey coach at Harvard University.

It was supposed to be a happy interlude really, a time between the reality of the minors and the hoped for gleam of the NHL. Sent down by B's management on January 28th, he had languished there until February 20th, his longest such banishment from Causeway Street.

What was it that writer had stated following that wonderful night in late March last year after he had scored a goal and recorded two assists in his NHL debut against Columbus? Ah, here it is. That writer had called him "the talk of the town."

The plaudits of the loquacious had been in full flower in the spring but had wilted in the fall, gone away like the blossoms of summer that had once shone in their summer glory.

But now, as the car headed north, an even more decisive transformation was about to unfold. Ryan had entered the car as a member of the Bruins franchise, the team that he had followed as a youngster, indeed the very team his father had

played for over the course of six full seasons, plus portions of two others.

But somewhere on the trip he received a phone call. Throughout one's life, there are a variety of phone calls nuisance ones, pleasant ones, sad ones, change of life ones.

This particular call might be placed in the latter category. After taking the call, Ryan continued to his destination and had dinner.

But his status had changed. He had entered the car in Providence as a member of the Bruins organization. When he exited the vehicle the B's were in the rear view mirror. He was now a member of the Minnesota Wild and he was back in the

Yes, the National Hockey League, not the minor league affiliate of the Minnesota Wild. So, after saying goodbye following dinner, it was back to Providence to pick up his hockey gear.

And then it was time to leave New England, perhaps not for good but at least for a little

He's was out on the highway once again and arrived in Greater New York at 2:30 a.m. — time enough to get some shuteye before meeting his new teammates later in the morning.

And it didn't take long for Donato to have a positive outcome while playing for his new team. That night he had two assists in Minnesota's 4-1 victory over the New York Rangers, a win that halted a five-game losing streak on the part the Wild. A few nights later, in his debut on Minnesota's home ice, Donato found the range for a tally in overtime that gave the Wild a 2-1 victory over St. Louis.

"There just wasn't a lot of opportunity (in Boston)," Donato told the Minneapolis Star Tribune. "There were a lot of guys battling for spots and it just didn't work out that way for me. I know that I'm a good player and that I'm ready for the NHL. It's a blessing in disguise. It's tough leaving Boston but I'm excited for a new position."

Those performances impressed Wild General Manager Paul Fenton. "We are looking to be a playoff team and Ryan can help us get there," he told Star Tribune writer Chris Hines.

And down on the ice level Head Coach Bruce Boudreau was also impressed. "He's going to bring some energy. He's got a history of being a skilled player. I'm sure he's going to work hard and that's what we need."

As the regular season comes down to its final weeks, it appears that Minnesota will be in for one wild ride as Ryan Donato and his new teammates seek to qualify for a postseason
