### I Am Getting So Tired of Cleansing Our History

St. Joseph's Day, observed on March 19th, is also celebrated as Father's Day in some Catholic countries like Portugal, Spain, and, of course, Italy. Italian-Americans, particulary of Sicilian heritage, celebrate St. Joseph as their patron saint. While it is customary to wear green on St. Patrick's Day, traditional St. Joseph's Day attire is red. Another tradition on this day is "la tavola di San Giuseppe," or St. Joseph's Table, which is an altar laden with food and flowers. Two "must have" foods for this Table are fava beans and lemons. The beans, because this is the crop that was said to have been saved with prayers to St. Joseph in Sicily, and lemons for good luck. But as can be seen in the photo above, anything goes!

# In Italy, Chocolate Easter Eggs are Works of Art

The hand-decorated chocolate eggs of Italy are created by the Michelangelo's of Confectioners. The eggs have borders, lattice and leaves. The flowers are made of colored sugar paste. The price of these eggs ranges from \$18 to \$1,000.

The world's most fantastic chocolate eggs are made in Italy. In Turin, the masterpiece of their efforts is on display for six weeks. A 220-pound chocolate shell with a sugar model of Piazza Vittorio Veneto inside was last year's masterpiece. It was crafted by 71-year-old Guido Bellissima, who is considered by many to be the master of this art.

Traditionally, the eggs have a gift inside. Those made for children usually contain a trinket, such as a toy doll. Children get very excited and want to discover quickly what surprise is in the egg. Eggs designed for wealthy adults might contain the keys to a new car or cruise tickets!

The DeCoster Company in Turin decorates 35,000 chocolate eggs each year for Easter. Another chocolate manufacturer is Sant' Ambroeus of Milan. Sant' Ambroeus designs a two-foot tall egg that is wrapped in a tablecloth worth \$400 — the egg sells for about \$1,000.

Peruginia is one of Italy's leading chocolate manufacturers. They ship 300,000 undecorated eggs to the United States each year. While the eggs are not decorated, they are beautifully wrapped in colorful paper. A couple of manufacturers that produce egg masterpieces are Peyrano and Majani (founded in 1796) in Bologna. Workers



hand-wrap the eggs in 100 different ways. Their annual production is 100,000 eggs — the prices range from \$100 down to \$18.

A handmade bittersweet chocolate egg made in a 10-inch mold would take about one hour to decorate and would sell in Italy for about \$25. Some of the eggs are made in nine different kinds of chocolate and each kind is wrapped in a different color.

In the United States, these fantastic chocolate eggs are found in the very best stores, such as Scalora on Rodeo Drive in Beverly Hills, California.

There seems to be no limit to creativity in Italy. A chocolate Easter Egg can be a very simple thing but, in Italy, it can also be a masterpiece!

### THE BRUTAL AUGUSTUS



Julia the Elder, daughter of Augustus.

Augustus lost his mother in 43 B.C., and his sister Octavia in 9 B.C. He married Claudia in 43 B.C., but divorced her before they started living together. Three years later (40 B.C.), he married Scribonia, who had been married twice before. He divorced her because she had a shrewish disposition. He then took the married and pregnant Livia away from her husband Tiberius and kept her for the rest of his life.

He was particularly fond of his two grandsons and became very protective of them. He suffered great heartache when his daughter Julia and granddaughter, also named Julia, were found to be guilty of every form of vice and banished them to an island for about five years. He denied them the use of wine and every form of luxury. No male was permitted near them without specific permission from Augustus, and he never referred to them except as his

two boils and his two ulcers. Whenever anyone pleaded for reconciliation with his two Julias, he openly called upon the gods to curse the pleader with like wives and daughters.

Augustus was never considered to be a legacy-hunter. Whenever he was left an inheritance by friends, he either turned it over to that persons' sons at once or, if they were minors, waited until they became of age and then gave them the money plus interest.

There were times when he was gracious and merciful towards those who made mistakes without evil intent. At other times (not very often), he became quite brutal. He forced a friend to commit suicide because he was convicted of adultery with Roman matrons. He broke the legs of his secretary for accepting a bribe to reveal the contents of a letter. When his son's tutors committed acts of arrogance and greed, he had them thrown into a river with heavy weights around their necks.

He vented his anger on even the most distinguished of his captives, and did not even spare them insulting language. One condemned man who begged humbly for a decent burial was told that the birds would settle his problems. A father and son who begged for their lives were told to cast lots or to play mora to decide which would live. He then looked on while the father was executed because he offered to die for his son, and thereupon the son took his own life.

### Navy's Decision to Abandon the Iconic Pea Coat Threatens Local Business

Since 1967, Sterlingwear of Boston, an East Boston manufacturer of outerwear, has been the sole official supplier to the U.S. Navy of the pea coats that are so emblematic of that branch of the service. Now the Navy has announced that it plans to abandon the centuries' old custom, eliminating the navyblue wool pea coat from sea bags and replacing it with a black nylon parka made in Puerto Rico.

"The negative impact that this decision has on our business is unparalleled in our long history of working with the U.S. Navy," said David Fredella, VP/COO of Sterlingwear of Boston. He continued, "The numerous small businesses that rely on

this product and the many employees that will be affected by this decision cannot be overstated. It is imperative that this decision be revisited and reversed.'

Sterlingwear of Boston has enjoyed a long and mutually beneficial relationship with the U.S. Navy. In times of need, the Boston manufacturer has responded and provided the necessary pea coats when needed, as well as accommodating design and material changes over the years.

"The impact of this decision is far-reaching and will affect the lives of so many who currently work in the textile and apparel industry, which is already severely impacted by the loss of manufacturing and jobs to overseas," said Jack

Foster, Director of Marketing, Sterlingwear of Boston.

The new parka will be worn shipboard and is not flameretardant. It is constructed of nylon and other synthetic materials. Wool, as in the traditional pea coat, is naturally flame-retardant, with wool being one of the greatest natural biodegradable flame-retardants known to the industry.

The effects of this illconsidered plan will ripple throughout Boston and New England. Every small East Boston business frequented by Sterlingwear employees will see a downturn in business if the garment maker is forced to lay off workers due to the loss of this contract.

Two of my clients, Ameri-

can Woolen Company and Northwest Woolen Mill, are the principal suppliers to Sterlingwear. It was Sam Brickle at Northwest Woolen Mill in Woonsocket, R.I., who first told me of this threat to our local New England manufacturing industries. Sam's mill, in cooperation with American Woolen Company in Stafford Springs, Connecticut, takes sheep's wool and transforms it into the durable, warm, and attractive fabric that Sterlingwear uses to produce a proudly made in the USA pea coat.

I'll let Sterlingwear have the last word. "To discontinue this garment that means so much, to so many, will be a disservice to those who have proudly worn or who currently wear the U.S. Navy Pea Coat," said Foster.

(Retired) Andrew Biggio.

The two Boston Police officers, Sgt. Norberto Perez and SWAT Team Officer Clifton Singletary, were among the officers responding to a domestic issue in an East Boston apartment when gunfire erupted and two officers were severely wounded. Despite a hail of bullets all around them, Sgt. Perez and Officer Singletary were able to

pull one of their colleagues out of harm's way and their efforts to pinch-off a bleeding artery and apply a tourniquet to his leg helped to save his life. The two officers are being honored with the Chapter's first-ever Hero Awards for their extraordinary and exemplary life-saving act.

Mia Martucci is 12 years old and a resident of Winthrop. She is being honored with the George Washington Honor Medal for her five years of dedicated fundraising for the Boston Children's Hospital Cancer Research Center, along with her toy drive to help lift the spirits of the children waging their battle against cancer at the Boston hospital.

Sheryl Howard of Winthrop is being honored with the George Washington Honor Medal for her "Veterans Honor Project." She involved many participants from numerous town organizations to ensure that Veterans Road in Winthrop would be adorned with the American flag on every utility pole as a respectful remembrance for those who served the country in military

USMC Sgt. (Retired) Andrew Biggio of Winthrop is being honored with the George Washington Honor Medal for his leadership and dedication in helping wounded veterans. He is the founder of the "They

Fought We Ride" fundraising project where more than 6,000 motorcyclists from near and far join in a ride through many communities in the Boston area, raising thousands of dollars that are used to assist wounded warriors.

# L'Anno Bello: A Year in Italian Folklore

St. Patrick and St. Joseph: Feasts to Welcome Spring

Hello, spring! I can feel the shifting of Mother Earth all around me, humming with the thrill of rebirth. The signs of spring are manifest everywhere. They are present in the sound of gurgling water as melting snow rushes down the storm drain. They are evident in the delicate white crocuses I recently saw lining the front path of someone's home. They appear in the candy-colored Easter eggs and grinning cloth bunnies that fill the seasonal departments of big-box stores. Though the weather still oscillates between balmy temperatures and wintry cold spells — even nor'easters! spring fever nevertheless grips my mind with all the energy of a hopping red-breasted robin. After the chilly and dark days of winter, the song of spring profoundly reverberates in our soul. The reawakening of nature and the growth of vegetation mimics the renewed energy and cheer blossoming in all living creatures. The calendar has tapped into this sense of rejuvenation and grants us two folkloric feasts that welcome spring and its accompanying beauty and promise. March 17th bursts with green to herald St. Patrick's Day. Two days later arrives St. Joseph's Day, a holiday honoring Italian heritage and commemorating one of the country's most beloved saints. Jointly, these two feasts celebrate the joy of spring and usher us into a season of hope and renewal.

Every year, I eagerly anticipate St. Patrick's Day. This holiday shines like a beacon of spring, an undeniable seasonal turning point. The very decorations of St. Patrick's Day overflow with spring imagery, from the lush green shamrocks to the rainbows which melt into pots of gold. St. Patrick's Day holds a special significance in Boston, due to our city's love of festivities and its large Irish-American population. I celebrate most holidays with symbolic food, and St. Patrick's Day proves no exception. I bake a creamy Irish soda bread studded with plump raisins and zesty caraway seeds. The bread is accompanied by a fresh spring greens salad laden with earthy beets, tangy goat cheese, and sweet caramelized pecans. Meanwhile, my father-in-law goes the traditional route and makes an Irish boiled dinner replete with potatoes, carrots, turnips and parsnips. Sometimes he will whip up a batch of Guinness stout brownies to end the meal. These seasonal foods encourage me to live in the present, patiently waiting for and then reveling in the unhurried edible treasures of the Earth. However, there is much more to St. Patrick's Day than food. This feast day honors St. Patrick, or San Patrizio in Italian, a Roman-British man first brought to Ireland as a slave. The most well-known legend concerning St. Patrick states that the patron saint of Ireland used a shamrock to teach people about the Holy Trinity, thus establishing this little spring plant as an enduring symbol of the holiday. St. Patrick's Day reminds me of brisk spring days when the forest appears lush and green after a rain shower, and a gossamer rainbow arches across the sky. This is a decidedly spring holiday, and as such forever lives in people's heart for its sense of joy and hope.

year. My father spent the days before this holiday scouring the woods with his friends, searching for firewood to help construct il faló di San Giuseppe, a giant bonfire held on the eve of the feast. These bonfires, with their abundant warmth and light that illuminates the inky night sky, symbolize the sun on its journey from winter to spring. Sometimes people will throw an effigy into the bon-fire to represent making a fresh start for spring. Of course, St. Joseph's Day has also become synonymous with zeppole, or fried, puffy donuts. My father loved his zeppole sweet and stuffed with cream, like the ones he would buy from bakeries in the North End around St. Joseph's Day. Meanwhile, my grandmother prefers savory zeppole made with potato. Either way, they are delicious. All of these treats remind me of a holiday that instills in me a pride in my heritage and gets me excited

for spring. As two quaint and folkloristic holidays approach us, we can revel in our anticipation for spring. After all, spring is not just a season; it is a resplendent manifestation of renewal, hope and optimism for the future. The greenery of St. Patrick's Day and the warm bonfires of St. Joseph's Day symbolize the essence of the spring season, calling to mind rites of purifica-



Two days later, on March 19th, arrives another feast of spring that holds enormous significance for my family. It is St. Joseph's Day, or la Festa di San Giuseppe in Italian. My father lovingly remembered breezy St. Joseph's Day celebrations in his mountainous hometown of Sulmona in the Abruzzi region of Italy, where the tender tree buds and the baying of lambs whispered the coming of spring. St. Joseph's Day serves as Father's Day in Italy, reflecting on the role of San Giuseppe as the husband of the Virgin Mary and the stepfather of Jesus. In Sicily and other regions of Italy, as well as many Italian-American communities, people build altars to St. Joseph loaded with bread, candles, pastries and fava beans. # Saint Marie-Eugénie De Jesus

Anne-Eugénie Milleret de Brou was born on August 25, 1817, in Metz, Moselle, France, north of Paris. Her family was privileged, wealthy, politically involved, and irreligious. Nevertheless, she was baptizedwhen she was 13. When her father lost his money and their estate and her parents separated, Anne-Eugénie moved to Paris with her mother. Her mother developed a deep concern for the poor of the city and Anne often accompanied her visiting families in need. Her mother died of cholera when Anne-Eugénie was 15 years old. She was boarded out with different families and, although outwardly she seemed happy, inwardly she was miserable.

At the age of 12, Anne-Eugénie made her First Holy Communion and it proved to be a life-changing experience for her. Through receiving this sacrament, she experienced the presence of God, a mystical moment and one about which she would talk throughout the rest of her life.

It was the custom to attend special sermons during Lent and Anne-Eugénie, while she was in her late teenage years, was invited to listen to a series of lectures at the Cathedral of Notre Dame given by the then Abbé Lacordaire, a famous preacher and social commentator of that period. Lacordaire was about to leave for Italy to



enter the Dominican Order and lead its re-establishment in France. As a result of his preaching, Anne-Eugénie had a conversion experience, became passionate about the Word of God, and became a dedicated Christian. She then went to confession with the Abbé Théodore Combalot, an associate of Lacordaire. Combalot told her that he was looking for someone to help him found a religious order devoted to Mary and to the education of the poor and thought that Anne-Eugénie could be such a foundress. At the age of 22, with four young companions, she founded the Religious of the Assumption. The congregation began in a small apartment on the Rue Ferou, Paris, and celebrated their first Mass together as a religious congregation on November 9, 1839. Today, the motherhouse of the Religious of the Assumption is on the Rue de l'Assomption, Paris. Over the years, Mother Marie-Eugénie, as she came to be known, founded thirty religious communities in nine countries.

Marie-Eugenie led the Assumption for fifty years. Her first priority was for her sisters, their formation and their work. She was concerned for their health as more than two hundred sisters passed away before she did, often young and of tuberculosis. She was constantly traveling from community to community encouraging, consoling and challenging her nuns.

As the Congregation became known, she was invited to start more and more communities. She saw her work being totally for the Church, and her loyalty to it was absolute. The last few years of her life were spent in increasing retirement. Gradually her health failed. Her legs refused to carry her and her speech also slowed, so that at the end she could only occasionally say a few words. Those around her were struck by her gentleness and patience. One day she managed to say: I am looking at my Lord. It is in looking at Him that we learn how to love. In 1898, Mother Marie-Eugénie died at the age of 80 in Paris, surrounded by her sisters. On February 9, 1975, she was beatified by Pope Paul VI and on June 3, 2007, she was canonized by Pope Benedict XVI. Her Feast Day is March 10th.

"Our location on Boston Harbor places us in a unique position to activate the waterfront. With this project, the ICA will make a cross-harbor connection that is central to our notion of art, civic life, and urban vitality," said Medvedow. "The Watershed represents an exciting and creative mode of growth for the museum. It takes art beyond our walls, building upon a decade-long history of public art projects that bring together landscape and contemporary art, as well as ongoing partnerships with East Boston youth communities."

The Watershed will be a raw, industrial space for art unlike any other in Boston. In addition to a flexible space for exhibitions, programming, and workshops, the Watershed will house an orientation gallery introducing visitors to the historic shipyard complemented by a



waterside plaza that will serve as a gathering place with stunning harbor views. Admission to the Watershed will be free for all.

"Boston's waterfront and harbor are one of the most unique aspects of our City, and I'm pleased the ICA is supporting our creative community in this welcoming East Boston space," said Mayor Martin J. Walsh. "The Watershed will offer Boston a new, engaging space for art and discovery, and I welcome their investment in Boston's diverse artists, residents, and visitors."

"We are thrilled to be working with the ICA on this ambitious and visionary endeavor that will connect the two neighborhoods we call home — East Boston and South Boston — through art and across the Harbor," said Tom Glynn, Chief Executive Officer of the Massachusetts Port Authority (Massport), which owns the property. "The Watershed will connect communities with Boston's dynamic working waterfront and shine a light on

its vital role in our city's history and future."

At the Watershed, the ICA will welcome visitors to experience immersive artworks by artists engaged with the issues of our times. The new facility is a central component of ICA's recently completed five-year strategic plan, A Radical Welcome, designed to advance the leading center for the vibrant intersection of contemporary art and civic life in Boston. For more on the ICA's strategic plan, visit *icaboston.org*.

Award-winning firm Anmahian Winton Architects (AW) has been engaged to execute the renovation of the facility. The design will embrace the history of the building's original design and use. Transportation from the ICA to the Watershed will be available by boat from docks adjacent to the ICA, and on the MBTA Blue Line.

Including the renovation and programming over the next five years, the project is expected to cost approximately \$10 million.

# Simple TIMES . . .

Freeway Says ...

With all the angst of a whopping winter storm stomping across the Midwest through the Northeast and arching deep along the Eastern seaboard to the Carolinas according to last Sunday's morning's news, I was immediately transported to the March 1971 snowstorm that hit my hometown in upstate New York.

Our region of the Northeast was just settling into spring wearing short sleeves, raking yards (with metal rakes), playing Wiffle ball, jumping rope, as the late-teen and early 20-year-olds waxed their Mustangs and Chevelles in our neighborhood. In our neck of the woods, all that activity was a sure sign of spring.

But, upon awaking to go to school the next morning, I and four of my seven siblings and our mom saw snowdrifts reaching the bottom of the bay window on the driveway side of our home! Moving excitedly to the living room to view the street and neighborhood, we saw snow banks covering the street and steps to houses, and strong winds swirling snow across the entire street causing visibility whiteouts.

We listened to an AM radio station that provided news of the storm. No Doppler radar forewarnings or satellites beaming weather-trends across America in 1971. No Weather Channel 24-hour television broadcasts. The radio was the primary source for weather updates and announcing school closings. That early March's wintry wallop clogged side-streets and closed schools for three days!

Anticipation grew as thoughts of once again hauling the Flexible Flyer and toboggan from the garage wall to extended snow mountains filled our heads. But there would be a gargantuan task ahead to remove snow drifts from driveways, sidewalks and porches. After eating a heaping bowl of oatmeal, my twin brother and I slid down snow-covered stairs off the kitchen door, trudging through waist-deep snow to reach our shovels inside the garage.

Our childhood home's driveway extended 120 feet and rules required we always clear the entire length. Keep the maximum width between houses free of snow. Same for sidewalks. Good thing we had lawn at the rear of our house and in four spots in front to toss three feet of snow. That eternal snow-scape seemed a heavy chore for two 11-year-old boys. Yet we enjoyed our outdoor chores — with no school. It set the foundation for a solid work ethic that remains today.

Shoveling snow at our family home would not be the only such task. We faced another couple hours clearing a 92-year-old neighbor's sidewalk, porches, and short driveway. Old Ray kept a large vegetable garden with a grape arbor, and rabbits inside his garage, and every autumn raked leaves from eight silver maples that stood tall on both sides of a small side-street two doors from our house. That street is where Old Ray's 1965 Rambler sat in his garage. We had to clear the 30-foot path of snow from his rear porch to reach the garage. Then his driveway.

While our parents picked up a few necessary groceries for Old Ray, his fierce independence could barely keep him from driving his car to the market. Two days later the plows arrived and piled snow atop already-shoveled snow from sidewalks, tipping the piles to 10 feet. Sun shone brightly as Old Ray called us and a neighbor friend to trek to the market with him. Though the slow ride a few blocks from the neighborhood seemed to last an hour, we arrived there and back home safely.

As 92 million Americans stare down the path of this year's monstrous March snowstorm, or Nor'easter as these storms are called nowadays, that March storm 46 years ago reminds me that little has changed. Schools close. People go outdoors with shovels and brooms and ice scrapers in hand. Plows rumble through streets. Privately owned snow removal operators seek opportunities to earn money. The sound of snow-throwers cut through howling winds. The scent of fireplaces or woodstoves wafts across neighborhoods. Biting cold air bears down on the snowy landscape.

Though snowstorms present dangers and cause difficulties, particularly for crews operating metropolitan mass transit systems of trolleys and trains that carry millions of people, I tend to think the new technology warning of snowstorms a few days out brings on unnecessary anxieties. Planning has merit. But the element of surprise we witnessed in 1971 brought lots of fun. Life being simpler never meant easier, yet we got on in great shape. What would Old Ray say?

# Nanna & Babbononno

A Nostalgic Remembrance



Easter is just a month away and I've been thinking of things that happened at this time of the year that I could write about. Last week, I told you about Babbononno, Uncle Gino, and the little lamb. Let's see, what I can add to the list of Easter stories? ... I know. Something happened several years ago that I was part of. Here we go:

Uncle Nick called one day to say he had received a call from Mamma Leone's. The New Yorkbased restaurant had opened a place in Boston on December 2nd, in 1972. It was then the late winter or early spring of 1973, and Lent would be beginning soon. He mentioned that the management wanted the union to put together four New Orleans-type strolling bands that could follow each other serenading the tables at the restaurant during the weeks preceding Lent.

As he continued, he told me that he wanted Dad to lead one of the groups and me another. He had two other musicians picked out to lead the third and fourth groups. His idea was to have each quartet specialize in different types of New Orleans music. One would be a string quartet that played semi-classical French music. The second would be headed by a trumpeter, or himself on sax, and they would play tunes that Louis Armstrong had recorded. Dad was to lead a four-piece group that specialized in downhome southern blues. He then said that I was to lead a novelty group that consisted of an accordion, soprano sax, washtub bass, and me with a kazoo and a tin whistle. My life as a musician was limited to me playing bass violin and bass guitar, nothing else. I had studied piano with a couple of people and could write and arrange due to my studies — but a kazoo and a tin whistle???

As Uncle Nick finished, I said to myself. "What the heck?" It was Lent and there wasn't much work until after Easter. On the night of our opening, I picked up Dad and Uncle Nick and we headed to Mamma Leone's. It was a new restaurant located near Copley Square in a newly constructed building that sat atop the Mass Pike and below a parking garage. The original Leone family had sold their New York restaurant and their name to a national marketing firm, and they wanted to make the Boston operation successful. Every amenity was extended to the sixteen-plus musicians that made up the four groups, including free parking, a giant-sized dressing room that was stocked with a invited him and his wife to

buffet-style Italian food setup, and people to wait on us all night long. The money was to be way above union scale and we were all happy with everything except the food.

As each of the four groups strolled around the cavernous restaurant serenading the dining audience, many complained to us about the quality of the food, or the lack thereof. After the third or fourth night, several of the musicians spoke to Uncle Nick about the buffet food that was set up in our dressing room. It wasn't good. He agreed with us and asked the management if they could switch it from Italian offerings to cold cuts, bread and the fixings to make sandwiches. The excuse was that the Italian food was too heavy to digest and the consequences made playing a bit difficult. They bought the excuse, and from then on we were served American and Italian cold cuts, bread, the fixings, and either soda (tonic to us Bostonians) or bottled water.

I told Uncle Nick about the complaints I had received about the food as we strolled from table to table. He said that he had heard the same complaints as he led his group in the procession of strolling quartets. My godfather made the decision to speak to the management, a group of businessmen sent in by Restaurant Associates, Inc., the national organization that now owned Mamma Leone's. None of the men were from Boston, although there were several upscale eating places in the city that they controlled. None of the men were Italian or Italian-American and none were restaurateurs. All were businessmen, and listened to my uncle's relay of customer complaints, including those from prominent Bostonians that we happened to know.

The management group sat in their Brooks Brothers suits at the conference table in one of their meeting rooms and listened to Uncle Nick speak. After he finished, he was politely told to stick to handling the entertainment and leave the food and function of the restaurant to them. After all, they were the professionals and knew what they were doing. Uncle Nick thanked them for listening to him and headed to the dressing room just as I was leaving with my quartet to stroll among the tables. I looked at him and he shook his head in the negative, saying, "Go ahead, go, I got nowhere with them. They politely told me to mind my own business, and that's what I will do."

I owed a friend a favor and

the restaurant for dinner and drinks on me. Neither was Italian, and neither was from a part of the country where they could have been exposed to Italian food (then, not now). Both politely told me the food was awful and I was embarrassed. I offered to take them out again, but they had to leave within a day or two and that ended the situation.

We musicians finished the engagement on Shrove Tuesday, the night before Ash Wednesday, were paid handsomely, and headed home. Uncle Nick called the next day stating that he had been contacted by the restaurant manager. He wanted a strolling trio to continue until further notice. The trio was to consist of an accordionist, me on bass violin, and Uncle Nick on clarinet and flute. Again we were to be paid way above scale and I agreed to be part of the trio. We continued playing at the Boston version of Mamma Leone's until it looked like there were more employees than customers. Within a short period of time, they closed their doors for the last time. The New York Mamma Leone's would continue until 1994 in Manhattan's theater district, where the Leone family ran one of the best Italian restaurants in the country. Then it disappeared. They began in 1906, sold out to the Restaurant Associates in the 1970s, and I think what happened in Boston eventually happened in New York.

Was Uncle Nick overstepping his bounds trying to tell the Boston management group what the customers told him? The musicians were composed of Italian-, Jewish-, and African-Americans, all of us complaining about the food, mainly to my uncle. We will never know, but the results were a vacant building in one of Boston's busiest downtown neighborhoods.

Unfortunately, no one is around for me to question about the events I described, so this week's story is based on my memory. Anyway, another Easter story is coming for next week. GOD BLESS AMERICA

### When Heavyweights Ruled

Jerry Izenberg Recalls the Time and the Excitement

From the time of John L. Sullivan and through most of the 20th Century, being the Heavyweight Champion of the World meant being the stuff of legends. It was as close to immortality as any man could get. Young boys would dream of growing up and one day being the next Jack Dempsey or Joe Louis. To hold that great title also meant being arguably the most famous man in the world. It is impossible to recall the Roaring Twenties without thinking of Dempsey. The '30s and '40s always have Joe Louis' visage looking at us from that time of the Great Depression and WWII. As America got back to work after the war, we had Rocky Marciano to remind us of the value of hard work and perseverance. In between each of these great champions were other great men who left their own mark on the history of boxing. The Heavyweight Championship was the most difficult to attain and most prestigious honor to capture in all of sports and, I would argue, in any realm of the world of entertainment.

It is sad that today it is just a memory. That great title no longer exists. Oh, there are people, a lot of them, who claim it, but none who have earned it. I doubt there are any young men today who wake up in the morning with that dream their grandfathers and fathers had of being the Champ. Those days are far behind us, but they didn't go away without a fight.

The final era when the Heavyweight Title still meant something was also one of its most exciting. Jerry Izenberg in his new book *Once There Were Giants: The Golden Age of Heavyweight Boxing* (Skyhorse Publishing, NY, NY) brings us back to that very exciting time.

If you were fortunate enough to have experienced boxing from the 1960s until the late 1980s, Jerry's book will bring back terrific memories of what may have been the most competitive period in the history of boxing among the big men. Mr. Izenberg argues it was, and he is standing on solid ground when he says so. It was certainly a very exciting time to be a fight fan.

He chronicles the rise and fall of the mob that took place from the 1930s up until the 1960s. We are introduced or reintroduced, depending on your age, to such characters as Owney Madden, Frankie Carbo, Jim Norris, Blinky Palermo, and many other gangsters who controlled boxing for decades. It is a sordid history of corruption and strong-arm tactics and very worth reading.

After Rocky Marciano retired, the Heavy-weight Championship fell into a sorry state. Cus D'Amato, who had crusaded against mob control of boxing, was able to take hold of the title with his young fighter Floyd Patterson. Mr. Izenberg sheds a lot of light on the real D'Amato who, it turns out, had his own mob connection. D'Amato also made it even more difficult for legitimate contenders to get a shot at the title because he was not going to allow his champion to step into

the ring with any opponent who had a pulse. At least with the old mob, a fighter could buy his way in. With D'Amato, the division went into a period where having talent only increased a fighter's chances of not getting a title fight.

Ironically, it took the underworld figure Sonny Liston to change things. When Sonny won the title by destroying Patterson, boxing epitaphs were being written. Boxing had gone from a mama's boy to a man who was pure evil. It didn't look like it could sink any further.

This is where Jerry's book goes from the darkness to the glory times. A young Cassius Clay had returned from the Rome Olympics waving his Gold Medal and proclaiming himself "The Greatest." He stepped up and whopped Sonny and began a new age in boxing. An age Jerry Izenberg was there to witness from beginning to end.

In a lively narrative, Mr. Izenberg brings us to ringside and into the backrooms to visit with the fighters and to relive these great fights. When Clay, now Ali, became champion, he fought everyone. Of course, a number of these contenders had grown old waiting for a title shot, but they were no longer going to be denied. Ali fought often and was always heard from. He was loved and hated, and he was exciting. Boxing was now back in a big way, and Mr. Izenberg brings it all alive again.

As Ali was mowing down the old line of contenders, a whole new crop was sprouting up.

While none seemed an immediate threat to Ali, it was going to get interesting. Well, it did get interesting when Ali was stripped of his title for refusing to be inducted into the Army. With Ali sitting on the sidelines, the heavyweight division still blossomed as many of the young prospects developed into serious contenders. By the time Ali returned to the ring, boxing was a whole new picture. It had certainly become much more competitive and even more exciting.

Jerry Izenberg follows these events up until the implosion of Mike Tyson, when it can be said heavyweight boxing was breathing its last. We are there for the three Ali v Frazier fights. The Foreman destruction of Frazier as well as Ken Norton's win over and two controversial losses to Ali. And the rise of Larry Holmes, a fighter who never got the respect he deserved.

Mr. Izenberg's insights are terrific, and his chapter on the Holmes v Cooney fight is particularly interesting. The racial overtones that fight took on were sad, but it is good to know they were not shared by the fighters.

There are also many behind-the-scenes stories about the rise and fall of Mike Tyson that include one very personal moment the author had with the future champ, as well as the story of Teddy Atlas's break with D'Amato and Tyson.

And if that isn't enough, Izenberg takes you to the Pruitt-Igoe Housing Project in St. Louis for a visit with Michael Spinks. The visit took place at midnight in the notorious project and it took plenty of courage for Jerry to show up. It does result in a very interesting story.

If you want to know what competitive boxing is like. If you want to know what it is like to have evenly matched contender fighting for the title. If you want to get a taste of the electricity that would fill the air all across the country when the Heavyweight Championship was on the line, you will find it in *Once There Were Giants*. It's unfortunate those times will never be seen again.

### HOOPS and HOCKEY in the HUB

It is a very successful league run by a very successful person — and it is right here in our area. The time is now for the organization and its leader to take center stage once again.

Welcome to the Hockey East Association, perhaps better known as the Hockey East Conference, or just HE. It's the premier college hockey conference in America, overseen by Commissioner Joe Bertagna, a man who has dedicated his life to this fast, fluid sport and is now in his 20th year at the helm.

Its time is now and his time is now because now is the time when Hockey East really shines — in college hockey's second season — the span that includes the Hockey East Tournament at the Garden plus the NCAA Regionals followed by the Frozen Four National Championship.

It is the time of year when Hockey East is often the face of the college hockey world — with a countenance that is all smiles, at that.

And why not? For when all is said and done, there is usually one or more representative from Hockey East toting home some hardware. The Hockey East Tournament champion receives an automatic berth in the NCAA regionals, but often multiple HE teams are also selected for atlarge berths.

Indeed, since the league started in 1984, Hockey East has played a prominent role in the NCAA tournament, sending some 105 teams forward to compete for regional and national honors.

As the years have gone on, Hockey East's presence on the national stage has expanded dramatically with the conference earning 33 of the 84 berths in the NCAA Frozen Four over the past 22 years. Nine have gone on to win the Big One — the NCAA National Championship. These include the University of Maine in 1993 and 1999, Boston University in 2005 and 2009, Boston College in 2001, 2008, 2010 and 2012, plus Providence College in 2015.

And when school's out, the spotlight continues to shine on Hockey East. Consider that 625 Hockey East players have been selected in the NHL Draft with nearly 100 making NHL rosters during the 2015-2016 season.

When Pittsburgh won the Stanley Cup last June, nine HE alumni proudly had their names inscribed on the historic hardware — Nick Boninio, Adam Clendening and David Warsofsky of BU; Brian Dumoulin, Ben Lovejoy and Rob Scuderi of BC; Bryan Rust of Notre Dame; Conor Sheary of UMass-Amherst; and Scott Wilson of UMass-Lowell.

The man who has been on the scene for all of this is the one who would prefer to share the credit rather than take all of it. But the directors of Hockey East know the real deal when they see him. In September, 2016, they extended commissioner Bertagna's contract through the 2019-2020 season in what an official conference press release

called "a direct response to the success" of the conference over the course of his tenure.

The commissioner goes way back in hockey — to his days as a netminder for Arlington High School in the late 1960s and early 1970s, followed by a collegiate career at Harvard University. He led the Ivy League with a 2.54 goals against average in 1972.

Which brings us to a side benefit of being Hockey East Commissioner. Because Harvard is not in Hockey East (it is in the ECAC), Bertagna can preside over Hockey East with complete impartiality while still being a fan of his alma mater.

After graduation, he played professionally with the Milwaukee Admirals as well as in Italy, where he helped lead the S.G. Cortina d'Apezesso team to the 1975 Italian Championship. He was also on the staff of the 1994 Men's Olympic Hockey Team.

Bertagna will tell you that he got to where he is by marketing himself as a person with multiple talents. He could play a sport well, he could write well, and he was a good student. Even while at Arlington High, he was phoning in scores to the local papers. He even had a diary on a competitive season when he played overseas published.

Over the decades, he has produced a number of books about hockey, the latest being *The Hockey Coaching Bible* that was released in 2015. He served two stints as the goaltending coach of the Bruins — from 1985 to 1991 and later for the 1994-1995 season. Early in his career, he also served as the Sports Information Director at Harvard.

As the Executive Director of the American Hockey Coaches Association, he currently oversees the publication of the organization's newsletter.

Bertagna was hired as Hockey East Commissioner on July 1, 1997, after a stint at the ECAC headquarters on Cape Cod. In his first month on the job, he secured a regional television contract for the conference. The exposure led to an increase in attendance for the conference tournament with the first sell-out coming in 2000.

As the first coach of women's varsity hockey at Harvard, Bertagna saw the need to expand opportunities for women and was instrumental in the formation of the Women's Hockey East Conference. In 2013, the Women's Hockey East Championship Trophy was named the Bertagna Trophy in recognition of his efforts.

Indeed, it is always hockey all the time in the Bertagna household, since Joe's summer days are spent running his goalie camps that have been a fixture on the summer hockey calendar for the past four decades.

Many prefer the ever-changing climate of the New England seasons, but for some in the region there is only one season — hockey season. And for that season, there is really no other man than Joe Bertagna.
