

Romney Cruises in Arizona, Santorum Surge Falls Short in Michigan

Mitt Romney barely won the Michigan Primary on Tuesday, starving off a strong challenge from former US Senator Rick Santorum and averted an embarrassing loss in the state he was born and raised in and a state in which his father was elected governor three times back in the 1960s, Romney won Arizona in double digits and had the support of both US Senator John McCain and Arizona's Governor Jan Brewer. Santorum was never a factor in this winner take all primary state.

However, in Michigan, it was down to the wire and Romney received 41 percent of the vote to Santorum's 38 percent. At his victory party in suburban Detroit, Romney stated "We didn't win by a lot but we won by enough and that's all that counts."

However, Santorum's strong second place finisher could be called a virtual tie and he does pick up a good number of convention delegates with his 38 percent share of the

Super Tuesday comes up next week and Massachusetts is part of this upcoming story. How big will Romney's margin be in his "home state" and what about the Ohio primary where Santorum seems to be doing quite well?

This bruising battle for the GOP nomination seems to be headed to the floor of the convention who will eventually face President Obama is still not clear yet. Many Republicans seem to be looking for a brokered convention and door number three.

Romney's narrow Michigan victory is not good news for Republicans. If the guy who's been running for five years and who has the most money to spend can only garnish 41 percent against a social conservative like Santorum, this state could likely go Democrat in November if it is a Romney-Obama fight.

By now many Republicans had thought the primary battle would have already ceased but it hasn't. The longer it goes, the battle the chances for Democrats and Obama.

Mayor Thomas M. Menino reminds residents that Boston's Daytime Neighborhood Street Cleaning Program has updated street sweeping days in many neighborhoods as the program kicks off this spring. The changes are designed to better align the sweeping schedule with trash and recycling days in an effort to boost the impact of the City's cleanup services and reduce neighborhood trash and litter. The new sweeping schedule and enforce-

ment will began in the South End on March 1 and citywide on April 1. Extended street sweeping will also begin March 1 for the North End, continuing the extension implemented in 2010.

"Keeping Boston's neighborhoods clean is a top priority of mine, as well as the residents of Boston, and these schedule changes will allow the city to clean streets in a way that maximizes the benefits of sweeping,' Mayor Menino said. "This is just one example of how we continue to evaluate and make changes to basic city services that benefit everyone. I look forward to seeing our neighborhoods shine once again this spring.'

The expanded program in the South End includes an expansion of the program into March and December and onto the 5th week of each month, at the request of the neighborhood. By moving the sweeping day to follow trash collection more closely, the new schedule will alleviate litter generated from the vehicle owner.

Residents are reminded to double check their sweeping schedule. The Boston Transportation Department has changed more than 4,000 street signs across the city to reflect the changes, as well as distributing more than 11,000 fliers to cars parked in the affected areas. Residents and other drivers are encouraged to register for "No-Tow" email reminders and visit www.cityof boston.gov/publicworks/

sweeping for comprehensive street sweeping schedule information. Residents can also call the Mayor's Hotline at 617-635-4500 for sweeping information.

The Daytime Neighborhood Street Cleaning Program is a cooperative effort of the Mayor's Office, the Public Works Department, the Transportation Department, and the Department of Innovation and Technology. Neighborhood streets throughout the city will be swept clean on a rotating schedule each week through November 30th. Vehicles are required to be moved in accordance with the posted Street Cleaning regulations. Since parked vehicles prohibit the equipment from getting to the curb, the street cleaning parking regulations are strictly enforced. Vehicles parked in violation of the posted regulations are subject to a \$40 ticket as well as towing. All towing for street cleaning violations is conducted by private tow operators at the sole expense of

THE THREE R'S IN OLD ROME

LUDUS in Latin means play, game, sport, child's play, diversion or school. Literarius means reading and writing. Put them both together and ludus literarius comes out to be an elementary school for children in old Rome.

Greek schooling and education was the forerunner of the Roman system. It should be noted that the Greeks paid great attention to their literary as well as their physical culture. The prohibition of schools was often used as a severe punishment for disloyal allies or provinces. In 550 BC there were laws which provided for a literary training at public cost for all boys. This attitude toward education was probably the most significant contribution in development of a civilization of the highest order by these classical Greeks. The young Greek citizen was free, intelligent and extremely accomplished. He had studied and participated in drama, knew the work of Homer and other great poets by heart, could play one or more musical instruments, sing and dance. He served at least one term in the army or navy, knew how to build walls and fortifications, was

was an expert at painting or some craft, and was knowledgeable in the work of architects, sculptors and painters, and he could discuss their work with intelligence and understanding. Athenian schools were only for boys. Mothers tutored their daughters in the domestic arts of sewing, spinning, etc. The classical Greek was truly a new order of man, and all of this was accomplished without a single day of busing.

Education in early Rome was not obligatory, but was always considered to be of great importance. Many a Roman youth received his early training from his father by learning his father's trade or business. Formal instruction in the ludus literarius was available to boys and girls alike and it was limited to reading, writing and arithmetic.

The magister was often forced to "luna lumen" (moonlight) in order to supplement his income.

The Roman school year began on March 24. This was the time when the new students brought their entrance fees called the "minerval". The balance of the school fees was paid each month. Classes were generally held under the awning or portico of some convenient shop and had to compete with all of the street noises. A screen or cloth drop provided shelter from the hot sun during appropriate seasons. The classroom furniture consisted of a teacher's chair and some stools for the children, writing tablets made of wax, some calculating boards call "abaci," and a blackboard. The partly open schoolroom, the noise of the teaching and of the punishment was of great annoyance to neighbors and passers by.

One fact was common in all elementary schools — no child was ever spoiled for fear of sparing the rod. The good old fashioned "schiaffo" seems to have been born here.



DON'T BE SURPRISED IF OBAMA THROWS ISRAEL UNDER THE BUS TO SECURE RE-ELECTION

It is no secret that President Obama has strained relations with Israel to a point unseen since the Carter administration.

Consider that Prime Minister Netanyahu was humiliated by Obama's snub on his last visit to the White House in March of 2010.

Fox News reported on that instance thusly: For a head of government to visit the White House and not pose for photographs is rare. For a key ally to be left to his own devices while the President withdraws to have dinner in private was, until this week, unheard of. Yet that is how President Obama treated Benjamin Netanyahu on Tuesday night, according to Israeli reports on a trip viewed in Jerusalem as a humiliation.

After failing to extract a written promise of concessions on settlements, Obama walked out of his meeting with Netanyahu but invited him to stay in the White House, consult with advisers and "let me know if there is anything new" a U.S. congressional representative, who spoke to the Prime Minister, said.

"It was awful," the congressional representative said. One Israeli newspaper called the meeting "a hazing in stages", poisoned by such mistrust that the Israeli delegation eventually left rather than risk being eavesdropped on a White House telephone line. Another said that the Prime Minister had received "the treatment reserved for the President of Equatorial Guinea."

Left to talk among themselves, Netanyahu and his aides retreated to the Roosevelt Room. He spent a further half-hour with Obama and extended his stay for a day of emergency talks to try to restart peace negotiations. However, he left with no official statement from either side. He returned to Israel isolated after what Israeli media have called a White House ambush for which he is largely to blame.

Sources said that Netanyahu failed to impress Obama with a flow chart purporting to show that he was not responsible for the timing of announcements of new settlement projects in east Jerusalem. Obama was said

Thankful for West End Roots and Representation of West End Museum

On January 28, 2012, The Middlesex County Bar Association (MCBA) elected Philip J. Privitera as its President. Privitera graduated Boston College Law School in 1995, where he served as the National Director for the Volunteer Income Tax Assistance (VITA) Program for the American Bar Association/Law Student Division (ABA/LSD) 1994-95. He also served as the ABA/ LSD First Circuit Lieuten-

ant Governor in 1993-94 and the ABA/ LSD President for Boston College Law School in 1992-93.

In 2009, Privitera was appointed to the Boston College Law School Board of Overseers by then Dean John Garvey, and where he still serves to the present day under current Dean Vincent Rougeau. Privitera graduated Summa Cum Laude from Belmont Hill preparatory high school in 1986, and then received his Bachelor's and Master's Degrees from Dartmouth College in Hanover, NH in 1990 and 1993 respectively.

In his experience as an attorney, Privitera looks back with gratitude to his family roots in the West End of Boston. His father **Francis D. Privitera** was born of Italian immigrants Giuseppina (Josephine) and Gaetano (Guy) Privitera who lived at 12 Hale Street in the West End. Hale Street is no longer on the map. In the 1950's, Hale Street, along with the houses that once stood there, and most of the original houses and streets of Boston's Old West End were taken by eminent domain. Everything was seized and destroyed in an "attempted" Urban Renewal Experiment.

President Phil Privitera recounts: "Ever since I can remember, I was told story-after-story by family members and friends about the West End being 'taken away.' I heard the stories so often, it was as if I lived the experience,

Privitera recalls watching video tapes: "In one moment there were frames of a vibrant, close knit, neighborhood ... a neighborhood one could only imagine ... one that could only be created in the back-lot of a Hollywood studio." In the next moment, however, "The film showed frames of bull dozers, wrecking balls and rubble." In one film, Privitera recalls an old woman leaning with one arm out of



a top floor window, reminiscent of his own grandmother: "She was waving her arm and looking distastefully, down at the wrecking ball and rubble all around her. She was in one of the last buildings still standing. It was painful to watch."

HOME DEPOT HAD GREAT EARNINGS

The market started out the holiday shortened week with a see-saw performance, ultimately finishing mixed and little changed. The healthy showing was broad based with hot shots such as Home Depot (HD), Macy's (M), Wal-Mart (WMT) and Steven Madden, Ltd. (SHOO) The US economy and job growth are improving and consumers are spending more freely. Rumors of the consumers' debt are exaggerated, said Lawrence Creatura, portfolio officer at Federated Investors. Retailers have adapted to consumers increasing price sensitivity and the good earnings by presenting correctly priced goods at an attractive price.

Home Depot earned 50¢/ share versus one year ago. Revenue rose 6% to \$16 million after surging a combined 51% in Q4. It seems to indicate a strong growth in sales of big ticket items and a rebound in home buying. Home Depot shares rose

nearly 3%, helped by a renewed focus on consumer service. Saks and Macy's both engaged a pretty good holiday shopping season. Macy's earnings rose 13% but US growth was exceptional.

Some store sales rose 1.5% from last year, the second straight quarter of corporate growth. Analysts see higher non-GAP earnings to \$2.47/share. For fiscal July it pegged increased its revenue forecasts see revenue of \$140.5 billion to \$4.185 billion up 9-10% on growth of 12-14%.

Small business revenue now sees higher GAAP operating income of \$1.465 billion on growth of activity increased, tax receipts tax revenue by 44% to \$295 billion. Dell's tax revenue was 21.1%. No way, the police in the case before the High Court didn't violate the US Constitution when they placed a GPS tracking device on a suspect's car and monitored the car's travels for 28 days. The justices were divided 5-4 on the rationale for the decision. The majority ruled the problem they faced was over the GPS's placement on private property where there was an expectation of privacy. One of the lawyers for the defense called the ruling "A signal event in Fourth Amendment history." Attorney Walter Dellinger added, "Law enforcement is now on notice that almost any use of GPS electronic surveillance of a citizen's movement will be legally questionable unless a warrant is obtained in advance."

The case decided in the courtroom concerned Antoine Jones who owned a Washington nightclub when police came to suspect him of drug trafficking. A GPS was placed on his vehicle without a warrant, tracking his every move and the evidence collected got him convicted. He was sentenced to life in prison. The US Court of Appeals for the District of Columbia Circuit overturned the conviction, saying it violated the 4th amendment which prohibits unreasonable searches.

The US Supreme Court has now upheld the Appeals us or potentially none of us.

Court's ruling. I agreed wholeheartedly with Justice Antonin Scalia who stated, "We hold that government's installation of a GPS device on a target's vehicle and its vehicle's movements, constituted a 'search' ... It is important to be clear about what occurred in this case. The government physically occupied private property for the purpose of obtaining information. We have no doubt that such a physical intrusion would have been considered a 'search' within the meaning of the Fourth Amendment." Justice Sam Alito disagreed with the majority opinion saying, "The use of long term GPS monitoring in investigations of most offenses impinges on expectations of privacy."

The issue of using GPS to track the bad guys is not settled by this decision. Further decisions will surely be addressed by the US Supreme Court but in this one case, the 4th amendment won the day as it should.

Liberals should be praising Justice Scalia for his decision in this case. The law is the law and the ends cannot justify circumventing the constitution. I accept the wide-lense approach in the understanding of the words and principles within the constitution. The founding fathers never heard of a GPS, they only heard of unreasonable searches and the need for warrants.

It doesn't matter if a guilty guy walks free, what matters is the upholding of our constitutional principles. Justice Antonin Scalia understood those principles quite well and the majority on the court made the only decision that could have been reached. Our Bill of Rights either protects all of







If you have been convicted of operating under the influence of Alcohol more than 20 years ago may that offence be added to your two current convictions so you lose your license for eight years?

EDWARD AUGER v. REGISTRAR OF MOTOR VEHICLES Opinion No.: 114951, Docket Number: CV2010-01729 SUPERIOR COURT OF MASSACHUSETTS, AT WORCESTER March 4, 2011, Decided • March 8, 2011, Filed

The plaintiff, Edward Auger, seeks **judicial** review of a **decision** by the Board of Appeal on Motor Vehicle Liability Policies and Bonds ("the Board"), which upheld a **decision** by the Registrar of Motor Vehicles ("the Registrar") that revoked the plaintiff's license to operate a motor vehicle in Massachusetts for eight years.

A review of the complaint, the motion papers, and the administrative record reveals the following facts. On September 11, 1984, the plaintiff was convicted of operating a motor vehicle while under the influence of an intoxicating liquor (OUI"). On November 30, 1988, he received a second OUI conviction. ON May 3, 2012, he

received a third OUI conviction. On May 4, 2010, the Registrar notified the plaintiff that, effective May 3, 2010, his license was revoked and suspended for a period of eight years. The plaintiff appealed this **decision** to the Board, which granted him a hearing on July 9, 2010.

The Court Said:

In the present case, the plaintiff did not have a single prior conviction of operating a motor vehicle while under the influence of intoxicating liquor more than ten years before receiving his most recent conviction. Instead, he had two OUI convictions, first on September 11, 1984 and then on November 30, 1988, before receiving his

third OUI conviction on May 3, 2010. Accordingly, the Board did not err when it affirmed the Registrar's **decision** to suspend the plaintiff's license for eight years, effective May 3, 2010. The plaintiff's motion will therefore be denied.

For the foregoing reasons, it is hereby ORDERED that the plaintiff Edward Auger's Motion for Judgment on the Pleadings be and is DENIED, and that the **decision** by Board of Appeal on Motor Vehicle Liability Policies and Bonds be and is AFFIRMED.

Enjoying the Mild Winter

It has been a mild winter; by comparison to the terrible winter we experienced last year, one could say that we are this year experiencing a veritable tropical vacation. Now it might not be as good as that, but the truth is, as of this writing, we have been spared the rigors of winter, frigid weather, piles of snow, endless gray skies, treacherous ice, and feel lucky to be at this point in March without a true blast from the North.

Living in the North End all of our lives, and parking our car in an open lot, we have become accustomed and even hardened to the fact that come winter our car will be buried at least once in snow and we will be out in the freezing cold digging it out and in some cases chopping it out of a cocoon of ice that has encased it. Last year

was a record, we had the dubious pleasure of digging out our car four times, toward the end of winter the piles of snow surrounding the car, mounded up from previous snowfalls, grew to be over six feet high giving the impression we were parking in an igloo, it is hard to believe that this year we haven't had to dig, chop, or scrape snow off our car once.

Taking advantage of the mild weather, we have been able to maintain a spring schedule of exercise, almost without interruption, right through the winter. We try to walk between three to five miles at least three times a week, using as one of our destination points a great little bakery in Chinatown where upon arrival we reward ourselves with a cup of coffee and green tea cake, which we are now able to

order in Mandarin Chinese. This past autumn, we figured we would not be able to regularly make the walk because of the anticipated cold weather, which is precisely what happened the year before in which we might have made it down to Chinatown three or four times during the winter. Because of the mild weather our schedule has remained the same and we have been able to visit with our Chinese friends uninterrupted.

As with so many who live in the city, not wanting to deny ourselves the pleasure of tending to plants and flowers, we developed over the years six distinct windowsill gardens made up of plants chosen for their ability to thrive indoors with only a moderate amount of sunlight. Normally, come winter, the plants do well to "hold their own" given the shortened days and radiant cold they're exposed to, this year all the plants thrived with some of them unexpectedly blooming in the dead of winter, it was almost as if winter had never happened.

It is obvious from what we are describing that it has not been a normal winter, in fact, it has been among the mildest winters we can recall, whether or not this is cause for concern, is uncertain, what is certain is that this winter has been a blessed relief, and we will most likely pay for our good fortune next year but for the present it will be pleasant walks to Chinatown along the Greenway, tending six windowsill gardens that are thriving when they should be merely "hanging on" and blessed freedom from the back pain and near frost bite that is our reward from digging our car out of an icy tomb, now that we are in March, it seems safe to say, enjoy the rest of this mild winter.

THE REGION LOMBARDIA HOLDS THE RECORD FOR TAX **EVASION!** It is certainly not to be very proud to be noted so lowly! During the year 2010, the Tax Revenue Agency did not conduct the necessary control on the taxpayers, only a little bit, about 6,000 were not checked. However, the amount recovered was quite high, for several taxpayers had failed, or omitted to file their tax returns. The amount of money from tax evaders was an astonishing 27.8 billion euro (@ \$42 bill.), about 5.7% more than in the preceding 2009. In the city of Trento (Region of Trentino-Alto Adige) the amount recovered from tax evaders was 71.6% more than in the previous year (2009). In the Region Lombardia, the tax evasion was a whopping 45.6% higher than in 2009. The Region Emilia-Romagna was the one to score a drop in tax evasion (54.9%). The Region of Lazio followed Lombardia in tax evasion of 4.8% (2009). The third place belongs to the Region Campania, even though a modest 2 billion euro was recovered by the fiscal authorities (actually 2.9 billion euro). The worst violators have turned out to be the largest corporations that do a yearly business of about 150 million euro. Of course, the center-north is where the worse taxpayers live, that is the most industrialized part of the country. Where the richest people also live.

I personally wonder how much Silvio Berlusconi, the second richest man in Italy (he has dropped from first place), has declared to the tax man! Just a simple, curious question!

A NEW GREAT DISCOVERY: MOTHER STEM CELLS MIN THE LUNGS! An Italian research scientist, who has been working for many years in the US, Piero Anversa, who is also the director of the lab for regenerative medicine at the Brigham and Women's Hospital in Boston, has discovered stem cells capable to regenerate all the elements that make up the lung, the alveoli, them bronchial tubes and the arteries. The magazine NATURE was the one to disclose this momentous discovery. Anversa described the stem cells of the human lung for the first time. The discovery may potentially offer to those who suffer chronic lung pathologies an important, entirely new option: the regeneration or repairing the lung's damaged spots.

Anversa comes from Parma (born in 1938), a real hunter of stem cells, who discovered also those in the human heart as well as in other animals, and also found clear evidence that stem cells found in the bone marrow can repair the heart, generating myocardial tissue and blood veins. Anversa stumbled in the heart stem cells while examining the bone marrow cells. The discovery of the heart stem cells has revolutionized the part of the regenerative medicine. The heart stem cells are today the most promising to cure a patient, after a heart attack, producing, in essence, a new heart that can function well. Anversa is working in a clinical experimentation which consists in extracting a sample of stem cells from heart-sick patients, making them multiply "in vitro," and then injecting them inside the damaged heart to see if they are capable of repairing it. If successful Anversa will have a new heart, healthy, while the patient will not develop future heart failures. The field is now open to a widespread use of the stem cells hoping to regenerate other organs and tissues. The idea is that the lung stem cells can be used to regenerate a patient's damaged organ afflicted with chronic respiratory illnesses.



Meryl Streep was engaged to Cazale at the time he passed away at 42 in March 1978. "I've hardly ever seen a person so devoted to someone who is falling away like John was," said Pacino. "To see her in that act of love for this man was overwhelming." Cazale was buried at Holy Cross Cemetery in Malden.

The two other films nominated for Best Picture that Cazale appeared in were Dog Day Afternoon, along with Al Pacino, and The Conversation with Gene Hackman and Harrison Ford.

Equally gifted in theater, where he began his acting career in 1962, Cazale met Meryl Streep in 1976 as they co-starred in the New York Public Theater's production of Shakespeare's Measure for Measure. Joseph Papp, producer of the New York Shakespeare Festival, referred to Cazale as "an amazing intellect, an extraordinary person and a fine, dedicated artist."

After high school, Cazale headed to Ohio to study drama at Oberlin College and returned to hone his acting talents at Boston University. Cazale met Al Pacino while both worked as messengers for Standard Oil in New York City. They roomed together in a communal house in Provincetown, where Israel Horovitz cast them in the Off Broadway play The Indian Wants The Bronx in 1968. Both actors won Obie Awards for their

A 2009 HBO-produced documentary I Knew It Was You is the best way to learn more about the complex, serious-minded Cazale, who stood tall amongst a generation of great actors in the 1970s. Robert De Niro, Pacino, Francis Ford Coppola, Gene Hackman and Streep, who reluctantly participated in the 40-minute documentary only after Cazale's brother Steven pleaded with her to do so, spoke fondly and emotionally of their friend.

We can only wonder what type of film Damon, Affleck, and the Wahlberg brothers would make with John Cazale. I'll nominate its finished product to earn Oscars galore.

Attention parents! Parents who browbeat their kids into being obedient and agreeable may not be giving them the best preparation for the real world. A new study shows that encouraging teens to argue calmly and effectively against parental orders makes them much more likely to resist peer pressure. University of Virginia researchers observed more than 150 13-year-olds as they disputed issues like grades, chores, and friends with their mothers. When researchers checked back in with the teens two and three years later, they found that those who had argued the longest and most convincingly without yelling, whining, or throwing insults — were also 40 percent less likely to have accepted offers of drugs and alcohol than the teens who had caved quickly. The key to having a constructive debate with your kids, experts say, is listening to them attentively and rewarding them when they make a good pointeven if you don't end up reaching a mutual agreement. Enough said.

STRUFOLI

A Fried Nugget-Shaped Pastry Prepared for Christmas and Easter

2½ cups flour

- 1/4 cup sugar 1 teaspoon baking
- powder
- ½ teaspoon salt
- 2 tablespoons melted butter or margarine
- 1 large egg (beaten)
- ½ cup milk
- 1 teaspoon vanilla 1 eight-ounce jar honey
- 1 small jar nonpareils
- 4 cups cooking oil

Mix first four ingredients in a ten-inch bowl. Add melted butter or margarine, beaten egg, milk and vanilla. Mix to make dough that can be rolled into a ball. Cut dough into four or five portions and cover. Roll each portion into long strips of one-inch thickness. Cut strip into half-inch portions. Heat oil in small saucepan or small deep fryer. Carefully drop a few Strufoli into hot oil. Stir with slotted spoon. Cook until golden brown. Remove from oil with slotted spoon. Set aside in a clean bowl.

Heat honey in a double boiler. Drop Strufoli, a portion at a time, into warm honey. Stir a few seconds. Remove with slotted spoon. Place in a clean bowl. Sprinkle nonpareils over them. Continue until all Strufoli are coated with honey and nonpareils. Serve hot or cooled.



A Nostalgic Remembrance



For the past few weeks, I told the story of a summer spent in Italy with Sal Meli, whom I had grown up with and Jose and Franny Encalada, who were celebrating their fifth wedding anniversary. For the next few months, we had many stories to tell about the land of our ancestors and the wonders that we encountered in our travels.

Things have changed over the years. Sal is living in a retirement community in East Boston, Jose and Franny still work, but spend most of their spare time playing the role of grandparents. I teach at a couple of colleges and type away at my computer writing stories for this beloved paper.

changed Things had enough from the time Babbononno and Nanna left Italy to the time I visited for Babbononno not to identify with many of the stories I brought home. I remember one story I told about when we visited Foggia, Babbononno's birth place. He listened and then became aggravated with the description of things, and finally blurted out, "You went the wrong way. You went in Spain, not Italy. That's not what Foggia looks like." I visited in 1972. He had left in 1896, hence the difference.

Just this past Thanksgiving, we had company from Italy stay with us for that holiday. Manuela is from Milan, has traveled all over Europe and speaks English almost without an accent. I compared notes with her about what I remembered from my travels through Italy and she told me what the areas I visited were like today. I could have mimicked Babbononno in terms of lack of identification over a 40 year span. I guess it's all relative

It seems that many cities and towns in Italy, like most other European countries, have signs and ads in their own language and in English. When I mentioned to Manbecame homesick for Amer-Naples, you can find McDoneven a Pizza Hut, believe it or not. It's pretty much the same in most of the other about the dialects we en-

"Most of them are gone or watered down. The majority of young Italians are well educated, today, and English is the mandatory second language. The only ones that don't speak it are the old folks from remote regions, but once they are gone, everyone will be conversational in English."

When she finished, I knew how Babbononno must have felt when I described his hometown after his 76 year absence.

Well, getting back to my return home ... I had several gifts I picked up for everyone. One important gift was a set of silver Rosary beads I bought for my mother at the Vatican. She used them constantly from then on, and when she passed away, she was laid out with her hands folded and those same beads wrapped around them.

The one thing I was a bit upset about was the story about my Godmother. Uncle Nick's first wife and he were my Godparents. Now, as you know, we Italians are as close to our Godparents as we are to our parents. I don't know if any other ethnic group holds as much reverence for Godparents as do Italians, and as a kid, I was always close to mine.

Uncle Nick and Ada Giorgeone were childhood sweethearts. She was also Mom's best friend growing up and she and my mother's middle brother were married around 1934 or '35. They stood up for my folks when they were married in '36 and christened me in '38. World War II separated them, and when Uncle Nick was discharged from the Navy, the marriage was over. He and Aunt Dorothy Hanscom began a relationship and were married in 1950. When Aunt Ada found out that Mom and Dad were still close with Uncle Nick and had befriended his new wife, she gave Mom an ultimatum ... them or me. They couldn't have children and we became the kids they never had. When John and Michael came along, they became surrogate grandchildren, and until Nick and Dorothy passed away, my kids spent just about every vacation with us in Florida hanging out with Uncle Nick and Aunt Dorothy.

Not having children, my aunt and uncle had the opportunity to travel extensively. They loved to take cruises and had seen much of the world. When my kids were young and were with us in Florida, quite often, they would sit on the floor after dinner and listen to Aunt Dorothy tell stories about foreign countries she and Uncle Nick had visited in their travels. I don't know whether she was the pied piper or the reincarnation of Auntie Mame, but my kids were mesmerized.

Aunt Dorothy was a Boston Brahmin, from an old Yankee family. As a matter of fact, my kids once asked her how far back her ancestry went in America and she replied, "The Revolution, both sides." The truth of the matter was that her family members were loyalists. When the war was over, they had to flee or be tarred and feathered, or worse. They couldn't afford to go back to England and fled to Canada. When they returned a generation or two later, they had another problem, they had converted to Catholicism, a no-no in Protestant Boston. Aunt Dorothy was the last in the line, and when she passed away only the name was left. Hanscom Airbase was named after one of her cousins, Lawrence Hanscom, but, that's it.

When my Godmother passed away, Mom told me she had attended her wake and funeral. When I told Uncle Nick, he and Aunt Dorothy made plans to have their civil marriage repeated, only this time by a priest in a Catholic church. Loretta and I stood up for them, but I'm out of space and that's a story for another day.





It was 50 years ago (March 2, 1962) that one of the most famous moments in the history of the NBA took place.

It was Wilt Chamberlain's 100 point game — a game that few saw and for which no video or film footage exists.

Wilt, whose duels with the Celtics Bill Russell became famous, accomplished the feat before only about 4,000 fans at the half filled Hersey Arena in Hershey, Pennsylvania as he led the Philadelphia Warriors to a 169-147 victory over the New York Knicks.

The regular season game was scheduled for Hershey as a favor to residents of that community for hosting Philadelphia's pre-season training camp over the years. There were two still photographers on hand but one left after the first quarter.

Chamberlain finished the regular season with an astounding 50.4 points per game average and a stellar 25.7 rebounds per game norm.

Then some 29 years later there was another fantastic performance — this time by a high school goalie named Tim Thomas. It was March 2, 1991 and Davison High School, with Thomas in net was playing Port Huron Northern in the Michigan high school playoffs.

To say the game went into overtime would be an understatement. Indeed, it would turn out to be one of the games in the history of organized hockey. Tied 2-2 at the end of regulation, the game wouldn't be decided until the sixth overtime period when Davison emerged a 3-2 victory.

That's right, they played hockey into the ninth period with Thomas going the entire game with stellar play in goal, making 62 saves over the course of the contest. For his part, Thomas remembers the exhaustion of his teammates "guys just sprawled out in the halls between periods." Thomas said the game started at 4:00 pm and didn't end until close to 11:00 pm. The fans sure got more than their money's worth.

THREE'S COMPANY — The NHL trade deadline passed and resulted in a pair of homecomings as both forward Brian Rolston and

defenseman Mike Mottau are returning to the Hub. In addition the B's also picked up defenseman Greg Zanon from the Minnesota Wild.

Rolston is better remembered by B's fans since he played here from 1999 to 2004 while Mottau, a native of Quincy, played at Boston College and won the Hobey Baker Award in 2000, effectively naming him the most outstanding player in college hockey for the 1999-2000 season.

"We've added some veteran depth to our lineup," noted Bruins GM Peter Chiarelli in a press conference. "I feel that Rolston is a motivated player with a terrific shot. He can really skate and can depth and versatility. He can move up and down the lineup and has a big shot."

Chiarelli assessment of Mottau was of a player who "adds strength to our defensive depth. He's a left shot D and we've been looking for some left shot D's. He has a good head on his shoulder plus good mobility. He keeps a nice gap for someone his size which is hard to do."

The GM feels that Zanon "is a real gritty competitor. He's a warrior type defenseman. So now we have eight defensemen in the mix. We've added the forward (Rolston) and we've also improved our defensive depth."

All three players indicated that they were glad to be coming to Boston. Well, I mean wouldn't you if you were just traded to a contender that has a chance to win the Stanley Cup. Last weekend Rolston Mottau were toiling away for the Islanders, a team that was next to last place in the Eastern Conference and going nowhere. The same can be said for Zanon in Minnesota where the Wild were in 12th place in the Western Conference.

Yet in one swoop here they are, with a team in second place in the East and challenging for first. How's that for improving your employment picture in life. Saved by the trading deadline bell for sure. From exile to euphoria. Maybe they're not The Big Three but they're certainly The Rescued (from oblivion) Three.
