Long Awaited Downtown School at 585 Commercial Street **Cheered by Local Officials and Families**

It was a celebratory mood at Friday's official announcement by Mayor Tom Menino that the City of Boston is acquiring the North End / Waterfront property at 585 Commercial Street to be renovated for a new K-8 public school in Downtown Boston. Since the news came out vesterday, it was disclosed that the City's purchase price is \$12.85 million for the space formerly occupied by Mitt Romney's presidential campaign and Roche Bobois furniture store.

The general footprint of the property will remain the same, according to city officials, but the entire interior will be renovated to school standards. The attached parking lot will be a drop-off space and allow for schoolrelated traffic to stay off crowded Commercial Street, especially during events and funerals at the Boston Harborside Home across the through June 2015. street.

Boston Public Schools will temporarily use the space for the Eliot K-8 Innovation School while that school is expanded into the former North Bennet Street School properties. Upon completion and pending School Committee approval, the school will accommodate more than 500 students in grades K-8.

After the Eliot properties are renovated, the new K-8 school is expected to open in September 2016. Design for the new downtown school will begin in Fall 2013, with construction expected to begin in June 2015. The Commercial Street facility will be used over the next two years as swing space for the Eliot K-8 School, as that school is expanded to the North Bennett Street School at 37-39 North Bennet St. and 48-52 Tileston St. in the North End. Eight classrooms and public space will serve Eliot students in grades 5-8

downtown families who have been very patient as we've worked to find a solution that would allow their children to attend a Boston Public School close to home," Mayor Menino said. "Today's announcement marks another step forward as we

work to improve our entire Boston Public Schools system, where more parents are choosing to send their children every year."

Boston Public Schools today also said today that it is seeing an 8% increase in students requesting Kindergarten (K2) seats for this fall. This year, 289 more families requested a K2 seat during the first round of registration as compared to last year.

The location offers direct access to the Harborwalk, a



SWAN BOATS OPENING



Mayor Thomas M. Menino and Boston's First Lady Angela Menino will host the first ride of the season as the Swan Boats open at the Public Garden Lagoon at 10 am on Saturday, April 13.

"It's time to put winter behind us and celebrate the arrival of

spring in the Public Garden," said Mayor Menino. "Come on down and celebrate the nice weather with a ride on the historic Swan Boats."

Mayor Menino will be joined on the first ride of the year with students from Boston Public Schools including the Ellis Mendell Elementary School in Roxbury and the Chittick Elementary School in Mattapan.

The students are drawing pictures of the swan boats in art class and their work will be randomly selected from all the drawings made. All of the artwork depicting the swan boats will then be on display at Boston City Hall for four weeks beginning April 22.

This annual rite is made possible thanks to the Paget family, owners and operators of the Swan Boats first launched in 1877 by English immigrant and shipbuilder Robert Paget. Mr. Paget designed the Swan Boats after attending the opera Lohengrin in New York City. At the end of the opera, the hero crosses a river in a boat drawn by a swan.

2013 marks the 137th season for the Swan Boats. The oldest and smallest boat in the fleet just celebrated its 102nd season, while the newest was launched in 1993. The swan on today's boats is made from either copper or fiberglass, depending on the age of the boat and encloses a paddle mechanism that is used to propel through the water.

Fully loaded, each Swan Boat weighs three tons and carries up to twenty passengers. The Swan Boats are built on copper-clad pontoons that contain air tanks to keep them afloat. After being stored in a safe place for the winter, the boats are returned to the Public Garden Lagoon in the spring with Mayor Menino and his young guests celebrating the first ride of the season.

bus routes and parking. Children from downtown neighborhoods would have access to the school, as well as families from East Boston and other neighborhoods identified in the BPS facilities long-term strategic plan if needed.

Over the past ten years, the number of school-age children has increased by 23 percent in downtown Boston; by 36 percent in the Back Bay; and by 20 percent in Beacon Hill. The City closed downtown schools more than 30 years ago, because at the time few expected these neighborhoods would again

> The Boston City Council must vote to approve funding from surplus property to acquire property. The proposal will be submitted to the Council on Monday, along with a request for an expedient hearing. The new school will also require approval from the Boston School Committee.

> Over the past several years, the City, along with the Boston Redevelopment Authority and Boston Public Schools, has scoured neighborhoods and pursued dozens of sites and buildings for the purpose of a downtown

school. The City also expanded capacity at the nearby Warren Prescott and the popular Eliot School in an effort to accommodate downtown families.

Mayor Menino and City officials have met repeatedly with parents from the Back Bay, West End, North End, Waterfront, Beacon Hill and parts of Charlestown, as well as representatives from Hill House on Beacon Hill, the West End Parent Group, the Beacon Hill Civic Association, the North End Waterfront Mothers Association. and the Downtown North Association.



MARILYN PETITTO DEVANEY **Governor's Councilor**



Marilyn M. Petitto Devaney is the first Italian American woman ever elected Governor's Councillor in the State of Massachusetts since the Governor's Council was established by the Constitution in 1780. Marilyn has been serving since 1999- completed seven two-year terms. Last November she was elected to her eighth term. She received 202,522 votes (from 32 cities and towns she represents) -75% of the

votes in her district — the largest number of votes ever received by any Governor's Councillor running with opposition.

Marilyn, born with a last name "Peters" is a lifelong resident of Watertown, Massachusetts - first generation American, the youngest child of three older sisters, of the late Andrew and the late Madeline (DeNucci).

Marilyn's father was born in Messina, Sicily. Her mother's family came from Avellino. Marilyn through the years was continually upset when she visited her family's grave - seeing the name on the stone "Peters." Marilyn's father, an Italian immigrant, faced such blatant prejudice. When they would not hire Italians, he was forced at age 17 to change his name from "Petitto to Peters" — to work — to survive. Marilyn couldn't change the past but she did make a change. Twenty-five years ago Marilyn went to court and took back her father's name that he was born with. Marilyn officially took "Petitto" as her middle name. Marilyn has been a member of the Cornelia Dei Gracchi Lodge, Sons of Italy of Watertown for 36 years and served a term as a Trustee. She is a long-time and present member of the Commission of Social Justice of the Sons of Italy of America.

Marilyn stated she joined the Sons of Italy to demonstrate her pride in being Italian American, her own way of vindication for the prejudice her parents and relatives experienced, as well as her own ... She wants to change the negative stereotyping of Italians and re-educate people — especially those of Italian descent — to be proud of all that Italians have contributed to this country.

Marilyn was married to the late John "Jack" Devaney, a Marine and Watertown firefighter, has four children and three grandchildren.

Marilyn, as a wife and mother with four children began college, earned her ABA at Middlesex Community College, Bachelor's degree at Suffolk University and Masters at Boston State College.

Marilyn has been very involved with her community, church and country. She is a member of the American Legion Auxiliary in Newton. She is a former CCD teacher and lector at St. Patrick's Church in Watertown. In the past, she even volunteered for six months with juveniles on probation in court. She was elected as one of Watertown's youngest town meeting members - then when Watertown changed to a city she was elected as a town Councillor-at-Large

Marilyn has earned the reputation of being the hardest- working councillor - The Council holds hearings twelve months a year - no vacation — with weekly meeting as well. The councilors have no staff. In 14 years Marilyn has been absent only once for a meeting and a hearing when her husband died.

Through the years, Marilyn has demonstrated her compassion and caring for those less fortunate and in need. 

WHATEVER HAPPENED TO THE HALF-MARATHON **FROM CATHEDRAL TO CITY POINT?**



For you chocolate lovers! The dentist may have warned you that chocolate would rot your teeth, but researchers are constantly discovering ways that chocolate can be good for your health. As far back as 1900 B.C., pre-Colombian tribes used Theobromo cacao in religious rituals, both as a sacred drink and as an offering to the gods. Our word "chocolate" probably comes from an Aztec word meaning "bitter water." Europeans took it back home and began serving it as hot chocolate to the upper classes. Candy bars didn't come along until the 19th century, when manufacturers came up with a process to make solid chocolate. Researchers found that people who regularly ate modest amounts of dark chocolate weighed less than those who didn't. Now studies have shown that chocolate has a very real effect on the mood of people under stress. It's not just a placebo; chocolate causes physiological changes in stress hormones by increasing melatonin (which helps to promote sleep) and dopamine and serotonin (which regulate mood). Another study showed that chocolate gives both men and women an emotional high that lasts four times longer than kissing. Eat it wisely and that dark brown substance might bring you health and happiness.

Roast Leg of Lamb

1 leg of lamb (5 to 6 pounds) 4 cloves of garlic 1 tablespoon thyme or oregano

1/2 cup chopped mint (optional) ¹/₄ cup lemon juice Salt and pepper


Rub the leg of lamb with half of a garlic clove. Then make several gashes with point of knife into the lamb leg and insert small cut portions of garlic clove into the narrow openings. Rub meat with mint, thyme, or oregano, whichever you plan to use, or some of each. Rub leg of lamb with salt and pepper. Add a little water to the lemon juice and pour gently over lamb. Place lamb fat side up in roasting pan. Place in preheated 325°F oven uncovered. After 30 minutes, baste lamb with juices from the roasting pan and repeat frequently. Lamb should be baked until meat thermometer reads 175 to 180°F. If you are baking without a meat thermometer, allow lamb to bake approximately 30 minutes per pound of lamb. Add more water mixed with a little lemon juice if more liquid is needed for basting

OPTIONAL: Small white potatoes, carrots and some mushrooms can be added around the leg of lamb after the lamb has baked about an hour. Continue basting vegetables as well as the lamb.

NOTE: I awoke Easter morning to a combination of aromas filling the kitchen. I watched as Mama put the lamb roast into the oven. I saw the chicken soup simmering slowly on the stove next to the tomato sauce Mama had prepared earlier. I always asked to have one of the meatballs as she completed frying them. When did Mama start all this, I wondered.

On the kitchen table, a bowl of hard-boiled eggs greeted my eyes along with a Cannatone (Easter Bread) for Peter and me. As Peter, Papa and I departed for church after breakfast, Nonna and Mama's sister Lena arrived to help make the ravioli. I knew then that the Easter meal would keep us at the table for a long time.

DNA Databases for Arrestees?

The U.S. Supreme Court is currently trying to balance the rights of citizens arrested but not convicted of a major crime to keep their DNA out of the government's hands versus the rights of crime victims seeking justice. If the court rules for Alonzo King of Maryland, more than one million DNA profiles that have been stored in a federal database for matching with future crime scene evidence may have to be purged and others will never be collected, leading some repeat offenders to go free.

Under consideration is a 2003 case in Salisbury, Maryland. A man wearing a hat and scarf and showing a gun raped and robbed a 53year-old woman in her home and then disappeared into the night. Nearly six years later Mr. King was arrested and charged with an unrelated assault. The police under federal law took a cheek swab of King's DNA. They then matched it with a sample taken at the scene of the 2003 rape and it

of the 2003 rape and is serving a life sentence. However, a Maryland court refused the conviction and said King had to be freed.

King in 2009 was not convicted of the crime he was arrested for having committed and pled out to a lesser charge of misdemeanor assault, a crime Maryland cannot take DNA samples. The lower courts ruled it violated King's rights based on the arrest alone. The U.S. Supreme Court is now expected to make a ruling before the summer.

Victim rights advocates defend the DNA testing laws. William Sammons of the Maryland Coalition Against Sexual Assault says, "The early collection of DNA prevents crime." However, opponents of the DNA testing of arrestees sees the practice of allowing police without a warrant or conviction as another loss of privacy. Getting DNA swabs from criminals is commonplace today. All 50 states and the Feds take Rights.

criminals to check against federal and state databases with the court's approval. However, 28 states and the federal government now take samples from people arrested long before their guilt or innocence is proven in court.

I HAVE NOTHING AGAINST THE POOR BUT ...

HOOPS and HOCKEY in the HUB

In the end, the very end, the visitors left with a victory that humbled their high status while the members of the home team exited with their heads held high, knowing that they had shredded the aura of invincibility surrounding their opponent.

Yes, it was a tough loss that the Celtics experienced at the hands of the defending NBA champion Miami Heat at the Garden on March 18. But with a nationwide television audience tuned in, it was a contest where the highly thought of Heat struggled against a Celtics lineup that lacked the talents of Kevin Garnett, Rajon Rondo and Jared Sullinger.

Miami won by just two points, a 105-103 count that only brought victory by a very narrow margin when Paul Pierce's three-point attempt for a win hit the rim and bounced away with seconds remaining.

"I told the guys that this was our first playoff game," said Celtics head coach Doc Rivers in his postgame press conference. "I was looking forward to the game because I didn't know how a lot of the new guys were going to react. Overall, although we lost the game, we passed the test. As he looked out at the assembled media members he offered this realistic thought: "But losing the game is what you'll remember."

In case you're wondering,

Rivers felt it was the mistakes that his players made, rather than the performance by Miami that cost his team the game.

"I just think that overall we made too many mistakes to win the game," said Rivers. "As hard as we played — and we played great — I just thought that we made too many mistakes defensively switching and giving up layups. I just didn't like the defensive mistakes that could have been prevented."

Indeed, Miami scored 50 of its points "in the paint" meaning from very near or under the basket. In addition, "the turnovers killed us," noted Rivers. "They had 24 points — that's almost a quarter of their points," coming out of turnovers by the Celtics.

In a matchup with such a close finish a little improvement in any one phase of the game could have meant victory for the C's. "We missed some layups down the stretch," noted Rivers. Here's a couple of others: the Celtics made 15 of 24 free throws over the course of the game. If they had made just three more they would have won. They were 10 of 21 from three point land. Had they made another there would have been joy on Causeway Street.

For most of the game it looked as if the Celtics would win and halt Miami's 22extending their own home

winning streak on the parquet to 12. The C's led at all the normal stopping points up 19-13 after the first quarter, ahead 59-53 at the half and out in front 82-78 after three quarters.

Early in the second quarter Boston actually led by 17 but Miami clawed its way back and actually tied the game twice early in the third. The Celtics then went out in front again with a modest lead, one they would not give up until Miami star LeBron James made a layup to tie the game with 1:21 left in the contest. He then hit what proved to be the winning hoop (a 21-foot jumper) with 10.5 seconds remaining.

"We have to run, that's who we are," said Rivers. "When we were doing that I thought we were terrific. When we tried to set things up we were not. But overall, I'll take the game. It was a fantastic game. I just don't like losing."

The Celtics were able to keep command most of the way because of the play of forward Jeff Green, who scored a career-high 43 points. It was a huge announcement that Green was back. Remember he was forced to miss the entire 2011-2012 season after he was diagnosed with an aortic aneurysm and underwent surgery.

There was a silver lining. He used his time off from game winning streak while basketball to complete academic work towards his de-

gree at Georgetown, graduating last May with a major in English and a minor in Theology. He then re-signed with the Celtics over the summer, inking a four-year, \$36 million contract.

"Jeff was terrific," said Rivers. "He attacked. Once he realized he had the advantage, he took advantage and that was great."

"It was the best team in the league and we took them to their breaking point," noted Green. "We've just got to continue to play like we did. When Kevin (Garnett) comes back, I think we will be more lethal. So long as we continue to attack and get stops we'll be in pretty good shape."

One person who wasn't a factor was former Celtics guard Ray Allen. He played is important in the home just over 30 minutes but stretch.

only scored six points for Miami, while being booed by fans that once hailed him as a champion. From a prince of the parquet to a disliked member of the Heat (at least in this town) — how fickle some fans can be.

There's one more regular season game left with the Heat — at Miami on April 12. The Celtics only have seven home games remaining, including the Knicks (March 26), Brooklyn (April 10) and Indiana (April 16).






Satchel Paige Once Said, "Never Look Behind or They'll Gain on You"
