Romney Carries Both Puerto Rico & Illinois Primaries

picked two recent primary victories. On Saturday, March 17, the luck of the Irish and Puerto Rican Gov. Luis Fortuna were with Romney. He carried Puerto Rico with over 80 percent of the vote and won all 20 delegates at stake that day. This past Tuesday, Romney won again. Achievement Awards at Italian Consulate

Consul Pastorelli Recognizes Seven Italians and Italian Americans for Their Outstanding Contributions to the Community

On Tuesday, March 20, the Italian Consulate General in Boston held a ceremony to award seven members of New England's Italian and Italian American community who have distinguished themselves in various fields of interest.

Consul General Giuseppe Pastorelli handed out the achievement awards, which had been introduced for the first time in 2011, during the opening ceremony at the Massachusetts State House for the 150th Anniversary of Italy's Unification.

The award for "Art, Culture and Entertainment" went to internationally known soprano Maria Scapagna. "I am very proud of my heritage," she said. "I remember crying when I put my foot on Italian soil for the first time." Scapagna has performed in the most prestigious opera theaters and concert halls in the world and is currently a voice lecturer at Boston University.

The "Business" achievement award was given to Paul Picknelly, a third generation Italian American

who continues in his grandfather's entrepreneurial footsteps. In fact, Peter Carmine Picknelly founded the Peter Pan Bus Company in 1933. Paul Picknelly is current president of Monarch Enterprises, while his brother Peter runs the bus company, which is still family-owned. During his acceptance speech, Picknelly pledged to improve the relationship between his hometown Springfield, Massachusetts, with Italian sister city

THE SAD RAGS OF OLD ROME

Last week I asked that we not feel sorry for the typical lady of the "olden golden" days of old Rome. Then I described in detail, her normal wardrobe. Some alternatives were available to the Roman men but the selection was greatly restricted. They wore an "alicula" which was a short cloak that only came down to the elbows. It was usually worn by young boys and it derived its name from the resemblance of the garment to wings. There was also the "abolla," a knee length cloak made from coarse material which was worn indiscriminately as an outer garment by all classes. It was made from a large oval shaped piece of material that was thrown over the left shoulder and arm like a side cape and it was secured by a clasp at the right shoulder.

They wore trousers or pantaloons called "bracae," such as were worn by many nations. The name is synonymous with the Gallic term "brakes," the Scottish "breek," and the English "breeches." They were made of wool, linen, cotton, silk, and even leather. The "cucullus" was a cowl or cape-like garment with a hood that was designed to be pulled over the head in inclement weather, or thrown back over the shoulders. This cucullus was often worn by persons of distinction who did not wish to be recognized.

Another interesting garment was the "paludamentum" — a short red cape that was worn by Roman generals over their armor. The wore it when they departed trip they changed into the toga, the garment of peace, before entering Rome. Later, the purple paludamentum was adopted by the emperors as a token of their imperial power. As this paludamentum was the cape of the Roman generals, so was the "sagnum" the cape of the Roman soldier. It was worn over their armor the same way that the generals wore their capes. The sagnum was a symbol of war as the toga was the symbol of peace.

The "chlamys" was a long mantle whose origin is lost in antiquity. It was worn in a manner that was similar to the shawl of today. Sketches taken from old coins, vases, or carvings show male dancers in a circle and wearing the chlamys. The "exomis" was a very common garment that was reserved for the summer months. It was a short sleeveless tunic that bared the right shoulder, arm and breast (Tarzan style). It was often worn by persons who were engaged in a very active or laborious work such as slaves, farmers and huntsmen.

The toga was the Roman counterpart to the conventional black morning coat of today. It was worn as the ceremonial dress on public occasions as an ancestral custom, and was a must for any respectable citizen. It was a garment worthy of the masters of the world, vividly expressive and flowing. The material was fine white wool and the togas of judges or magistrates had a very distinguishable purple border. Foreigners and Roman for war. During their return exiles were forbidden to wear

the toga. In pattern, it was formed of two large segments of a circle, with the straight edges together. The length was about three times the wearer's height and the width was about two thirds of the length.

It was folded and pressed with special plaits so that when properly worn it was thrown over the left shoulder, then brought around under the right arm, and again thrown over the left shoulder. The part across the chest was known as the "sinus" or bosom, and it was usually deep enough to form a pocket for small articles. The emperor Claudius passed a law requiring the toga to be the mandatory garment for all magistrates. The emperor Domitian required it to be worn in the theater, and Commodus made it a mandatory garment for the spectators in the amphitheater.

The toga was a very expensive garment to buy, was very uncomfortable to wear, and was so over complicated that great skill was required to keep it looking well. Constant attention and adjustment was required while walking or in just about any kind of movement. It was also very heavy, and being white required frequent laundering. People gradually developed substitutes for the toga, such as a long tunic called the "synthesis." Finally the crafty Romans devised a way to dispose of two problems at one time when they ordered that the toga be worn only in the casket (Amen).

What Ails the Republican Party

Republican party is not the fact that it is in the minority. It has been in the minority before. What ails it is a certain sort of yielding to opportunism, a yielding to that element within the party clamoring for liberalization, clamoring to the Republican party to throw away the birthright of conservatism and enter the lists against the radical Democratic party on the Democratic party's side."

The quotation above is from J. Fred Essary, Washington correspondent of the Baltimore Sun, speaking in Providence, RI at the 83rd Annual Meeting of the National Association of Cotton Manufacturers, October 7, 1937. Mr. Essary continued:

"No, I think the Republican party could return to power if it would go back first to its old moorings, return to the old faith, become the champion, the unblushing defender of the great conservative thought in American life. It may have to wait longer than 1940 for victory."

Substitute "2012" for "1940" and Mr. Essary's remarks could be delivered today. Unfortunately, his call for a return to conservatism was rejected by party leaders. The result was four decades of Democratic party hegemony with the Republican response to the prevailing liberalism being a faint, "me too." Will the Republican Party make the same mistake again this year? Has it already?

It's one of my pet theories that voters don't expect any candidate to agree with them on every issue. What they look for is someone who is competent and whom they trust and agree with on important issues. No doubt Romney's well qualified to very likeable.

"Gentlemen, what ails the administer this Republic. Indeed, much of his "pitch" is based on his success in the investment world. But in selecting a President we are doing more than picking an investment fund manager.

That leaves issues and character to distinguish the contenders. On issues (he's wrong about just about everything) and character (he's self-absorbed and petulant) the current occupant of 1600 Pennsylvania Avenue is deficient. But the American people will not throw out a sitting President unless they have a pretty good idea that they will get someone better in his place.

To the extent that there is a conservative "orthodoxy" (a strange concept given that it is part of the conservative temperament to reject the notion of ideological purity) Romney has carefully aligned himself with the views of the majority of Republican voters. He calculated just how far to the left he needed to swing to get elected in liberal Massachusetts, and he thinks he knows precisely how far to sway toward conservatives to get the GOP nomination. He invested his money in his campaign, sure that his perfectly researched econometric model of voting patterns will pay off as a business investment. But as Russell Kirk summed it up, borrowing a phrase from Edmund Burke, conservatives distrust "sophisters, calculators, and economists," and rightly so. For a nation is too complex with too many independent actors to ever yield itself to so cold-blooded an approach. It's not enough for voters to agree with you, you need them to like and trust you. It is not clear that the machine-man that Romney has made himself into is

VOTER ID'S REQUIRED TO PREVENT FRAUD

It was recently reported there are two million dead people registered to vote in various states. We must not allow another election to be sullied by illegal voting.

Consider, the problem, and it has happened in every national election in recent memory is voter fraud and it is real. In many cases, those implicated are members of left-leaning groups run by unions, George Soros, illegal alien activists and in each election, the far left has an army of operatives padding voting rolls. During the 2000 elections, about 5,700 felons voted in Florida. In St. Louis, election officials discovered that pets and deceased were being registered to vote.

There are 34 states requiring voter ID's, several with photo requirements.

I mention this fact in view of the Justice Department just filed an objection to Texas voter ID law.

Governor Rick Perry stated, "The Obama administration has once more gone too far in its overreach," after the Justice Department objected to the state's new voter photo ID law, saying "Texas failed to demonstrate that the law is not discriminatory by design against Hispanic voters."

Texas has a responsibility to ensure elections are fair, beyond reproach and accurately reflect the will of the voters. The DOJ has no valid reason for rejecting this important law, which requires nothing more extensive than the type of photo identification necessary to receive a library card or board an airplane. "Their denial is yet another example of the Obama administration's continuing and pervasive federal overreach," Perry said.

Texas is the second state to have its voter ID law challenged. The Justice Department already blocked a similar law from taking effect in South Carolina — the first time a voter ID law was rejected by the department in

South Carolina sued AG Holder in response, arguing that enforcement of its new law will not disenfranchise any voters.

It is vital to note, the Supreme Court's Rebuttal of Voter ID Detractors:

Boston EMS EMT and 12-Year-Old Girl Honored as 911 Heroes

To honor their courageous actions during an extremely emotional call, Boston EMS EMT Sara Curry and 12-year-old Tanisha Andrade of Hyde Park were awarded the 9-1-1 Medal of Honor and 9-1-1 Heroes Certificate at the Commonwealth of Massachusetts 9-1-1 Heroes Awards® Ceremony recently. The ceremony took place at the Yard House Restaurant in the Fenway neighborhood.

"Our Dispatch staff is the critical link between the public and our field crews every hour of every day. I am extremely proud of EMT Curry and her dedication to doing everything she could to ensure a good outcome for this family," Boston EMS Chief Jim Hooley said. "I am also very impressed with the composure this young girl had in such a frightening situation."

On December 30, 2011, Boston EMS EMT Sara Curry received a 9-1-1 call from a pregnant female in active labor who was attempting to drive herself to the hospital. The caller also had children in the car with her; the oldest was 12-year-old Tanisha. After instructing the patient to pull over and stop, Curry quickly determined the location of the vehicle as well as other information. Then speaking with Tanisha, Curry calmly instructed her how to help her mother deliver the baby. Though Tanisha was obviously scared, Curry maintained a calm and reassuring demeanor. Curry continued to instruct Tanisha until emergency crews arrived.

Saint Nicholas of Flue

Nicholas was born on March 21, 1417, into a prosperous peasant family, in the Swiss Canton of Unterwalden on Lake Lucerne. He is said to have been a conscientious child who at an early age was fond of prayer and practiced mortification. At the age of 21 he entered the army and is thought to have fought in battles near the Etzel in 1439, in the Canton of Zug in 1443 and assisted in the capture of Zürich in 1444. Nicholas fought in the Thurgau war against Archduke Sigismund of Austria in 1460. It was due to his influence that the Dominican Convent St. Katharinental was not destroyed by the Swiss confederates.

At the age of 25, he married a girl from Sachseln, named Dorothy Wyssling, who bore him five sons and five daughters. They farmed in the municipality of



Flüeli in the alpine foothills, above Sachseln on Lake Sarnen. He continued in the military 'till the age of 37, rising to the position of captain; Nicholas was held in high esteem in his canton, and proved to be a capable farmer, military leader, judge and councilor. After living about twenty-five years in wedlock he listened to a powerful inspiration that came to him in a dream, that

he should devote himself entirely to the contemplative life; with the consent of his wife, he left his family on October 16, 1467, to live as a hermit settling at Ranft about an hour's walk from his home in Sachseln where he became known as "Brother

Legend tells us that for nineteen years Nicholas lived without benefit of food or drink, as was established through a careful investigation, made by the civil as well as the ecclesiastical authorities of his time. He wore neither shoes nor hat, and even in winter he dressed merely in a hermit's robe. His reputation for sanctity grew and Nicholas was visited by leaders from all parts of Europe seeking his advice. The enormous influence of Nicholas was demonstrated in 1481 when a dispute broke out between delegates of the Swiss Confederation at the Diet of Stans, creating an imminent threat of civil war. An appeal by Henry Ingrund, pastor of Stans, was made to Nicholas to mediate; he worked through the night and came up with a set of proposals that was agreeable to all sides in the dispute thus saving Switzerland from civil war.

Nicholas is honored among both Protestants and Catholics for having helped create the permanent national unity of Switzerland. He passed away in 1487 surrounded by his family. He was beatified in 1669. After his beatification, the municipality of Sachseln built a church in his honor where his body was interred. He was canonized in 1947 by Pope Pius XII. His feast day is celebrated on March 21 except in Switzerland and Germany where it is September 25. Nicholas is the Patron Saint of Switzerland.



Simple TIMES...

But this particular column is not about my mom. Immediately, I thought of her upon reading about the former Boston Roman Catholic Diocese's Bishop Richard G. Lennon in the Sunday, March 18, edition of the Los Angeles Times.

Remember him? If you don't, please allow me to give you a brief re-introduction. In December 2002, Lennon's pal Cardinal Bernard F. Law got run out of Boston after the growing priest sex abuse scandal revealed he covered up abuse after abuse after abuse by pedophile priests under his thumb throughout his 18-year reign of shame. The entire Boston Catholic community was shocked when Lennon was appointed to replace Law.

Lennon was Law's closest ally. He quickly caused a revolt by the faithful as he asserted his authority to shutter several parishes in Boston. Lennon arbitrarily picked out St. Leonard's parish in the North End. But Boston Catholics tired

of the acerbic Lennon and sent him packing in May 2006.

It is déjà' vu as Bishop Lennon has used his authority to shutter numerous ethnic parishes in Cleveland's Roman Catholic Diocese since 2010. But this time a bombshell tossed by the Vatican court, the Congregation of the Clergy, smacked Lennon in the miter as it ordered 13 of the nearly 50 churches he ordered closed to open anew.

Two years of daily protests outside locked churches, prayer vigils in the face of Lake Erie's biting winter wind, a lawsuit against the Vatican, and flooding Vatican City with letters, the unprecedented decision has deepened the faith of the mostly middle-class parishioners that the power of prayer is working in their lives.

We really will celebrate when we meet inside our church, not on the sidewalk," explained truck driver Wojtek Fleszar, leader of Sunday prayer vigil at the closed St. Casimir, a stronghold for many years in the Polish community. "We have been praying for two years outside the church."

A large parish, St. Patrick, aligned with several other parishes to establish Endangered Catholics, a gamely group that garnered support from public sector organizations in a show of force opposing the diocese's decision to close parishes.

True to character, Lennon initially denied any decision by the Vatican court, but soon after a spokesman claimed he had "not opened his mail." After leaders of three of the closed parishes ordered Lennon to promptly give back property, money, and reopen the churches, he "made no commitment to reopen the churches any-



Freeway Says ...

Due to his increasing popularity and several suggestions from readers (and after much negotiating on our part with his huge salary demands), our friend Freeway has consented to try to answer readers' questions concerning him or any of our little four-legged friends. Freeway says, I am always writing about my pooch friends now it is time for something different. Is your pet bunny too plump? Hay, vegetables, pellets and fruit — rabbits love to eat all four, but do you know how much your pet should be getting of each? Here's how to prevent your bunny from gaining too much weight. They love to eat and they adore sweets and in turn, pet rabbits have a tendency to become overweight bunnies. In fact, obesity is the second most common health issue faced by pet bunnies, after tooth problems. What's more, they often spend a lot of time inactive in cages, so they tend not to burn off the food they eat. This can lead to a number of health problems, including digestive issues, urinary tract problems, a weak heart, and dirty fur. An overweight bunny also can face problems performing an essential part of their diet. Rabbits produce a type of night feces called cerographs, which are rich in protein, vitamins, and minerals, and they need to eat some of these feces to stay healthy. Overweight rabbits cannot reach their rump to eat the cerographs, and they may become malnourished as a result. The Dutch rabbit is one of the most common rabbit breeds in the United States, featuring fur that is often white mixed with brown or black. Some people prefer the smaller dwarf rabbits or lop rabbits, which have ears that hang down rather than standing up. Other pet owners like angora rabbits, which have long hair that is always in need of grooming.

So how can you keep your pet rabbit in shape?

Choose the healthiest rabbit food for your pet. Pet bun-

bit food for your pet. Pet bunnies are vegetarians, so rabbit food should mostly consist of fiber and carbohydrates. When people think about a pet rabbit's diet, they are likely to think mainly of food pellets. However, a diet of just pellets is a sure way to an overweight bunny. In fact, pellets should be used spar-

ingly, as they were originally designed for the growth of meat rabbits. The healthiest diet for a pet rabbit is apportioned this way:

Hay at least 85 percent of a pet rabbit's diet should be a grass hay like timothy, oat or barley. Hay is essential to a rabbit's digestive process, and it also helps their teeth. You can give a rabbit unlimited amounts of hay. Alfalfa hay is also acceptable, but keep in mind that it must be doled out because it has more protein and calories than grassy hays.

Vegetables the second most important rabbit food is fresh leafy greens such as kale, collards, romaine lettuce, mustard greens, beet tops, carrot tops, parsley, endive, and radicchio. You should serve your adult pet bunny about two to four cups of leafy greens daily for every five pounds of body weight. You also can provide smaller amounts of other vegetables like Brussel sprouts, broccoli, green peppers, and pea pods.

Pellets you can supplement your pet rabbit's diet with pellet rabbit food, but you should do so sparingly. An adult bunny only needs one-quarter cup of pellet feed daily for every five pounds of body weight. Be sure to buy pellets with 18–20 percent fiber and between 14–16 percent protein. And don't buy more than six weeks worth at a time because it will go bad.

Fruit (carrots, too) think of fruit as your pet bunny's version of sweets. A bunny will likely eat all the fruit you provide, but will gain weight as a result. Limit fruit to no more than two ounces for every six pounds of body

weight. Because carrots are so high in sugar, you should treat them as a fruit and serve them just as sparingly. How to help your rabbit lose weight.

An overweight bunny must lose weight the same way an overweight person does by eating right and exercising.

Exercise for wild rabbits usually cover a home range of about two acres every day in their hunt for food. Keeping your pet bunny cooped up all day is a surefire route to rabbit obesity. You need to get him out of the cage an hour or two every day and encourage him to run around and play. You also can provide some toys in his crate for him to chew and enjoy.

Diet if your rabbit is obese, you should cut out the pellets and fruit completely. You can also limit the veggies if your bunny doesn't start losing weight. A pet rabbit can live on an all-hay diet for a month or two, if necessary.

Rabbits can become overweight very quickly through a poor diet and sedentary lifestyle. Feed your pet rabbit right and you'll have a happy companion who will be around for years.

I know that any of my readers that has a pet rabbit enjoyed this piece of information. For those that don't — have a carrot on me!!!



to ing new report by the Centers Disease Control and Prevention.



Ten processed foods are responsible for 44 percent of the sodium in our diets, and bread tops the list, likely because we eat more of it than we do recognizable salty snacks like chips. Lunch meats, pizza, and soups also make it easy "to eat a whole bunch of sodium without it seeming salty," Penn State food scientist John Hayes tells the Associated Press. On average, Americans consume 3,300 milligrams of sodium per day -1,000more than what is recommended for most people and more than double what African-Americans, people over the age of 50, and other groups at risk of high blood pressure should ingest. Experts say reading labels to find low-sodium products is crucial. Depending on the brand, a slice of white bread can contain anywhere between 80 and 230 mg of salt, and a cup of canned chicken noodle soup between 100 and 940 mg.

It's the cry of an Italian girl Joni felt her voice was nothing special, because singing was all around her: "Italians — they cook, sing, and make babies."

SHRIMP SCAMPI OVER LINGUINE

Or as Hors d'oeuvres

- 1 pound medium shrimp (cleaned and deveined)
- 5 cloves chopped garlic 3 tbsp margarine or butter
- 2 tbsp olive oil
- 2 tbsp chopped parsley
- 1 bottle clam juice 1/4 cup white wine or sherry
- 1 pound linguine Grated Romano or Parmesan

In a skillet, over low heat, melt margarine or butter and add olive oil. Add chopped garlic. Simmer slowly, careful not to brown garlic. Remove skillet from heat. Slowly add clam juice. Return to heat and add cleaned shrimp. Stir and cover to simmer slowly until all shrimp turn pink (about ten to fifteen minutes). Add wine or sherry and parsley to this broth and cover. Simmer to a boil and then remove from heat. Set aside. Reheat if necessary before serving.

For cooking linguine, follow directions on the package. When pasta is cooked, strain and place pasta in a large serving bowl. Add shrimp broth and stir. Serve linguine in individual bowls topped with shrimp and grated cheese of choice. Place additional broth and shrimp on table for guests.

OPTIONAL: To serve as hors d'oeuvres: Prepare shrimp as mentioned above. Place the prepared Shrimp Scampi in a serving bowl on your table, adding a serving spoon for the guests to help themselves. Also have available plates, forks, and napkins. Garlic bread and/or crackers go well with the hors d'oeuvre.

NOTE: This easy-to-prepare recipe is one of my brother Peter's specialties that became a favorite in my home. In the 1950s and '60s Peter developed great enthusiasm for cooking. That is when I learned to prepare his Shrimp Scampi. I believe Peter and I inherited Mama's eagerness and joy to try new recipes, hoping always to please the appetite of family and friends.

More than half of the 50



Nanna & Babbononno

by John Christoforo

A Nostalgic Remembrance



Babbononno was a master carpenter. Carpentry was one of his two trades when he decided to stay in America. He had learned a bit about construction, but his forte was furniture. He could make anything with hand tools. When he was a boy, most tools were hand tools, as electricity was something brand new. Machines that we take for granted like a lathe that turns out round table legs, he operated with a foot treadle. Saws, planes, files and rulers in his hands were like magic wands, he would wave them and the result would be furniture parts that he would glue together and later finish with a rich brown color and a hand rubbed luster that would allow you to see your face reflecting back.

None of his sons were interested in his day time trade. They all followed his other career path, music. All my uncles became musicians. Two out of the three would play professionally all of their lives. Uncle Paul, the oldest, Uncle Nick (my Godfather), the one in the middle, both learned sax, clarinet and flute. Uncle Gino, the youngest, learned drums, but would give it up in favor of a business career following WWII.

I was the first born grandson, and therefore, the second coming of a god. I spent a lot of time with Babbononno due to the fact that we, as an extended family, lived in one house, today a threedecker on Eutaw Street in East Boston. As far back as I can remember, Babbononno taught me how to use the hand tools that were like artists implements in his possession. Along with this education, I received instructions in reading music the way he was taught, called the solfeggio method. This is the arithmetical articulation of the notes on lines and in spaces as they flow along on a piece of music paper. I would have to sing them and beat them out as if I were conducting an cluding my friends, were orchestra. When we were in transferred to the Central, the cellar, I used the same woodworking tools he used, and by the time I was eight or nine, was pretty good at making things out of wood and understanding the concepts that make up written music.

By the time I hit my teens, the house at 70 Eutaw had long been sold. We all lived

in apartments in East Bosthree-deckers and ton Babbononno was a retired gentleman of leisure. He had hoped, though, that I would follow in his footsteps and take up working with wood for a living. Dad had other ideas. He wanted me to go to college. He had no trouble with me becoming a musician, as he had made a living playing bass violin, tuba and Sousaphone before WWII. When the war began, the big bands were breaking up with most of the musicians going into the service. He knew that he would have to serve, but until he was called, decided to teach school and became a machine shop teacher at East Boston High School, his alma mater. The time frame of teaching allowed him to be able to play music just about every night of the week, and he juggled two careers for the rest of his life.

There's a term I learned as a young man, "Yankee work ethic." It may have been applicable for the Yankees, but to me, I learned the "Italian work ethic." This was just as good, if not better. When I was about nine or ten, I began to wash and wax cars for people in the neighborhood. A year or two later, a couple of the older kids from Eutaw Street began working at both the Seville and Central Theaters in East Boston. As I hit the advanced age of thirteen, I wanted to dress in a uniform and do the same thing. I began hanging around the Seville, helping my neighborhood chums before the theater opened and helping them pick up the seats after a matinee to allow the cleaning ladies to sweep the floors. As a result, I got to know the manager and the assistant manager, both of whom told me that they might have a job for me as soon as there was a vacancy.

It was the middle of the summer of my thirteenth year, and a couple of the ushers at the Seville, inas they were in need of an usher staff. Another of the ushers was selected to be the head usher and was told by the manager to put me on the payroll. It was the middle of August, when I went in one day to help out, I was directed to the usher's room and fitted for a uniform. They needed to fill in the empty

slots and I was the first one picked. Both Mr. Ray, the manager, and Mr. Wall, the assistant manager called the head usher and me into the office and I was told the rules and regulations that accompanied the position. I was also informed that I had to go in town and obtain working papers to keep the job, and just before the meeting concluded, I was informed that my salary was based on the state minimum, fifty-five cents per hour.

I ran home to tell the family about my new position in life. Nanna was delighted and dunked a piece of bread in the gravy she was making, gave it to me to test her mixture and said that she would make sure all of my white shirts would be ready for me when I had to work. Mom told her that I only had one white shirt, but Nanna assured me that I could have a couple that Babbononno didn't wear. At age thirteen, he and I were about the same size. When Babbononno heard the news, he didn't express the joy I felt. He was hoping that I would stay with music and woodworking. He had sort of ignored my car washing business as he couldn't identify with cars ... he hated them and they hated him, but that's a story for another day.

When Dad arrived home, I told him about the job, and his comment was, "I don't know if they will let you work nights, you're too young." It dawned on me, I had to obtain working papers to legally work at the Seville, but you had to be sixteen years old to get them and I was only thirteen. A few days later, I had my work schedule and I was set to go with a royal blue and red uniform, a matching necktie and a Babbononno white shirt. The following day, I headed to downtown Boston, found the Social Security Administration and obtained my first Social Security card. My first day found me under the scrutiny of both the manager and assistant manager. When I finished work that afternoon, they reminded me about my working papers, and I assured them that, on the next day, I would head to the state building in town that issued them.

I didn't know what to do. I was thirteen and had to be sixteen to obtain the necessary documents to stay on the job. I bluffed my way through a couple of weeks, giving every excuse I could come up with as to why I hadn't picked them up yet. Mr. Wall, the assistant manager, kept pushing the subiect and I knew I couldn't con him any longer.

I had a problem that seemed impossible to resolve, but that's a story for another day.

Carolina has rekindled political war over state voter identification laws. While the merits of the suit will surely be hashed out in the political arena, the Supreme Court has in fact weighed in on the constitutional arguments offered by opponents of voter ID laws, and found them wanting.

In light of the issue's prevalence, it is worth revisiting that decision to see what the nation's highest court had to say about voter ID laws.

In the 2008 case Crawford v. Marion County Election Board, the court upheld an Indiana voter ID law, which the National Conference of State Legislatures classifies as one of the strictest in the nation. The law requires voters to present a photo ID at polling places. Those who cannot may cast a provisional ballot, which will only be counted if the voter affirms the ballot in person with a photo ID — within 10 days.

The Supreme Court upheld a decision by the Seventh Circuit Court of Appeals, finding that "showing free photo identification is not a significant increase over the usual voting burdens, and the State's stated interests are sufficient to sustain that minimal burden." It is also worth noting that prior to enacting the voter ID law, Indiana did charge for photo ID's. A provision to the law repealed that fee, presumably to rescind financial barriers to voting. Like Indiana, South Carolina offers free service to state residents.

I have just been advised; Texas in its new photos ID law will also provide voters with free photo service.

The majority opinion, written by then — Justice John Paul Stevens — no conservative stalwart - examined each of the objections offered to this day in opposition to voter ID laws.

The opposition claims that ID laws are burdensome, are have no argument when they consider that states offer free

identification cards to any resident who request one.

Classes of voters, however, those requirements may provide additional burdens. Those include the homeless. indigent, or elderly, and those with religious objections to be photographed. The laws inclusion of provisional ballot exceptions, the court ruled are ample to mitigate those restrictions. "And even assuming that the burden may not be justified as to a few voters," Stevens added, "that conclusion is by no means sufficient to establish petitioners' right to the relief they seek in this litigation" namely, invalidation of the entire law.


Key to the court's decision was the fact that the petitioners had not disputed the state's interest in protecting the integrity of the voting process. Rather, they claimed that the law was a partisan attempt to restrict voters, to the advantage of state Republicans.

In conclusion, the court found the law was spurred by legitimate concern — one that even its opponents could not dispute - and "the precise interests advanced by the State are therefore sufficient to defeat petitioners facial challenge."

This just in, you won't believe that Officials of the NAACP are presenting their case against U.S. voter ID laws, arguing to the international diplomats that the requirements disenfranchise voters and suppress the minority vote.

The United Nations Human Rights Council is investigating the issue of American election laws at its gathering in Geneva, Switzerland. This, despite the fact that some members of the council have only in the past several years allowed women to vote, and one member. Saudi Arabia still bars women from the voting booth completely.

You have to ask yourself, where is the outrage from the Democratic Party and Obama himself?

STUDY MUSIC TO HELP THE BRAIN STAY HEALTHY IN SENIOR YEARS. The many music lessons taken to learn to play piano or the guitar, sometimes under a parents' prodding, and during the early years, are beneficial in later years, not necessarily to join an orchestra. It is primarily to help the brain to stay alert and active in senior years. Researchers have studied 70 healthy adults, between ages 60–83, dividing them into groups based on a level of musical experience. The results have disclosed that those with a better knowledge of music had better success passing cognitive tests, much better than those who had no musical knowledge, reading music or playing an instrument.

Musical activity is a cognitive exercise which coordinates the study while keeping the brain in shape, capable of facing the challenge of old age. The study of an instrument requires years of practice, learning and of creating alternative connections in the brain, which compensate for the cognitive decline as we age. In a test, those who studied music for long periods of time succeeded better than others. Of course, those who never learned music scored very low. In short, the length of musical studies, it was found, turned out to be more important than continuing to play an instrument.





The bus rumbled south through the frozen landscape, carrying its sullen passengers through the darkness of the northern Maine night.

It was mid-January and even though Boston would be snow free in the winter that never was, there was plenty of snow in the northern reaches of the Pine Tree state.

Snow has a way of covering up what you don't want to see — a pristine blanket upon the land — but it can't disguise the thoughts and hurts concerning an experience.

And so, as the bus continued on its five-hour journey toward the Hub, the Boston College men's hockey team certainly had a lot to think about — and a lot of time in which to do it.

For the Eagles had just been beaten twice over the weekend by Maine. And there was no getting around it. Things were beginning to look bleak for the team that had captured the previous two Beanpot Tournaments as well as the last two Hockey East championships.

To start the weekend the Eagles had dropped a 4-3 decision in overtime to the Black Bears. And yes, they had really lost it. Up by a goal with just over five minutes left in the contest, BC had taken a pair of penalties, creating a two-man advantage for the Black Bears that they took full advantage of by scoring to tie the contest. Maine then scored in the overtime session to capture a 4-3 victory.

The next night, despite a hat trick by Barry Almeida, Maine once again upended BC 7-4 to sweep a series from the Eagles for the first time since the 2005-2006 season.

"Sometimes," said Boston College coach Jerry York, "you have to hit rock bottom to make yourself better."

And they did. The darkness of a day — in the predawn hours — always comes before the light. And gradually things began to brighten for the Eagles.

They went on to win the Beanpot, sweeping by Northeastern 7-1 in the opener and then scoring a 3-2 overtime victory against arch rival Boston University in the championship game one week later, a game that missed by a mere six sec-

onds from entering a firstever double overtime in a Beanpot title game.

The wins kept on coming through the rest of February and into March. As they entered the Hockey East semifinals at the Garden the Eagles had won 13 consecutive games. They would leave with the streak at 15, the longest among Division I teams, as they became the first team to win three consecutive Hockey East titles. It was BC's 11th Hockey East crown overall and its fifth in the last six years. It's also the longest BC win streak in the Jerry York era (1994present).

The Eagles put away Providence 4-2 on Friday night and then took out a measure of revenge on Maine in the title game, dispatching the Black Bears as freshman forward Johnny Gaudreau scored twice in just over a two minutes span in the first period while junior goal-tender Parker Milner stopped 41 shots over the course of the contest.

Gaudreau, who had been named MVP of the Beanpot, also came away with the honor at Hockey East, making him the fifth freshman to win the tournament's MVP Award. Three other BC players also won the honor in their freshman season (Brian Leetch in 1979, Scott Legrand in 1990 and Chuck Kobasew in 2001.

"We are continuing to get outstanding play from Johnny up front and from Parker Milner in goal," noted York in the post-game press conference. "They have been two of the reasons why we have been on a run like this. They have stepped up their game."

And York was also reflective thinking back to that five-hour bus ride through the darkness after that long, lost weekend in Maine.

"We got beat on those nights by the success of the Black Bears," he explained. "We had thought we were a much better club than that. We were not firing on all cylinders and our goaltending was a little erratic."

Indeed, at that juncture in the year York was playing three goaltenders. But as he noted "Parker has stepped up major league since that point in the season."
