MassDOT: Boston – Alford Street Bridge

Beginning March 28Th: Two Lanes of Traffic in Each Direction Open **During Peak Commuting Hours**

Some Off-Peak Travel Time Lane Closures Continue for Bridge Deck Maintenance

The Massachusetts Department of Transportation (MassDOT) has announced that crews will re-open all travel lanes on the Alford Street Bridge in Boston beginning on Thursday, March 28th, a month earlier than scheduled, so that there will be two lanes of travel open in each direction during morning and evening peak commuting hours. Crews will continue to implement lane closures during off-peak hours as needed to complete the remaining construction operations.

The bridge was reduced to one lane of travel in each direction in October 2018, and was expected to remain in this configuration 24/7 through the end of April 2019. These impacts have allowed crews to safely and effectively conduct bridge deck replacement operations.

The Alford Street Bridge is a City of Boston owned structure that carries traffic on Route 99 over the Mystic River. This work period was selected with input from key stakeholders including the United States Coast Guard. The Mystic River channel must be closed to marine traffic during bridge deck replacement operations, and marine traffic volumes are lowest during this time frame.

As always, work will be conducted in ways that help minimize the impact on the local community and traveling public. MassDOT encourages the public to be mindful of these traffic impacts. Those traveling through the area should reduce speed and use caution. The schedule for this work is weather dependent and subject to change without notice.

ITALIAN AMERICAN HISTORY THE ITALIANS IN LAWRENCE, MASS

The Bread and Roses Strike

Traveling north towards New Hampshire, it's less than an hour from Boston to Lawrence, Massachusetts.

Aptly called "Immigrant City," Lawrence became home for many different immigrant communities because of the plentiful jobs from its burgeoning textile industry. Miles and miles of textile mills were built in Lawrence. This was the city that produced textiles that clothed the nation and the world. However, in order to keep the wheels moving, the mills depended upon thousands of low-skilled laborers, most immigrants arrived during the great wave of European immigration to America that ended in the 1920s.

In 1890, the foreign-born population in Lawrence had reached 28,577. It was comprised of 7,058 Irish; 6,999 French Canadians; 5,131 English; 2,465 German; and 1,683 English Canadian.

By 1920, thousands of Italians

had arrived as evidenced by the number of the city's social clubs. The Portuguese had 2; the English had 2; the Jews had 3; the Armenians, 5; the Lebanese and Syrians, 6; the Irish, 8; the Polish, 9; the French Canadians and Belgian-French, 14; the Lithuanians, 18; the Germans 4: and the Italians, 32.

Italian immigrants had been attracted to Lawrence by posters all across the regions of southern Italy promoting the city as a place where immigrants could find good work and economic prosperity.

One poster read:

"No one goes hungry in Lawrence. Here all can work, all can eat."

Upon their arrival, however, the thousands of Italian immigrants realized that they had been seriously deceived by the fake posters.

Living conditions were so horrendous that mill workers could expect an average life-span of only 35 years. The work week consisted of 56 hours for \$6.50 a week. Rental for dilapidated housing, which was little more than a cold-water flat, was about \$3 a week. So, families shared rental space. They cooked and slept in shifts. In order to survive, everybody in the family who could work had to work. However, the miserably crowded conditions gave rise to a host of diseases, which accounted for the early death

Working conditions in the mills were extremely unsafe, hours were long, Social Security did not exist at the time, and there was no compensation for work-associated accidents.

It all came to a head on January 12, 1912, when a new law took effect, which reduced the maximum work week from 56 to 54 hours.

However, the textile mill owners were not about to suffer any

CLAY IS A BRICK, OR IS IT?

"And it came to pass as they journeyed from the east, that they found a plain in the land of Shinar; and they dwelt there. And they said one to another, go to, let us make brick and burn them thoroughly. And they had "brick for stone and slime had they for mortar" (Genesis 11:2-3). The plains of Mesopotamia contained hardly any stone. What little there was had high gypsum content and for all practical purposes was soluble in water. When left exposed to the elements it would disintegrate rapidly. The most had to be made of what nature had provided and that was an excellent quality of river clay. These Mesopotamians

were very knowledgeable in the manner of baking brick. Their technique, plus the high quality of the clay, furnished a product which was far superior too much of our modern brick. The major problem was the high cost of their fuel, plus the millions of bricks that were required for the enormous

platforms and the buildings. They were consequently forced to resort to a very simple and expedient method of mixing the clay with straw as a binder, then drying the bricks in the sun and using them unbaked. This reduced their building costs considerably and the buildings remained solid as long as the roof was watertight and the sidewalls were kept in good repair. However, if the structure was neglected for a few years, it would crumble into dust. Mounds of earth now mark the site where splendid palaces once stood.

Abandoned furnishings were also buried in the moist debris, and these too have rotted away and are gone forever.

The ancient inhabitants of these lands were not unlike the Egyptians. In death, they also were surrounded with their precious belongings. They even went so far as to have themselves buried with their chariots, a bodyguard of soldiers, and many,

or all of their wives. Grave robbers were also a problem here as they were in Egypt. They couldn't build pyramids, so they resorted to a system of burial in an immense hole, dug as deep into the ground as the water table permitted. In some cases, these holes were seventy feet deep. After the burial ceremonies were concluded, the ground was leveled off and all tracks of the spot disappeared.

It was later discovered that some of the underground royal tombs were completely rifled. How the robbers ever found the locations is still a mystery today. A few of the richest tombs that have been discovered intact give some idea of the tremendous wealth in gold, silver and jewels that probably still lie beneath the plains of Mesopotamia where many ancient kings will continue to rest in peace for hundreds of years to come (if they can get their wives to stop talking).

financial loss. For starters, they sped up the wheels of production to make up for the lost hours. That was bad enough, but it got worse when they cut the workers' pay by two hours.

The two-hour difference came to thirty-two cents a week, the cost of four loaves of bread.

So, once the deduction appeared in their checks, workers were furious.

It began with the Italians and the Polish who hollered: "Short pay. Everybody out."

And so, the famous "Bread and Roses Strike" began. However, this time Italians led the two-month strike affecting 28,000 strikers who spoke over 45 different languages.

Skilled organizers Joseph Ettor (a 2nd generation Italian American) and Arturo Giovanitti from the Industrial Workers of the World (the IWW), rushed to Lawrence to represent the striking workers. The IWW struck fear into local and state leaders since it was socialist, some would say communist, in its leanings.

At the Mayor's request, the Governor sent in uniformed state militia armed with guns and bayonets to protect the mills and block the striking workers.

(The militia included student volunteers from Harvard.) This resulted in time to time clashes between the armed militia and the Lawrence police on one side and the unarmed strikers on the other side.

Law and order became impossible to maintain. Thousands of angry strikers courted confrontation and defied the militia by daily marches through the streets.

Finally, acting to keep their children out of danger, Italian parents sent 240 children by train from Lawrence to New York City where strangers volunteered to serve as host families. The children were housed, fed, and well-cared for until the strike was over.

However, the sight of these underfed, shabby looking, pitiful Italian children marching through the streets of New York shocked the nation. Newspaper headlines of innocent children moved Congress to hold hearings. The mill owners capitulated, and the strike ended in March of 1912.

The workers won a series of pay increases and better working conditions. And for the first time — Italian immigrants led the way!

L'Anno Bello: A Year in Italian Folklore

Blossoming into April

As April approaches, a whole month of spring and sunshine stands before us. dazzling for our enjoyment. April smells like fresh flowers and the pungent scent of trees after a delicate rainfall, like balmy breezes and juicy strawberries. Soft rains drizzle down outside my window, making the grass seem lush and greener than a mint sprig, the pavement shiny and smooth like obsidian. I am reminded of the old rhyme I cheerfully intoned as a young girl: "April showers bring May flowers!" Indeed, April is the time of the year when spring finally feels in full bloom, when flowers, rain and abundant sunshine meld together to form an energetic, playful month. The purported origin of April's name also reflects its qualities of rejuvenation and rebirth. April may derive from the Latin word aperire, which means "to open." Truly, all of nature is opening and awakening at this point, from the purple tulips peeking out of the dirt to the buds on tree branches and the baby animals walking on wobbly legs. As the Latin origin of the name suggests, April is a significant month in Italy. Not only is it a full month of spring and the frequent home of Easter, but April brims with its own folk traditions, holidays and customs particular to Italy. Italians even start the month in a jovial fashion, surreptitiously pinning paper fishes to each other's backs during pesce d'aprile, or April Fools' Day. The following is a sampling of quirky and

April Proverbs: Italian folklore abounds with multiple proverbs related to months and times of the year. These hearken back to the days when Italian society was primarily based on agriculture. Farmers needed to pay special heed to the weather in order to determine important and vital times like when to plant and what crop yields to expect. As such, most of the Italian proverbs related to April (which I gathered from the wonderful website italvrevisited.org) concern themselves with the weather of the month. One proverb declares: "L'aprile piovoso, fa il maggio grazioso." Translating to "a rainy April makes a grateful May," this is the Italian version of the April showers bring May flowers dictum. Another proverb says

characterize April in Italy:



"Marzo tinge, aprile dipinge" meaning that what March dirties, April cleans up; just as April rains and vegetation takes over the muddy or snowy changeable weather of March. However, another proverb admonishes "Aprile, non ti scoprire." It warns against discarding your coat during April, as there are still cool days left!

Easter (April 21st): Oh, Easter! I love everything about this feast, from its rebirth symbolism to the large family gatherings laden with delectable, seasonal food. Easter is one of the most important holidays in Italy, where it is known as Pasqua. There, people attend Mass in churches decorated with olive branches and flowers, then head home for a banquet featuring Italian Easter delicacies like colomba pasquale (a sweet bread shaped like a dove, sometimes with colorful Easter eggs tucked inside) or pastiera (a pie made with wheat berries, sweetened rice, or ricotta cheese, depending on the region). As a little girl, I knew Easter was approaching when my father brought home a large uovo di cioccolato, or chocolate egg, from a specialty shop in the North End. Waiting to break open the egg and discover the treasures hidden inside served as a wonderful metaphor to the surprise and promise of Easter.

Rome's Birthday (April 21st) and St. Mark's Day (April 25th): Italy is filled with many cityspecific holidays, and two of the most intriguing fall during April. Rome's Birthday honors the founding of the city, all the way back in 753 B.C. Romans celebrate with festivals, parades, concerts, and fireworks displays throughout la cittá eterna (the eternal city). Four days later, the charming maritime city of Venice displays similar gaiety for St. Mark's Day, or la Festa di San Marco, the feast day of Venice's patron saint. Carnivals, markets and

parties center around the enormous St. Mark's Square, the beating heart of the city. Celebrate both holidays by enjoying food from each region. How about a plate of spaghetti alla carbonara (spaghetti with egg sauce) on Rome's Birthday and some risi e bisi, or risotto with peas, on St. Mark's Day?

Liberation Day (April **25**th): This patriotic holiday honors the liberation of Italy from Nazi and fascist occupation during World War II. On

April 25th of 1945, the cities of Turin and Milan were the first to be freed from the occupation, and their liberation prompted a chain of events which culminated in Italy's freedom. Italy celebrates Liberation Day, or Festa della Liberazione, with processions, speeches and countrywide events. My ancestors, including my grandparents, still lived in Italy during the Second World War and had to deal with all the horrors that accompany an armed conflict, from bombings to mob violence to food shortages. As such, I always feel compelled to remind people of this springtime feast, a holiday commemorating the ordinary Italians who fought so hard to free their beautiful land from the terror of fascism.

May Day Eve (April 30th): I love this holiday! Since ancient times. European folklore has attributed the first day of May with magical properties. People believed that elves, fairies and witches were especially active on this day. In Italy, May Day is known as Calendimaggio, and celebrations begin the night before, on the last evening of April. Cities hold festivals and events with a spooky twist, replete with witch decorations and magical themes. Honor this day by taking a walk during dusk and contemplating the wonder and mystery still left in

Sagre: In conclusion, I would like to point out that towns and cities all over Italy hold sagre, or food festivals, throughout the year. They focus on seasonal, local ingredients and the various ways to highlight them in delicious dishes. Most Italian sagre focus on the country's premiere spring vegetable, the artichoke, or carciofo, I absolutely love artichokes and look forward to them every spring. Enjoy artichokes the way Italians do - stuffed in pastas like ravioli or tortellini, fried, or simply marinated in olive oil. Yum!

Collectively, these April celebrations typify the folklore and love of the seasons so often found in Italian culture. When spring finally arrives. everyone is in the mood for a party, and Italians are no different! No matter which April holidays you choose to honor, make sure you do so with love in your heart and optimism for the upcoming spring. That way, all of your days are sure to be filled with joy!



Nine Things Your Dog is Trying to Tell You?



We like to speak to our dogs and ascribe all sorts of emotions to them, but truth be told, they're much simpler beings than humans. Dogs are motivated by the basics: food, activity, and companionship. They tend to behave differently around their owners than when they're interacting with other people or animals. Your dog's behavior around you actually does have meaning behind it. From the desire to protect you to an intuition about your health and happiness, read on to what your dog would tell you if he or she could speak.

Why do dogs lay on your feet? You may think your dog belongs to you, but you also belong to your dog. This means that your fur baby is going to claim you and protect you. When he or she is sitting on your foot, it's an ownership thing. It's not just that he or she wants to be close to you there saying, this is mine; now it smells like me, don't go near it. He or she does this for three main reasons: to feel secure about his or she place in your life, to warn other dogs that your are spoken for and because he or she wants to protect you. To ensure your protection, dogs will also bark at guests, growl at other dogs when outside and pull on the leash while out for a walk. There's a line of thinking that the dog is your scout. He or she sees themselves as a member of the pack, and wants to make sure everything is cool before you get there.

Your dog mimics your mood. Whether it was a stressful day at work or a fight with your significant other, your dog will pick up on how you feel and feel it, too. It goes without saying, when you're stressed, they're more stressed; when you're happier, they're happy. They match up moods with you better than a spouse or a partner. They sit there and study you. This relationship works the other way too: If you want to make your pooch relax, than you know to pet him or her. You can, like a gas pedal, change that dynamic with your dog. A little love goes a long way.

Your pup acts crazy when there's not enough playtime. If she or he is eliminating on the floor, chewing furniture or running circles around the coffee table, your dog is probably trying to tell you she or he needs more activity in their life. That's where we see a lot of behavioral issues with dogs in households. This is particularly true for active breeds, such as herding or hunting dogs. The Dalmatian was trained to be a hunting dog. You can't take an animal that's used to running eight miles a day, put it in an apartment, and expect it to be OK. If your dog's destroying stuff, he or she is saying, I'm bored, you need to give me something to do. While exercise is important dogs should receive 45 to 60 minutes of physical exercise and 15 minutes of behavioral training per day. Make him or her play search and seek games for her food or even use a food puzzles that she or he can solve before her or his meal is dispensed.

Dogs get destructive when

they have separation anxiety. While most dogs are going to bark for a few minutes when you leave the house just to let you know you're forgetting someone some dogs have a much more serious reaction. It's like a kid lost at the mall without his parents. They Freak out. They think you're not coming back. They often attach the area when you leave; they'll tear up the doorframe, they're destructive. If you come home and they've had diarrhea or (are excessively) panting, their cortisol levels to high, and you have to take action. You may have to take your dog to a dog behaviorist to receive a training program and possibly a canine antidepressant. To help assuage the trauma associated with your departure, you can try training intervals. First, put your coat on, grab your keys and go stand outside for 30 seconds. Come back in, and then go out for one minute, then five, and build from there. It's also helpful to give your dog a treat or a toy before you leave to keep him or her distracted.

Some dogs alert you about a health problem. It's a hard phenomenon to explain, but many dogs seem to be able to detect illness in their owners. Some dogs can actually detect a wide array of serious conditions, including seizures related to epilepsy. We know that there's a chemical marker that a few dogs are detecting, just like they can detect bed bugs, mold, peanuts, drugs or explosives. They can smell the ketones on a diabetic's breathe when their sugar is low. For people with epilepsy (about to have a seizure) they can alert their owner so they can get out of harm's way. Some canines are even more naturally empathetic to humans. Often these dogs become therapy dogs, providing affection to those in need, while also sensing and being able to react to health problems. Some people just need a dog to lay still with them; others need a reason to get out of bed. It's the weirdest thing how therapy dogs know when to (move) close or far away.

Dogs act differently when they're sick. It's important to

pay attention to your pooch's behavior because if something seems amiss, he or she probably not feeling well. You want to catch things in the earliest period to prevent unnecessary pain or worse. You just need to pay attention to your intuition. That means noticing behavior that's out of the norm. If he or she is not as playful as usual, acting aggressively, having trouble getting up or isn't eating properly, than he or she could be sick. You want to pay particular attention to eating habits. Food is their currency. If she or he isn't eating enough or is eating too much, if he or she is drinking more water or needs to eliminate more, or if you have a dog that losing weight, then something's wrong.

Your dog follows a routine. Routines help dogs anticipate how their day is going to go, such as when it's time to eat, go to the bathroom, and sleep. Knowing what to expect is really, really important, otherwise they don't know how to react. A general routine is best, but that doesn't mean you have to do everything at the same time each day. In fact, varying the time will actually help in the long run. Otherwise, your dog will start running the show. You don't want them to force how the clock works. If they do, it's likely that your dog will insist on his 5:00 a.m. feeding on a Sunday, when you want to sleep until 8:00 a.m. If you control their food, you control them in a good way.

Dogs respond to tone. Correcting your dog is important to good behavior, and how you do it is key to having them listen to you. Avoid explaining your dog's behavior to him or using a calm voice when reprimanding. Take a firm tone and be direct. Dogs respond to tone. If you say, "No!" While a bad action is happening, you're going to get a much better response than if you say it in a gentle voice or wait to say it afterwards. To ensure results, it has to be said in the moment of action, and in the same way every time. If you want to train your dog to be calm when he sees another dog, you can't wait until that dog has passed to give him a treat for being good. You can't wait until you get home. That says putting down the leash means a treat, instead of the action (you're trying to enforce).

Dogs learn differently than humans. There's no doubt your dog is part of the family but that doesn't mean he or she should be treated like a person. Thinking your dog has the motivation of a person is the number one problem. Whether our dog eliminates in the house or chews up the remote, the cause has nothing to do with revenge. It's not an emotional or rational response. It's either a lack of training, illness or stress reaction that can be triggered by a change in the house. So if your dog is acting out, start by trying to find the root cause. Is she or he is sick, improperly trained or has there been a recent change in routine? Once you locate the cause, understanding and correcting her or his behavior will be much easier.

Saint Kuriakose Elias Chavara

Kuriakose was born on February 10, 1805 at Kainakary, Kerala. He came from an ancient Nasrani Christian family. His parents were Iko Kuriakose and Mariam Thoppil. Kuriakose was baptized on February 17 at St. Joseph's Syro-Malabar Catholic Church, his parents dedicated him to Mary.

From age 5 to 10, he attended the village school to study languages, different dialects, and elementary sciences under the guidance of a Hindu teacher. Desiring to become a priest, he began his studies under the parish priest of the church of St. Joseph. At the age of 13 in 1818, he entered the seminary at Pallipuram where he studied with Father Thomas Palackal who was its rector. Fr. Palackal hoped to establish the Carmelites of Mary Immaculate, which would be the first religious institute in India founded by indigenous people.

A few years after joining the seminary, a major tragedy occurred in Kuriakose's life.

His father, mother, and his only brother died in a small pox epidemic that devastated

his village. Kuriakose, who was just 13 years of age at that time came to know of their deaths three weeks after the incident and was unable to attend their funeral. He was heart- broken. He returned to the seminary and rededicated himself to his studies.

He was ordained a priest on November 29, 1829 and celebrated his first Holy Mass at Chennankari Church. After his ordination, he was engaged for some time in pastoral ministry.

In time, he became co-founder and first prior-general of the Congregation of the Carmelites of Mary Immaculate. The main work of the Congregation is education aiming at the intellectual, social, economic, moral and spiritual advancement of people, especially women and children; it works today in eight countries with almost 5,000 members.

He founded several seminaries, introduced annual retreats for priests and people, started forty-hour adoration, and gave special attention to catechumens. Taking into account the needs of the people of that time, he also established a house for the dying and destitute and schools for general education. It was only because of St. Kuriakose who was appointed the first Vicar General of all the Syro-Malabar Catholics in 1861 that the Church could withstand the many threats to ecclesial unity caused by various schisms.

Kuriakose passed away on January 3, 1871. He was Canonized by Pope Francis on November 23, 2014. The Feast day of Saint Kuriakose Elias Chavara is February 18th.

Call to Artists for Permanent Public Art

At New East Boston Police Station

Mayor Martin J. Walsh and the Mayor's Office of Arts & Culture, in collaboration with the Boston Art Commission and Boston Police Department, recently announced a call to artists to create a permanent piece of public art that complements a new police station in East Boston that was funded through Mayor Walsh's Imagine Boston 2030 Capital Plan.

"Incorporating public art into the construction of this new police station is exciting because it gives us the opportunity to make the building more welcoming, approachable, and reflective of the rich culture in East Boston," said Mayor Walsh. "Through the Percent for Art program, we will continue to make more public art available for people to enjoy all across the City of Boston."

This call to artists is part of the City of Boston's Percent for Art program, announced by Mayor Walsh in 2016, which sets aside one percent of the City's annual capital borrowing as a budget for the commission of public art. The City also has Percent for Art projects underway in Jamaica Plain and Roxbury.

The public art will be placed on the future new Area A-7 Police Station in East Boston, which recently received an investment of \$29 million through the Mayor's capital plan for design and construction of a new 27,505 square foot station that will be situated at the intersection of East Eagle and Condor Streets. The new building will be welcoming to the community, while having a civic presence through public art.


"Any opportunity, be it through police work or art work, that allows the men and women of the BPD to expand their capacity to protect and serve our community members while drawing attention to and highlighting the accessibility of our neighborhood police stations, as well as the approachability of our hard-working police officers is most certainly a project that we want to participate in and fully support," said Police Commissioner William Gross.

Artists are encouraged to consider three key qualities of the East Boston neighborhood in their applications: its deep history within a wide variety of immigrant communities, its geographic location and how that has put it on the front lines of climate change, and its strong neighborhood identity and close-knit community.

"In a changing, diverse, and growing neighborhood like Eastie, public art can bring people together by communicating at several levels to several folks," said Kannan Thiruvengadam, director of Eastie Farm and an East Boston resident. "It can beautify space, make people stop, see, and wonder, and provoke thought and conversation."

The City has identified several potential sites for the artwork, including the entrance lobby, the community room, and three locations outside of the station. The project is expected to take approximately two years to complete.

This call to artists is open to

all artists, artisans, architects, landscape architects, or teams with experience in public art, site responsive design, project management, and construction administration.

"This project is the perfect opportunity to showcase the power public art can have on uniting communities and fostering cross-cultural exchange," said Kara Elliott-Ortega, Chief of Arts and Culture for the City of Boston. "I look forward to seeing how this project helps us reach a new level of creative problem solving and bridge the gap between law enforcement and local residents."

An Artist Selection Committee comprised of representatives from the Boston Art Commission and local arts professionals representing East Boston will review applications using criteria including experience, past work, knowledge of materials and their durability, experience working with multiple stakeholders, and how well the artist/team responds to the goals and community values outlined in the call.

The deadline to apply for the project is Thursday, April 25th at noon EST.

Fuller delivers the menu for this masterpiece with entrees as, Wes Montgomery's "Fried Pies," the jubilation of Stevie Wonder's "Overjoyed," Brown's energetic "Lined With a Groove," a pair of Fuller originals, the pretty "Jane's Theme" and the fast-paced tune "The Mooch." THE BEST OF THE RUNAWAYS (Vinyl) UMe

For the first time in over 36 years, the pioneering rock 'n' roll quintet, The Runaways issue an expanded "Greatest Hits" LP collection on standard black and limited fire engine red vinyl. The Runaways exploded on the rock scene with the idea of an all-female, teenage band playing raging rock 'n' roll. With persistence, the L.A. quintet proved their point with infectious rock 'n' roll anthems that included, "Cherry Bomb," "You Drive Me Wild," "Queens of Noise" and "I Love Playin' with Fire." A new cover photo features the classic Runaways lineup of singer Cherie Currie, guitarists Joan Jett and Lita Ford,

bassist Jackie Fox and drummer Sandy West. The "Baker's Dozen" of cuts has material drawn from Runaways albums — The Runaways, Queens of Noise, and Waitin' for the Night — all released originally on the Mercury Records label. The Runaways created hard-hitting rock 'n' roll with an unmistakably female point of view at a time when the music was largely limited to male performers. In the years since, The Runaways have been acknowledged as musical revolutionaries and cultural innovators, and a key influence and icon for just about every female rocker who followed. These tunes capture The Runaways at their most raucous and uncompromising, combining rousing choruses, pointed lyrics and raw instrumental interplay, and once again demonstrating why their music continues to carry such transcendent rock 'n' roll power.

DAVE ZINNO – UNISPHERE: STORIES TOLD (CD) Whaling City Sound

Bassist Dave Zinno teams up with Mike Tucker (Saxophone), Eric "Benny" Bloom (trumpet & flugelhorn), Tim Ray (piano), and Rafael Barata on drums, to form an ensemble that will give your ears a treat with nine performances. They step off nicely with the sweet breeze of "Neurotico," the melodic groove of "Larrytown," followed by the sexy sax overtones of "The Opener," along with an exquisite cover of Lennon-McCartney's "Michelle" arranged by Ray, and the moving "Requiem" composed by Tucker in his father's memory. Zinno's double bass line open "Ta," showing the power and passion within the ensemble, trailed by the menacing opening notes and dark journey of the ten-minute experience of "Seventh Hour," plus Zinno's original composition titled "Backup," and puts the finishing touches on their exciting album with the closing slice, "Triste," which is a celebration of the group's exciting ideas and collective ability mashed together in a din of percussive, beautiful noise. The last chapter describes "Stories Told" as a melting pot of pure jazz excitement.

NICK GRINDER - FARALLON (CD) Outside In Music

Trombonist Nick Grinder takes his inspiration from the Farallon Islands, west of the Golden Gate Bridge, which provided a backdrop to his youth growing up in the Bay Area, and puts them to music. The initial slice "New and Happy" is filled with intricate counter-melodies, followed by the poignant and memorable "Potential." the explosive "5 Steps" climbs rapidly, along with the moving "Inaction," addressing the killing of Trayvon Martin, and the dark "Belly Up" marks the midpoint. Second half happenings have, "Deciduous," dealing with the culture shock one feels of evergreen differences from West to East, the pensive title track, using "Staged" to evoke the distant beauty of the Islands, and the final strokes to Grinder's masterpiece has Thelonious Monk's classic "Reflections."

A Nostalgic Remembrance



Easter is coming soon, and I have a few interlocking stories that correspond to this time of year. The first story includes Sal Meli, the friend from East Boston that I traveled the world with when we were young and I was single. The other subjects concern Babbononno, who was in his mid 90s when the forthcoming events took place.

It was the spring of 1970 (49 years ago) and Easter was at the end of March that year, on the 29th, I believe. Mom was putting together a list of who would be celebrating with us, and asked me about Sal. Sal's parents had recently retired from their jobs, given up their East Boston apartment and moved back to Sal's father's hometown of Canicati, a suburb of Agrigento, Sicily. Mom asked if Sal might want to spend Easter with us, and when I asked him he said that he would.

This was also a point in time when Babbononno was about 95 or 96 and was a new resident at the Columbus Nursing Home, then located on Saratoga Street in East Boston. He reached a point in his mid 90s when he needed more help or attention than any one person could provide, and so, the decision was made to move him to a nursing home.

After Nanna died, Babbononno lived with us until my folks headed for Belmont. My grandfather was never happy there: nowhere to by DeNobili cigars, nowhere to buy a copy of Il Progresso, nowhere to buy a copy of the Post-Gazette, and no store-front social clubs where he could discuss politics and all things Italian, in Italian. He was lost. Dad, Mom and my uncles found him an apartment back in East Boston near Maverick Square, and within a few days, there was the return of a missing smile on Babbononno's ancient face. He struck up a friendship with an Irish widow who lived next door and as she put it to my mother, "I'll look after Michael." I don't know how they communicated. The woman (I think her name was Maureen) spoke English with a thick Irish brogue, and Babbononno spoke fractured English. Somehow, they understood each other. Babbononno was happy until Maureen passed away and he headed downhill from there. He needed someone to care for him 24/7, and the decision was made, next stop, the Columbus Nursing Home.

Mom made out the guest list for Easter. It included Aunt Mary, my father's sister who had been widowed in the 1960s, her son, my cousin Jim Dello Russo, Babbononno, Uncle Nick and Aunt Dorothy, and Sal Meli.

After the preparations were underway, things went well and Easter week arrived. There wasn't much music for free lance musicians during Lent unless you had a steady job playing at a nightclub, a ballroom, a restaurant or a hotel lounge. This meant that Dad helped Mom get things ready for Easter Sunday. When Easter finally arrived, my job was to pick up Babbononno and Sal Meli. There

was no reason for Sal to drive to Belmont from East Boston, as I had to go to Eastie to pick up Babbononno, anyway. I decided to pick up Sal first, knowing that if I needed help with Babbononno, my grandfather knew him and could communicate in Italian with him if it was necessary. Sal was a bit morose due to his folks moving back to Italy and his latest lady friend breaking off their relationship. Actually, his girlfriend was pushing for a permanent relationship, and Sal wanted to stay single, so off she went. Anyway, I picked him up first and we headed to the nursing home, about five minutes from where he lived. Babbononno was ready and waiting impatiently. When I asked him what was wrong, he complained that he had been ready for hours. When I reminded him that I was to pick him up at 11:00 a.m., he looked at his watch, swore under his breath in Italian and handed me his coat. I helped him put it on, after which he donned his fedora; fixed the brim, looked down at the spit-shine on his shoes adjusted his tie, and was ready to head out. He was dressed with a suit and tie and looked the part of an aging Boston businessman ready to head to work.

Once outside, Babbononno looked around and asked, "Wayza da Cadillac?" I told him that I had traded the car in for a Chrysler, Imperial. He then asked, "Dis new carra is gooda won like da Cadillac?" I told him that it was even better than a Cadillac. He then asked, "Dis Imperiale, itza gudda da top you pusha down"? I answered yes, that it was a convertible, and he came back with, "Den, pusha da top down, pleeza.'

Once the top was down, Babbononno ordered Sal to get in the back seat. He then sat in front ready to ride shotgun, and then asked, "Dis Imperiale gudda da seatza whata go up and downa?" When I said that I could raise or lower the seats, he ordered me to raise his seat up as far as it would go. (Babbononno was only 4' 11" tall; the raised seat made him look a lot taller.)

Once I was ready to drive off, he looked at his watch, and then told me to drive slowly to Orient Heights Square and take a right onto Bennington Street and head toward Day Square. His next command was, "Anna you driva slow." We were soon near Moore Street where St. Mary Star of the Sea Church is located, and he asked me to take a right and stop in front of the church. He had timed our arrival with the end of the Italian Mass. As the old Italian ladies exited the church, Babbononno waved at them, tipped his hat and yelled out, "Buona Pasqua, Buona Pasqua tutti," (Happy Easter, everyone.)

Once we left the area, I had to put the top back up. It was March and still very cold, but I could tell from the actions of my grandfather that he still had that spark in him that made him who he was all his life.

He spent the day sitting at the

dinner table at my folks Belmont house, enjoying the dinner my mother had prepared for Easter, and I knew that spark was still there as the holiday dinner was winding down. When it was time for an after dinner drink, Babbononno asked, "Jenny, you gudda suma Frengia cognac?" I answered that I had a bottle of French cognac hidden away somewhere. He then asked, "You giva me liddle bit?" I said I would and he added, "Widda Frengia Cognac, I needa cigarro Cubano." I obliged him once more, gave him one of my Cuban cigars, cut the tip off and handed it to my smiling grandfather. He dipped the chewing end into the glass of cognac, put it in his mouth and waited for me to light the other end. After I did, he puffed the cigar, sipped the cognac, sat back and sighed as if he was in heaven. This is the memory I have of Babbononno's last year or two on Earth. He made it into his 98th year and then closed his eyes one day and that was it. He's gone, my folks and the rest of the family are gone. Sal deals with the middle stages of dementia and lives in complex that has custodial care for the inhabitants. The Chrysler Imperial, too, is long gone, but the memories of those days' lives on.

Recipes from the Homeland

NONNA MARY'S FISH CAKES

1 lb. of cod or haddock fillet

3 large or 4 small potatoes 1 tablespoon grated Romano

margarine

2 tablespoons chopped parsley 2 1/2 tablespoons butter or

1 four-quart pan Medium-size Teflon skillet 1/4 cup cooking oil

1 egg, beaten

1/4 cup dried bread crumbs (optional)

Peel, cut and wash potatoes. Cover potatoes with water in the four-quart pan and bring to a boil. Boil for fifteen minutes. Meanwhile, remove all skin and bones from fish. Add cleaned fish to boiling potatoes. (If desired, fish may be boiled separately.) Boil fish and potatoes slowly for about ten to twelve minutes. When potatoes and fish are cooked, drain contents in colander for a few minutes. While still warm, place potatoes and fish in a bowl with butter and salt to taste. Add grated Romano cheese, parsley, and beaten egg. Stir and mix well. If mixture is too soft, add some bread crumbs to absorb any extra liquid. Store covered in refrigerator to cool. Mixture is easier to shape into flat fish cakes when

SHAPING: Take a FULL tablespoon of mixture in hand and shape like a flattened meatball. Heat oil in skillet. Fry fish cakes until golden brown. Turn over with spatula to brown on other side. Then remove from skillet and place in paper plate to absorb excess

OPTIONAL: For those who prefer baked food, place the fish cake mixture in a lightly oil-sprayed baking dish. After covering the baking dish with aluminum foil, place it in a preheated 350°F oven to bake for about twenty minutes. Remove cover to lightly brown top before serving. For the first six years of my life, my parents had only one car between them. My father would take it to work early in the morning and we wouldn't see it until evening. They're on the Warpath In Cleveland





VITO ANTUOFERMO

Italian and Italian/American

There has been no shortage of world champion boxers with Italian ancestry. The names Tony DeMarco, Tony Canzoneri, Carmen Basilio, Rocky Marciano, Rocky Graziano, Jake LaMotta, and Marty Servo are just a few who come to mind. Some get overlooked for their Italian lineage because they did not fight under their original names. Fighters such as Johnny Wilson (Giovanni Panica), Sammy Fuller (Sabino Ferullo), Lou Ambers (Luigi Giuseppe D'Ambrosio), and Tippy Larkin (Antonio Pilleteri) are a few who Anglicized their names either to make them easier to pronounce and remember, or so they could draw crowds in areas that were not favorable to Italians.

The list above is just a fraction of the great Italian/American fighters who stepped into the ring over the past century. There have also been a number of native born Italians who have won world championships. Some of these names are not familiar to American fight fans but should be. Others are quite well known. All boxing fans have heard of Primo Carnera and Nino Benvenuti. The names Sandro Mazzinghi, Duilio Loi, Carmelo Bossi, and Bruno Arcari may not ring a bell, but all were world champs, and all were terrific fighters. Another champion, Vito Antuofermo, is well known but I'm not sure if many people know he was born in Italy.

Antuofermo's family immigrated to the United States when he was 17 years old and it was in New York that he began his amateur boxing career. In 1970 he won the New York Golden Gloves in the welterweight division. In 1971 he turned professional and in 29 fights over four years he won 27, lost 1, and had a win draw. He closed out 1974 with a decision win over the great Emile Griffith.

After the victory of Griffith, Antuofermo returned to Italy

where he still held citizenship. While there he continued his career and went on to win the European Super Welterweight Title from Eckhard Dagge in 1976. After losing the European title to Maurice Hope later that year he returned to the United States where he began campaigning as a middleweight.


With eight straight victories including wins over Bennie Briscoe, Eugene Hart, Mike Nixon, and Wille Warren, Antuofermo earned a shot at champion Hugo Corro. He would return to Europe to face the champion and the fight took place in Monaco. Antuofermo

banged out a close decision victory and came back to America with the title.

Antuofermo would make his first defense against Marvelous Marvin Hagler in Las Vegas, and in a close fight the decision was announced as a draw, meaning the champion retained the title.

Marvin was not given an immediate rematch and Antuofermo instead took on British Champion Alan Minter. The fight, also held in Las Vegas, was another very close affair only this time the challenger was given the decision. In a rematch three months later Minter won when Antuofermo could not continue because of cuts.

Antuofermo would get one last shot at the championship in 1981 when he again fought Marvelous Marvin Hagler in Boston. In this bout he was cut early and the fight ended with Hagler's hand raised in victory at the end of the fourth round.

After the fight with Hagler, Antuofermo would not step into the ring again until 1984. He fought just five more times, winning four and then retiring after being stopped by Matthew Hilton.

Antuofermo ended his career with a record of 50 wins (21 by KO), 7 losses (5 by KO), and 2 draws. After retiring he worked in movies and on television. He had parts in *Goodfellas* and *The Godfather Part III*, as well as in the TV series *The Sopranos*. Antuofermo now lives in Long Island, NY and runs a landscaping business.

Antuofermo holds wins over five world champions and always fought with the heart of a lion. Four out of his five losses were due to cuts, and if not for that there is no knowing how far he would have gone.

They entered and waited in anticipation, the media members who had gathered in the postgame press conference room at the TD Garden following the Celtics game against the San Antonio Spurs.

It had been another one of those nights where the team that was the pre-season pick to be a top contender in the Eastern Conference (and thus have a pretty good shot at gaining the NBA Finals) had fallen short once again. This time the 115-96 result had stretched the losing streak to four games, not exactly the type of showing a club wants to have as the start of the playoffs looms ahead.

Indeed, with just a handful of games to go in the regular season, there wasn't optimism in Celtics Nation but questioning and uncertainty.

Yes, the Celtics would make the playoffs but not in the powerful, demonstrative way that had been foretold with elation way back in October.

No, this team of Green and White hoopsters will most likely finish fifth in the Eastern Conference, meaning that there will be no home court advantage in the first round of the playoffs and that a decisive game 7, should the proceedings come to that, would be played on an opponent's court hundreds of miles away from Causeway Street.

And thus, the members of the media waited. And waited. Finally, after about 20 minutes had gone by, Brad Stevens entered the confines of the room, the doors were shut to the outside world, and the coach's second somewhat extended meeting of the night commenced.

The first, of course, had just concluded down the hall in the Celtics locker room, one that perhaps was the longest of the season following a home game.

In fact, the first question of the press conference dealt with that fact, a reporter asking what essentially had taken place in that special place that is walled off to everyone for a period of time following the conclusion of a home game.

You should know that many players (both former and current) feel very highly about Stevens as a coach — and as a human being. Kelly Olynyk, now playing for the Miami Heat, definitely feels that way. Isaiah Thomas, now with the Denver Nuggets, has indicated that Stevens is the best coach he has ever had.

So, how did Stevens begin to answer that first question? He said two of the most important words we've ever heard a coach say. Not words said in the middle or towards the end — but at the start.

His first words were "I listened." Those words set Stevens apart from a lot of coaches in the land. Just that fact separated him from so many of his counterparts — "I listened."

He also stated that he talked. And yes, he said there was emotion in the room. "There was a lot of frustration in there but we got beat by a good team (the Spurs won their 43rd game of the season). "But ultimately, we don't need to ride an emotional roller coaster. We need to get a lot better."

And he indicated what will be needed for the Celtics to forge a path of success in the playoffs. "We've given up 115 or more points in a lot of games recently. Our defense has to improve dramatically if we're going to make a push to ultimately get what we want out of the next couple of months."

Stevens even admitted that the team was better as a defensive unit much earlier in the season than it is in the closing days of the regular season — something that must be improved for victories to come their way in the playoffs.

"You know, we were a better defensive team in the first two months of the season than we've played at any time in the last month." And, in Stevens 'mind, improvement does not show in just isolated games. "It's about how well we do it every single night. That's what we have to get back to. We're getting exposed by good teams. At the end of the day we have to do better for the full 48 minutes defensively."

Stevens indicated that good defense is a key part of success, even in the pros where scoring can be prolific. "I don't want us to be a team — I've never been part of a team — one that was solely reliant on whether you make shots or not. Right now, that's our deal. We're just relying on whether we make shots. Instead, we have to be a buckle down team that gets stops and finds a way to win. And we need to play to that every night."

In his own way, Stevens admitted that the team was going through a tough stretch, that it was not the team of October possibilities but of late March realities.

"It all shows when things are tough. It's not just about riding the wave of the good times and the praise and the pats on the back. It's about buckling down when things are hard and getting back up off the mat, writing your own ending and doing everything you can to be the best you can when it's all on the line. You hope that these are all things we can take with us. I think ultimately we'll see how the rest of this story plays itself out."

A step in the right direction was taken a few nights later when the Celtics defeated the lowly Cleveland Cavaliers, 116-106, on the road. It wasn't a spectacular victory but as they say in the NBA, a win is a win, is a win.

The Celtics will be the authors of their own final chapters this spring. Whether that conclusion will be compelling, uplifting, disappointing, or frustrating only time will tell.
