# Biden Hits Bottom of Barrel

Joe Biden has dismal underwater approval ratings clearly based on deep discontent with rising inflation and a souring economy. He has given Republicans great hope going into the 2022 midterms in which the GOP hopes to retake both Houses in Congress.

His approval rating has fallen to 37 percent with 55 percent disapproval down 4 percent since November and 15<sup>th</sup> percent since last April, according to an *ABC News/Washington Post* poll.

According to the poll, if the election were held today, 49 percent of registered voters would vote for a GOP House candidate, compared to only 42 percent of Democrats

Going back to Harry Truman, only Donald Trump at 36 percent had a lower approval rating. Gerry Ford tied Biden at 37 percent.

# CPAC Picks Trump in 2024

Former President Donald Trump was the overwhelming favorite for the 2024 GOP nomination, according to a straw poll. Trump received 59 percent in the straw poll with Gov. Ron DeSantis who received 31 percent. Back in July 2021, Trump received 70 percent to DeSantis at 21 percent. CPAC attendees seem to think, if Trump wins the nomination, he will face 2016 opponent Hillary Clinton.

According to Miranda Devine at the *New York Post*, "Donald Trump gave his strongest hint yet at a speech to CPAC conservatives Saturday (Feb. 26<sup>th</sup>) that he plans to run for president in 2024." ... We did it twice and we'll do it again," Trump said. "We're going to be doing it again, a third time."

# **Boston to Lift Public Indoor Mask Order**

Effective Saturday, March 5, 2022

Masking is Still Recommended to Minimize the Spread of COVID-19 and for Those with Heightened Risk Factors

Citing improving COVID-19 metrics in Boston, Mayor Michelle Wu and Dr. Bisola Ojikutu, Commissioner of Public Health and Executive Director of the Boston Public Health Commission, announced that the City's indoor masking mandate will be lifted effective Saturday, March 5, 2022. At a meeting held March 1st, the City's Board of Health voted unanimously to endorse the recommendation from Dr. Ojikutu to rescind the order. The decision was made based on key COVID-19 metrics, which show continued improvement in the prevalence and severity of the COVID-19 pandemic in Boston.

Beginning this Saturday, residents and visitors to Boston will no longer be required by the City to wear a face covering in indoor public spaces, such as gyms, bars and restaurants, museums, and entertainment venues. Individual operators may still choose to require masking. Public transportation, health care settings, and congregant care settings are still subject to state and federal mask orders. The Boston Public Schools will continue to require masking while BPHC and BPS leaders monitor metrics including school positivity and vaccination rates following last week's school vacation. The Board of Health will hear additional updates on COVID-19 and school masking at its next regularly scheduled meeting on Wednesday, March 9<sup>th</sup>.

The masking requirement will be lifted at City buildings including for City employees, except for Boston Public Schools and Boston Public Health Commission. Masks are recommended in city buildings where vulnerable populations are served, such as Boston Public Library branches and BCYF community centers.

"I'm grateful that our city is ready to take this step in our recovery thanks to the hard work and commitment of residents keeping our communities safe over many, many months," said Mayor Michelle Wu. "As we continue to make progress even while living with COVID, Boston will continue leading on public health to keep our communities safe, healthy, and prepared."

"Based on the data we've seen over the past weeks, we can remove some of the prevention and mitigation strategies that have been necessary to protect residents," Commissioner of Public Health and Executive Director of the Boston Public Health Commission Dr. Bisola Ojikutu said. "I am optimistic

about where our city is headed, and the Commission will continue to monitor our key metrics and adjust our policies accordingly."

"Mayor Wu and Dr. Ojikutu have guided our City through the latest surge with steady hands and thoughtful, informed public health decisions," said Manny Lopes, Chair of the Boston Board of Health. "Based on the data BPHC has presented, we feel confident in the recommendation to lift the masking order."

While masks are no longer mandated in certain indoor settings, the Boston Public Health Commission recommends masking in these settings if you are at high risk for severe illness or if you will be around individuals who are. There are many people in Boston who are vulnerable to COVID-19, including individuals who are immunocompromised, seniors, and those who are unvaccinated, including young children. Wearing a wellfitting mask or respirator while indoors minimizes your risk of getting infected with COVID-19 and spreading it to others. Because masking offers a first line of defense when there is

# Subway Service Changes:

Effective Monday, March 21, 2022, the Union Square Branch of the Green Line Extension

(GLX) opened to MBTA riders. Union Square Station will join the Green Line, and Lechmere and Science Park/West End Stations, which were closed during construction, will reopen.

Effective Monday, March 14, 2022, Green Line weekday schedules will shift throughout the day with the Green Line C branch adding one weekday trip.

There will be no schedule changes on the Red, Orange, and Blue Lines.

Complete subway service schedules will be posted in early March.

# Bus Service Changes:

The MBTA continues an aggressive hiring campaign for bus operators. While this hiring campaign takes place, bus service changes continue to be made with special focus on maintaining service levels on routes with durable ridership, increasing service on the



# AT HOME IN OLD ROME — NERO'S GOLDEN HOUSE

Nero Claudius Caesar Drusus Germanicus, emperor of Rome from 54 to 69 A.D., earned in his short life (he died at the age of thirty-one) a richly deserved reputation as one of the most cruel, depraved, and despotic emperors that ever ruled Rome. We have all heard the expression "Nero fiddled while Rome burned." This may or may not be true, but it seems to sum up the heartless cruelty of this ruthless tyrant.

His mother, Agrippina, married Claudius, her own uncle, and later poisoned him in order to clear Nero's path to the throne. After becoming emperor, Nero caused the poisoning death of Brittannicus, the son of Claudius. Nero also caused his own mother to be murdered in order to please his mistress, Poppaea Seaina. He divorced his wife Octavia and later had her put to death. He married Poppaea and during a subsequent fit of rage, kicked her to death. He then offered to marry Antonia, the daughter of Claudius, but she refused and he put her to death. He finally married Statilia Messalina after putting her husband to death. He is also held responsible for the death of Saints Peter and Paul. There is at least one television comedian who would probably say "now there's a wild and crazy guy."

Nero might have held the Christians responsible for the Roman conflagration of 64 A.D., but history places the responsibility directly upon him. It is said that the great fire was the changed if this cruel and evil only way that he could have man had never walked on the completed a wholesale eviction of hundreds of thousands of residents in order to clear

golden house.

As an interesting contrast to the ruthlessness of Nero, we note the compassion of the Emperor Augustus who, less than one hundred years earlier, sacrificed part of the design of his Forum because of his respect for the right of one property owner who refused to sell out.

This memorable conflagration during Nero's reign started near the Circus Maximus and then, driven by a hot, oppressive, dust-laden wind from the Libyan Desert called a "sirocco," it swept through the valley between the Palatine and Caelian Hills. The fire was finally stopped six days later at the Esqualine Hill. More than a hundred thousand homeless Romans were transferred to the Gardens of Agrippina, Hero's inherited property on the other side of the Tiber, where just by chance a great number of tents and small one room sheds were ready and waiting to receive the homeless.

Nero then had all of the land he needed for his planned palace and a lot more to spare. He rebuilt this spare area in strict accordance with a new building code which specified fireproof materials and height restrictions. Some say that the reconstruction was a great benefit to Rome, but is this justification for the countless numbers of Christians who were blamed for the fire, and then mercilessly persecuted because of it? Oh, how history would have been face of the earth.

The first architects ever to be mentioned by name in the the land for the erection of his history of Rome were Celer and Severous. They poured the emperor's wealth and their skills into the construction of what became known as Nero's Golden House. It occupied the space of nearly one square mile in the midst of the city.

This was not a continuous building that occupied three hilltops and the connecting grounds; the entire area was enclosed by three colonnades, each about a mile long, and there also was a grand entrance portico, which faced the Forum. Within this enclosure, they built the imperial residence. The area contained beautiful parks, gardens and vineyards, including large baths which were supplied with water, via aqueduct, from sulfur springs about twelve miles away, and special baths which were supplied with sea water from the Mediterranean. There was also a temple built of a rare translucent stone and a lake for mock naval battles.

The foundation walls and other sub-structures are all that remain of Nero's Palace, but it is certain that it contained every adornment and decoration that this abundant and artistic civilization could furnish. The name Golden House was used because of the gold-plated tiles on the roofs. Much gold was also used in cornices, moldings, column bases and caps. There were ivory wall panels, easel paintings, statues, countless vases of every size and form, and a display of wealth and comfort almost beyond description.

Here again we learn of another of the great ironies in history; one of the most brutal men the world has ever known was permitted to occupy one of the most luxurious living places that the same world has ever produced.

# Rosemarie E. Sansone

Whose Life's Work Was the Betterment of Boston

May She Rest in Peace

Rosemarie E. Sansone had a warm and winning way with people, and she put that gift to work for the benefit of the City of Boston during a career that encompassed public service, community affairs and business. Each step along her progression from roles in political organization, advertising, city politics, cultural affairs and university administration was brought to bear as she led the successful transformation of downtown Boston into one of the city's most vibrant districts.

Sansone died of cancer at home in Lexington, Mass., on February, 21, 2022.

Sansone was president and CEO of the Downtown Boston Business Improvement District, or BID, until her retirement on February 15, 2022, her 77th birthday. She had served on the board and later led the Downtown Crossing Partnership, the BID's predecessor organization. In that role she steered the successful campaign to establish Boston's first business improvement district, which runs from the Financial District through Downtown Crossing and into the Theater District. The BID celebrated its 10th anniversary in 2020, and, under Sansone's leadership, it has transformed downtown Boston. Perhaps the most obvious visual cue for the BID's success would be the contrast between the gaping hole at the former Filene's site when the 2008 recession halted a development project there and the vibrant scene at Summer and Winter Streets today.

Sansone's vivacious spirit — evident in her voice and eyes as she connected with family, friends and colleagues - served her well as she worked on behalf of the city and its people. She was able to convene and unify people in pursuit of the common good.

"Whether in her role as Boston city councilor at large or her nearly 12 years as president at Downtown Boston BID, Rosemarie was a trailblazer who never let anything stand in the way of bringing people together," said U.S. Secretary of Labor Martin J. Walsh, former mayor of Boston. "Her steadfast leadership paved the way for an innovative and vibrant downtown Boston that generations to come will be able to explore and enjoy. It was a privilege to call Rosemarie a friend."

Sansone went straight into politics after graduating from Lexington High School, working first with then Lt. Gov. Francis X. Bellotti in 1964 and later getting involved in Kevin H. White's 1970 gubernatorial campaign. In 1976, after working for several years in advertising, Sansone became director of the successful campaign to pass the Equal Rights Amendment in Massachusetts.

At a time when few women held elective office, Sansone was elected in 1977 to the Boston City Council, which at the time was a nine-member citywide body. She was the third woman elected to the Council and the only woman councilor for much of her two terms in office.

"She was definitely a path breaker in terms of women in Boston politics," said Carol Hardy-Fanta, senior fellow at the McCormack Graduate School, UMass Boston. "We have recently become a bit blasé about women on Boston City Council — including the accomplishments of Ayanna Pressley and Michelle Wu — but let's not forget women like Rosemarie Sansone, who ran and won a seat twice on the City Council in the late 1970s when there was even less support for women in what was definitely a 'man's world.""

Then Councilor Sansone, who wanted to expand opportunities for people interested in municipal service, formed the Committee for Change, which led to an expanded City Council with nine district representatives and four at-large members. She felt that the new configuration would give Boston's neighborhoods a stronger voice in City Hall and make it easier and less expensive for neighborhood-based candidates to seek office. Sansone did not run for a third term.

"Rosemarie was a dear friend, mentor and colleague whose friendship, advice and loyalty were a lifelong blessing," said former District 1 City Councilor Diane Modica of East Boston. "Her leadership at the helm of the Committee for Change established Boston District City Council seats and subsequently gave me the wonderful opportunity to serve on the Council." Modica, an attorney who served as Commissioner of Consumer



Affairs and Licensing in the Flynn administration, also worked with Sansone to bring the acclaimed Concerts on the Common to Boston in the 1980s.

Mayor Ray Flynn invited Sansone to join his administration as director of the Mayor's Office of Business and Cultural Development, where she played a pivotal role in attracting businesses, tourism and conventions to the city.

"Rosemarie leaves her mark in every Boston neighborhood," said Flynn, who later served as ambassador to the Vatican. "She worked closely with community activists to offer family-friendly

neighborhood events, and she expanded the international Sister Cities Program, encouraging residents of paired cities to visit and learn from one another. Her vision for revitalizing Boston's downtown business district — initially during her time at City Hall and later as the BID's leader — led to the area's transformation into a national model. And through her efforts the once-notorious Combat Zone was made over into a thriving center for commerce and culture."

In 1994, she joined Suffolk University as director of public affairs, with responsibilities that included collaborating with public- and private-sector partners on downtown's ongoing revitalization.

"Rosemarie brought both professionalism and fun to her role at Suffolk," said Professor Robert J. Allison, chair, of the University's Department of History, Language, & Global Culture, who noted that Sansone was the driving force behind the yearlong celebration of Suffolk's 2006 centennial. "I was fortunate to have met her early in my career and have had her example of honesty, integrity, candor and good humor as virtues to emulate. Rosemarie was one of those rare people who told you what she thought, but also asked you what you thought."

Sansone transitioned from Suffolk University to the Downtown Crossing Partnership in 2007.

"The city of Boston was her life, and Rosemarie was constantly making it better from her time as a city councilor to that of a downtown leader," said BID board member Margaret Ings, vice president for Government and Community Relations at Emerson College. "She had a unique ability to bring people together. She was empathetic and committed, not only to the BID and its members, but to everything going on downtown. She got up each day to serve this city, and, because of her personality and infectious energy, Rosemarie more than deserves the title of 'the Heart of Boston.'"

Sansone studied liberal arts at Suffolk University and earned a master's degree in Education from the Harvard Graduate School of Education. She received an honorary doctor of fine arts degree from the Art Institute of Boston. For her significant contributions to Boston's built environment, Sansone was honored with a Norman B. Leventhal Excellence in City Building award in 2019.

She has served on many boards, including Revolution 250, which commemorates the anniversaries of significant events that led to the outbreak of the American Revolution; the Greater Boston Convention and Visitors Bureau; and the Economic Development Industrial Board. In 2013-14 she served on Mayor Martin J. Walsh's transition team, and in 2016 she cochaired the commission that oversaw the creation of the Raymond L. Flynn Marine Park in Boston's Seaport.

While she was dedicated to her professional activities, Sansone also was an artist who worked in watercolor and printmaking. In recent years she realized her artistic calling was in fabric arts and quilt-making, and many friends' and colleagues' homes are graced with her vibrant pieces.

She also enjoyed travel and visited Italy, where her mother was born, dozens of times on her own and as a representative of Boston. New York City was another favorite and frequent destination.

Sansone was the daughter of the late Stephen J. and Rose M. (Picciarelli) Sansone and the sister of the late Michael S. Sansone. In addition to her life partner, David Lancaster of Lexington, Sansone leaves a circle of very close friends.

Her death resulted from a rare clear cell endometrial carcinoma.

Funeral services were private. Interment was at Westview Cemetery, Lexington.

# L'Anno Bello: A Year in Italian Folklore

Lent, a Season of Reflection

We find ourselves at the start of the changeable month of March, and spring seems palpably in our grasp. Sparkling shamrocks and mischievous leprechauns adorn doorways and windows across my town, reminding me of the upcoming St. Patrick's Day festivities. Robins herald the arrival of a new season with their blazing red breasts as they hop about on the slowly budding tree branches. Crocuses and daffodils begin to wink from newlychurned dirt. However, though the signs of spring prove plentiful, other aspects of nature tell us that we are still in a period of transition, when the weather remains as unpredictable as the March winds. Clumps of old snow, stubborn to melt, may cling to the ground under trees or on the edges of parking lots, while an occasional slategray sky threatens additional wintry weather. Bursts of frigid air still send us scrambling for heavy coats, scarves and gloves. In supermarkets, agricultural produce comes to a virtual standstill, as the lemons and oranges of winter dwindle before they can be replaced by the tender greens and herbs of spring. During this time of the year, when winter reluctantly yields its hold on spring, folk customs around the world honor the changing of the seasons. For example, we are now in the period of Lent, an interval which boasts profound religious significance but also cultural and seasonal importance. Lent mirrors the changes occurring in the natural world and guides us towards spring with a sense of promise, hope and renewal.

This year, Lent began on

covers a 40-day period prior to Easter, the most important feast in the Christian calendar. These days serve to prepare the faithful for Easter through purification rituals such as prayer, fasting, charity and self-reflection. The timing of Lent is highly symbolic, as it occurs during a seemingly barren season in which nature also purifies herself after a long winter, emerging ready for the rebirth of spring. In order to appreciate the glory of Easter and spring, we need to embrace the seasonal transition with contemplation and introspection, an opportunity which Lent generously affords us. When my father was a child in Italy, Lent, or la Quaresima, functioned as a somber and austere period, matching the chill sterility of nature. Though the rules have relaxed since then, the rite of purification remains the crux of Lenten customs in Italy and beyond. This explains the popular practice of giving up a bad habit or an indulgence for Lent, a tradition which is not mentioned in the Bible but nevertheless fits seamlessly with the folkloric cleansing rituals of the season. The purpose of this Lenten abstinence should not be deprivation, but rather a chance to examine our values or priorities and improve ourselves. This Lent, for example, I gave up my browsing some of my favorite websites, in order that I may break my Smartphone habit and spend more mindful time with my family. The promise of Lent, however, stands in the fact that all of our hard work will be rewarded with a beautiful springtime. After all, the English term for Lent March 2<sup>nd</sup>, Ash Wednesday. It shares the same root with the

word lengthen, referring to the growth of daylight in the spring sky!

goodbye to your favorite treat, though. In Italy, this meditative time inspired the creation of unique folk traditions and customs that would come to define the tapestry of pre-Easter celebrations. The most famous Lenten rule involves the forbidding of meat on Fridays; as such, ingenious Italian cooks devised many fish and vegetable dishes for these days. A visitor to Italy during Lent will notice farmers' markets bursting with fresh fish and baccalá (dried cod), along with the first spring vegetables, from which can be crafted a nourishing minestrone. Italians also snack on quaresimali, or almond biscuits, which, as the name suggests, are made especially for Lent. According to the author Helen Barolini in her book Festa, a simple and customary Italian Lenten dessert is pizza fritta, fried dough sprinkled with sugar. My mother and grandmother would frequently whip up this dessert when I was younger, much to my pleasure, though I only recently learned of its Lenten connotations. The people in Italy also celebrate the fourth Sunday of Lent as Mezza Quaresima, or mid-Lent. These festivities mark the halfway point of Lent and honor the imminent arrival of Easter, and many Italian towns and cities hold parties and processions reminiscent of Carnival. Of course, due to the self-reflection and sacrifice that accompanies Lent, it is important to remember that giving is just as powerful as abstaining. People in Italy and around the world commemorate Lent with charity and community service, and truly there is no better way to spread the light of spring than by helping others. Though the checkered March

weather makes it appear as if winter will never quite lose its grasp on spring, holidays like Lent skillfully guide us in managing this transition and welcoming a new season. Now that the luxurious chocolates of St. Valentine's Day and the raucous Mardi Gras decorations are swept away, the time proves right for purification and introspection. The rites of Lent, replete with their emphasis on self-improvement and reflection, echo the regeneration of nature as the vernal equinox, and later Easter, approach. Lent is a time to do good deeds, to ruminate on the successes and challenges of the past year, and to cleanse yourself of negative emotions and distractions prior to triumph and rejuvenation of spring. Significantly, Lent is a season of hope—hope for the promise of Easter, hope for the return of the spring sun. Nature will reawaken, the sun will resplendently shine, and the wheel of the year will roll on, carrying with us through life's treasures.

A society separated by the oppressed and oppressors means a segment of that society always being a victim. Who wants to always see themselves as helpless?

The last thing society needs is an educational program that begins with stereotypes of its own about children regardless of race and culture. Children already have natural equity as they look at each other and take each other as a classroom full of children excited about

I found two quotes years ago that have served me well. All of us might be much better off remembering these two quotes. The first is by Dr. King, "Our lives begin to end the day we become silent about things that matter," and the second quote, "We may encounter many defeats, but we must not be defeated," by Maya Angelou.

We must all be more than anti-racist, we must be antiracist. We just can't be anti-racist. We must be antiracist, always standing up and speaking out for equality in our humanism.



A Nostalgic Remembrance



I recently received a phone call from a dear friend in New York. Back in the day, she, Sal Meli and I were part of a dance crowd that patronized the Latin clubs in New York City. When I say, "Back in the day," I mean when we were in our '20s. If I wasn't playing with a band on a particular weekend, Sal and I would head for New York to dance.

Dolores, the lady friend I mentioned, could mambo all night and was Sal's dancing partner. When she called, she sounded depressed. I thought it was due to our status as old timers and that her health wasn't that good, something I was already aware of. Her conversation concerned Sal. She told me that she had called him and he didn't know who she was, and terminated the conversation. I was aware of the fact that Sal is dealing with dementia, a mental state that has caused him to now reside in a nursing home.

When my conversation with Dolores ended, I called Sal's sister, Maria, and asked whether her brother's condition had deteriorated. She sadly revealed that Sal no longer knows who she is, and is in complete custodial care. Her comments included his overall condition: "Physically, he's as healthy as a horse, but mentally, he's lost it."

Later, I began reminiscing about the old days. Beginning in my early '20s, Sal was my best friend. I met him one summer's day at the handball court then located at Shay's Beach (now Constitution Beach) in East Boston. We hit it off right away, and on that forth coming weekend, headed for the Newport Jazz Festival which was in its infancy back then.

As time progressed, I joined him as part of the Cave crowd. In the '60s, the Cave was the only Latin American night club in Boston and the best cha cha and mambo dancers frequented the club on certain nights of the week. We soon

half Italian girl from Boston who wandered into the Cave one night and wound up dancing with Sal. They became an item and planned to get married a few months later. For whatever reason, things fell apart, the engagement ended and the wedding was cancelled. Sal never got over it and he never became serious with anyone again. Every time he and a lady friend got too close, he backed away ... just in case.

When I met Loretta and we decided to get married a year later, I asked Sal to be my best man and he agreed. Seeing Loretta was from the North End, we were married at St. Leonard's in July of 1977, and Sal was by my side. Whomever he was dating from that point on, was always welcome at our home, but he never seemed ready to attempt another commitment. When our son, John was born, Sal was the proud Godfather.

The friendship continued until my sons, John and Michael were adults, and after that, Sal seemed to drift away. When I spoke to his sister about the situation, she told me that he was becoming something of a recluse as time went on. I was involved with so many things that I didn't have much time to socialize and called Sal only when I was passing through East Boston and allowed myself enough time for a cup of coffee with him. Each time, he seemed more and more out of sinc with things. I later discovered that his sister found him passed out on his kitchen floor one day and had him hospitalized. After that romantic episode I mentioned above, he never got serious again and has remained a confirmed bachelor.

As I mentioned in my first paragraph, our old friend from New York called. At Christmas time Dolores and I usually call each other and talk about our children, grand children and the old days dancing the pounds away at New York's Latin clubs. This time, the entire conversation was about the person we knew as Sal Meli.

All I can say is, "Think young and stay healthy."



Abstinence from meat on Fridays, as well as Wednesdays for some, is a Canon Law that many of the older Italian Roman Catholics abide by on a year round basis. While the newer generation tends to preserve the tradition by "abstinence from meat" only on Fridays during the Lenten season which starts on Ash Wednesday and ends on Easter Sunday. During this time, many families, as well as restaurants, create some absolutely fabulous "Meatless Friday" dishes, many of which you'll find are rooted in old world tradition!

Having been raised in a Sicilian family that followed the old rules of the Roman Catholic Church, in our home, meat was never eaten on Wednesdays or Fridays. As a result, we ate a lot of "meatless" dishes and most were absolutely amazing! One of my favorite was a dish my Nonna used to refer to as "Elbows and Peas". It was made by simply sautéing shallots (and pancetta when made on a day meat is allowed) in olive oil, adding fresh peas, mixing in elbow pasta, and topping with a generous amount of parmesan cheese and sprinkling of red pepper flakes, to taste. "Gomiti e Piselli della Nonna" is a peasant style Meatless Friday dish that is sure to please the adults and children at your table alike!

## **NONNA'S ELBOWS and PEAS** Gomiti e Piselli della Nonna



1 pound elbow pasta 4 to 5 quarts water 3 to 4 shallots, finely chopped 4 ounces pancetta, chopped (not to be used on Meatless

Fridays)

½ cup olive oil (more if needed) 1 pound frozen, defrosted peas 1 to 2 cups freshly grated parmesan cheese red pepper flakes

In a large stockpot with 4 to 5 quarts of water, add some salt and cook the elbow pasta until al dente. Set cooked pasta aside and reserve  $1 \frac{1}{2}$  to 2 cups of the pasta water.

In a saucepan, add the olive oil and warm over medium heat. Add the shallots and pancetta (when using) and cook for about 8 to 10 minutes until pancetta is cooked and shallots are soft and translucent. Add the peas and 1 cup of the reserved pasta lower the heat and cook for about 5 to 6 minutes. Add the cooked pasta, and season with some grated parmesan cheese and red pepper flakes. Add more pasta water if needed and toss together. Cook over low heat for just a few minutes before ladling in bowls and serving with additional grated cheese and red pepper flakes, as desired.





# HOOPS and HOCKEY in the HUB

FAN FAVORITE TACKO FALL NOW WITH CLEVELAND CHARGE — When he was here you couldn't miss him — not only when he was on the court but also when he was sitting on the bench.

When he was here in the Hub, he was the top favorite substitute player for the Boston Celtics. Standing an imposing 7-6, he attracted attention just by his presence. And he simply captivated the fans during pregame warmups.

After all, when he was with the C's, he was the tallest active NBA player. He also is currently listed as one of the tallest people in the world by the Guinness Book of World Records.

Tacko Fall was probably the most admired seldom used bench player in decades for the C's when he was in the parquet palace a couple of years back. Currently he is playing in the G League (the NBA's minor league circuit) for the Cleveland Charge and holding his own.

He had played in 12 games through the end of February, starting in every one of them and was averaging a healthy 13.5 points per game while getting in an average of just under 29 minutes of court time per game. He also was averaging 10.5 rebounds per game and blocking an average of 2.7 shots per contest.

The G League experience will probably be good for Fall, who has yet to nail down a more permanent position with an NBA team. Back in 2019, Fall went undrafted, but signed a short term contract to play with the Celtics in the NBA's Summer League.

Based upon that performance — he led the summer team in field goal percentage with 77 percent from the field — the C's signed him to a two-way contract for the regular season, meaning he could play for both the Celtics and their G League affiliate, the Maine Red Claws (now the Maine Celtics).

Discovered in his native Senegal in his early teen years by a local coach, Fall traveled to the United States where he played high school basketball for a school in Texas. At the time that he led the school to the state championship, he was thought to be the tallest active secondary school player in America. He then moved to Florida for his senior year and excelled there as well.

Recruited by over 40 colleges, he stayed within the region, enrolling at the University of Central Florida after graduating from high school with a 4.0 average. He stayed all four years and graduated with a degree in computer engineering.

Fall played sparsely for the Celtics but did fine in Maine averaging 12.9 points and 11.1 rebounds per game. He also was named to the G League's all defensive team.

During the 2020-2021 season the societal effects of COVID-19 limited his playing time. Fall still had a two-way contract but in reality it became a one-way situation since the Red Claws did not play because of the pandemic. Thus Fall remained on the bench in Boston and only got into a few games.

Just before the opening of NBA training camps for the current 2021-2022 season, Fall signed with the Cleveland Cavaliers. He was in a two-way situation up until early January when he was waived by the Cavs and then signed by the Charge three days later. In addition to allowing him to keep his status as an active player, the current deal also provided an additional benefit: he did not have to move again because the Charge also play in Cleveland — just at a different facility.

CHARA CONTINUES TO CAPTIVATE — He is closing in on his 45<sup>th</sup> birthday—it will be on March 18<sup>th</sup> when he blows out all those candles—but he still plays like a younger man.

Yes, that is Zdeno Chara — simply known as Z throughout the NHL — who still shows up nearly every night, though these days he is playing for the New York Islanders, the team that initially employed him some 24 years ago when he began his lengthy and impressive NHL career.

Through the end of February, the tallest man in the league (6-9) had played in 45 games in the Islanders' back end, averaging a healthy 18 minutes and 16 seconds per game of ice time in the superfast game that is played at the NHL level. He had also just set the NHL record for games played by a defenseman (1,652). And counting.

It is hard to believe that Chara was selected as late as he was — in the third round (56<sup>th</sup> overall) by the Islanders during the 1996 NHL draft. After a year in the minors, Z joined the ranks of the NHL and never looked back.

There was a Boston angle early in his career — when former B's coach Mike Milbury (then the GM of the Islanders) sent him to the Ottawa Senators in 2001. He played in the political capital of Canada until 2006.

That summer is when Jeff Gorton, then an assistant GM with the B's, inked the prized free agent to a deal that would signal the start of a new era on Causeway Street.

Chara would serve as the captain of the Bruins for all of the 14 seasons that he was in Boston, playing in 1,023 games with the historic franchise, scoring 148 goals to go with 333 assists for a total of 481 points. He was the captain when the B's beat Vancouver to win the Stanley Cup in 2011 and was also the team leader in 2013 and 2019 when the B's made it all the way to the Stanley Cup Final.

Although it was a loss, the 2019 setback to St. Louis was perhaps the most inspirational series of his career since he played the last three games with several mouth and jaw injuries, doctors having essentially wired everything into place after he was hurt in Game Four.

It was the type of inspiration that made teammate Brad Marchand exclaim, "He's a warrior."

Time marches on and Z moved on to play for Washington last season and now the Islanders as his NHL career continues, as it has for 24 years, in a forward mode.
