Mr. Mayor, WHERE DO WE PUT IT ???

Recently, there has been talk coming out of Boston City Hall concerning the raising of fines for throwing snow into the street or for not shoveling sidewalks in front of homes and businesses. Anyone reading this that lives, works or just frequents the city regularly probably has seen a street or sidewalk that is completely covered in mounds of snow. Traveling across the city's neighborhoods, there are still streets with so much snow that fire apparatus or EMS would have a difficult time maneuvering.

Residents using the age-old "spacesaving" technique have made it impossible for the city to plow curb to curb except on main roads. One newspaper quoted an East Bostonian as saying before he moved his space saver that the city needed to remove the snow from his street. Another resident from Southie stated he would continue putting out his space saver no matter what the city said.

If the mayor is worried about snow being thrown into the street or the fact that many sidewalks haven't been shoveled yet, then do something about streets being so badly plowed.

One idea would be to utilize a system similar to the street sweeping program run throughout the city's neighborhoods between March-December. The city could designate a different group of streets per week and ask residents to remove their vehicles in order for plows to clear paths not only on sidewalks but also empty parking spaces rendered unusable due to plowed snow accumulations. Up in the city of Montreal, the whole city gets its snow removed not only from the streets but sidewalks too. If this is successful in Montreal, perhaps it is worth consideration here in our city as well. The City of Quincy has been doing a great job as many side streets are now fully accessible due to snow being carted away on trucks rather than pushed to the side by plows.

Stirpe Nostra

HERMES AND MERCURY

Hermes was the Greek god of herds, commerce, travel, and messenger of other gods. Mercury was the name of his Roman counterpart, and both are considered to be one and the same. Trickery, cunning, inventiveness and versatility were his major characteristics. These became apparent from the moment of his birth. Stories about his escapades sound incredible, but then, that's what legends are all about.

Before noon on the day he was born, he found a tortoise shell, made holes in the opposite ends of it, and drew cords of linen through them, and thereby invented the lyre. Later that same day he stole 50 head of cattle from his brother Apollo, and then hid them in a cave before bedding down for the night in his cradle. Later, this young god was ordered to return the cattle, however, he had so delighted his brother by playing the lyre, that Apollo made him a gift of the cattle. Mercury was also made herald to the gods in addition to the guide of the dead in the lower world.

This god was also worshipped as the one who bestowed the benevolence of fertility on the herds and their pastures. Again, legend tells us that he spent a considerable amount of time in those pastures, and an equal amount of time with the wood nymphs, bestowing the blessing of fertility on them also. He became the father of many children by these nymphs, Pan and Daphnis being the most widely known. Pan, as you may recall, became a god of the fields, forests,

flocks, and shepherds. He was usually represented with horns, ears and legs of a goat. Daphnis became the Sicilian shepherd that taught Pan to play the flute. Daphnis was also considered to be the inventor of bucolic (rustic or countrified) poetry.

Hermes (Mercury) presided over commerce, gymnastics, thievery, and everything else that required skill

and dexterity. As the god of commerce and guardian of the roads he showed his benevolence to all men. Anything found on the roads by travelers was considered to be a gift from this god. Mounds of stones were raised in his honor at rural crossroads as every passerby added a stone. Square posts were set up in streets, open spaces, before entrances, and as mile stones along certain roads. These posts were made of wood or stone, and the head of the god was carved at the top. Some of these posts were carved with proverbs or riddles, while others contained the names of those who had fought and died for their country. This concept was also used in Rome as a decorative feature in houses, villas, and for garden rails.

As the father of Autolycus, the prince of thieves, Mercury bestowed upon his son, the gift of changing stolen goods so as to make them unrecognizable. By this gift, Autolycus became the first stolen goods "fence" in world history.

Mercury was represented in art by some of the world's greatest sculptors. Most famous, no doubt, is the form which is similar to the FTD florists' emblem. The original statue, now in the Bargello of Florence, was done in bronze by Florentine sculptor Giambologna. He depicted Mercury as a slender youth with calm features, winged hat, and winged sandals. In one hand Mercury holds a purse, the symbol of the mischievous little thief and the god of gain, while in the other hand he carries the "caduceus," emblem of his influence over the living and the dead. This caduceus, the winged staff with two serpents twined about it, is the symbol of the medical profession today.

As the gods of sleep and sweet dreams, Mercury could open or close the eyes of mortals. This is the reason why the last libation of the day was offered to him, and if forgotten, became a good excuse for just one more nightcap, salute!

Live Racing to Return to Suffolk Downs

Last Friday officials of Sterling Suffolk Racecourse LLC and the New England affiliate of the Horsemen's Benevolent and Protective Association ("NEHBPA") announced that they had reached an agreement for the horsemen to lease the East Boston racetrack for live racing in 2015-2016.

The two-year licensing deal is subject to the passage of enabling legislation to extend racing and simulcasting in Massachusetts. The current law sunsets March 31st. Approval of the agreement by the Massachusetts Gaming Commission ("MGC") is also required.

According to Suffolk Downs and the Horsemen's Association, the duration of the 2015 Thoroughbred season has yet to be determined. It may be from one live racing day up to 50 days, depending upon the MGC's final approval as well as the distribution of funding for purses from the state. The Horsemen's Association hopes to make it a full 50-day season of live racing, as do I. There's little better in this life than an afternoon at the track, especially if it is a warm, sunny Saturday in May.

Suffolk Downs opened on July 10, 1935. According to information on the Suffolk Downs website: "Immediately, the track became entrenched into the city's sporting and social fabric, attracting an average daily attendance of nearly 15,000 in its first year, a figure that peaked at 18,388 in 1945. Average attendance remained 5 figures until the early 1970s, when the racing schedule was drastically expanded to as many as 200 days a year."

However, over time, public tastes regarding professional sporting events changed. "In the 1920s and 1930s the sporting public's attention was divided among baseball, horse racing, and boxing. After the war, however, the field grew to include, most prominently, football and basketball, but also hockey, professional wrestling, and, eventually, soccer." — American History through American Sports: from Colonial Lacrosse, Volume 1, edited by Danielle Sarver Coombs, Bob Batchelor.

It is also no coincidence that attendance at Suffolk Downs began to shrink in the 1970s. In 1971 the Commonwealth instituted the Massachusetts Lottery. That, and other legal gaming opportunities, cut into the business at the track, formerly the only place to wage a legal bet in the U.S. outside of the State of Nevada.

By the late 1980's, "The Downs" was suffering and closed at the end of the 1989 season. The venerable track re-opened in 1992, but closed again at the end of the 2014 season.

The potential restoration of live racing at the 80-year-old landmark will protect hundreds of direct and non-direct Thoroughbred industry jobs in the Commonwealth while preserving the 62 breeding farms and 6,650 acres of open green space in the state-wide agricultural network.

Residential Street Sweeping Update

The Boston Public Works Department announced that posted residential street sweeping will be postponed in neighborhoods with March street sweeping until streets are cleared to the curb and gutters are free of ice and snow. In order for streets to be properly swept, a thaw and large scale melting must occur. The Public Works Department will notify residents once streets are clear enough for street sweeping to resume.

The City's Daytime Neighborhood Street Cleaning program currently runs from April 1st through November 30th for all neighborhoods except the North End, the South End, and Beacon Hill. The daytime program parking restrictions are not in effect during the months of December and March except in the North End, the South End, and Beacon Hill.



A Nostalgic Remembrance

A couple of weeks ago, I was in the middle of a story about one of my first vacations as a young man traveling without my parents. Sal Meli, whom I had grown up with in East Boston, Tom Aylward, a new friend who taught with me at the school and I headed for St. Thomas and Puerto Rico. We had spent a few days in St. Thomas' capital city, Charlotte Amalie, and were ready to head to San Juan, Puerto Rico. The only negative part of the trip to St. Thomas was the aftermath of befriending some naval officers. The command staff of the USS Thresher, an American submarine, often stayed at the Gramboco Inn, the hotel we were staying at in St. Thomas. Not long after our stay at that hotel, the sub went out on maneuvers and sank with all the sailors perishing as a result. It was not a happy time.

Once the goodbyes were over, the three of us headed for San Juan. We had a reservation at the Hotel Normandie, the oldest resort of its kind in Puerto Rico. I had a slight problem once we landed. The day before, my nose started running and by the time we reached San Juan, I had trouble breathing and had lost my sense of taste. We picked up a car, which I had reserved back in Boston, and drove to the hotel. After checking in, the guys were raring to go. I felt sick, but went along anyway. We headed for Loquillo Beach, one of the ten most beautiful beaches in the Caribbean. It is horse shoe shaped and the salt content in the water is extremely high, you automatically float. Once at the beach, I had to wrap towels around myself. I was freezing. The air temperature was about 85 degrees, but I was shivering. I think I was definitely sick.

The guys went swimming, but I was so cold I couldn't. Spotting a food stand, I decided to find out if they had hot coffee. I love Puerto Rican coffee. It is a lot like espresso. The woman behind the counter asked who my tourist friends were. When I replied (in Spanish), "How did you know they are tourists?" She replied that it was winter and Puerto Ricans don't go to the beach during the winter months. As I looked around, I saw that she was right. The only people I saw looked like tourists, not locals. When it was time to head back, I was s-i-c-k.

Sal and Tom headed for the pool to check out the ladies

and I went to bed. When it was time for dinner, Sal told me to stay in bed and they would bring me back something to eat. I insisted on joining them and we got cleaned up and headed out. En route to the old city of San Juan, I was having trouble breathing. Sal changed direction mentioning that he had a friend who was a druggist who worked at a pharmacy near one of the hotels. We headed inside the drug store, and fortunately, his friend was working that evening. I explained my problem and he gave me some large pills saying that I would normally need a prescription for them, but seeing the circumstances, I needed them right away. He gave me the instructions on how and when to take them, with the added instruction of, "Whatever you do, don't drink when taking this medication.'

I followed his instructions, taking one of the pills before we left the drug store. Within minutes, my breathing began to return to normal. Unfortunately, my taste buds were still on vacation and I couldn't taste the dinner I ordered once we were at the restaurant. Later that evening, we headed for a hotel where someone Sal knew was playing. Tito Rodriguez was called the Frank Sinatra of Latin America. He was short, handsome and talented. His band was one of the most popular in New York and San Juan, on par with Tito Puente and Machito, back when Salsa was the way to go. We met some girls from New York who were on vacation also. I asked one of them to dance and we mamboed the night away. Between the medication and perspiring due to my physical movements, I began to feel better by the time we headed back to the Normandie.

Back then, hotel doors opened with keys and you would leave your key at the front desk on your way out and pick it up when you returned. When I asked for our key, the desk clerk pulled a note out from the cubicle our key was in and said that I had gotten a call earlier in the evening. I read the note which came in from my father. It instructed me to call regardless of the time. A bandleader had called to see if I could play a job the night of our return and needed an answer right away. I called home. Babbononno answered with, "Ah-low, ooh izza dissa, pleaza?" I yelled back, "Babbononno, it's me, John."

He replied, "Hey, Jenny, dayza band leeda wadda call ah see iffa you canna play foh hizza banda nexa Sunday nighta. Izza dissa Ok?" 

Saint Agnes of Bohemia

Saint Agnes of Bohemia, also called Agnes of Prague, was born in Prague in the year 1200. Agnes was the daughter of King Ottokar I of Bohemia, making her a descendant of Saint Ludmila and Saint Wenceslaus, patron saints of Bohemia. Agnes' mother was Constance of Hungary, who was the sister of King Andrew II of Hungary, so Agnes was a first cousin to St. Elizabeth of Hungary. At an early age she was sent to the monastery of Treinitz, where she was educated at the hands of the Cistercians.

Agnes was engaged to Henry, son of Frederick II, Emperor of Germany, when she was nine. She was overjoyed when Henry married the daughter of the Duke of Austria, as she had offered herself to God and hoped to live a life of austerity and virginity. Her brother then betrothed her to Emperor Frederick, and when in



1235 Frederick sent for her, she petitioned Pope Gregory IX to intercede. Frederick was incensed that she would

refuse him but, on learning that St. Agnes had left him to become the spouse of Christ, he is said to have remarked: "If she had left me for a mortal man, I would have taken vengeance with the sword, but I cannot take offence because in preference to me, she has chosen the King of Heaven." He released her from their engagement.

In 1236 Agnes entered the Order of St. Clare in the monastery of St. Saviour in Prague, which she herself arranged to have built. The Convent was staffed by five nuns sent by St. Clare, Agnes was named abbess soon after and became renowned for her humility, aid to the poor, and her dedication to poverty. She died in Prague on March 2, 1282. She was canonized by Pope John Paul II on November 12,

WHAT'S BEHIND BAD PET BREATH?

Just like people, some dogs and cats have stinky breath. Here's how to recognize if the stench signals a serious health problem and how to say bye-bye to bad pet breath. Bad dog breath or cat breath can certainly be unpleasant, but more impor-



tantly it could also be an indication of a health problem. Bad breath in pets is most commonly due to dental disease, including gingivitis, periodontitis, and decayed or abscessed teeth. There are other all too common factors that can cause bad breath in pets, non-medical causes include eating malodorous foods or coprophagy (eating feces).

When bad breath becomes a problem in rare instances, it could be an indicator of a more serious health problem. An ammonia odor may be due to kidney disease while an acetone-type odor can be a sign of diabetes.

Other pet illnesses that include bad breath include possible symptoms of: sinusitis, rhinitis, neoplasia, autoimmune disease, FeLV and FIV in cats, foreign bodies, and open fractures. Considering all these possibilities, it's best to see your veterinarian if the bad breath is lingering and persistent. You should always have your veterinarian examine your pet if you notice any odor coming from its mouth, as many of these causes are potentially life-threatening conditions. At minimum, most of these will cause discomfort for your pet.


In most, non-chronic cases, brushing your pet's teeth is the simplest way to remedy the situation. I would recommend purchasing a pet specific toothbrush. There are brushes with longer handles for big dogs and brushes that fit over your finger for small dogs and cats. If you've never brushed dog teeth or cat teeth before, you may want to start with a damp washcloth or gauze passed over teeth to get them used to the sensation. Then you can switch to the toothbrush. Concentrate on the outside surfaces of the teeth. Place the toothbrush at a 45-degree angle at the gum line and use short back and forth, circular motions along the base of the tooth and in between teeth. You may only be able to do a few teeth during these early sessions, but don't get discouraged. Most pets can be taught to accept tooth brushing if you are patient and take it slowly.

Here are other tips that our experts recommend:

- 1. DON'T IGNORE IT. Since bad breath might be hiding a more serious medical condition, have a vet check it out
- 2. HAVE NECESSARY DENTAL WORK DONE. In some instances, dental work on your pet's teeth or gums may be necessary to eliminate the problem, so don't be surprised if this is what your vet recommends.
- 3. **RELY ON BRUSHING.** Once your vet has given the okay, you can incorporate pet teeth brushing based on the techniques explained above.
- 4. CONSIDER RINSES. Certain additives to your pet's drinking water and oral rinses may be effective at reducing bad breath. Speak with your veterinarian as to which ones may be best for your pet.
- 5. CHOOSE THE RIGHT CHEW. Dental chews claim to clean your pet's teeth, but most dental treats are not effective. Ask your vet what would be best to use.

Set aside time to take care of your pet's dental needs not only for better breath, but most importantly for your pet's overall good health.



Benvenuti! This month we will visit Piemonte which translates literally as the "land at the foot of the mountains". This second to the biggest Italian region borders France to the north. Its alpine high peaked mountains, beautiful valleys and glacial lakes along with natural mineral springs give this region its uniquely beautiful mountainous charm. White truffles from Alba, chestnuts, cardoons, wild game, cheese like Castelmagno and Gorgonzola, rice like Arborio, Carnaroli and Vialone growing in the Po valley are signature food products of this region. Piemonte is home for excellence in chocolate and confectionary: among many are the rich and velvety gianduiotti chocolate, still hand made in local artisan chocolate stores. Cuneo, city in Piemonte, is home to the Ferrero factory, producer of brands like Nutella. To this very day, pane e Nutella (bread and Nutella) is the number one snack for Italian children. Barolo, Barbera, Nebbiolo, Barbaresco and Dolcetto, regional wines of certified origin and outstanding quality as well as the herb-flavored Vermouth produced in Torino, are widely appreciated in the U.S. This week's recipe is a great example of Piedmontese influence on French cooking and illustrates the exchange of gastronomic ideas between France and Italy that dates back to the time when Piemonte was part of the Savoy kingdom (including France, Switzerland and Italy) and the Savoy dialect, a variety of French, was spoken. Bagna caòda (hot bath) is a vegetable fondue or dipping sauce. Vegetables are quickly dipped in a hot sauce of garlic and mashed anchovies and eaten along with toasted bread. Very traditional and popular throughout Piemonte.

Bagna Caòda (serves six)

4 Tbsp butter 5 cloves of garlic, thinly sliced and without the hearts

1 cup extra virgin olive oil

1/4 lb anchovy fillets Assorted fresh vegetables like celery, carrots, fennel, cauliflower, bell pepper, cardoons Slices of toasted Italian bread

Preparation: wash and cut the vegetables in bite-size pieces and arrange into a serving platter. Melt the butter in a pan and sauté the garlic. Gradually add the olive oil and stir in the anchovies to obtain a creamy consistency. Simmer for about 30 minutes and transfer into an (electric or a traditional) fondue pot. Bring to the table and keep the temperature on simmer. Dip the vegetables in the bagna caòda and enjoy them along with some toasted bread. If you don't have a fondue pot, use a pre-heated terra cotta bowl in order to keep the bagna caòda at a constant hot temperature. Buon appetito!

Bagna Caòda (Serve Sei)

50 g di burro 5 spicchi d'aglio privati dell'anima e sminuzzati 250 ml di olio extra vergine di oliva 100 grammi di filetti di

acciughe sott'olio

Verdure fresche assortite come sedano, carote, finocchio, cavolfiore, peperone, cardi crude o scottate Fette di pane tostato

Preparazione: taglia le verdure a strisce o a pezzi monoporzione. Adagiale su un piatto da portata. Sciogli il burro in un tegamino e aggiungi l'aglio. Gradatamente aggiungi l'olio e le acciughe, mescolando in modo da ottenere una consistenza cremosa. Fai sobollire per circa 30 minuti e trasferisci in una pentola per founduta (elettrica o tradizionale). Porta in tavola mantenedo la temperatura costante e molto calda. Intingi le verdure nella bagna caòda e accompagnale col pane tostato. Se non hai una pentola per founduta, usa un pentolino di terracotta precedentemente scaldato in modo da mantenere la bagna caòda a temperatura costante a tavola. Buon appetito!

History of Football in Boston Part I

With the Civil War occupying headlines and the minds of the century old republic with the nightmarish notion of separation, a group of Boston area preparatory school boys met on the pastures of Boston Common to play a game. At this time the "game" lacked any real rules, and was quite chaotic and frankly disorganized, symbolic of the nation it was being played in. This would change when a student from the Latin School, Gerrit Smith "Gat" Miller decided that he had had enough of this violent and messy affair. Miller, the grandson of well-known New York abolitionist Gerrit Smith, wanted to fashion a game that would follow a specific system of rules and sought out to organize and produce a less violent, more gentlemanly game.

This was an era before the

pass, so Miller blended running, a precursor to rugby, and kicking, from the everpopular sport of soccer, to create what historians refer to as the "Boston Game", a hybrid of the two sports.

During the summer of 1862, he and about 15 other boys formed a squad, the Oneida Football Club.

Wearing simple gear consisting of a red silk handkerchief tied around player's heads, between the years 1862-1865, it is chronicled that the Oneida's never lost a match or surrendered a point. The objective of the game was to cross the opposition's goal line, (sound familiar?) while taking part in a continuous play, until one team had accomplished the feat twice. This could last hours.

The most famous game in Oneida history came in a November 7, 1863 meeting versus a combined squad from Boston Latin and English schools. After nearly three hours of mostly nonstop action, the Oneida's triumphed as they would throughout their three-year existence.

This new way of playing the sport was soon adopted in area colleges, most notaevolution of the forward bly at Harvard University

during the 1870's. Harvard would stay with the Boston style while other Ivy League Universities such as Yale and Princeton continued to use the traditional kicking game. This in turn put Harvard University on the path to playing rugby, primarily versus the MacGill School in Montreal, Canada. These interactions would lead to other U.S. schools joining in on the fun.

Although it was far from the game that Tom Brady has played to perfection with the New England Patriots, a solid case can be made that the birth of the game we love today began in the city of Boston.



LEONARD NIMOY

The Vulcan with a Cauliflower Ear

Leonard Nimoy, who was born and raised in Boston's West End, passed away recently. While Mr. Nimoy was never a boxer, and is best known for his role as Mr. Spock in the *Star Trek* TV series and movies, boxing did have a part in shaping his acting career.

I was never a big fan of *Star Trek*, but I have always found Leonard Nimoy to be a very fascinating man outside of the role he is famous for. He led a very interesting life and was active in many different art forms. Not only was he a TV and movie star, he also spent time on stage, was an accomplished photographer, poet, narrator, and even released a record album.

I viewed a 2014 documentary, Leonard Nimoy's Boston, his son Adam made about him. Mr. Nimoy and Adam spent time reminiscing and walking through the areas of Boston where Leonard grew up. The stories are wonderful to listen to, tales of selling newspapers, working for a vacuum dealer, and selling greeting cards, it brings us back to a very different Boston than the one we know now, before urban renewal destroyed a vibrant neighborhood and displaced many poor, but happy families.

The old West End was a lively neighborhood where many immigrants first settled when they came to this country. Leonard's parents arrived here from the Ukraine and were Jewish. There were many Jews in the area and also a huge population of Italians along with many other ethnic groups. The West End was a beautiful representation of the American Melting Pot.

The Nimoy's lived at 87 Chambers Street, which has since been covered over by the Charles River Park luxury apartments. Three doors down from their building was a synagogue where the Nimoy's would worship. The only remaining Jewish House of Worship from that period is the Vilna Shul on Phillips Street. A number of years ago, Nimoy narrated a documentary about the Vilna Shul in an effort to raise money to restore and preserve it. Towards the end of the film the camera zooms in briefly on a golden pair of hands that appear to

be giving the Vulcan sign of greeting. Mr. Nimoy in interviews has said that it was his memories of seeing this ancient symbol while worshipping that gave him the idea for it in the Star Trek series. He remembered seeing worshipers using it while he was at the synagogue and thought it was a beautiful gesture, and seeing that Earthlings of all backgrounds make some gesture towards each other when first meeting, be it a handshake, bow, salute, or something else, he thought it would be fitting for Vulcan's to have such a thing. Seeing as it was in a Boston synagogue that the young "Spock" first saw this, I think Boston can take some credit for what has become a gesture of peace known throughout the galaxies.

Leonard got his first taste of acting at the Elizabeth Peabody Community Settlement House at 357 Charles

Street. While there he was spotted by a priest who was so impressed with his talent that he offered to fund 50% of a scholarship for him to attend a summer acting program at Boston College, an offer the young Nimoy jumped at. It would take years before he found success in the world of acting. While working to get by, he told a story of the time he was driving a cab in California when a young Jack Kennedy hailed him. They had a wonderful conversation in which they compared the commonalities in politics and acting. Kennedy told him that while there were many competing for leading

roles in both professions, "There was always room for one more good one."

So, where does boxing fit into all of this? Well, it turns out the first major film role Mr. Nimoy had was as a boxer in the movie *Kid Monk Baroni*. I watched the movie recently and it is pretty good. The future Mr. Spock plays

the lead role of Monk Baroni, an angry young man with a disfigured face who finds an outlet for his anger in the boxing ring. It is appropriate that a priest leads him in this direction as that mirrors his journey to acting in his own life. The movie follows the usual boxing movie formula with the leading man finding success in the ring and love outside of it only to squander both, but to be led back to a good and meaningful life by his friends who never lost faith in him. Jack Larson, who portrayed Jimmy Olsen in the Superman TV series, plays Monk's best friend Angelo. Bruce Cabot is Monk's manager Mr. Hellman. Cabot is best remembered for his role in the original King Kong with Fay Wray. The entire movie was filmed in nine days and Nimoy was paid less than a thousand dollars for the part. It did receive decent reviews and was shown at the Bowdoin Square Movie House where the marquee proudly proclaimed "The West End's Own Leonard Nimoy Starring in Kid Monk Baroni."

Mr. Nimoy has said that the role did not lead to fame and fortune, it would be many more years before that happened, but it did something very important for him. He said it gave him the confidence that he could do the work. This confidence would serve to motivate him to keep sticking with it until he finally made it. He had the determination of a championship boxer. Oh, and he also showed some good footwork and hand movement in the movie. I have not been able to find out if he ever actually spent any time in the ring outside of the movie, but he certainly showed ability in the scenes I saw.

In 2012, Mr. Nimoy was given an honorary degree by Boston University. In his speech he said to the graduates, "You are the creators and curators of your own life and work. Give us your best. We crave it, we hunger for it." Leonard Nimoy always gave us his best and we are all the better for it.

It's the stretch drive for the Bruins as the local team seeks to make the playoffs over the course of the final weeks of the regular season.

The NHL trading deadline came and went in the Bruins offices with management electing not to disturb the core of the team. That means that the team that has basically been in place since the start of the season will finish it, either remaining in the wild card slot it has occupied for weeks or slipping out of contention and into inactivity come the middle of April.

It's true that Jordan Caron is gone, traded to the Colorado Avalanche for center Maxime Talbot. But Caron was a utility player, the ultimate yoyo man on the B's roster since he shuttled between Providence and the Hub over the years as needed while never earning a permanent spot in the Boston lineup. However, timing is everything and Caron was on a Duck Boat in the 2011 B's Stanley Cup victory parade as the vehicles wound their way through the downtown streets of the Hub.

The Bruins also acquired Brett Connolly from Tampa Bay in exchange for draft picks. He was a first round selection in the 2010 draft and could be a positive addition as the B's make a run for the playoffs.

We've said it all along and we'll say it again. The 2014-2015 Bruins are a playoff team — when everyone is healthy and all players are firing on all cylinders. Unfortunately, there have been gaps in the season where the team has sagged and they needed to fight to right the ship.

But the B's, of late, have seemed to catch fire at just the right time. However, they may no longer be in full control of their own destiny. A victory, for example, does not necessarily mean putting additional distance between the B's and their fellow playoff aspirants.

A recent case in point came on the last day of February when the B's scored a pretty good victory over Arizona at the Garden. The B's came away with two points from that win, but didn't move a bit in the standings. Why? Because Florida, the B's nearest rival for a playoff berth, had won earlier in the day, meaning the B's had not been able to widen the fourpoint margin in the standings. So things remained as they were — with one less game to go in the regular season. In essence, the day for both teams was a tie.

Still, the B's played impressive hockey and sent the signal that they are ready to essentially defend their possession of their wild card playoff berth from all comers. And it may well be Florida, the team that picked up B's fan favorite Shawn Thornton last summer that poses the biggest challenge.

Indeed, the most referenced NHL team in the Hub outside of the B's may well be the Panthers over the next few weeks. "How did Florida do today" was heard up and down press row during the B's game with Arizona. Expect such queries to grow exponentially as the season enters its final fling.

As this was being written, Florida had narrowed the gap with Boston and was only two points behind the B's for the second wild card slot, with Philadelphia five points out and Ottawa six. What makes the situation with Florida especially interesting is that through a quirk in the schedule the Panthers and the B's will face off against one another three times in the closing weeks of the regular season.

The first will come at Florida on March 21st, while the second will be a matchup on Causeway Street on March 31st. The third will be at Florida on April 9th in the next to last game of the regular season. Two nights later the B's close out the campaign by playing at Tampa Bay. The Bruins also have two games at Ottawa — on March 10th and 19th while they also play at Washington (the team ahead of them in the wild card standings) on March 15th and April 8th.

"We have to continue to play like we did recently," offered Bruins defenseman Zdeno Chara. "We are gaining more confidence. We have about 18 games left and we know where we're at. It's going to be a fight until the end. A lot of teams are going to be fighting for those last spots and we just have to continue to play like we did recently (finishing February with back-to-back victories)."

Brad Marchand feels that the B's may well have turned the corner and are headed in the right direction. Thinking back to earlier in the season, he recalled "it just seemed that when things were going wrong, we still played good hockey, but still wound up with a loss. There were other years, like last year, when we didn't always play our best, but seemed to find a way to win. We're very happy with how we're progressing now. We're turning the corner and we're playing good hockey right now. We're going to continue to build on it and continue to get better."

Marchand expressed the growing confidence that the Bruins felt as February became March. "We can beat any team in this league on any given night. We know that, especially when our team is healthy. We're going to work and do the best we can."

The big question, though, is whether the Bruins "playing their best" will be enough. It could, especially with the showdown games that are looming with Florida, Ottawa and Washington. Opportunities to be gained or lost with the season on the brink.
