Proposed North End Hotel Bad Idea & Bad Bet

It was revealed last week that Normandy Real Estate Partners - the same folks who are proposing to plunk another hotel on Blackstone Street in the middle of what is supposed to be the North End's Haymarket/Market District - once again are facing the failure of one of their other hotel ventures.

The company had planned to construct an 11-story hotel at 275 Albany Street, but in a letter to the Boston Redevelopment Authority (BRA), the company indicated that "shifting economic conditions" led it to scrap the hotel plans previously approved by the BRA and that "given current market conditions, the applicant was unable to secure a hotel operator despite diligent efforts to do so."

This comes on top of revelations last summer of continued significant financial difficulties the company has been having making a go of the Ames Hotel on Court Street in downtown Boston. And those revelations came after the company changed the Albany Street project from two hotels and retail to one hotel, residential and retail, abandoning the second hotel in favor of a residential tower.

Community leaders and officials who have examined the issue have been opposed to the idea of putting a hotel on Parcel 9 on



Blackstone Street where Boston's historic "pushcart" vendors set up every weekend. Along with the rest of us, the Haymarket Pushcart Association, which prevents those vendors, has been strenuously opposed to the hotel idea.

Aside from magnifying the types of conflicts which have created difficulties between the Haymarket operations and the hotel which already exists at the end of Blackstone Street, a hotel would be a misuse of property that should be used to tie

IMPORTANT INFORMATION

New Posted Street Sweeping

The Boston Public Works Department is implementing a posted street sweeping program on several streets in your immediate neighborhood. These additions will complete the posted sweeping program for the North End. Currently, many cars on these streets do not move on the scheduled street sweeping day and the sweeper cannot access the curb area. This program will allow for more effective mechanical street sweeping resulting in a cleaner environment in your community.

The new streets to be posted for sweeping are:

- Battery Street, from Hanover to End Thursdays 8:00AM—12:00PM
- Clark Street, from Hanover to Commercial Thursdays 8:00AM—12:00PM
- Cross Street, from N. Washington to Atlantic Tuesdays 12:00PM—4:00PM
- Garden Court, from North Sq to Fleet Tuesdays 12:00PM—4:00PM
- Moon Street, from North Sq to Fleet Tuesdays 12:00PM—4:00PM
- Stillman Street, from Salem to End Tuesdays 12:00PM—4:00PM
- Typically, the North End posted sweeping program begins on March 1st. However, due to the many snow events, the placement of the signs on these streets has been delayed. Therefore, the program and enforcement for these streets ONLY will begin on April 1,

2013. The Boston Transportation Department will post the signs on your street prior to that date. The signs will indicate the days and hours when the parking restrictions will be in effect. **Please note the information on the signs prior to April 1st**.

- \bullet The odd numbered side of the street will be swept on the 1^{st} and 3^{rd} designated weekday of the month. The even side will be swept on the 2^{nd} and 4^{th} designated day of the month.
- \bullet The program will typically run from March $1^{\rm st}$ through December $31^{\rm st}$ each year.
- This program will be enforced through parking fines as well as the towing of vehicles. Please comply with the posted regulations.
- Comprehensive street sweeping information can be found by logging on to www.cityotboston.gov. Weather and road conditions will occasionally require cancellation of street sweeping and enforcement. You can register for posted street sweeping electronic reminders and cancellation info by accessing the No-Tow link at that website. Inquiries can also be directed to the Mayor's 24-Hour Service at 617-635-4500 at any time.


Stirpe Nostra

No discussion on the Italian Renaissance would be complete without including one of the greatest geniuses the world has ever produced. Few artists have matched the grandeur of his conceptions or the power of his creations. To know his life is to know the history of Italy's glory.

Michelangelo di Lodovico Buonarroti-Simoni was born in Caprese, Tuscany, in 1475, at the height of the great Italian Renaissance. Today we know him simply as Michelangelo. Chiefly, he was known as a sculptor and in this art he created some of the greatest masterpieces that this world has ever known. Additionally, he was a painter and in this art also he created some of the greatest masterpieces that this world has ever known. He was called upon

to prepare a defense for his beloved City of Florence when it was under siege and in this effort he designed one of the most effective defenses known up to that time. As proof that he was every bit as cultured as he was talented, he also wrote poetry which is still being republished today.

History credits Michelangelo with more than 50 great artistic creations. The most famous appear to be the Pieta' of St. Peter's, the Sistine Chapel ceiling, the Sistine Chapel wall and the dome of St. Peter's Basilica.

The title *Pieta*', as we know, is given to any representation in painting or sculpture of the Virgin Mother grieving over the body of Jesus after the Crucifixion. Michelangelo's Pieta' will be dis-

cussed in more detail in the next issue of this column.

In 1508 Pope Julius II ordered Michelangelo to paint the ceiling of the Sistine Chapel. This is the work where much of it was done while lying on his back. Here, he chose to present a condensed version of events recorded in the Book of Genesis. He painted 343 colossal figures on 10,000 square feet of ceiling, and at the age of 33, after four years of agonizing labor, created the most powerful piece of painting in the world. Twenty-four years later he returned to paint the titanic Last Judgement on the altar wall of the same chapel. This work shows sinners being condemned to Hell by Christ's furious judgment. It is one of the largest fresco paintings ever executed and the most comprehensive in the world.

Michelangelo was 72 years old when commanded by Pope Julius III to take over the position of Architect for the Basilica of St. Peter, then under construction. He was the eighth of about fourteen men who served in this capacity. Here, he served without compensation "For the love of God only." The design and construction of the central dome is attributed to him and once again he produced one of the greatest masterpieces of art.

Rendering unto Caesar and unto God

The United States Commission on Civil Rights has announced that it will hold a briefing, in Washington, Friday, March 22nd, to examine recent legal developments concerning the intersection of non-discrimination principles with those of civil liberties.

Two topics will serve as starting points for a discussion involving religious liberties and non-discrimination rules and their broader implications for civil liberties: the Hosanna-Tabor v. EEOC case and student group nondiscrimination policies, including the Christian Legal Society v. Martinez case. Also at issue are religious liberty claims under First Amendment provisions other than the Religion Clauses.

There will be two panels at the briefing. The first panel will be composed of scholars involved in the Hosanna-Tabor v. EEOC or Christian Legal Society v. Martinez litigation: Kimberlee Colby, Senior Counsel at the Christian Legal Society, Ayesha Khan, Senior Litigation Counsel, Americans United for Separation of Church and State, Daniel Mach, Director, American Civil Liberties Union Program on Freedom of Religion and Belief and Lori Windham, Senior Counsel, Becket Fund.

The second panel will consist of experts who will discuss the broader conflict between anti-discrimination norms and civil liberties. Experts scheduled to appear on the second panel include Alan Brownstein, Professor, University of California at Davis Law School, Marc DeGirolami, Associate Professor, St. John's University School of Law, Leslie Griffin, Professor, University of Nevada Las Vegas Law School, Marci Hamilton, Professor, Benjamin N. Cardozo School of Law, Michael Helfand, Associate Professor, Pepperdine University School of Law, and Edward Whelan, President, Ethics and Public Policy Center.

If you are concerned about current domestic threats to religious liberty, including the Obama Administration's attack on Catholic schools, hospitals and charities, this is your opportunity to comment. Public comments are being accepted until April 21st. Lawyers and professors of law may dominate the Washington briefing later this month, but the public comment period is open to anyone who is distressed that our First Amendment Right to Free Exercise of Religion is being attacked by the very federal officials who took oaths to defend the Constitution.



De Niro's Neo-Nazi Southie Put-down

A few years ago I read that when the Italian Republic was about to honor Hollywood actor Robert De Niro numerous Italian-American organizations officially reacted to that honor by asking the Italian government not to do any such thing since De Niro's long Hollywood career added negatively to those horrible stereotypes of Italians and Italian Americans as mostly gangsters. I believe the Italian government withdrew the honor after getting much negative feedback from Italian-American organizations here in the United States.

I read where Senator Jack Hart reacted very negatively to an upcoming Showtime show that De Niro is the executive producer of, stating, "I am offended on behalf of all the good residents of South Boston that this project in any way will be filmed and thereby reflect poorly on the town." Hart has lived his whole life in Southie and added, "I have never encountered anything resembling a neo-Nazi group."

Rep. Nick Collins also said, "I am tired of Hollywood writing and rewriting scripts and making movies that characterize people from Boston or South Boston in such a grotesque and unflattering light. If this is all De Niro has left in the tank, he should just retire."



Getting back to Hart's first-hand knowledge about Southie and neo-Nazis, like him I remember when some out of town white supremacist group came up to Southie to seemingly exploit tensions caused by the federal busing court order. When they arrived they were met with resistance and told to go back to where they came from. They did in haste. Never to be seen again on A Street, B Street, East Broadway or West Broadway.

This new cable series is called *The 4th Reich* and has been called a cross between the films *American History X* and *The Town*. Hollywood is calling it a crime-thriller that mixes race, religion and politics. The series follows the former leader of the neo-Nazis who gets released from prison to return to Southie as a spy for the FBI.

I read that the Anti-Defamation League's New England Chairman Jeff Robbins said the show could actually serve a useful purpose if it's done right." Done Right? Showcasing South Boston residents as political extremists or sympatric to extremism, how can that be done right, especially when history shows just the opposite?

I remember back in the early 1970s as a 20-something opponent of forced busing. We were constantly being bad-mouthed by the liberals and their daily rags. They didn't see those white supremacists being run out of town. They apparently thought they would be welcomed as allies in a common fight. I'm sure they were surprised by South Boston's reaction to bigots coming into their fight. How many times did the liberal media try to paint Jimmy Kelly as a loudmouth racist? How many times did they remark about the South Boston Marshals being storm troopers?

You can't make anti-busing or I.R.A. movies anymore, so Hollywood has moved onto Nazis now. I never lived in Southie but as someone who fought alongside South Bos-ton from Charlestown, I knew what Southie people were all about and I understood the fight they fought. I fought alongside them.

When I think of South Boston or Charles-town, I think of hard working folks trying to survive and raise families as best they can through good times and bad. I think of people like my grandfather from West Cork who arrived in Charlestown over 100 years ago. He, like many others came for a new start and a chance to be living in this country. They came to marry and raise families and give their children more opportunities than they ever received back home.

De Niro, like all of Hollywood, would rather show gangsters, neo-Nazis and bank robbers than what really is the story. Paint up stereotypes and sell stuff that is simply exhausting

cally complex and justifiably the most popular of the six funeral motets he wrote for St. Thomas' Church in Leipzig. It was written in 1723 for the funeral of Johanna Maria Käsin, the wife of Leipzig's postmaster. The chorale melody on which it is based was by Johann Crüger; the German text is by Johann Franck and speaks of Jesus Christ freeing man from sin and death.

Composed in July 1874, Brahms's Kleine Hochzeits-Kantate (Little Wedding Cantata) for chorus and piano is rarely heard and was written at the peak of Brahms's compositional powers. Brahms composed this piece in 1874 at the special request of his friend, the famed Swiss poet Gottfried Keller, who wrote the words. The work was commissioned by Keller's close friend Marie Exner for the wedding of her brother Sigmund Exner with Emilie von Winiwarter, whose names Keller worked into his poem. Brahms throughout his life declined invitations to write music for special occasions; this charming "little cantata" is a rare exception to that rule. Unpublished during Brahms's lifetime, the work first appeared in 1927 and has not been often

performed. Composer Daniel Pinkham wrote his popular Wedding Cantata in 1956 for the marriage of his friends Lotje and Arthur Loeb. The texts from the Song of Solomon (Song of Songs) are great favorites at weddings and anniversaries. Pinkham invested them with pro Musica featuring Bach, a variety of musical contrasts and moods — sudden, serene, racing, slow, eager, contemplative, longing, intense — all in a 10-minute composition. We learned much from Jimmy Kelly about standing up and speaking out against injustice.

This book now calls Jimmy Kelly names but Jimmy isn't here anymore to defend himself. Kelly was a good man who always put up a good fight to defend his values and his neighborhood. He was too loud at times because being part of any silent majority wasn't his style. I considered him a friend as he did me. We stood together back in the bad old days when a federal court order singleeducation and many young people of that era. Jimmy Kelly was no racist or blowhard, he truly cared about life

Rosa Parks was called many ugly names after she refused to stand at the back of a bus in 1955 and inspired a whole movement to fight harder. She once said something that Jimmy Kelly could have also said, "You must never be fearful about what you are doing when it is right."



STRUFOLI

A Fried Nugget-Shaped Pastry

- 2 ½ cups flour 1/4 cup sugar
- 1 teaspoon baking powder
- ½ teaspoon salt
- 2 tablespoons melted butter or margarine
- 1 large egg (beaten)
- ½ cup milk
- 1 teaspoon vanilla 1 eight-ounce jar honey
- 1 small jar nonpareils
- 4 cups cooking oil

Mix first four ingredients in a ten-inch bowl. Add melted butter or margarine, beaten egg, milk and vanilla. Mix to make dough that can be rolled into a ball. Cut dough into four or five portions and cover. Roll each portion into long strips of one-inch thickness. Cut strip into half-inch portions. Heat oil in small saucepan or small deep fryer. Carefully drop a few Strufoli into hot oil. Stir with slotted spoon. Cook until golden brown. Remove from oil with slotted spoon. Set aside in a clean bowl.

Heat honey in a double boiler. Drop Strufoli, a portion at a time, into warm honey. Stir a few seconds. Remove with slotted spoon. Place in a clean bowl. Sprinkle nonpareils over them. Continue until all Strufoli are coated with honey and nonpareils. Serve hot or cooled.



From what I remember, Italians have always loved pets. Even going back to ancient Rome, they loved their animals. When Pompeii was excavated, the entrance to someone's home had an inscription cemented to the floor, "Cave canum." (Beware of the dog.) My first recollection of a family pet was when I was very young and we all lived in one big house on Eutaw Street in East Boston. Nanna had a cat named Tippi. She was orange and white, had a pleasant disposition and was bilingual. She reacted to both English and Italian. She was dedithe neighborhood.

expired rodent, she would wait until Babbononno, my father or one of my uncles returned home and have them remove it from the house. Then came the day when Tippi, proud of her latest kill, dropped the limp body of a garden snake at Nanna's feet. Nanna screamed loud enough for my mother, Aunt Eleanor and cousin Paula to all run to her rescue. As I was in the kitchen when the present was delivered and witnessed the whole scenario, I just stood there and watched. After all the ladies had arrived, not one of them would touch the snake to remove it. Tippi sat aside the snake looking up at Nanna as if to say, "Look what I brought you this time!" Not finding the girls in the lobby, he headed inside the darkened theater, walked up and down the aisles yelling, "Angie, a du sta?" ("Angie, where are you" ... in dialect) As he yelled, the dog echoed him with a bark. When he finally found Mom and Ada, they were given orders to accompany him home. They explained how they missed the first part of the cofeature to Nanna when they arrived home and she calmed Babbononno down, but the girls were so embarrassed that it was a long time before they returned to that same theater.

On the other side of the family, Grandpa Christoforo raised canaries and had a cat for a pet when Dad and his sister, Aunt Mary, were kids. I don't know much about the birds, but understand that Grandpa taught the cat to do things that dogs were trained to do and the cat followed him around just like it was a dog.

The cat didn't show up for dinner one night and was missing for a few days. Grandpa searched for him and only discovered the cat's location when he heard it cry somewhere in the back yard. When he saw the cat, he saw blood on the hind quarter. He picked it up and saw that it had been shot. He held the cat in his arms, walked to the South Ferry, brought the cat to Boston and headed for the Angel Memorial Hospital. The cat was too far gone and had to be put to sleep. When my grandfather was back home, he asked all of the Chelsea Street neighbors if they knew anything about someone shooting animals in the neighborhood. He did find out who did it, but the rest of the story is not printable.

Years later, when we moved to Belmont, I inherited a dog from an old girl-

U.S. Senate Debates Federal IDs for All

together the Haymarket and the Public/Farmers Market being developed on Parcel 7 into a viable expanded Market District.

Now it appears that not only is the hotel proposal a bad idea, but a bad financial risk. Considering the statements made by the very individuals seeking to build the hotel on Parcel 9 about the difficult economic conditions in the hotel market, and in light of the financial difficulties they have encountered on their other two Boston hotel projects, it makes no

sense for the state to pick a hotel project for Parcel 9. This is especially true when the alternative to choosing the hotel is a project which would expand the Market District has broad support from the community, local public officials, the Haymarket vendors and the project Advisory Committee and involves a development team looking to be involved for the long-haul and not just secure the permitting approvals and sell off the development rights to third parties.

HOOPS and HOCKEY in the HUB

He was the only player on the roster never to see ice time during the Bruins post-season run to the 2011 Stanley Cup Championship.

Night after night he sat on the bench as his teammates went over the boards and onto the ice. It was his fate to be the backup to the best Bruin that spring during two of the most memorable months in Bruins history.

The player who played every moment of every game that special spring was Tim Thomas, a veteran goalie who was in the culminating stages of a personal ice hockey odyssey that had seen him languish in the minor leagues for years before finally joining the B's and gradually blossoming into the star of wonder that captivated the hockey world.

He was the man of the hour, the days, the weeks and the months. When it was all over, Tim Thomas had etched a personal saga into Stanley Cup history and left a legacy that may very well not be equaled in Bruins history.

But over on the bench there was the forgotten one. The one who came to practice every day, got ready every day and was present at every one of those Stanley Cup games just in case he was needed. For every single one of those 25 playoff games that spring he never was.

He is Tuukka Rask, a player born and raised in Finland who has been with the B's for a number of years, a player who got his start as a backup to Thomas and got thrown right into the everyday mix when Thomas went down with an injury in March of 2010.

And step right in he did. He wound up the 2009-2010 regular season by playing in 45 contests and coming away with a Thomas-like goals against average of 1.97.

Then came the playoffs and the Bruins laid an egg — a big one.

The B's got by Buffalo and then faced the Philadelphia Flyers, who had qualified for the playoffs on the very last day of the regular season by beating the New York Rangers.

Everything looked fine as the B's jumped out to a 3-0 lead in games. But the Flyers clawed their way back to even the series at 3-3. Even in Game 7 the B's burst out to what appeared to be a commanding 3-0 lead but the Flyers came back to erase that deficit and eliminate the Bruins. It was one of the worst collapses in Stanley Cup history. It was a team malfunction for sure. But the last line of defense always gets more scrutiny. And that last line was Tuukka Rask.

Like Coach Claude Julien, Rask was back the next season for the regular season that culminated in the Stanley Cup run. Although he didn't see action in the playoffs, he did play 29 regular season contests as a backup to Thomas, earning a 2.67 GAA. Last year he played in 23 more, coming away with a 2.10 GAA.

What was all that over the years? That was seasoning, according to Julien, who believes it takes goaltenders the longest to develop.

"I've always said that for a goaltender to be successful it's important that he have some maturity and that does take a little longer. That's my personal view. I've always felt the goalie takes a little longer (to develop) than forward players and defensemen."

In addition, Julien thinks Rask has been in a setting that's been beneficial to "I think he's been fortunate to be here. I also think we've been fortunate to have him here with a good goaltender like Tim Thomas. So he learned the ropes right away. He was allowed to grow at a decent rate and now he's ready for it. Having been here for a number of years, he's a goaltender ready to take over."

And with Tim Thomas' departure to Colorado for what looks like retirement, Julien has put his faith in Rask.

"Right now, there no doubt I have the same confidence (that he had with Tim Thomas). At the same time, Tuukka is going to want to prove himself through a whole year, not just a 20-game span. He's going to want to be solid from start to finish. I think that's his challenge and he's looking forward to it."

And his teammates have been impressed thus far.

"We call him quick like a cat because he's so quick," observed Nathan Horton.

"He's been doing that all year, every game. He's such a great guy. We just want to see him do well. He's been amazing for us."

"He's playing great," chipped in Andrew Ference. "I don't think he's really surprising anybody. He's been solid for us for a number of years. He's been just kind of waiting patiently. I know everyone want the best for him so it's really nice to see him doing what I think everybody hoped and expected he would do. He's living up to expectations, which is not easy to do, especially in that position."

As for himself, now that he's playing regularly, Rask

definitely notices a difference. "I feel good out there. Sometimes when you don't play that much, you jump in there and it feels like the games are really fast — and you don't see those pucks so well. But right now things are kind of moving along and the puck seems to find a way to hit me."

So far he's kept those pucks out of the net at a rate that's good enough for a 2.09 GAA through early March.

It's Tuukka's time and how far the B's go this spring will definitely depend on him. If the first third of the abbreviated season is any indication, a long run in the playoffs awaits.

In order to be eligible and responsible to bid on this contract General Bidders must submit with their bid a current Certificate of Eligibility issued by the Division of Capital Asset Management and an Update Statement. The General Bidder must be certified in the category of **ELECTRICAL**.

The estimated contract cost is **NINE HUNDRED THOUSAND DOLLARS** (\$900,000).

Bidding procedures and award of the contract and sub contracts shall be in accordance with the provisions of Sections 44A through 44J inclusive, Chapter 149 of the General Laws of the Commonwealth of Massachusetts.

A proposal guaranty shall be submitted with each General Bid consisting of a bid deposit for five (5) percent of the value of the bid; when sub-bids are required, each must be accompanied by a deposit equal to five (5) percent of the sub-bid amount, in the form of a bid bond, or cash, or a certified check, or a treasurer's or a cashier's check issued by a responsible bank or trust company, payable to the Massachusetts Port Authority in the name of which the Contract for the work is to be executed. The bid deposit shall be (a) in a form satisfactory to the Authority, (b) with a surety company qualified to do business in the Commonwealth and satisfactory to the Authority, and (c) conditioned upon the faithful performance by the principal of the agreements contained in the bid.

The successful Bidder will be required to furnish a performance bond and a labor and materials payment bond, each in an amount equal to 100% of the Contract price. The surety shall be a surety company or securities satisfactory to the Authority. Attention is called to the minimum rate of wages to be paid on the work as determined under the provisions of Chapter 149, Massachusetts General Laws, Section 26 to 27G, inclusive, as amended. The Contractor will be required to pay minimum wages in accordance with the schedules listed in Division II, Special Provisions of the Specifications, which wage rates have been predetermined by the U. S. Secretary of Labor and /or the Commissioner of Labor and Industries of Massachusetts, whichever is greater.

The successful Bidder will be required to purchase and maintain Bodily Injury Liability Insurance and Property Damage Liability Insurance for a combined single limit of **TEN MILLION DOLLARS** (\$10,000,000). Said policy shall be on an occurrence basis and the Authority shall be included as an Additional Insured. See the insurance sections of Division I, General Requirements and Division II, Special Provisions for complete details.

No filed sub-bids will be required for this contract.

This Contract is also subject to Affirmative Action requirements of the Massachusetts Port Authority contained in the Non-Discrimination and Affirmative Action article of Division I, General Requirements and Covenants, and to the Secretary of Labor's Requirement for Affirmative Action to Ensure Equal Opportunity and the Standard Federal Equal Opportunity Construction Contract Specifications (Executive Order 11246).

The General Contractor is required to submit a Certification of Non-Segregated Facilities prior to award of the Contract, and to notify prospective subcontractors of the requirement for such certification where the subcontract exceeds \$10,000.
