## No Leinance ... Only Justice **Tsarnaev Guilty on All Counts**

On Wednesday afternoon, April 8, 2015, Dzhokhar Tsarnaev was convicted in the Boston Marathon bombing trial. Tsarnaev, 21, looked on, with arms folded at his defense table, listening to one guilty verdict after another. In the end, he was found guilty on all 30 counts, 17 of which are punishable by the death penalty.


Many court experts had predicted a long deliberation, but in the end the jury needed a little more than a day and a half to reach a verdict. The federal grand jury found Tsarnaev guilty in the deaths of three spectators, Krystle Campbell, Lingzi Lu and Martin Richard, along with MIT police officer Sean Collier, shot in Cambridge on the following Thursday.

The Boston Marathon has been forever changed by this

heinous act of terror and will always be a bittersweet day in our city. It was just an-other Marathon Monday on April 15, 2013 until two shrapnelpacked pressure cookers placed by Dzhokhar and his older brother Tamerlan exploded near the finish line wounding over 260 spectators along with three mortally wounded victims. The annual Patriots' Day celebration in-

of mass carnage. Tamerlan, 26, died during a shootout in Cambridge, run over by Dzhokhar during his getaway attempt.

Can there ever be closure to this? The answer is prob-



stantly turned into a scene ably not. How can the many victims and their families move on from seeing loved ones die or maimed forever? The jury heard the heart wrenching testimony of Bill Richard, who lost his son on that tragic day. Richard described in detail having to make the heartbreaking decision to leave his mortally wounded lit-tle boy to help his six-yearold daughter. We also will remember forever heroes who ran into the carnage and the first responders who aided victims.

At the time of the bombings, I was two weeks away from re-

tirement as a police officer and can remember the general panic over this attack and the massive shutdown and dragnet that ended in a

boat in the backyard of a Watertown home where Dzhokhar was hid-ing. Everyone was relieved by his capture, but our sadness continued, as it does today.

On this Wednesday, the younger Tsarnaev came increasingly closer to meeting his fate. Next week, the jury will determine the fate of the defendant; whether he will be executed or live out his life behind bars at the expense of the people he and his brother wanted to exterminate. Either way, justice will have been served, but closure likely will never come for those whose lives were ripped apart on an otherwise beautiful April Monday two years ago.

We remain Boston Strong and we will persevere.

#### Does Cruz Have a Strong Enough Primary Base?

I like U.S. Senator Ted Cruz, R-Texas. I like his stances on the major issues facing America, but can he put together a coalition large enough to win the nomination, and if he does, how does he win in November 2016?

There are four Republican wings: the evangelicals, the strongly conservatives, the somewhat conservatives and the moderates. Between 35-40 percent are somewhat conservative.

# Stirpe Nostra

A weekly column highlighting some of the more interesting aspects of our ancestry . . . our lineage . . . our roots.



Jupiter was the Roman counterpart to Zeus. In the list of Principal Roman deities, Mars appears to have been second only to Jupiter and he was held in verv high regard by the Latins from the earliest times. Probably the most important reason for that kind of reverence was the fact that Roman legend names Mars as the father of Romulus, founder of Rome. Mars was believed to be the son of Juno (Hera in Greece) who bore him after touching a wonderful spring-flower (a likely story).

In addition to his position as the god of war, Mars also became known as one of the mightiest gods of nature. As a nature god, he accorded fertility and protection to fields, herds, and families, and was invoked at blessings during spring festivals to keep the crops free from sickness, bad weather, and any other kind of harm. As god of war, the symbols of Mars were the wild wolf, the woodpecker, and the lance. Before the start of a battle, the legion commander usually sacrificed to this god and would then strike his lance while crying out "Mars awaken!" Sacrifices were made to Mars during campaigns, while military honors for valor were

also conferred in his name. During early times there were about eight open areas or plains in the roman capital that were set aside for exercise or amusement. The most celebrated plain was the one consecrated to Mars and called the "Campus Martius." Teams of horses called "Equirra" competed in mock war games here about threetimes a year. One of the participating horses was sacrificed to Mars at the end of the games. The horse's blood was

collected, preserved in a temple, and entrusted to a special priest (flamen Martialis) where it was used only for purposes of purification.

During ancient Roman times the term "flamen" was used to describe "one who kindles the sacrificial fire." Flamen was also used to identify a special kind of priest in the worship of their gods. There were fifteen flamen, of which three were high priests known as "flamines Majores". One of these high priests was called "flamen Dialis" or the high priest of Jupiter, the second was named "flamen Martialis" or the high priest of Mars, and the third was called "flamen Quirinalis" in honor of "Quirinus," the Sabine equivalent of Mars, who was worshipped as the founder of the old Roman capital.

Lastly, we find that even Emperor Augustus got into the act when he built a magnificent temple to this god and named it "Mars Ultor" (Mars the Avenger). It was built in appreciation for the assistance he had received when he defeated Brutus and Cassius at the Battle of Philippi in 42 B.C., thus avenging the murder of his ancestor Julius Caesar.

#### BERGDAHL PUTS BULLS-EYE ON U.S. TROOPS

As a Vietnam War veteran, I am at a loss over why the Obama White House with the consent of the Joint Chiefs of Staff made the decision to trade off five Taliban biggies for Private Bowe Bergdahl last May.

At the time of the release, when an immediate uproar began, Susan Rice stated that Bergdahl served his country with honor and distinction and further stated that we never leave anyone behind. That press conference in the Rose Garden last summer still galls me. One would think Bergdahl had just won the Congressional Medal of Honor.

## L'Anno Bello: A Year in Italian Folklore

Opening Up to April

Easter Sunday has passed, but there is still a whole month of spring and sunshine to enjoy in April. April smells like fresh flowers and the pungent scent of trees after a delicate rainfall, like balmy breezes and juicy strawberries. As I sit to write this article, a soft rain drizzles down outside the window, making the grass seem lush and greener than a mint sprig, the pavement shiny and smooth like obsidian. I am reminded of the old rhyme I cheerfully intoned as a young girl: "April showers bring May flowers!" Indeed, April is the time of the year when spring finally feels in full bloom, when flowers, rain and abundant sunshine meld together to form an energetic, playful month. The origin of April's name also reflects its qualities of rejuvenation and rebirth. April derives from the Latin word aperire, which means "to open." Truly, all of nature is opening and awakening at this point, from the purple tulips peeking out of the dirt to the buds on tree branches and the baby animals walking on wobbly legs. As the Latin origin of the name suggests, April is a significant month in Italy. Not only is it a full month of spring and the frequent home of Easter, but April brims with its own folk traditions, holidays and customs particular to Italy. The following is a sampling of these quirky and culturally rich practices:

• April Proverbs: Italian folklore abounds with multiple proverbs related to months and times of the year. These hearken back to the days when Italian society was primarily based on agriculture. Farmers needed to pay special heed to the weather in order to determine important and vital times like when to plant and what crop yields to expect. As such, most of the Italian proverbs related to April (which I gathered from the wonderful website italyrevisited.org) concern themselves with the weather of the month. One proverb declares: "L'Aprile piovoso,



fa il Maggio grazioso." Translating to "a rainy April makes a grateful May," this is the Italian version of the April showers bring May flowers dictum. Another proverb says "Marzo tinge, Aprile dipinge" - meaning that what March dirties, April cleans up; just as April rains and vegetation takes over the muddy or snowy changeable weather of March. However, another proverb admonishes "Aprile, non ti scoprire." It warns against discarding your coat during April, as there are still cool days left!

• Rome's Birthday (April 21st) and St. Mark's Day (April 25th): Italy is filled with many city-specific holidays, and two of the most intriguing fall during April. Rome's Birthday honors the founding of the city, all the way back in 753 B.C. Romans celebrate with festivals, parades, concerts, and firework displays throughout la cittá eternal (the eternal city). Four days later, the charming maritime city of Venice displays similar gaiety for St. Mark's Day, or Festa di San Marco, the feast day of Venice's patron saint. Carnivals, markets and parties center around the enormous St. Mark's Square, the beating heart of the city. Celebrate both holidays by enjoying food from each region. How about a plate of spaghetti alla carbonara (spaghetti with egg sauce) on Rome's Birthday and some risi e bisi, or risotto with peas, on St. Mark's Day?

• Liberation Day (April 25<sup>th</sup>): This patriotic holiday honors the liberation of Italy from Nazi and fascist occupation during World War II. On April 25 of 1945, the cit-

ies of Turin and Milan were the first to be freed from the occupation, and their liberation prompted a chain of events which culminated in Italy's freedom. Italy celebrates Liberation Day, or Festa della Liberazione, with processions, speeches and countrywide events. My ancestors, including my grandparents, still lived in Italy during the Second World War and had to deal with all the horrors that accompany an armed conflict, from bombings to mob violence to food shortages. As such, I always feel compelled to remind people of this springtime feast, a holiday commemorating the ordinary Italians who fought so hard to free their beautiful land from the terror of fascism.

• May Day Eve (April 30th): I love this holiday! Since ancient times, European folklore has attributed the first day of May with magical properties. People believed that elves, fairies and witches were especially active on this day. In Italy, May Day is known as Calendimaggio, and celebrations begin the night before, on the last evening of April. #### Iran Played Us Good

Well, according to all the newspaper headlines on Good Friday, the United States, Iran and five other world powers came to an "affirmation" on a pact that will be completed and signed in June.

The day before, President Obama held another of his Rose Garden appearances where he basically said the deal about to be signed is the best thing since the invention of sliced bread. He said it would be clearly verifiable for the world to see. He also took time to chastise his Republican critics. He made it a point to state that this would be a deal between not the Obama White House and Iran, but between the United States and Iran. However, that can't happen until the U.S. Senate does its constitutionally charged duty to ratify the agreement. If the Senate doesn't, this pact, which will be a U.N. Treaty, will have no force of law for the United States.

We have a president who clearly sees himself as a citizen of the world, where apparently he holds more faith with the impotent United Nations than he does with the Legislative Branch of our federal government.

The Iranian Republic, and I use the term loosely, has "played us." Instead of a bad deal in April, we could get a worse deal by June during the affirmation period. Already, inspections of their nuclear facilities must be planned with the Iranians. No surprise visits to see what is really happening I guess.

My father used to read a lot of history going back centuries. He studied a guy named Sun Tzu from China and found him quite interesting. Five centuries before the birth of Christ, he wrote "The Art of War" in which he advised that "the supreme art of war is to subdue the enemy without fighting." Sun Tzu knew that "all warfare is based on deception." This great general told the troops to "let your plans be dark and impenetrable."

The Islamo-nazis of Iran know the ancient strategy of Sun Tzu well and used it in Switzerland at the negotiation table with China, Russia, Britain, France and Germany. It was their battlefield and they came out pretty much the real winners in Switzerland.

The Obama White House has painted itself into a corner of its own making. While Obama seems to play politics, the Iranians play realpolitiks.

The White House seems on an ill-advised course of pushing the Republicans into supporting its historic deal. White House flak Josh Not-so-Earnest accuses the GOP of pushing something "not at all in the best interests of the United States."

From this view, it looks like just the opposite. Iran feels emboldened into becoming the Big Man in the Mid-East, which will only bode ill for any so-called peace in the Mid-East or in the world.

Those who do not learn from the past are only doomed to repeat it.

## Saint Lidwina of Schiedam

St. Lidwina of Schiedam 1380 - 1433 Memorial - 14 April Patroness of Skaters and the Chronically III

Lidwina was born at Schiedam, Holland, April 18, 1380 though her father Peter was from a noble family, he was quite poor. Her mother Petronella, born at Kethel, Holland, was a poor country girl. Very early in her life Lidwina was drawn towards the Blessed Mother and prayed often before the miraculous image of Our Lady of Schiedam. During the winter of 1395, Lidwina went skating with her friends, one of whom caused her to fall upon some ice with such violence that she broke a rib on her right side. Gangrene appeared in the wound caused by the fall and spread over her entire body. For years she lay in pain which seemed to increase constantly. She became bedridden and suffered the rest of her life from various illnesses. Lidwina had a wonderful gift of prayer and also visions, numerous miracles took place at her bedside.

From her fifteenth to her fifty-third year, she suffered every imaginable pain. In a vision she was shown a rosebush with the words, "When this shall be in bloom, your suffering will be at an end." In the spring of the year 1433, she exclaimed, "I see the rosebush in full bloom!" She passed away on Easter morning 1433, she was in deep contemplation and beheld, in a vision,

Christ coming towards her to administer the Sacrament of Extreme Unction.

Immediately after her death, her grave became a place of pilgrimage, and as early as 1434 a chapel was built over it. Joannes Brugmann and Thomas à Kempis related the history of her life, and veneration of her on the part of the people increased unceasingly. In 1615 her relics were moved to Brussels, but in 1871 they were returned to Schiedam. After being venerated for centuries, Saint Lidwina was canonized on March 14, 1890 by Pope Leo XIII. She is Patroness of the chronically ill, ice skaters and town of Schiedam



#### **ELEANOR OF AQUITAINE (1122-1204):**

The First Modern Woman



Of course, what angered the French nobility is precisely what makes her such a fascinating figure to contemporary historians. She was one of the first women to not only fund a war, but also fight in one. Her claim to fame, though, was also a blotch in her legacy. The Second Crusade proved a disaster and the army of her first husband, Louis VII, suffered tremendous casualties at the hands of the Turks. This was hardly Eleanor's fault. In 1141 she had supplied Abbé Bernard thousands of military vassals and, though she stood by her husband in the Crusade, supporting the original intention of recapturing the city of Edessa, she foresaw the fatal error of King Louis' path toward Jerusalem. Her calculations proved correct and the King's army was slaughtered by the thousands near Mount Cadmos in an ambush. Disguised in a tunic, King Louis VII escaped with his life but with a lot of explaining to do. Eleanor's greatest loss in the battle was that of her uncle Raymond who had tried to steer the army in the right direction, but was overridden by King Louis.

An ill-tempered man who

Louis was not about to let his reputation among the French royalty be tarnished so he placed the blame indirectly on his wife (criticizing the actions of one of her vassals), while also fighting to preserve their marriage. At the time, because of the King's influence in France, many historians and scribes took his account, accusing Eleanor of slowing down the army and its lack of preparedness. By the late 1100s, the pristine reputation of Eleanor of Aquitaine was beginning to diminish in France.

The aftermath of the Second Crusade was the beginning of the end for Eleanor of Aquitaine and Louis VII. They bore two daughters but the commitment was over. The King himself saw as much and in 1152 conceded to divorce. An annulment was granted in March of that year by Archbishop Hugues de Toucy. That same year she remarried Henry Duke of Normandy in a quiet unceremonious ritual. With him she had five sons put pride above all else, King (something she couldn't give

Henry VII, much to his chagrin and something that led to their marriage annulment) and three daughters.

History has been kind to

Eleanor of Aquitaine and she remains one of the few figures who were controversial in their day but have been vindicated by time. If nothing else, everything that Eleanor of Aquitaine did was unprecedented in her day. She was already a much desired heiress before her marriage to Louis VII, but it was after their marriage that she made history. In a time when women of royal blood were relegated to the court, she was actively involved in blueprinting the direction of the Second Crusade and had her husband followed her advice, he may have avoided a massacre. At the very least, history has proven her to be a sound military strategist, a topic woman were not allowed to venture in. The turbulence of her first marriage (after the failed Crusade, she and Louis VII sailed back to France on separate ships, still hostile over the turnout) is testament to her strong will and free-spirit. If there was one woman who braved the scandal and stigma attached to divorce it was Eleanor of Aquitaine and her noble lineage continued after her second marriage. Almost as if in accordance with her groundbreaking life, she lived to an unusually old age for her time, dying in 1204 at the age of 82, well into the political careers of her children. Her legacy was secure.





But in a stunning reversal, the U.S. Dietary Guidelines Advisory Committee recently recommended no longer listing cholesterol as a "nutrient of concern," That turnaround is in keeping with mounting evidence that for most healthy adults, eating foods high in cholesterol does not significantly contribute to the amount of cholesterol found in the blood most of which is produced naturally by the body. Doctors warn that individuals with health problems such as diabetes or heart disease should continue to avoid high-cholesterol foods, but such foods' overall impact on good health may be less significant than was previously thought. "It's turned out to be more complicated than anyone could have known," says Wake Forest University biochemist Lawrence Rudel. "Eating too much a day won't harm everyone, but it will harm some people.'

Americans today consume nearly the same number of calories - about 3,400 a day — as Americans in 1910 did, but the weight of the average American has increased substantially due to lack of exercise.

#### PASTA FAGIOLI

Pasta with Beans

- 1 can cannellini beans (white beans)
- 1 medium onion chopped 2 garlic cloves chopped (optional)
- 1 minced fresh tomato (optional)
- 4 tablespoons olive, canola, or vegetable oil

1 can chicken broth (optional) ½ pound pasta of choice grated cheese of choice

(optional)

In saucepan, heat oil over medium heat. Add chopped onion and simmer until onion is lightly browned. If using chopped garlic, add to onion. Stir and cook for a few seconds. Garlic should not brown. Add minced tomato (optional), stir, and cover. Simmer for about five minutes. Then add can of cannellini beans and stir. Cover cook over low heat for a few minutes. If sticking, add a little water or some chicken broth. Cover and simmer for about five minutes. Salt to taste. Remove from burner and set aside.

Cook pasta of choice according to directions on the package. After draining cooked pasta, place it in a larger serving bowl. Add beans to the pasta and stir before serving in individual bowls. Serves two.

NOTE: One of my favorite pasta with the beans is the small shell. However these healthy, hearty beans are delicious as well with Ditalini or elbows. I remember Mama sometimes cutting up spaghetti into one-or-two-inch portions and cooking that for serving with the beans.

This is a meal frequently called "pasta e fasulli." It seems every Italian dialect has its own pronunciation for this wholesome and frequently prepared meal during the depression years.



## News Briefs

THE SOLAR SYSTEM: NASA'S SPACE TELESCOPE KEPLER, WE'RE NOT ALONE! Space exploration continues to uncover new planets well outside the solar system, in the process creating a new map of the universe, unthinkable only a few years ago. The "Kepler" was sent into space in 2009. It quickly began to collect images and data about 150,000 stars. In 2013, one of the reaction wheels malfunctioned causing the shutdown of its activity, risking the telescope's demise, to end its mission. The "alien" planets discovered now number 1,700. They rotate around 305 stars, in planetary systems somewhat similar to our solar system. NASA published a sizable part of the discoveries in the Astrophysical Journal. The astrophysicists have discovered the new planets by analyzing data collected by the telescope in May 2009 and in March 2011. About 95% of the new planets are smaller than our neighbor Neptune, which is four times the size of Earth. Some are smaller than Earth and were found in an area defined habitable, where water at the liquid stage and forms of life may exist. The researchers have focused their attention on a planet they have called "Kepler-2965," twice the size of Earth, whose orbit is around a star which is half our sun. It could be a world similar to Earth, except scientists have not been able to understand if this planet is gaseous or as rocky one as the Earth. The discovery of all those planets outside our system establishes an unprecedented step forward to pinpoint worlds of smaller dimensions. The plan to launch a new telescope in 2018, the "James Webb," that may be able to study in details the new worlds discovered by Kepler. To talk of habitable worlds that may offer some form of life is, for now, a little premature!



With the Bulldogs gone following a mediocre 4-4 1929 season, Boston would get a second chance at a pro team in 1932 when the National Football League awarded West Virginia native George Preston Marshall and two minority owners a franchise. Remnants of what had been the Newark Tornadoes, the move

was symbolic of a burning desire by the NFL to have a presence in Boston.

Originally named the Braves, a name chosen because the team shared the Wigwam" Braves Field with baseball's National League Braves, Boston won its first game on October 9, 1932 in a 14-6 home win over the New York Giants. Similar to the Boston Bulldogs, the Braves first season would end with four wins and four losses and two ties.

Unlike the Bulldogs, the team would survive to see a second season in Boston, although its name did not.

With his two minority owners backing out, after one season, Marshall now held unlimited power over the team. He decided to rename it the Redskins, working out a deal with the Boston Red Sox to call Fenway Park home. Marshall also hired Head Coach William Henry "Lone Star" Dietz. Dietz claimed to have been of Native American descent but most likely fabricated this to get out of combat in World War I.

A popular rumor is that Marshall renamed the team in honor of his new coach and the fact that four players on the squad were of Native American descent. However, a 1933 article in the Hartford Courant quotes Marshall as putting this theory to rest. "So much confusion has been caused by our football team wearing the same name as the

Boston National League baseball club that a change appeared to be absolutely necessary. The fact that we have in our head coach, Lone Star Dietz, an Indian, together with several Indian players, has not, as may be suspected, inspired me to select the name Redskins."



Today, a push exists to change the name of the franchise, now in Washington, from the controversial "Redskins." If the team wasn't named out of a sort of bigotry for his coach and players, where did Marshall get the name? Perhaps Marshall was peeved that the Braves had asked him to find a new home field, causing him to distance himself from them. To date, there is no confirmation.

Marshall was well regarded as a racist, in modern day football, he would have never been allowed to own an NFL franchise. His team was the last in the NFL to add an African-American player and he would often be seen wearing ceremonial Indian head-dresses during games or at other functions in an attempt to draw in fans.

When visiting the TD Garden, home to the Bruins and Celtics, take a walk up to the second floor to the Sports Museum. On display you will find a 1935 Redskins sweater among other memorabilia.

By 1936, the Redskins time to shine had arrived. Under Head Coach Ray Flaherty, Boston went 7-5, clinching the NFL's Eastern division, a first in Boston pro football history.

On December 13, 1936, at the Polo Grounds in New

York, the Redskins met the Green Bay Packers led by the legendary Earl Louis "Curly" Lambeau. The Redskins were not yet ready for prime time as evidenced by the Packers 21-6 win.

The championship game was to be played in Boston, however Marshall decided the Polo Grounds was a more prominent and suitable location.

The teams' future looked promising, however Marshall believed that future should be in the nation's capital, moving the franchise to Washington, D.C. citing dwindling fan support in Boston.

That season, the Redskins won their first title, besting the Chicago Bears 28-21 in the 1937 NFL Championship game.

So close with the Redskins, Boston would have to wait 65 years for its first NFL title.





### HOOPS and HOCKEY in the HUB

excitement and expectation in the Boston Celtics regular season that time is now. By the time the clock clicks down towards midnight on April 15 — the income tax filing deadline — the C's will know their fate. Whether they have made it into the 2015 NBA playoffs or will be having another extended summer break will be decided before another week has passed.

As in all the pro leagues, it is far more important to be playing your best at the end of the season, rather than in the first part. True, early season victories can provide you with victories in the bank, but only quality play at this time of year can provide the possibility of peak playoff performance. Judging by their play over the last several weeks, the Celtics have indeed saved their best for last.

And, really, when you think about it, the Celtics really experienced at least two different extended spans of results during the 2014-2015 regular season. If you recall there were all those nights early in the season when the Celtics were essentially a first half team. They would take the lead (and sometimes a very large one) at some point during the first half, go into the locker room for halftime and then emerge onto the court for the final 24 minutes as basically a totally different squad.

Over the course of the second half, that night's opponent would gradually assume the lead. Some nights it might be as early as the third quarter, while on others it might not occur until the latter stages of the fourth. But whenever it occurred, another potential victory had slipped through the hands of the Green, replaced by another sad setback — many times in front of a still loyal home crowd.

In mid-December the move that everyone knew was coming took place. Sports Illustrated had predicted in its NBA preview edition that Rajon Rondo, the last player on the roster from the 2008 NBA Championship team, would be gone by the league trade deadline in February. Technically, the magazine was correct but in reality the deal with the Dallas Mavericks had nothing to do the league-wide deadline.

By the time that rolled around Rondo was history and a new player had been acquired, Isaiah Thomas from the Phoenix Suns. The deadline also put a stop to roster movement that had become a spigot. Some 25 players had been on the roster for at least one night. When the deadline passed that stopped and the composition of the team was set for the stretch run. Head coach Brad Stevens had a perma-

> The improvement didn't happen right away. Many observers pick the portion of the season following the annual All-Star break as the demarcation line. When the Celtics resumed action, they appeared to be a different team, more energetic, more focused, more positive and in general possessing a new persona that saw them fight to the finish in the vast majority of games. The addition of the talented Thomas helped immensely. Yes, they still lost, but on those nights that they did, they did so without a defeatist attitude. They took the setback and learned from it.

> But, on many more nights than in the first portion of the season, they won. They won going away, they won by coming back, they won in the last minute but they won. They also won enough to bring them into contention for a playoff berth—something that many felt back in October was just about impossible. After all, this was supposed to be another rebuilding year.

And while the offensive side has dramatically improved — especially with the addition of Thomas — Stevens has indicated that it is the defense that may well be the deciding factor concerning whether the team makes the playoffs or not.

"The effort has really been good," said Stevens following a recent game. "We talk about it before every game. We have to play with a defensive DNA. We have to make it part of who we are every day. That's got to continue to be the emphasis. I think that's a good emphasis to have because you're focused on what you can control and nothing else."

Making the playoffs would be a big plus for the Celtics. They are a young team and even if they didn't get by the first round it would give the players a muchneeded introduction to the post-season atmosphere and environment.

Remember, in college you do not play a best-of-seven series against an opposing team. The NCAA "March Madness" Tournament is a one-and done-deal. You win and you go on. You lose and you go home.

In the NBA playoffs you may lose a game or two (even three) but you continue on to play another day. Nothing beats experience. Thus making the playoffs this year, even if they do not go far, would be a very helpful introduction to the playoffs for the young Celtics as they continue their upward progress.

We'll know shortly how it all turned out but one thing is for sure. The last couple of months in the regular season has been one exciting time.
