Three successful Italian-American civil and public servants and 30 accomplished scholarship recipients will be honored at the Fourth Annual Massachusetts Education and Law Awards. The event, hosted by the Commission for Social Justice and the Scholarship Commission under the auspices of the Grand Lodge of Massachusetts, will take place on Sunday, May 7, 2017, at the DoubleTree by Hilton in Andover, Massachusetts.

The Commission for Social Justice is pleased and honored to announce the following recipients of this year's awards.

This year's "Justice Award" recipient is the Honorable Dennis J. Curran, an Associate Justice of the Massachusetts Superior Court. Judge Curran earned his bachelor's and master's degrees from the University of Pennsylvania, and Juris Doctorate from the University of Virginia. He was a Boston trial attorney for over 20 years. He served as the First Assistant Legal Counsel to the Governor of Massachusetts from 1970-1983,


(Major Violation's Division), and as Suffolk County District Attorney from 1977-1979. He was first nominated as an Associate Justice in the District Court in 2002 by Governor Jane Swift. A year later, he began to serve in the newly constructed Boston Municipal Court. In 2006, he was appointed to the Massachusetts Superior Court by Governor Mitt Romney. Judge Curran was the recipient of the 2015 Massachusetts Bar Association's Chief Justice Edward F. as Assistant District Attorney Hennessey Award, and the 2016

Massachusetts Academy of Trial Attorney's President's Award for Judicial Excellence. Judge Curran resides in Wellesley with his wife, Dorothy. They have two children and one grandchild.

The recipient of the "Law Enforcement Award" is Alessandro Pizzi, a retired Chief Probation Officer of the Massachusetts Trial Court. He earned his bachelor's degree in Psychology in 1969, and his Master of Arts and Certificate of Advanced Graduate Studies in 1972 from Assumption College. In 1978, he earned his Master of Science in Public Administration from Northeastern University. He served in the United States Coast Guard from 1970-1972. He began his professional career in 1972 on the Massachusetts Rehabilitation Commission, and was with the Probation Department of the Massachusetts Trial Court from 1972 until his retirement in 2009. He has served on the Advisory

Board for the Town of Franklin, and the Franklin Charter Commission. He coached youth soccer for 16 years, and youth baseball for 20 years. He has been a member of the Quattro Eroi Lodge #1414 of Franklin for over 25 years. He resides in Franklin, has three children, and seven grandchildren.

The "Public Service Award" recipient is The Honorable Joseph R. Faretra, Clerk Magistrate of the East Boston District Court. He attended Wentworth Institute of Technology and went on to graduate from the Lincoln College of Technology of Northeastern University with an Associate Degree in Civil Engineering. After graduation, he went to work for the Massachusetts Department of Public Works as an engineer overseeing the construction of the interstate highway system. In 1969, he went to work at the Massachusetts State House, where he

served as Secretary of Social Services to Governor Francis W. Sargent until 1974. In December 1974, he was appointed as the Clerk Magistrate of the East Boston District Court. He has received a number of prestigious awards, including the Distinguished Service Award from the Italian American Civic League for outstanding involvement in the Community. He lives in Winthrop with his wife, Rosalind. They have four children and four grandchildren.

The public servants and scholarship recipients honored during this event are shining examples of the hard work and achievements characteristic of the Italian-American community and our young scholars and leaders. We hope that we can provide a unique opportunity for the recognized students to witness and celebrate the successes of accomplished professionals, and for the Law and Justice awardees to meet and inspire the best of the younger generation. For the attendees and their families, this event will be the most impressive that the Grand Lodge of Massachusetts has to offer, and will encourage future participation in the Sons of Italy.

CALIGULA

A study of all the stories, events, and characters associated with the rise and fall of the Roman Empire would be like reading an entire library, and would probably take a 100 years to fully understand and record its beauties. A capsule explanation divides the history of Classical Rome into three distinct periods: 1. The Regal Period (the legendary kings like Romulus), 753 to 510 B.C.; 2. The Republic (the time of the great Roman Senate, ending with the death of Julius Caesar), 510 to 27 B.C.; and 3. The Empire (the period of Roman emperors starting with the great Augustus and ending with the pitiful Romulus Augustulus), 27 B.C. to 365 A.D.

During the period called the "Empire," there were many good emperors like Nerva, Trajan, Hadrian, Antoninous Pius, and Marcus Aurelius. Unfortunately, along with the good, they also had to contend with the bad. There were rulers like Caracalla, who not only built one of the world's largest bath tubs, but was also noted for his brutality; Heliogabalas, who was noted for his debauchery; and Commodus, the son of Marcus Aurelius, who was reported to have been the most bloodthirsty and unruly emperor that has ever been recorded in all of history. Those of us who are in good health pay a daily tribute to the memory of this character.

Then there was Nero, the archenemy of all Christians, who was one of the cruelest, de-

praved, and despotic emperors that ever ruled Rome.

Finally, there was a nutcake named Caligula, who was just plain off his "Roman rocker." His reign got off to a pretty good start, but the finish just defies description.

Caesar was the family name of Gaius Julius Caesar, and after his death the title of Caesar was given to all of the Roman emperors from Augustus to Hadrian. References are still being made to these 12 Caesars whose popular names, in chronological order, are: Julius Caesar, Augustus, Tiberius, Caligula, Claudius, Nero, Vespasian, Titus, Domitian, Nerva, Trajan, and Hadrian.

Caligula was born of Germanicus and Agrippina, in an army camp, in the year 12 A.D., and was brought up among the legions. The name Caligula was given to him by the soldiers because of the "caligae," or army boot, that he was required to wear. His proper name was Gaius Caesar Augustus Germanicus and it was the name he preferred. As a young man, while in the court of his grandfather Tiberius, he displayed a naturally mean and vicious temper, a wanton love of cruelty towards persons of lesser rank, and a most abandoned and unprincipled debauchery. He became a most eager witness to tortures and executions of prisoners, and he reveled at night in adultery and gluttony.

Greek and Roman mythology tells of Phaethon, the son of Helios the sun god, who borrowed his father's sun chariot and was about to set the world on fire through reckless driving when Zeus destroyed him with a thunderbolt.

Tiberius often said that to allow Caligula to live would prove to be the ruin of all men and that he (Tiberius) was breeding a viper for the Roman people and a second Phaethon for the destruction of the world.

The will of Tiberius made his two grandsons, Druses and Caligula, joint heirs to his private property. (What a mistake that was!) There are some conflicting reports about the death of Tiberius. One sure bet was that he did not die of natural causes. It was known that his death was

Fake News and the Fake Clinton Narrative

So now there is a book out (which I have not read) revealing problems within the Hillary Clinton campaign for the presidency that doomed the otherwise inevitable election of the most qualified candidate to ever run for president. Losing campaigns are, invariably, followed by analyses that show that despite the outward appearance, everything was fine, but there were problems known at the time to only the campaign insiders that explain the unexpected loss.

I don't buy it. I was not so bold as to confidently predict a Trump victory; I did, however, throughout the campaign, tell friends that she was not, as the news reported, a prohibitive front-runner. I had no special insight into the inner workings of the Clinton campaign; I didn't need any to know that her campaign had trouble from the start.

1. The ninth-year curse. Since WWII, the history of the presidency has been eight years of a Republican in the White House (1953-1961), followed by eight years of a Democrat (1961-1969), and followed by eight years of a Republican (1969-1977). The pattern was broken by Carter, who served but one failed term, and Reagan/Bush with 12 years of Republican presidency. After that, we reverted to pattern with eight years of a Democrat (1993-2001) and eight years of a Republican (2001-2009). All other things being equal, we should have expected eight years of Obama to be followed by a Republican. The mainstream press insisted that Clinton had the advantage because she was of the same party as the popular incumbent. They conveniently ignored that in 1960, Nixon, VP to popular incumbent Eisenhower, could not overcome the ninth-year curse any more than Gore in 2000 could turn Bill Clinton's popularity into a victory in the ninth year. Her party registration was, from the very beginning, a liability, not the asset that the press said it

2. The mainstream press repeated that she was consistently ahead in the polls and had an insurmountable advantage. In fact, to my knowledge, there was no reputable poll that indicated that. The polls showed a slight lead, so small that a true account would have reported it as neck-and-neck. Further, there was one extremely telling number. Clinton never got above 49% in the polls, with Trump trailing slightly in the mid-40s. Clinton was not the incumbent, but she was running as if she were the incumbent seeking a third term. One rule of thumb that anyone who follows political races knows is that, in a two-way race, if the incumbent is polling at below 50%, the challenger will win. You learn this in "Campaign 101;" undecided's break for the challenger.

3. Related to #2 was the fact that Clinton, by one important measure, was one of the most qualified persons to run for president. As former first lady, senator, and secretary of state, she had ample Washington experience and universal name recognition. Yet, with all that going for her, she could not get above 49% in the polls in a race against someone who had never held public office and was prone to intemperate utterances not typical of some-'one seeking the most powerful job on the planet. It didn't take a tell-all-book after the fact to tell me that her candidacy was in trouble.




John E. Benoit

Magical May Day

see that the trees no longer hide their blossoms. Just moments ago, it seems, branches stood bare, with only the tiniest speck of a green bud poking through. Now the vibrant tone of fresh, young leaves fulfills the spring promise made by these delicate early sprouts. Whenever I notice the ever-larger number of trees bursting with frothy green foliage or gossamer purple flowers, I float with excitement over the sheer beauty of nature. From the clouds that scuttle across a sky as a perfectly blue as a robin's egg, to the jewel-toned berries that begin to shine from shop shelves and farmer's markets, the vivacity of spring has encircled the world. With all of this regrowth blooming around us, it is little wonder that the spring calendar is laden with celebrations that call for outdoor festivities, prompting people to enjoy nature. One such seasonal feast, commemorated by our Italian ancestors since ancient times, honors the rejuvenation and fertility of nature that occurs as spring yields to summer. or Calendimaggio, with quaint This folkloric festival is known as May Day, and it renders homage to the trees, flowers, and the mystical transformations of nature that characterize spring. More recently, May Day developed into a labor holiday, one which pays tribute to the contributions and sacrifices of rate the town with spooky lights workers worldwide. In all of its manifestations, May Day focuses our attention to the magic of nature and the rhythmic bloom of a reawakening world.

Looking out my window, I can of a mysterious Saint Walpurga. Since May Day serves as a transitional seasonal milestone, poised on the cusp between spring and summer, people in older times believed that witches, fairies, and sundry other supernatural beings rambled through the Earth during this liminal evening. Contemporary Scandinavians and Northern Europeans still dress like witches on Walpurgis Night, welcoming May Day with bonfires and picnics. Italians also link the month of May with the paranormal. The ancient Romans dedicated May to the worship of the dead, perhaps prompting the old superstition that it is unlucky to marry in May. Europeans now celebrate the woodland sprites thought to be especially active in May, and indeed, May Day festivities revel in the wonder of the springtime forest. People adorn their homes with greenery and, in a remnant of an old fertility ritual to help crops grow, dance around maypoles festooned with garlands and ribbons. Many Italian cities and towns celebrate May Day, festivities. The medieval city of Assisi hosts a Renaissance fair where costumed participants enjoy parades, concerts and balls. The citizens of Nogaredo, a city in the northern region of Trentino, dress up as witches for their Calendimaggio feasts and decoand bonfires. Magic is certainly appropriate for May Day — after all, what greater magic is there than the rebirth of nature in the spring?

flock to the beach or mountains, gather for picnics, or visit famous historical sites. Others attend parades that focus on the achievements of the Italian labor movement, or partake in demonstrations that call for an end to the workplace injustices, which still persist to this day. As part of the Italian-American community, we too can celebrate *la Festa* del Lavoro by ruminating on the remarkable strides that Italians have made in the United States. At the beginning of the twentieth century, most Italian immigrants arrived to America with little money or formal education, but nevertheless worked hard, often in strenuous and thankless jobs, to provide for their families. Italians became particularly active in the labor struggle that rocked the nation at the turn of the century, quickly forming unions, participating in strikes, and raising the demand for shorter work days, injured workers' compensation, and an end to child labor. We should thank the Italians and other immigrant groups for the safety regulations and labor law advancements made in the workplace since those long-ago days. However, la Festa del Lavoro also urges us to continue our ancestors' campaigns. Many labor injustices still exist both in the United States and the world at large, including slavery, children forced into dangerous jobs, and unsafe conditions in factories and mines. Just as flowers and leaves bloom with renewed vigor during the spring, so too should our compassion bloom, and we should strive to make the world a better place for our fellow humans.

May Day is all about rejoicing in the beauty of nature, which manifests itself in a plethora of forms. The rejuvenation of Mother Earth reverberates in the rites of May Poles, flower wreaths, and the decoration of homes with greenery and blossoms, a practice the ancient Europeans called "bringing in the May." The mysterious nature of our world, that shivering sense of excitement that accompanies the unknown, echoes through May Day's emphasis on witches, fairies and woodland pixies. Finally, our human nature, which should always carry kindness and compassion, shines in the way we stand in solidarity with the dignity of others during International Workers' Day. Throughout May Day and the month thereafter, let us aim to incorporate all these aspects of nature into our own souls. Let us make our inner being rise from the depths of winter like spring leaves bursting into the sunlight. Let us open our eyes in wonder as we contemplate the magic present in even the most mundane facets of our everyday lives. Let us dedicate ourselves to the Earth, which we call our home, and to improving the lives of our brothers and sisters who share our planet. By opening ourselves to the magic of May Day, we will foster an eternal spring in our very souls.


Today, the only thing important to many placard-carrying radicals is that everyone should agree with them because they very smart and the rest of us are stupid.

Reagan & Eisenhower Book Lecture

The Friends of the North End Branch Library hosted local North End author Dr. Gene Kopelson the other night at the Library. Kopelson gave a very informative talk about Ronald Reagan's first run for President in 1968, which was unsuccessful. Kopelson studied this period in history because he felt no other historian had adequately covered Reagan's political beginnings. Although his book, Reagan's 1968 Dress Rehearsal: Ike, RFK, and Reagan's Emergence as a World Statesman, narrates a much wider topic, Kopelson focused his talk on the relationship between President Eisenhower and Mr. Reagan, who was not in politics at that time. According to Kopelson, President Eisenhower encouraged Mr. Reagan to enter politics and gave Mr. Reagan moral and practical support. President Eisenhower and Ronald Reagan had similar policy ideas, agreeing on having a smaller federal government, foreign policy though the show of military strength and threats, and common sense solutions to domestic issues. Kopelson spent years researching his new book at both the Eisenhower and Reagan Presidential Libraries, including listening to newly uncovered audio tapes of Eisenhower and Reagan that were not previously studied by researchers. If political history interests you, especially from a Republican perspective during the 1960s and 1970s, then this book is for you.

Dog Behavior: People and Kids

A new baby in the house can be very stressful for new parents, especially if there are other children to care for. You might feel that you no longer have time for your pet, or the pet might be a danger to your child. Don't believe any of the old wives' tales about animals being vindictive and jealous towards children; most pets accept new children when it's handled correctly, and if you are prepared to work with your pet. Most problems result from pack order problems — the dog does not want to relinquish his status in the "pack." You should start dealing with this issue well before your new arrival arrives. You might want to speak to a professional behaviorist if you think your pet might be "jealous" of your child. Most problems, including bites, between kids and household pets are entirely preventable. Parents must closely supervise their kids and animals when together — NEVER leave a young child unattended with a pet. The age at which they can spend any time together without supervision depends on the maturity of the child and the temperament of the pet. It only takes a split second for a move from a child to turn into a bad move from the pet, and injury occurs. Dogs sometimes see children as subordinate members of the pack who need to be put in their place, and a trainer or behaviorist might be able to help you immensely. But if your pet is showing signs of aggression, and you truly believe your children are in any danger, it would probably be best to find a home with a person prepared to deal with your pet. Children also need to be taught to respect their pet's needs and feelings; empathy for others is a very important lesson!

This said, NO child should be expected to fully care for a pet until they are mature enough to care for themselves. No matter what a child promises, they ARE only children and will need help from their parents. Parents must realize that when getting a pet for their child, THEY will end up taking care of the pet. If this is not acceptable, then do NOT get the pet to begin with! Too many animals die in shelters for this reason.

Also, too often a parent expects the pet to respect the child more than they expect the child to respect the pet. This is quite an unreasonable expectation.

Dogs are turned into shelters and destroyed daily for biting kids who have poked them with sticks; teasing them, especially when the dog is tied up and frustrated about its inability to leave a bad situation (and if the chain or rope breaks?), small kids bouncing on them, hitting them, or trying to ride them, etc. The pet must pay, usually with its life. Teaching children the safe ways to approach all animals, to respect them and treat them kindly, and to make sure pets are well-socialized, trained, and protected from unruly children is the safest way to give a pet and a child that potentially incredible relationship they can have with each other. Each time a child is good to an animal, he or she is teaching that animal that kids are nothing to be afraid of and lessening the chances that the animal will ever threaten a child. It's a training process that lasts a lifetime, for both the child and the pet.

Meanwhile, if your spouse, boyfriend, or girlfriend is having a problem with your pet, you must try to find out why. Often with dogs, pack order is a problem here also. If a dog is living with one person when the other comes along, a dog might not want to give up the "second in command" position in his "pack." This is often interpreted as jealousy, when it's really a dominance problem, and your new significant other will have to establish dominance. It can also be a problem when you and your partner are inconsistent, each treating the pet differently. You will have to start establishing a new relationship between you, your partner, and your dog. You can call a professional behaviorist or trainer; their job is to train you to train your dog and establish that better relationship. It will be well worth it for you and your pet!

Simple TIMES . . .

The special season of Spring is flourishing. Every turn presents a surprise of yellow, pink, green, white, and myriad other colors. That scene was ever before me in Boston on Easter Sunday, where a persistently pleasant southwest breeze

carried temperatures to 86°F. Something else significant stirred in the old city, too, on the weekend celebrating Easter, Passover, Patriots Day, and Marathon Monday. A quiet energy filled the air unlike previous years a day before the oldest marathon on the planet.

As the Red Sox played in Fenway Park, an unusual calm hung over every street and neighborhood I passed through, even as thousands of people meandered about parks, streets, sidewalks, outdoor cafes, lawns, benches, and numerous venues.

My April visits have witnessed loud sounds, intensity that lingers at the mere thought of Marathon Monday — boisterous crowds anticipating race day or simply praising aloud the joys of warm air and bright blue skies.

I hopped the Green Line at Riverside and rode on through Kenmore Square. The trolley filled up more at every T stop. Then my outdoor trek turned towards Boylston Street to witness the goings on at the Finish Line. Passing through Copley Square where the vast majority of activity occurred as runners waited in line for their bibs and gift packs, I saw the street was blocked from vehicle traffic.

Selfies and group photos were shot amidst the backdrop of the blue and yellow arch built over the famous Finish Line. A large ball awash in varying colors depicting earth was rolled by college students encouraging onlookers to sign it.

My stroll ended at Downtown Crossing to see visitors and tourists shopping. The area lacked the weekend crush of revelers and shoppers and restaurant seekers. Macy's even closed the day before the Boston Marathon! I never saw that happen before.

Crowds casually moved about. No hurry to grab a sandwich and race to work or catch a bus. So what could this quietness be that covered the Boston Common, Public Garden, and the parkway that beautifies Commonwealth Avenue?

One of my favorite oases in Boston is the Soldiers and Sailors Monument, which honors Massachusetts citizens who sacrificed their lives in the Civil War. It is the highest area of land — known as Flag Staff Hill — in the Boston Common.

So it is there that I decided to ponder my day's chronicling. People sit or lay on the lush lawn circling the historic 126foot column; others rested on the benches surrounding the platform at the base where a woman figure named America holding the flag of the United States stands atop the 130-yearold column looking south.

Some folks snapped photos of America. Others stood quietly reading the bronze tablets depicting the purpose of the Monument's historic symbolism. You catch a fascinating view of the neighborhoods in every direction from there, especially the sun gleaming off the tall buildings looking west. The balmy breeze gave relief from a warm, dry day.

I realized that spring vacation may have stolen the usual crowd from the city. Perhaps the tenor of these uncertain times with Easter, Passover, and Holy Week all culminating on that day brought a collective spiritual reverence.

Suddenly, my thoughts returned to a brief stop earlier in the Public Garden as people of all walks of life peacefully partook in the grandeur of the outdoor haven, where atop that ground the battle for liberation resulting in democracy occurred 241 years ago. And I recall saying quietly, "How blessed are we to enjoy such peace and harmony here." The way life ought to be everywhere.

Saint Camillus de Lellis

Camillus was born at Bocchianico, Abruzzo, Italy, which was then part of the Kingdom of Naples, on May 25, 1550. His mother, Camilla Compelli de Laureto, was very shy and retiring. She was nearly fifty when she gave birth to him. His father was an officer in both the Neapolitan and French royal armies and was seldom home.

Camillus had his father's temper and, due to her retiring nature, his

mother felt unable to control him as he grew up. She died in 1562.

Tall for his age, at 16 Camillus joined his father in the Venetian army and fought in a war against the Turks. As a soldier, he became addicted to gambling, and by 1574 found himself penniless on the streets of Naples.

In February 1574, he resolved to change his life and attempted to join the Franciscan Order. A wound in his leg, however, was seen as incurable and kept him from being accepted. After his rejection, he traveled to Rome and worked for four years in a hospice. Committed to a life of prayer and penance, he wore a hair shirt and received spiritual direction from St. Philip Neri. He was 32 when he entered the Jesuit College in Rome and was ordained in 1584.

Camillus was appalled by the quality of care given the sick and decided to form an association of Catholics who would provide them with both physical and spiritual care.

He established his order, the Fathers of a Good Death (1584), later known as the Order of the Ministers of the Sick, or simply as the "Camillians," and bound the members by vow to devote

themselves to the plague-stricken. Their work was not restricted to the hospitals, but included the care of the sick in their homes and prisons.

The order's original name, the "Fathers of a Good Death," reflected the desire to aid the sick and dying in their spiritual salvation and prepare the dying to receive their last rites.

The group received papal approval from Pope Sixtus V in

1586. Pope Gregory XV raised the Congregation to the status of an Order, equivalent to the mendicant orders, in 1591. In addition to the traditional vows of poverty, chastity, and obedience, they took a vow of unfailing service to the sick.

Throughout his life, Camillus' ailments caused him suffering, but he allowed no one to wait on him and would crawl to visit the sick when unable to stand and walk. It is said that Camillus possessed the gifts of healing and prophecy. He resigned as Superior General of the Order in 1607, but continued to serve as Vicar General of the Order. By that time, communities of the Order had spread throughout Italy, and even as far as Hungary. He assisted in a General Chapter of the Order in 1613, after which he accompanied the new Superior General on an inspection tour of all the hospitals of the Order in Italy. In the course of that tour, he fell ill. He died in Rome on July14, 1614. He is the Patron Saint of hospitals, nurses and the sick.

He was canonized in Rome in 1746, by Pope Benedict XIV. Saint Camillus de Lillis' Feast Day is July 18th.



Nanna & Babbononno

A Nostalgic Remembrance



past, I have to confess. I didn't complain about the winter weather or the cold in any of my columns because I haven't been in Boston since January 3rd. I can't take the cold weather any longer and have been writing "Nanna and Babbononno" from southern Florida. Since brain surgery three and a half years ago, my thermal index doesn't work the way it used to, and if it's below 65 or 70 degrees, I'm cold. So, Florida it is ..

I knew how some of my friends felt when I attended a board of directors meeting by utilizing a video conference call. They saw the tan on my face and asked how things were. Snow had hit New England the day before and they were still shoveling out. When they saw my face, one of the board members asked me how things were. My answer was, "It was cool enough yesterday that I couldn't put the top down on my car." The members of the board had a few choice words for me in both English and Italian. None of them were complimentary.

Since we decided to spend the winter in Florida, Loretta has pushed me into going to Mass every Sunday. As a result, we have attended services at several churches nearby. If I may be blunt, most of the priests seemed to be going through the motions and I kept looking at my watch wondering what time Mass would end. That was the case until we attended Mass at St. Thomas More in Boynton Beach. Someone recommended the parish, calling the priests, "Something special."

Before I go on, I have to mention my family and their parishes through the years. Nanna and Babbononno attended Mass at the Mt. Carmel church in East Boston. As a matter of fact, they were married there. For many years, it was the only Italian church in that part of the city. Mom and my uncles, when they were all very young, attended Sunday Mass there with my grandparents. But when the family moved from Orleans Street to Eutaw Street, they chose the Sacred Heart Parish. My parents were married there and I was baptized there, received first Communion there, and was confirmed there. Years later, I would be a member of a Cub Scouts group that was sponsored by the church, and when I hit my teen years, I joined the C.Y.O. Those were happy days for my family and

My problem was that I really couldn't identify with any of the priests as they were a lot older, very traditional, and at times, standoffish. After Loretta and I were married and the kids came along, my sons became alter-servers and I got to know a couple of the priests at our parish rather well. Once they were reassigned to other parishes and my kids went off to college, things became less involved and it was Mass on Sunday morning, and that was it.

I've mentioned Fr. Joseph

Now that Easter is in the from the Holy Rosary Parish in Winthrop. He is the priest who comforted me after brain surgery three and a half years ago. He is the Catholic prelate at Mass. General Hospital where I was a patient. I met him a second time when a close friend passed away, General Bill Hurley, and then a third time when Bill's widow and family held a memorial Mass for him, last spring. There was a connection between us which I still can't explain.

> I have met a man in Florida who is in that category of someone who is not only a man of the cloth, but also a man of the people. Fr. Julian Harris is the pastor of St. Thomas More, the parish with the largest congregation in the county of Palm Beach. He was born into a southern Baptist family in South Carolina in 1954. He joined the Marines and learned Turkish at one of their training schools. As a result, he was assigned to the Middle East during the '70s. After his discharge, he headed off to college and earned a bachelor's degree, a master's, and a doctorate in historical theology.

> For reasons known only to himself, he converted to Catholicism in 1984. He was ordained in 1991, served in several capacities in the Dioceses of Palm Beach, and since 2002, has been the pastor of St. Thomas More in Boynton Beach.

Fr. Harris brings a unique blend of Baptist preaching and Catholic faith to his services. His congregation is composed of white, black, Latino, Asian, and Native American worshipers. When he finishes a sermon, rather than saying, "Amen," the audience applauds him. Coming from a Baptist background, music is important to Fr. Harris's Mass. The choir director, Pierre Harris (no relation), brings orchestral music with a chorus to life during each Mass. His enthusiasm encourages the congregation to sing along, something I never experienced back home. Fr. Harris's associate is Rev. Alex Javier Vargas, a diminutive Honduran who is never without a smile on his face

During Lent, the parish held a "fish fry" on Wednesday and Friday nights. Loretta, several friends, and I attended one Friday night and Fr. Harris joined us for part of the meal. At the table, we talked and I spoke about my encounters with Fr. Joseph from back home. I've mentioned in past columns that each time when I was in his company, he put his hand on my forehead to issue a blessing and I felt a surge of energy rush through my body. I mentioned that no one could explain the sensations I felt, and Fr. Harris told me not to try looking for answers, just to accept the experience that goes above and beyond what words can express.

At Easter services, a retired priest, Fr. DeVita, a friend of Fr. Harris, caught up to me just as Mass had ended, and handed me a key chain with a fob on it in the shape of a cross and an image of Jesus raised in the center. He said it was blessed and that I should put it in my car. He then hugged me and said, "Buona Pasqua."

With all of this that I have experienced, I feel closer to my beliefs than ever before. I have never been one to succumb to the fire and brimstone style of preaching. This time around, things are different. I leave Mass on Sundays feeling satisfied and reflect on what I have experienced. By the way, there is usually no standing room once Mass begins.

Oh, one Sunday, after a provocative sermon by Fr. Harris, a woman who had been standing in the back of the church, knelt down, clasped her hands and yelled, "Hallelujah!" I had never seen this before in a Catholic church, but it summed it all up.

I hope this column doesn't sound like a sermon; I just thought you might like to hear about what I have experienced while away from home.

Recipes from the Homeland

POTATO SALAD ALĽ ITALIANA

4 potatoes

1 large onion (Vidalia preferred

in season)

1 tablespoon oregano 3 tablespoons cider vinegar Salt and pepper

3 tablespoons olive oil

Peel skins from potatoes. Cut into one and a half or two-inch portions. Wash potatoes and set aside. Heat enough water in a saucepan to a boil. Add potato portions. Cover saucepan. Boil potato portions until tender (about fifteen to twenty minutes). Do not overcook

While potatoes are cooking, remove outer skin from onion. Cut onion in half, lengthwise, and then into one-quarter-inch strips.

Strain potatoes from water when fork-tender and place in a bowl. While potato portions are hot, add the onion, olive oil, oregano, cider vinegar, salt and pepper to taste. Mix the contents thoroughly. Cover bowl and place in refrigerator to chill before serving.

Additional vinegar may be added for a more vinegary taste.

OPTIONAL: Potatoes may be washed and placed whole in heated water to boil until skin separates slightly (approximately thirty minutes). Place potatoes in a bowl. Remove skin and then cut and follow directions given above. I find additional flavor from potatoes when boiled whole with skin.

Serves four.

NOTE: As a youngster, I helped Mama many times as she prepared large portions of this salad for summer cookouts in Wilmington. This popular potato salad also traveled frequently with us to the numerous family picnics. Aunts, uncles, and cousins gathered in one or two of Papa's trucks and followed us to north or south shore beaches.

This is not only simple to make but can be prepared the previous day. Allowing the potatoes, oil, vinegar and oregano to blend overnight in the refrigerator enhances the flavor of this salad.


In the end, the next four months are up to all of us. We have no other option.



My father, who was a professional wrestler and knew Carnera, told me

HOOPS and HOCKEY in the HUB

It was all in the immediate aftermath that we have come to know so well in this region. The Bruins had been beaten, their season was over, and the long extensive off-season — which in recent years has not only come

to encompass the summer but most of the spring as well - had begun.

Still, in the moments following their 3-2 overtime defeat at the hands of the Ottawa Senators in Game 6, there was some activity. Crews began disassembling some areas while some media members made quick and quiet entrances to the press conference area. But out in the corridor, which had been a scene of activity in the pre-game hours, it was silence that prevailed as the sentinel of the moment.

It was just a short time after the 6:14 p.m. dismissal of the Bruins — the exact time that an Ottawa shot made its way by Tuukka Rask and into the net, sending the Senators forth to meet the New York Rangers in the next round, while discharging the members of Bruins Nation who had gathered at the Garden back into their communities for an extended break from the Bs.

There was a lengthy period of waiting before the doors to the inner sanctum of the Bruins locker room was eventually opened, allowing members of the Fourth Estate to cross over the threshold and into the den for the final time this season.

The atmosphere was not quite as funereal as one might expect for an occasion that carried with it the reality of finality. Several Bruins emerged from an inner area and gave their assessments of the series, the season, and the scenarios that had come to encompass this year of change, challenge, and yes, last but not least, chagrin.

It was, after all, a campaign that had seen a coaching change, a berth gained in the Stanley Cup Playoffs for the first time in three years, and the disappointment that came through losing a hard-fought series that saw every game decided by a one-goal margin with four going into overtime.

Gone were the happy times of the 18-8-1 finish down the stretch overseen by interim head coach Bruce Cassidy, now replaced by the somber-toned, serious comments that the aftermath of a season-ending defeat inspires.

And, of course, one will never know what the outcome would have been if the players out with injuries had instead been out on the ice.

"I think our lack of having some players we relied on earlier in the year did catch up to us," noted Cassidy with candor in his final Garden post-game press conference of the year.

"I think Brandon Carlo and Adam McQuaid are big-time penalty killers for us. It was no

fault of the players out there, it's just that those guys really excel in that aspect of the game. I also think we missed Tory Krug's puck-moving ability in the games that we had trouble creating offense. I think Ottawa just made a play or two in the games they won and we didn't."

And in the locker room stood captain Zdeno Chara — the NHL player who has an unparalleled view of all he surveys. In the NBA, he'd be just a player of more or less average height, but here in the NHL his 6'-9" height makes him lord of all he surveys.

And yes, the tallest player in the NHL was still standing proudly a half hour after leaving the ice for the final time this season.

"They (the injuries to players) are part of hockey," noted Chara as a rather large group of media gathered around. "We can't really be standing here feeling sorry for ourselves because we lost so many guys because that's part of the playoffs. We came back multiple times in every game. Everybody did what they could to get that extra push, that extra goal."

But when you come so close, disappointments also play a role. For instance, the Bruins had three games on Garden ice in the series with Ottawa. The Senators won two of them.

'Yeah, it's disappointing," said Patrice Bergeron in front of his stall in the locker room. It's disappointing to lose a series, it's disappointing to lose two of those games. Yeah, that's it."

One of the characteristics of series-deciding games that go into overtime is that there isn't a conclusion, an ending. The proceedings just come to an abrupt halt — and don't resume. One moment the two teams are playing all out. In the next it is over.

"We battled hard to give ourselves a chance to be back (in the Garden) for Game Six," explained Bergeron. "We got back into the game and it went into overtime so it definitely stings a lot. It's tough to be standing here (right after the loss)."

Veteran forward David Backes, who signed a five-year contract with the Bs back on July 1st, felt the same way.

"It's all over and it stings. I wish I had an eloquent sentence to give you, but right now it's just that feeling where you're replaying plays and thinking of every little play you had, wondering if you could have done something different, if you could have done something more, to help your team."

A season ends, an arena goes silent, the sights and sounds of the players and fans are no longer seen nor heard, the bright lights of television booths are dimmed.

Shakespeare once wrote that winter was the season of discontent. But that is not true in hockey. For it is then that buildings are alive, that players and fans are heard, and that media lights shine bright.

It is summer that brings silence, a measure of sorrow and regret, and a sequence of inactive days. It is the summer of our discontent.
