# International Christian Relief Organization Responds at the Epicenter of the Coronavirus in the U.S.



In Manhattan's Central Park, Mount Sinai Health Systems and Samaritan's Purse, an evangelical Christian aid group, erected a field hospital to serve about 68 overflow patients in the East Meadow. During the Civil War, Central Park also hosted a hospital to treat wounded soldiers.

Samaritan's Purse deployed its Emergency Field Hospital to New York City, New York, where the local medical infrastructure is severely overwhelmed. In cooperation with the Federal Emergency Management Agency (FEMA), New York state officials, and local hospital authorities, Samaritan's Purse opened a 68-bed field hospital, specially designed as a respiratory care unit. This response comes one week after Samaritan's Purse opened an identical unit in Cremona, Italy — making it an unprecedented medical response for the N.C.-based

organization as two Emergency Field Hospitals are run simultaneously.

An advance team arrived in New York on Friday, March 27th, to begin assessments and site preparation. The Emergency Field Hospital was trucked from North Carolina on four Samaritan's Purse tractor-trailers. Once it arrived on-site, it built and operational in roughly 48 hours. This convoy's arrival will be followed with doctors, nurses, lab technicians, water and sanitation experts, and other support staff.

out of beds, and the medical staff are overwhelmed," said Franklin Graham, president of Samaritan's Purse. "We are deploying our Emergency Field Hospital to New York to help carry this burden. This is what Samaritan's Purse does — we respond in the middle of crises to help people in Jesus' Name. Please pray for our teams and for everyone around the world affected by the virus."

The United States now has the largest outbreak of COVID-19 with nearly half of these cases in New York state. Thousands of new cases are reported each day.

# Stirpe by Prof. Edmund Turiello Nostra A weekly column highlighting some of the more interesting aspects of our ancestry...our lineage...our roots.

#### HADES, THE PLACE



Last week, we learned that ancient mythology believed Hades to be the name of a god, and also the name of a place. We then examined the legend surrounding Hades, the god. He was the brother to Zeus, ruler over the infernal regions, and over the ghosts of the dead.

Today, our attention is directed to Hades the place, that mythological world of the dead. According to the belief of the ancients, this world of the dead and the abode of the god Hades was located in the depths of the earth. It was considered to be a place where all dead souls went while they awaited their judgment and final commitment. It compared with the place, we now assume to be Purgatory, represented as a grove of barren willows veiled in darkness or clouds, and where the sun never shone. The ground was covered with asphodel, a dreary plant of the lilt family that was often planted on graves. The entrance to Hades was on the far side of a wide river named Oceanus or Acheron (both names have been used).

The burial of the dead was a most solemn duty among the ancient Romans. It was incumbent upon anyone who found an unburied body, at least to cast earth upon it three times. If no funeral rites had been performed, the soul of the dead

person could not be received in Hades, but wandered homeless upon the earth for one hundred years. Other ancients believed that children who were released from all other obligations to unworthy parents were nevertheless bound to bury them. The neglect of burying one's relatives was frequently mentioned by orators as a grave charge against the moral character of any man.

Charon was the name of the boatman who conducted the souls of the dead across the river to the infernal regions. The fare that was charged for this service was one obolus (a coin of low value), and in order that the ghost might meet this demand, the ancients placed that coin under the tongue of the deceased person. To this day, we are told of the countless members of skeletons that have been found with coins that had been placed in their mouths.

The entrance to the kingdom of Hades was guarded by a dog named "Cerberus," a terrible monster with three heads, a tail of three serpents, and a body bristling with vipers. He was friendly to all who entered, but if a ghost tried to escape, the dog would seize that shade and hold him, fast. Brrrrr.

# **The RIDE Paratransit Service Updates**

MBTA Discourages All Non-essential Travel

Customers Encouraged to Visit: mbta.com/coronavirus for Full Details

The MBTA has announced temporary updates to the T's paratransit service, The RIDE, in a continuing effort to prioritize safety, protect the health and safety of the T's customers and workforce, and to preserve the continuity of transit services for those who must travel for purposes that are absolutely necessary.

"These measures are being implemented after carefully considering how the spread of COVID-19 could affect the most vulnerable members of our community," said MBTA General Manager Steve Poftak. "Although some of these changes may create inconveniences for some customers, these are being put in place in an effort to do everything we can to protect the health and safety of those customers and RIDE vehicle drivers, while continuing to provide this vital service."

Details on these changes are below with more available at <a href="https://www.mbta.com/coronavirus">www.mbta.com/TheRide</a>:

- Eliminating Shared Trips: Until further notice, every effort will be made to avoid trips where customers are sharing a vehicle. RIDE customers will continue to be able to take a personal care attendant or guests on their vehicle.
- Extending Eligibility and Postponing Eligibility Appointments: The RIDE Eligibility Center (TREC) is currently closed to in-person assessments. On a temporary basis, existing customers with expiring eligibility will be extended automatically. New RIDE customers may be granted temporary eligibility if they meet the medical necessity criteria provided to their licensed healthcare provider by TREC.
- Booking Windows Adjustments: Effective Saturday, March 28<sup>th</sup>, RIDE customers will temporarily be allowed to book trips only 1-3 days in advance. This change is intended to prevent cancellations and service disruptions for customers with necessary travel as business availability changes due to COVID-19. All trips already booked will not be affected.
- **Subscription Process Updates:** All RIDE customers with subscription trips will be contacted to confirm that their automatically renewing trips are still required. This is intended to reduce cancellations for destinations that are closed.
- **Reduction of Transfer Trips:** The RIDE will make every effort to eliminate currently occurring

transfer trips to reduce customer interaction with multiple drivers.

- **Daily Vehicle Cleaning:** All MBTA fleet vehicles, including RIDE vehicles, are disinfected every 24 hours.
- **Delay of RIDE Software Transition:** Due to COVID-19, the Routematch Software Transition scheduled for late March has been delayed. The RIDE will be in touch when an updated timeline for the transition has been determined.

The MBTA strongly urges customers to avoid any and all unnecessary travel. Residents over the age of 70 or with underlying health conditions, who are considered at high risk when exposed to COVID-19, should limit social interactions with other people as much as possible, in accordance with guidance issued by the Department of Public Health.

#### **Enhanced Cleaning and Disinfecting**

In addition to encouraging good hygiene practices and social distancing, the MBTA is continuing its enhanced cleaning and disinfecting protocols, which includes:

- Disinfecting all fleet vehicles buses, trolleys, subway cars, Commuter Rail coaches, ferries, and RIDE vehicles every twenty-four bours:
- Cleaning all high-contact surfaces such as handrails, fare gates, and fare vending machines in subway stations once every four hours.

The MBTA continues to follow guidance from the Massachusetts Department of Public Health, with the MBTA encouraging its riders and the public to:

- Wash hands often with soap and warm water for at least twenty seconds
  - Cover coughs and sneezes
- Stay home if sick
- Avoid touching eyes, nose, and mouth
- Clean areas that are frequently touched with sanitizing spray or wipes

#### **MassDOT Advisories:**

#### Route 1 Chelsea Temporary Closures and Lane Reductions

The Massachusetts Department of Transportation (MassDOT) announced that beginning the first weekend of April 2020, Route 1 northbound and southbound in Chelsea will be reduced to one (1) travel lane during five (5) weekends in the spring for necessary bridge repairs and safety improvements. This project to, in part, replace the Route 1 Chelsea Viaduct, is using accelerated bridge construction methods to ensure that the vital section of Route 1 through Chelsea can continue to safely and efficiently process passenger and freight traffic.

Lane Reductions: Route 1 will be reduced to one (1) lane in each direction during the following weekends: April 3<sup>rd</sup> to April 6<sup>th</sup>, April 24<sup>th</sup> to April 27<sup>th</sup>, May 1<sup>st</sup> to May 4<sup>th</sup>, May 15<sup>th</sup> to May 18<sup>th</sup>, and May 29<sup>th</sup> to June 1<sup>st</sup>. Lane reductions will begin at 10:00 p.m. on Fridays with two lanes available again by 5:00 a.m. on the following Monday. During the lane reduction weekends, work continues around the clock.

In addition, during the spring, the Carter Street off-ramp from Route 1 southbound in Chelsea will be closed on four weekday weeknights and also during three full weekends. Each closure will begin at 10:00 p.m. and conclude no later than 5:00 a.m. on the scheduled end date.

**Closures:** The first weekend closure will occur on Friday, April  $24^{\rm th}$ , beginning at 10:00 p.m. and conclude on Monday, April  $27^{\rm th}$ , at 5:00 a.m. The following weekend closure will occur on Friday, May  $1^{\rm st}$ , at 10:00 p.m. and conclude on Monday, May  $4^{\rm th}$ , at 5:00 a.m. The final weekend closure for the Spring will occur on Friday, June  $5^{\rm th}$ , at 10:00 p.m. and conclude on Monday, June  $8^{\rm th}$ , at 5:00 a.m.

Drivers are urged to utilize public transit options such as the Newbury/Rockport Commuter Rail Line and seek alternate routes. Drivers looking to exit Route 1 southbound in Chelsea should use the Route 16 westbound exit towards Everett and take Revere Beach Parkway to Everett Ave.

Drivers are urged to reduce speed, exercise caution, allow extra time for their trip, and pay close attention to signage and directions by police while traveling through work zones.

All work is subject to weather conditions.

#### Somerville to Medford Temporary Lane Closure on Route I-93N

The Massachusetts Department of Transportation (MassDOT) is announcing a temporary closure of the left lane on Route I-93 northbound between Somerville and Medford.

The closure began on March 30<sup>th</sup>, and will last approximately two (2) weeks. The work will occur daily from 7:00 a.m., to 7:00 p.m., with the lane closed for the duration of the project. This impact is necessary to establish a work zone so that the contractor can make utility upgrades.

Appropriate traffic control devices, including construction signs, law enforcement details and advance message boards will be in place to guide drivers through the work area. The schedule for this work is weather dependent and subject to change without notice.

The project contractor is Coviello Electric & General Contracting, Inc. of North Reading, MA. The project is scheduled to complete in the spring of 2021.

### L'Anno Bello: A Year in Italian Folklore

The Exuberance of Italian Holy Week

Obviously, advice on gatherings and reunions contained within are not applicable to this current time when social distancing is the best practice. Please read these articles as a testament to the joy and love that imbues Italian celebrations — and as suggestions for ways to spend time in the future once this pandemic is but a memory!



After the damp and bitterly cold early spring fogs, in which every raindrop feels like the pinprick of an ice crystal, I look forward to the promise of Easter, the premiere holiday of the season. Signs of Easter sprout around me as surely as the first purple tulips spring from the rich soil. Marshmallow Peeps wink playfully at me as they line shop selves in brilliant hues ranging from robin's egg blue to bright tutu pink. Baskets and wreaths boast eggs dyed with bold solid colors or glittery patinas. At the mall, costumed Easter Bunnies pose for family photos with children in frilly dresses and crooked bowties. However, as much as the coming Easter fills me with pleasant anticipation, I am reminded that the week preceding the holiday brims with its own unique customs and traditions. The week's very name, Holy Week, reveals its profound importance in the religious year. Italians call Holy Week la Settimana Santa and celebrate its arrival with much fanfare. The Holy Week festivities in Italy emphasize seasonal spring folklore while also paying homage to the intricate and inspiring spirituality of this period. Whether filled with displays of palm leaves or colorful eggs, Holy Week in Italy and around the world heralds the Easter holiday with the reverence, love and joy it deserves.

Holy Week begins this year on April 5th, which is Palm Sunday. Palm Sunday commemorates Jesus' entrance into Jerusalem, when adoring crowds welcomed Him by waving palm branches in the air. Along with its religious significance, Palm Sunday remains attuned to the seasonal beat of spring, symbolically

falling during the time of the year when tree branches begin to blossom. My father grew up in the mountainous region of the Abruzzi in Italy, where he would spend Palm Sunday, or Domenica delle Palme, collecting the olive branches that grew plentifully in the hills and fields near his home. This was the same country wilderness, laden with ancient orchards and thick forests, about which village elders whispered stories of sprites hiding under rocks and wolves darting among the trees. My father and his friends would then bring the branches to the local parish, where the priest would bless them. This quaint sylvan ritual embodied all the pleasures of spring, such as communal outdoor excursions and metaphorical links to the themes of rebirth and spiritual awakening. Throughout Holy Week, Italians also give their homes a thorough spring cleaning in preparation for Easter and the days of visiting to follow. Holy Week ends with Good Friday, or Venerdí Santo, the solemn remembrance of Jesus's Crucifixion. In Italy, processions of black-robed participants set the somber and pensive atmosphere of the day. Processions that focus on the Virgin Mary are known as the Addolorata, a name indicative of Mary's grief and pain. Therefore, Holy Week begins in triumph but ends in tragedy, encompassing all the emotional spectrum necessary for the joy

For me, Holy Week has always meant Easter preparations, particularly those with an emphasis on the Italian traditions of my ancestors. My parents would reserve a day, usually Holy Saturday, for decorating

Eggs have formed an integral part of Easter celebrations since ancient times due to their rebirth symbolism: though they appear cold and sterile on the outside, they contain new life inside. I always enjoyed picking the egg dyes, and I would often choose a bright or glittery color to match the cheerful hues of the flowers growing outside my home. Easter eggs form a sweet part of Italian holiday customs as well. During Holy Week, my father would always buy a gigantic chocolate uovo di Pasqua (literally, "Easter egg") from a specialty shop in the North End, wrapped in pastel foil. We would patiently wait until Easter to ceremoniously break the egg open, eagerly anticipating the treats concealed within — usually candy. An Italian superstition decrees that everyone must wear at least one new piece of clothing on Easter, again illustrating the theme of renewal central to the holiday, and as such my mom and I would often shop for a new outfit t during Holy Week. When I was a child, this meant a lacy, flowery dress. Though I no longer seek out itchy dresses, I do pick my new clothes with bright colors or a flowered pattern to reflect the spring season. Finally, my mother and I spend much of Holy Week planning our Easter menu. On Holy Saturday, I bake my traditional Italian ricotta pie to be served at the feast the next day. Therefore, I associate Holy Week with the joy and promise of an exciting holiday to come. Its customs have instilled in me an appreciation for the blooming new season of spring, for the spirituality of Easter, and for my Italian heritage as a whole. Holy Week is a profound and

multifaceted period of the year. It revels in the springtime and the resurgence of nature all around us, from the flowers fluttering proudly in the sunlight to the bunnies munching on the fresh green grass. It grants us an opportunity to enjoy the warm spring weather and to find peace and reflection in the spiritual traditions of the pre-Easter season. In Italy, people honor Holy Week by engaging in symbolic rituals like collecting olive branches on Palm Sunday, cleaning their homes, and decorating eggs. No matter which customs we take to heart, we should celebrate them in a way that expresses gratitude toward nature and the cycle of the year. Easter, after all, is the supreme holiday of hope and rebirth, and Holy Week encapsulates that feeling. Holy Week teaches us that if we live in harmony with nature and with respect for the ways of our ancestors, we will find a strength inside us brighter than any spring sun.



# Saint John Baptist De La Salle



De La Salle was born on April 30, 1651, into a wealthy family in Rheims, France. He was the oldest child of Louis de La Salle and Nicolle Moet de Brouillet. Nicolle's family was a noble one and ran a successful winery business and she was a relative of Claude Moët, founder of Moët & Chandon.

De La Salle received the tonsure at age eleven and was named canon of Rheims Cathedral when he was sixteen. He was sent to the College des Bons Enfants, where he pursued higher studies. When De La Salle had completed his classical, literary, and philosophical courses, he was sent to Paris to enter the Seminary of Saint-Sulpice on October 18, 1670. His mother passed away on July 19, 1671, and on April 9, 1672, his father died. This circumstance obliged him to leave Saint-Sulpice on April 19, 1672. He was now twenty-one, the head of the family, and as such had the responsibility of educating his four brothers and two sisters. He completed his theological studies and was ordained to the priesthood at the age of 26 on April 9, 1678. Two years later he received a doctorate in theology.

He fully intended to work among the wealthy people of his area throughout his career. Unexpectedly, De La Salle's life changed dramatically. A promise to a dying friend to assist a group of Sisters in their work with orphan girls brought De La Salle to education. Further assistance to a friend starting a school for poor boys in Rheims solidified his true vocation as an educator, an endeavor which would consume his entire life.

By 1684, having given up his personal wealth and title in society, De La Salle brought a group of schoolmasters together to form the Institute of the Brothers of the Christian Schools. The Institute was soon after recognized as an official Congregation of Religious in the Roman Catholic Church. The Congregation's primary purpose



was to serve the educational needs of society, particularly among the poor. De La Salle passed away on April 7, 1719.

De La Salle and his Brothers took up the cause of education vigorously. In addition to the founding of schools in 22 cities by the time of his death, De La Salle contributed significantly to the entire field of education through his writings and innovative methodology. John Baptist de La Salle was Canonized on May 24, 1900 by Pope Leo XIII. Fifty years later, Pope Pius XII declared John Baptist de La Salle the Patron Saint of Teachers.

The Feast Day of Saint John Baptiste De La Salle is April 7<sup>th</sup>.



Sinatra is no easy feat. Singing the crooner's songs at age four is even more remarkable. Yet that's exactly the age Anthony LaBarbera began his interest in "I started singing whenever

my grandmother, aunts, and uncles came to our house for dinner or parties or holidays. My parents always played music on the stereo. And singing became a large part of those family gettogethers," says Anthony.

Anthony's father introduced him to all the great singers. "All Italian crooners," he adds.

"My parents told me I have an 'old soul.' I gravitated towards Italian music, of course, but I love music from the Big Band era. And there was so much good music from the 1950s and '60s."

# Nanna & Babbononno

A Nostalgic Remembrance



I never thought I'd say this, "I'm stuck in Florida." I love Florida, especially in the winter when it's cold and snowy in Boston. But, it's time to come home and I can't. Loretta feels that the inside of a plane would be like an incubator and I'm not going to argue with her. Everything has changed, restaurants are closed (just take out), supermarket shelves are bare, especially where bottled water and toilet paper are concerned. Dean Saluti told me the same thing exists back home.

Another reason we can't go home is our son Michael. He was out in Hollywood for a couple of months working, and when everything was shut down, he decided to come home. He is OK, but has quarantined himself for a couple of weeks just in case. He doesn't want to be near John's family until he's sure he is not carrying the Coronavirus.

I had been playing bocce two mornings a week and that is now on hold. I had been "hanging around a cigar bar" a couple of nights a week and that is now on hold. I had been using the pool several afternoons a week, and it is now closed. I had been playing cards one night per week and the clubhouse is now off limits. I prevent myself from becoming bored by improvising. I've recently bought a tabletop electronic piano and have been doing some medley arrangements of "oldies" from the Great American Song Book. A neighbor, Joe Kessler, is a guitarist and we practice our music. We had been getting together with a pianist, but that's now on hold due to the scare.

With the restaurants closed or only doing takeout, Loretta has been cooking up a storm and her Italian food is great. Her courses at Cambridge College are now on line and she is teaching via the computer. When I spoke to Dean Saluti and John Silva, my close friends who are also Professors at Cambridge, they said they have had to do the same thing.

We have heard from friends who live in Europe, and they are worse off than we are. Loretta's girlfriend and her mother live in Barcelona. Whatever they need, is delivered ... no gathering at supermarkets. Another friend who lives in Zurich can't get home. Her mother lives in Milan, but the Swiss/Italian borders are closed. Northern Italy seems to have had more cases of Corona flu than other parts of Europe. Someone said that it is because there is a large Chinese population in northern Italy and they have the corner on dollar stores, but I wonder if that is just a coincidence???

I think that we will have to stay put for another month or two and then see what the situation is like ... I WANT TO COME HOME!!! I miss La Summa's, Javeli's, Santarpio's, and one or two Chinese restaurants that are authentic. Being Italian, I think of my family first and food second. Actually, there are a few good Italian restaurants down here, as there is a large Italian population, but outside of Boston, New York, and San

Francisco, they don't know what good Chinese food is.

I do remember restrictions to our life style, but it was during World War II and we lived with Nanna and Babbononno. Food was rationed, gasoline was rationed, there were curfews and restrictions everywhere you looked. Uncle Nick was in the Navy. Uncle Gino was in the Army Air Corps. Dad was with the OSS, the forerunner to the CIA, and I was under the tutelage of Mom, Nanna, and Babbononno. When I went shopping with Mom and Nanna, they had ration books that they had to use to buy food, as you were only allowed a certain amount. So, a lot of what we ate was homemade by Nanna.

Car owners couldn't buy tires and did a minimal amount of driving to compensate. Gas was restricted. You were issued a sticker that was placed on the bottom of the passenger's side of the front wind shield. A capital A allowed you three gallons of gas per week. A capital B allowed you eight gallons. Class C drivers included war workers, police, doctors and letter carriers. Class T included all truck drivers and Class X was reserved for politicians and "other important people." I don't think the C, T, and X drivers had any restrictions. Dad, my uncles and most musicians had a letter B, and unless they were playing somewhere (at night), took public transportation.

I remember a couple of instances when Dad hadn't used his weekly allotment of gas. After Sunday dinner, he would take us for a ride. Uncle Paul would do the same thing. But no one would dare drive too far, maybe Revere Beach or Wood Island Park in the warm weather, or just somewhere close for a joy ride during the colder part of the year.

Uncle Nick was stationed at the Newport Naval Station. He had auditioned for the Andre Kostelanetz Orchestra, the band that serenaded the officers and men who were stationed or sailed from there. He had passed the audition and became a member of the reed section of the orchestra. As a result, he was often able to come home on Sundays. The war, unfortunately, led to his divorce from my Godmother, Aunt Ada, his first wife.

Uncle Gino served with the 5<sup>th</sup> Air Force and was stationed in the Pacific constantly in harm's way. But, he survived, thank God. The times were tough and we were scared, but we survived. I remember one black out. Every home had to have their lights shut off and their shades drawn because of the threat of enemy bombers overhead. Again, thank God, it never happened.

One thing I remember vividly. After dinner on a few occasions, Babbononno and I were the only ones still at the dinner table. He would take a long sip of wine, take me by the hand, walk me outside the house and point to the flag in the front window. It was a white flag with a red border and two blue stars in the center. He would point to the

flag and say, "Quelli sono i miei due figli." (Those are my two sons) When we returned to the kitchen, he would have another sip of wine and sigh. Mom and Nanna were more stiff upper lipped. We survived.

Uncle Nick came home and married Aunt Dorothy and they spent the rest of their lives together. Uncle Gino married Aunt Ninna who is still alive and the last one of that generation still with us. I get emails from her a few times a week. They are usually jokes as she is very funny. So, what I'm saying is, Don't despair. This epidemic will eventually blow over and we will make it. In a short time, we will be laughing about some of the things we horded, like toilet paper and bottled water.

To quote one of Frank Sinatra's hit songs, "Let's Take It Nice and Easy." See you next week. Keep safe and "Non Carborundum Iligitmi," Latin for, "Don't let the bast\_\_d wear you down."

Today, there are over 250 different types of *pane* (bread) made throughout Italy. Every region has its own variety that is typically rooted in the history and tradition of the area. For centuries, bread has been viewed throughout the motherland as the symbol of life. It was believed that the grain represented fertility. Therefore, the loaves it produced were regarded as sacred. This belief of bread being sacred lead to the creation of the communion host, which was initially baked



by nuns using only the finest quality of wheat. To this day, specific breads are still baked for celebrations of devotion, and to commemorate various religious festivals. These breads differ between regions depending on availability of ingredients.

In my family, homemade bread accompanied almost every meal. One of my favorites was my Nonna's Pane alle Olive (Olive Bread). This soft bread was loaded with olives that excreted a unique salty flavor into the dough. The crust was golden crisp and the taste, absolutely amazing. Hailing from "Italy's Heel," the southern region of Puglia, Pane alle Olive is the perfect accompaniment to a holiday cheese board or served alongside of just about any meal you'd like!

# OLIVE BREAD Pane alle Olive

olive oil

1 cup warm water 1 pkg. rapid rise yeast

3 cups all-purpose flour

1 tablespoon sugar

1 teaspoon salt

2 tablespoons shortening

1 teaspoon olive oil

1/8 cup Sicilian castelvetrano olives

1/8 cup Sicilian black oil cured olives

sea salt, black pepper, garlic powder

1 egg beaten with 2 tablespoons water (egg wash)

Generously grease a large bowl with olive oil, set aside. Line a baking sheet with parchment paper, set aside.

In a small bowl, add warm water, sprinkle with yeast, set aside. In medium mixing bowl, add flour, sugar, salt, shortening and olive oil, mix well. While mixing, slowly pour in yeast mixture and continue mixing until dough forms. Knead with dough hook or by hand for 6-7 minutes until dough is soft and smooth. Knead in olives until combined. Place dough in greased bowl, turning once to coat, cover with plastic wrap and place in a warm dark place for 1 hour, or until doubled.

When ready, remove dough from bowl, shape to form a solid or braided loaf, and place on prepared baking sheet. Cover with plastic wrap and place in a warm dark place for 1 hour to rise.

Preheat oven to 400°. Uncover bread, brush egg wash all over bread, sprinkle with garlic powder, salt, pepper and place in oven for 25-30 minutes or when golden colored.







### HOOPS and HOCKEY in the HUB

Maybe a sportswriter could be forgiven if the scribe had made a typo when writing about Bill Sharman, one of the standout players to grace the roster of the Boston Celtics in the 1950s and the early 1960s.

You see, replace that "h" in Sharman's name with a "t" and you have an apt description of one of the most versatile performers ever to stride upon the storied parquet floor at the original Boston Garden.

That's right, "Starman" would be a correct summation of his career. O was he ever.

William Walton Sharman was the real deal, adept at two sports, not just one before choosing the path that would eventually lead to his induction into the Basketball Hall of Fame in 1975 as a player and in 2004 as a coach.

Bill Sharman was born in Abilene, Texas in 1926 and, following military service in World War II, went on to have a stellar career in both baseball and basketball at the University of Southern California.

As a first baseman, he was a member of the 1948 Trojan team that won the College World Series. When the action turned to the hardwood, he was named a basketball All-American and the Pacific Coast Conference Player of the Year in both 1949 and 1950.

Following graduation in the spring of 1950, it supposedly was decision time but in an era when the sports seasons did not overlap he enjoyed the best of both worlds. He signed a minor league contract with the Brooklyn Dodgers and was selected in the second round of the NBA draft by the Washington Capitols.

For the next five years, he would play both sports on the professional level. However, he only would make it onto the roster the Brooklyn Dodgers once — in September of 1951, when MLB teams are allowed to increase their rosters. But he never got into a game.

After five seasons of minor league ball, Sharman saw that his future was on the court, not on the diamond. By then, he had been playing for the Celtics since the 1951-1952 campaign.

In another era, far into the future, there would be the Big Three of Larry Bird, Kevin McHale and Robert Parrish. Back in the middle of the 20th century Sharman would team with fellow Boston star Bob Cousy to form a "Terrific Twosome" backcourt for the C's. To this day, some basketball historians consider it the finest backcourt in the history of the game.

The pair would combine to win four NBA titles together in the 10 seasons that Sharman played on Causeway Street before he concluded his years with the Green at the end of the 1960-1961 campaign.

Most everyone likes things that are free but Sharman made a specialty out of the basketball version of that word. He was one of the best free throw shooters that ever took the floor.

He led the NBA in foul shooting for seven seasons — including five consecutive years (1951-1952 through 1956-1957) — and finished with a career percentage of 88.3 from the line. He went over 90 percent twice (90.5 percent in 1957-1957 and 93.2 percent in 1958-1959).

Twice Sharman had consecutive foul shooting streaks that topped 50. The first occurred in the 1955-1956 regular season when he hit 55 straight. The second came in the 1959 playoffs when he made 56 in a row — an achievement that still ranks first in the NBA playoffs.

And even when Sharman was guarded he had an eye for accuracy. In nine of his 10 seasons with the Celtics, he shot over 40 percent from the field.

How did he acquire all that accuracy? By practicing, of course. It is common today for NBA teams to have a morning "shootaround" on the day of a game. It gives the players a chance to have a somewhat longer time on the practice floor than in the pre-game warmups. It also allows the coaching staff to further evaluate players whose status might be questionable for that night's game.

The routine of the morning "shootaround" was inaugurated by Sharman, who lived in what we now call the Metrowest region during his playing days. Eager to get in some additional practice time on the day of a game, he sought out various gymnasiums where he could shoot baskets.

From a practice for one to a practice for all, the routine took hold not only with his Celtics teammates but throughout the rest of the league.


After his playing days had concluded, Sharman entered the coaching ranks, first at Los Angeles State, then with the Utah Stars of the old ABA, then with the San Francisco Warriors and finally with the Lakers — yes, those Los Angeles

He guided the 1971-1972 Lakers that featured stars Wilt Chamberlain and Jerry West to a then NBA record 69-13 regular season mark (that included a record 33-game win streak). That culminated with the first NBA championship for the franchise since it had moved to the West Coast from Minnesota in 1960. Sharman was named NBA Coach of the Year.

Sharman coached for four more seasons before moving into the team's executive suite as General Manager. While serving in that post, he oversaw the drafting of Magic Johnson and the acquisition of two more NBA Championships in 1980 and 1982.

He then became president of the franchise and was in the top seat when the Lakers won three more championships — in 1985, 1987, and 1988. He then retired but remained with the club as a consultant.

When he died from the complications of a stroke in October, 2013 at age 87 he certainly left the legacy of a full life lived.
