If Postal Service Wants to Cut Out Saturday Mail Deliveries Let Them

Menino Announces End of His 20 Year Mayoral Career

Thomas Menino, beloved Boston Mayor, announced that he will not be running for a sixth unprecedented term. He gave notice of this last Thursday, in a speech given at Faneuil Hall, "I am here with the people I love, to tell the city I love, that I will leave the job that I love," he said. Most Bostonians are saddened by this fact, but the general consensus is that Mayor Menino, although of great service to Boston for the past 20 years, has greater health concerns that would be compromised during a sixth campaign. As Michael Dello Russo, a North End resident, said "He's done all he could do, a great job, but it's time for him to go."

Menino is the first Italian-American to serve as Mayor in Boston. His term began in 1993, when current Mayor Ray Flynn was appointed Ambassador to the Vatican. Menino served as acting mayor for four months and was then elected. Ever since then, he has held an immense political dominion, maintaining office for five consecutive terms with little opposition, due to his popularity among all citizens.

He is called "Mayor of the people," with a reputation for attending little and big events alike throughout the city. His personal approach and dedication to public office solidified the people's appreciation and made him likable and relatable; as shown in a recent poll published in the Boston Globe, the Mayor has personally met more than half of Boston's residents. Frank Mendoza, another resident of Boston, said that although he didn't always agree with Menino's politics, "it's sad he's not running again, even more so for him, he enjoyed what he did and he did a great job for the city."

In his State of the City speech back in January of 2012 he underlined several successes of 2011, such as reducing crime, bettering education and creating job opportunities. He also addressed the problems that 2012 was facing, the most notable being the school dis-



tribution system which he vowed to have fixed one year from then. In this year's speech he celebrated the progress made, but insists there's always room to be better. For Tom Menino, it's not only about school distribution, "Let us stay focused on moving forward with that process and on improving quality in all of our schools,' he said.

Another thing that made Menino different was the special focus he gave to neighborhoods. His politics worked with the baseline that successful neighborhoods make for a successful city. In his own words," the point is this: if we help our neighbors learn more, produce more and succeed more, we will do more to help Boston than anyone can do for us."

Healthcare was also a concern for Boston's Mayor. He tackled it from a different angle than most politicians. Instead of focusing on the economic aspect and talking about public or private individually right away, such fill.

as his 2012 plan with a common goal for Bostonians to become healthier and shed one thousand pounds by the end of the year.

Mayor Menino also involved himself in controversial issues and stood by his beliefs. An avid supporter of gay rights and gender equality, he has launched programs that contribute to women getting the same pay as their male counterparts, such as "Women on Main," and as some may recall, greatly opposed the chain restaurant Chick-Fil-A setting up in Boston, because of the chain's president's public opposition to gay marriage. He also made clear his stance on gun regulations and worked hard to make them happen, as he said in his State of the City this year, "Mayor Bloomberg and I will keep working with almost one thousand mayors and over one million Americans. Life-saving solutions, which have long been within our reach, are now within our grasp. Stand with us on guns and say enough is enough."

It's fair to say that the way Tom Menino guided Boston focused on everyone. Time and time again he emphasized the importance of supporting each other and combined his politics with core human values. He has without a doubt left a very positive mark and he will be greatly missed. As Karen, a Brookline resident who worked in the North End's Health Center for sixteen years, explained, "A path has been made by Menino, it will be great to see if somebody healthcare he came up with can follow that." The next solutions that could be done mayor has some big shoes to



Misguided U.S. Trade Policy Claims Another Victim

America's oldest textile trade association, citing three decades of failed government trade policy and subsequent industry contraction, announces consolidation with a similar organization in order to more effectively represent the U.S. textile industry.

On March 19th the Board of Government of the National Textile Association ("NTA"), based in Boston, and my employer since 1994, voted to cease operations and turn the Association's membership list and assets over to the National Council of Textile Organizations ("NCTO"), based in Gastonia, N.C., effectively merging the two groups, each of which represented a substantial part of the domestic U.S. textile industry. The merger was effective April 1st.

Hank Truslow, Sr., of Sunbury Textile Mills, the only U.S. fabric-maker that was a member of both NTA and NCTO prior to the merger said, "It is a sad day when a 159year-old organization, effectively serving its members, decides to close its doors. We attribute this historic denouement to failed and destructive government trade policies under the last five Presidents, Republican and Democratic."

The consolidation, which involves a third group, the American Manufacturing Trade Action Coalition ("AMTAC") is undertaken to form a stronger more effective voice in Washington. George Shuster, Chairman of Cranston Prints Works and Chairman of NTA, as well as Co-Chairman of AMTAC said: "The creation of this merged organization will allow the domestic textile industry to more quickly and effectively address the wide range of federal policy developments of importance to the over 1.5 million workers in the United States whose jobs are either directly or indirectly tied to this critical manufacturing sector."

The immediate and pressing concern of the new organization is the ongoing Trans-Pacific Partnership ("TPP") free trade agreement negotiations. The consolidation will improve the structural efficiency of the industry's representation in Washington by

combining and maximizing the various strengths of the three separate associations; more efficiently utilizing the industry's financial resources by eliminating duplicative efforts; and allowing for a more systematic effort to recruit new members, specifically domestic textile companies that currently are not members of any textile trade association.

To the new organization the former members of NTA bring important breadth of product sectors and geography. NCTO's coverage of the wool textile industry, upholstery fabrics, and knitted textiles, will be substantially increased by the merger with NTA. NTA's American Flock Association brings to NCTO an entirely new textile sector. Overall the NTA membership, with wide representation in the Northeast, Midwest, and West Coast, will greatly enhance NCTO's geographic representation, which will be extremely helpful as the industry fights for a strong rule of origin and long tariff phaseout schedule in the TPP.

Karl Spilhaus, longtime President of NTA, said, "I am extremely proud of NTA's membership; they are survivors of a turbulent economic climate, characterizing the innovative and entrepreneurial spirit that made our American industry great."

The National Textile Association traces its history to 1854, the founding date of the Hampden County (Massachusetts) Cotton Spinners Association. It was reorganized in 1865 as the New England Cotton Manufacturers Association and became the National Association of Cotton Manufacturers in 1906. In 1954 the name was again changed to the Northern Textile Association. In 2002 the Northern Textile Association merged with the Knitted Textile Association to become the National Textile Association.

Social Security Sounding More Like a Ponzi Scheme Every Day

I recently read a well-written letter to the editor in the Merrimack Journal (NH) by a Dan Bogdan of Merrimack. He was criticizing the opinion pieces that the newspaper runs by U.S. Rep. Carol Shea-Porter, a liberal Democrat if ever there was one. As Bogdan describes Shea-Porter, he could be describing any number of liberal Democrats on Capitol Hill. He says, "She uses a lot of words without any clear distinct ideas. Her, we all have to work together (voted party lines 97 percent last term), but she shows no leadership.'

After reading Mr. Bogdan's letter I think he should run for Congress next time around because he so easily explains all the blue smoke and mirrors down in the Nation's Capital. He's right about the sequester. It is like your boss promising a dollar an hour raise but only to renege and give you half a buck instead. Sequesters only cut the raise in future budgets. Liberal Democrats call a 50 cent an hour raise a cut if you first were promised a buck. However, isn't still a raise?

Look at Social Security. The government collects one dollar from you for the Social Security tax, they pay out 75 cents to retirees and then put the 25 cents into the general fund and issue a government bond (an IOU for short) to the Social Security fund. Next, they collect one dollar in taxes from you for the general fund to run the government. They add the 25 cents from the Social Security fund and then borrow 40 cents from China to pay to operate the government, all total \$1.65. As the letter writer from Merrimack, NH points out, "This will work for Social Security until 2033 at best, the government will have to sell off the bonds to pay Social Security.'

Here is something the liberals don't want us to know. Right now, the general fund owes \$4.8 trillion, that's T for trillion to Social Security. At this point the system will only be able to pay out 75 cents on the dollar in benefits. Our government will be forced to go into more debt by issuing more bonds or print more funny money to cover it and jack up inflation rates. We have a choice to make a difficult choice at best. We can balance the budget and pay down the debt or do nothing and get forced to make painful choices. Will we continue down this road of spending? Or like most of us, do with less and




Saint Gemma Galgani

Maria Gemma Umberta Pia Galgani was born on March 12, 1878, in the village of Borgo Nuovo near Lucca, Italy. Gemma was the fifth of eight children; her father, Enrico Galgani, was a prosperous pharmacist. Soon after Gemma's birth, the family relocated north from Borgo Nuovo to a large new home in the Tuscan City of Lucca. Gemma's mother, Aurelia Galgani, contracted tuberculosis, because of this hardship, Gemma was placed in a private nursery school when she was two-and-a-half years old, and was regarded as a highly intelligent child.

Several members of Gemma's family died during this period, her oldest brother Carlo, died at an early age, her mother Aurelia died from tuberculosis, which she had for five years. Gemma's brother Gino, while studying for the priesthood, died from tuberculosis as well as her sister Giulia.

Gemma was sent to a Catholic boarding school in Lucca run by the Sisters of St. Zita. She excelled in French, arithmetic and music. She applied but was not accepted by the Passionists to become a nun because of her poor health. At age 20, Gemma developed spinal meningitis, but was healed, attributing her extraordinary cure to the Sacred Heart of Jesus through the intercession of Gabriel of Our Lady of Sorrows (later canonized a saint), and Saint Margaret Mary Alacoque.



Gemma's father passed away shortly after she turned 18, making her responsible for the upbringing of her younger siblings, which she did with her aunt Carolina. She declined two marriage proposals and became a housekeeper for Giannini family.

On June 8, 1899, Gemma experienced a premonition that she was to be granted a special grace. Shortly thereafter, she received the marks of the stigmata. Each Thursday evening, Gemma would fall into rapture and the marks would appear. The stigmata remained until Fri-

day afternoon or Saturday morning when the bleeding would stop, the wounds would close, and only white marks would remain in their place. Gemma's stigmata continued to appear until the last three years of her life. With her health in decline, Gemma's spiritual director, Fr, Germanus Ruoppolo directed her to pray for the cessation of her stigmata; she did so and the experience ceased

In January of 1903, Gemma was diagnosed as having tuberculosis. She died quietly in the company of the priest, on April 11 at age 25. He said, "She died with a smile which remained upon her lips, so that I could not convince myself that she was really dead."

The fame of her sanctity spread rapidly throughout the world. She was beatified by Pope Pius XI on March 14, 1933 and canonized by Pope Pius XII on Ascension Day, May 2, 1940.

Stretching My Roots

Nature has come a long way from the barren, snowy winter. I walked to class on Monday in balmy sixty-degree weather, relishing the comparative heat wave in my pale blue windbreaker and orange polka-dot tee. I have also noticed the trees all around me, filling with fragile green buds, their roots firmly entrenched in the ground. These trees have inspired me to examine my own roots, which extend from Italy and South America to the United States and which I long neglected in the early years of my life. Just like nature, I too have come a long way in how I view my identity as an Italian-American.

When I was a little girl in elementary school, being Italian was a mark of shame, a stain which forever labeled me as an outsider — at least, that is how I perceived it. The problem lay not in the fact that I was Italian, but that I was too Italian, too oldcountry. My classes teemed with plenty of other kids who had Italian surnames, as typical in the Boston area. However, their ancestors had arrived to the United States decades or even centuries before and their first names and customs remained decidedly American. I was the only girl in the class with an unpronounceable name -Alessia — and I quickly grew frustrated and embarrassed over how many times I had to correct people about it. I was the only girl, it seemed, whose family opened presents on Christmas Eve instead of Christmas Day. When my friends gushed over Italian food, they meant Americanized staples like spaghetti with meatballs and lasagna filled with runny red sauce. My mother cooked odd things like orechiette with broccoli rabe, oregano-seasoned potato croquettes and choux pastries with thick yellow egg cream. I hated the

fact that my family spoke Italian and Spanish at gatherings instead of English. I hated the fact that the programs on the Italian channel were so loud and goofy. Most of all, I hated the fact that being Italian reflected so poorly on my self-esteem.

Gradually, however, I be-

gan to realize that the problem lay inside me, not in being Italian. I used to be blind to the number of people who expressed interest and admiration in my Italian heritage: the teachers who exclaimed how beautiful my name was, the friends who told me that they wished they spoke a foreign language, the many admirers of my mother's authentic Italian cuisine. As I matured, my Italian life became something to be proud of, something that made me wonderfully unique. All of this coincided as all things ethnic became "trendy" again (thanks, hipsters!). Coffee isn't just coffee anymore; you order cappuccino and espresso. You would be hard-pressed to find a sandwich shop that does not label their delicacies as panini. The other day, I was eating lunch at a chain restaurant and discovered that they had orechiette with broccoli rabe on their menu, the same dish that once served as a symbol of my otherness. Now, whenever I see the world around me reveling in Italian culture, I realize how silly I had acted before. Everyone else thought that old-world customs were special except for me. I am embarrassed about my previous under appreciation of my heritage, and constantly seek new ways to explore it today.

I believe that my status as an Italian-American connects me to a rich past of folklore, customs and traditions that have been passed down through the many wise hands of history. It means being closer to the earth as I craft recipes from seasonal ingredients like artichokes, fennel and asparagus. It means celebrating holidays not as commercialized days of consumerism but rather quaint reminders of agricultural societies past, whether it is by enjoying a late-night dinner on a still Christmas Eve night or pinning a paper fish to someone on April Fools' Day, known as pesce d'aprile in Italian. It means partaking in a joie de vivre so typical of the Italian people. I still think Italian television shows are loud and goofy, but I now believe that is part of their charm. I enjoy watching them with my father, who has done more than any other person to introduce me to the wonders of Italian life.

I encourage everyone to take pride in their ethnicity and culture, whatever it may be. I work in a very diverse school district and I swell with pride when I see students who have not forgotten the importance of their heritage. My fiancé is of French, Ukrainian and American Southern descent and I am always goading him to search back into his roots for ideas on holiday celebrations and folk customs. Rather than a badge of shame, I now view my Italian-ness as an integral part of my personality, a code encrypted in my DNA that makes Ally Di Censo who she is. Like the spring trees, I know I comfortably rest with my roots proudly on the ground but my branches extending upward, ready for whatever change the future





WHAT TO BRING TO A MEETING WITH A FINANCIAL ADVISOR

Crucial Questions & Essential Documents

The financial planning process is not but it has a purpose. It gives the advisor a merely a matter of numbers. When you meet with a financial advisor to map out a strategy for wealth accumulation or wealth preservation, you may find yourself intellectually and emotionally engaged on a level you hadn't anticipated. It may actually give you a better understanding of what you want

A solid, multi-aspect financial plan takes many things into account. It may include a tax minimization strategy, an estate plan, an investment policy statement, defined steps toward business continuation or a business exit and more. Now, what is at the root of all of this? What might make you adopt a particular investment style, establish a particular trust, or set certain financial and lifestyle goals for retirement? Your values, your attitudes, your lifestyle circumstances, your needs and your wants.

It all revolves around you.

The discovery meeting & beyond. Financial advisors commonly have a discovery meeting with a new client. Beforehand, you will likely be asked to share some pertinent information in a questionnaire, such as:

- Your age;
- Your present income level and projected future income;
 - Your current and future needs;
 - Any projected expenses;
- Your assets and liabilities;
- The number of dependents you are responsible for:
- Any possible health or external issues that may impact your finances

The completed questionnaire is commonly emailed or mailed to the advisor prior to the discovery meeting. To complement the rather basic information in the questionnaire, the client usually brings the following items to the discovery meeting:

- Recent financial statements for your IRA(s) and 401(k)s, assorted funds and other types of investment accounts and Social Security benefits (if you currently receive Social Security income)
- Information on insurance coverage, employee benefits, any wills and trusts and any pension income or stock options, COLI or forms of deferred compensation
- · A copy of your latest personal (and if applicable, corporate) tax returns

This may seem like information overload,

necessary briefing on the state of your financial life. It also opens the door to a quite necessary conversation — one which can prove valuable and illuminating.

For example, what purpose does money have in your life? What is it there for, what should it help you accomplish? What should it do for your heirs? To greater or lesser degree, your investment strategy, your retirement strategy, your business continuation strategy and your estate plan will express your values and beliefs. Your financial decisions should be aligned with those values and beliefs.

Questions to consider while engaging the advisor. Some people believe that fee-based advisors will be less inclined to "push" products. Some advisors allow you to choose how they will be paid during the relationship.¹

If you become wealthier from the financial strategy you adopt, you can take satisfaction in the tangible financial progress you make. Apart from that, there is also the emotional satisfaction of knowing that you have been proactive and addressed important financial concerns in your life.

Do you have a financial strategy in place? Or could your current approach use some refinement given the way the markets and the economy have changed recently? SHALL WE GATHER

I have high expectations for this book. Shall We Gather written by a personal friend of mine, Ed Nicholson, and his brother, John. Ed Nicholson is a full blown minister whose popularity has him preaching and conducting weddings and related functions everywhere. His brother John was an FBI agent who passed away in 1977. the rugged mountain area of West Virginia, where Ed Nicholson was born. The story centers around three youngsters, Matthew who lives with his grandfather, Mr. Flint

and Matthew's two friends, Atwell and Taylor. Ed Nicholson cleverly uses Matthew as a third person to tell his amusing and sometimes sad observations of these hill people struggling to endure the difficult times brought on by the 1930 Depression.

Early in his book, he writes about two neighbors, Mr. Dodds and Mr. Bates who enjoyed wrestling each other, until one evening Mr. Dodds, a policeman, got tired of wrestling and pulled out a gun and started shooting at Mr. Bates. Mr. Bates did so much whooping, jumping, and dodging causing Mr. Bates to miss. "Mr. Bates figured that the Lord was trying to tell him something, so he got baptized- even before they released him from jail."

As I continued to read Ed Nicholson's effectively written words I could almost hear the distinctive West Virginian accent. His colorful description of the beleaguered characters that are throughout this book is classic. For example, he describes Preacher Moose. "He was a very small man, baldheaded and all wrinkled up with about seventy years of plenty rough living."





Berlin alone, it turns out, had 3,000 such sites. The documents cast new doubt on the notion that ordinary Germans did not know of the horrors their Jewish neighbors faced.

Recipes from the Homeland

VEAL AND CABBAGE STEW

1-1/2 pounds veal shoulder chop

- 1 small cabbage
- 1 medium onion chopped
- 3 small garlic cloves chopped
- 2 ripe tomatoes
- 4 small white potatoes
- 3 carrots
- 2 pieces dried bay leaf
- 4 whole cloves
- 1/4 cup canola, vegetable or olive oil ½ cup minute or regular rice
- (optional)

Salt

Heat oil slowly in saucepan before adding veal shoulder to sear on both sides. Remove meat from saucepan and set aside in a platter.

Add chopped onion and chopped garlic to saucepan and simmer until onion is opaque. Do not burn garlic. Add chopped fresh tomatoes or ten ounces canned crushed tomato. Stir, cover and simmer for about ten minutes.


Meanwhile, peel potatoes and carrots. If potatoes are large, cut into two-inch portions and set aside. Cut carrots into two-inch portions and set aside separately. Remove spoiled outer leaves of cabbage. Cut cabbage in half. Cover onehalf with plastic wrap and store in refrigerator. Cut second half into three portions, wash and set aside.

Add veal to the saucepan. Cover and simmer about five minutes. Add carrots, bay leaf and whole cloves to the saucepan. Stir, cover and simmer slowly about ten minutes. Then add potatoes to the mixture. Place cabbage portions over potatoes and carrots. Spoon the tomato mixture over cabbage. Add a little water if needed. Cover and simmer until meat and vegetables are fork tender. Salt to taste. Remove bay leaf before serving. Serves two.

OPTIONAL: Cook rice of choice according to directions on the package. Serve rice plain or with some tomato mixture over it. Then add a serving of meat and vegetables to the platter.

NOTE: I loved watching Mama create different recipes during the years. Now I encourage others, including my children, to be creative and vary meats and vegetables in recipes. For instance, this meal can be prepared using Italian pork sausages, or shoulder pork chops in place of veal shoulder. The meat used in preparing this will determine the flavor of the stew.

A Nostalgic Remembrance

Now that the Easter holidays are over, weddings are the focal points of the spring.

I remember how few jobs playing music were around during Lent, especially if you specialized in Irish or Italian weddings. Once Easter was over, everyone who owned an instrument worked the wedding circuit.

Several times over the past few years, I have seen the film The Wedding Planner on TV. It stars Jennifer Lopez as a woman who specializes in designing a wedding concept for a young couple. It was cute and entertaining, but it got me thinking about the old days when someone in the family was getting married. In an Italian family, there were wedding planners: the girl's mother, the girl's grandmother, her aunts Maria, Santina, Angelina, all on her mother's side and a couple from her father's side who came out of the woodwork only at Christmas and Easter. Add to this the input from great aunts on both sides and you have the idea of who was around to help with advice to plan a wedding.

Let's say Barbara comes home one evening and announces that her boyfriend, Joey, has asked her to marry him and she said yes. Her parents liked Joey and give their consent, but tell Barbara that Joey has to come to the house and ask their consent. When Joey satisfies their wishes over a middle of the week dinner, the word goes out to the rest of the family within minutes of Joey's departure. By the next morning everyone related to, affiliated with or living within ten blocks of Barbara's parents know the whole story.

The first thing Joey and Barbara have to do is go to Barbara's church and speak to a priest who agrees to marry them. They are then told they will have to attend a few classes where older married couples talk to prospective young couples about the do's and don'ts of married life. Another necessity that has to come from the priest is the date and time the couple have the wedding at the church and whether they want a full Mass with Communion or a quick service just to make it look good. without.

Back home, Barbara's mother insists on a full Mass and the couple agrees to her demands. The next step is to find a hall for the reception. If the church has a downstairs meeting room, this might be the place for a reception. If not, the parents will begin to call people in charge of Sons of Italy halls, American Legion halls, Knights of Columbus halls. Disabled American Veterans halls and VFW halls. Once the place is booked, a determination has to be made as to whether a caterer will handle the food for the guests or if the food should be prepared by three generation of women from Barbara's family. If Barbara's family can afford a caterer, the aunts who were enlisted to help will collectively say, "Grazia a Dio." (Thank God)

Barbara's father knows a musician who plays for a band that might be free to entertain the wedding reception. The musician is called and he, in turn, gives the band leader's phone number to Barbara's father. When they speak, the conversation includes, "How much do you cost?" "How many men do you have?" "Does someone play accordion?"

"Does someone in the band sing in Italian?" If all of the answers suit Barbara's father, he will book in the band.

During all of this, Barbara and Joey ask their brothers, sisters, closest cousins and best friends if they will be part of the wedding party. This used to include a maid of honor, a best man, six brides maids and six ushers. Not to slight anyone, if they have a big family, these original attendants might be joined by another dozen, six male and six female.

Once all of the participants are chosen, Barbara, her mother, her grandmother, an aunt or two and the maid of honor head for a bridal shop, usually one in the old neighborhood that everyone has used for a couple of generations. They will pick out the wedding gown and the dresses to be worn by all the female attendants. Joey will bring his best man and the ushers to a tux rental establishment to get them fitted. Once all of this is over, Barbara's father calls an undertaker friend to see if he can borrow or rent one of his limousines for the wedding,

From this point on, all of the ladies plan a bridal shower for Barbara and the guys plan a bachelor party for Joey. Back then, a bridal shower was a surprise event held at someone's house

and all kinds of gifts would be given to the prospective bride. If the fathers of the bride and groom were invited to the bachelor party, the guys would have to keep it rather tame as compared to what might be planned if it were just the guys.

While all of this is going on, the wedding list has to be determined. Family and friends have to be invited, and back then, no one was left out. Relatives, even distant ones, could count on being invited, as well as most of the people in the neighborhood. From here, all of the ladies in the family would get together and write out the invitations that were picked up from the local card shop owned by a relative. Another relative, who owned a flower shop, would supply the bridal bouquet and all the other flowers that were to be displayed at the church and at the reception.

Joey and Barbara would decide what they wanted to spend on gifts for the wedding party and what kind of cigars to buy that Joey would pass out to all the men at the reception. When all of this was determined, a meeting at Barbara's house would be held to examine the costs. The woman's side usually paid for the wedding, meaning the cost was coming out of Barbara's father's pocket. The rehearsal dinner would be paid for by Joey's parents held at their home or at a restaurant they picked. Lastly, the two fathers would get together to see what they were going to give the wedding couple for a gift. Should it be the money for a honeymoon or some money to help get them started in life as a married couple, who knows, maybe it was both if they could afford it.

Now with everything set, where will the newly married couple live? Chances are, one of the parents or a relative had a three-decker in East Boston, the North End, Revere or Medford and an apartment was available. Hopefully, the apartment was within walking distance of where all the parents lived.

The wedding day arrived and Nonna's prayers were answered ... it didn't rain. All went well and they lived happily ever after. Is this a Cinderella story or just the way it used to be if you were lucky enough to be part of an Italian family???

Welcome to the Malden Field of Dreams

On Sunday, March 17th over in South Boston for the annual St. Patrick's Day Parade, I bumped into an old friend Domenic D'Ambrosio, who I knew years ago when he worked at the Mayor's Office at Boston City Hall doing special events across Boston neighborhoods. Nowadays, he is still doing special events and community relations, but this time with Baseball Field of Dreams LLC over in the City of Malden. This groups is developing the project hoping within 14 months or so to open a new state of the art "green" ballpark with a 6,300 seat capacity, have a Kids Zone and a grassy family-oriented picnic seating area. All monies to build this project will be privately financed.

Two excellent architectural firms are designing the park. Pellham Phillips Architects is one. This firm designed Hammond Field out in Missouri which is now the home of the Double A Springfield Cardinals. The second firm is The Architectural Firm based right here in nearby Chelsea. When ready for use by an Atlantic League minor league team it will also be available for use by the Malden High School varsity baseball team for its home games. The developer also proposes to use Malden Park, as it is being called, for business meetings, musical concerts and other community and commercial uses.

This looks like a win-win for all involved. It will create jobs, both in construction and long-term at the facility. It will provide an economic boost to the City of Malden and the region surrounding it. As I stated, the developers are seeking a Malden franchise in the independent Atlantic League of Professional Baseball. Most

of the ballplayers in this league have already moved through developmental minor leagues. Roughly, 35 percent of the players in this league have some Major League experience. Players like Ricky Henderson and Ruben Sierra played in the Atlantic League. The league plays a 138-game regular season (69 home games) and the season starts in late April until mid-September, depending on playoff games.

The team has no name yet. The Field of Dreams folks are looking at a community contest to name the team in 2014 and naming rights will help with the financial projections. If all goes well the Malden (name to be picked later) will be on the field throwing out the first pitch to home plate in April 2015.

As a baseball fan, I hope all this comes to pass because it would give kids and families a way to see baseball live without going flat broke. The Malden Field of Dreams can hopefully do for Malden what the Brockton Rox and Lowell Spinners have done for their respective host cities.

Bad news for Dice-K as the Cleveland Indians released him from his Minor League deal and more bad news for ex-Red Sox hurlers as the San Diego Padres dump Freddy Garcia too.
