Drum Roll for Losers



Winthrop Square Project

The Friends of the Public Garden and Boston Common have been faithful stewards of these beautiful public green spaces for many years. The city owes them an enormous debt of gratitude for their dedication. However, that dedication has blinded them to the much larger picture of the myriad benefits flowing from the Winthrop Square development.

This project, on city-owned land, is a once-in-a generation opportunity for Boston, with an unprecedented \$150 million offered by Millennium Partners to build a 750-foot tower on the site of a condemned garage. The project will fill the city's coffers with funds to be invested in the protection of parks all over Boston, including Boston Common, but more importantly, it will support construction of new affordable housing and renovation of existing affordable housing in Chinatown, East Boston, and South Boston. It will provide thousands of jobs and over \$12 million annually in property taxes to the city.

It will also cast a minimal morning shadow on the Public Garden and Boston Common, which currently is not allowed by law. There will be no impact whatsoever on the growing season of the flowers, trees, or shrubs that grace these beautiful parks. However, because of these limited shadows and a little known, 26-year-old shadow law, the Friends of the Public Garden are fighting to stop

this development project and refuse, on behalf of the other Bostonians, the benefits that go with it.

While I appreciate the dedication of the people who protect these parks, we would respectfully ask them to reconsider their opposition and remind them that the parks are here, in the heart of our city, for the benefit of all the people of Boston, whether they have had opportunity to enjoy them or not. Boston Common is the oldest public park in the nation, and it is called the Common, because it is here for the common good, for every person who resides in Boston or visits from far and wide.

Like many times before, on a Saturday this past January, over 175,000 people came together on the Common and throughout the Garden, in support of women's rights and in opposition to President Donald Trump's initiatives. The grass was surely trampled, the ground beaten down, as thousands and thousands marched in solidarity. This is exactly the role of these spaces in our civic life and the city embraces it.

Why? Because the public good of this historic gathering so far outweighed any limited imposition on the land. Because the purpose of these spaces is for the people to gather, to celebrate, to protest, to play, to live, in harmony with this city, as a united community. This is their home, our home. Since 1634 and 1837, these public spaces have

witnessed the lives of millions of people; they have sheltered and eased the weary and have provided a haven and times of inspiration.

The Winthrop Square development, at no cost to the life of these green spaces, offers a widespread and historic well of opportunity. Affordable housing, jobs, playgrounds, and safe spaces for our children are immediate and important issues that the Winthrop Square project will directly address throughout the city. The citizens of Boston are in need of an affordable place to live and for meaningful and sustainable long term employment. This project is not just a one-time opportunity generator (as remarkable as a \$150 million payment to the city is) but will continue to work for the city as long as it exists.

The Winthrop Square project shines a light on a unique and widespread public good that will vastly outweigh morning shadow. To stand in the way of this unprecedented opportunity, based on nothing more than a few minutes of incremental shadow early in the morning that are already allowed by other developments would be a tragic mistake. If the Public Garden and Boston Common could talk, we have no doubt they would say the same.

Stirpe Nostra

PIUS TIBERIUS

Tiberius Claudius Nero Caesar, second emperor of Rome, was the third of the twelve Caesars and was also the third member of the Julio-Claudian line. He was born on the Palentine Hill on November 16, 42 B.C., the son of Tiberius Claudius Nero and Livia. His mother Livia later married Augustus. His father died when Tiberius was only nine years old and at that young age he eulogized his dead parent from the rostrum in the Forum. While in his early teens, he and Marcellus accompanied the chariot of Augustus in the triumph at Actium (the defeat of Marc Antony and Cleopatra).

At a later age, Tiberius married Agrippina, the daughter of Marcus Agrippa, the army general, statesman and builder of the Pantheon. They lived happily for a few years, but he was forced to divorce her and to contract a hurried marriage to Julia, the daughter of Augustus, an act he regretted for the rest of his life. His marriage to Julia soon cooled to the point where he ceased to live with her.

His first military service was as a tribune of the soldiers (commander) wherein he led a campaign against Armenia and Parthia, and was responsible for resettling forty thousand prisoners of war into new homes along the Rhine. He returned to Rome riding in a chariot, honored with the Triumphal

Regalia, a new kind of distinction never before conferred upon anyone. His popularity mounted and in time he held the offices of quaestor (public prosecutor), praetor (chief magistrate), and consul (one of the two highest magistrates).

During the height of his success, Tiberius withdrew from political life, asking for leave of absence because of weariness of office and a desire to rest. He

made a hasty departure from Rome and settled in Rhodes for about seven years. He returned to Rome and took up residence on the Esqualine Hill where he attended mostly to his personal affairs and exercised no public functions. Claudius was adopted by Augustus along with Marcus Agrippa. The practice of adopting adults was not uncommon in Rome during imperial times.

During a revolt and ensuing three-year war with Illyricum, Claudius was given command of fifteen legions plus an equal number of reserve forces. His perseverance was amply rewarded by a complete victory over this territory which now makes up a part of Yugoslavia. The victory took on more importance because of a simultaneous defeat of three Roman legions in Germany. Thus, through Claudius the day was saved for Rome in this area. Because of this success, a "Triumph" or great victory parade was held in honor of Tiberius. He was offered the surname of Pannonicus, Invictus, or Pius. It is interesting to note that this all took place in the year 9 A.D. and the name Pius in Latin means conscientious, godly, holy, motherly, brotherly, sisterly, good, sacred or patriotic. I'm not complaining, just explaining.

The Wicked mart Investor

We all remember "The thrill of victory and the agony of defeat" from ABC's *Wide World of Sports*. The host Jim McKay left this tidbit out: many winners were once losers who decided to change course. It's too bad the average investor doesn't embrace needed change; he lets a status quo bias dictate his investment decisions.

To explore this topic, I turn my attention to someone eminently special to me, Braintree-born marathon runner Sean Quigley. *The Wicked Smart Investor* had the privilege of witnessing his first steps.

The significance of that milestone only became apparent when he started running track at Archbishop Williams High School. Sean was fast and won many awards. His most prestigious award was the 2003 National Scholastic 500M trophy. I was elated for my fellow Bishop.

Sean continued to rack up successes at La Salle University and beyond. He placed well in the 2008 U.S. Olympic trials. The next year, he won the Boston Mayor's Cup during our beloved Mayor Menino's tenure. Now that Sean is running in the Boston Marathon as an elite runner, I'm beaming with pride. After all, I changed his diapers so I can somewhat lay my claim to him.

He put in a lot of hard work and sacrifice to get to this point. It took a bit of trial and error for him to optimize his training program. Sean only thinks of winning. If something isn't working, he puts it far, far behind him.

The average investor finds making changes harder to do. This is called the status quo bias and it can as dream-crushing as Heartbreak Hill. Simply put, investors have an innate preference for the current state of affairs. Furthermore, they perceive any change from the status quo as a loss even if that change is beneficial. Humans frequently make emotional, irrational investment decisions that can damage their financial well-being. I realize "them are fighting words" in Wicked Smart Boston. But before you get mad, remember I didn't call anyone stupid; I simply called them "human."

Let me offer some proof, and I'll shrink it down to fit in a nutshell. In 1991, a group of behavioral economists led by Daniel Kahmann created experiments that reliably reproduced the status quo bias. They asked a group of research subjects what they would do in the following scenario: An uncle left you some cash that must be invested in company A, B, C, or D. The subjects had some financial knowledge so they were comfortable selecting investments. The resulting choices were somewhat evenly distributed among the choices. Now, there was a second group and they were told that the funds were already invested in company B. They could change to invest in any of the companies. Guess what? Although they could make any choice, most of them decided to stay with company B. That is the status quo bias.

I see this bias often and it can be quite harmful. Investors have different risk tolerances and time horizons as they go through life and it's prudent to adjust investments accordingly. When I suggest changes, I can almost see, taste, hear, feel and smell investors' defense mechanisms. Think really hard before rejecting changes suggested by your advisor. Changing it up is what made Sean an elite marathoner. I wish we could change recent marathon history, but that's impossible. We'll never forget what happened because we're a city overflowing with compassion. But a strong finish by a likable local would further assuage enduring wounds and upgrade Boston Strong to Boston Stronger. Let's root, root, root for the home team and cheer on Sean Quigley.



Co-headlining with Ms. Zanicchi will be her American hosts, the iconic Rock & Roll, Vocal Group, and Grammy Halls of Fame vocalists, **The Platters**® ("Only You," "Great Pretender," "My Prayer," "Smoke Gets in Your Eyes"). Ms. Zanicchi and The Platters represent the multigenerational kinship that symbolizes the unity of the Italian and American people via the universal language of music.

The purpose of the tour is

Holy Week in Italy: A Time of Tradition

crystal, I look forward to the promise of Easter, the prime spring holiday. Signs of Easter the first purple tulips spring from the rich soil. Marshmallow Peeps wink playfully at me as they line shop selves in brilliant hues from robin's egg blue to bright tutu pink. Baskets and wreaths boast eggs dyed with bold solid colors or glittery patinas. At the mall, costumed Easter Bunnies pose for family photos with children in frilly dresses and crooked bowties. However, as much as the coming Easter fills me with pleasant anticipation, I am reminded that the week preceding the holiday brims with its own unique customs and traditions. The week's very name, Holy Week, reveals its profound importance in the religious year. Italians call Holy Week la Settimana Santa and celebrate its arrival with much fanfare. The Holy Week festivities in Italy emphasize seasonal spring folklore while also paying homage to the intricate and inspiring spirituality of this period. Whether filled with displays of palm leaves or colorful eggs, Holy Week in Italy and around the world heralds the Easter holiday with the reverence, love and joy it deserves.

April 9th, which is Palm Sunday. Palm Sunday commemorates for the joy of Easter. Jesus' entrance into Jerusalem, when adoring crowds welcomed Him by waving palm branches in the air. Along with its religious significance, Palm Sunday re-

After a damp and bitterly cold year when tree branches begin March in which every raindrop to blossom. My father grew up felt like the pinprick of an ice in the mountainous region of the Abruzzi in Italy, where he would spend Palm Sunday, or Domenica delle Palme, colsprout around me as surely as lecting the olive branches that grew plentifully in the hills and fields near his home. This was the same country wilderness, laden with ancient orchards and thick forests, about which village elders whispered stories of sprites hiding under rocks and wolves darting among the trees. My father and his friends would then bring the branches to the local parish, where the priest would bless them. This quaint sylvan ritual embodied all the pleasures of spring, such as communal outdoor excursions and metaphorical links to the themes of rebirth and spiritual awakening. Throughout Holy Week, Italians also give their homes a thorough spring cleaning in preparation for Easter and the days of visiting to follow. Holy Week ends with Good Friday, or Venerdí Santo, the solemn remembrance of Jesus' Crucifixion. In Italy, processions of black-robed participants set the somber and pensive atmosphere of the day. Processions that focus on the Virgin Mary are known as the *Addolorata*, a name indicative of Mary's grief and pain. Therefore, Holy Week begins in triumph but ends in Holy Week begins this year on tragedy, encompassing all the emotional spectrum necessary

For me, Holy Week has always meant Easter preparations, particularly those with an emphasis on the Italian traditions of my ancestors. My parents would mains attuned to the seasonal reserve a day, usually Holy Satbeat of spring, symbolically urday, for decorating eggs with falling during the time of the my brother and me. Eggs have

celebrations since ancient times due to their rebirth symbolism: though they appear cold and sterile on the outside, they contain new life inside. I always enjoyed picking the egg dyes, and I would often chose a bright or glittery color to match the cheerful hues of the flowers growing outside my home. Easter eggs form a sweet part of Italian holiday customs as well. During Holy Week, my father would always buy a gigantic chocolate uovo di Pasqua (literally, "Easter egg") from a specialty shop in the North End, wrapped in pastel foil. We would patiently wait until Easter to ceremoniously break the egg open, eagerly anticipating the treats concealed within — usually candy. An Italian superstition decrees that everyone must wear at least one new piece of clothing on Easter, again illustrating the theme of renewal central to the holiday, and as such my mom and I would often shop for a new outfit during Holy Week. When I was a child, this meant a lacy, flowery dress. Though I no longer seek out itchy dresses, I do pick my new clothes with bright colors or a flowered pattern to reflect the spring season. Finally, my mother and I spend much of Holy Week planning our Easter menu. On Holy Saturday, I bake my traditional Italian ricotta pie to be served at the feast the next day. Therefore, I associate Holy Week with the joy and promise of an exciting holiday to come. Its customs have instilled in me an appreciation for the blooming new season of spring, for the spirituality of Easter, and for my Italian heritage as a whole.

Holy Week is a profound and multifaceted period of the year. It revels in the springtime and the resurgence of nature all around us, from the flowers fluttering proudly in the sunlight to the bunnies munching on the fresh green grass. It grants us an opportunity to enjoy the warm spring weather and to find peace and reflection in the spiritual traditions of the pre-Easter season. Puerto Rican Governor Warns Baker of Puerto Rican Flood

We all know right now that Puerto Rico is in financial trouble and has been for some time. The governor of Puerto Rico reportedly sent Governor Charlie Baker a letter warning him that the approaching "cliff" in federal Medicaid funding on the paradise island under the Affordable Care Act could flood the mainland with thousands of migrant Puerto Ricans with many of them flooding into the City of Chelsea in the near future.

Governor Ricardo Rossello has reportedly called upon Baker to ask our Congressional delegation to seek more funds for healthcare on the island. 

Saint Andrew

Patron Saint of Scotland

Saint Andrews is Scotland's legendary golf course, a course that all avid players want to play at least once in their lifetime.

What is the connection with Saint Andrew, one of the Twelve Apostles and brother of Saint Peter that links him so firmly to the history of Scotland? An early legend is related to that of Emperor Constantine's victory at the Battle of the Milvian Bridge (312 AD). Similar to Constantine (but not the Burning Cross of Constantine's), King Oengus of the Picts saw a Saltire Cross (distinct X-shaped cross of Saint Andrew) in the sky, formed by clouds, ahead of his victory over the Saxons at the Battle of Athelstaneford (735 AD). Óengus and his combined force, emboldened by this apparent divine intervention, took to the field and despite being inferior in numbers were victorious. Having interpreted the cloud phenomenon as representing the cross upon which Saint Andrew was crucified, Óengus honored his pre-battle pledge and appointed Saint Andrew as the Patron Saint of Scotland. The white saltire set against a celestial blue



background was subsequently adopted as the design of the flag of Scotland.

Another legend states that the relics of Saint Andrew were brought by divine guidance from Constantinople to the location where the modern Scottish town of St. Andrews stands today.

St. Regulus, who was a monk at Patras, received a vision

telling him to hide some of Andrew's bones. Shortly after Regulus' dream, many of Andrew's relics were transferred to Constantinople by order of Roman emperor Constantius II around 357. Regulus later received orders in a second dream telling him to take the bones "to the ends of the earth." He was to build a shrine for them wherever he shipwrecked. He landed on the coat of Fife, Scotland.

Legend also states that the relics were originally in the collection of Acca, bishop of Hexham, who took them into Pictish country when he was driven from Hexham (c. 732), and founded a see on the site of St Andrews.

National heroes William Wallace and Robert the Bruce both appealed to Saint Andrew in times of emergency.

St. Andrew is the patron saint of fishermen and singers. He is also the patron saint to several countries and cities including: Scotland, Romania, Russia, Ukraine and Patras. His feast day is celebrated on November 30th.

Happy Birthday to a close Scottish friend.





The Swan Boats are built on oak-framed pontoons sheathed in copper just as they were initially constructed in 1877.

The Tragic Death of Brandon Lee



Brandon Lee, a rising star who, like his legendary father, was gone too soon.

As far as the courts were concerned, the death of Brandon Lee on the set of *The Crow* was an accident. Too many hands were involved in preparing the gun used in the scene, said the court, that it was impossible to pinpoint a single person responsible. Indeed, the more we read into the tragedy that befell the 28-year-old actor, the farther away we seem to get to finding a real culprit and the stranger the case seems to get.

Certainly it involved some ignorance of how firearms work and this was a dangerous subject to be unaware of when breaking from the standard Hollywood practice of using dummy cartridges for shooting scenes. The .44 Magnum revolver had been used before in the picture and the set-up for the fatal scene involved Lee walking into his apartment carrying a grocery bag to find a mobster played by the late Michael Massee waiting to kill him. The set-up was simple enough. Massee's character would fire dummy cartridges at Lee while Lee detonated a squib from the grocery bag, a small explosive that, combined with the firing of dummy cartridges (real bullets with the powder removed), created the illusion of a gunshot.

However, not was all ok when director Alex Proyas (making his directorial debut in America) started filming the scene. In an earlier scene in which the revolver was fired, the crew unknowingly left the primer in place when they reinstated the blank bullets into the revolver. Later, this bullet became lodged partway into the barrel. When fired, it would be released with the same amount of force as a loaded bullet. To add an extra layer of bad luck, J.B. Jones, the film's special effects wiz, and stunt coordinator Jeff Imada had both left the set, leaving no one knowledgeable about props on sight.

The scene moved forward with no one guessing that the fate of Brandon Lee was already tragically sealed. About eighty people were on site when Massee fired the revolver fifteen feet from Lee. Lee managed to detonate the squib before being hit in the abdomen and collapsing.

According to an eyewitness present, "It didn't really appear to the people on the set like anything was wrong." And not until the cameras stopped rolling did the crew realize the actor was hurt and bleeding immensely. An ambulance was quickly dispatched and Lee was sent to the New Hanover Regional Medical Center in Wilmington, North Carolina, where the filming was taking place. He was stabilized and surgeons quickly tried to stop the bleeding and repair the intestinal and vascular damage. By the time his family arrived, he had been transferred to the intensive care unit and he never woke up. He died on March 31,

Much confusion and some finger pointing followed but, ultimately, the death was ruled an accident. The movie was finished with the use of stunt doubles and computer graphics. Director Alex Proyas was never to become a major force in Hollywood, a good portion of his subsequent work (*Knowing*, Gods of Egypt, etc.) being bombarded by critics. But The Crow became his biggest hit (both in America and his native Australia) and, along with Dark City and I, Robot, remains among his best-liked work. Though Paramount dropped the stigmatized picture, Miramax took a gamble that paid off. *The Crow* became a box-office smash, aided in fact by those seeing it as the legacy of Brandon Lee. Michael Massee, the unfortunate actor who unwittingly fired the fatal shot, took a brief hiatus from acting and though he returned to some success with The Amaz-



ing Spider-Man in 2012 and its sequel, he never got over the incident. "I don't think you ever get over something like that," he said in 2005.

But blame was nowhere to be found. As Mark Harris wrote in *Entertainment Weekly*, "In all likelihood, the cause of Brandon Lee's death is simpler, and so perhaps more horrifying: Somebody made a mistake."

And yet, there were those who were not satisfied with so simple an explanation, a common phenomenon when a terrible tragedy is explained so simply. Popular culprits in the eyes of conspiracy theorists are the Triads, a violent gang based in Hong Kong that forms part of the Chinese underworld. The grudge, according to rumors, traces back to Lee's father, Bruce Lee, who popularized martial arts in America and became a legend. Indeed, the similarities between Brandon's death and that of his father twenty years earlier are undeniably shocking. Both father and son died while filming a movie and both deaths were untimely. Supposedly, the Triads were angered by Bruce Lee's stardom as it was exposing secrets of martial arts and killed him when he ignored their warnings. After his son became a star, it is claimed, they continued their vendetta making sure he wouldn't follow in his father's footsteps, and so sabotaged the props on the set.

Talking of the conspiracy theories last October in *The Telegraph*, Tim Robey said, "This is all stuff for fetishists of the macabre. The real solution to Brandon's initially-baffling demise was a one-in-a-million instance of the wrong gun being unloaded on him, at the wrong time, and in the wrong anatomical place."

Robey goes on, "Even now, coping with a dead star is no one's idea of easy. In 1993 it was close to impossible, and pushed the film's budget up considerably. To the huge relief of all involved, they pulled it off. Though Paramount declined to pick up what was now a markedly different proposition from the one they'd agreed to, Miramax bought the rights instead."

In a morbid way, Brandon Lee managed to avoid one fate he always feared--standing in his father's shadow. He tried shifting away from martial arts movies and *The Crow* was supposed to be his big breakthrough to stand on his own. Though through a horrible accident it didn't make him a star, it did create his legacy.

Parla Come Mangi!

(Speak as You Eat!)

Benvenuti! This time of the year announcing the arrival of spring, the awakening of nature and the renewal of life is filled with great anticipation in Abruzzo. In preparation for Pasqua (Easter), eggs, the symbol of life, are used to prepare many dishes like brodo di stracciatella where eggs are combined with chicory and endive, and scrambled in broth or the traditional timballo, where eggs are $hard\text{-}boiled\ and\ layered\ in\ between\ layers\ of\ crepes\ to\ make\ a\ sort$ of lasagna. The typical Easter sweets are called pupe e cavalli in this region and consist of cookies shaped like girls (pupe) for the girls and horses (cavalli) for the boys. In these sweets, raw eggs in the shell are cast right into the cookie dough and cook as the cookie bakes in the oven to wish prosperity and life. The earthy cuisine of Abruzzo reflects the farming and livestock production typical of this region with recipes that originate in the kitchens of the shepherd's wives. Sheep, goats, and lambs are still raised following the trans $humance\ farming\ method\ where\ they\ graze\ on\ alpine\ meadows\ in$ the warm season and are brought to lower valleys as the fall arrives and leads in to the winter. As a result, their meat is tender and tasty and their milk is of outstanding quality. Lamb has always been an important part of the Mediterranean culture as it was used as a sacrificial animal in ancient times and early Christian rituals. The Lamb of God, in the New Testament, is the symbol for Jesus, particularly during the Easter season. This traditional recipe from Abruzzo called agnello all'uovo e limone combines lamb with egg and lemon, is very easy to prepare, and would make a wonderful addition to your Easter menu. Enjoy this delicious beloved dish with a glass of Montepulciano d'Abruzzo. Buona Pasqua a tutti!

Agnello All'uovo e Limone

(Lamb with Egg and Lemon)

1 cup finely chopped onions 4 oz ham 2 Tbsp butter Nutmeg 2 ½ lbs leg of lamb (deboned and chopped)

Salt and pepper to taste All-purpose flour 1 cup meat stock 1 cup dry white wine 2 egg yolks Juice of 1 lemon

Preparation: Cut the ham into thin strips and sauté it with butter and onion in a stew pot. Season with salt, pepper and grated nutmeg. Toss the pieces of lamb in flour, add to the onion and brown lightly. Pour over the meat stock and simmer, allowing to thicken. Add the wine, salt to taste, cover and cook over low heat for about 2 hours. When cooked, remove the lamb from the pot, transfer to a serving platter and keep warm. Remove the pot from the heat, beat the egg yolks with the lemon juice and stir into the meat juices. Return the pot to the stove and whisk continuously over a very low heat until the sauce is frothy. Pour over the lamb and serve immediately. Buon appetito!

Agnello All'uovo e Limone

1 cup di cipolle finemente tritate 100 g di prosciutto cotto 20 g di burro Sale e pepe q.b. Noce moscata q.b. 1 Kg di coscia d'agnello (disossata e in pezzi)
Farina
250 ml di brodo di carne
250 ml di vino bianco secco
2 tuorli
Succo di un limone

Preparazione: Taglia il prosciutto cotto a listarelle e soffriggilo in una pentola insieme al burro e alla cipolla. Aggiusta di sale e pepe e aggiungi della noce moscata. Passa i pezzi di agnello nella farina, agiungili alla cipolla e falli dorare. Aggiungi il brodo di carne e fai sobollire fino a far addensare. Aggiungi il vino, regola di sale, copri e cuoci a fiamma bassa per circa due ore. A cottura ultimata rimuovi l'agnello dalla pentola, trasferiscilo in un piatto da portata e tienilo in caldo. Rimuovi la pentola dal fuoco, sbatti i tuorli con il succo di limone ed aggiungili al sugo di carne rimasto nella pentola. Metti la pentola sul fuoco e, a fiamma bassissima, mescola costantemente con una frusta fino ad ottenere una salsina cremosa. Versa sull'agnello e servi immediatamente. Buon appetito!

Nanna & Babbononno

A Nostalgic Remembrance



Like most people my age, I read a newspaper column a couple of times a week that is affectionately called the "Irish Sports Page." Actually, it is the obituary column found in Boston's newspapers. I guess we Italians and Irish were always big on wakes and funerals. It is part of our overall heritages. But, especially when you are beyond a certain age, you look for names of people who are your contemporaries.

About a week and a half ago, I read that Chuck Berry passed away at the age of 90. He was one of the pioneers of rock and roll, beginning his career when that form of music was called rhythm and blues in the early '50s.

My teen years were in the mid-fifties and I was part of that first rock-and-roll generation. I danced to the music of Fats Domino, Bill Haley and the Comets, Little Richard, Clyde McPhatter and the Drifters, the Clovers, and many others. None of them was as influential as a tall, thin guitar player who told a story with every song, Chuck Berry. I found out many years later that he was one of the main inspirations for two of the most famous groups in pop music over the decades, the Beatles and the Rolling Stones. He was also the inspiration behind the styles of many aspiring guitar players over a 60 year period.

When I became a student at Boston English High School, I was in the company of many boys with Italian last names from East Boston, the North End, and the West End. There were Italian boys from other neighborhoods around the city--Brighton, Hyde Park, Roxbury, and Jamaica Plain — but they weren't like "my crowd" from what we called, "The real Italian neighborhoods." We knew how to dress, what our hair should look like, how to speak with the latest expressions mixed in, and we knew how to dance better than most. Our only competition came from African-American boys our age. The term used then to make a comparison was, "The Colored competition."

We shopped at a store on Boylston Street called Sumner's (For men who know style). They featured the latest in high-style clothing, one-button roll collar suits with pegged pants, and roll collar shirts that we called "Mr. B. shirts." The "B" was short for singer Billy Ekstine who designed the shirts. We added to the suits one-inch wide ties, suede shoes, our initials on our shirt collars and, in the winter, double breasted overcoats.

All the Italian barbers learned

to cut our hair according to the latest trend, D.A. haircuts. The D.A. stood for "duck's ass," because the back of our pompadour style was combed toward the center, which gave the appearance of its name. Those of us with curly hair had a problem. Not long after the barbers cut the hair into a D.A., it would curl up again. As a result, the barbers began selling us pomade, thick pomade, a lot thicker than Vaseline Petroleum Jelly. They told us that this was the stuff the colored boys used to keep their hair straight and we bought the most popular brand, Royal Crown. A small container was ten cents.

Dad and Babbononno weren't too happy with my teenage taste in music. I had been brought up on classical music, opera and jazz. The new sound was really a kissing cousin to jazz, but not what Italian boys should listen to. Of course, all of my friends went through the same thing with their parents, so we all defied those parents and dressed in accordance with the style I described and listened to the music originally called rhythm and blues.

There was only one station on Boston radio that played this type of music. Its call letters were WBMS. After a major shakeup in the late '50s, the name would change to WILD, and remain with those letters until they went off the air in the not too distant past. They had a broadcast day that began at sunup and ended at sundown.

The number one disc jockey was called Symphony Sid. Do any of you remember him? Because of the way he spoke (with the latest slang and hip talk), we all thought he was black. He actually was a nice Jewish boy from New York who dominated the R and B music until DJs like Bill Marlowe came on the scene and took the music to new heights. There was a shakeup in 1958, and Symphony Sid was fired and things began to change. DJs with names like Arnie "WooWoo" Ginsberg came on the scene and R and B became rock and roll.

By that point in time, I was in college and abandoned the zoot suite, the suede shoes, and the D.A. haircut. The Ivy League styles took over and jazz and folk music were the musical choices as far as the college students in and around Boston were concerned.

Dad never prohibited me from experimenting with my styles of dress or my hairdo. I knew that he had to convince Babbononno that it was only a phase I was going through, and he was right. Dad was always right. Without saying it, he probably had done similar things back when he was a teenager in the mid-'20s.

I remember going to my first dance that featured R and B stars. It was right after Easter, and we dressed in our new clothes. The musical groups and the singers were integrated as well as the audience. That was a no-no back then, but we did things our way. We've come a long way since then, I think.

When I read the obituary on Chuck Berry, and a brief biography that accompanied it, I began to reminisce about those days. Since the '80s, I've seen many of the groups that became famous in the three decades that proceeded. The singers were older, heavier, and grayer than back in the day, but some of the vocals were still pretty good. The revivals are called Doo Wop revivals and as they do their thing, we old folks reminisce and think about those "record hops" we danced at oh so long ago.

We had a priest at the Sacred Heart in East Boston who headed up the CYO. On Thursday nights, we had a dance at the school that was to the left of the church. On slow numbers, if we danced too close to our partners, the priest (I believe his name was Fr. Mackin) would come up to us, push us apart and say, "Leave room for the Holy Ghost."

With the passing of Chuck Berry, the end of the first generation of teen music is ending, also. I wonder if we will ever see another musical dawn like that again.

Grow an Abundant Tomato Harvest in a Pot

by Melinda Myers

Harvest and enjoy the gardenfresh flavor of tomatoes right outside your kitchen. Grow them in containers set on your patio, balcony, deck or stairs. You'll enjoy the convenience of harvesting fresh tomatoes just a few feet away from where you prepare your meals. And your guests will enjoy harvesting fresh tomatoes to add to their salad or sandwich.

Tomatoes need warm air and soil to thrive. Containers give you the ability to jump start the season. Plant tomatoes in containers earlier than in the garden and leave them outdoors when it's warm (but bring them inside whenever there's a danger of frost). Protect your plants with the help of seasonextending products like cloches, red tomato teepees, or garden fabrics. These will help warm the soil and air around the plants, reducing the number of days to your first harvest.

Select flavorful and diseaseresistant varieties for your container gardens. Consider 'determinate' tomatoes that are more compact and generally less than four feet tall. But don't eliminate your favorite indeterminate tomato. Just provide a strong, tall support for these plants that continue to grow six feet and taller throughout the season.

Grow your tomatoes in a sunny spot that receives at least eight hours of direct sunlight. You'll grow the biggest harvest and reduce the risk of disease.

Fill your container with a quality well-drained potting mix. Add a slow release organic fertilizer to your potting mix if needed. This type of fertilizer feeds the plants for several months. Give the plants an additional feeding midseason or as directed on the fertilizer

Check soil moisture daily; water thoroughly and often enough to keep the soil slightly moist. Maintaining consistent soil moisture means healthier plants and fewer problems with blossom end rot. This disorder is not a deadly disease, but it causes the bottom of the first set of fruit to turn black.



Sadly, not only did Dick Radatz have a career that fell pretty quickly downward, but he also passed away on March 17, 2005, when he fell down a flight of stairs in his home.

GEORGES CARPENTIER The Orchid Man

Great French Boxer Fought in Every Division from Flyweight to Heavyweight

Georges Carpentier led an amazing life. He made his professional boxing debut at the age of fourteen in 1908 fighting as a flyweight. He would go on to fight in every weight division as he grew in size, eventually challenging Jack Dempsey for the Heavyweight Championship of the World in 1921. He had won the World Light Heavyweight Title a year earlier when he defeated Battling Levinsky by knockout.

While Carpentier had great success in the ring, he also gained fame as an aviator in World War I. He was awarded two of France's highest military honors, the Croix de Guerre and the Medialle Militaire. When he signed to fight Dempsey, the press played up the angle of Carpentier the war hero vs. Dempsey who had not served in the war. The match was the first boxing match to draw over a million dollar gate with 80,108 people in attendance. Though Carpentier was a brilliant boxer with a tremendous right hand punch, he was outmatched by Dempsey, who knocked him out in the fourth round. But not before the challenger staggered the champ in the first round.

Near the end of his career, Georges would fight future champ Gene Tunney who stopped him in the 15th round. He would finish his career with a record of 90 wins, 14 losses, and 6 draws.

Georges was also a talented stage and screen actor as well as a song and dance man. He was immensely popular on both sides of the Atlantic with his charming personality and warm smile. He remained friends with former rival Jack Dempsey for life. Georges Carpentier passed away in 1975 at the age of 81.

Carpentier was a stylish boxer/puncher who wrote instructional books on boxing. Even in

They smiled broadly, raised their sticks and hugged one another, all symbolic of the band of brothers they have become. It has been a long, challenging and uncertain road, one littered with the unforeseen and highlighted by changes.

Yes, the Bruins have earned a berth in the Stanley Cup Playoffs for the first time since 2014. But when the moment arrived the observance was muted, with anything that signified a celebratory atmosphere held to an absolute minimum.

The lights that illuminated the ice were muted. Indeed, the Jumbotron cameras had to be opened to their light-gathering maximum in order to capture the immediate aftermath of the 4-0 victory over Tampa Bay. The scene in the arena resembled twilight rather the bright dawn of a new age.

Once media members gained access to the Bruins locker room, the atmosphere differed little from the aftermath of a midseason victory. Yes, the Bruins were happy, but not overly so. There were smiles, but no more than you might see in the aftermath of a win earlier in the year.

If anything, there was the understated emotion of relief with the certainty of knowing that you have successfully negotiated a basic challenge that, in turn, will lead to additional positive possibilities. There was also the sense that the team had accomplished its business, had completed a mission, and would soon face other challenges ahead.

Indeed, when one thinks about it, the Bruins haven't won anything yet. Montreal has the Atlantic Division title while Washington can claim the Metropolitan Division and Eastern Conference crowns. The Bruins still have empty pockets — but at least a chance to fill them.

In truth, though, a lot had been saved. Not to have made the playoffs probably would have meant that interim head coach Bruce Cassidy would not be retained. The acquisition of a playoff berth increases the probability that he will become the permanent head coach.

In addition, a playoff berth also probably means the retention of Bruins General Manager Don Sweeney and Bruins President Cam Neely. Both were perceived as vulnerable if the Bs had once again been idle in the spring for a third consecutive year.

And although the night belonged to Bruins goalie Tuukka Rask, who recorded his eighth shutout of the season, the 38th of his career, and his fourth against the Lightning, the improvement of backup Anton Khudobin down the stretch has made a big difference.

A problematic performer in the nets earlier in the season, Khudobin has been stellar of late, winning his last six games, including a 3-2 victory over Western Conference leader Chicago on April 2nd on the road.

And the change? Well, everyone knows what that was sending longtime head coach Claude Julien out the door and elevating Cassidy to the interim head position. Through the clinching game, Cassidy's record stood at 18-7 since the changeover, a remarkable record over the last third of the regular season.

Just about everyone seems to have improved — even Khodobin. Remember the old saying that a rising tide lifts all boats? Bruins fans may well be seeing it played out before their eyes.

The point is that since the changeover, the Bruins have gained confidence. Cassidy made the point in a postgame press conference that players know that if they make a small mistake, the goaltender will be there to serve as a capable backup — a feeling that wasn't there earlier in the season. To have a capable backup in net as the team enters the playoffs is a tremendous asset. Khudobin has come on strong down the stretch

Indeed, the entire team is peaking at just the right time. Over the course of a long 82game regular season, it isn't so much how a team plays early on, but how it is playing as the playoffs approach.

And right now the Bruins are playing their best hockey of the year at just the right time. They are peaking at the most appropriate time. A host on one of the local sports talk radio shows made the point that nothing ignites the Boston area in the spring like Boston Bruins playoff hockey.

To be sure, Celtics fans are also passionate — but in a more urbane and understated way. Bruins followers are more emotional, more wear-it onyour-sleeves passionate.

It was the Bruins that lifted the city in the aftermath of the Marathon tragedy; it was the Bruins that played into late June before bowing out in the 2013 Stanley Cup Final against Chicago at the Garden.

It is the Bruins that are an NHL Original Six team, with all the heritage that means to the sport of hockey. Yet another Bruins team goes forth into the playoffs, better primed and more ready than they would have been a few short months

Veteran University of Wisconsin coach Bob ("Badger Bob") Johnson coined the phrase "It's a great day for hockey." We'll see how many of those great days the Bruins will participate in this spring. Based upon how they are playing of late, the possibilities are bright indeed.
