North End Residents Oppose Cross Street Hotel

The North End community and its residents have mounted stiff opposition to a boutique luxury hotel planned for the property on the Greenway-end of Salem Street. Since this project was first proposed, residents have been saying that it is out of character with the neighborhood and many of their complaints are focused on its disruptive impact on the quality of life.

Community stakeholders have organized a signature drive and have voiced opposition and it doesn't appear that neighbors plan to go away, as they continue their message of "enough is enough'

With this site being at the gateway to the neighborhood, community reaction has been



universal that North End residents DO NOT WANT A HOTEL LOCATED THERE.

Comments by business owner Dr. Paul M. Cangiano of Vision North:

"The North End needs every parking space it can get its hands on. This proposed project is going to take public temporary/North End overnight parking spaces for its own benefit. I have patients that use these spots daily to run into my office for a quick check up or to pick up items. By taking these spots away it is unfair to the residents, visitors, and the North End businesses."

"An increase in traffic flow in this area that is already congested will create a bottle neck of traffic. Hotel clients being dropped off or doubleparked will only make things worse. I already have patients calling even during COVID traffic conditions stuck in traffic in this area. Not to mention how the effects of a Bruins/Celtics game will have on this intersection. The Hotel's proposed design adds no benefit to the North End community or the businesses. It should not be allowed any relief of any existing zoning codes. It could be built without zoning waivers but would not comply with the builders finance goals at the community's expense."

North End Parking Alternatives **During Outdoor Dining Season**

The City of Boston has addressed North End resident parking concerns by offering alternatives in partnership with the TD Garden, Government Center Garage, HayMarket Garage at Parcel 7, and the Sargent's Wharf **Lot**. North End residents who meet the offer requirements will be eligible for a parking space at one of these parking garages. Residents who applied last year **MUST** reapply.

Space is limited and parking spots be offered on a first come first served basis. Once a resident is assigned a parking spot they must use that spot for the duration of the offer. No exchanging of spots is allowed. Please see below for parking spot availability, eligibility requirements, and instructions on how to apply.

PARKING SPOT AVAILABILITY:

HayMarket at Parcel 7 is offering free 24/7 parking.

The Government Center Garage is offering free parking spots available nights from 4:00 p.m. - 9:00 a.m. and 24/7 on weekends.

The **TD Garden** is offering free 24/7 parking. This offer is not guaranteed for the full length of the outdoor dining program.

Sargent's Wharf Lot is offering parking spots at \$300/month available 24/7.

ELIGIBILITY REQUIREMENT:

All applicants must have a valid residential parking permit for the North End neighborhood. **INSTRUCTIONS:**

Applicants will need to supply the following information to complete the form:

Name, Email, Phone Number, Resident Parking Number and License Plate Number

Applicants will also be asked to select their parking garage preference by ranking the options available. Preferences are not guaranteed.

Applicants will be contacted within 48 hours with an approval or denial.

Approved applicants will be sent a follow-up email and must complete the instructions to finalize the application process.



THE BASILICAN CONNECTION

The development of the ancient Roman Basilica was described in the last issue. The connection between this structure and the Basilicastyle Christian Church goes back to the year 312 A.D. This is when Constantine marched at the head of a powerful army towards Rome and defeated Maxentius in three battles. During this time, Constantine made open and public declarations in favor of Christianity; consequently, considerable numbers of Christians flocked to his standard, swelled the ranks of his army, and gained his full confidence by their orderly and faithful conduct.

A contemporary writer named Caecilius tells us that during the night preceding the third battle, Constantine was advised in a dream to inscribe the shields of his soldiers with the "celestial sign of God," the sacred monogram of the name of Christ. He followed this command and his obedience was rewarded by a decisive victory at the Milvian Bridge.

According to a different source, however, Constantine is reported to have seen this sacred monogram high in the noonday sky with the words clearly inscribed in Greek: "By this sign you will conquer." This appearance clearly astonished Constantine and his entire

army. The Savior then appeared displaying the same celestial sign of the cross, directing Constantine to use this symbol on this standard and to advance with the assurance of victory.

This celestial sign is, of course, the two initial letters X and P from "Xpiozos," the Greek name for Christ, and it is what we now call "The Labarum." The decisive victory at the Milvian Bridge secured Constantine's supremacy as emperor of the Roman nation. He was eventually moved to stop all persecutions and to adopt Christianity as the religion of the empire. The Christians were then permitted to occupy some of the pagan temples, baths, and basilicas for the practice of their religion. In time, they settled on the basilicas as the structure having the interior design, which most closely suited their needs.

Although it was unknown to the builders of ancient Rome, their basilica was destined to become a very important style of structure, and a direct link between pagan Rome and Christian Rome.

Massachusetts Registry of Motor Vehicles Implementing Grace Period For Certain Expired Inspection Stickers

Law Enforcement Aware of These Instances of Expired Stickers
Due yo Applus' Vendor Outage

Vehicle Owners with Expired March 2021 Stickers Should Plan To Obtain Inspection by End of April; Additional Time Requested For Newly Purchased or Registered Vehicles

Additional Time Will Be Granted for Failed Motor Vehicle Inspection and Retests

Due to the nationwide system outage of motor vehicle inspection services by its vendor Applus Technologies (Applus) impacting inspection stations and motor vehicle owners, the Massachusetts Registry of Motor Vehicles (RMV) is allowing a grace period for specific motor vehicle inspection requirements outlined below. The RMV is working in close partnership with the Executive Office of Public Safety and Security (EOPSS), the Massachusetts Chiefs of Police Association (MCOPA), the Massachusetts State Police (MSP) and other stakeholders to mitigate the impacts of the outage.

The RMV continues to urge Applus to safely and swiftly restore services and provide additional information on the extent of the outage's impact, which began on Tuesday, March 30. The three-phase process required to return the MA Vehicle Check program to full service that is secure and safe has been in progress. These phases are 1) Remediation (completed), 2) Restoration and System Testing (current phase), and 3) Go-Live and Post- Go-Live Support. The restoration phase, which is the current phase, involves a deliberate and methodical resetting of Applus Technologies' IT environment and will take some time to restore the safety and emissions stations to testing capabilities fully. Based on recent conversations, inspections will not be performed today, Tuesday, April 6th, Wednesday, April 7th, Thursday, April 8th, or Friday, April 9th.

"The RMV shares the frustrations and disappointment with the tremendous inconvenience Applus's outage is causing and recognizes the significant impacts on customers and business owners across the Commonwealth,' said Acting Registrar of Motor Vehicles Colleen Ogilvie. "The RMV remains committed to its efforts to ensure Applus makes Massachusetts a priority in quickly and safely returning the inspection program to operation."

The RMV is allowing a grace period for certain expired motor vehicle inspections. The RMV has advised law enforcement that compliance with the safety/emissions inspection requirement has not been possible since March 30th, in light of the outage caused by the malware attack against Applus.

• Motor vehicles with expired inspection stickers from March 2021 ("3" sticker on windshield)

should be granted until April 30, 2021, to obtain an inspection.

• Vehicles newly purchased or registered on or after Tuesday, March 23, 2021, should be granted until April 30, 2021, to obtain an inspection. Newly purchased vehicles must typically be inspected within seven (7) days of registration.

• Customers who recently had an inspection rejection and are in the 60-day free retest window will be afforded one extra day for each day Applus's system remains unavailable but should plan to facilitate their inspection as soon as possible once the system is restored and stations are online.

The RMV is taking these and other steps to mitigate the impacts of Applus's outage. Additionally, the RMV, in partnership with the Department of Environmental Protection, has formally notified Applus that it is in breach of its contract and is exploring all possible remedial measures pursuant to the terms of the contract as Applus works to restore service as expediently as possible.

You can donate money to Ermada's osteoporosis foundation which will soon be set up. Due to the Covid-19, funeral services and burial will be private.



L'Anno Bello: A Year in Italian Folklore

April Showers Bring a Great Month

Obviously, advice on gatherings and reunions contained within are not applicable to this current time when social distancing (and mask wearing!) is the best practice. Please read these articles as a testament to the joy and love that imbues Italian celebrations — and as suggestions for ways to spend time in the future once this pandemic is finally over.



Easter Sunday has passed, but there is still a whole month of spring and sunshine to enjoy in April. April smells like fresh flowers and the pungent scent of trees after a delicate rainfall, like balmy breezes and juicy strawberries. Soft rains drizzle down outside my window, making the grass seem lush and greener than a mint sprig, the pavement shiny and smooth like obsidian. I am reminded of the old rhyme I cheerfully intoned as a young girl: "April showers bring May flowers!" Indeed, April is the time of the year when spring finally feels in full bloom, when flowers, rain and abundant sunshine meld together to form an energetic, playful month. The origin of April's name also reflects its qualities of rejuvenation and rebirth. April derives from the Latin word aperire, which means "to open." Truly, all of nature is opening and awakening at this point, from the purple tulips peeking out of the dirt to the buds on tree branches and the baby animals walking on wobbly legs. As the Latin origin of the name suggests, April is a significant month in Italy. Not only is it a full month of spring and the frequent home of Easter, but April brims with its own folk traditions, holidays and customs particular to Italy. Italians even start the month in a jovial fashion, surreptitiously pinning paper fishes to each other's backs during pesce d'aprile, or April Fools' Day. The following is a sampling of quirky and culturally rich practices that characterize April in Italy:

• April Proverbs: Italian folklore abounds with multiple

proverbs related to months and times of the year. These hearken back to the days when Italian society was primarily based on agriculture. Farmers needed to pay special heed to the weather in order to determine important and vital times like when to plant and what crop yields to expect. As such, most of the Italian proverbs related to April (which I gathered from the wonderful website italyrevisited.org) concern themselves with the weather of the month. One proverb declares: "L'aprile piovoso, fa il maggio grazioso." Translating to "a rainy April makes a grateful May," this is the Italian version of the April showers bring May flowers dictum. Another proverb says "Marzo tinge, aprile dipinge" – meaning that what March dirties, April cleans up; just as April rains and vegetation takes over the muddy or snowy changeable weather of March. However, another proverb admonishes "Aprile, non ti scoprire." It warns against discarding your coat during April, as there are still cool days left!

• Rome's Birthday (April 21st) and St. Mark's Day (April 25th): Italy is filled with many cityspecific holidays, and two of the most intriguing fall during April. Rome's Birthday honors the founding of the city, all the way back in 753 B.C. Romans celebrate with festivals, parades, concerts, and fireworks displays throughout la cittá eterna (the eternal city). Four days later, the charming maritime city of Venice displays similar gaiety for St. Mark's Day, or la Festa di San Marco, the feast day of Venice's patron saint. Carnivals,

markets and parties center around the enormous St. Mark's Square, the beating heart of the city. Celebrate both holidays by enjoying food from each region. How about a plate of *spaghetti alla carbonara* (spaghetti with egg sauce) on Rome's Birthday and some *risi e bisi*, or risotto with peas, on St. Mark's Day?

• Liberation Day (April 25th): This patriotic holiday honors the liberation of Italy from Nazi and fascist occupation during World War II. On April 25th of 1945, the cities of Turin and Milan were the first to be freed from the occupation, and their liberation prompted a chain of events which culminated in Italy's freedom. Italy celebrates Liberation Day, or Festa della Liberazione, with processions, speeches and countrywide events. My ancestors, including my grandparents, still lived in Italy during the Second World War and had to deal with all the horrors that accompany an armed conflict, from bombings to mob violence to food shortages. As such, I always feel compelled to remind people of this springtime feast, a holiday commemorating the ordinary Italians who fought so hard to free their beautiful land from the terror of fascism

• May Day Eve (April 30th): I love this holiday! Since ancient times, European folklore has attributed the first day of May with magical properties. People believed that elves, fairies and witches were especially active on this day. In Italy, May Day is known as Calendimaggio, and celebrations begin the night before, on the last evening of April. Cities hold festivals and events with a spooky twist, replete with witch decorations and magical themes. Honor this day by taking a walk during dusk and contemplating the wonder and mystery still left in the world.

• Sagre: In conclusion, I would like to point out that towns and cities all over Italy hold sagre, or food festivals, throughout the year. They focus on seasonal, local ingredients and the various way to highlight them in delicious dishes. Most Italian sagre focus on the country's premiere spring vegetable, the artichoke, or carciofo. I absolutely love artichokes and look forward to them every spring. Enjoy artichokes the way Italians do - stuffed in pastas like ravioli or tortellini, fried, or simply marinated in olive oil. Yum!

So there you go — wonderful ways to celebrate Italian heritage throughout April. When spring is in the air, everyone is in the mood for festivity, and Italy is no different! Whichever holidays and customs you choose to honor, make sure you feast with joy in your heart and optimism for the bounty of spring



Saint Laura Montoya

María Laura de Jesús Montoya Upegui was born on May 26, 1874 in Jericó, Columbia the second of three children to Juan de la Cruz Montoya and Dolores Upegui. During the Colombian Civil War of 1876, her father was killed and her family became impoverished, as a result, Laura was sent to live with her maternal grandmother.

In 1881, Laura was sent to an orphanage due to the precarious economic condition of her grandmother. The orphanage was managed by her maternal aunt Sister María de Jesús Upegui. In 1890,



her aunt enrolled Laura at "Normale de Institutoras" of Medellín to receive training to become a schoolteacher as a means of having an income to support the financial difficulties her mother faced. She was educated at the Escuela de Espíritu Santo in Amalfi and then in Medellin. In 1886, she went to live on a farm to care for an ill aunt and it was there that her desire to become a religious began.

Laura graduated as a teacher in 1893 and was sent to teach the indigenous peoples of Colombia where she eventually began working as a missionary teaching them the Catholic faith as well. Many Colombians viewed indigenous peoples as less than human, but Laura knew this was not the case.

By the time she reached her early 20s Laura very much wanted to become a cloistered Carmelite nun, but her experience as a missionary left her with a desire to spread the Gospel to others, particularly people who were discriminated against such as the native groups she had worked with. In 1914, she founded the Congregation of Missionary Sisters of Immaculate Mary and Saint Catherine of Siena. Laura left the city of Medellin, where she had lived, and traveled to the jungles by mule to live among the native people who were the poorest and most discriminated against in society

Although the bishop supported her work, many other Christians felt the effort was wasted. Laura ignored the criticism. Her spiritual writings were aimed at her nuns, helping them better to understand their call to serve God among the native peoples of South America.

Mother Laura, as she was known by her sisters, spent the last nine years of her life in a wheelchair in great pain. She died October 21, 1949, in Medellin.

Mother Laura was Canonized on May 12, 2013, Saint Peter's Square by Pope Francis. At her canonization ceremony, Pope Francis praised Saint Laura for "instilling hope" in the indigenous people of her nation and for teaching in a way that respected their culture. She was Colombia's first saint and the patron saint of orphans and people who suffer from racial discrimination. Today, the sisters of her order work in 21 countries in the Americas, Africa, and Europe.

Introducing a Memoir by Dom DiLeo, Childhood Resident of the North End, Entitled:

Once a Northender, Reflections from Boston 1930-2020


Once a Northender is a lovingly told memoir, written by Dom DiLeo, as he looks back on his life from the perspective of a first generation Italian-American in the 20th Century. The book begins with the birth of Dom's father in Sicily in 1887 soon after Italian unification, and swiftly brings us to his periodically traveling back and forth to America as a young man to work in the orange groves and build railroads in Florida in the 1910s. Like so many other Italian immigrants at the time, Dom's father and his young bride ultimately left Italy for good and settled in Boston's North End soon after World War I. With wit, humor, and fondness, Dom's story takes us back in time to the tenements, streets, shops, schools, playgrounds and characters of the North End where he spent his childhood in the 1930s and 40s along with seven brothers and sisters, many cousins, and other first generation and immigrant Italians just like him.

The 290-page writing spans Dom's life and is replete with delightfully warm, detailed anecdotes reminiscing about his childhood, his growing up during World War II, his colorful family, and his own

small brushes with fate, fortune, and fame. As a young adult, the book continues to take us further down the path of Dom's life. In engaging and conversational style, we get glimpses into Dom's military service and time spent in the US and Post-War Europe in the 1950s. We learn about Dom's education not only in the North End but onward to public school in Medford, MA as well as college and law school at Boston University, to the great pride of his immigrant parents. Dom's story includes some challenges he has faced personally and professionally, while ultimately looking back as having learned from his experiences and being the better for them. Last, Dom

also recounts "the greatest time of my life," starting with a love story leading to a marriage lasting 55 years and counting, through to raising kids and having grandchildren of his own. Dom's stories are charmingly real and funny, as he includes advice on making it all work, having fun, and never forgetting to laugh

Once a Northender provides



the reader insight into what life was like for the middle son of Italian immigrants in the Boston area back in the early and mid-1900s up through his life today, told with endearing warmth from the perspective of someone who has seen and experienced decades of change firsthand. It is a humble story of one man's life as a reflection of our own. If not of

ourselves, then perhaps through the lens our parents or grandparents who came to this country looking for something better than what they left behind. Ultimately, Once a Northender can be viewed not just as one person's story, but as a living testament to the larger, collective immigrants' story, still continuing on the path to finding something better while enjoying what you have each day on the road to getting there.

As one reviewer praised, "Dom's book is both a personal memoir and an important record of the past. In telling us his life story, Dom is also telling us something important about the Italian American experience, about the

North End as an immigrant neighborhood, and about our shared American nation. Dom writes with an easy and friendly style, with wit, humor, and compassion. It is a book from the heart." James S. Pasto.


An ecdotally, Once a Northender is also a love letter to my Dad from me. The idea began as a Father's Day present – a gifted chance to write down

my now 88-year old father's colorful and vibrant stories to pass along to his children and grandchildren. For all the sadness and isolation COVID-19 brought the world and our corner of it, our suspended lives enabled Once a Northender to emerge. To make endless days of nothing-to-do seem a bit more tolerable during last year's lockdown, my Dad and I met each evening for many months to put his stories onto pages. Not only did I learn about his history, I learned a lot about him. Partnering together to turn memories into chapters, and chapters into a novel, I believe he learned a bit about me in return. Looking back on our time together, I think it's safe to say Once a Northender brought us both some happiness, joy, and fresh perspective in an otherwise isolating and melancholy year happening around us.

We hope *Once a Northender* brings its readers a bit of that happiness, joy, and perspective as well

Director Nuria Giménez discovered some home movies made by her grandparent's midway through the last century. Based on that rich material, which shows the couple — she, of similar elegance to Ingrid Bergman; he, as burly as a circus strongman — traveling around the world. Giménez planned a sophisticated and fascinating film structure; created a diary recounting specific moments of her existence, her worries and her innermost thoughts. The result is this experimental feature, My Mexican Bretzel, using silent home movies, fleeting snippets of sound, and diaristic narration to tell the story of Vivian Barrett, a wealthy Swiss woman, and her husband, Léon, a WWII pilot-turned entrepreneur. A partial hearing loss doesn't impede Léon from creating a pharmaceutical wonder drug that changes their lives, propelling the go-lucky couple into a world of adventure, romance, and mystical truth seeking. From the '40s through '60s, from the Alps to Le Mans to Manhattan to Hawaii, vulnerability, belonging, truth and mid-century opulence are explored in a way that only the magic of cinema allows ... with a dazzling twist.

HONOR KILLING (Blu-ray) Troma Films

When a young woman is brutally attached, she seeks the aid of her own flesh and blood, but she is further betrayed when her own family decides the only honorable thing to do is to kill her. But you can't keep a good woman down. After surviving the botched execution, she becomes driven by one thing, revenge. She hires, and is trained by a shady, rugged bounty hunter named Viktor, in the many ways to inflict pain. The woman takes her new skills on the road in search of the man who pulled the trigger, her father. Taking a knife, bullet and fist to every male obstacle along the way, she leaves a trail of savage men along her journey.

WATERBOYS (DVD) Corinth Films

Waterboys tells a humorous and moving story of the evolving relationship between crime

novelist Victor and his celloplaying son Zack. When his girlfriend dumps Zack, and Zack's mother dumps Victor on the same day, the two men grieve and briefly console one anther before heading off on a trip to Scotland where Victor hopes to promote his latest book and spend some time booking with Zack. Victor's selfish tendencies nearly alienate the fragile relationship he shares with his son, and the trip becomes increasingly turbulent as the reasons for the pair's domestic troubles come to light.

In this passionate film titled Entre Nos, Mariana is determined to keep her family together. Her children, Gabriel, 10, and Andrea, 6 grew up in Colombia without their father, who immigrated to the U.S. years earlier to make a better life for his family. Finally, after years of separation, the family is reunited in New York City. However, Antonio announces he has found work in Miami, and will be moving there alone, and will send for the family when he is settled. Much time passes and Mariana doesn't hear from him. Worried and desperate, she finds out from her only friend that her husband will not be coming back. Alone, with fifty dollars to her name, in a strange city, where she can barely speak the language, Mariana must find a way to provide for her family, not only financially as she faces eviction and homelessness, but also emotionally. After all her options run out, Mariana turns to the city's trash collecting cans in order to put food on the table. With Gabriel and Andrea working beside her, the family finds the most stability they have known since their arrival, and it is during these challenging moments that the family triumphs.

WOMEN WITHOUT MEN (DVD) IndiePix Films

Women Without Men chronicles the intertwining lives of four Iranian women during the summer of the upheaval of the 1953 coup d'état. The 1953 Iranian Islamic revolution, a cataclysmic moment in history, when an American-led, British-backed mission led to the overthrow of Prime Minister, Mohammad Mossadegh, and reinstalled the Shah to power. Over the course of several days, four disparate women in the Middle East from Iranian culture are brought together against the backdrop of political and social chaos. As the political turmoil swells in the streets of Tehran, each woman seeks to be liberated from her predicament. It is only a matter of time before the world outside the walls of unrest seep into the lives of these four women as their country's history takes a tragic turn. A Nostalgic Remembrance



It's baseball season again and I am a forever Red Sox fan. As you may know, I am still in Florida, but don't hold that against me. My cable package includes NESN and several other sports stations. The importance of this information is that I have seen most of the Sox pre-season games, with Alex Cora back at the helm.

Babbononno was never interested in sports. According to him, when he was a kid in Italy, soccer was a relatively new sport (1863, I think) but he claimed he was too small to play, and besides, he loved music. His youngest son, Uncle Gino, played both football and baseball for East Boston High School. His other sons, Uncles Paul and Nick (my Godfather) followed in their father's footsteps and concentrated on music. But for Dad, it was another story.

My father loved football first and in second place was baseball. He tried to interest me in football at a young age, but I was ambivalent and concentrated on my first love, baseball. Baseball to me was centered on the Boston Red Sox. The Braves didn't matter to me and I could have cared less when they moved to Milwaukee in 1953. No REAL Bostonian liked the New York Yankees, but I did enjoy attending Brooklyn Dodgers games when we were in New York and Dad brought me to Ebbets Field. I must admit, I was sad when they moved to Los Angeles in 1957.

As a kid, I played baseball from the time the snow disappeared from the streets of East Boston until the snow fell again in the late fall of the year. There was no Little League that we kids knew of and we put our own teams together and at first played in a back parking lot at East Boston High School and later at the City Yard located a few blocks away. I started out as a center fielder, but as I got older, moved to second base. I guess I was something of a power hitter and usually batted third, which made me happy, because my favorite athlete of all times, Ted Williams, always batted third. My eye for hitting the ball was sharpened as, after dinner, we kids played half ball in front of our houses until it was too dark to see the half ball. In New York, they played stick ball in the streets of the New York boroughs. All you needed was an air filled rubber ball and a broom stick. In Boston, we played half ball. We would chip in to buy a fifteen cent pimple ball, cut it in half and swing at the half being scaled at us as we stood on the sidewalk with a broom stick (cut off from the working end of a broom).

When Dad wasn't playing a wedding on a Saturday afternoon, he would pile a bunch of kids in his '37 Plymouth and bring us to Wood Island Park to practice and play a game. I couldn't get enough of baseball. Due to Dad's love of football, in the fall of the year, I played tag football is the Chapman School yard located across the street from where we lived on Eutaw Street. We kids put up a peach basket on the fire escape of that same school yard and played basketball, but I was short and uncoordinated for that sport. A couple of kids owned hockey sticks and a puck or two, but I had no interest and still don't know the rules of the game.

Well here it is many decades later and I still love baseball. Most of all I love the Boston Red Sox. A few years back I had the best of all worlds. Dean Saluti and Margie Cahn had a home on Bay State Road just in back of Kenmore Square. I had a sticker to park in one of Dean's slots in back of his home and often used it when I headed to Fenway Park. Back then, Dr. Mike Foley ran the first aid station at Fenway and had three reserved seats just to the right of the Sox dugout. I was coaching a Little League team at that point in time and had one of Dr. Mike's sons on my team, and Mike and I became close friends.

When the Yankees were in town, I would park in one of Dean Saluti's spots, walk across Kenmore Square to Fenway Park, tell the ticket taker that I was a guest of Dr. Foley's and head to one of Mike's box seats ... second or third row, just to the right of the Sox dugout if I remember correctly. When Mike was free, he would join me with hot dogs, sodas, and score cards for me and whomever else he invited. A couple of times a Down-Mainer would join us as Mike's guest, the writer, Stephen King. I really enjoyed his company. Just as the games with the Yankees would begin, I would join in the singing of the National Anthem and then say a couple of silent Hail Mary's hoping they would help the Sox beat the New Yorkers.

Each time I walked the ramp that led me to my seat, my memory harkened back to my childhood when Dad brought me to Fenway. There was a particular smell that I remember, a combination of popcorn and newly cut grass. With the COVID virus still with us, I won't get to Fenway even after I come home from Florida, but I intend to follow the Sox on NESN and whichever other station broadcasts their games. Even if I was to head to Fenway Park, I don't have any special advantages. Dean and Margie sold their Bay State Road home and now live in the suburbs. Dr. Mike Foley left Fenway's first aid station when the current

When you hear the word *grissini* or Italian breadsticks, most often what comes to mind are those pencil thin sticks of crisp, dry baked bread you often find wrapped in wax envelopes on the tables of Italian American restaurants. Originating centuries ago in Turin, Italy, *grissini* were traditionally made from flour, water, yeast and butter, lard or olive oil. These plain crunchy sticks have always been extremely popular and today you can find several variations of this recipe. Some are now thicker and softer and even flavored with cheeses and spices. While the plain thin crisp *grissini*are amazingly delicious wrapped in prosciutto and served as an appetizer, the thicker and softer breadsticks are perfect as a dipping stick for all of your soups and sauces!

In my home, homemade bread was served with dinner almost daily. My Nonna made bread in all shapes and sizes, ranging from individual rolls to hard or soft crusted Italian bread and even assorted breadsticks. Her "Garlic Parmesan Breadsticks" were always a favorite of everyone's. They can be made soft and thick, or thin and crispy and they're absolutely perfect to serve as an appetizer, with dinner, or even to enjoy as an afternoon snack!

GARLIC PARMESAN BREADSTICKS Grissini all'aglio e parmigiano



6 cups warm water 4 teaspoons active dry yeast

2 teaspoons sugar 6 cups bread flour

2 cups parmesan, cheese, grated (if desired, grana padano, asiago or pecorino romano can be substituted) 2 teaspoons salt1 teaspoon grated black pepper3 to 4 cloves garlic, pressed

2 tablespoons olive oil ½ cup olive oil, more if needed (for brushing on breadsticks) garlic salt (optional)

Line four baking sheets with parchment paper and set aside. Pour warm water in a medium bowl, add yeast and sugar, set aside about 4 to 5 minutes to activate.

In a large mixing bowl add flour, grated cheese, salt, pepper and pressed garlic, mix together. Add water and yeast mixture, then olive oil, and with your hands mix together and knead until dough comes together. Continue kneading with your hands, or an electric mixer with a dough hook, for about 10 to 15 minutes, until a soft, smooth dough forms.

Grease a large bowl with olive oil, place dough in the bowl and cover with plastic wrap and a dishtowel. Place the covered bowl in a warm dark place and allow dough to rise for about an hour, or until doubled in size.

Remove dough from bowl and place on a lightly floured board. Knead for a few minutes and cut in half. Cut dough into pieces and roll each piece into a long thin or thick pencil shape the length of the width of the baking sheet. (These pieces can be as thick or thin as you want your breadsticks to be. The thinner pieces result in hard and crunchy *grissini*, thicker become soft on the inside and slightly crisp on the outside.) Place breadsticks evenly and spaced apart on the two prepared baking sheets. Brush with olive oil and sprinkle with garlic salt or leave plain, cover with plastic wrap and a dishtowel and allow to rise for about a half hour. Repeat with the remaining half of the dough (This recipe can be cut in half if desired and only two baking sheets will be needed).

Preheat the oven to 375°. Uncover breadsticks, place in oven and bake until golden brown. Remove breadsticks from the oven and allow them to remain on the baking sheet to cool and crisp. Serve immediately.



The Tet Offensive: A Turning Point in the War

Public support for the Vietnam War was always shaky, especially with the rise of hippie culture, but if there was a single pivotal moment in public sentiment it came after the Tet Offensive of early 1968, when the North Vietnam Army launched coordinated attacks on several cities in South Vietnam both to crush the South Vietnamese moral and to convince the United States to start a withdrawal process.

In part, this was due to the shock it stirred. Whatever Robert McNamara and other White House publicists believed privately, they presented a mostly optimistic demeanor when talking about the war effort on camera. By and large the media bought it (or was made to buy it) as a notable shift was evident in how the war was discussed following the attacks.

General Vo Nguyen Giap, commander of the North Vietnamese army, chose January 31st (with approval from Ho Chi Minh) as the day to launch the attack. The People's Army of Vietnam had been responsible for some preparatory attacks on U.S. garrisons along the Cambodian border in the fall of 1967, and about a week before launching the Tet Offensive attacked a U.S. Marine garrison at Khe Sahn.

On January 30th, many South Vietnamese families began gathering in major cities in celebration of the Lunar New Year. The Viet Cong started by attacking 13 cities, and by the following day, they had attacked over 120 sites including U.S. bases. The attacks shocked the Army of the Republic of Vietnam. Sending shockwaves throughout the United States via news broadcast was a brazen assault on the U.S. Embassy in Saigon, which though eventually warded off, saw Viet Cong platoons overwhelming the buildings courtyard.

By far the bloodiest and longest battle occurred in the city of Hue, where the Viet Cong had little trouble taking over the city, and for three weeks terrorized the residents, breaking into their homes arresting, and often murdering civilians sympathetic to the Army of the

Republic of Vietnam or U.S. intervention. Most of these bodies were dumped into mass burials in remote areas by the nearby Perfume River and to this day, many of the lost are still missing.

On February 26th, U.S. and South Vietnamese forces took back the city, but the damage was devastating. About 2,800 civilians had been executed (another 3,000 were unaccounted for) and most of the city's cultural and educational institutions had been destroyed. American military casualties numbered close to 150, while South Vietnamese numbered close to 400.

True, the number of casualties on the Viet Cong side was much higher at almost 5,000. Indeed, Giap had either underestimated the U.S. and South Vietnamese forces when he planned the surprise attack or maybe a physical victory was beside the point. Be that as it may, the Tet Offensive came to a close by early March when the number of casualties sustained by the Viet Cong became too large to sustain battle. Nonetheless, the Tet Offensive met General Giap's objectives. For many Americans who had been skeptical about the Vietnam War, the Tet Offensive became a solidification of their cynicism. For others, who had seen not only a victory in Vietnam, but in the geopolitical games of the Cold War, the Tet Offensive was a crushing blow. President Johnson, no longer able or willing to gloss the war, announced he would no longer escalate the war, limit bombings, and begin peace talks, which would last another five years and bring many more casualties.

Laker Icon Baylor Dead at 86

Growing up in Boston as a basketball fan and loving all those great Boston Celtics championship teams I always loved lots of basketball players around the league, too.

Elgin Baylor, the Lakers 11-time NBA All-Star recently passed away at 86 years old. He and he alone revolutionized basketball from a ground game to an aerial show.

His second career as a general manager for the LA Clippers ran from 1986 until 2008. Baylor was the first NBA player to surpass 70 points in a game with a 71 point game on December 11, 1960 against the Knicks.



RECALLING WHEN DANNY DID DOUBLE DUTY — Time has the effect of acting somewhat like an eraser. Not exactly, of course, but certainly in the way of placement. We often associate people with their most recent accomplishments, relegating to further back in memory the notable actions of prior years that played a role in who they became in contemporary times.

Danny Ainge is the current general manager and president of basketball operations for the Celtics. Many can recall his playing days with the C's, spanning some eight seasons, years that included the NBA Championship teams of 1984 and 1986 plus the ones that made the 1985 and 1987 NBA Finals.

But what many don't remember is that Danny Ainge accumulated a stunning athletic resume in high school and then went on to play two sports while in college — one professional and the other with his college teammates.

Ainge was a stellar athlete at North Eugene High School in Oregon — the only high school athlete ever to be acclaimed an All-American in three sports (football, basketball and baseball) by Parade magazine. In football, he was a versatile performer, proving he could go both ways. During his junior year he made all state as a wide receiver. Then, as a senior, he received the same honor as a member of the defensive unit.

He also led the basketball team to two consecutive state championships, a period during which the team compiled an outstanding 52-1 record. In the state high school playoffs, he actually swished an 85-foot shot, the longest ever made at the University of Oregon's home court. His four-year career statistics included averaging 24.5 points, 8.7 rebounds and 3.6 assists per game. And that was before the debut of the three-point shot.

It was during his college years that Daniel Ray Ainge became a two-sport athlete. Back in 1977, just prior to entering Brigham Young University, he was drafted by the expansion Blue Jays in the Major League Baseball Draft. When he signed with Toronto that meant he could not play college baseball. So, while he played basketball for BYU, he also played professional baseball for four seasons, starting in the late spring and throughout the entire summer.

Ainge stayed and played all four years at BYU, earning the Wooden Award in 1981 as the outstanding collegiate basketball player in the nation. He led the Cougars to the Elite Eight in his senior season, famously going-the entire length of the court and eluding four Irish defenders to beat Notre Dame in the closing seconds of a March Madness game.

When his four years finally ended he walked off the collegiate court for the final time having set nine Western Athletic Conference records, 10 BYU school records plus an NCAA national mark of having scored in double figures in 112 consecutive games.

And there was also baseball, keeping Ainge on the go since he would hit the diamond right after the close of the academic year. Danny was also very proficient in the classroom. A 1981 graduate of BYU with a degree in communications, he was inducted into the Academic All-America Hall of Fame in 2000.

While he played four seasons of professional baseball, he spent only one season exclusively in the major leagues. Over the course of his pro career on the diamond, he played for the Blue Jays as well as their AAA affiliate in Syracuse, N.Y. — often for both teams during the same season. He was mostly an infielder but sometimes saw duty in the outfield as well.

During his combined career with Toronto and the Syracuse Chiefs he hit a total of eight home runs. One of the first he hit was with Syracuse in 1978, a shot that broke the scoreboard on impact. That first year was the only season he played completely at the minor league level, seeing action in 119 games for the Chiefs.

Although his batting average was near .300 in the first couple of months, it tailed off to a season ending .229 with 89 hits in 389 at bats and 30 runs batted in.

The 1979 season would start a pattern that would run for the next two seasons. Alternating between the Blue Jays and the Chiefs in 1979 as a 20-year-old, he would play 87 games with Toronto, bat .237 and hit his only two MLB home runs. The first was a solo shot — his only hit of the game — in a 6-2 road victory over Seattle on June 2. The second also came at Seattle on August 21 (an 8-4 loss). Again, it was his only hit of the game. He also played 27 games for Syracuse where he collected 25 hits in 101 at bats.

Following his junior year at BYU, Ainge once again divided baseball between Syracuse and Toronto. It was a season that was comprised of only 38 games with the Jays as compared to 80 with the Chiefs. His batting average was almost identical with each team, .244 with Syracuse and .243 with Toronto.

The year 1981 would mark the last year that Ainge would play baseball. He would remain exclusively with Toronto, appearing in 86 of the 162 games and ending up with a .187 batting average. His final appearance in a major league uniform came on September 22 in a 13-inning, 3-2 loss to Oakland, a contest in which he saw action as a pinch runner and played shortstop but did not bat.

Overall, his MLB career included 665 at bats across 211 games which led to 146 hits (including 19 doubles, four triples and those two home runs), 128 strikeouts, 57 runs scored, 37 runs batted in plus 12 stolen bases and a .220 batting average. He was 22 years old when he walked off the diamond for the last time.

But the best lay ahead. He joined the Celtics the following season (1981-1982) and played 15 years in the NBA (with Boston, Sacramento, Portland and Phoenix), retiring in 1995. He went on to coach Phoenix for three plus seasons. He was hired by the legendary Red Auerbach on May 9, 2003 to lead the Celtics in an executive capacity. The entire back page of the next day's Boston Herald featured a huge photograph of the two plus the headline "O Danny Boy." He was back in Boston and things haven't been the same since.
