Breakdown of Civil Society Front and Center in Baltimore

As an American, I am appalled by what America is now witnessing down on the streets of Baltimore following the funeral of Freddie Gray, who died in a hospital following his April 19th arrest and transport to the police station for booking. The officers who took him into custody are all on leave while prosecutors hold an investigation into Gray's death.

This past Sunday, following some violence the night before, Baltimore Mayor Stephanie Rawlings-Blake held a press conference at which she stated, "I have instructed (the police) to do everything that they could to make sure that the protesters were able to exercise their right to free speech ... We also gave those who wished to destroy space to do that." I am all for giving folks the right to exercise their free speech rights, but no

way should anyone be given space to loot, burn and attack police officers.

Her words are troubling. She seemed to be giving rioters permission to commit unbridled violence. Now she is saying she said no such thing, but her words were captured by the media, she said what she said. She owns those words. Trying to say the media was twisting her words seems incredulous.

One of the most severely wounded veterans in the nation, Vinnie is the recipient of the Bronze Star and Purple Heart. While serving in Iraq in 2007 with the 82nd Airborne, Vinnie was critically injured by an insurgent's improvised explosive device. After surviving 40 operations and a year long coma Vincent has become

an inspiration for people throughout the nation. All proceeds from Vinnie's Run went to creating a handicapped accessible living space for Vinnie.

Every year Boston's Wounded Vet Run will be dedicated to different disabled veterans. Proceeds raised go towards housing modifications, recreational objects, cars, basic

Stirpe Nostra

MINERVA

Minerva, formerly Menerva, goddess of wisdom, was one of the great Roman divinities. Jupiter, the Roman counterpart to Zeus was first, his wife Juno was second, and Minerva who was identified with Athena, was third.

Demaratus was wealthy citizen of Corinth who, with his family, migrated to Italy and settled in Tarquinii about 658 B.C. His son Lucumo eventually became a king of early Rome and took the name Tarquinius Priscus. This was the Tarquin who united Jupiter, Juno, and Minerva, into one common temple. It was also the reason why these three divinities were usually toasted as one whenever food or drink was sacrificed to

All of the attributes of Athena were gradually transferred to Minerva, however, because she was a maiden goddess, the Romans sacrificed to her only calves that had never borne the wooden frame that we call the yoke. Minerva was worshipped as patroness of all the arts and trades. During her annual festival she was called upon for help by all persons who desired to distinguish themselves in art or craft. As a special patroness of women, she conferred upon them skill in spinning, weaving and sewing, while at the same time she guided men in the dangers of war, endowing

them with cunning, prudence, courage, and perseverance. Because of this attribute, she was often represented wearing armor, and the spoils of war were frequently dedicated to her. She was credited with being the inventor of musical instruments, especially the wind variety which were so often used in religious

The annual festival honoring this goddess lasted from March 19th to the 23rd. It was called Quinquatrus because it began on the fifth day after the Ides (15th) of March. The festival was celebrated by artisans, poets, artists, and all other persons who were considered to be under the protection of Minerva. The first day of festivities honored the anniversary of the founding of her temple

while the following days featured gladiatorial contests, musical presentations, social gatherings in private homes, and masked processions. Roman teachers and their pupils treated this festival time as today's colleges treat their mid-year vacation. They began a new course of study when classes resumed. This is also the time when teachers received their yearly stipend from parents of students. A bit of interesting trivia—persons who taught arithmetic, accounting or bookkeeping in old Rome were called calculators.

May Day

which has little significance in America, but is widely observed in other nations.

For those Americans who have heard of May Day, probably the first thing that comes to mind is the celebrations in Great Britain. Dancing around the May Pole, crowning of the Queen of the May, Morris Dancers, and so forth. During the period of Puritan repression of the people of England (1649-1660) May Day was outlawed, which explains why here in New England, founded by Puritans, the May Day traditions never took hold. But even in the rest of America, May Day is not widely observed. May Day traditions are observed in various ways in several other European nations. The origins are unclear and may even trace all the way back to the ancient Roman festival of Floralia, which was celebrated on the fourth day before the Calends of May (April 28th in our calendar).

May Day is also, in many nations, Labour Day (or Workers Day, or some other name of the same effect). The connection of May 1st and honoring working men and women goes back to 1889, when some socialists named it International Workers Day. The Catholic Church celebrates Saint Joseph the Worker, as an optional memorial, on May 1st.

Here in America, where we don't have much use for socialist ideas, we celebrate our Labor Day on the first Monday in September. Actually, we capitalists had our Labor Day before the socialists. The first Labor Day celebration in the U.S. was on

Today is May Day, May 1st, Tuesday, September 5, 1882, in New York. The following year it was repeated on September 5th, which was a Monday. Fairly quickly the first Monday in September came to be designated as Labor Day, first by a few States, and then more, so that by 1894 Labor Day was a public holiday in 23 of the 44 States. (Civics quiz, which States were admitted to the Union after 1894? Answer at the bottom of this column.) In 1894 Labor Day, on the first Monday in September, was designated a federal holiday.

> So, why is it that in the movies, when a plane or ship is in extreme distress, someone gets on the radio and cries, "Mayday, mayday, mayday?" Well, in 1923, a senior radio officer. Frederick Stanley Mockford, in Croydon Airport in London, England was asked to think of one word that would be easy to understand for all pilots and ground staff in the event of an emergency. He came up with Mayday from the French m'aidez ("help me!") In 1927, the International Radiotelegraph Convention of Washington adopted the voice call Mayday and defined it as corresponding to the French pronunciation of the expression "m'aidez." Nicholas was a member of a Special Forces group in Afghanistan when he was ambushed. Nick lost a leg due to the attack and still serves in the Army. He is the recipient of the Silver Star, Bronze Star, and three Purple Hearts.



Army SSG Travis Mills: Maine Wounded in Afghanistan

Travis was with the 82^{nd} Airborne when he was critically injured on his third tour of duty in Afghanistan by an IED (improvised explosive device) while on patrol, losing portions of both legs and both arms. He is one of only five quadruple amputees from the wars in Iraq and Afghanistan to survive his injuries.



Army SSG Brendan Ferreira: Seekonk, MA Wounded in Afghanistan

Brendan fell victim to a suicide bomber while deployed to Afghanistan. Ferreira suffered the amputation of his left arm, serious sight impairment in both eyes, 100 percent hearing

loss in one ear and 50 percent loss in the other, multiple broken bones in his face, legs and torso, and severe lacerations and burns on his entire body.



Army SSG Michael Downing: Middleboro, MA Wounded in Afghanistan

Michael was on his second deployment when he was left a double amputee after an IED explosion in Afghanistan in September 2008. He has had a long road to recovery. SSG Downing enjoys spending time with his wife Dawnalee and their four children. Before his injuries he played golf and hockey and was a softball coach for his daughter's team.

L'Anno Bello: A Year in Italian Folklore

Merry, Marvelous May

When trees bloom, they Italy also retains a strong bloom all at once. It seems that just a few weeks ago, the branches were bare, with only the smallest hint of a bud peeking through. While these were delicate and exciting signs of the spring to come, the season now bursts with the green of the first-forming leaves. As I see an increasing number of branches blossom with new leaves or ethereal pink flowers, I cannot help but shiver with excitement at the glory of nature. From the warm breezes that waft over a perfectly blue sky to the abundant berries that line shop shelves with their gem-like colors, the beauty of spring envelops the world. Indeed, spring seems to ready the world for celebrations and outdoor festivities in which to enjoy nature. For this reason, people have, since ancient times, honored a seasonal feast that revels in the growth and the fertility of nature as spring crosses over into summer. Known as May Day, this folkloric holiday pays tribute to the trees, flowers and mysterious rites of nature that characterize spring. In recent years, May Day has been adapted to a feast honoring the contributions of workers worldwide. However celebrated, May Day is a holiday that calls our attention the magic and rebirth that blossoms around us during this time.

May Day, as the name may suggest, occurs every year on May 1st. For the ancient Celts, May Day was a holiday known as Beltane. Beltane marked the beginning of summer and the time when livestock could be moved to wider pastures to graze. In most European cultures, May Day celebrations start the evening before, on April 30th — a holiday called Walpurgis Night, in honor of a mythical Saint Walpurga. Since May Day functions as a transitional period, standing on the cusp between spring and summer, people believed that witches, fairies and a plethora of other supernatural beings wanluminal evening. Modern

connection between May and the paranormal. The ancient Romans devoted the month of May to the worship of the dead, perhaps fueling the old superstition that it is unlucky to get married in May. Europeans now celebrate the legends of the woodland sprites that are particularly active during May, and indeed, May Day festivities honor the bounty of the spring forest. People decorate their homes with greenery and dance around May Poles bedecked with garlands and ribbons, a ritual which supposedly grants fertility to crops. Many Italian cities brim with quaint traditions on May Day, or Calendimaggio. In the small medieval city of Assisi, festivities take the form of a Renaissance fair, as costumed people enjoy parades, dances and concerts. The residents of Nogaredo, in the northern region of Trentino, dress up as witches for their Calendimaggio celebrations and decorate the city with a supernatural aura. Magic is definitely in the air during May Day, as what greater magic is there than the rebirth of nature during spring?

In addition to folksy nature celebrations, May Day also serves as Labor Day in many countries. In Italy, May 1st is a public holiday called la Festa del Lavoro, part of International Workers' Day. Italians both honor the contributions of workers throughout the country on this holiday, while also enjoying a day of rest. Families may flock to the beach or mountains and hold outdoor picnics — similar to the nature festivities of the ancient May Day — or visit famous Italian sites. Others focus on parades that commemorate the achievements of the Italian labor movement, or call for an end to workplace injustices that persist to this day. Italians quickly became active in the labor campaigns that swept the country in the early twentieth century, as they formed unions, participated in strikes, and raised the call for shorter work days, compensation for injured workers, and an end to child labor. We have Italians and other immigrant groups to thank for the safety laws and job regulation advancements made in the workforce since that time. However, la Festa del Lavoro also reminds us to continue our ancestors' battles. In the United States and in the world at large, many labor injustices still exist, from slavery to child workers to a lack of safety factories and mines. Just as nature blooms anew during the spring, so should our consciences bloom, and bring attention to the issues affecting our fellow humans.

May Day is also about reveling in the beauty of nature, in all of its myriad forms and faces. The regrowth of Mother Earth manifests itself in the rites of May Poles and greenery and the decoration of homes with boughs and flowers, a practice the ancient Europeans called "bringing in the May." The mystery of our world, the appreciation for that which we cannot see, shines through May Day's emphasis on woodland spirits and witches and fairies. Finally, the basis of human nature, which should always include kindness and compassion, is evident in the respect for the dignity of others proclaimed in labor commemorations. This month, let us work on adopting all of these facets into our own personality. Let us make our soul regrow from despair much like the leaves bursting from the trees. Benvenuti! This week's recipe would be a perfect pairing with last week's recipe savoiardi. The recipe for this glorious Italian dolce al cucchiaio (spoon dessert), is believed to have been created in the 16th century by Italian Renaissance Chef Bartolomeo Scappi. Its name is said to come from Saint Pasquale Bayon because in Piedmontese dialect, San Pasqual Bayon runs together into one word: "Sanbajun," which with a little imagination sounds like "zabagliun." This Saint's feast day is celebrated every year in Turin on May 7th and in 1722 this Saint was chosen to be the Patron Saint of the "Associazione Cuochi di Case e Famiglie" (Association of Home and Family Cooks).

Zabaione

12 egg yolks 1/2 cup sugar 1 pinch of cinnamon

3/4 cup Marsala Small glass of rum

Preparation: in a small pot, whisk the egg yolks and sugar until the mixture is almost white. Dissolve the cinnamon in the Marsala and add the rum. Gradually pour the Marsala into the pot with the custard whisking continuously. Place the pot over a bigger pot with some boiling water in it (in a Bain Marie) and carefully, whisk the custard over a low heat until smooth and frothy. Remove from the heat and pour into dessert bowls. Serve warm or cold. Buon appetito!

Nanna & Babbononno

A Nostalgic Remembrance



I couldn't believe it, I drove north on Meridian Street in East Boston the other day and looked at what used to be the Seville Theater. It was a hole in the ground and my chin dropped. This was the premier theater in Eastie when I was a kid and I worked there for 10 years from 1952 through 1962. As a kid, Mom occasionally would bring me to a matinee if I didn't have school or if it got over early. Being a neighborhood theater, they would have a double feature every day. The opener would be a B-level film and the feature, a first run that just left downtown Boston.

There were several other theaters in East Boston during the first half of the 20th Century: The Central, which was part of the company that owned the Seville, The Gem that offered dishes or silverware to the patrons during the week to stay alive and The Orient Heights, which I remember, but never entered. The only thing I remember about the Orient Heights Theater was seeing two teenagers hanging out in front, former singer, Bobby Vincent and the late Tony Conigliaro. I understand there were other theaters in the '20s and '30s, but they were gone by the time I was knowledgeable about East Boston's types of entertainment.

Dad once told me that he went to work for a steel company just after graduating East Boston High School in the late '20s. He had been a machine shop major and accepted a job with the company that put up the super structure for the Seville.

When it was completed, it would be part of a neighborhood concept of theaters owned by the New England Corporation, Theater NETOCO. These neighborhood theaters were on a theme basis. As an example, the Seville was named after Seville, Spain, the English of Sevilla, equivalent Espana. The interior motif the side. She and I stared at was that of southern Spain each other in shock not during the reign of the Moors. The ceiling was medium blue with blinking lights that represented stars. A cloud machine gave the ceiling the look of a night in the tropics.

As I said, there were several other theaters in the sections of Boston with geographic motifs, the Egyptian in Brighton and the Oriental in Mattapan. The former resembled Egypt during the days of the Pharaohs and the later, the Oriental, a part of China during the forbidden years.

Babbononno preferred the Central, the other NETOCO theater in East Boston. It often showed Italian films, and as a child I often accompanied him. Mom and Nanna liked the Seville as it featured a first run film that of service extended to the

had just left the downtown theaters, and for half the intown price, you got a co-feature, a news reel and maybe a cartoon or a Three Stooges short.

Around 1951, a couple of my neighborhood friends who were a few years older, became ushers at both the Central and Seville. At about the same time, the parent company NETOCO was sold to the American Theater Corporation, and at the age of 13, lying about my age, I accepted a job at the Seville. I told the management I was 16 and used my neighborhood friends as references. I looked older than I was and thought I had them fooled. When I brought my uniform home, Babbononno made me bring it to his friend, Billy the Tailor for correct sizing so it would look like a custom fit. At the theater, I was the kid, answering to the Manager Jim Ray, Assistant Manager Jim Wall, the Head Usher Al Yanelli, Stage Manager Dave Turner, and whoever else seemed over me. That meant everybody.

After my first year, Mr. Wall left as there was no need for an assistant manager. The head usher fired me at least once per month, but was stopped by Mr. Ray. After coming up with excuses for three years for not having my working papers, at sixteen, I finally obtained them and pleased Mr. Ray. Years later, I would find out that he knew my age all along, but let things slide. I would also find out years later that he considered me the son he never had, but that's a story for another day.

On a given evening, Dave Turner, the stage manager, told me and a candy girl that Mr. Ray wanted us in his office without delay. After Theresa Guelli and I entered, Mr. Ray shut the door, glared at us and told us that he had caught the ushers and candy girls stealing from the cash box and stealing candy and popcorn to sell on knowing what to say. Mr. Ray also mentioned that we weren't part of the conspiracy, and at age 15 for Theresa and 16 for me were now head candy girl and head usher, respectively. All the others were fired. These were positions we would hold until we left the Seville several years later.

When I told Dad and Babbononno about my new promotion, it was pizza and beer at Santarpio's, with Babbononno slipping me his beer when no one was looking as I was a teenager. Everyone looked the other way.

Things went well for me. In the late '50s, the company policy indicated that afternoon matinees were a thing of the past, and Mr. Ray concentrated on the quality

public during the evenings, and I was part of it. On Sundays, I would open the theater. I attended the 11:30 Mass at Sacred Heart and after opened the gates that protected the outer lobby from the street around an hour later. I would head for the boiler room, turn on the heat or the air conditioning — depending on the season — and burn the trash from the night before.

After Mr. Ray gave me the position of head usher. I had to hire a new crew and did this to the best of my ability. A couple of the new ushers were quite determined, followed orders to the letter and were still present when I left in 1962.

In 1961, Mr. Ray was let go. I had put a petition together, had it signed by 1,000 East Bostonians and submitted it to the corporate office. They didn't care. The ATC was on its last legs and they made changes throughout their theater chain. Mr. Ray was replaced by Frank Fereirra, who had been the manager of the Central prior to its demise by fire five years

Mr. Ray would wind up at Adams Theater in Dorchester. I would meet him at Ken's in Copley Square about once every other week for a late-night bite to eat. I made the decision to leave the Seville by 1962. I was teaching school in Boston, playing music at night, taking graduate courses in between and something had to go \dots it was the Seville.

After ten years of growing up and learning the ropes, I had to move on. The ATC would go out of business in the '60s and the Seville would close, never to open again. Now, it's a hole in the ground.

Is Wladimir Klitschko an All Time Great? Galento

A Heavyweight Championship fight taking place in Madison Square Garden has always been an exciting event.

Unfortunately, it is a very rare occurrence these days, so I have to admit I was a bit excited to have the chance to watch last Saturday night's matchup between World Champion Wladimir Klitschko and Bryant Jennings.

There was a lot of talk before the fight of how Klitschko ranks among the all time great champions. He was even compared to Joe Louis. With a record of 64 wins, 53 coming via knock out, against just 3 losses, and not having lost a fight in 11 years, the numbers look very impressive. He was going in against an undefeated fighter with a lot less experience, 19 wins, 10 by knock out, and no losses, but who was being touted as a worthy challenger. Jennings certainly appeared confident, so I was looking forward to what I hoped would be an interesting fight, and it was. I will not go into detail about the bout, but instead take what I saw in his performance, along with what I have seen in the past, to see how Wladimir stacks up in the all time great ratings.

To begin with, Klitschko has many of the qualities of a great champion. He is a class act from start to finish. When asked about the referee's behavior during the bout, where it seemed the third man was badgering the Champion, Wlad was gracious, he didn't complain and just said the ref had a job to do and did it as best he could. There is also never any trash talk from Dr. Steelhammer. He comports himself well, he is always in good shape, and he put his life on the line by returning to the Ukraine during the Russian invasion to show support for his countrymen. He and his brother have also been appointed "Ambassadors for Integration," a role they have embraced as they work to emphasize the commonalities of the peoples of the world. The Champion, who has a PhD in Sports Sciences, is a tremendous role model for young and old alike, something that boxing has had too little of in recent years. The only flaw when considering putting him on an all time great list is the fact that he really has very little boxing talent.

I hate to say that, and I know I will be criticized for it, but the fact is Wladimir Klitschko uses a very basic European amateur style. In the Jennings fight, against a guy who was shorter than he is, Wlad never threw an uppercut. He gets flustered when hit and he rarely throws a combination, but when he does, it is not more than two punches. He is very heavy on his feet and lacks rhythm. He may be athletic, but he does not move well in the ring. He has done well because his opposition has been so poor. His size and strength have gotten him through most of his fights, and in the Jennings fight, against a guy who, frankly, looked like an amateur, he had a very difficult time dealing with movement. He even admitted after the fight when asked why he had not

thrown many right hands, he didn't feel he could hit such an elusive target. That does not speak well for someone with so many fights under his belt.

As I thought to how he would stack up to previous champions, I decided to begin from the reign of Larry Holmes and go backwards. I honestly cannot think of one former champ who would not have defeated Klitscho. In the past I have given my opinion on how Wlad would have done against another very physically big champion, Primo Carnera (I picked Carnera to beat him.), so I thought now I would think a bit about some of the contenders of the past and how he would have done matched up against them.

Off of the Jennings fight I got a pretty good indication of how he would do against a fighter in a crouch, though Jennings certainly was no Jack Dempsey. Wlad was wide open for an overhand right as well as a left hook to the body, providing his challenger would pivot a bit to the right first. He is basically open to a sucker right. I immediately thought of Tony Galento, a fighter who is often joked about, but one who actually was a very good fighter. Galento knew how

to slip a jab and deliver a solid left to the body followed by an overhand right that he would have landed flush on Wlad's jaw. The Champion would never have seen the punch coming, which would have really shaken him up. Galento would have moved just enough to his right to be in Klitschko's

blind spot. Two Ton Tony would have ended this fight in one or two rounds as he would have spotted the flaws in the Champion's defense as soon as the bell rang.

It is sad, but true that Wladimir Klitschko is a below average fighter when it comes to past eras. His jab is tentative and his right, while powerful, is not effective against a fighter with some skill and movement. His size, which is what he gets by on today, would not have helped him in the past. Could he have been better if he had better schooling? I really don't think he would have improved a lot as he is too muscle bound and tight.

I ran this idea about past contenders challenging Wlad by historian Mike Silver, and he told me he thought even Charley Burley, the all time great middleweight, would have taken him. I have to agree.

HOOPS and HOCKEY in the HUB

When it was over, all over, you knew that this had been much more than a fourgame series for the Boston Celtics.

Those four games with the Cleveland Cavaliers had been a boot camp, a training experience and an introduction to the NBA postseason that will serve those young men in Green and White well in the years to come.

Keep in mind that the playoffs are unlike any other experience in basketball. In high school and college you might play an opponent twice during the regular season, but often with weeks between games. Then in the playoffs the winner of one game advances while the loser goes home.

Not in the NBA. Whether you win or lose the first game you live to play another day - and another and another and another — and even more if a series is stretched to its full length of seven games.

Really, there's no other test like it in basketball. You play your opponent both home and away in short order. The player who did just grand in game one might just be the goat in game two. Adjustments are made as the series progresses. Just ask Celtics guard Isaiah Thomas who virtually couldn't buy a basket in the last two games of the series. In game four he came out and missed his first ten shots. "The Cavs made it tough on me and all my teammates," he said.

Yes, that's what can happen in the playoffs as teams make changes to focus on certain players. But you know what? You learn from something like that. You learn to live another day as you make adjustments even if another day isn't until the playoffs next vear.

"You're learning every minute of every day," said Head Coach Brad Stevens in his final press conference of the season shortly after the conclusion of Game Four. "I've always said I've learned from every coach I've coached against. I thought the Cavs did a lot of great things. I thought their individual talents stretched our defense. And I thought our guys responded well a lot of times, but not quite well enough. We had three eight point losses in a row. You're always trying to grow and get better."

And much like a scientist who has just conducted a field study, there's loads of data and information to study.

"We have a lot of information and that's good," explained the coach who just concluded his second season on Causeway Street. "That's a really a good thing. We know where we can get better. We know individually where we need to improve. We know collectively where we need to improve. And the come summer.

best thing that I take from the whole year is that there's growth, there's building and there's progress. Now we have to build on it. That's the challenge. The hard part now is continuing it and building on it. But we've got a good environment. That's a real positive moving forward."

For a coach whose team just absorbed four defeats, Stevens refused to dwell on the negatives and continued the theme of taking positives from the sweep his team endured.

"I think the biggest thing for us is that we got some experience (in the playoffs). But we didn't get it against a run-of-the-mill team. We got it against a team that a lot of people think will come out of the East. I think playing against some of the best players in the world — that stretches you and that's a good thing. That's why I'm glad we played the Cavs. You're going to be chasing that level of player, trying to figure out how to stop them or how to make it more difficult for them. We've shown that we've been in games, even though we haven't controlled everything we can control. I've learned a lot and I'm excited about where we stand, but I know we have a lot of work to do."

And that was a point that Stevens really stressed. That he wasn't satisfied. "We haven't played a perfect game yet. We were 40-42 (in the regular season) and lost 4 straight in the playoffs," as he emphasized that there was room for improvement all around. "I think we can get a lot better. None of us signed up to play for the Boston Celtics for a quick exit. That is something to keep in mind moving forward. The (Garden) crowd was as good as it gets and the longer that you play — I can't imagine what that would be like.'

The coach even drew upon a business image as an illustration. "I've heard this term thrown around in basketball circles some and certainly in other industries as well: it was a great opportunity to build upon and extend our corporate knowledge. Being able to reflect back on times when we guarded a certain action because we were forced to do so — and being able to do that on the fly maybe next time. Being able to reflect better on how somebody is guarding us because we can think back on it."

By making the playoffs, the Celtics won't be participating in the draft lottery later this month. That's reserved for teams that didn't make it to the postseason. The next big day on the calendar will come at the end of June when the annual NBA Draft will be held. The Celtics have two picks available. But Danny Ainge is known as a dealer. There could be quite a bit of action off the court
