

This past Tuesday, May 10th, was another big election day for voters in Nebraska, West Virginia, and Massachusetts.

Hillary Clinton won Nebraska as expected, but Bernie Sanders upset Hillary in West Virginia where he beat her big, 51 percent to 36 percent. With his West Virginia win, Sanders has now won 19 states to Clinton's 23. Sanders vows to fight on and has been campaigning in California recently for that state's June 7th primary. However, Clinton inches closer to the 2,383 delegates needed to secure the nomination. Trump received a great vote in West Virginia, where he now keeps piling up votes to officially win the GOP nomination.

## Stirpe Nostra

#### THE TRUTH ABOUT THOSE SABINE GALS

753 is the date given as the beginning of Rome. Of course, there are few people who are unfamiliar with the story of Romulus and Remus. In their adult years, these twins had a great desire to found a city in the area where they were reared. Romulus took the Palatine and Remus took the Aventine. Each built walls around his domain. The most common story to come down to us from antiquity is that Remus leaped over the Palatine wall in mockery of his brother, whereupon Romulus, in great anger, slew him. At that time Romulus is supposed to have said, "So perish whoever else shall leap over my wall." Romulus acquired sole power and founded the city which bears his name.

After attending to the worship of the gods, Romulus called all of his people together and gave them the rules of law, since there was nothing else but law that could unite them. The city was expanding because they built their walls and defenses to suit the terrain rather than the population. They were strong and could wage war on any of

their neighboring states, but the scarcity of women was their greatest problem because it posed the threat of being wiped out in a single generation and bring an end to the greatness of this young nation. Romulus sent envoys to the neighbors to make friendly advances and to provide for intermarriages, but they were rejected and returned without success.

Romulus concealed his resentment and started preparations for their national festival and games honoring Neptune, the mythical god of the sea.

The neighbors were invited, and many who lived nearby came to see the festival and this new city. The visitors included people from Caenina, Crustumium, Antemnae, and the Sabine country. Homes and hearts were opened to the visitors and they marveled at the rapid growth of the Roman nation. The start of the games occupied the attention of the guests and they didn't notice the assembling Romans in the background. At a given signal, the young males darted through the spectators to seize and carry off the maidens. Some

of exceptional beauty were marked out in advance for the Senators, and these were taken to pre-designated houses. The games broke up in panic and the parents of the girls fled in great sorrow. They charged the Romans with violating the very essence of hospitality. The stolen maidens were no less indignant, and Romulus visited them to explain that it was the pride of the parents in refusing intermarriages that caused this deed. During the ensuing wars, the aggrieved nations were quickly defeated by the Romans and it was the body of the dead king of Caenina that was mounted on a frame, carried up to the Capitol Hill and deposited beside a sacred oak. Romulus then marked out the limits of a temple to Jupiter. After suitable offerings, this became the first temple that was consecrated in Rome.

History makes no further mention of these Sabine girls, but alludes to a generation of very happy Romans. What else can be said except "Figlio maschile e cento anni."

#### Romney for President?

"He came pretty close to being elected president, so I thought he may consider doing it, especially since he has been very forth-right in explaining why Donald Trump and Hillary Clinton should not be president of the United States," said William Kristol in a phone interview with the *Washington Post* last Friday. In that interview he reportedly confirmed that he and Romney had a meeting in Washington to discuss Romney's potential run as an Independent.

Has the Republican establishment gone stark raving mad? Is Romney seriously considering this? I thought Mormons didn't do drugs, but Kristol must have given Mitt something stronger than a caffeine-free diet Pepsi if he got him to buy into this scheme.

Let's, as they say, break down the numbers.

1. Can Romney or any other Independent win? No. No Independent candidate has won a single state since 1968, when George Wallace won five states of the old Confederacy. He won't even be on the ballot in Texas (38 electoral votes) because the deadline to file was May 9th. Can he get nearly 90,000 signatures by June 9th to get on the ballot in North Carolina (15 electoral votes)? Unlikely. Say he gets on the ballot in California (55 electoral votes), where he has until early August to get the necessary 180,000 nomination signatures, then what? In 2012, Romney got 37 percent of the vote in the Golden State as a major party nominee. With current polls showing Clinton winning by comfortable margins over Trump, and that even without Romney pulling votes away from Trump, it doesn't take much analysis to see that Romney cannot win California. He has more time to get on the ballot in New York, and needs only 15,000 signatures. However, he must get at least 100 from each of the state's congressional 27 districts. Even when he ran as a major party candidate, Romney was weak on the sort of on-the-ground, precinct-by-precinct organization needed to pull that off. But say he does get on the ballot and competes for the Empire State's 29 electoral votes. Does he really believe that he can do better than New Yorker, Trump, and former New York Senator, Clinton? So, there are four states that account for a quarter of the electoral vote off the table. Romney would need to get two-thirds of all the remaining votes to win. In other words, the only way this late entry, non-major party candidate can win at all is if he wins in a landslide. The Las Vegas bookmakers have a name for betting on that happening, a sucker bet.

2. Can Romney win enough votes to deny both of the other candidates the 270 necessary to win, thus throwing the election to the House of Representatives where each State delegation would have one vote? That seems unlikely. If Wallace, with a more coherent, but repugnant, basis for a third-party run (Wallace was a segregationist who won some of the States of the old Confederacy during a time that the battle for civil rights for African-American was one of the topics at the center of political discourse) couldn't do it, what makes Romney think he can? Can he win Massachusetts where he was Governor? Well, he couldn't when running headto-head with a Democrat, now he'd need to do it while splitting the Republican vote. Ditto for his native State of Michigan and adopted State of New Hampshire — he lost both in 2012. Perhaps he pulls off a win in Mormon Utah and gets 6 electoral votes. Will that be enough to deny the others 270? Who knows? Could that make a difference in a close election? Well, in 2004, Bush could have lost those 6 votes and still had 10 more than needed. In 2000, had Bush lost the then 5 votes from Utah and everything else stayed the same, the election would have gone to the House of Representatives. In the 1960 election, the closest ever in popular vote, Kennedy would still have won, even with 33 fewer electoral votes. In the unlikely event that Romney got enough votes to send it to the House of Representatives, it looks good for him. Remember, each State gets one vote. In 33 States, the delegation is majority Republican. Democrats are the majority in 14 delegations, while three are split evenly. Even though Trump is the Republican nominee, the Republican establishment does not like him and would likely vote for Romney. That would give us a President who most likely would have come in third place in both the popular and the electoral vote. Watch for a massive movement to change our voting system after that!

**3.** The most likely scenario. Romney takes just enough votes away from Trump that Clinton wins. The Republican establishment has no problem with Clinton as she represents the Democratic establishment and the Republican and Democratic establishment have much more affinity for each other than they do with their own voters.

## Saint Remigius

Saint Remigius, the great apostle of the Franks, is one of the patron saints of France. He was famous for his learning, sanctity and miracles. Traditionally, it is believed that he was born at Cerny-en-Laonnois, near Laon, Picardy, into the highest levels of Gallo-Roman society. He is said to have been the son of Emilius, count of Laon, and Celina, daughter of the Bishop of Soissons, which Clovis had conquered in 486. He studied literature at Reims and soon became so noted for learning and sanctity that he was elected

Archbishop of Reims at the age of twenty-two. Remigius, as bishop, had as his chief aim the propagation of Christianity in the realm of the Franks.

Remigius is known to have corresponded with Clovis, but the king, although married to a Christian, Clotilda of Burgundy (later St. Clotilda), remained indifferent to religion until two incidents changed his mind. First, the couple's infant son was cured of an illness, and then, in 496, Clovis's army, near defeat in a campaign against the invading Alemanni, won a sudden and decisive victory. Convinced that these events were evidence of the power of Christ, Clovis sought to be converted. Along with his leading warrior chiefs, he was baptized by Remigius at Reims on December 25, 496.

Clovis granted Remigius stretches of territory in which Remigius established and endowed many churches. He erected, with papal consent, bishoprics at Tournai, Cambrai, and Terouanne, where he ordained the first bishop in 499. The authors of Gallia Christiana record numerous and generous donations made to St. Remigius by members of the Frankish nobility, which he presented to the cathedral at Reims. In 517, he held a synod at which, after a heated discussion, he converted a heretic bishop who held Arian views. Remigius is said to have baptized more than 3,000 of the king's soldiers at the time of Clovis' conversion. He was also credited with many miracles.

It is believed that Remigius passed away on January 13, 533. St. Remigius' relics were kept in the Cathedral of Reims until they were transferred to Epernay during the Viking invasions and, in 1099, to the Abbey of Saint-Rémy. His feast is celebrated on October 1st.

## L'Anno Bello: A Year in Italian Folklore

Fining Trust and Beauty in Nature

Around this time of the year, when delicate spring gently gives way to the heat of summer, I feel the pull of nature calling me. The trees have erupted in full bloom, and whenever I look up through their branches, I see a bright mosaic of lacy green leaves silhouetted against the sunlight. Since the days are now longer, evening falls softly with a dusty glow, reminding me of dinners eaten outdoors watching the sunset. Yes, this is the time of the year when I want to spend as much time out in nature as possible. My husband and I often take walks in a state park near my town, reveling in the shady trees, the burbling waters of the streams, and the miniscule flowers dotting the meadows. Even just walking to my mailbox on a warm and sunny day, watching the birds dart in and out of the bushes, is enough to lift my mood. This desire to return to nature has roots in a deep and universal longing, so much so that many May holidays around the world

encourage celebrations in the outdoors.

When I was in Italy with my family years ago, some of my most vivid memories recall places of natural beauty, along with the lovely human interactions they enabled. Our first stop was Milan, and we stayed at a small inn nestled on an old side road. I remember stepping into the hotel's courtyard, which blossomed with wild trees and colorful bunches of flowers. A worn statue of a Roman goddess peeked out from the foliage, making me feel as if I had stepped through a looking-glass into days long past. A friendly group of Japanese girls staying at the hotel offered us some oranges they had recently bought, and the experience felt transcendent, a crossroads of culture, nature and history. In Rome, my family wandered into a secluded area of some ancient ruins, where, far removed from the bustle of the busy city, we heard only the sound of the breeze flutter-

ing through trees and chirping birds. Until we started talking to two jovial college-aged brothers from Colorado, I could not shake the sensation that the breeze and the birds were really spirits of antiquity announcing their presence. The latter half of my trip to Italy was spent in my father's hometown of Sulmona in Abruzzi, a bucolic hamlet of rolling hills, braying sheep, and expansive meadows. It felt more like the real Italy than other places that cater exclusively to tourists.

The holiday of Pentecost falls on Sunday, May 15th, and Italians will spend this important Christian feast day incorporating rituals from the outdoors. Pentecost is part of the Easter festivities, occurring on the seventh Sunday after Easter, and it celebrates the descent of the Holy Spirit upon the disciples of Jesus. Some Italians refer to this feast as Pasqua Rossa, meaning Red Easter, due to the red vestments clergy wear in honor of the Holy Spirit. Many Italian churches scatter rose petals from the ceiling on this holiday, bringing the ubiquitous flowers of May into the celebration, as a way to commemorate the Holy Spirit descending on the disciples. In England, Pentecost Sunday is known as Whitsunday, and there the festivities heavily take on an outdoor quality. People celebrate with Whitsun Ales at town fairs filled with feasts, folk dancing, parades, and charitable collections to benefit the village church and poor families. The Easter season is one filled with multiple references to the rebirth and renewal of the Earth and vegetation, which in religious ceremonies also refers to the renewal of faith and hope. In Italy and other European countries, the Easter festivities do not end on Easter Sunday, but rather move on to encompass other feasts like Ascension Day and Pentecost, reminding us that the beauty of nature and the revitalization of the season continue as spring turns to summer.

May remains one of the most significant months for appreciating nature and all it has to offer. When I was an undergraduate student, I took a wonderful course on Buddhism. One spring day, the professor took us out to the woods to meditate. He explained that by becoming at peace with the outdoor surroundings, we do not separate ourselves from the world but rather reach down into our deeper consciousness and find ways to better our interaction with the world. I also learned this lesson while I was in Italy, and from investigating European holiday customs like those of Pentecost. By taking the time to appreciate the natural world around us, we are forced to look within, and honor our own mind and soul. Perhaps that is the message of the breeze fluttering through the trees after all.



Bocelli has recorded fourteen solo studio albums of both pop and classical music, three greatest hits albums, and nine complete operas, selling over 80 million records worldwide. He has had success as a crossover performer, bringing classical music to the top of international pop charts. In 1998, he was named one of People's 50 Most Beautiful People. In 1999, he was nominated for Best New Artist at the Grammy Awards. "The Prayer," his duet with Celine Dion for the animated film Quest for Camelot, won the Golden Globe for Best Original Song and was nominated for an Academy Award in the same category. ## Ray Barron's 11 O'CLOCK NEWS

On this day: The birth of Dante Alighieri, Italian poet, in 1265; and the death of Gary Cooper, film actor, 1961. Cooper is at the Sacred Heart Cemetery, Southampton, Long Island, New York. Originally he was buried in Los Angeles, but he was moved 13 years later to Long Island to be near his wife.

Officials at San Francisco State University are investigating a videotaped confrontation between an African-American woman who grabbed a white student with dreadlocks and accused him of cultural appropriation. "You're saying I can't have a hairstyle because of your culture? Why?" Cory Goldstein asked the woman. "Because it's my culture," she responded, blocking his path. "She kept grabbing me" Goldstein later said.

Flying high! Hartsfield-Jackson Atlanta International Airport remained the world's busiest passenger airport in 2015 — holding off its closest competitor, Beijing, to take the title for the 18th year running. More than 100 million passengers passed through Atlanta's international airport in 2015, a rise of 5.5 percent over

Recent poll stuff: Neither one of the two remaining presidential candidates is regarded favorably by a majority of registered voters. Donald Trump remains the most disliked candidate, with 65 percent of voters viewing him unfavorably, and 24 percent favorably. Only 32 percent hold a positive view of Hillary Clinton, and 56 percent see her unfavorably — a gap almost twice as wide as it was last month.

Since 1976, 72 percent of the nation's executions have occurred in the 11 states of the old Confederacy. Studies have shown that blacks are far more likely than whites to be sentenced to death when convicted of murder, especially if the victim is white.

This March was the hottest on record, making it the 11th month in a row to break the global high temperature record. "We discovered that since the time of Christ, the male species has worn long hair and beards about 90 percent of the time," the congressman reassured a hair-harried nation. "The western world turned to short hair and clean-shaven faces only after the Prussian victory over France. All the great heroes of America have worn long hair. It's nothing for Americans to get alarmed about."

Worst hemorrhoids: An article published in The Wall Street Journal on August 10, 1973, offers hindsight on the Battle of Waterloo. An overlooked factor in the French defeat was the health of Napoleon Bonaparte. According to medical historian Rudolph Marx, the emperor spent much of the day resting in his tent, laid low by an excruciating case of swollen hemorrhoids. Lack of sleep and opium administered by his physician left him too groggy to mount his horse and take advantage of a breach in Wellington's flank.

Most unusual weather forecaster: Mrs. Fannie Shields of Baltimore, Maryland, owned a cat named Napoleon back in the 1930s who could predict the weather with an accuracy that was deadly. During an especially severe dry spell that gripped Baltimore in 1930, when human meteorologists were offering no hope for relief, Mrs. Shields phoned the Baltimore newspapers and told them that rain would fall within 24 hours. How could she be so sure? the papers asked. Easy she told them. She had just seen her cat Napoleon sitting with his front paws extended before him and his head on the ground, his own way of indicating that it was going to rain. The paper, needless to say, took her for a mad woman. The following day, it rained! In the ensuing months, the papers published Napoleon's forecasts. They were accurate more often than not.

Most unusual beads: In some coastal areas of Italy, squid eyes are strung and used for necklaces and bracelets.

Most unusual racket: An article in the June 28, 1967, New York Times carried the following headline: GARBAGE CARTING IN GRIP OF MAFIA.

Worth repeating. Shortly after the United States declared war on Italy in 1941, the federal government classified more than 600,000 Italians living in the United States as "internal enemies." During World War II, an estimated 1.2 million Americans of Italian descent served in the U.S. military, constituting one of the largest segments of the U.S. combat forces of about 12 million. Yes, I was one of them.

Our show biz great and noted musicologist Al Natale reveals what Wally Cox had to say about Arthur Godfrey. "People think what they see on TV is reality. That's why everyone thought Arthur Godfrey was the salt of the earth. More like salt in your coffee! Ask anyone who ever worked with him — he was one of the meanest, pettiest, most rotten-souled performers, and I do mean performers, that ever worked on television or any other medium."

Permanent address: Al Jolson, vaudeville's great entertainer who passed away October 23, 1950, is at Hillside Memorial Park, Los Angeles, California. In the cemetery, there is a statue of the jazz singer resting on bended knee, arms stretched out, singing his famous rendition of "Mammy." And Rocky Marciano, heavyweight champion, is at Lauderdale Memorial Gardens, Fort Lauderdale, Florida. On the evening of his 46 birthday, he died when his plane crashed into the only oak tree in an Iowa cornfield.

## Parla Come Mangi!

(Speak as You Eat!)

Benvenuti! Nestled between Abruzzo, Lazio, Campania and Puglia, Molise is the second smallest region in Italy. Once part of Abruzzo, Molise has been its own region since 1963. With a very similar topography to that of Abruzzo, Molise is a land of simple hearty flavors of the mountains. Molise has only a small piece of coastline located near the medieval city of Termoli. Pork is the dominant meat in the region and it is flavored and seasoned in many ways as it is used to make a wide array of sausages and specialty hams. Ventricina di Montenero di Bisaccia, a seasoned spreading sausage made from lean leg meat, famously comes from the area near Campobasso, Molise's capital city. Goat meat and lamb meat are also widely used in Molise, as well as wild boar, chicken and rabbit. Mushrooms, black and white truffles, and olive oil are other well-known products of the region. Superior dairy products are also part of the culinary excellence of Molise thanks to artisanal production methods and the very high quality raw materials. Among the "pasta-filata" cheeses of the region, Fior di latte is a type of cow's milk mozzarella produced in the Bojano area, near Campobasso. Another local specialty is Scamorza, a gourd-shaped melting cheese that is mild and slightly sweet. A very tasty cheese is the Caciocavallo which translates as "cheese on horseback". Mild and slightly salty, Caciocavallo's aroma and taste are similar to the provolone cheese when eaten young and gets sharper with aging. Another variety of cheese that is particularly interesting is the Burrino, a sort of small Caciocavallo with a heart of soft butter in the center — an absolute must-try! Luckily, to taste these wonderful cheeses you don't have to travel as far as Italy. Molise-born and trained Master cheese-maker Luca Mignogna runs Wolf Meadow Farm in Amesbury, just north of Boston. His farm is truly an authentic "caseificio artigianale" (artisanal cheese facility) and his commitment to high quality and his passion and dedication to sustainable production methods fully reflect the Italian standards of excellence that can be tasted in every slice.

This week's recipe — Fiadoni molisani — are a sort of mini calzone that are as easy to make as they are to eat. This dish, whose original recipe dates back to the Renaissance, makes a delicious appetizer. The cheese traditionally used for the filling is the Rigatino, made from a mix of cow and sheep's milk. Rigatino is not produced in the States, therefore it can be substituted with Primo Sale, a very young cheese removed from the mold after first salting. Enjoy your home-made Fiadoni with a glass of Biferno bianco wine.

#### Fiadoni Molisani

3 1/8 cups flour 8 eggs (2 yolks, six whole) 7 oz. lard or butter Pinch of salt 28 oz. of Primo Sale

½ cup grated Pecorino cheese Dried sausage (cut into small pieces) 2 egg yolks (beaten)

Preparation: Pour the flour onto a work surface (or into the mixer) and incorporate the lard or butter after cutting it into small pieces. Add a pinch of salt and the two egg yolks. Knead well, adding one or two tablespoons of lukewarm water as needed. Once a smooth dough is formed, wrap in plastic and let rest for about 30 minutes in the refrigerator. In a large bowl, prepare the filling by beating the remaining six whole eggs with a pinch of salt and adding both cheeses and the sausage. Mix well. With a floured rolling pin, roll out a thin (but not too thin) layer of dough. Cut out discs with a large cookie cutter (about 3") and place 1 tablespoon of filling in the center of each. Wet the edges of the discs and fold them in half sealing the edges together with a fork. Arrange the Fiadoni on a cookie sheet lined with parchment paper. Pierce the surfaces with a fork and brush them with the beaten yolks. Bake in a pre-heated 350°F oven for about 30 minutes. Serve while still warm. Buon appetito!

#### Fiadoni Molisani

400 g di farina 8 uova (2 tuorli + sei uova intere) 200 g di sugna o burro Un pizzico di sale

800 gr di Primo Sale

100 g di formaggio pecorino (grattugiato) Salsiccia secca (tagliata a pezzetti) 2 tuorli (sbattuti)

Preparazione: Versa la farina a fontana su una superficie di lavoro (o nel mixer) e incorpora lo strutto o il burro (tagliato a dadini). Aggiungi i due tuorli ed il pizzico di sale. Impasta bene aggiungendo uno o due cucchiai di acqua tiepida se necessario. Forma un impasto liscio quindi avvolgilo con della pellicola e fallo riposare per circa 30 minuti in frigorifero. In una grande ciotola prepara il ripieno sbattendo le restanti sei uova intere con un pizzico di sale e aggiungendo entrambi i formaggi e la salsiccia. Mescola bene. Infarina un mattarello e stendi uno strato sottile (ma non troppo) di pasta. Con un coppapasta ricavane dei dischi di circa 10 cm di diametro. Poni un cucchiaio di ripieno al centro di ogni disco. Inumidisci i bordi dei dischi e piegali a mezza luna sigillandoli bene con una forchetta. Disponi i fiadoni su una teglia foderata con carta da forno. Fora la superficie con una forchetta e spennella con del tuorlo d'uovo sbattuto. Cuoci in forno preriscaldato 180°C per circa 30 minuti. Servili caldi. Buon appetito!

A Nostalgic Remembrance



#### **UNCLE GUS and MUSSOLINI** Part V — The Conclusion

Before I begin, there are two things of importance that I want to share with you:

First of all, over the years, I've been looking for a picture of the front of the Seville Theater, my home from 1952 through 1962. Last week. I met with two East Bostonians, Fran Ippolito Riley and Theresa Malichek, to discuss my future involvement with the East Boston Museum and Historical Society. Among the things presented to me was a picture of the front of the Seville Theater from the photo collection of the late Paul Paulson. I am now in seventh heaven. More about this new friendship and my involvement with the museum and society at a later date.

Second: This Sunday, May the 15th, this column will be 25 years old. I'm proud of it and hope to continue writing it for another 25 years. To those of you who knew of this and congratulated me in advance, my sincerest thanks. I am eternally grateful.

Let's get back to Uncle Gus ... Last week, I left off with Uncle Gus telling me about himself and several of Mussolini's inner circle who were left behind to deal with the Americans who were advancing north on the west coast of Italy. The Americans, after several fatal mistakes, finally kicked butt in Salerno, Naples, Anzio/ Nettuno, Cassino, and then headed to Rome where the people were ready to greet the American conquerors. Uncle Gus and a group of volunteers, who had been part of the Fascist inner circle, surrendered to General Eisenhower and General Clark and formalized the changing of sides. One of the first things they collectively did was abolish the Italian monarchy and set up a republic.

He continued with, "Mussolini, in the mean time, fearing his life was in danger, fled to northern Italy where the Nazis were still in control. In April of

'44, the partisans tried to capture him away from his German protectors. Fearing the inevitable, he left Milan and tried to make it to the Swiss border. The Italian partisans caught him and his lady friend, Claretta, near Lake Como. The next day they were shot to death and hung upside down in Milan's central Piazza. No one knows who really shot Mussolini because about a dozen people tried to claim responsibility or credit for the act. In my estimation, it was a Communist plot led by a guy named Audisio or another named Partini. I don't know at this point. But even better, as far as we were concerned, two days later, Hitler committed suicide. With the Americans setting up a new democratic republic, we insisted that Sandro Partini become the country's first president. So, much of what I just said is from what I had heard, because after Mussolini fled Rome, I stayed behind and awaited the American 5th Army."

This was a one-hour solo performance as we sat at the seaside restaurant relishing the fishes we had picked out of the salt water tank. Uncle Gus, after consuming several glasses of Lambrusco, seemed uncertain which side he was on, but I think, like most Germans and Italians, he became reconciled to the fact that the war was over, his side had lost, and it was time to get on with their lives. Actually, Italy was in shambles, and they had a new strange form of government which was broke. Germany was in the same situation with a generation of young men dead, but Gus didn't seem to care about them, and that's a story for another day.

When we headed for the rented FIAT 127, Sal and his father jumped in the back seat. They were short and the back seat could be quite cramped if you were over 5'8" which they weren't. Uncle Gus was about

6' and he sat in front as my copilot. He, once again, became quite talkative, "Let's look at the aftermath of the war; Mussolini was dead, Hitler was dead. The Americans were all over Italy and the Russians controlled much of Germany. To avoid a total Russian takeover, the French, British, and Americans had to hurry from the west to take over whatever they could just as the Nazi high command surrendered to the Russians. In the middle August of '45, you Americans ended the war with Japan with two new bombs."

"There was a proposal for a new international organization to replace the League of Nations which your President Wilson helped put together after WW I. It didn't work, and supposedly, I was to be part of a group of international representatives that was to layout the groundwork for this new organization that would avoid future wars and setup standards for human rights. They called it the United Nations and the cabinet of the new Italian government chose me to be one of the representatives considered for a branch of the new league that would maintain world peace, the Security Council."

"About three months after Japan quit the war, an international conference was held in San Francisco of your country. By the end of October, there were about 50 countries that would formulate the charter that would get things started and determine where the international headquarters would be located. A plot of excavated land on 49<sup>th</sup> Street and First Avenue in New York City was declared the site and that's where they built the United Nations World Headquarters."

"There were problems right from the beginning; they were called Communism. Russia was Communist. China's government fell to them in '49, and then Eastern Europe, one country after another. I was there, but I had no say ... no vote. Italy was not voted into the U.N. until 1955. After we were admitted, I worked with the Security Council until I decided to retire. And, here we are heading south from Palermo to Agrigento, with me talking all the way."

When Sal's parents retired and moved back to Agrigento and bought a luxury condo, Uncle Gus, a bachelor, shared it with them. A few years later, Carmelo, Sal's Father, experienced some health problems. The family sold the condo and moved to Boston where better medical treatment was available. Uncle Gus came with them, but returned to Sicily when his own health started to decline. I never saw him again. He passed away in Italy with just Sal physically capable of heading there for his funeral.

I wrote this story because I could only find bits and pieces of it in history books, and thought you should know about Uncle Gus while my memory is still intact.

In 1996, Roger was in his horrible 4-year stretch when he went 40-39, but against the Tigers he did look like Rocket Man once again.

In 1997, he went free agent and ended up with the Blue Jays where he surprisingly got back on top of his game again. Clemens spent two years in Toronto, then on to the NY Yankees where he continued to look like the superstar pitcher again.

Sadly, Clemens got caught up in the Steroid Era scandals which have kept him, to date, from getting elected into the Hall of Fame. Someday in the future he probably will, but those lingering questions are still too strong to open that door of honor to him.

By the way, Kerry Woods also struck out 20 batters in a game in the 1998 season.

#### **BENNY LEONARD** — In His Own Words

With the recent publication of Mike Silver's book Stars In The Ring: Jewish Champions in the Golden Age of Boxing, I have been reminded not only of how boxing was once nearly dominated by Jewish fighters, but also how one, Benny Leonard, stood out above all the rest. It is surprising that in all the years since Leonard was champion, there has only been one biography of him published. That book was by the founder of Ring Magazine, Nat Fleischer. Unfortunately, it is not a very good book and does not do justice to the great Lightweight Champion. Fortunately. Mr. Silver fills the void with his chapter on Leonard in his new book. Mike captures the essence of Benny Leonard in his thoughtful and thorough look at the Ghetto Wizard.

While my thoughts turned to Benny, I was also lucky to come across an interview the reigning champ had given to journalist Robert Edgren in 1921. This historic piece was shared by boxing researcher Gregory Speciale, the man who has unearthed more incredible historic boxing items than anyone I know.

I thought I would share a few of Benny Leonard's quotes from both works along with some photographs. Remember, boxing experts have consistently rated Leonard among the top ten fighters, pound for pound, for decades. He is also considered by many to be the greatest lightweight of all time.

Mike Silver has a wonderful quote from Leonard that was passed on by the great trainer Ray Arcel. When asked by Arcel why he studied four-round preliminary fighters sparring in the gym, Leonard replied, "You can never tell when one of those kids might do something by accident that I can use."

Mike also has this passage, "In his prime, Leonard was far superior to most of his opponents, but he never sought to humiliate them. I don't want to hurt the other guy,' said Leonard. I want to stop him. But that does not mean I am eager to cut him up and murder his self-respect. The credo of the professional ring is to win with speed and your best means of execution. As for that 'killer instinct', I never had it as a kid when bringing home the pay was very important, and I never had it as a champion."

Here are a few gems from the Robert Edgren interview of 1921:

"Study is the thing that makes successful fighters nowadays. Yes, the day of the boy with a

strong back and a thick skull has gone by. You have to be a student to get to the top and stay there. I'm champion and any other lightweight could make a fortune beating me. Yet nothing can induce the best of them to meet me in the ring. I'm in a funny position as a champion without a contender for his title. Tendler, Jackson and the others know I can beat them, but they don't know why. They think it is because I have an awful 'kick.' They think I am bigger and stronger than I am. They don't realize I can beat them because I am a better student."

"You have to study three things to be a first class fighter.





First, your opponent's mind and habit of thought; second, your own mental control of timing and movement; and last, physiology."

"Do you know what a knockout is? It's simply a shock to a nerve, carried to the brain. There are three knockout points on the head, each where nerves lie near the surface. For instance, a straight blow on the end of the chin isn't a good knockout punch. But hit a man on either side of the chin, an inch or so back, or above the eye tooth, and you deliver a shock to a nerve connecting with the brain. The nerve telegraphs the brain that you're knocked out, and down you go."

"Now for myself. I study my self most of all, because after all, it's my machine that does the work. Every blow I use I've practiced thousands and thousands of times, studying every detail of delivery. I've put as much study into the delivering of a lifting right hand body punch as a man would need to learn Greek. I follow every inch of the blow and try to improve it in detail."

"NOW, about those 'six-inch punches' they say I use. I've heard hundreds of people talk

about my knocking fellows out with a six-inch punch, the way they used to say Bob Fitzsimmons did. I never knocked out anybody with a short punch. I don't believe any other fighter ever did.

"What I do is just this. I fool the eye. The speed of your arms in feinting counts. I feint rapidly with my arms when advanced, and suddenly I strike. The feinting is intended to fool my opponent so he won't know when the real blow starts, and if it fools him, it fools the spectators, too. You see me feinting and hitting, and what your eye catches is the general effect, because my arms are moving as fast as I can move them."

"You don't know that when I struck the blow my elbow was drawn farther back that one time, and instead of striking six inches or a foot, I really drove my fist two feet or more. They say Dempsey uses short punches. Dempsey takes twice as long a drive as he seems to take, and as for Carpentier, I watched him beating Levinsky, and he puts the punch into the finish of a blow that travels a yard or more."

Leonard sounds more like a college professor than a boxer, but in his day many boxers looked upon the sport of boxing as an art and studied it as if they were going for an advanced degree. Well, that is just what they were going for. I hope you have enjoyed these tidbits from one of the all-time greats, and I also hope you will spend time exploring the rich legacy left behind by such champions as Benny Leonard.

## HOOPS and HOCKEY in the HUB

HOCKEY SAVED IN SPRING-FIELD — Like a last-minute goal that provided a muchneeded victory, a number of investors have stepped forward in Springfield to make sure that there will be an AHL franchise in that city this fall.

You may recall that the Springfield Falcons were sold to the Phoenix Coyotes, who plan to move the team to Tucson, Arizona — much closer to that NHL club's base of operations. That would have ended an eight-decade presence of AHL hockey in the city.

But you had to wonder — in part because the AHL office headquarters for the entire league is also in Springfield. As the Springfield Republican newspaper stated "AHL President Dave Powers has always supported efforts to keep a team in Springfield."

All wondering ended two weeks later when it was announced that a group of Springfield investors had bought the Portland, Maine, franchise and would move it to the Western Massachusetts city in time for the start of the 2016-2017 season.

As a native of the Springfield area, your faithful correspondent feels somewhat divided — somewhat positive that there will be hockey in Springfield, somewhat negative that a team was poached from another community in New England to make that happen.

It leaves a bad feeling with you when one reads on the Portland Press Herald's website that taxpayers helped pay for a \$34 million renovation of the Cross Insurance Arena (formerly the Cumberland County Civic Center) in 2013 and are now looking at essentially a building with a significant surplus of open dates. Taxpayers also must cover any operating losses at the arena — which amounted to \$600,000 last year, even with the hockey team playing there.

The Pirates, who played in Maine for 23 seasons, had just completed the second year of a five-year lease. To get out of the agreement, the team needs to make a \$100,000 payment.

The Maine Red Claws, an affiliate of the Boston Celtics in the NBA Development League, play their home games at the Portland Expo Building and are not interested in moving.

It should also be stated just what is being moved and how it might be received in the Springfield area — given that region's underwhelming support of the Falcons in recent years.

Portland, like Springfield, has had attendance problems. The Pirates were last in the 30-team AHL in attendance during the 2014-2015 season (2,963 per game) and 29th in 2015-2016 (3,363 per game), just a bit better than Springfield, which had the lowest last season (3,108).

So, the team that was next to last in attendance is leaving that community and moving to the one whose team had the lowest attendance. Somehow, that just does not seem like good business sense.

In addition, remember that Springfield is only about 30 miles from Hartford, which has its own AHL franchise — the Wolf Pack. Thus, as one travels south from Springfield, the fan base changes as you enter Connecticut.

We've read that officials in Springfield are hopeful that attendance will increase when the MGM casino opens there in 2018. Their thinking is that Springfield will become somewhat of a destination area and the hockey team would be seen as another entertainment option.

Perhaps. But don't bet on it. SPEAKING OF SITES — It served the Celtics well over the years, but before too long the storied franchise will have moved on to a different address with even more modern amenities.

We speak, of course, of the Celtics decision to move from their current practice facility in Waltham into a new one in Brighton near the Massachusetts Turnpike.

There will be a familiar neighbor in the area — the Bruins will have their own new practice facility close by. And there will also be something else that's familiar — a new commuter rail station.

The announcement means that the Celtics will leave their practice area at Healthpoint in Waltham, a facility that has served the team since 1999.

Prior to that, the Celtics did not have a permanent practice area of their own, using the gym at Hellenic College in Brookline for such purposes. The Healthpoint facility was built during the Rick Pitino era and was state-of-the-art for its time. It features not only the Celtics practice area, but a complete health club for individual members as well.

The new facility, which is scheduled to open in 2018, won't be open to the public in that sense, but will host occasional community events as well as ones for season ticket holders.

More and more colleges and pro franchises are upgrading their practice facilities. There's the increased realization that it's the location where the athletes spend the majority of their time.

The building will have two basketball courts; the latest audio-visual technology; large strength, conditioning, physical therapy and rehabilitation areas; and an expansive locker room and players' lounge, along with an expanded facilities for media members.

IN MEMORIAM — Remembering Howard Garfinkel, whose well-known summer Five Star Camp in Pennsylvania became a destination for college coaches and elite high school basketball players. Garfinkel, who died in his native New York City on May 7th at age 86, hosted the camp for 42 years (1966-2008). Over the decades, it drew nearly 300 coaches and numerous players who went on to stardom in the NBA, including Michael Jordan, LeBron James and Moses Malone.

Garfinkel's first hire for a camp coach: Bobby Knight, who went on to become the head coach at the University of Indiana.
