

venerated as a saint in the Catholic Church. He was born Francesco Forgione, and given the name Pius (Italian: Pio) when he joined the Capuchins, thus he was popularly known as Padre Pio. He became famous for his bearing the stigmata. On 16 June 2002, he was canonized by Pope John Paul II.

CHOW DOWN IN OLD ROME, Part I

Food-food, where the h____ does it all come from? I think one of the most humorous of the quickies is told by a TV comedian who presents his candidate for the bravest person in the world — the primitive man who first spotted a cow and said to his friend, "do you see that animal with the big bag hanging down? I'm going to subdue it, then squeeze that bag and whatever comes out — I'll drink it." Dio mio what guts he must have had. I often wondered if his friend might have said, "O.K. and if there is any of that stuff left over we'll put it out in the sun for a week or so. When it gets all thick and moldy we can spread it on some bread and eat it. Then we'll kill the animal, slice the stomach into strips and cook it with tomato sauce. We might even bake part of the head in our oven and throw the tail in our next bowl of soup." I will never forget the day that I came home from school and saw my dear father baking half of a cow's head in the oven. I didn't go near him for a week and it took a month for me to get over the shock. I wonder who was the first person who ever made stuffed "calamaro" or "anguilla"? How about the first person who ever swallowed an oyster? I also wonder who started all of those stories about oysters (probably just an old wives' tale). For thousands of years, pre-

historic man ate his food raw. Then by accident or by forest fire, he discovered the additional joy of eating cooked food (similar to our newlyweds of today). This was the beginning of the long and slow process of discovering which meats were best prepared by heat and away from direct flame and which were best cooked over, in, or under the fire.

The early Romans were a frugal people, the poorer classes subsisted on a basic diet of coarse bread and a porridge made from millet or polenta meal. The usual drink was water. High fire risk in the crowded tenement houses kept cooking methods at a primitive minimum and was avoided whenever possible. Figs, cheese (an interesting combination), olives and dried or salt preserved foods were good substitutes (have you priced any prosciutto lately?). The situation changed dramatically with the more affluent or wealthy, or so called "nouveaux riche." This was especially noticeable during the height of Rome's greatest glory. No part of Roman life escaped eastern influences, but food and cooking seemed to be most affected. Simple meals among friends grew into exotic banquets. Plain and simple dishes now became highly involved and extravagant creations. Cooks showed their artistry by creating fantastic and at times

incredible culinary concoctions. It was in the homes of the wealthy that the dining room (triclinium) was no longer reserved for simple family meals, but became a circus for acrobats and

Throughout this classical period, breakfast, lunch and dinner as we know them were called "jentaculum, prandium and cena." Both jentaculum and prandium were simple meals for all classes. The jentaculum varied from only a glass of water in some instances to porridge, bread, cheese and sometimes a watered down wine which even today bears the name of "sciacquare." Prandium varied from a simple piece of bread to the more nourishing accompaniment of cold meat, vegetables and fruits, washed down with (you guessed it) a

little wine. Both jentaculum and prandium were meals that were taken without ceremony and in any room of the house that might be convenient. The main event was the cena, the serious evening meal. In all of Roman life there seemed to be one common attitude toward the cena; it was always eaten after the work of the day was done, it was always eaten in the "triclinium" and it was always the most important meal of the day.

Speaker DeLeo to be Honored

with MBA Legislator of the Year Award at Annual Dinner

Winthrop resident and House Speaker Robert A. DeLeo will be presented with the 2012 Legislator of the Year Award at the Massachusetts Bar Association's Annual Dinner on May 31 at the Westin Boston Waterfront. The dinner will also include a keynote address from Victoria Reggie Kennedy and the distribution of the Annual Access to Justice Awards.

"Speaker DeLeo is to be lauded for his commitment to court management reform, of which he has been a true leader. Massachusetts could never have achieved these historic reforms without his vision," MBA President Richard P. Campbell said. "The MBA is grateful for all the hard work he put into this issue of critical importance to the citizens of the commonwealth.'

"I am honored that the Massachusetts Bar Association has chosen to recognize me as the Legislator of the Year," DeLeo said. "I'd be remiss to not share this honor with my colleagues in the House of Representatives, however. This award is so special for all of the members, as we in the House have worked so hard over the past year to create and pass legislation that makes the Massachusetts court system more efficient."

In April 2011, DeLeo filed landmark legislation, in collaboration with the Supreme Judicial Court, which overhauled court management. The bill, signed into law last August, included the creation of a civilian court administrator. The reforms were in line with recommendations in MBA reports from 1976, 1991 and 2003.

DeLeo will be honored for this achievement, his ability to join groups often on opposing sides and a long history of working to ad-

lation. This is DeLeo's second time receiving the honor; the first came in 1998 for his support of guardianship legislation.

The MBA Legislator of the Year Award is presented annually to a state or federal legislator who has distinguished him or herself in public service through outstanding contributions to the legal profession, courts and the administration of justice.

DeLeo was elected to the House of Representatives in November 1990 and has served as chair of House Ways and Means. A graduate of Suffolk University Law School, he is a past member of the Winthrop Democratic Town Committee and Winthrop Board of Selectmen



SAD DOG TALE FOR WWII VET

Because his two dogs violate the recently-instituted pet policy of 25 pounds per dog, a 91-year-old disabled, decorated World War II veteran is being evicted in a few

JJ Smith supposedly was protected by the "grandfather clause" for the past several years at Granada Highlands in Malden. He moved there 12 years ago precisely because they accepted dogs of all sizes.

That's what previous management told him repeatedly. Just days before his eviction notice, Smith had received a renewal lease. Puzzled, he was told that the 1,000-unit hilltop community has a weight limit per dog of 25 pounds. His Labrador and German Shepherd, 11 and 4 respectively, each weighs about 70 pounds.

Smith flew 26 missions as a ball turett gunner on a B-17 Flying Fortress with the Eighth Air Force over Nazi Germany. His pilot was his Watertown childhood friend, the late Malden auto dealer Wilfred J. Smyly.

Each earned an Air Medal with four oak leaf clusters, three battle stars, and other awards.

"People often say, "Thanks for your service!" when they see my wartime service cap, he said. "Apparently, my dogs extra weight outweighs my five years of wartime service."

Ironically, Smith noted that some 40 years ago, when he was the daily "Hub-Bub" columnist for the former Boston Herald Traveller, he raised funds in two days for a needed new cage for two homeless mountain lion cubs at the Franklin Park Zoo. "I'm not looking for funds — just a threebedroom apartment or house to rent that accepts dogs. This situation is more stressful than combat or when I was backup goalie for Boston University's first great hockey team in 1947-48 when we had the best winning percentage in Terrier hockey for 32 years between 1919 and 1951." he said.

"I've had dogs for 88 years and none were ever destructive inside or out of the house", he said.

Smith, his two daughters, one also disabled, thus far have been unable to find a place for the family and pets.

"I'm not abandoning my dogs, they're family." the retired combat vet said.

"Apparently, I'm supposed to be more angry about what Mitt Romney does with his money than what Barack Obama does with mine."

Family gatherings and spending time with family was her favorite pasttime. She also enjoyed reading her prayers, taking walks and bingo.



Salvatore Ferragamo (b.1898 - d.1960)

To many of us shoes are just a means to prevent hurting our toes or providing a cover for our feet. But, for others it is fashionable to wear and be seen wearing a well made shoe. For fashion and a well made shoe you have to look to the leader. In that regard you have to consider Salvatore Ferragamo. shoes are known and worn throughout the world.

Salvatore Ferragamo was born in Bonito, a town near Avellino Italy, on June 5, 1898, the eleventh of fourteen children. He was married to Wanda Miletti and had six children, Fiamma, Giovanna, Ferruccio, Fulvia, Leonardo and Massimo. He made his first pair of shoes at the age of nine for his sister who was going to make her confirmation. His desire and passion for shoes led him to study shoemaking in Naples. After completing his schooling he opened a small store in the family home. At the young age of 16 he joined his brother in Boston, Massachusetts, where his brother was working in a cowboy boot factory. It probably did not take much convincing on his part for they moved to Santa Barbara and then on to Hollywood, California. Here he opened a shoe shop for repairs and handmade shoes and soon was making shoes for celebrities and designing shoes for the movies. He designed the red shoes that Judy Garland wears in the Wizard

of Oz. His designs of shoes were sold in stores such as Gimbel's and Saks Fifth Avenue. But he had a small problem, in that the shoes looked good but some complained that their feet hurt. This led him to study anatomy at the University of Southern California.

Ferragamo returned to Florence, Italy in 1927 making shoes for some of the wealthiest and powerful women, such as Eva Peron and Marylin Monroe. His shop was located on the Via Mannelli and from here he experimented with designs, applying for patents for ornamental and utility models. When 1933 rolled around Ferragamo filed for bankruptcy due to bad management and the economy. He continued growing his company and during the 1950s his employees numbered about 700 expert personnel that were capable of manufacturing 350 pairs of handmade shoes a day. His designs ranged from "objet d'Art" to the traditional and elegant. In 1936 he invented the wedge heel and went on to design platform soles and metal support in high heels. Due to material restrictions, he experimented with other materials including cork, Manila hemp, needlepoint lace and others. It may be hard to believe but he created over 20,000 styles in his lifetime and has 350 pat-

ents. He also invented the invisible shoe made of nylon and a black heel. His most famous invention was the "Cage Heel."

Ferragamo died August 7, 1960, in Fiumetto, Italy, he was 62 years old. After his death, his wife Wanda ran the company. His six children would later take part in running the company. ing may well end up in federal court and possibly even up to the U.S. Supreme Court when he ruled a woman who cashed a \$1 million lottery ticket may have to give up the money to another woman who threw the ticket in a waste container outside a convenience store. The judge decided that Sharon Duncan was entitled to the winnings and not Sharon Jones who claimed the lottery money after finding the ticket in a trash bin of discarded tickets.

Jones' lawyer immediately said he would appeal the judge's decision, as he should. Jones' lawyer noted that Duncan testified in the courtroom that she threw the ticket away and should such people then be allowed to throw items away and then reclaim the item after it proves to be valuable? Can Duncan say, as the lawyer stated, that she wanted to "un-abandon it." Don't things become trash when someone throws it away?

The judge in the case, White County Judge Thomas Hughes found that Jones did not meet the burden of proof that Duncan abandoned her claim to the ticket. Jones found the ticket in the trash, what more proof did she need to get the winnings? The judge, however, said, "The \$1 million was never found money." How can he say that with a straight

Duncan's lawyer argued that his client made a mistake by throwing the ticket away but that the ticket still belonged to her after it fell into the waste container. If that logic stands, as a police officer, I think it will have dire consequences. How often do we hear of police finding incriminating evidence

An Arkansas judge's rul- in barrels placed on the sidewalk of a suspect's home on garbage day that led to the prosecution of the suspect at trial? Criminal defense lawyers have come to assume that once someone abandons their property, it becomes free game for anyone, including law enforcement. Courts always rule in these cases that 4th amendment rights were not violated and the subsequent search of the barrels is seen as being a legal search and seizure. If this little case of a lottery ticket down in the Town of Beebe, just 40 miles from Little Rock is upheld, you can bet every criminal defense attorney in the nation will start using this case for their clients too. Lots of unintended consequences are

I often buy lottery tickets, sometimes at Steve's Market on Smith Street in North Attleboro. Steve's, like most convenience stores, has a barrel outside by the door for discarded tickets. I always assumed everything placed in that bin was garbage belonging to no one any longer. Abandoned property, once abandoned, can't really be reclaimed unless of course you dig down inside the bin yourself to get it.

If the state lottery commission in Arkansas saw no good reason not to give the \$1 million prize to the person holding the winning ticket she had. They gave her the money. She didn't steal the ticket from anyone; she simply found it in the trash.

Bottom line for me? I'm not going to throw quickly away any lottery tickets outside the place where I purchased them any longer. I'll carry a magnifying glass with me at all times.





Saint Godric of Finchdale-Hermit

Godric was born of very poor parents about the year 1065 at Walpole in Norfolk, England. In his youth, he became a peddler selling his wares in the surrounding villages; he later took to the sea becoming a prosperous trader. Godric made trips to Scotland, Flanders and Scandinavia. It was on one of his visits to Scotland that he visited the Holy Island of Lindisfarne where he was impressed with the religious deportment of the monks and the accounts of the holy life of Saint Cuthbert, the seventh century Bishop of Lindisfarne. Inspired by Saint Cuthbert, Godric resolved to imitate the religious fervor of the great saint and to give up all earthly pretensions. He then embarked upon pilgrimages to Saint Andrew's in Scotland; he also went to Jerusalem and Compostella, Spain.

Upon his return to Norfolk. Godric, for a brief time, became steward to a rich household but due to the injustices perpetrated by the landowner on his neighbors; Godric left his employ for away in 1170.

After completing his pilgrimage, Godric went to the north of England to live a life of a hermit; it was there that he met an old monk and recluse by the name of Goodwin, who for two years taught him the ways of monastic interior life.

In 1110 Godric went to Finchdale where he retired to a little hut, there he lived the austere life of a hermit practicing and offering spiritual advice to all who visited him for the rest of his life. He chose St. John the Baptist and St. Cuthbert for his patrons and models.

It is believed that Godric was one of the early known lyrical poets in English, four holy songs composed by him have come down to us, remarkably he was untrained in music. Godric passed



In 2005 Daniele released Iguana Café. Between 2005 and 2010. Daniele released three more studio albums: Il Mio Nome e Pino Daniele e Vivo Qui. Ricomincio da 30 and Electric Jam. In 2010, Daniele released his 13th studio album, Boogie Boogie Man.

The book begins with crucial building-block basics such as semolina pasta dough, tomato sauce and chicken broth before moving on to regional dishes such as broccoli tortellini with white sausage ragu from Tuscany, fried spaghetti nests with prosciutto and scamorza from Molisse and grilled meatballs with bay leaves and lemon from Sicily. What delicious reading!

Another Kennedy book! "Mrs. Kennedy and Me: An Intimate Memoir," by Clint Hill with Lisa McCubbin. In brief, in November 1960, Hill, who had been on President Eisenhower's Secret Service detail, wasn't looking forward to his new assignment which he viewed as a demotion — of protecting Jacqueline Kennedy. Broiled or Baked HADDOCK ALLA SICILIANA

Broiled Haddock Sicilian Style

- 1 pound haddock fillet 1 medium onion
- 1 large chopped garlic clove or garlic powder
- 2 fresh tomatoes
- 1 tablespoon oregano flakes
- 1 or 2 tablespoons grated Romano cheese (optional)2 tablespoons olive, canola, or vegetable oil
- Salt and pepper


Spread some oil on bottom of a broiling tray or baking pan. Place haddock fillet skin down on tray or baking pan. Cut tomatoes into ¼-inch slices and place over haddock fillet. Cut onion in ¼-inch slices and layer over tomato. Sprinkle oregano, salt and pepper to taste over onion. Spread chopped garlic, or garlic powder, over contents. (Optional) sprinkle grated cheese over contents. Next, sprinkle oil of choice over all. Cover and place at least two inches below broiling coils. Broil for about fifteen minutes. Remove from broiler. If dry, add a small amount of water. Cover and return to broil for about ten minutes. Remove from oven. Baste haddock with the liquids that accumulate in the broiling tray or baking pan. Return uncovered and brown onions and tomato. Check frequently to prevent burning or drying out.


*Cooking time for the haddock fillet depends on the thickness of the fillet.

NOTE: When Mama prepared this meal, I remember enjoying the fragrances of garlic, tomato, oregano and broiling fish that spread throughout the kitchen. Mama liked adding some Romano grated cheese occasionally over the contents. She referred to this meal as "Haddock alla Pizzaiola."

As the haddock cooked, I checked to be sure that we had plenty of bread available at home. I enjoyed dunking my bread in the juices while eating the broiled fish, and I still do.

Nanna & Babbononno

A Nostalgic Remembrance

This column begins year 22 and I thought I would satisfy several requests I have received from readers. I will look back at my first column and write about my grandparents coming to America. Actually, they came at different times and under different circumstances, with a chance meeting that began part of my family in America.

Babbononno was born Michele Contini in Foggia, Italia in February of 1875. His father, Angelo, passed away when Babbononno was just a child and it left his mother, Maria, to bring up her children. I'm not sure, but I believe my grandfather had two or three brothers. Michele was an unruly child with a mind of his own and lacking in discipline. As a result, my great grandmother sent him to the local priest to learn a trade before he got himself into trouble. The priest to whom Michele was assigned at their parish soon discovered hidden talents in the young child. His new charge was good at using the tools that created original and period pieces furniture. The man of the cloth also discovered that this wild child had a flair for music and he taught him how to play drums and gui-

Michele was soon under control and concentrated on making things out of wood and playing music ... guitar for dancing and drums for marching. As was the case back in the day in Italy, he was married while still in his teens and soon had a child to support. Unable to make enough money for a way of life that was better than his own past, he joined the Italian marines as a musician. The number one marine band often toured the European world serenading the leaders of the different allied countries of Italy. There was an annual tradition that this band had adhered to since the presidency of Thomas Jefferson. Washington, D.C., and ser- years later. enade the folks at the White House. In 1896, Michele Contini was a drummer in that band.

While the band was playing in Washington, my grandfather received a transatlantic cable from the Reuter's Service. It was bad news. His teenage wife had passed away in childbirth.

The baby, who would be and pay their way to named Paolo, was okay and was being taken care of by great grandmother. Michele was devastated and became very depressed. When the tour ended and the band was ready to return to Italy, Babbononno resigned his commission and stayed in America. Washington was not the place for an immigrant who didn't speak a word of English. He heard that there was an Italian population in New Orleans and he headed there only to find that the discrimination against his people was so severe that, after the assassination of a mayor, the population blamed the Italians and either were shooting at them in the streets of the city or capturing them and hanging them vigilante style.

Michele next headed for New York City. It proved too big, too noisy and too crowded for him in spite of a sizable and growing Italian population. He next tried Portland, Maine. Back then, that city was an outpost of civilization and he soon left for a city just to the south, called Boston. He, somehow, wound up in the North End and while having lunch in a Hanover Street restaurant, met a fellow Italian named Antonio Ceruolo. The two men hit it off and Michele asked if he, Antonio, knew where he could get a room. It just so happened that his new found friend and several other men had an apartment on Salem Street. Fortunately, one of the men had just moved out and my grandfather was asked if he would like to take his place. He said yes and within days, was out hunting for work with the aid of his new friend, Antonio. Before long, Michele was playing guitar with a local band that specialized in Neapolitan dance music. He also joined a marching band called the Italian Marine Band in America as the drummer. > Antonio was a plasterer by trade. He had a talent for carving his dried plaster into beautiful scroll work on ceilings, cornices and circular bases of chandeliers. As a result of his talents, he did rather well financially. As a result, when he had enough money saved, he would send for members of his family

America. He did this for all of his brothers and sisters, except one, who was married with children and had decided to stay in Italy. One of his sisters who was on the list to come to America was one of the youngest of his siblings, Giovannina. When Babbononno saw the picture of his buddy's next family import, he was smitten with what he saw. When she arrived, she came through Ellis Island and Michele and Antonio headed to New York to intercept her.

Michele soon expressed interest in his friend's youngest sister. I guess the picture didn't lie. Even though Antonio was now his best friend, he was skeptical regarding a musician dating his sister. Antonio had a lady friend, Maria, whom everyone called, Mariaucchia. They were the first to be married and when they were, bought a large multi-apartment house on Orleans Street in East Boston. Soon, Michele and Giovannina were married too and rented one of the apartments in Antonio's building. As part of the practice of Americanization, my grandparents changed their names from Michele and Giovannina to Michael and

My grandmother worked before her first child was born. She did hand stitching and found work detailing men's suits for a tailor. With Babbononno working days and playing music nights, the three incomes helped out in what could have been rough times for two people trying to make it in America.

At work, Jenny heard rumors that her husband had a wife and two kids in Italy. One day, she confronted her husband. Tiring of the gossip, she decided to bring things out in the open and see if they were true or not. Babbononno confessed that he did have two children. who were back in Italy, but his wife was dead and his mother was bringing up the children. My grandmother thought things out, headed for her money hidden in the sugar bowl, gave her husband what she had saved and said that his children belonged with their father in America and told him to send for them. At the same time, Jenny was pregnant. It would be a girl named Angelina and she would become my mother.





SUFFOLK DOWNS' 2012

Live Racing Season Begins Saturday, June 2

NBC's Voice of the Triple Crown Larry Collmus Returns for Guest Appearance on Opening Day

Suffolk Downs will open its 2012 live racing season on Saturday, June 2 with a guest appearance by NBC's voice of the Triple Crown Larry Collmus, who served as track announcer at the East Boston oval from 1992-2008, the track announced today as it introduced its racing schedule and other plans for the upcoming season.

Collmus, who last Saturday called his second Kentucky Derby for NBC, will return to the Suffolk Downs announcer's booth for the first time since 2008 to call a few races on the Opening Day program. He will also be available for a meet and greet with fans. T.D. Thornton returns for his fifth full year as track announcer after previously splitting time with Collmus.

Opening Day will be followed by a pair of three-day race weeks (Monday, Wednesday and Saturday) before adding Tuesdays to create a four-day schedule through the end of September. As of October 1, the schedule would return to a three-day week through the conclusion of the meet on Monday, October 29. As it did last year, the track is awaiting approval of legislation to reduce the number of racing days required to offer simulcasting from 100 to 80. This proposal was reported out of committee favorably on Thursday, May 3.

Earlier this month, Suffolk Downs reached an agreement with the New England HBPA to maintain a minimum of \$8.25 million in purses, ensuring daily overnight purses of \$103,125, the same as last year.

"We look forward to the 2012 racing season and having Larry return to help us kick it off," said Chip Tuttle, Suffolk Downs' Chief Operating Officer. "As we continue to pursue the development of a world-class gaming and entertainment resort, we remain committed to offering a racing program that is attractive to fans and financially rewarding to our horsemen."

"Our negotiations with track management this offseason were very productive and we are very excited about the upcoming meet," said Anthony Spadea, President of the New England HBPA. "We remain optimistic about the future of racing at Suffolk Downs and we look forward to continuing to work together toward our common goal of sustaining the racing industry and the positive impact it has on the agricultural community in this state."

Suffolk Downs will continue to honor individuals and groups who have made a positive impact in the local community through its "Community Winner's Circle" program. On Opening Day, the track will recognize Paul Antonino of Wakefield, who on April 1 entered a burning building on Chelsea St. in East Boston to alert residents of a fire that was raging above them and assist elderly residents in escaping the building safely. The track will also recognize Generations Incorporated for its programs in East Boston and Revere in which older adults volunteer their time to assist children in need of literacy tutoring.



HOOPS and HOCKEY in the HUB

For a person known for his voice he was honored in a singular way—with the sound of silence.

That was how those present in the media dining room at the TD Garden showed their respect for Carl Beane during the ceremony honoring his life that took place at Fenway Park on May

The dining room is usually alive with the sounds of various conversations as media members chat with one another in a pre-game ritual that is as traditional as anything at the Garden.

But now, as the appointed time approached, a quiet came over those gathered. It was respectful and dignified. Indeed, it was as close to a sacred moment as one perhaps would ever witness in that particular place. As the large high definition television screen focused on Fenway, each person reflected on the Carl Beane they had known for many years.

It was as if two venues, the Fenway Park media area and the Garden media setting were joined, rather than being a few miles apart.

And why not? For it was their relationship with Carl Beane that joined everyone together.

Carl, known far and wide as the Voice of Fenway Park in the final decade of his life when he served as the public address announcer there, had a much longer career in radio before he ever got behind the microphone high above home plate. And it was through that career that all members of the Boston sports media came to know Carl.

You see, Carl was one of the few media members to hold credentials to all the major sports teams in the Boston market—the Red Sox, Patriots, Bruins and Celtics plus Boston College football. Thus, if someone covered only one team-say the Bruins-he or she knew Carl and Carl knew that person. Thus, by covering all five teams Carl knew everyone-media members, players, coaches and front office executives.

For more than three decades Carl worked long hours gathering sound bites via traditional tape recorders and later with digital devices that he would package into short summaries complete with his own audio descriptions before sending them to a variety of stations.

It had started with several stations in his native Western Massachusetts and had later expanded throughout New England and beyond. Eventually, he came to service national outlets. One Christmas season I recall hearing Carl while visiting relatives in Wisconsin.

And it required long hours. When David Ortiz hit his famous home run to defeat the Yankees in 2004 the blast came about 1:15 a.m. Carl then set what is believed to member who was the last to indeed had died at home.

leave the venue of a night game. What time did Carl leave Fenway? At 6 a.m.

Your correspondent came to know Carl initially through mutual geography, both of us having been born and raised in Western Massachusetts about eight miles apart. Carl loved his home area, living his entire life in Hampden County — first in Agawam, then in Ware and later in the town of Holland. And all his life Carl loved local radio. He could cover the Patriots one weekend and then do play-by-play for the annual Palmer - Ware Thanksgiving Day game five days later. He could cover the Celtics one night and be in a small Western Massachusetts gym the next calling small town high school basketball. The day he died he had filled in on the morning show at a small radio station near where he lived.

And yes, it was a long drive out to the Sturbridge exit on the Mass. Pike before you got off and went down some local roads. But Carl didn't seem to mind. There was a time in his career when he would cover an event at the Garden, drive home for 3 to 4 hours sleep and then get up and drive to Hartford where he would be on the air in the morning.

And Carl maintained fast friendships with those who had a similar calling, shall we say. One of the ones he valued most was that of Bob Sheppard, the iconic public address announcer at Yankee Stadium for more than half a century. Carl usually visited the Stadium at least once a season and followed up with phone calls throughout the year. I remember when he related how Bob could not come to the closing of the old Yankee Stadium because of health reasons so the Yankees had him tape the lineup introductions at his Long Island home. Bob would be granted a much longer life than Carl, living to be 99. Carl passed on at age 59.

In addition, Carl usually visited at least one new baseball stadium per year, creating an interesting juxtaposition—the announcer from the oldest facility in the game visiting with those who plied their trade at the newest.

Maybe there was some symbolism in Carl's passing. Identified so strongly with baseball, a game that features nine innings and nine players per side, he died on May 9. In addition, he died a good distance away from the bright lights of the city that fostered his career, driving alone on a lightly traveled country road on a spring day alive with the rebirth of nature near that small town of Holland. In a way, sudden and tragic though his death was by a heart attack, Carl died where most would want to be when the final call comes. Born in Hampden County and living within its borders be the record for a media his entire life, Carl Beane
