Memorial Day Brings Less Masking For All Of Us

Federal health authorities (CDC) last week cleared the way for Americans who are fully vaccinated against the coronavirus to drop mask wearing in most situations. Some states have already lifted the mask mandates, others are now following suit. Free at last, free at last! Thank God Almighty free at last!

"We have all longed for this moment," Dr. Rochelle P. Walensky, CDC Director stated at a White House press conference, "If you are fully vaccinated you can start doing things that you had stopped doing because of the pandemic."

Governor Charlie Baker announced on Monday, May 17th that the new CDC guidance will allow vaccinated folks to lift their veils starting on Saturday, May 29th Memorial Day Weekend, but still follow local laws or regulations and business establishments can still require masking if any so wish.

Black Mom Compares Critical Race Theory in School To Ku Klux Klan Tactics

A Black mom took aim at Critical Race Theory during a local school board meeting comparing the educational tactics with those used by Nazi Germany and the Klan. "Critical Race Theory is not an honest dialogue, it is a tactic that was used by Hitler and the Ku Klux Klan on slavery many years ago to dumb down my ancestors so we could not think for ourselves," Shawntel Cooper said at the Loundoun County, VA School Board meeting on May 11th, "Critical Race Theory is racist, it is abusive, it discriminates against one's color … You can not tell me what is or is not racist."

This fiery rebuke came as parents at the district

Baker-Polito Administration to Lift COVID Restrictions May 29th

State to Meet Vaccination Goal by Beginning of June Commonwealth Will Adopt CDC Face Covering Guidance

On Monday, the Baker-Polito Administration announced that the Commonwealth is on track to meet the goal of vaccinating 4.1 million residents by the first week of June and all remaining COVID-19 restrictions will be lifted effective May 29th.

The Commonwealth's face covering order will also be rescinded on May 29th. The Department of Public Health will issue a new face covering advisory consistent with the Centers for Disease Control and Prevention's updated guidance. Face coverings will still be mandatory for all individuals on public and private transportation systems (including rideshares, livery, taxi,


ferries, MBTA, Commuter Rail and transportation stations), in healthcare facilities and in other settings hosting vulnerable populations, such as congregate care settings.

Governor Charlie Baker will end the State of Emergency June 15th.

The Administration also announced updates that will be effective May 18th to revise face covering requirements for youth and amateur sports and other guidance relating to childcare programs and K-12 schools. The Administration will release updated guidance for summer camps effective May 29th.

The Administration is able to take these steps to reopen the Commonwealth's economy because Massachusetts is on track to meet the goal set in December to fully vaccinate over 4 million individuals by the first week of June. The Commonwealth leads the nation in vaccinating residents, with 75% of adults receiving at least one dose. To date, over 4 million residents have received a first dose, with 3.2 million fully vaccinated.

New cases have dropped by 89% since January 8th. COVID hospitalizations are down 88% since January 1st and the positive test rate is down by 88% from peaking at 8.7% on January 1st to 1% today.



Effective May 29th

Effective May 29th, all industries will be permitted to open. With the exception of remaining face-covering requirements for public and private transportation systems and facilities housing vulnerable populations, all industry restrictions will be lifted, and capacity will increase to 100% for all industries. The gathering limit will be rescinded.

All industries will be encouraged to follow CDC guidance for cleaning and hygiene protocols.

On May 18, 2020, the Administration published the reopening phases, which called for ending restrictions when vaccines became widely available. Today, there are over 975 locations for Massachusetts residents to access vaccines without delay.

Face Covering Guidance

In line with updated CDC face covering guidance, the Administration will rescind the current face covering order and issue a new face covering advisory effective May 29th.

Non-vaccinated individuals are advised to continue wearing face masks and to continue distancing in most settings. The advisory will also recommend fully vaccinated individuals no longer need to wear a face covering or social distance indoors

or outdoors except for in certain situations.

Face coverings will still be required for all individuals on public and private transportation (including rideshares, livery, taxi, ferries, MBTA, Commuter Rail and transportation stations), healthcare facilities and providers, congregate care settings and health and rehabilitative day services.

Face coverings will also remain required indoors for staff and students of K-12 schools and early education providers.

Youth and Amateur Sports Face Covering Guidance

Effective May 18th, the youth and amateur sports guidance will be updated to no longer require face coverings for youth athletes 18 and under

youth athletes 18 and under while playing outdoor sports. Effective May 29th, all youth and amateur sports restrictions will be lifted.

K-12, Early Education and Summer Camp Guidance

Effective May 18th, guidance from the Department of Elementary and Secondary Education and the Department of Early Education and Care will be updated to no longer require masks for outdoor activities like recess and to allow for the sharing of objects in classrooms, in both K-12 and childcare settings. This guidance will remain in effect beyond May 29th.

The Administration will release updated guidance for summer camps, effective May 29th, which will include no longer requiring masks for outdoor activities.

State of Emergency Order

Governor Baker will end the State of Emergency June 15th, and the Administration will work with legislative and municipal partners during this period in order to manage an orderly transition from emergency measures adopted by executive order and special legislation during the period of the State of Emergency.

THE GOTHIC SYSTEM

Gothic architecture was born during the $12^{\rm th}$ century civilization of France. It evolved from the Romanesque-style, of which it was a natural outgrowth. The style is semi-technically defined as a system of vaults, supports, and buttresses, strong enough to bear the crushing weight of the roof. The stability of the structure was maintained chiefly by an equilibrium of counterthrusts.

A few fast explanations are in order at this time. Arches and vaults are in the same family. A true arch or vault exerts a sidewise push called a thrust. When sitting in a church facing the altar, the openings on either side, which are spanned by arch-type construction, are properly called arches. Arch construction, which spans from the left side over the right side, is called a vault. Vaults may run straight across or they may run diagonally. Diagonal vaulting that divides a ceiling into four parts is called "quadripartite" vaulting, and if the division is in six parts, it is called "sexpartite vaulting." If I support a wall by standing tight against it, I am buttressing the wall. If I stand away from the wall and push against it with my arm extended, then my arm becomes a flying buttress.

The 13th century in France was an age of religious enthusiasm. It brought about the construction of about 80 cathedrals and 500 churches. A religious fervor swept the country as cities competed with each other to build the largest and most lofty churches, while people gave money, labor, or food.

Gothic architecture in Europe is sometimes called "Christian Pointed Architecture." It started in the area known as the "Ille de France" and then spread throughout the rest of France and into England, Germany, Italy, and Spain. One of the problems that developed with the use of round arches and vaults was that those with varying trajectories exerted varying degrees of thrust. Pointed arches can be brought to any desired height without increasing the thrust, and this was a major factor in the development of the Gothic system.

Three of the major characteristics of Gothic churches may now be listed as the employment of: 1. pointed arches; 2. high vaulted ceilings; and 3. flying buttresses.

Buy American!

Recently a reader sent me an article clipped from the March, 2021, issue of National Defense magazine on one of my favorite topics — Made in U.S.A. — specifically as it relates to an Executive Order of President Biden's strengthening the Buy America requirements for U.S. government procurement.

U.S. manufacturers welcome any action on the part of President Biden to



promote U.S. manufacturing. Establishing a Made in America Office within the Office of Management and Budget and giving it oversight of waivers from Buy American requirements is a good step. It follows on President Trump's executive order which strengthened Buy American requirements. The Buy American Act gives a preference to articles made in America of components "substantially all produced in the United States." However, the executive branch long construed "substantially all" to mean at least 50%. President Trump raised that to 55%. The Buy American Act encourages the use of domestic products by imposing a price preference for domestic products. President Trump increased the price preference from 6 percent to 20 percent for large businesses and from 12 percent to 30 percent for small businesses.

However, the Buy American Act, alone, cannot save U.S. manufacturing. The Buy American statute is waived in situations where the United States has reciprocal trade agreements, including the World Trade Organization Government Procurement Agreement. That's a long list of countries — nearly 50 — for which it is waived. Since the 1990s the U.S. has severely limited our own ability to give a preference to domestic manufacturing in government procurement as we have opened government procurement to foreign competition. In return, those nations have opened their government procurement to us.

Additionally, contracts awarded by State and local authorities under Federal grant programs are not covered by the act unless authorizing statutes explicitly provide for application of the act.

What is needed is government policies, such as tax policies and other incentives to make things in America. So, I'll be watching to see what the 117th Congress and the Biden Administration do in the areas of taxation and manufacturing incentives. One thing that causes concern is President Biden's energy policy. The resurgence in U.S. manufacturing over the past decade was driven, in part, by relatively low energy costs and reliable energy.

President Trump's imposition of tariffs on China was long-overdue, and I am pleased to hear that President Biden does not plan to remove them soon. Certainly, President Biden's position on how to respond to China will be different — more likely to work with Congress, with our trading partners, and with the World Trade Organization — but I do not see him allowing America to return to a pattern of letting China get away with not fulfilling its WTO commitments.

Aside from government contracting for goods for purchase by the general public, there are Federal Trade Commission rules regarding use of the phrase "Made in USA." They require more than mere final assembly in the U.S., and require substantially all content be American. If you make merchandise in the U.S. and want to say, "Made in USA," you need to consult those rules. I provide a Made in USA certification service.

THE MONTH OF MAY IN CHARLESTOWN HISTORY

It is hard to believe that we just passed the 40th anniversary of the People's Firehouse #2 when Townies were resolved not to let City Hall close the Winthrop Street Firehouse and deactivate the Engine 50 apparatus. The neighborhood began to occupy the firehouse on April 10, 1981, and it ended on May 8, 1981. It only took a month for the city to relent and reopen the house and reactive Engine Company 50.

As a member of the People's Firehouse Committee, that occupation showed people could beat City Hall, but it took both words and actions to make it happen. Many members of the People's Firehouse have passed over these past 40 years and those of us who remain will always know we did what we had to do. Today, 40 years later, not only is the firehouse still open and functional, it has also had major infrastructural improvements to the firehouse as well.

Also, another anniversary just passed. Fiftynine years ago on May 10, 1962, Charlestown witnessed the near total destruction of the old Charlestown Potato Sheds, which was hit with a 7-alarm fire with smoke from the blaze seen for miles around during the afternoon rush hour that day.

Both of these stories have a connection through me and my family. I was part of the People's Firehouse Committee in 1981, and my Uncle Jim Callahan owned one of those Potato Sheds that went up in flames in 1962. Two sheds nearest the Prison Point Bridge were saved, his was one of them. He hung in there a few more years before calling it quits.

These two events are part of Charlestown's long history. The Charlestown City Seal has a motto written in it, "Liberty - A Trust to be Transmitted to Posterity." I would like to add, "History Transmitted to Posterity, Too."

Free and open to the public from Memorial Day weekend through November 2021

The Boston Camera Club this week announced The Focused Eye: Our Unique Views, an outdoor photography exhibition on the Public Green at Fan Pier in Boston's bustling Seaport District. Spanning an entire city block at Northern Avenue and Marina Park Drive, the photo banner exhibition will run from Memorial Day weekend through November 2021.

For the first time in the club's history, the imagery of BCC members will be on display outdoors in an immersive exhibition featuring 88 images printed on a large-scale banner, 5-feet high and 250-feet long. One image from each participating member's submissions was selected, and expertly sequenced by curator Emily Belz. Each image speaks to the next by subject, color, composition or use of light to form a bridge, creating a compelling visual experience, honoring each individual's view as well as that of the collective whole.

"It's a joyful experience for me to curate connections between photographs, pulling out what are sometimes obvious, sometimes hidden, and sometimes even humorous, parallels between pictures," said Belz. "Indeed, in this installation each photographer presents a Unique View and a meaningful contribution to this collective public art project," she added.

This project has a companion website: www. BostonCameraClub.photos, featuring an artist statement from each photographer and creative contributions from community groups from across the greater Boston area, including: Actors' Shakespeare Project; Boston Latin Academy Photography Club; Boston Latin Academy 7th Grade English Language Arts class; Mission Hill Women's Writing Group; Never Too Late to be a Poet; Rehearsal for Life; and ZUMIX.

Participants from these organizations contributed poems, prose, audio, video, and artwork in response to the exhibition's photographs. All

viewers of the banner and website are encouraged to share their own reactions on social media using the hashtag #BCCPHOTOBANNER.

"The community partner collaborations enhance the viewing of the individual images as does the professional sequencing of photographs on the banner," said Boston Camera Club President Tom Hill, who noted that the project was entirely conceived and developed by club members. "Collaboration with these community groups has built bridges among artists of all ages who would not otherwise have had opportunities to connect within the greater-Boston community. The timing of the exhibition could not be better and will supplement the diversity of outdoor art in Boston at a time when residents, workers, and visitors are breaking out of their pandemic cocoons."

L'Anno Bello: A Year in Italian Folklore Pentecost and an Appreciation for the Natural World

Around this time of the year, when delicate spring gently gives way to the heat of summer, I feel the pull of nature calling me. The trees have erupted in full bloom, and whenever I look up through their branches, I see a bright mosaic of lacy green leaves silhouetted against the sunlight. Since the days are now longer, evening falls softly with a dusty glow, reminding me of dinners eaten outdoors watching the sunset. Yes, this is the time of the year when I want to spend as much time out in nature as possible. My husband and I often take walks in a state park near my town, reveling in the shady trees, the burbling waters of the streams, and the miniscule flowers dotting the meadows. Even just walking to my mailbox on a warm and sunny day, watching the birds dart in and out of the bushes, is enough to lift my mood. This desire to return to nature has roots in a deep and universal longing, so much so that many May holidays around the world encourage celebrations in the outdoors.

When I was in Italy with my family years ago, some of my most vivid memories recall places of natural beauty, along with the lovely human interactions they enabled. Our first stop was Milan, and we stayed at a small inn nestled on an old side road. I remember stepping into the hotel's courtyard, which blossomed with wild trees and colorful bunches of flowers. A worn statue of a Roman goddess peeked out from the foliage, making me feel as if I had stepped through a lookingglass into days long past. A friendly group of Japanese girls

In Rome, my family wandered into a secluded area of some ancient ruins, where, far removed from the bustle of the busy city, we heard only the sound of the breeze fluttering through trees and chirping birds. Until we started talking to two jovial college-aged brothers from Colorado, I could not shake the sensation that the breeze and the birds were really spirits of antiquity announcing their presence. The latter half of my trip to Italy was spent in my father's hometown of Sulmona in Abruzzi, a bucolic hamlet of rolling hills, braying sheep, and expansive meadows. It felt more like the real Italy than other places that cater exclusively to

The holiday of Pentecost falls on Sunday, May 23rd, and Italians will spend this important Christian feast day incorporating rituals from the outdoors. Pentecost is part of the Easter festivities, occurring on the seventh Sunday after Easter, and it celebrates the descent of the Holy Spirit upon the disciples of Jesus. Some Italians refer to this feast as Pasqua Rossa, meaning Red Easter, due to the red vestments clergy wear in honor of the Holy Spirit. Many Italian churches scatter rose petals from the ceiling on this holiday, bringing the ubiquitous flowers of May into the celebration, as a way to commemorate the Holy Spirit descending on the disciples. In England, Pentecost Sunday is known as Whitsunday, and there the festivities heavily take on an outdoor quality. People celebrate with Whitsun Ales staying at the hotel offered us at town fairs filled with feasts, some oranges they had recently folk dancing, parades, and bought, and the experience felt charitable collections to benefit the village church and poor families. The Easter season contains multiple references to the rebirth and renewal of the Earth and vegetation, which in religious ceremonies also refers to the renewal of faith and hope. In Italy and other European countries, the Easter festivities do not end on Easter Sunday, but rather move on to encompass other feasts like Ascension Day and Pentecost, reminding us that the beauty of nature and the revitalization of the season continue as spring turns to summer.

May remains one of the most significant months for appreciating nature and all it has to offer. When I was an undergraduate student, I took a wonderful course on Buddhism. One spring day, the professor took us out to the woods to reflect on nature. He explained that by becoming at peace with the outdoor surroundings, we do not separate ourselves from the world but rather reach down into our deeper consciousness and find ways to better our interaction with the world. I also learned this lesson while I was in Italy, and from investigating European holiday customs like those of Pentecost. By taking the time to appreciate the natural world around us, we are forced to look within, and honor our own mind and soul. Perhaps that is the message of the bright spring flowers and the breeze fluttering through the trees after all.



This comes days after NEW Health began offering walk-in COVID vaccination clinics at their North End and Charlestown locations. In the North End you can walk into St. Leonard's Church, located at 31 Prince Street, Thursdays from 2:00 p.m. to 4:00 p.m. and both Fridays and Saturdays from 9:00 a.m. to 12:00 p.m. to receive your vaccine. If you prefer to make an appointment you are still able to do so by calling 617-724-8725.

To date, NEW Health has administered over 1,800 first doses at their North End location and another 1,800 at their Charlestown location.

Saint Daniel Comboni

Daniel Comboni was born at Limone sul Garda, Brescia, Italy on March 15, 1831, into a family of farmers employed by one of the rich local landowners. His parents Luigi and Domenica were very attached to Daniel due to the fact that of eight children he was the only survivor, all the others died in their infancy. Poverty forced Daniel to leave home. He went to school in Verona and attended the Institute founded by father Nicola Mazza. During his years spent in Verona, Daniel discovered his calling to the Priesthood.

While at the Institute, Daniel developed a deep interest in the mission of central Africa drawn by the descriptions of the missionaries who returned from there to the Mazza Institute. Daniel was ordained in 1854, and three years later left for Africa along with five other missionaries of the Mazza Institute. Upon arrival in the Sudan, Daniel was immediately made aware of the multiple difficulties that were part of his new mission. The deaths of several of his young fellow missionaries and the poverty of the people only served to drive him forward never dreaming of giving up.

Daniel returned to Italy to work out a new missionary strategy. In 1864, while praying at the tomb of Saint Peter in Rome, Daniel was struck by a brilliant inspiration that lead to the drawing up of his famous plan for the rebirth of Africa trusting in the human and religious capacities of the African peoples, which was a project with the slogan, "Save Africa through Africa." Daniel wanted the European continent and the Universal Church to be more concerned with the African continent. He carried out appeals throughout Europe from December 1864 to June 1865 for the spiritual and material aid for the African missions.

In 1867 and 1872 respectively, Daniel founded two missionary Institutes, one for men and one for women: these become known more widely as the Comboni Missionaries and the Comboni Missionary Sisters.

On July 2, 1877, Daniel is named Vicar Apostolic of Central Africa by Cardinal Alessandro Franchi and consecrated Bishop a month later.

On November 27, 1880 he traveled to the missions in Sudan from Naples for the eighth and final time to act against the slave trade and though ill, managed to arrive in Khartoum on August 9 in summer and made a trip to the Nubia mountains. On October 10, 1881 he died in Khartoum during the cholera epidemic.


Daniel Comboni was Canonized on October 5. 2003 by Pope John Paul II. The Feast Day of Saint Daniel Comboni is October 10th.

The title is quite comprehensive and appropriate: My 50-Year Love Affair with Radio by Boston area talk show host Jordan Rich (with Stephen A. White;) a suitable title because Jordan Rich has been a part of local radio going back to, well, a half a century.

In this relatively recent memoire, Jordan provides a considerable quantity of background information pertaining to a medium that has enjoyed much success going back to the early years of the last century. Indeed, with On Air, My 50-Year Love affair with Radio, the author traces some of those local iconic radio personalities who have been welcome visitors on countless radios since the early years, when Guglielmo Marconi's invention of wireless audio transmission truly augmented communication.

And, since WBZ Radio (the station which Jordan has broadcast his popular weekend third shift program for many years) will observe the granting of its license exactly 100 years ago (September 15th to be exact,) it is with this station, and later others that Boston radio has had a long history of on-air personalities providing news, entertainment, sports, public affairs, local community coverage and a plethora of other types of broadcasts, in a medium that not only was

a predecessor to television but still retains its popularity (albeit competing with a myriad of other channels of expression.)

National radio of course, had its stars and renowned newscasters; however, Boston could claim such notable personalities as Sherm Feller, Norm Nathan, Larry Glick, Jerry Williams, Paul Benzaquin, Jess Cain, Gus Saunders, Jim Westover, David Brudnoy, Dave Maynard and numerous others.

It was these individuals who made an impression on Jordan, who even as a young man displayed an enthusiastic interest in radio; and to become part of the industry, it was important to study, work and hone his skills with the hope that he too, would be able to work in an industry which would be fulfilling.

And rewarding it was. On Air, My 50-Year Love Affair with Radio traces back to Jordan's days as a student at Randolph High School where he had shown a propensity for acting — something that helped with his talent as voice over artist as well as his countless Master of Ceremonies engagements, and of course, this early training helped with an innate ability to be an all around radio personality.

His subsequent college career at Curry College helped in refining his skills as an emerging on air talent including some practical experience with putting together a show — along with some essential knowledge of various types of music. It was at Curry that Jordan also met Ken Carberry with whom he would eventually form Chart Productions, a recording studio which has been a mainstay since the early 1980s.

But it is radio where Jordan's had an audience - and the audience got to know Jordan. In this autobiography, Jordan relates the experiences of moving among different stations; due to the nature of the business — whether due to programming changes or changes in management, or a decision to broadcast national programs versus local ones during certain hours, it is more common than not for radio personalities having to find another station from which to broadcast. However, it doesn't make the transition to a new position any less easy. In On Air ... Jordan is up front with the challenges he needed to meet - not with just having to relocate to a new station when a station introduces a new format, but in meeting other, and often more daunting dilemmas.

Although the book's title refers to Jordan's experience in radio, behind the scenes circumstances, all while Jordan was doing his on air responsibilities and all the other tasks associated with the business factor much in Jordan's chronicle. Yes, Jordan was living a demanding schedule, and in 1995, a wake-up call came and eventually, after some time and thanks to necessary treatment, was able to get back to a regular routine. Jordan writes sincerely about the often misunderstood diagnosis of depression and how he was able to address this issue with the hope of helping others. Sometimes just addressing certain issues can result in people (listeners in this case) open up and ask for

Jordan also writes movingly about his wife Wendy of 33 years and her bout with cancer — a disease that ultimately claimed her in 2013. A difficult time to be sure, for not only Wendy but also the impact that cancer has on family and friends.

Jordan also writes of how the industry has changed — that there are new forms of communication; in fact, Jordan who still broadcasts and continues to work in the voice-over business at Chart Productions, has embraced one of the new communication forms, Podcasts, where the objective of relaying information is achieved through current technology.

Jordan also warmly discusses his meeting and marriage to his new wife Roberta — who as Jordan states: "Meeting Roberta brought love into my life for a second time, making me quite the lucky man."

On Air, My 50-Year Love Affair with Radio is a ten chapter narrative, with Forward by former Director of News and Programming at WBZ Radio Peter Casey, which gives an account of the life thus far of Jordan Rich — a life that has been lived against the backdrop of the world of radio. The author writes in a straightforward manner and approaches issues that can often be sensitive but issues that are addressed openly with the aim of helping those who might be experiencing similar experiences.

And, this book also ends on an optimistic note; Jordan not only mentions his Podcasts but his continuing involvement in the community. He fondly recalls that with such an interesting career, he has had the opportunity to work in a profession not only which he has loved and respected — but a career where he has the opportunity to interview many people from all walks of life, as well as knowing, even if only through the air waves, those many people who have called into the studio and participated in what also has become without a doubt, a prominent part of Boston Radio - The Jordan Rich Show.

Nanna & Babbononno

A Nostalgic Remembrance



Well, here is the first column that begins my 31st year writing *Nanna* & *Babbononno*. Loretta just returned to Florida. She had gone home to help celebrate son John's 40th birthday, and his and wife Beth's 7th anniversary. I was tied up and couldn't make it, but I did a "FaceTime" get together with John, Beth, and the grandchildren. That made us all feel better. My cell phone was my salvation.

Later on, I began thinking, "What did we do before cell phones were invented?" Electronic devices are nothing new, but the sophistication of today's pocket computers makes them a learning tool as well as a communication device. Let me give you an example working backward. Before I owned a cell phone, I used a beeper. People would call the beeper number and leave their name and phone number and I would return the call. These devices faded into obscurity once cell phones became practical.

Let's see, what did we use before the beeper form of communication. We used the telephone. Back in the day, I had everyone's phone number memorized. Now, all their numbers are stored in my cell phone directory and I'm lucky if I remember my own number.

Going back to the days when Nanna and Babbononno were young, my grandfather needed a phone. At night, he was a musician, and booking work and hiring musicians became a lot easier. They started out with a 4-way party line, 4 separate phones hooked up to the same circuit. If one of the 4 lines was in use, you couldn't use your phone until they were off and you could get a dial tone. If another line was in use, you could eves drop on the conversation if you were nosy.

By the 1930s, my grandparents were able to obtain a 2-way party line. It worked the same way, but now there were only two numbers on one circuit. When my folks moved from Nanna and Babbononno's house to 74 Eutaw Street in East Boston, Dad was able to get a 2 party phone. I even remember the number sequence: East

Boston 7- 2509-W. (This was during WWII) You would pick up the receiver of the phone and an operator would say, "Numberrr Pleezzze." You would them give her the number you wanted to call and she would ring it for you. Not long after the war ended, Dad announced that we were getting a private line and the phone number was going to change to Logan 7-2552. Later the Logan 7 was changed to Logan 9, but the 2552 stayed. Not long after that, we were gifted with a phone that had a dialing mechanism. This meant that, once you heard the dial tone, you could dial a number minus the operator's assistance.

When we lived on Eutaw Street, we had only one phone. It rested on a table in the living room and was black in color. When we moved from East Boston to Belmont, Dad had two phones installed. This meant that you could make or receive calls from either one. One hung on the kitchen wall and the other one on that same table from the living room in Eastie. Only now, it was in the hall on the second floor just outside the bedrooms.

Eventually, the kitchen phone became cordless and Mom could walk around the downstairs rooms carrying her phone with her as she spoke. Her comment was, "Will wonders never cease."

Babbononno arrived on this Earth before telephones and he had a running battle with them most of his life. In his later years, he needed a hearing aid and wouldn't admit it. When I would call him, he would answer with, "Ah low, hooza dis." I would yell, Babbononno, it's John." He would reply without hearing or understanding correctly, "You wanna tawka a Meesta Contini?" I would have to keep yelling for him to finally understand who it was. Nanna was more receptive to the use of the phone even though she was born before they were invented.

Television before the early '60s were as primitive. You had to get up off your chair to change the channel by turning a dial on the set. It didn't matter much, as we only had 3 commercial channels in Boston, 4, 5, and 7. Beginning in the '60s, remote tuning devices became practical and you could actually go from channel 4 to 5 just by hitting a button ... Space age technology!

The first cell phones were just that, phones, phones that operated from a beam put out by a space satellite. As time went on, they became miniature computers as well as telephones. As an example, I became part of a summer program at MIT years ago. It was called The Foundations of the Internet. The internet is a computer-aided form of international communication. I worked my way through the courses and my final project was to find the flag of Chad (a small country in West Africa). It took me about a half hour of mathematical calculations programmed into the computer, then, low and behold, there was the flag of Chad. With my iPhone, I press a button and command, "Find the flag of Chad." Within seconds, there it is three vertical stripes, on the left, navy blue, in the center, yellow and on the right, red.

My cell phone replaces a phone directory — both white and yellow pages, newspapers, magazines, a dictionary, and an encyclopedia. If I want to be multilingual, I can translate whatever I want into all the major languages on the planet.

I wonder what is down the road just a few years from now. Whatever comes along might be above and beyond me, just like the TV remote was complicated for my mother. After Dad passed on, Mom would call me a couple times a week and state that her TV was broken. I would head over to her house and reprogram her remote, and until she accidently deprogrammed it again, it would work.

Think about all of the conveniences we live with today that make life easier. Just as an example, I had my 66 Thunderbird shipped to Florida so I could have one of my toys to drive. It has no air conditioning and my friends wonder how I can tolerate the heat when I drive. Not that long ago, the artificial cool air we take for granted didn't exist except in upscale movie theaters. Taralli Dolci or "sweet taralli" are quite different from the well-known savory version that are most often found in the Puglia region of Italy. Taralli Dolci are also from Southern Italy but they are softer and heavily glazed round rings of semi-sweet dough. Some versions of these "sweet taralli" are prepared by boiling, then baking and glazing. Whereas others (such as the ones we are referring to today), are simply baked and then glazed. These delectable cookies belong to the cucina povera or "peasant cooking" that is typical of Southern Italy, as they are made with few simple ingredients. Taralli Dolci are usually prepared for holidays or special occasions. They are loved by adults and children, irresistibly delicious, and ever so easy to make!

My Nonna had several recipes for "sweet taralli". Some were on the soft side, others a bit harder. She'd flavor some with vanilla, others with lemon or anise, and sometimes she'd even use a combination of both! The recipe I am sharing today was given to me by Father David Renne, a young handsome diocesan priest from Erie, Pennsylvania. Father David shared his family's recipe for what he referred to as "Tudaducees" which I am almost positive means "Taralli Dolci". Father David stated, "I know everyone probably has their own family version of this cookie, but here's mine. We call them "Tudaducees" or just "S's and O's." I made his family's recipe, and they were absolutely fabulous!

FATHER DAVID RENNE'S SWEET TARALLI Taralli Dolci



6 eggs 1 cup granulated sugar

1 cup oil

1 tablespoon anise, lemon or vanilla extract (Father David uses anise) 4 ½ to 4 ½ cups all-purpose flour

6 teaspoons baking powder

Icing: (Father David stated "confectioners' sugar, melted butter, milk, and extract of choice (optional). Begin with small amounts of each ingredient, adding until you have a consistency you desire, should be thin, but not runny. I use anise or vanilla flavoring in these cookies, but you could use lemon, vanilla, almond, etc. Enjoy"

I used:

4 cups confectioners' sugar 2 tablespoons butter, melted

½ cup milk

1 teaspoon extract (I used vanilla)

Nonpareils to decorate Mix well, adding more confectioners' sugar or milk, if desired

Preheat the oven to 350°. Prepare 2 baking sheets by lining with parchment paper or silicone mats and set aside.

In a medium mixing bowl sift together the flour and baking powder and set aside.

In a large mixing bowl, add the eggs and sugar and beat until creamy. Add the oil and extract, mix well. In small increments, add in the flour mixture, mixing with a wooden spoon after each addition. When dough is well mixed, refrigerate for about a half hour.

Remove dough from refrigerator and place on a floured board and knead a couple of times, adding flour if necessary. Dough should be soft and workable, not sticky or stiff. Take a small cookie scoop or heaping tablespoon size of dough and shape into "S" and "O" shapes or knots. Place one by one, slightly spaced apart on prepared baking sheets. Bake for about 12 to 14 minutes or until bottoms of cookies are light tan in color. If you bake 2 at once, be sure to rotate top to bottom and front to back halfway through baking Allow to remain on baking sheet for 5 minutes then transfer to wax paper to cool.

When cool, Father David recommends "ice the bottoms, allow to dry well, then flip and ice the tops and sprinkle with nonpareils."

Robert Kennedy Assassinated



Robert Kennedy was assassinated on June 6, 1968, almost five years after his older brother John and yet so much had happened in the interval that the nation hardly had time to heal. The Vietnam War continued to rage, spawning protests, occasionally violent ones. Dr. Martin Luther King, Jr., had been slain by an assassin's bullet earlier in 1968 and riots were exploding.

Robert Kennedy must have seemed like a breath of fresh air to many disillusioned Americans. Like his brother, he was young and charismatic and had just won the presidential primary in California with incumbent Lyndon Johnson announcing his decision not to run for re-election. Kennedy, many thought, was the best hope against Republican candidate Richard Nixon.

The dream, however, kept evading our nation's youth. It would come to a tragic burst and America realized it was still a long road to unity and peace.

After announcing his win, the former attorney general made his way out of Los Angeles's

Ambassador Hotel accompanied by bodyguards Rafer Johnson and Roosevelt "Rosey" Grier, (a former professional football player) amidst a mob of cheering supporters. But there was one individual who was not there to cheer. He was 22-vearold Sirhan Sirhan, an immigrant from Palestine who saw Kennedy as a symbol of empty promises from the West for the future well-being of Palestine.

Sirhan pushed his way through the crowd, concealing his revolver and fired at Kennedy. Grier and Johnson tackled the assailant (five bystanders were injured in the scuffle) but the by then another Kennedy had slipped away and the turmoil that swept this country gained more fuel.

Sirhan confessed to the murder the following March and was sentenced to death, but his sentence was commuted to life when California overturned the death penalty in 1972.

At the time, that mattered little. A nation could still not find answers, could still not find peace.





The Golden Age of Boxing

Which One?



It's not unusual to hear boxing fans talk about their definition of when something called a Golden Age of Boxing took place. Quite often, these fans will choose the time when they were younger and first getting into boxing. This is only natural because at that point boxing was exciting enough to draw them into it, so they naturally feel it was at its peak because it was new to them and fascinating.

Others study the different eras, something that is now easier than ever with the emergence of YouTube. These folks tend to be more analytical and go to great pains to study the style and quality of the opponents facing one another.

Other things that influence people's judgment is the style of boxing that is in vogue. Before WWII, there were a great many fighters who had very few knockouts on their records. Men such as Maxie Rosenbloom, Billy Conn, and Jack

Sharkey. Fans going to see these boxers in action did not expect the fights to end in knockouts, yet all three were solid draws. I doubt they would be today as fans are less in tune with skill and more with power punching. I have heard people scoff at the mention of fighters such as Conn being called great because of their low kayo percentage.

I recently picked up a copy of George Kimball's book *Four Kings*. The subtitle is *Leonard*, *Hagler*, *Hearns*, *Duran and the Last Great Era of Boxing*. While I have not yet read the book, the title intrigues me. Looking at the photos of the four champs on the cover, I think Mr. Kimball was on to something.

The first thing that struck me about it is the fact that all four of these great fighters fought each other. Now, beside the fact that there are no fighters around today that come anywhere close to the caliber of these outstanding champions, you rarely hear of top fighters facing one another. Just look how long it took for Mayweather and Pacquiao to get it on.

And while the fearsome foursome Kimball writes about all had solid knockout percentages, all had tasted defeat. That did not cloud their reputations, it only proved that they could come back and be even better than they were.

Now while it can be an endless argument about what the greatest era in boxing was, I would put forth that boxing had a lot of great eras and, agreeing with Mr. Kimball's subtitle to his book, the period of the late '70s to early '80s was the last one.

I use as my criteria how the fighters from one era would have done in another era. While it is easy to look at the fighters from the '70s and '80s as great by comparing how they performed against those active at the time as well as on another, how would they have stood up against the crop from a different age. Would this group have looked as outstanding if they were facing, Cerdan, Robinson, LaMotta, Greb, Steele, Burley, Armstrong, and many others from pervious times?

I would say that while it is not guaranteed any or all of them would have become champions, I have no doubt they all would have been in the mix. They be up against some very great fighters and would be stretched to their limits. However, none of them would embarrass themselves, and any of the earlier contenders and champs would have to work hard to beat them. I don't believe there would be any blowouts here.



Another thing I found exciting about the last Golden Age was the fact there were so many fights where going into the ring nobody could be certain who would win. Or, in the case of Duran vs. Hagler, where a champion considered over the hill would put on a great exhibition of skill and endurance.

I'll leave the argument for when the greatest era was for another day. For now I will leave you with the idea of thinking about how well boxers from one period would fare in another.

HOOPS and HOCKEY in the HUB

RETURN OF THE NIGHTMARE MENTOR — He was discovered by accident as a player. Later he was spurned by the Bruins as a potential bench boss, a decision that cost the B's dearly years later.

And now he's back, once more the crafty commander of an opposing team, hoping to derail one last possible conquest by their crucial central core of players that has captured one Stanley Cup and made it to the final round on two other occasions.

We speak, of course, of Peter Laviolette, a man who was once the Bruins coach-in-waiting but later went on to have success with several other franchises.

Discovered by a pro scout who got lost while driving to another assignment, Laviolette completed four seasons of college hockey at Westfield State and later played four years with the Providence Bruins, accumulating 111 points as a defenseman.

After his final minor league game in 1997, he entered the coaching ranks, leading the Wheeling Nailers of the East Coast Hockey League all the way to the third round of the ECHL playoffs.

The next year he returned to Providence as head coach. What a year it was as he led the P-B's to a 56-15-4 regular season record that culminated in a Calder Cup Championship campaign. Laviolette was named AHL coach of the Year in his first season as a bench boss in the league. The following year Providence made it to the conference finals.

It was no secret that Laviolette was on the radar of Bruins management. During those two years at Providence, he was interacting with the big club during the combined practices that are a feature of the early days of training camp every fall.

And thus it was that Peter Philip Laviolette, Jr. became a Bruins assistant for the 2000-2001 season. It was not a good year for the storied franchise. After Pat Burns was dismissed early on, Mike Keenan was brought in. Hardly a favorite in the Hub, the B's went on to finish ninth in the Eastern Conference, losing the last playoff spot to Carolina via a tiebreaker. The season was over and Keenan was gone — his contract was not renewed.

Thus, there was an opening for the former Providence coach. But management did not go in that direction, preferring to hire Robbie Ftorek. During the 1999-2000 campaign, he had coached the eventual Stanley Cup winning New Jersey Devils before being dismissed with nine games left in the regular season.

From AHL Coach of the Year to out the rear door in the Hub. However, when one door closes, often another opens. And for Laviolette, the best was yet to come.

He immediately became the head coach of the New York Islanders for two seasons before moving on to Carolina, where he directed the Hurricanes as they soared to the summit as they claimed the 2006 Stanley Cup Championship.

Five years removed from his rejection in Boston, he was at the center of the rejoicing in Raleigh.

But his biggest comeback may have come four years later. Laviolette was now behind the bench in Philadelphia. In a storybook conclusion to the 2009-2010 regular season, the Flyers got in under the playoff demarcation wire by defeating the New York Rangers in a final regular season game overtime shootout.

In the second round of the playoffs they met the Bruins, who cruised to a 3-0 lead in games before Laviolette launched Philly back to life. The Flyers proceeded to capture the series by winning four straight games. In fact, it was a comeback within a comeback, since at one point in Game 7 the Flyers were actually down by a 3-0 score.

It was a huge embarrassment for the Bruins, who became only the third franchise at that point in NHL history to lose a playoff series after taking a 3-0 lead in games. The Flyers would go on to defeat Montreal in the Eastern Conference Finals before losing to Chicago in the Stanley Cup Final.

For the B's it was the meltdown series that will be forever remembered. The worst in franchise history. They say that truth is stranger than fiction and this was a nightmare that had come true. Engineered against them by someone they had spurned, no less.

While the B's would rebound to win the 2011 Stanley Cup Championship over Vancouver, it would indeed be a bit longer than a full year before they had the opportunity to overlay that low point with a title. The Bruins were eliminated on May 14, 2010 but would not win the Stanley Cup until June 12, 2011, thus giving fans 13 months to remind them how they lost. Indeed, their flop of the year before was an undercurrent throughout the 2010-2011 campaign.

Both Laviolette and the Bruins would go on to experience additional success — with the Franklin native leading Nashville to the 2017 Stanley Cup Final while the Bruins made it to the championship series twice more — losing to Chicago in 2013 and to St. Louis in 2019.

Now, the former Bruins coach-in-waiting has returned to face the B's in the playoffs once more — this time as the leader of the Washington Capitals. The one who engineered the Bruins nightmare of 2010 also has a huge ally on his roster this time around.

He's none other than Zdeno Chara, who played for the Bruins from 2006 through the pandemic challenged 2019-2020 season. Chara bled Black and Gold, indicating on numerous occasions that he wanted to retire as a Bruin.

It was not to be, even with the regular season shortened to just four months. After employing him for 14 years, the Bruins couldn't find a way to live with Chara for an additional 120 days.

After Chara sustained a facial injury during the 2019 playoffs, he later returned to duty with his jaw essentially wired in place. Teammate Brad Marchand proclaimed: "He's a real warrior." Now the big man (6-9) is playing for the opposition in the playoffs.

Will the nightmare of 2010 have a sequel in 2021? We will know before the month of May becomes a memory.
