Walsh, Forry and 3:00 am Nightlife?

A 3:00 am closing could be happening sooner than we think. The State Senate is considering amendments to the fiscal 2015 budget proposal and Mayor Marty Walsh apparently has dusted off some of his legislative prowess gathered over 17 years on Beacon Hill by teaming up with Sen. Linda Dorcena Forry on an amendment that allows communities to control their own sale of alcohol later than the current 2:00 am deadline.

Forry's measure would allow communities to go beyond the 2:00 am mandatory deadline in cities and towns that are serviced by MBTA late-night service.

Walsh has made it clear, he sees the possibility of closings of bars and restaurants as late as 3:30 am in order to add to Boston's reputation as a world-class city.

Apparently, the powers that be at City Hall think this would help the city's economic growth and that it would also benefit from more entertainment, transportation, food and drink from all those burning well beyond the midnight oil.

There are many folks who think later closing hours is a great idea but there are also others such as North End residents who see the idea as less than great.

Personally, if Boston allows nightlife to 3:30 AM, you can bet nearby communities like Somerville, Cambridge and Quincy may have no choice but to follow Boston's lead or see their local economies suffer as entertainment venues lure them to Boston after dark.

Stirpe Nostra



Our second distinguished scholar from the Silver Age of Latin literati is Decimus Junius Juvenalis, generally referred to as Juvenal, and considered to be the most representative satirical poet of this age. Satire as you know is that kind of writing which ridicules a person's vices or follies.

Juvenal was born in Aguinum, in the southern part of Italy, sometime around 63 B.C., was well educated in his rhetorical studies, and started writing satire when he was about forty years of age. He lived a simple lifestyle in a country estate near Tibur (Tivoli), and at various times in his life held the office of Tribune, and of Flamen. He was exiled to Britain or to Egypt because of a satirical attack on a favorite of the emperor, and he died while in exile about 130 A.D.

are unknown, but sixteen of his satires remain. All are written in a special kind of rhythm of verse called dactylic hexameter. The style of these poems represents the final development of satire among the Romans. His work is emotional, scornful, the language is abusive, and in his writing he attempts to set himself up as The total works of Juvenal a judge to censor the actions

of his contemporaries.

His concerns were mostly centered around those dark vears in Roman history from Nero to Domitian.

Although he displayed great passion and imagination, Juvenal is mostly distinguished from earlier satirists in his concerns about depravity and vice.

He possessed a savage indignation or scorn, and in his poetry he was able to fabricate memorable lines and

Once again, like so many other greats, his fame came long after his death. His satires gained popularity toward the end of the fourth century, and for the next hundred years he became one of the most commonly read of the Roman poets. His work was rediscovered in the ninth century when he became one of the "golden authors" of the Middle Ages.

A DAY OF REMEMBRANCE, Not Just a Day Off

Well, Memorial Day Weekend 2014 has come and gone. Last week's issue of the Post-Gazette, which came out on the Friday before the three-day weekend, was full of tributes to our fallen soldiers, seaman, Marines, airmen, and Coast Guard. But I have to wonder, how many readers missed those worthy stories and exhortations because they were so occupied with enjoying the long weekend that kicks off summer in this part of the country that they didn't read a newspaper.

I tried to observe the true meaning of the day, but it wasn't easy, as I used the three-day weekend to open up the summer place. Communities around the Commonwealth held Memorial Day events, and I'm sure that many persons attended, but how many missed the observances because they were traveling to or from cookouts or other activities?

It was not always so. Until 1971, when the Uniform Monday Holiday Act of 1968 went into effect, Memorial Day was on May 30th. Simple math tells you that the holiday would have resulted in a three-day weekend two out of the seven possible dates, and two out of seven times it would fall on a Saturday or Sunday, which was already a day off for many workers. With Memorial Day on a fixed date, the most likely outcome (three out of seven) would be a midweek (Tuesday, Wednesday, or Thursday) holiday. Many persons argue that the Monday holiday law is responsible for our holidays to lose much of their significance, as they tend to become generic three-day weekends.

Should we go back to May 30th for Memorial Day? I think not. Three-day weekends are popular, and with good cause. It's not just about having an extra day off; it's about having consecutive days off so that travel to relatives and friends to observe the holiday is possible. And, after all, the men and women who served, and died, for our nation, did so to preserve our freedom and way of life. For Americans our way of life includes freedom to attend, or not attend, a patriotic rally or parade on Memorial Day, as well as the freedom to just enjoy the day.

Padre Pio Mass & Procession June 22nd

Saint Pio of Pietrelcina, or more commonly referred to as Padre Pio was born Francesco Forgione on May 25 1887, in the farming Italian town of Pietrelcina. He is famous for bearing the stigmata and joined the Capuchins at an early age. He then left the friary to begin his studies to become a priest, which is why he is known as Padre Pio, Father Pius in Italian, a name given to him when he joined the Capuchins. His life was shrouded with illness and controversy due to his stigmata, which the Vatican doubted were real, thus prohibited him from practicing mass and hearing confession. Later in his life however, Pope Pius XI admitted to be misinformed and encouraged Catholics to visit Padre Pio. He was finally allowed to preach and celebrate Mass.

In honor of Padre Pio, who was canonized a Saint by Saint John Paul II on June 16, 2002 and to raise funds for St. Leonard Church; the Friends of Padre Pio have organized a service. A Mass in Italian with a few words in English will be held at 10:30 am on June 27th at St. Leonard on Hanover Street followed by food and beverages at 12:00 pm in the downstairs hall. Tickets are \$10.00 and all of the proceeds will be going to the church. A procession in celebration of Padre Pio will commence at 2:00 pm at Hanover and Prince Streets and continue throughout the streets of the North End.

Saint Bernard of Menthon

Saint Bernard, also known as Bernard of Montjoux, was born in 923, probably in the castle Menthon near Annecy. He was descended from a rich, noble family and received a thorough education. His father wanted him to marry but Bernard refused deciding to devote his life to the Church. Under the guidance of Peter, Archdeacon of Aosta, Bernard rapidly progressed. He was ordained a priest and on account of his learning and virtue

was made Archdeacon of Aosta in 966, having charge of the government of the diocese under the bishop.

Seeing the ignorance and idolatry still prevailing among the people of the Alps, he resolved to devote himself to their conversion. For forty two years he continued to preach the Gospel to these people and carried the light of faith even into many cantons of Lombardy, effecting numerous conversions.

For another reason, however, Bernard's name will forever be famous in history. Since ancient times there was a path across the Pennine Alps leading from the valley of Aosta to the Swiss canton of Valais, over what is now the pass of the Great Saint Bernard. Though the pass was extremely dangerous, especially in the springtime on account of avalanches, it was often used by French and German pilgrims on their way to Rome. For the convenience and protection of travelers St. Bernard founded a monastery and hospice at the highest point of the pass, 8,000 feet above sea-level, in the year 962. A few years later he established another hospice on the Little St. Bernard at 7,076 feet above sea-level. Both were placed in charge of Augustinian monks after pontifical approval had been obtained by Bernard during a visit to Rome.

These hospices are renowned for the generous hospitality extended to all travelers over the Great and Little St. Bernard, named after the saint. At all seasons of the year, but especially during heavy snow-storms, the monks accompanied by their well-trained dogs, went out in search of victims who may have succumbed to the severity of the weather. They offered food, clothing, and shelter to the travelers and took care of the dead. They depended on gifts and donations for sustenance.

Bernard passed away at Novara, Brescia in 1008, he was canonized by Pope Innocent XI in 1681. Saint Bernard's feast is celebrated on May 28. He is the patron saint of mountain climbers.



Judge

Domenic J. F. Russo

Judge Domenic J. F. Russo was born at home to the Honorable Joseph and Anita (DiMare) Russo on January 17, 1932 at 33 Green Street in the West End, a multi-ethnic, poly-racial section of the City of Boston. He was the second of four siblings, joining his sister Josephine and later joined by brothers Vincent and Joseph. His father, Joseph Russo, was a distinguished member of the Boston City Council 1938-1946



Judge Russo attended the Boston Public School system and he received his undergraduate and law degrees from Boston University.


In 1953 he married the then Rosemarie Maiolino and they had five children: Joseph V Russo; Lynda M. Kelleher; Julie A. Kelly; Mark X Russo. and David P. Russo. Judge Russo and his wife were blessed with 12 grandchildren.

After admittance to the Bar he entered private practice in 1956, joining the Law Offices of Samuel A. Valenti. In 1966 he was appointed to the position of First Assistant Clerk/Magistrate of the Brookline Municipal Court. On March 13, 1980, he was sworn in, by Governor Edward King, as a Justice of the Milford District Court. In 1992 he was re-appointed by Governor William Weld as First Justice of the East Boston District Court. Since his appointment Judge Russo has served, by designation, as a Superior Court Justice in three counties and in forty of the sixty-nine District Court Divisions.

For thirty-six years he brought his enthusiasm, legal and management skills and a deep concern for people to the Courts of the Commonwealth. As a First Assistant Clerk/Magistrate, he developed and honed skills in case management in which he was recruited to pass on to others. When Judge Russo came to a court to help, as a clerk later as a judge, he did it with grace and intelligence. He knew how to listen and how to learn about the culture of that court, its bar and its community. He taught more than just case management. He showed how to instill employee dedication, morale and teamwork, how to, by combining efficiency, fairness and civility with community involvement, build public confidence in the court system.

It did not take long after being s worn in as a judge in 1980 to gain recognition as one of the District Court's premier problem solvers. No problem was too large or issue too complex for Judge Russo. In addition to his appointment to the Milford and East Boston District Courts, he served as Managing Justice in Lynn, Lawrence and the Lynn and the Peabody jury sessions. He, with his son David, developed and installed a computer system for data and docket control in those courts.

As First Justice in Milford and especially as First Justice of his home area Court at East Boston, he demonstrated judicial efficiency. He has shared these skills as an instructor in "Courts and the Community" at the National Judicial College in Reno and as a presenter on "The Safe Neighborhood Initiative" at the Kennedy



School of Government, Harvard University. There is also an international appreciation of his talents. Judge Russo was selected to consult with judges in Brasov, Romania under a State Departsponsored ment program to encourage and create independent an judiciary in that new democracy.

In 1997 Justice Russo was recipient of Pirandello Lyceum's esteemed "I Migliore

in Mens et Gesta" award. Judge Russo has served as Secretary, Treasurer, Vice President and member of the Executive Board of the Massachusetts Judges' Conference. In 2001 he was the recipient of its prestigious President's Award for Judicial Excellence.

At seventeen, he enlisted, as a seaman recruit, in the United States Naval Reserve and served with distinction retiring as a Lieutenant Commander in 1980.

His many other judicial activities have included membership in: the American Bar Association; the Massachusetts Bar Association; the Boston Bar Association; the National Italian-American Bar Association; and the Justinian Law Society. Judge Russo's civic enrollments and activities include: the Order Sons of Italy in America, Massachusetts Commission for Social Justice, the Renaissance Lodge; the National Italian American Sports Hall of Fame; Knights of Columbus, 4^{th} degree, Bishop Chevrus Assembly; Augusta Fraternal Associates; the Augusta Club of Boston; the Dante Aligheri Society; the Holy Name Society; the Winthrop Lodge B.P.O.E. #1078; the Wardroom Club and the Naval Reserve Officer's Association. Along the way he busied himself as a coach in Winthrop's Little League baseball; Member and later President of the Winthrop High School Band Parent's Association. In 2000 Judge Russo was chosen as "Winthrop's Citizen of the Year".

But no picture of Judge Domenic Russo would be complete without highlighting what gave him the greatest pride and pleasure: his family. Although a proud Boston West-Ender, he moved to his wife's hometown of Winthrop where they raised five children. Rosemarie, his bride of 62 years, was according to Judge Russo what kept him centered and fulfilled. They had a shared pride and enjoyment when surrounded by their children and twelve grandchildren. In 2002 Judge Russo, upon attaining the age of 70, retired from active service as a Justice of the Massachusetts Trial Court. However, in April of 2004 he assumed the chairmanship of the Public Employee Retirement Administration Commission (PERAC).

Judge Domenic J. F. Russo, it can truly be said, enjoyed a distinguished career of excellence in service to his country, the Commonwealth of Massachusetts, his church and his community.

L'Anno Bello: A Year in Italian Folklore

Welcoming June, Italian Style

Is it really almost June? Sometimes I have to check a calendar, counting down the few short days until the end of May, to really make sure. June is one of my favorite months because it is laden with many exciting occasions. June houses the last day of school, and as a teacher this event tingles with unique energy and bittersweet memories. Everything feels different, from the voice of my students, as animated as a bubbling brook, to the hot summer air that flows through the windows to the stacks of papers that piled up around my classroom, worn remnants of a year gone by. This June will also host the World Cup, an event my dad is positively ecstatic about. I can already imagine that every time I see my father this month, he will be accompanied by the sound of cheers and sportscasters screaming "goal!" on television. Yes, June is an exciting month, but it is also a month laden with its own superstitions and folkloristic curios. Let's take a look at the Italian roots of June, or

The name of June has roots deep in Italy — ancient Rome, in fact. It is named after Juno, the Roman queen of the gods and the goddess of marriage. It is perhaps because of this connection that June remains a popular month for weddings even to this day. I myself chose June as the month for my wedding, and this year on June 22nd I will celebrate my first anniversary. In the United States, the full moon in June is known as the Strawberry Moon, a name that came from the Native

and continue for one year.

Americans of the Algonquin tribe, who equated June with the ripening of strawberries. Strawberries are known as fragole in Italian and form the basis of many succulent summer desserts, from nontraditional tiramisu's to puddings or salads made with other forms of frutti di bosco, or berries (literally, frutti di bosco means "fruits of the forest" - isn't that a lovely name that conjures images of berry-picking in the lush green woods?). Speaking of moons and marriages, June is also the month when many couples take their honeymoon. The origins of the term honeymoon are mysterious, but may derive from the medieval custom of drinking mead — a beverage of fermented honey after a wedding. In Italy, the term honeymoon translates directly into luna de miele. However, June in Italy isn't just marriages and fruit. It is also a patriotic month, as la Festa della Repubblica occurs on the second Sunday of the month. This national day honors the referendum voted on by Italian citizens in 1946 which established the Republic.

Of course, Italians pepper their everyday lives and holidays with proverbs, and the month of June is no different. Most June proverbs date back to the olden times when most Italians worked in agriculture and depended on interpreting natural signs to predict the success of the harvest. One proverb admonishes that rain in June spells bad luck for the crops: "Acqua di Giugno rovina il mondo" ("June water ruins the world"). Another

proverb, speaking to the Italian sense of caution, declares that "Finché Giugno non é all'otto non togliere il capotto" — meaning do not take off your coat until after June 8th, generally saying that there may still be cold days until around that time. Finally, other proverbs herald the fruits and crops that emerge in June. One says that "Giugno le ciliege a pugno," referring to the plentiful cherries that abound this season. Indeed, cherries are a fruit that strongly remind me of warm summer days, and whenever the temperature rises, I look for ways to incorporate them into smoothies, cream and cakes. Another crop-related proverb announces that "Per San Barnabá, l'uvaviene e ilfioreva." The feast day of San Barnabá, or St. Barnabas, occurs on June 11th, and this proverb informs Italians that though flowers die off around this time of the month, the grapes start to emerge, ready to grow and ripen in time for the harvest in September. Collectively, these proverbs remind Italians of the significance of summer planting, and look ahead to the crisp autumn days when farmers will be rewarded with the fruits of the Earth's bounty.

June is a month that embodies everything we love about the height of summer: sunny warm days, trees resplendent in their green glory, the promise of long vacations, delicious berries and cherries in season. It is a month with ancient ties to

Boston Should Keep Fighting for Host Status

As a resident of East Boston, I disagree with the conclusions many assert including even the *Boston Herald* editorial board on Mayor Marty Walsh seeking host status for both the Wynn Casino proposal in Everett and the Suffolk Downs-Mohegan Sun proposal for a casino on the Revere side of the track property.

Yes, the Massachusetts Gaming Commission has ruled against Boston on being a host community but who didn't think that would happen. Telling Mayor Walsh to forget about host status and reminding us about the rules that the gaming commission set up being followed forgets one important thing. Which rules are we talking about? The ones that originally said that Suffolk Downs would get one bite of the apple last November 5, 2013 where both Revere and East Boston had to each vote for the casino or the proposal failed

The rules were supposed to be the rules except, I guess, the rules are the rules except if East Boston votes the wrong way which the community did. Then, Revere and Suffolk Downs meet and low and behold there's a new casino not to be confused with the old one except this time it was a Revere casino.

sion for RUFF members. Janet and RUFF hope to





CARVING A NICHE FOR HIMSELF

The Untold Story of Luigi Del Bianco and Mount Rushmore

By Douglas J. Gladstone Published by Bordighera Press

Author Gladstone was ten years old when he became aware of Mount Rushmore's National Memorial, which he viewed, on a View-Master's reel.

Forty years later, Gladstone learns that it was sculptor, Luigi Del Bianco who was responsible for giving those four presidential faces their "refinement of expression." Gladstone announces, his purpose for writing this book is to give Luigi Del Bianco proper credit for the artistic endeavors he performed on the monument. Something he never did receive.

Gladstone writes, "Ironically, it was the failure of Rex Allen Smith the preeminent writer on Mount Rushmore to mention the Italian immigrant, who was the chief carver at Mount Rushmore from 1933 through 1940 ..." This led Lou, Luigi's grandson and his uncle

Caesar to champion Luigi's contributions and attempt to rewrite history. Gladstone's revealing book may correct this oversight. Eventually, Luigi met the famous sculptor, John Gutzon, who designed the monument, and became his most valued assisstant.

Lou Del Bianco, has been a vigilant champion of his late grandfather's contributions to Mount Rushmore ever since he discovered many books that had been written about the memorial that excluded Luigi.

Luigi was born aboard a ship near La Havre, France on May 8, 1892. His parents came from Meduno, Italy, some 482 kilometers from Rome and 94 kilometers from Venice. Gladstone offers a rousing appreciation for Luigi and the people of Meduno, who are mainly stone masons taiapiera. Luigi Del Bianco came from this powerful artistic ancestry. Luigi was 6 feet tall, and grandson Lou was 6 feet 4 inches tall.

Jim Sapone, a Del Bianco family friend states the following: "It's very simple, Luigi wasn't given the credit he was due because of a bias against Italian-Americans, because of bigotry."

Lou Del Bianco was "thunderstruck" when he learned from his mother that Luigi had carved Lincoln's eyes. Lou notes sadly, "Most authors don't mention Luigi in their reports." However," The most credible and reliable source was — Gutzon Borghum, the monument designer. Lou notes further, Gutson Borghum loved my grandfather."

"Chief carver was Luigi's official title, he was responsible for giving the monu-

ment its 'refinement of expression' as characterized by Borghum, he gave the monument its soul."

In 1935 Luigi brought his family consisting of three children and wife Nicoletta Cardarella to the Black Hills of South Dakota. Cardarella never did fit in with the locals. She couldn't find the

proper ingredients to make her Italian dishes. Luigi and his family got along with the local Lakota Indians, they became blood brothers. "The Indians were foreigners and so was my grandfather," explained Lou.

Gladstone makes the following clever analogy. "History has not treated Luigi Del Bianco very kindly. "It's

like talking about the '36 Yankees and not mentioning Joe DiMaggio."

To keep his grandfather's story alive, Lou has been performing a one-man, 45-minute show about Luigi's life and work titled, *In The Shadow of the Mountain:* The shows were a huge success and were awarded, "A five-time Parent's Choice Award winner."

Despite all the negative input regarding the carving of the Rushmore Monument comments such as what follows persistently surfaced. "... in a 1936 letter, Borghum described Del Bianco as "the only intelligent, efficient stone carver on the work who understands the language of the sculptor."

Gladstone builds on his argument to recognize the artistry and creativity of Luigi Del Bianco by quot-

ing the Italian immigrant, physician and patriot, Philip (Filippo) Mazzei, a friend of Thomas Jefferson, "All men are created equal." Gladstone continues to assail the numerous bigots by noting the "German backlash resulting from World War I and the lynching of 11 Italian-

Americans in New Orleans in 1891." Gladstone vehemently goes on to detail case after case of prejudice and bigotry in South Dakota of African-Americans and Chinese descendants who were not excluded from the bigotry they faced in South Dakota.

As an attempt at fair play Gladstone writes, "a local politician said he didn't see any point in introducing any specific resolution or proclamation commemorating Del Bianco, either." However, Gladstone capably garnered this comment from Smith Nelson's daughter of historian, Rex Allen Smith, "Obviously, if Daddy left out Mr. Del Bianco that's a huge omission, but, based on my knowledge of my dad, it had to be unintentional."

Luigi Del Bianco died on January 20, 1969 of accelerated silicosis, a condition caused, in part, by not wearing a mask.

Author Gladstone should be praised for writing about an outstanding sculptor, Luigi Del Bianco, an Italian immigrant who by all accounts was mainly responsible for the creative carving of the world acclaimed memorial, Mount Rushmore. Also, Gladstone should be acclaimed for his tenacious reporting revealing the biases against immigrant's, especially Italian immigrants.

NOAH's Climate Adaption Workshop

PROJECT UPDATE

If after a climate adaptation meeting, community residents applaud, something went right!

That's what happened after NOAH's first Climate Adaptation Workshop at the East Boston Branch Library, in the Menino Community Room. After 2 hours and 15 minutes of intense conversations about how storm surge flooding could impact infrastructure, planning objectives and neighborhood responses, the group of community-minded residents there were happy.

The Workshops were developed at NOAH's Community Building and Environment Department to produce in-depth discussions within community and agency groups and cross sector conversations between community and agencies. The meeting format and processes were specifically designed to create participation from people in urban environmental justice communities.

Resident delegates were chosen to represent all neighborhoods by NOAH's project staff Chris Marchi, Director of Community Building and Environment, Manlio Mendez, Community Organizer and Magdalena Ayed, lead volunteer and Project Organizer.

The process grouped each neighborhood's resident delegates together so they could support each other in technical, but important discussions. Experienced and well qualified Community Consultants were provided for each of the three neighborhood groups, to offer technical and strategic advice and support if needed throughout the event.

The night started with a short Presentation by Professor Paul Kirshen, of the University of New Hampshire, who together with Professors Jack Wiggin of UMass and Ellen Douglas of Tufts are conducting this research for the National Oceanic and Atmospheric Administration

Professor Kirshen then handed out huge color flood inundation maps which showed which areas would be impacted by flood waters if Boston experienced a 10 foot storm surge. Since New York had a 12.5 foot storm surge in October of 2012, this scenario had direct regional relevance.

Community resident delegates were asked to consider the impacts from such an event as if they were 'sitting at their kitchen tables' and offer their true expertise knowledge of themselves, their families, their neighbors and their community perspectives and to consider the things that they most want to protect in their communities. After a short discussion of community values facilitated by the Community Consultants, each of 'the neighborhoods' hosted a series of three 15 minute meetings with specialist and leaders from agencies responsible for a) infrastructure, b) planning and c) neighborhood response.

The conversations were lively and in depth, focusing on serious matters such as evacuation routes and shelters, sewerage back-ups into residents' basements, risks presented by the oil tank farms along the Chelsea Creek and at-risk placement of utilities such as boilers and electrical sub-panels.

After the meeting, most delegates agreed that they would have liked more time in each of the three discussion groups. But we got through the agenda and held our timeline agreeing to 'leave something to do in Workshop number 2!'

The second Workshop is planned for June 25th, also at the library. It will center on creating plans for what we can do to stop, absorb and cope with flood waters.

This adaptation planning process promises to create a great deal of data and progress in informing researchers, agencies and communities about how engagement on global climate change crisis planning can be done in a manner which includes the necessary community-based planning input. Part of the reason people may have applauded was that they genuinely appreciated the opportunity to have neighborhood-scale conversations with Department Heads and decision makers from the agencies which are most relevant to their communities' concerns.

The next step in this adaptation planning process is for the researchers and community alike to review our notes! Just about all of our Neighborhood Delegates are internet connected, so

Why We Need the Middle-Class


For a while I've wondered at the cause for the depletion of quality everywhere in the manufacturing world, but now the reason is obvious. With the disappearance of the middle-class market goes accessible quality manufacturing. It's obvious everywhere from bottled drinks, to shoes, to clothing, to toys, to DVD and Blu-ray cases, to furniture.

In part this is because the consumers are no longer interested or enticed in investing in the best quality product. The new trend is to buy cheaper substandard and replace when needed. But this is a consequence of a larger problem, the shrinking of the middleclass and, by extension, the middle-class consumer. Any politician who wants credit for setting the economy back on track better realize that the key is the strengthening of the middle-class as consumers.

As is, there are two kinds of retail businesses that are currently doing well. The Nordstroms, Thomasvilles', and the Saks Fifth Avenues of the world are doing fine because their clientele generally remain unphased by financial downturns, and the Walmarts, Targets, and fast food industry as a whole does well because, economically speaking, the majority of Americans are being left with increasingly fewer choices. Don't believe me? Look at the kind of businesses that are struggling:

Sears, Friendly's, Shaws, JCPenney, and Best Buy, all once popular choices for shoppers of modest means. Now they are faced with two options, pay more than what they can afford for a single chair at Thomasville or a single shirt at Lord & Taylor or piling up on disposable junk from Christmas Tree Shops. Similarly, the rise in obesity can simply be curbed by giving the middle-class a dining option in between the Top of the Hub and McDonald's. Not that the endangered family diners like Bickford's, Howard Johnson, and Friendly's are much healthier, but they are not priced or timed for mass consumption and dietary abuse is minimized.

Of course, corporations have made the most of the situation by cutting corners in their products. Bottled water companies, for example, are proudly promoting that their bottles are now made with less plastic as a commitment to the environment. But is that what's really motivating it? Certainly, by cutting costs by using less material, companies can afford to sell for less and entice customers of lesser means to buy their products. It's truly a win for the companies because they spend less and get some good PR to boot, tooting themselves as environmentally conscious manufacturers. If these same companies could afford to keep prices up to a mid-tier level and con-



sumers were still willing or able to pay for them accordingly, I have a haunch that all pretenses of being in with the green movement would go out the window.

On a global scale there is ample evidence that the lack of a middle-class breeds instability and violence. Latin America as a whole is a perfect example where every revolution from the Cuban to the current one in Venezuela comes down to hostility between the rich minority and impoverished majority. The saddest part is, none of these revolts end well for anyone. The rich are crushed and the poor remain poor. What the middle-class does for the poor is create a realistic alternative. They remind them that, no, they will likely never be able to live like the Trumps or the Kardashians, but they can still work toward getting a nice home in a good neighborhood and raise a healthy family. Isn't that what the American Dream was always about, rather than owning yachts and resorts?

So clearly is the resurrection of the middle-class a large part of the solution to me that I've made up my mind for 2016. The candidate that best convinces me that they will strengthen the middle-class market will get my vote. Game on.

Nearly a quarter of Latinos are now former Catholics. In 2013, 55 percent of Hispanics identified themselves as Catholic, down from 67 percent in 2010. A growing number of Latinos identified themselves as evangelical Protestants – while 18 percent said they had no religious affiliation.



MAMA'S HOMESTYLE PIZZA

DOUGH:

- 1 cup lukewarm water
- 1 package dry yeast*
- 2 tablespoons oil
- 1 teaspoon salt 1 teaspoon sugar
- 2 cups flour
- *If using Rapid Rise Highly Active Yeast, follow direction on the package.

PIZZA TOPPINGS:

- 1 pizza baking tray approx. 14" x 16"
- 8 ounces shredded mozzarella cheese
- 14 ounces crushed tomatoes
- 4 tablespoons Romano grated cheese
- 3 tablespoons oregano
- 1/4 cup olive oil or oil of choice


DOUGH PREPARATION: Place lukewarm water in a bowl. Sprinkle yeast over water and mix until dissolved. Add oil, sugar, salt and stir. Gradually add flour until all water is absorbed. If dough is too soft, add additional flour until it is the desired consistency. Spread a little oil in bowl before placing dough in bowl. Cover with a clean towel and set aside to rise. Put in a warm place. Dough will be ready for spreading when it doubles in size.

PIZZA: Spread some oil over bottom of baking tray. For ease of spreading dough in tray, flatten and spread dough in tray, moisten both hands with oil. Spread dough in tray to thickness desired.

TOPPINGS: Sprinkle mozzarella over dough, followed by topping with crushed tomato. Spread grated cheese and oregano over tomato. Sprinkle olive oil over contents and along inside edges of pizza. Other toppings of choice like chopped mushrooms or vegetables of choice can be added. Salt to taste. Bake in preheated 400°F oven for about twenty minutes. Thickness of dough and the number of toppings may vary time of baking. Bottom of pizza should brown.

To increase recipe, guideline is one cup of water for two cups of flour, except when using cake flour. When using cake flour, additional flour may be needed for one cup of water.

NOTE: It was always a festive time for our children when my parents prepared pizza at home for us. Mama mixed the dough by memory. The children watched Papa add the toppings. After years of watching them at home or in the bakery, I wrote out the ingredients and measurements they used. I have shared this recipe with my children, friends, and relatives. Though prepared dough is readily available now in most supermarkets, I still prefer mixing Mama's pizza dough recipe for our baked-at-home-pizza.

A Nostalgic Remembrance

Memorial Day was and is a day off from school, at least in Massachusetts. For the kids I chummed around with, it meant our first of the season trip to Revere Beach. We knew that the old folks headed for cemeteries to put flowers on the graves of loved ones, but for us, it was the beach and a swim (if you liked cold water). Now, someone is going to ask, "What about Shay's Beach in the Orient Heights section of East Boston?" Well, when I was a kid, Shay's Beach, or should I say, Constitution Beach was void of sand. The tide just rolled in on mud flats. There was no bath house, no hand ball court and no parking lot, just mud and the tide.

On the weekend that proceeded Memorial Day, the crowd that "hung out" on the corner of Brooks and Eutaw Street made plans as to time and departure point. At that point in our lives, most of us were in junior high (middle) school and didn't drive as of yet. A couple of the boys who were 16 would not have been able to get their fathers' cars as they would be needed to transport the adults of the family to the cemeteries where their loved ones were buried. We were basically on our own. At a given time, we showed up on the corner of Eutaw and Brooks Streets with bathing suits and towels in gym bags. If no lunch money was available, the rest of the bag might contain sandwiches and fruit. The Italian kids all had sandwiches that left oil slicks somewhere in the bag. The Irish kids all had peanut butter and jelly on American white bread. We definitely didn't swap lunches if that was the case.

At the departure time, we would head down the Brooks Street hill, passing all of the streets named after battles of the American Revolution: Monmouth, Eutaw, Trenton, Lexington, Princeton, Saratoga and Bennington Street. Bennington was a main street and there was a bus Heights Station and then the train to Revere Beach. We all lied about our ages and paid the kids fare which might have been 5 or 10 cents ... I'm not sure, but we got away with it. Once we walked from the station to the beach, we discovered that we weren't the only kids who were going to use Memorial my bathing suit, a towel, my

Day as the kick-off for summer activities. We also discovered that summer had not yet arrived and it was sweater weather, but we were hale and hearty kids and what did we care. We picked out a location and spread our towels. One of the kids always had a blanket and two or three of the kids would hold it around you so you could change into your bathing suit. We continued this until everyone was in their suit and then collectively, head for the water. If luck was with us, the tide would be in. If it wasn't, we would have to walk several hundred feet just to be knee deep in the ocean.

On one given Memorial Day, high tide had come in at around the time that we had arrived. Once in my bathing suit, I noticed that most of the people on the beach were only up to their ankles or knees in the water. I thought that was kind of strange until I stuck my feet in. The water was freezing, probably in the low 50s at that time of year.

My feet began to turn blue within minutes. If there was a dare devil among the crowd, they might be tempted to jump in. There was a kid called "Squeaky" an accurate nick-name due to his high pitched voice. If he was the first one to dive in, he would be squeaking as he came up for air. I was not as adventuresome and only allowed my legs to turn blue. My bathing suit never got wet until July rolled around two months later.

If anyone had forgotten their bathing suit or didn't own one, there was no problem. The bath house at the MDC building (now the State Police building) would rent you a bathing suit for 25 cents. These bathing suits were navy blue and were shaped like briefs except they were made of coarse wool. Five minutes after putting them on, your inner legs were chafed bright red. This happened to me only once and I learned my lesson. stop near the corner. We Once, when Dad brought all would take the bus to Orient of us to the beach, Babbononno had to rent one of those tighty-whities turned navy blue. Five minutes after he had them on, I learned how to swear in Italian. My grandfather was roaring.

On one of those Memorial Day outings, I had forgotten to bring a sandwich. I packed

baseball glove, a baseball, a pimple ball to play with in the water (it never got used that early in the season) and a baseball cap, but no sandwich.

We staked out an outpost on the beach right across the street from Joe and Nemo's. For you younger folks, Joe and Nemo's made the best hot dogs you ever tasted. New Yorkers brag about Nathan's hot dogs, but they didn't even run a close second to Joe and Nemo's. They used Nepco hot dogs, steamed the hot dog buns and you got your choice of mustard, relish, onions or just ketchup. All this and 3 dogs for a quarter ... Tonic was 10 cents. Back in those pre-Seville Theater days, I had a car washing business and always had a bit of money in my pocket, and a couple of times, was happy I had forgotten my lunch. I loved Joe and Nemo hot dogs. I still reminisce about buying those dogs back then, and talk about them with people old enough to remember what they tasted like.

Seeing that the water was too cold to swim in, out came the baseball gloves, the balls and the Red Sox caps. We would play near the water's edge to avoid the main crowd of people, especially the older ones who might not be able to get out of the way of a ball that was overthrown. Someone might ask, "How come we didn't play with a Frisbee?"

I don't think they had been invented yet. If they had been, no one told us kids from East Boston about them.

Later in the day, those of us with some money would look across the street at the amusements and wonder if we had enough for some of the rides. I wasn't a daredevil.

Some of the kids would head for the Cyclone, the rollercoaster in the middle of the beach. Most of the amusements would have opened that weekend and we made our choices. I preferred the bumping cars. Some kids called them the dodge-ums, but to me they were bumping cars. I think I learned how to drive due to driving them trying to avoid getting hit. My favorite Revere Beach past time was the shooting gallery. I was a pretty good shot with a rifle and won many prizes (all junk). At the end of the day, we would retrace our steps and head home. Each time, I had great stories to tell Nanna and Babbononno. GOD BLESS AMERICA

News Briefs

NAVIGATING THROUGH THE COMPLEXITY OF ITALIAN POLITICS. Many of the people who read the Italian newspapers find considerable difficulty to understand the complexity of new words, in short, an advanced new language. More so when foreign, new words, mostly English, are used. Here are just a few samples.

Over the last year, or so, new expressions such as 'Golden Rule,' which was introduced by the economist and former Premier Mario Monti, entered the Italian political discourse. The phrase would have provided a real flexibility with regard to the public expenditures, i.e. to take productive investments, from the deficit, in order to guarantee that the entire expenditure for all the co-financial projects — with Europe — wouldn't constitute an onus on the assets of the public treasury. This Italian idea, however, found no favorable echo in Europe, for it was seen as an 'economic excess' at a time when the overall economy looked gleam. Let's now explain the 'Pact of Stability' which is possible when the flexibility applied to those countries, of the European Community, that are 'virtuous,' i.e., they have a deficit under control: below the 3%. We now discuss the 'Fiscal Compact,' which is the close scrutiny of the public funds, which sets up a new rule: beside the deficit that should be low, the debt must also be low. Whenever the rhythm of the reduction isn't adequate, monetary sanctions follow. The flexibility concerning the expenditures is applied but only to those who respect the rules of the debt.

A NEW HIGHWAY CODE IN ITALY: KINDLY, PAY CLOSE ATTENTION! It has been customary, for many decades, that when you drive in Italy you better pay close attention to the road rules, or you will be stopped by the 'Polizia Stradale' (Highway Patrol's) risking a fine if you have violated the rules. The moment you get the copy of the booking fine receipt, you are given an option: pay the fine right on the spot, or when notified by a Court's officer. Many paid on the spot to avoid additional Court's fees. A new Bill recently introduced in the lower House of the Italian Parliament calls for the following alternative: if you pay on the spot you now have the option to pay the assessed amount of violation discounted 20%. However, a new amendment added to the Bill entices the violators to save 30% from the amount, which could be quite high in the case of a serious violation. This money, from the fines, can now provide immediate financial resources to the public treasury. The new law would also eliminate waste of time as well as the frequent harassments by an unengaged bureaucracy! Another amendment, well received, calls for the discount, whichever is accepted, to be granted if paid, seemingly to the Court, within 5 days. Otherwise no discount is granted! So, be careful when driving in Italy or you ... you know what!

The History of the Italian Soccer Team — Part I

National team dates back to May 15, 1910 where in Milan the team debuted ver-6-2 win marked the beginning for a team whose future would produce 4 world championships. The team's iconic blue jersey was missing as, for economic reasons, white shirts were chosen. The "azzurro" blue was

selected the following year as the official color of the team, paying homage to the House of Savoy, the Royal family of Italy. The love affair with the boys in blue was christened in a loss to Hungary.

Despite being one of Europe's strongest units, the Italians choose to not participate at the first world tournament staged 1930 in Uruguay. The distance of the trip and cost associated factored into the federation's choice to remain home.

The tournament was assigned to Italy in 1934 and the host nation led by coach Vittorio Pozzo and legendary players Giuseppe Meazza, who is considered one of the best football players of all time, Luis Monti, Raimundo Orsi and Angelo Schiavio did not disappoint. In the quarterfinals, Italy faced off versus the United States and soundly defeated the Red, White and Blue 7-1. In the quarterfinal, the Azzurri would face the Spanish in a highly contested game. Tied 1-1 after the overtime periods the game was replayed the following day with Meazza scoring the match winner. In the semifinal, Italy defeated Austria 1-0 advancing to the final match versus Czechoslovakia. The Czech's took a 1-0 lead with under 20 minutes to play, however Orsi tied the game 10 minutes later and the Italians won it in extra time on a Schiavo goal in the 95th minute. Italy was awarded the Jules Rimet Trophy named for the French Attorney credited with the idea of a Quadrennial tournament to crown a World Champion.

In 1936, the Italians were once again victorious at the Summer Olympics staged in Berlin, Germany winning Gold, much to the disappointment of Adolph Hitler who saw his German side knocked out in the Quarterfinals.

The 1938 tournament was held in France and was a continuation of the previous four years. Italy's toughest test came in the semifinal versus the Brazilians. Despite the South Americans fire power, Italy triumphed 2-1 advancing to its' second straight championship game. A highlight of the semifinal was a Meazza penalty kick, taken while holding

where in Milan the team debuted versus France. The discontinuation of the tournament until 1950. This time the Brazilians were the host nation and Italy still suffering from the tragic events of the 1949 plane crash of the Torino club team, which featured 10 out of the 11 starters for the National team, bowed out in the first round. Instead of flying to Brazil, the team opted to take a 16-day boat trip fearing a repetition of the previous year's tragedy.

The team would suffer through 3 more humiliating first round knockouts at the grand stage in 1954, 1962, and 1966. But undoubtedly the most embarrassing chapter in the team's rich history came in 1958, when the team failed to even qualify for the tournament in Sweden.

The Azzurri suffered their most embarrassing loss in 1966, 1-0 versus the North Koreans. Despite the fact that Italy was the favorite to win the tournament, which was contested in Great Britain they returned home to Italy thoroughly humiliated.

That loss sparked the revival that led to Italy's triumph in the European Cup Championship of 1968, which was staged in Italy. By 1970, Italy was back on track with talented players Giacinto Facchetti, Gianni Rivera, Luigi Riva and Roberto Boninsegna and looked like a formidable contender. In Mexico, the team started slowly but reached the finals after a grueling 120minutes with the West Germans. Considered an epic match, some call it the match of the century, Italy led 1-0 in the semifinal game until a 90th minute West German goal tied it and forced overtime. The overtime session saw the West Germans take a 2-1 lead before Italy finally won the game 4-3. Just four days later in the final, the Italians looked like an exhausted squad versus the great Brazilians led by world legends Carlos Alberto, Jairzinho and the unforgettable Pele. After a 1-1 first half draw, Italy had nothing left for the second, succumbing 4-1 to a more experienced and rested Selecao. The game was the final Brazilian national team appearance for the footballing great Pele. Despite the loss, Italy had returned to the upper echelon of World soccer and the bittersweet 1970 tournament began the rebirth of a proud tradition.

I don't write often about the current scene and prefer to focus on the greats of the distant and not so distant past. Boxing always has been a dangerous sport, but today young boxers are being led into the ring by trainers who, for the most part, know nothing about the art of boxing. They are being sent out at the sound of the bell having been taught little to nothing about defending themselves. It is my opinion, and I have some anecdotal evidence, that the promoters, mostly the TV people, encourage this lack of defensive skills because it leads to more "wars," and that is what the fans want. Every fight is being compared to the Ward Gatti encounters as if that is something to strive for. The art has been taken away from the Manly Art of Self Defense. I have been criticized for pointing many of these things out, and for questioning the morality of the sport. One so called expert, and in boxing anyone with internet access can be an expert, has called me a hypocrite and said I should no longer be involved in boxing. Maybe he is correct, but I would like to take a moment to explain, not to him, as he is not worth the ink, but to my readers, my love hate relationship with boxing, and why I will continue to write about it.

Jimmy Cannon called boxing the Red Light District of Sports, and that is exactly what it is. By its very nature it has always attracted a rough crowd. Talk to anyone who has spent time in a boxing gym over the years and they will tell you stories about the wise guys and weirdoes, the con men, and people with no consciences they have encountered there. You will hear stories about fighters who have been killed or crippled because they were over matched or put into a fight when they had a preexisting head injury. You will hear the stories about the boxers who were tossed aside and ended up in the streets when they were no longer able to sell tickets and their brains had been scrambled. Not a pretty pic-

ture. Yes, it has always been a cruel sport inhabited by low lives. But there is more to the picture.

Boxing has been a big part of my life since I was a little kid. I was always drawn to it and never cared much for other sports. I got myself to a boxing gym at an early age, and while I could write a book on the terrible things I saw happen, I have to say I have also met some of the best people I have ever known because of boxing. It is such a paradox that a sport that attracts the lowest of the low also has had some of the best people not only in all of sports, but in society as a whole.

I was reminded of this fact the other day when I attended a luncheon in Woodbridge, CT. I was invited down by a fellow named Rick Kaletsky, the author of "Ali and Me: Through The Ropes," a terrific book about his lifetime love of the former champ and his adventures with him. He also has a Muhammad Ali museum at his home. Rick gathered a group of boxing writers and historians at Katz's Deli. Also in attendance were former welterweight contender Gaspar Ortega along with his son the world-class referee Michael Ortega. The class of the boxing world was there. Good friend Dan Cuoco, the head of the International Boxing Research Organization (IBRO) whom is tireless in his work keeping the memories of the boxers of the past alive. He is constantly doing research and answering queries from fans and family members who are seeking information on a long forgotten fighter. Dan sees to it that these fighters

Henry Hascup, the President of the New Jersey Hall of Fame, a man who has done a tremendous job of honoring the great NJ fighters of the past, and another extremely knowledgeable boxing guy. Seventy-eight-year-old Gaspar Ortega who demonstrated some of the boxing moves he used to use in the ring was just amazing. In a short demonstration he showed techniques that are never seen today. Gaspar is still in great shape and would most likely be able to beat most of those in his weight class even now. There were many other terrific gentlemen in attendance, but space doesn't permit me to name all of them. What I would like to say is, each man there represented the good in boxing. They were all very knowledgeable about the sport, they were all gentlemen, they showed the utmost respect for each other even while having their disagreements, and they all cared about those who step into the squared circle. Boxing, a brutal sport occupied by such kind and deep thinking people. Yes, it is a paradox.
