MUSAE (THE MUSES)

Greek mythology tells us that the Muses were originally the nymphs of springs, whose waters gave inspiration to all who bathed in them. One of these springs was called Castalia. It was a celebrated place on Mount Parnassus (southern Greece), where a high priestess of Apollo was accustomed to bathe.

The early history of Greek poetry and music includes many legends about the Muses, those goddesses of song in general. Later, as folklore developed, they became representatives of the various kinds of arts, sciences, and poetry. Homer, the traditional poet of ancient Greece, sang of the Muses dwelling on Mount Olympus and singing to the lyre of Apollo during the meals of the gods. Hesiod, who gave us the first genealogy of the gods referred to the Muses as the nine daughters of Zeus. He listed

General belief held that the favorite haunts of the Muses were certain springs located at the foot of Mount Parnassus, a mountain in southern Greece. All of the Muses were usually represented as virgin goddesses with long garments and a cloak. Musical contests were held in their honor every five years. Athenians sacrificed to them in schools. while the ancient Spartans did so before a battle. The god Apollo was looked upon as their leader, with whom they shared knowledge of the past, the present, and the future. They also gladdened the hearts of men and gods with their music.

Charter of Liberty

"We hold here that the right to a speedy trial is as fundamental as any of the rights secured by the Sixth Amendment. That right has its roots at the very foundation of our English law heritage. Its first articulation in modern jurisprudence appears to have been made in Magna Carta ...'

Chief Justice Earl Warren

delivering the opinion of the U.S. Supreme Court in the matter of Klopper v. North Carolina, March 13, 1967.

Magna Carta (or, in English, "the Great Charter") was signed by King John (best remembered in the popular mind as "Bad King John" of the Robin Hood tales) on June 15, 1215. The document, which marks its 800th anniversary next month, is, in important ways, the foundation of the liberties of English and American law. The origin was a dispute between the king and the barons, and neither was wholly satisfied with the compromises contained in the Charter. At the request of John, Pope Innocent III annulled it. But the genie of liberty was out of the bottle and the Charter was amended and reaffirmed through the next few years and, in 1225, took the final form that makes it a foundational document in the English system of government and in every nation whose legal system owes something to English law.

Magna Carta did not create trial by jury, but it did enshrine it as a right, as well as the concept of due process.

"No free man shall be seized or imprisoned, or stripped of his rights or possessions, or outlawed or exiled, or deprived of his standing in any other way, nor will we proceed with force against him, or send others to do so, except by the lawful judgment of his equals or by the law of the land."

Even though England, to this day, has a State Church, Magna Carta laid down the law that even the king must respect certain ancient liberties of the Church. In America this became the religious establishment and free exercise clauses of the Constitution.

"The English Church shall be free, and that men in our kingdom shall have and keep all these liberties, rights, and concessions, well and peaceably in their fullness and entirety for them and their heirs, of us and our heirs, in all things and all places forever."

President Ronald Reagan summed it up well in his April 16, 1986, Law Day Proclamation

"The foundations of freedom upon which our Nation was built included the Magna Carta of 1215, English common law, the Mayflower Compact, the Act of Parliament abolishing the Court of the Star Chamber, and numerous colonial charters."

BALTIMORE DOESN'T NEED A RUSH TO JUDGEMENT

As a retired police officer, I have grave concerns over the quickness of the serious charges of either second degree murder or manslaughter against the six officers involved in the arrest of Freddie Gray, who sustained a fatal injury while in police custody. All the officers have been also with charged with false imprisonment too. These are all serious charges and are being viewed by some quarters as seemingly over-charging, which can only make policing in high-crime areas even more difficult. There seems to be a rush to judgment in many pockets of urban America.

The job of a state's prosecutor is to gather all the facts and assemble all the evidence, then apply everything to the law as written. I have faith that when all the facts are exposed to a jury, it is not a slam-dunk for Maryland's State Attorney Marilyn Mosby.

I was disappointed that her press conference sounded so political as she stated, "I heard you call for "No justice, no peace." Your peace is sincerely needed as I work to deliver justice on behalf of this young man." Was her Friday press conference an attempt to keep Baltimore from rioting over that weekend rather than searching for justice wherever it leads?

Many national conservative voices are lashing out at the prosecutor. Knowing she comes from a family with a long line of police officers, I feel she is going to be fair and impartial in the courtroom as she attempts to prove the charges she has made against all six police

I was not happy seeing citizens parading in the street as if all six officers are going to get convicted. This is a country with a Judge Roy Bean mentality. America doesn't arrest you in the morning, put you on trial in the afternoon and then hang you by 5:00 pm.

The state must prove its charges and a jury must decide on the evidence collected. Justice isn't a case of the loudest voices winning.

As a police officer, there is much to be concerned about what happened on the morning of April 12th when Gray was arrested. He died while in custody and that is troubling. When exactly did Gray get injured, how did he get injured and who is responsible for his injuries?

Hopefully, a fair trial will come up with some of these questions and a jury will do the right thing based on evidence and not raw emotion. All of us are held accountable for our actions. No one is above the law, not good guys and not bad guys.



Last week, Baltimore came front and center in the national eye, or perhaps a national black eye. When we watch a TV show, we know it is pretend, but what we are witnessing is real life. I don't know that much about Baltimore except that it is one of America's big cities. An urban center with a large African-American community.

His wake was held about a week after his arrest. Within hours of his funeral, the city exploded as angry protesters turned into a mob with unbridled anger in response to the death of Gray.

The police were hopelessly outnumbered by the mob, who began roaming their community in a fit of rage, burning and looting businesses. By now we have all seen the image of that CVS Pharmacy being torched and consumed in flames. In all, 144 cars were set afire, 19 buildings destroyed and over 100 police officers injured.

Most of us at home watching try and assure ourselves that it could never happen here, but we fool ourselves with that thinking.

Politicians show just how useless most of them are when in the midst of an uncontrollable situation like the breakdown of order. The Baltimore mayor actually didn't help matters when she all but encouraged looters to loot.

Unnamed sources informed the media that the mayor allegedly ordered the police to stand down and let looters loot, since it was only property. However, like all true blue liberals, the mayor lives in a gated community where her property is safe from any mob.

The police commissioner sounded quite frustrated with the breakdown on the streets and wondered out loud why folks would destroy their own community. He didn't understand any of it. Sadly, he is not alone, but I can remember watching this unexplainable action going back to when I was 17 years old watching the Watts community in Los Angeles go up in smoke back in 1965.

Last week, Baltimore came I can remember watching my cont and center in the ational eye, or perhaps a long hot summer of 1967 or ational black eye. When we atch a TV show, we know is pretend, but what we are I can remember watching my country burn during that long hot summer of 1967 or in the aftermath of the assassination of Martin Luther King, Jr., in 1968.

Of course, we have socalled national leaders stoking the flames of victimhood, like the Rev. Al Sharpton who apparently couldn't wait to fly down to Baltimore to take charge as only the Rev. Al can.

I saw that mom racing down to the violence to catch up with her masked son and start whooping him in front of endless TV cameras and taking him to the woodshed. Many call her a hero for responding as she did, others thought her violent outburst was over the line.

What bothered me was that a mom raced down to the scene of the mob and not the young man's dad. That to me is an ongoing problem that sadly goes back many generations. Too many men go AWOL in all communities, but it seems especially so in Black communities. The family structure has been weakened in the last 50 years, as too many have given up hope and expect the government to fix everything for them. It can't, and you can't pour money at the issue to make it vanish.

The mayor of Baltimore thinks the focus needs to be on police reform, but you can't talk abouth that until you talk about the trashing of communities by its own residents.

U.S. Sen. Bernie Sanders, who just announced for president, thinks we need to give our young people free college to prevent them from looting. What is he talking about? You can't keep handing out free stuff to make people act better. All of us are responsible for our own actions and need to be held accountable. We can't let folks off the hook by excusing wrong behavior.

Politicians are to blame more often by doing little more than fueling the flames of frustration and anger that has been simmering since the last flame was extinguished in the Watts riots of 1965.

Boston has its racial problems, but here we do talk and listen to one another more than in most large U.S. cities, which is to the credit of all of us who live here. We can't fool ourselves into thinking Baltimore can't happen here, but we must constantly work as if it could happen to prevent it from ever happening here in the Cradle of Liberty.

Keep your eyes on Baltimore and your soul in Boston.

Saint Rosa Venerini

Rosa was born in Viterbo, Italy, in 1656, then a part of the Papal States. She was the daughter of Goffredo Veniti, a physician, and Marzia Zampichetti, who was of an ancient family of Viterbo. They had four children Domenico, Maria Maddalena, Rosa and Orazio.

Rosa joined a Dominican women's community briefly during 1676, but returned home to comfort her mother after Goffredo's sudden death. Rosa's brother who was 27,

also died. Her mother was heartbroken at their passing and died within months. When her family crisis was over, Rosa invited local women to her home to recite the Rosary in a group.

This eye-opening experience shaped Rosa's future, pointing her toward her ultimate vocation in the field of teaching.

In 1685, with the help of two friends and the approval of her local bishop, Rosa opened Italy's first public school for girls. It was supported by some Church and state officials. Many of her critics were silenced by the school's success in uplifting the character of young women. Rosa left Viterbo and founded ten schools in the Diocese of Montefiascone between 1692 and 1694. She also trained a local successor, the future Saint Lucy Filippini. In 1713, Sister Rosa



managed to open a school in Rome, three years later, Pope Clement XI paid a visit accompanied by eight cardinals. Witnessing the work of Rosa Venerini's teachers, the Pope thanked her, declaring: "With these schools you will sanctify Rome."

The success of Rosa's work also increased her daily responsibilities. She undertook difficult journeys for the sake of her work, while maintaining a strong prayer

life that kept her oriented toward God's will in all of her undertakings. She sought spiritual direction from Jesuit priests who helped her to combine an active apostolate with a life of contemplative prayer. She cultivated a close daily relationship to God while working to establish over 40 schools.

Sister Rosa passed away in Rome, on May 7, 1728; she was beatified in 1952. It was not until sometime after her death that Blessed Rosa's lay school teachers were organized as a religious congregation: they are found in America as well as in Italy, for the Venerini Sisters have worked among Italian immigrants since early in the twentieth century. Saint Rosa was canonized on October 15, 2006 by Pope Benedict XVI. Her feast day is May 7th.

Desert Dance is a film set in Iran, and who better to create the original score than Emmy and Ivor Novello-nominated composer, Benjamin Wallfisch. One of the film's score highlights include three dance sequences especially created for the movie as a collaboration between Wallfisch and choreographer Akram Khan. One highlight that jumps out immediately is the nine-minute Desert Dancer. Wallfisch captures the essence of the film's tone with the themes for the characters that, along with the desert dance shows why composer Wallfisch is often nominated, and has worked on 42 movies to date. LUDOVICO EINAUDI - TARANTA PROJECT Ponderosa Music

Pianist Ludovico Einaudi shares his passion for 'taranta,' a musical form connected to the tarantula spiders often found in the fields of Salento. It was believed that their deadly bite could reputedly only be cured by the trance-like dance. His ability to mix classical and roots music is well known, and the boy from northern Italy finds that part of his heart is in Southern Italy's Salento. In a dozen slices Einaudi delivers tasty sounds as, Introducio ad regnum Tarantulae, the biting sound of Taranta, trailed by the soaring vocals of Fimmene, the spirited Nazzu Nazzu, the driving beat of Choros, and hits the midpoint with the energetic Core Meu. The second half is just as rewarding with the fast-paced, Tonio Yima/Rirollala, the haunting Mamma La Rondinella, setting the stage for ten breathtaking minutes of Preludio Nar-I-Sehar, the vocal gem Ferma Zitella, plus the polyphonic and rich orchestral harmonies of Santu Paulu Finale, and the solemn voice and piano beauty Nuvole Bianche.

TRON SYVERSEN - PIANO MEDITATIONS **TK Music Productions**

Piano Meditations is music for relaxation and well-being, compliments of musician Tron Syversen, who has created a stunning series of albums that have put him at the forefront of the new age music field. The liner notes describe this gem as "A contemplative album that will take you on a series of sacred meditations into the depth of your own soul." Syversen joins forces with the voices of Edler Lorentzen and Siri McAlpine, to deliver four tracks that represent relaxation music at its most sublime. No time is wasted as the group starts off their album with the spontaneous Tribute, trailed by No Blues No Really No Blues, the latter a rejoinder to Miles Davis' No Blues, sharing ideas between the three saxophonists on Past Progressive, using the chord changes of Irving Berlin's How Deep is the Ocean to deliver Deep High Wide Sky, and the unique, delicious sound of Strange Attractions then Birds. For your listening pleasure Berkman and friends add a piano trio version of No Blues No Really No Blues, followed by the lush, horn-laden West 180th Street, then a nod to the late jazz trumpeter Freddie Hubbard with the bop of Up Jumped Ming, sadly coming to an end with the simplicity of Psalm.

Thanks to the "fast growth of specialized scents in fabric softeners, household cleaners, and body sprays," the typical American smells "sweeter and cleaner than ever," said Drew Harwell in The Washington Post. BRACCIOLI (Served in Tomato Sauce)

4 thinly sliced beef steaks 3/4 cup flavored bread crumbs

1 tablespoon of grated Romano cheese 1 tablespoon olive oil

1 small garlic clove, chopped white thread

In a bowl, mix bread crumbs, chopped garlic and grated cheese. Add olive oil to slightly moisten the bread crumbs. Take one beef slice at a time. Spread some bread crumbs in the center of meat. Leave sides of meat about half-inch clear of bread crumbs. Gently roll from long end of meat, gradually folding in the sides so bread crumbs won't fall out. Roll the meat to the end. Squeeze the rolled meat in your hands. Take white thread, and wrap around the roll and sides of meat to secure ends from opening.

Brown on all sides in a skillet before adding to your tomato sauce. Cook in sauce about 45 minutes. Before serving, remove Braccioli from sauce. Let stand in platter a minute before removing thread. Then slice into 1/2-inch portions and serve separately or with cooked pasta.

NO LONGER STEM CELLS FROM AN EMBRYO: THE END **OF THE OLD WAYS.** A new technology has been elaborated to obtain stem cells, from one of the eight cells of an embryo without interfering with the developments, but making possible the growth of a single stem cell. The new technology puts an end to the ethic debate that for years has raged about the use of stem cells extracted from an embryo ending in the destruction of the embryonic stem cell. The magazine Nature Communication has described the new approach, conducted by an international research group working at the Swedish Institute "Karolinska." In reality the new technique consists in isolating a single cell, leaving the others to continue their development to create a new being, right in the uterus. The embryonic development, has been noted, appears to be quite accelerated, as observed, in the human

NEW MEDICAL DEVICES AND ELECTRIC CARS IN THE **NEAR FUTURE.** A little more than three years from Steve Jobs' passing, the time has come to think "differently," as Steve Jobs once stated, to go back and think "big." 

"It will be a big adjustment for every rookie. Welcome to the NFL ... they'll get a big dose of New England Patriots football ... the strong will survive. The other ones will fall off. And we'll keep going." Next up are OTAs (Organized team activities) beginning on May 26th. The 2015 season is a mere four months away.




Patriots Pick DT Brown 32nd Overall


As Miller says, "Teamwise-personally, it's been a good fit so far (as a Yankee). Hopefully, I've held up my end of the bargain.



HOOPS and HOCKEY in the HUB

HAL GILL COMPLETES A SWEET 16 — It's often been said that teams will look far and wide for potential talented players to sign in the National Hockey League. In the case of Hal Gill, the Bruins didn't have to look very far. There he was at home in Boston's west suburbs, about a half hour away from the Garden.

Gill, who had grown up surrounded by the history of this area, made some of his own during his career. Selected in the eighth round by the B's in the 1993 Draft, he would defy the odds that come with such a low choice by playing some 16 seasons in the NHL.

But first came college and a four-year career at Providence, during which the Friars won the 1996 Hockey East Championship at the Garden. That was a foretaste of the future for Gill, who within the next 18 months, would come to call the Causeway Street arena his permanent hockey home for the next several seasons.

He would make his NHL debut with the B's on October 17, 1997, record his first NHL assist on November 6th and then tally his first NHL goal on November 13th against the St. Louis Blues. By the time it came to say goodbye, those numbers had increased to 36 goals and 148 assists for 184 career points, while playing for 6 different franchises over the course of those 16 seasons. Indeed, this large 6-7, 240-pound defenseman left one big mark on the NHL.

And it could be said that Boston was fortunate enough to get the best of those Hal Gill years. He played in 68 regular season games and 6 playoff contests during his rookie season. Then during his second year (1998-1999) he played in 80 games, starting a streak of 9 straight seasons where he played in at least 76 games of the yearly 82-game regular season schedule.

During the 2001-2002 campaign, he put up 22 points as he helped the B's start a playoff run that lasted 3 consecutive seasons. The next season (2002-2003) he paced the Black and Gold with a plus 21 rating, the best of his career.

However, Gill will probably be remembered best as the victim of a Joe Thornton hit that came on January 10, 2006. Thornton, the former captain of the Bruins, had been traded to the San Jose Sharks back on November 30, 2005. When he left the Black and Gold Jumbo Joe was leading the Bruins in scoring. And when he returned that night, he was still leading the B's in scoring even though he hadn't played for them in over a month.

There had been a tremendous buildup for what was informally being called "Joe Thornton Night" and fans packed the Garden hoping to see Jumbo Joe play a comlittle over five minutes gone heart truly is.

in the first period, Thornton hit Gill from behind and drove him hard into the boards, injuring the defenseman. The refs not only assessed a checking from behind penalty, but also gave Thornton a game misconduct, meaning he could not continue to play. For the rest of the night, the man everyone had come to see was nowhere to be seen.

There comes a time for every player to leave the Bruins. For a special few, it comes with a retirement announcement. For most others, it comes through a trade or free agency. And thus, it was that, Hall Gill signed as a free agent with the Toronto Maple Leafs on July 1, 2006. After learning the game as a child in the Boston suburbs, after a superb high school career and a memorable collegiate career at Providence College and after 10 years with the Boston Bruins, Hal Gill would be permanently based outside New England for the first time in his life.

And he didn't disappoint. He played all 82 games for the Leafs while scoring 20 points. The next year (2007-2008) he set career highs in points (24 and assists 21. which he finished with Pittsburgh after being dealt to the Pens at the trading deadline.

Some might call that sad, but it was really Gill's salvation. Four months later there was Gill skating in the Stanley Cup Final. The Pens fell short, but the experience worked wonders for the next year (2009) Gill grasped the Cup, playing in all 24 playoff games in the march to the title. He shared that victorious moment with Bill Guerin and Sergei Gonchar who had also played with the Bruins in the past.

Next it was on to Montreal for the better part of three seasons. It was in October of 2011 that Gill would play his 1,000 NHL game, becoming only the 12th player in the long history of the Habs to achieve that milestone as a member of the Canadiens.

Trade talk became a reality again and in February 2012 Gill found himself sent to Nashville in a swap that would see him play portions of two seasons with the Predators. After that there was a final stop with the Philadelphia Flyers.

As with many long careers, it was one of high points and low points, straightaway's and curves, zigs and zags, challenges and cheers. Unlike many players it was played mostly in his home area, from youth leagues to high school, to college and Causeway Street.

But for all his travels over the last several seasons, Gil never forgot his home area. Today, he and his wife Anne and their three children live in Lincoln, just a few wheel spins from Concord where it all began. Proof that you can come home again plete game.
