Drunk Driving Identical Twin Calls Sister Who Shows Up Drunk Too

Memorial Day Speaker Gets Mic Shut Down

There was a bit of a drama recently in Hudson, Ohio when the keynote speaker at a local cemetery had his mic feed cut because of what he had started to say. The Akron Beacon Journal reports that after retired Army Lt. Colonel Barnard Kempter started delivering his remarks, organizers seemingly lowered the volume making his remarks unheard by those assembled. His speech apparently was censored when he went off his script and started talking about the origins of this somber holiday.

Kempter's remarks spoke of the origins of this holiday that was rooted in a ceremony held by freed slaves on May 1, 1865, when as many as 3,000 freed slaves among them 300 children came to honor the dead at the tattered remains of a Confederate POW camp.

The organizers of the event reportedly told the newspaper that the speaker was told what to tell the audience and that those remarks about the origins

The Continental Congress passed an act establishing an official flag for the new nation On June 14, 1777. The resolution stated: "Resolved, that the flag of the United States be thirteen stripes, alternate red and white; that the union be thirteen stars, white in a blue field, representing a new constellation."

Amateur poet Francis Scott Key wrote the "The Star-Spangled Banner," on September 14, 1814, inspired by the sight of the American flag still flying over Baltimore's Fort McHenry after a British attack. It officially became our national anthem in 1931.

The Pledge of Allegiance was written in August 1892. It was originally published in The Youth's Companion on September 8, 1892.

In its original form it read: "I pledge allegiance to my Flag and the Republic for which it stands, one nation, indivisible, with liberty and justice for all."

In 1923, the words, "the Flag of the United States of America" were added. At this time it read: "I pledge allegiance to the Flag of the United States of America and to the Republic for which it stands, one nation, indivisible, with liberty and justice for all."

In 1954, in response to the Communist threat of the times, President Eisenhower encouraged Congress to add the words "under God," creating the 31-word pledge we say today.

Bellamy's daughter objected to this alteration. Today it reads: "I pledge allegiance to the Flag of the United States of America, and to the republic for which it stands, one nation under God, indivisible, with liberty and justice for all."

Section 4 of the Flag Code states:

During The Pledge of Allegiance one should be standing at attention facing the flag with the right hand over the heart. When not in uniform men should remove any non-religious headdress with their right hand and hold it at the left shoulder, the hand being over the heart. Persons in uniform should remain silent, face the flag, and render the military salute."

The original Bellamy salute, first described in 1892 by Francis Bellamy, began with a military salute, and after reciting the words "to the flag," the arm extended toward the flag.

Shortly thereafter, the pledge begun with the right hand over the heart, and after reciting "to the Flag," the arm was extended toward the Flag, palm-down.

In World War II, the salute too much resembled the Nazi salute, so it was changed to keep the right hand over the heart throughout.

On August 3, 1949, President Harry S. Truman officially declared June 14th as Flag Day.

The colors of the flag are symbolic as well; red symbolizes



hardiness and valor, white symbolizes purity and innocence, and blue represents vigilance, perseverance and justice.

There are a few locations where the U.S. flag is flown 24 hours a day, by either presidential proclamation or by law:

- Fort McHenry, National Monument and Historic Shrine, Baltimore, Maryland
- Flag House Square, Baltimore, Maryland
- United States Marine Corps Memorial (Iwo Jima), Arlington,
- On the Green of the Town of Lexington, Massachusetts
- · The White House, Washington, D.C.
- United States customs ports of entry
- Grounds of the National Memorial Arch in Valley Forge State Park, Valley Forge, Pennsylvania

Raise Up Massachusetts Applauds **Fair Share Amendment Vote by Constitutional Convention**

Tax on Million-Dollar Incomes to Fund Transportation and Public Education Will Appear on November 2022 Statewide Ballot

State legislators voted 159-41 to place the Fair Share Amendment, the proposed state tax on incomes above \$1 million, which would raise approximately \$2 billion a year for spending on transportation and public education, on the November 2022 statewide ballot. The Raise Up Massachusetts coalition of community organizations, faith-based groups, and labor unions, which has led the campaign for the Fair Share Amendment since 2015, issued the following statement in response:

"We applaud the state Legislature for voting to place the Fair Share Amendment on the ballot, and for giving the people of Massachusetts the opportunity to vote on this vitally important proposal.

"Right now, our economy is working great for those at the very top, but it's not working for the rest of us. That's because Massachusetts hasn't been making the investments that are necessary to create broadly shared prosperity. The Fair

Share Amendment simply asks individuals with incomes above a million dollars in a single year to upgrade our roads, bridges, and public transportation.

"Giving every student access to a high-quality public education, upgrading our crumbling transportation infrastructure, and making our public colleges and universities affordable again is the best way to lift up our economy for everyone, and to ensure Massachusetts remains a great place to live, work, and raise a family. The Fair Share Amendment would provide sustainable, long-term revenue for investments in transportation and public education, without asking low- and middle-income families to pay a penny more."

The campaign to pass the Fair Share Amendment on the November 2022 ballot is already in full swing, with more than a dozen local rallies happening across the state this month. During the rallies, speakers will address the need for major

investments in transportation and public education, and call for million-dollar earners to to pay a little more to improve our pay their fair share to support public schools and colleges, and our economic recovery and the public services we all depend on. More than 100 organizations and hundreds of activists across the state are working together through the Raise Up Massachusetts coalition to win the Fair Share Amendment on the ballot next year.

BACKGROUND ON THE FAIR SHARE AMENDMENT

The Fair Share Amendment is a proposal to amend the Massachusetts Constitution, creating an additional tax of four percentage points on the portion of a person's annual income above \$1 million. The new revenue generated by the tax, approximately \$2 billion a year, would be spent on "quality public education and affordable public colleges and universities, and for the repair and maintenance of roads, bridges and public transportation." Saint Maria Crocifissa Di Rosa

Paola Francesca Di Rosa was born on November 6, 1813 in Brescia, Italy as one of nine children born to the rich industrialist Clemente Di Rosa and Countess Camilla Albani.

Losing her mother to a terminal illness at age eleven, her education was entrusted to the Visitation Sisters. At seventeen, Paola left school to assist in the running of her father's estate and household. To these duties she soon added the care and spiritual welfare of the girls working at her father's mills and other factories in the city.

Paola also founded a woman's guild and arranged retreats and special missions. When the cholera epidemic devastated Brescia in 1836, she and a widow, Gabriela Bornati, served the victims in the hospital with such dedication that Paola was next asked to undertake the supervision of a workhouse for penniless girls, which she did for two years.

In 1840, with Gabriela Bornati, she started a congregation with her contemplation.



the purpose of serving the sick and suffering in hospitals. Taking the name of Handmaids of Charity, they started with four members and soon grew to number twenty-two.

Paola took the name Maria Crocifissa upon her profession of religious vows, it was a synthesis of her whole life, very spiritual life was firmly grounded on the imitation of Christ's suffering on the Cross. This was the foundation of her life, her teaching and

As the community expanded, her father provided a large house in Brescia, and their rule of life was provisionally approved by the bishop in 1843. Anticipating Florence Nightingale by several years, the Handmaids of Charity ministered to the wounded in the war which ravaged the region

After a meeting with Pope Pius IX in 1850, the constitutions of the Handmaids of Charity of Brescia were approved.

A second cholera epidemic hit northern Italy and pushed the growing order to its limit. After establishing foundations in Spalato, Dalmatia, and Verona, Mother Maria collapsed, and was brought home to Brescia

She passed away peacefully on December 15, 1855, at the age of forty-two.


Maria was Canonized on June 12, 1954. The Feast of Saint Marcia Crocifissa Di Rosa is December 15th.




VITRUM!

The stained glass treated in the last issue highlights a French contribution to ecclesiology. The Italians, especially those of Renaissance Italy, expended little effort on stained glass compared to their work in other media, such as painting and sculpturing. But the ancient Egyptians were among the earliest contributors to the glass culture and technology.

The oldest specimen today is an opaque blue Egyptian glass vase, which is now in the British Museum; it dates back to the sixteenth century B.C. Even the Egyptian tombs and mummy cases contained glass cups and bottles in considerable numbers, and in some paintings (about 2300 B.C.), the process of glass blowing is clearly depicted.

A story is told by one ancient historian that the discovery of glass was quite by accident. The River Belus in Phoenicia contains a sandy beach that stretches for about a half mile. The story goes on to relate that a ship belonging to some traders in natural soda put in here and built a fire to prepare their meal. Since, however, no stones suitable for supporting their kettles were available; they rested them on lumps of soda from the cargo. When these lumps became heated, and were completely mingled with the sand on the beach, a strange translucent liquid flowed forth in streams; and this, it is said, was the origin of glass, as we know it.

Sand from this district proved to be particularly suitable for glass making and was exported in great quantities to workshops in other areas. Alexandria was another center for glass making with a sustained reputation for many centuries.

Phoenician glass has been found in Etruscan cemeteries and we are told that glassdrinking cups were used to replace those of gold and silver. One historian said that glass cups sold in his time for a paltry sum of half an "as" (a Roman copper coin having a value of less than one cent).

I remember sitting in a car idling outside of Woolworths at Liberty Plaza in August of 1993, just waiting for my mom to pick something up there, when I heard the "boom heard round the hub." I had no idea what was going on, but the mirror and all the glass in the car was quaking as if a dinosaur from Jurassic Park were stomp-





Town of Sharon, Massachusetts Targets Columbus Day

The Town of Sharon is considering eliminating Columbus Day and replacing it with Indigenous Peoples Day. International Indigenous People's Day is celebrated on August 9th; Native American Heritage Day is celebrated the Friday after Thanksgiving, and the entire month of Native American Heritage Month. We have posed the question: Why is the Town of Sharon targeting Columbus Day?

As both Italian-Americans and Native Americans are protected classes of minorities and suffered extreme discrimination, throughout America's history, the Italian-American Alliance of Massachusetts opposes pitting one ethic group against others. Such actions are a violation of protected civil liberties and the Italian American Alliance considers such acts as racist and bigoted.

The Italian American Alliance is soliciting support for keeping Columbus Day a recognized holiday on the Sharon Town calendar in alignment with the Federal and State holidays and urge the Selectmen adopt the last Friday of November as Native American Heritage Day in conjunction with the Federally recognized Native American Heritage Day.

Although this particular effort is focused on the town of Sharon, Massachusetts, we believe that this effort to erase Christopher Columbus from a prominent place in American history is part of the campaign to fundamentally transform American culture and values. We are writing to you as representatives of the Italian-American Alliance, of Massachusetts. The Italian-American Alliance is the largest Italian-American cultural organization in New England with

Recently, your community has been debating changing Columbus Day in favor of Indigenous People's Day. This contentious issue has increased divisions among all of our communities.

Christopher Columbus is the penultimate symbol of the Italian-American and immigrant communities. The origins of Columbus Day in the United States are founded in the very principles of equality and justice. The view of Columbus in Italy, carried forward by many Italian-Americans, is that Christopher Columbus is an inspiration, an example of perseverance for taking an action which changed the world.

Italian-Americans were one of the most oppressed and discriminated ethnic groups in America. In fact, in Massachusetts in 1921 a jury convicted and sentenced to death Sacco and Vanzetti based on anti-Italianism and anti-immigration sentiment.

Only in 2019 did the city of New Orleans apologize for the largest mass lynching to have ever occurred on American of 11 Italian immigrants living in New Orleans in 1891. After being acquitted of the crime of murdering a popular police officer, an unruly and violent Jim Crow mob lynched them. In a showing of remorse with the sincerest apologies, President Benjamin Harrison proclaimed Columbus Day of 1892 a national holiday. Ten years later President Franklin D. Roosevelt and Congress established October 12, 1937, as the Columbus Day national holiday. In so doing forever intertwined the history of Columbus with the forming of America as the cultural and ethnic symbolism to not only the Italian-American community, but also the American public. This was a step in bringing about credibility and acceptance of Italian immigrants.

The alleged misdeeds of Christopher Columbus are derived from one historian, Howard Zinn; who has been routinely and roundly discredited by modern researchers and scholars like Dr. Mary Grabar in her book Debunking Howard Zinn (https://www.youtube.com/watch?v=BtNfqJx40IM). Moreover, Georgetown University professor and Zinn contemporary Michael Kazin proclaimed Zinn's publication as "polemic disguised as history. Modern scholars have made clear that genocide is the deliberate action of a government to eliminate an entire group of people. Genocide is NOT the accidental clash of microbes.

On the charge of slavery, historians note that native indigenous people had been enslaving each other for many hundreds of years before Columbus ever left Spain. Additionally, Ryan P. Smith, writing for the Smithsonian Magazine reminded us that Indigenous tribes, most notably the "Five Civilized Tribes" of the Cherokee, Chickasaw, Choctaw, Creek and Seminole, openly practiced chattel slavery and held African slaves. Choctaw Chief Greenwood LeFlore owned over 15,000 acres of land in Mississippi and held over 400 African slaves. Cherokee Chief John Ross was not only a slave owner, but after the events of the Trail-of-Tears, he and many other tribal chiefs joined the Confederate States of America and fought with the South to preserve slavery.

In contrast, according to Stanford Professor Carol L. Delaney's book Columbus and the Quest for Jerusalem, Columbus not only never owned a slave, he also never participated in the institution of chattel slavery. Columbus has been miscredited with beginning the transatlantic slave trade when after retaliating against the local and cannibalistic Carib Tribe, he captured approximately 40 prisoners of war, presented them to the Spanish Crown, who subsequently released those captured; as was customary across the globe. Further, it is well documented that Christopher Columbus supported the indigenous peoples he met and advocated on their behalf to the King and Queen of Spain and the Pope. Christopher Columbus support of the indigenous tribes was so sincere, particularly toward the Taino peoples; he adopted a Taino boy as his own son.

In closing, Columbus Day symbolizes unity, a fight against racism and discrimination against all immigrants and minorities living in the United States. To not protect Columbus is to discriminate against Italian Americans and their national origin. (please see Courage and Conviction: The True History of Christopher Columbus https://www.youtube.com/watch?v=NJliggj1kOs.) I urge you to preserve October 12th as Columbus Day, and join me in the fight for social justice by recognizing the last Friday of November as Indigenous Peoples Day to coincide with Native American Heritage Day; a holiday established by federal law in 2008 and subsequently recognized by 184 indigenous tribes and the National Indian Gaming Association.

L'Anno Bello: A Year in Italian Folklore

Unwrapping the Gift of Each Month

At the beginning of the month, I have a special ritual. I open to the new page on my desk calendar and look through the days of the month, decorating holidays or anniversaries with quirky doodles. Each new month is like an unwrapped gift, quivering with anticipation and a sense of mystery. Indeed, I have always been fascinated by months and, more importantly, their essence. In my mind, every month of the year has a unique character, an underlying trait that sets its days apart from those of other months. Holidays, saints' days, superstitions, family occurrences — all of these events add up to a rich and particular tapestry that typifies any month. During the olden days, when society was primarily based on agriculture, people viewed months as separate entities, depending on the weather and cycles of the sun and moon to help them plant. This is a much more romantic view than the way we perceive months in the modern era, when calendars are synonymous with busy schedules and frozen fruits allow us to eat out of season. I believe that we should reclaim the aura of uniqueness that surrounds each month, enjoying them for their own properties and emotions. For a model on how to do this, we must turn to Italy.

The magic of each month is deeply ingrained in Italian folklore. No matter the season, one can be sure that any given month abounds with its own proverbs and superstitions. Take our current summery month of June. In Italy, the peasants of yore bequeathed a number of weather-related proverbs that looked ahead to the harvest of late summer, or simply commented on the climate that characterized the

month. One saying declares: "Giugno ventoso, porta presto il grano sull'aia," meaning that a windy June will soon bring the grain to the farmyard. Another proverb, which reads "In giugno, in bene o in male, c'é sempre un temporale," warns that in June, no matter how good or bad the weather has been, there will always be a rainstorm! Other proverbs relate to the feast days of the saints, which dot the Italian calendar and provide people with a focus for religious devotion and a reckoning system for determining important dates in the agricultural year. Italians may repeat the rhyme "Per San Barnabá, il piú lungo della 'sta." This roughly translates that the feast day of St. Barnabas, or June 11th, is the longest day of the summer, referring to the fact that this date actually coincided with the summer solstice in the years before the Gregorian calendar reform. A charming yet slightly foreboding dictum declares: "La notte di San Giovanni, ogni erba nasconde inganni." This means that on June 23rd, the eve of St. John the Baptist's feast day, every herb hides some form of deceit — a callback to the old tradition of gathering herbs on this night, when it was believed that the magic of the summer solstice imbued them with mystical healing properties. Finally, other proverbs simply relish the bounty of nature available in June, such as "Giugno ciliege a pugno," which means that cherries are plentiful in June. What a lovely month these proverbs reveal!

May translates to an abundance of flowers and the first hints of summer heat from a brightly shining sun. June is the end of the school year, a month of outdoor excursions and mysterious evenings eating out under the pale twilight of late evening. July includes fireworks bursting across a starry dark sky, trips to the rolling ocean waves or the energetic city. August is golden, like ripening grain, with mornings that smell like the woodsy charm of autumn. September means harvest and rhythm, red and yellow leaves and the glorious crunch of apples. October is synonymous with shadowy nights and glowing pumpkins, with the wind spookily whistling through bare tree branches. November simultaneously means the chill of early winter and the warmth of family gatherings, sharing an abundance of food. Finally, December envelops jingling bells and flickering candles, holidays of light and family and goodwill. Collectively, all the months complement each other, adding to that indelible cycle we call the year.

This month, think of all the wonderful feelings and sensations that June brings to you, whether they relate to the summer season, a birthday or anniversary, or even a food you enjoy. We all would reap the benefits of living each month for its uniqueness, as this allows us to focus on the present moment and relish all the beauty that life and nature afford. Let us go on to look at each month not simply as a page on a calendar, but an opportunity ripe for celebrations and markings of the passage of time. That way, every month is a proverbial gift for us, granting us both the transience and endurance of time.

Boston Universal Pre-K Accepting Applications for 2021-22 School Year

UPK Expanding to Offer Up to 750 Seats in Community Settings, Begins Pilot Program for 3-Year-Olds

Boston Universal Pre-K (Boston UPK), an initiative of the Boston Public Schools (BPS) and the City of Boston, has opened applications for prekindergarten seats in community-based settings for the 2021-2022 school year. Prekindergarten (pre-k), also known as K1, is offered in the City of Boston at no cost to families. Eligible students must be Boston residents and turn four years old on or before September 1, 2021. Three-year-old students in the new, limited pilot program in community-based settings must turn three years old on or before September 1, 2021.

Boston offers a mixed-delivery pre-k system, which includes options in both BPS classrooms as well as community-based centers across the city. Boston UPK is entering its third year of serving pre-kindergartners in community-based settings, including child care centers and neighborhood community centers.

As of the 2020-2021 school vear. Boston UPK serves 41 classrooms at 31 sites funded under 18 community organizations across the City of Boston. Pre-k curriculum and quality in community-based settings are aligned with that of K1 in BPS classrooms. This includes using the nationally recognized Focus curriculum, providing a 6.5-hour school day for 180 days per year, and aligning community-based teacher qualifications, starting salary, and professional development with that of BPS school staff.

Expansion to allow for pilot-

ing 3-year-olds in UPK: As a new pilot program in the 2021-2022 school year, Boston UPK will serve a limited number of 3 year olds, in addition to 4 year olds. Existing Boston UPK community-based sites will be given the option to have mixed classrooms with up to 25% of seats in each classroom for 3 year olds. Not all Boston UPK sites may serve 3 year olds, and Boston UPK hopes to expand the program in subsequent years.

"The Boston UPK program provides a high-quality preschool education for every 4-year-old in the city, preparing students at an early age for school and in life through developing routines, building social, emotional, and critical thinking skills," said Boston Mayor Kim Janey.

Registration is now open for pre-k for the 2021-22 school year: Applications are now open for Boston UPK seats in community-based settings. Applications are accepted on a rolling basis, and there is no deadline to apply or enroll. However, applying early provides a greater likelihood of locating open seats in or near a family's neighborhood. Parents and caregivers can find more information on Boston UPK in community-based settings and complete an application at: bostonpublicschools.org/upk.

"Boston Public Schools is excited to offer the pre-k experience at no cost to families to more of our youngest learners in Boston. Boston UPK seeks community partners through

grant application process:

Boston UPK is looking to identify prospective community-based sites interested in being grant-funded under Boston UPK to expand the number of centers that serve as Boston UPK sites. Community-based organizations or early learning centers interested in becoming a grant-funded Boston UPK site can find more details and the Grant Application at: www. bpsearlylearning.org.

In 2005, Boston made a commitment for accessibility to preschool for all 4 year olds in Boston. In 2013, Boston became a recipient of the Preschool Expansion Grant, which continued until 2019. In 2015, the City emphasized high quality - not just expanded access - to preschool, and in 2019 Boston announced the \$15 million Quality Pre-K fund to provide the startup funding for additional seats in communitybased settings. Boston UPK is funded through the City's Pre-K Fund, Boston Public Schools district funds, and public and private philanthropy.

In 2020, the Boston School Committee approved a Connector system to ensure continuity of the kindergarten experience for students in Universal Pre-K in community-based organizations transitioning to kindergarten within BPS. In 2021, Boston Mayor Kim Janey approved expansion of Boston Universal Pre-K to allow a limited pilot program for 3-year-olds to provide relief to families most impacted by the COVID-19 pandemic.

ensure that the tax continues to apply only to the highest income taxpayers, who have the ability to pay more, the \$1 million threshold would be adjusted each year to reflect cost-of-living increases.

Massachusetts needs fair and sustainable funding to meet our long-term needs for investment in transportation and public education. Now more than ever, we need investments in our public schools to help students recover from the effects of the pandemic, and to ensure that all students have access to a complete and well-rounded education. We have a large backlog of neglected and structurally compromised bridges, tunnels, roads, paths, and public transportation infrastructure in need of repair. Tuitions and fees at our public colleges and universities are among the highest in the country, and students are forced to take on enormous debt to receive a degree.

As we recover, new revenue is necessary to improve our public schools and pre-K programs; rebuild crumbling roads, bridges, sidewalks, and bike paths; make high-quality public higher education affordable; and invest in fast and reliable public transportation. Long before the pandemic, we needed new investments in our transportation and public education systems, and now those investments are needed more than ever to lift our economy into an equitable recovery and tackle the longstanding racial inequities that hold our state back from its full potential.

Our wealthiest residents can clearly afford to pay a little more to fund the investments we all need. For years, the highest-income households in Massachusetts — those in the top 1 percent — have paid a smaller share of their income in state and local taxes than any other income group. They've also benefited from repeated federal tax cuts: 83 percent of the 2017 tax bill's benefits went to the top 1 percent, and in 2020, the federal CARES Act included \$135 billion in tax breaks for wealthy business owners. And while countless people and small businesses suffered during the COVID-19 crisis, multimillionaire investors saw their net worth skyrocket. The 20 billionaires in Massachusetts saw their wealth increase by a total of \$17.2 billion during the first seven months of the COVID-19 pandemic alone.

A previous citizen's initiative version of the Fair Share Amendment, initiated by members of the Raise Up Massachusetts coalition, received over 157,000 signatures from Massachusetts voters in 2015. The Fair Share Amendment was supported by a large majority of Massachusetts voters in repeated public polling and was set to appear on the November 2018 ballot, but the process of qualifying the question for the ballot was challenged by a corporate-backed lawsuit, and it was removed from the ballot by the state's Supreme Judicial Court. Nothing in that Supreme Judicial Court ruling, which related to the citizens' constitutional amendment process, applies to the legislative constitutional amendment process that was used to place the Fair Share Amendment on the November 2022 ballot.

Public support for the Fair Share Amendment has remained consistently strong over the years. Independent polling conducted by the MassINC Polling Group in December 2020 found that 72 percent of Massachusetts voters support the Fair Share Amendment. while UMass Amherst found in March 2021 that 65 percent of Massachusetts residents support the amendment, including 52 percent who strongly support it.



A Nostalgic Remembrance



MY FIRST CAR ... Back in the day, most young men had a love affair with their first car. I was no different, but the car was purchased out of necessity rather than for pleasure.

As a mid-1950s teenager hanging out on a street corner in East Boston, I observed most of the guys in my age group buying cars. Those that did were the ones who had quit school and gone to work. What they could afford usually included late '40s and early '50s cars that were around \$500. I worked part-time at the Seville Theater and couldn't afford to buy a car as of yet, so I became part of the crowd that pitched in for gas when we went somewhere as a group.

When I decided to study bass, Dad taught me well and I learned fast, spending more and more time practicing. Just as I began my second year of college (September of 1957), I began playing professionally and worked with other musicians and small bands from East Boston, and there was always someone to pick me up for the jobs we played. As my reputation grew, I began getting calls from some of the better-known bandleaders to perform with them. None of them were from East Boston, which meant that I needed my own transportation to get to a specific location. Dad couldn't drive me as he worked with bands that played just about every night, and even if he could drop me off on his way to work, there was no way he could fit two bass violins and two people in a 4-door Chevy. Babbononno didn't drive nor did my mother, so, I was out of luck. I had to pay street corner friends to take me to work and pick me up, but that was often difficult as most of my jobs were on weekends and my friends with cars either had dates or were heading to dances or parties on weekend nights. With difficulty, I survived.

One day, at the beginning of my sophomore year in college, Dad told me that he had a friend who owned a garage in Malden and he had a 1954 Chevy that he had done over from bumper to bumper, motor job, paint job, new tires, new upholstery, etc. I could have the car for \$550. We road tested the car, a model 150, the low end of Chevy models back then, and I loved it. The only luxuries were a radio and heater. What made it practical was a 90-horsepower, six-cylinder engine, and the fact that both I and my bass violin fit comfortably inside.

I looked at my East Boston Savings Bank book and saw

that I had exactly \$550 dollars saved. Most of it was savings from when I washed and waxed cars and later from what I earned as an usher at the Seville Theater. So, I bought the car. Now, there was another problem. I had to register the car and insure it. That total cost was, ironically, \$550. When I told Dad I had a problem, he told me that I had \$550 in the bank. I assured him that I didn't, having spent it on the purchase of the '54 Chevy. He assured me that I did have the money. When I looked at my bank book, I saw that there was a deposit of \$550 that had been made. Dad rescued me and I put the car on the road.

After driving it for a couple of weeks, I couldn't stand looking at the black wall tires. I couldn't afford new tires and opted for what we called "falsies." They were white wall inserts that could be attached to black wall tires to make them look like white walls, and with them, my first car was complete. Mom bought me a blessed medal. One half is of St. Christopher and the other half is Our Lady of the Highways. I've had it pinned on the visors of every car I've owned since.

That '54 Chevy had a small engine, a 90-horse power Blue Flame six cylinder with a standard three-speed column shift. Driving carefully, I got about 20 miles per gallon on low octane gas, which made the car economical. When there was a gas war between gas stations in Chelsea (5 gallons for a dollar), instead of putting in \$2.00 worth of gas, I would fill the tank. I was all set for the next couple of years.

I graduated from college in May of 1960, and accepted a job teaching drafting and graphic arts at Tewksbury High School. My '54 Chevy became part of a car pool with three other East Bostonians who also taught at the school. The rest of the faculty called us the "East Boston Express." We four, Joe Crotty, Jim DeMento, Paul Ciccarelli, and I would take turns driving, which meant that I would drive one week per month from Eastie to Tewksbury. I now had three incomes: I stayed working at the Seville Theater a couple of nights per week after college, played music on weekends, and I had a salary from Tewksbury, so money wasn't an issue any longer.

One day as we four members of the East Boston Express exited my car in the parking lot of the high school, one of the rear seat passengers went through the floor and was standing on the muffler. I pulled up on the rubber mat that covered the floor and there was no floor. It had rotted out. When I got home, I pulled the rubber mat out from the other side of the back seat and pulled up the same mat from the front seat area. The floor and part of the body of the '54 Chevy were rusted out, which meant that I either was going to need extensive bodywork, or I was going to have to buy a new car. It was now 1962, and time for me to say goodbye to my first car.

I had a student whose father was the used car manager at Wilmington Ford. My student set up a meeting and I spotted a 1958 Thunderbird sitting among their offerings to the used-car buying public. The car had been factory supped-up and after I test-drove it, I had only two words for the seller, "How much?" They offered me \$550 for my '54 Chevy, exactly what I paid for it four years earlier, and so, I bought the Thunderbird.

The TBird was fast, comfortable, and the first 4-seater in the Thunderbird line, which meant that my bass violin fit inside. But, it wasn't the same. My first car and I had had a love affair, just because it was my first car. After purchasing my first Ford product, I discovered that men (maybe women, too) had love affairs with their cars. I used it to head to school, to work, and to take lady friends parking at night in Wood Island Park until the police from Station 7 swung through and kicked us all out.

I used that first car to take Mom and Babbononno places they wanted to go as neither drove. I've owned many cars since that '54 Chevy, the TBird I mentioned, a couple of Lincolns, several Cadillacs, two Imperials, and a Mercedes here and there, but none could compare with my first set of wheels, a used '54 Chevy six cylinder. Like most men, I had a love affair with my first car, a vehicle I'll never forget.

Torta salate or savory pies are made throughout Italy in a variety of ways, from vegetable variations to those with assorted meats and cheeses, or even a combination of both. The ingredients used varies throughout the regions, yet regardless of the filling, all are encased in a shell made from a savory Italian shortcrust pastry or a flaky buttery dough. These savory pies are similar to those known of the French accent known as the "quiche". However, the torta salate's filling is made up mainly of vegetables, meats, and cheeses, while the quiche has a prominent egg and cream base.

Savory pies have been in my family for years. Typically, when they are made for an occasion, the filling is based on the ingredients that are in season and available. On the other hand, in pure Sicilian "cuccina povera" style, my Nonna would also make a torta salate, just as she made her frittatas, from leftover ingredients that she had on hand. Savory pies are delicious when eaten for breakfast or lunch, and this Torta Salata Zucchine e Patate, served at room temperature, can be enjoyed at any of your family gatherings or summer events!

ZUCCHINI and POTATO SAVORY PIE Torta Salata Zucchine e Patate



1 roll of puff pastry 4 cups russet potatoes,

- sliced thin 6 cups zucchini, sliced thin
- 1 onion, sliced thin
- 1/4 to 1/2 cup olive oil
- 4-6 ounces pancetta, optional (if you prefer all vegetable, just eliminate as I did)
- 1 pound of fresh mozzarella, cut into bite sized cubes 1/4 cup freshly grated parmigiano-reggiano cheese 1 extra-large egg, beaten
- 1 egg yolk, beaten, to brush pastry salt and freshly ground black pepper

In a large frying pan, add some of the oil and sauté the onion (and pancetta, if desired) until cooked, add the potatoes, and continue to cook until the potatoes slightly soften, not too much. Remove all ingredients with a slotted spatula and set aside. In the same pan, add more oil and fry the zucchini, one layer at a time, removing when cooked with a slotted spatula and then allow to dry on absorbent paper towel.

In a large bowl, add the beaten egg, parmesan cheese, and salt and pepper, beat together well. Add the mozzarella cubes, onions, potatoes and zucchini, fold together well.

Preheat oven to 350°. Roll out the puff pastry to fit into a 9-inch pie plate or tart pan, with an extra 1½ to 2 inches hanging over the sides (to fold over the ingredients). Add the ingredients, level, and then fold the edge of the crust over evenly around the torta (it almost looks like a crostata). Brush the visible edges of the crust with the beaten egg yolk and bake for about 35 to 45 minutes or until the ingredients are cooked and the pastry is a golden brown. Let cool before cutting.

As of now, the pool is **unofficially scheduled to open June 30**th. That date may change. The registration process will be the same process as last year. All registrations are done online through the city website. The website is *boston.gov/bcyf*. The city will no longer be collecting money orders, cash, or checks for payments. This year there is no fee for City of Boston residents. The city memberships for the pool are currently not available. Please keep checking the website for updates.

POOL-SPECIFIC GUIDELINES

- Due to capacity limits to enhance visitor safety, visitors must register for a swim time slot *through our registration system*. Walkins will not be allowed. Registration will go live 24 hours before the following day's sessions and will remain open until all spots are taken or until the session is half over, whichever comes first.
- Sessions will be time-limited. Visitors are asked to register for and attend one session per day. If visitors register for more than one session per day, we reserve the right to cancel their registration if there is a waitlist of individuals looking to attend.
- Visitors are asked to arrive not more than 10 minutes before the start of their session. They will be asked to maintain six feet of distance from others while waiting outside of the facility for the session to begin.
 - Capacity guidelines limit visitors to 75 per session.
- Preference will be given to Boston residents.
- Visitors must come dressed to swim as locker rooms and changing areas will be closed.
- Restrooms (if access is required) can be accessed through a locker room. But, visitors cannot use the lockers or changing area.



Mike Marshall was the Real Rubber Band Man and a Cy Young Winner, Too



Mike Marshall, 1969

Mike Marshall became the first MLB relief pitcher to win a Cy Young when he set a MLB record by pitching in 106 games for the LA Dodgers back in 1974. He pitched in the majors from 1967 through 1981 for nine teams, compiling a 97-112 record and 3.14 lifetime ERA. He also threw 880 strikeouts and 188 saves.

Marshall won the Cy Young Award in 1974, going 15-12 with a 2.42 ERA and 21 saves. He was nicknamed "Iron Mike" and "Rubber Arm" setting records for most appearances in relief (208.1), games (83) and consecutive games pitched (13). He was an All-Star in both 1974 and 1975 with the Dodgers.

He began his career with the Montreal Expos in 1970-73

and had a 1.78 ERA with them in 1972. Marshall also played for the Atlanta Braves and Minnesota Twins before finishing up with the NY Mets in 1981. With the Twins in 1979, he set the AL Record with most season game appearances (90). This guy had a demon screwball that broke in opposite directions of a slider and curveball.






SUMMER READING

Some Suggestions

This is the time of the year when summer reading lists become ubiquitous. I'm not sure if most people spend a lot of their summer immersed in books, but for those who do I thought I would offer up a few choices from the world of boxing. Not all are recent, but they are all available and you shouldn't have a problem finding copies.



Ali: A Life by Jonathan Eig is the definitive biography of the self acclaimed Greatest. The book is deeply researched and covers Ali's life from childhood until his death. The book flows, and though weighing in at 672 pages is a smooth read. My only criticism of it is that while Mr. Eig includes the warts and all of the Champ's live, in the end he hesitates when assessing the plusses and minuses.



Sucker Punch by Jack Cashill is the perfect book to read in conjunction with Mr. Eig's work. Written in 2006, in Sucker Punch Mr. Cashill is not afraid to be completely honest about Ali's flaws. His book is also well researched and in depth. It is refreshing in that the author is not in awe of


Muhammad. Out of the hundreds of books written about Ali the vast majority worship before the myth. This is unfortunate in that the unvarnished Ali is a more interesting figure than the manufactured one. In reading Jack Cahill's book you will find that to be true.

While on the subject of Ali, there are two other books that should not be overlooked. The first is Blood Brothers: The Fatal Friendship Between Muhammad Ali and Malcolm X by Randy Roberts and Johnny Smith. This is a fascinating look at the young Ali along with the man who stood by him and who was a great influence on his life, Malcolm X. The insight into the lives of the two men is fascinating, and the betrayal of Malcolm by his young friend is disturbing and tragic to read about. It also tells the story of the Nation of Islam (The Black Muslims) and how deeply involved and controlled by them Ali was. Not much attention is given to them in the myth of Ali, but for years he spouted their racist and fanatical hatred. In reading about this relationship it makes if hard to reconcile Ali's becoming known as a great Civil Rights leader. He certainly was not.


Mark Kram's **Ghosts of Manilla** is built around the third Ali/Frazier fight, but goes into detail about the relationship between the two men. It is one of the few works about the two that gives Joe Frazier the respect and credit he deserves. Reading about them side by side makes one think hard about who was the better role model. It left little doubt in my mind that Joe Frazier comes out on top.

Getting away from Ali, I have a couple more enjoyable reads.

Glass City by Paul Beston is a historical novel that centers on the Jack Dempsev vs Jess Willard fight that took place in Toledo, Ohio in 1919. While written as a novel it is fact filled. The book brings us back to that hot July 4th and the days leading up to the fight. With a mixture of fictional





HOOPS and HOCKEY in the HUB

ANOTHER SIDE OF AN ICONIC COACH — When one sees, hears and reads about well-known people involved in athletics, it often comes with the assumption that what one is learning about the famous person is uplifting, worthy of our attention and our praise.

But sometimes something is not told, or if it does make the media, it is buried in a story or just mentioned in passing by broadcasters.

Thus, it was somewhat disheartening to learn that Coach Mike Krzyzewski, the veteran men's basketball coach at Duke University, who will be retiring at the end of the 2021-2022 season, has an aspect of his behavior that we view as less than positive.

We learned this by reading sports columnist Ian O'Connor's piece in the *New York Post* the day after the coach revealed that next season would be his last.

We don't often quote extensively from others in the media but we thought it relevant here — especially since O'Connor opened his column with remarks that seemed to run counter to the personality and prevailing image of Coach K that is projected by the media.

"The first time I sat directly behind the Duke bench, I could not believe what I heard," wrote O'Connor in a piece entitled The Source of Mike Krzyzewski's legacy — Fueling Rage.

"Mike Krzyzewski was already an all-time great basketball coach, but I had no idea that he was a world-class curser, too. Even a drunken sailor would have insisted that he be ejected from the game.

Coach K's profanity knew no bounds. Refs, players, assistants, you name it — nobody was spared. I remember thinking to myself: 'There are a lot of grandmothers across America who adore this guy who would be mortified if they sat within 15 rows of him.'"

O'Connor does not say exactly when he sat "directly behind" the Blue Devils bench but obviously it wasn't early in Krzyzewski's run, which has encompassed 41 years at Duke and 46 seasons overall. Prior to coming to Duke, he had first played and later coached at West Point. He also served in the U.S. Army for several years.

What is telling is that the night O'Connor did take his seat near the coach, "he was already an all-time great basketball coach." Yet no one in authority at Duke or the NCAA had apparently requested or specifically required that he modify the comments he would routinely make during a game.

One needs to pause and consider that for a moment. Could you imagine if other persons with a high standing at Duke University (or any other school for that matter) conducted themselves in such a manner — and in public no less.

Consider the ramifications if a member of the Duke faculty used such language while conducting a class. How about a dean speaking to an assembly of faculty members or even the institution's president addressing the Duke community as a whole? There would be an uproar — and rightly so. How would such behavior reflect on them or on the institution that had hired them for such important positions? Not well, we think.

Yet at Duke, which according to its official website, "maintains an historic affiliation with the United Methodist Church" and whose official motto is "Knowledge and Religion," there is apparently an exception when it comes to the famous coach.

To be sure, Coach K is a very successful bench boss, having led Duke to 12 Final Four berths and 5 National Championships. And just how much does he receive in compensation? Just over \$7 million a year as a base salary — for coaching, of course, an "amateur" team. And remember, that figure does not include endorsement deals. Families of students attending Duke, a private university, without a financial aid package had to pay just over \$78,000 for the 2020-2021 academic year — a figure that included tuition, room and board, fees, supplies, books, and personal expenses.

In a novel set in the Boston area that we were reading a few years ago, the lead character remarks "Let our deeds be our ambassadors." And indeed, Coach K and other high-profile mentors are ambassadors for their institutions, especially when they go on the road for games at other schools.

Like it or not, Division 1 football and basketball coaches are the highest profile representatives of the institutions that employ them. Many in the general public don't know anything else about the schools. That is why it is so important that they act like the ambassadors they truly are at all times.

One person who was the opposite of Coach K during his career on the sidelines was Tony Dungy, who coached for 13 seasons in the NFL and led the Indianapolis Colts to the 2007 Super Bowl title. For many players who had experienced coaches that screamed and yelled a great deal, Dungy was a welcome relief. He currently works for NBA Sports as an analyst for NFL games.

Dungy considered himself a teacher who respected his players. He reportedly never swore, hardly ever raised his voice and prohibited hazing of rookies. He did set high standards and believed in clear lines of communication — telling players how they could improve in a calm, conversational style.

Meanwhile, if you want to see Coach K in person one final time in the Boston area, circle the date (when it is announced) that he will bring his team to Chestnut Hill next season to take on Boston College in an Atlantic Coast Conference matchup.

Ordinarily, we'd encourage you to get your tickets early, so you might be able to sit closer to the action and experience more of the atmosphere of the game as the Eagles take on a team with a powerhouse basketball heritage.

But considering how Coach K's game-day diction might permeate the area of those in the nearby seats, we encourage, for this one event, that you consider the less expensive sections in the higher realms of the arena. That way, from up there, Coach K may be seen but not heard — perhaps a preferred option when one considers the alternative.
