

Stirpe Nostra

LUCAN

Marcus Annaeus Lucanus, usually called Lucan, our next Roman scholar was a most important poet in the Silver Age of Latin literature. He was brought to Rome at an early age, where his education was supervised by the most prominent teachers of the day. He was the nephew of Seneca, the tutor of Nero.

The talents of Lucan developed during his younger years, and he soon became famous as a poet. Lucan's popularity awakened the jealousy of Nero, and consequently Lucan was forbidden to write any more poetry, or even to recite in public. Appalled by this prohibition, he joined Piso's famous conspiracy to assassinate Nero, but was soon betrayed. Lucan was promised a pardon if he turned informer and soon denounced all of his accomplices. Imperial treachery was more than Lucan could his veins and expired while deal with, and after the conspirators were executed, Nero issued an order for

the poet's execution. Escape appeared to be hopeless, so at the age of twenty-six, while in the prime of his life and career, he opened feebly reciting poetry.

We are told that Lucan wrote prose as well as poetry,

but that his only work currently in existence is an epic poem in ten books, given the title of "Pharsalia." This work fully details the struggle between Caesar and Pompey after Julius crossed the Rubicon, and all events are arranged in chronological order.

Due to the changing moods and the spirit of the poem, it's quite evident that the ten books were written within different time frames. Earlier books flatter Nero, while later volumes loudly proclaim the blessings of freedom along with offensive criticism against his tyranny.

In spite of his youth, Lucan's work is said to contain greatness. It is characterized by a superior quality of diction, excellent imagination, and a mature tone in thought. The "Pharsalia" is generally accepted to be one of the best and second only to Vergil's "Aeneid."




"The Emblem of the Land I Love"

Saturday, June 14th, is Flag Day. It commemorates the adoption of the flag of the United States by the Second Continental Congress in 1777. It's a good time to reflect on the meaning of the flag and of the Pledge of Allegiance that many of us recited daily in school.

I pledge allegiance to the Flag of the United States of America, and to the Republic for which it stands, one Nation under God, indivisible, with liberty and justice for all.

The Pledge of Allegiance to the Flag of the United States of



America should be rendered by standing at attention facing the flag with the right hand over the heart. When not in uniform men should remove their headdress with their right hand and hold it at the left shoulder, the hand being over the heart. Persons in uniform should remain silent, face the flag, and render the military salute (U.S. Code Title 4 Sec. 4.)

The original Pledge of Allegiance, "I pledge allegiance to my flag and the Republic for which it stands — One nation indivisible — with liberty and justice for all," was written in September of 1892 by Francis Bellamy for The Youth's Companion magazine in Boston. The phrase was printed on leaflets and sent to schools throughout the United States. The first organized use of the Pledge of Allegiance came on October 12, 1892, when some 12 million American school children recited it to commemorate the 400-year anniversary of Columbus' voyage.

In 1923, the first National Flag Conference in Washington D.C. voted to change the words "my flag" to "the Flag of the United States of America." Congress officially recognized the Pledge of Allegiance in 1942, but in 1943, the Supreme Court ruled that public school students could not be forced to recite it.

The words "under God" were added in 1954 by then President Eisenhower, who stated at the time, "In this way we are reaffirming the transcendence of religious faith in America's heritage and future; in this way we shall constantly strengthen those spiritual weapons which forever will be our country's most powerful resource in peace and war."



Padre Pio

Mass & Procession June 22nd

Saint Pio of Pietrelcina, or more commonly referred to as Padre was born Francesco Forgione on May 25 1887, in the farming Italian town of Pietrelcina. He is famous for bearing the stigmata and joined the Capuchins at an early age. He then left the friary to begin his studies to become a priest, which is why he is known as Padre Pio, Father Pius in

Italian, a name given to him when he joined the Capuchins. His life was shrouded with illness and controversy due to his stigmata, which the Vatican doubted were real, thus

prohibited him from practicing mass and hearing confession. Later in his life however, Pope Pius XI admitted to be misinformed and encouraged Catholics to visit Padre Pio. He was finally allowed to preach and celebrate

In honor of Padre Pio, who was canonized a Saint by Saint John Paul II on June 16, 2002 and to raise funds for St. Leonard Church; the Friends of Padre Pio have organized a service. A Mass in Italian with a few words in English will be held at 10:30 am on June 22nd at St. Leonard on Hanover Street followed by food and beverages at 12:00 pm in the downstairs hall. Tickets are \$10.00 and all of the proceeds will be going to the church. A procession in celebration of Padre Pio will commence at 2:00 pm at Hanover and Prince Streets and continue throughout the streets of the North End.

Saint Anthony of Padua

There is perhaps no more loved and admired saint in the Catholic Church than Saint Anthony of Padua. Saint Anthony, called Saint Anthony of Padua because of his long residence in that city, was born in Lisbon Portugal in 1195 receiving the name Ferdinand at his Baptism. He was placed by his parents, at an early age, in the Community of the Canons of the Cathedral of Lisbon.

joined the Canons Regular of St. Augustine, in the monastery of St. Vincent, just outside the city walls (1210). Two years later he entered the Monastery of Santa Croce in Cóimbra (1212), where he remained for eight years, occupying his time



At the age of fifteen, he mainly with study and prayer. Gifted with an excellent understanding and a superb memory, he gathered from the Sacred Scriptures and the writings of the Holy Fathers a vast knowledge of theology. The death of five Franciscans who shed their blood for their Faith in

Morocco in the year 1220 and whose bodies had been brought to Saint Anthony's monastery for burial inspired him to become a Franciscan. Thus, Ferdinand left the Canons Regular of St. Augustine to join the Franciscan Order taking the new name of Anthony.

A short time after his entry into the order, Anthony started for Morocco, but he was stricken down by a severe illness, which affected him the entire winter compelling him to sail for Portugal the following spring. His ship, however, was overtaken by a violent storm and driven upon the coast of Sicily, where Anthony remained for some time,

Dear Daddy,

Happy Father's Day! I love you so much, and I hope I always show you how much I appreciate you, on this holiday and every other day of the year.

Daddy, I really enjoyed gardening with you last week. Even if we were just doing something as simple as pulling up dry weeds and unclogging the electric plow, it felt so nice to be spending time together in the spring sunshine. It made me miss the days when I was just a little girl and would help you dig in the dirt so you could plant tomatoes and herbs and zucchini. I remember how you pointed out all the worms and bugs that crawled among the plants and taught me how essential they were to ensuring that our crops grew beautifully and healthily. I remember how you guided me to make sure that I was watering the plants just enough. I remember the bundles of lavender you brought home to Mom, and how they would make the kitchen smell like sweet soap. You had so much patience with me, Daddy, and so much enthusiasm about the natural world that it continues to inspire me, even today. In fact, I think our time in the garden is a metaphor for how you helped me blossom into the young woman I now am: just like the plants that grow in our backyard, you gave me both roots and petals.

These proverbial roots come from the fact that you always placed emphasis on our family's traditions and heritage. Whenever I hear the silly songs on the Italian channel playing from our living room, I have to smile — your love for this channel was a constant part of my

childhood, an unvielding listening to one of Dan's

reminder of the music and language and customs of my ancestors. That is why I still sit down with you to watch Italian game shows, Daddy. You would take me to the North End on balmy summer days, where we would eat pizza and gelato together, and where I would always watch you buy copies of Italian newspapers. You made sure that our Christmases were filled with boxes of panettone and our Easters with large chocolate eggs, holiday traditions that connected me to the wider world of my heritage, and taught me the symbolic meaning hidden behind every custom. Today we have a president unlike any other. Did he actually think we the people would like his actions? If he did, he is even further out of the loop than I gave him credit for.



until he had regained his health. He then journeyed to Assisi to attend a general chapter that was to begin entirely unnoticed.

It was at Forli, where Anthony was asked to speak to his brethren gathered for an ordination, that his powers of oratory and knowledge of Holy Scripture were noticed. It was at that moment that Anthony's public ministry began. Saint Francis, informed of his learning directed him to teach theology to the brethren which he taught successively at Boloand Padua.

It was as an orator, however, rather than as professor, that Anthony made his greatest impression. He possessed abundantly all the good qualities that characterize an eloquent preacher: a loud and clear voice, a

winning countenance, wonderful memory, and profound learning. So numerous were those who flocked to hear on May 30th where he went him that no church could house them and he was often forced to preach in the open air.

At the end of Lent, 1231, Anthony retired to Camposanpiero, near Padua, where. after a short time he was taken with a severe illness. Transferred to Vercelli, and strengthened by the apparition of Our Lord, he died at the age of thirty-six years of age, June 13, 1231.

During his lifetime he was gna, Toulouse, Montpellier held in high esteem with miracles attributed to him.

> Saint Anthony was canonized less than one year after his death.

He is especially invoked for the recovery of things lost. He is a Doctor of the Church and Patron of the Poor.

The Three Stooges: Celebrating 80 Years of Laughter



was a TV fan and, as their nominated short Men in popularity proves 80 years after they left manager Ted Healy and became a comedy act sensation, the same is true for many new fans. The rise of The Three Stooges is an all-American success story. With their roots in Yiddish routines, they got their start in vaudeville before joining up with Ted Healy where they started appearing in minor roles in such movies as the Joan Crawford vehicle Dancing Lady (which was also the film debut of Fred Astaire) and Hollywood Party along with many musical shorts as Nertsery Rhymes and Beer and Pretzels.

For a time, Healy proved a viable manager for the Stooges and records indicate that he maintained a close friendship with Moe Howard. But, considering how quickly Healy's career deteriorated through alcoholism, it's amazing their partnership lasted as long as it did. But doors often close just so a better one can open and in 1934 Moe Howard and Larry Fine parted ways with Ted Healy while Shemp Howard continued his own career, leaving a spot open for his brother Curly to join the trio. The rest, as they say, is history. Eighty years ago, The Three Stooges as the icons we have loved for generations (bowler-haired Moe, mattress-spring haired Larry,

I was a Stooge fan before I official team with the Oscar Black. That short remains one of their best and set the mold for the classic Stooge formula. It was A) set against a backdrop that was not inherently funny; a hospital, B) the boys were cast in a respectable profession; doctors, C) pure hilarity ensues. Yes, this is the episode with the classic gag of the Stooges charging out of the office first with bicycles, then with boats, and then on horseback, each time the intercom says' "Calling Dr. Howard, Dr. Fine, Dr. Howard."

Under producer Jules White at Columbia Pictures, the Stooges made some of their best films during the Curly years. Some of their very best include Three Little Pigskins (1934), where they wreck a football game with hilarious results, Uncivil Warriors (1935), one of their many "period-piece" shorts, this time the Civil War, mashed with contemporary gags and lingo, Hoi Polloi (1935), my personal favorite Three Little Beers (1935), which I love more for final chase with rolling beer barrels than the better-remembered golf game in the first half, Movie Maniacs (1936), Half Shot Shooters (1936), A Plumbing We Will Go (1940), and In the Sweet Pie and Pie

The war years added new themes and new material for parodying. The Stooges and bald Curly) became an became one of only two



comedians (besides Charlie Chaplin) to attack Hitler through comedy before the United States even entered the war with the very funny shorts You Nazty Spy! (1940) and its sequel I'll Never Heil Again (1941).

Curly's health began to take a toll on him after the war and much of his youthful energy (which his comic persona was based on) began to fade. In 1947, after a severe stroke, he retired from the act and was replaced by the original third Stooge, Shemp. He was no Curly, but brought his own comic wit to the trio. Shemp has suffered, unfairly I think, by the misfortune of coming in as Curly's replacement, an act no comedian could follow, but the Stooges continued to make a number of marvelous shorts with Shemp, though age was beginning to take effect on all three.

When the Stooges did dip was, in fact, after Shemp's death. Moe refused to let the act die out and so put it on life-support, adding Joe Besser (whose entire persona was a knock-off of Phil Silvers) and then Curly-Joe for their foray into feature-films.

But it's the Stooges in their prime that have become staples of American pop-culture and whose films have become a rite of passage for a new generation of young men. Even television caught onto their appeal and their shorts, made a decade before the medium became a commodity, have now become a classic sitcom.

The Stooges were never well-received by the highbrow critical establishment. They did lack the subtlety of Chaplin or Buster Keaton and they went too fast for a pay-off to build carefully constructed gags like Laurel & Hardy. And the Marx Brothers will always reign supreme for verbal wit. But the basic style of Stooge knock-about has one advantage over their competitors;



"Parla Come Mangi!" (Speak as You Eat!)

Spaghetti all'Amatriciana

Serves four

1 pound of spaghetti 4 slices of pancetta or "guanciale" ¼ inch thick 1 small yellow onion Freshly ground black pepper 1 - 28 oz. can of peeled tomatoes (pureed) 4 Tbsp. extra virgin olive oil Splash of dry white wine

Fine salt to season the sauce and coarse salt for the pasta water Red pepper flakes to season (optional) Grated Pecorino Romano cheese to taste (alternative cheese: Parmigiano Reggiano)

Preparation: Dice the pancetta and the onion. In a saucepan, combine the onion, the pancetta, some ground black pepper and the olive oil and cook until golden. Add the splash of white wine and let it evaporate. Add the pureed peeled tomatoes and season with salt and the optional red pepper flakes. Cook over medium-low heat for about 30 minutes. Bring a pot of salty water to a boil and cook the pasta. When the pasta is "al dente," drain it and transfer it to a serving bowl. Evenly coat it with the sauce and stir in the grated cheese. Buon appetito!

When I moved from Rome Time for show business stuff by the great to Boston ten years ago I was delighted to see how the Italian language, customs and traditions were strongly preserved, incorporated into daily life and passed from one generation to the next. To this very day, the pride for our Italian heritage and culture has grown strong and we are honored to make our children feel proud to be Italian! The healthy and delicious food that we eat is an important part of our culture because behind every dish there is a story and behind the hands that prepare it, there is always a passionate narrator. I remember cooking in my nonna's kitchen and being fascinated by her life stories that always translated into delicious food. I am honored to share with you some of my best recipes that incorporate traditional Italian regional cuisine. We will start our "Journey through Italy" celebrating the region "Lazio" and its cuisine with: "Spaghetti all'Amatriciana". This recipe is born in Amatrice, in the province of Rieti, a town located in the region Lazio near the border with Abruzzo, in central Italy. The recipe has an ancient tradition connected to its territory and strictly uses spaghetti pasta. Originally made without tomato sauce, onion and wine; this dish was the main meal of many shepherds that lived on the mountains of Amatrice. The shepherds originally brought pecorino, black pepper, dried pasta, guanciale and lard in their "purses" "Guanciale," cured pork cheek, a delicacy of Lazio, is the traditional ingredient for the preparation of this dish, but since it's not an easy find, it can be substituted with "Pancetta," a type of bacon made of cured pork belly meat. I like my spaghetti all'Amatriciana with onions, tomato sauce and white wine.



checked the engine fluids and then headed out of Boston Harbor. When they reached the outer islands of the harbor, a pea soup fog came in and blanketed them so there was no visibility. Antonio guided the boat's direction with his compass and all was well. That is, until the engine started to sputter as if it was out of fuel. It then stalled. No matter what the mechanic of the crew did, the engine would not start. The crew began to grow apprehensive due to the problem and the date, Friday the 13th. When Antonio looked at his compass, it was spinning around and around so they had no idea which direction they were heading. Antonio, grabbed a portable megaphone and began yelling out for help. While he did this, one of the crew hit the boat's bell every few seconds in case someone was near, another boat, that is. This cry for help was finally answered. After yelling, Ahoy through the megaphone and ringing the bell for some time, a voice in the fog finally answered. Another fishing boat was in the vicinity and offered help. The other fishing boat followed the sound of the voice and the bell and became visible to Antonio and his crew only when it was within five feet of them. The captain of the boat spoke with Antonio, but both men only caught a few words here and there. The captain of this Gloucester base was Portuguese. What Antonio understood from the conversation was that the captain of this boat, which was named the Ave Maria, was also named Antonio and he offered to tow Antonio's boat back to Boston Harbor before they continued fishing in the fog of the outer islands.

Antonio agreed and the Gloucester based boat threw a line which Babbononno caught. Several of the crew fastened the rope to Antonio's boat and the Ave Maria towed Antonio, his crew and my grandfather back toward Boston. Just as they reached a point where they could see through the fog, Antonio from the Gloucester based boat yelled for our Antonio to try to start his engine. It started. He then yelled for our boat to untie his rope and head in to safety. Babbononno states that when he saw the Custom House and then Boston's fish pier, he stopped saying Hail Maries.

Antonio maneuvered his fishing boat into his usual birth at the fish pier. The harbor master helped dock the boat and asked Antonio what happened. Antonio, in broken English, explained to the harbor master the events of the day that led them into cutting the day's fishing very short. As the harbor master heard the tail end of the story, his eyes opened wide and he became white as a ghost, according to Babbononno's description of the scenario. When Antonio asked what was wrong, the harbor master stuttered and then blurted out, "The Ave Maria was a Gloucesterbased fishing boat that was well known even to those of us who worked out of Boston. The captain, named Antonio, was a friendly and honest man that everyone here liked, but one day toward the end of the Great War (World War I), the Ava Maria was fishing off the north shore of Massachusetts and was torpedoed by a German U boat and it sunk with all hands aboard."

At that point, the harbor master walked away and left Antonio, Babbononno and Antonio's crew speechless. Antonio and Babbononno made the sign of the cross simultaneously and the rest of the men just stared in silence.

I don't know if this was a true story as my grandfather loved to tell stories. He called that Friday the 13th "Lucky Friday" from then on, but never accepted another invitation from his paesano. Antonio, unless it was a shore side fish dinner that was accompanied by a good bottle of wine.

I've checked the historical records, and there was a Gloucester based fishing boat called the Ave Maria that was sunk by a German submarine (U boat) off the coast of Massachusetts, just before WWI ended in 1918. You figure it out??? I can't. GOD BLESS AMERICA



Legendary Rock Drummer ... Legendary drummer, Ginger Baker, renowned for his work with Cream and Blind Faith was once voted as "The musician least likely to survive the '60s." But now, four decades and a few years later, he has proved them all wrong and is heading to the United States for a June 2014 jazz fusion tour and a new CD titled Why?! Teaming up with funk and jazz giant tenor saxophonist Pee Wee Ellis the architect of James Brown's era — defining soul of the late '60s, bassist Alec Dankworth, and African percussionist Abass Dodoo, the band is known as Ginger Baker's Jazz Confusion. Together they play hip, progressive jazz originals ina-Thelonious-Monk-style but with exciting African rhythms.

Ginger Baker's recognition as a drummer began during the Graham Bond Organization in the early sixties. The band toured with The Who, The Troggs, The Moody Blues and Chuck Berry, attracting press interest for their outrageous behavior and riotous fun. In 1964, Baker was considered "one of Britain's great drummers" by Melody Maker journalist, Chris Welch.

Baker, who was inducted into the Rock and Roll Hall of Fame in 1992, Modern Drummer Hall of Fame in 2010 and Classic Drummer Hall of Fame in 2011 and whose awards include a 2005 Grammy® Life Time Achievement Award and a 2008 Zildjian Top Drummer Award, was also impressing music journalists. He also attracted attention from many musicians, one of them being Eric Clapton. The two met, jammed, saw one another play in their then-current bands, added bass player Jack Bruce and formed Cream. In Baker's own words, they created "instant magic" and began touring earning £45 per show and later smashing box office records previously set by The Beatles.

But since when haven't Americans embraced the underdog status? That's what we're built on.

The key for the red, white and blue will be a positive result versus Ghana. A win has the potential to invigorate the team similar to the way their 2002 result against Portugal at that year's tournament did. After Ghana, the United States will face a superbly talented but somewhat underachieving Portugal side led by Cristiano Ronaldo. Ronaldo, like his national team, is one of world soccer's top talents but also seems to disappoint at major tourneys. Why couldn't the U.S. upset Portugal or at the very least manage a draw? Next up will be the Germans. Thomas Muller, who helped the Germans to a third-place finish four years ago, along with strikers Lukas Podolski and the ageless Miroslav Klose should give countryman and former German national team coach Klinsmann his toughest match of the tournament. However positive results in their first two games could still allow the U.S. to advance regardless of this match versus the Germans. While many "experts" may find it foolish to think that the United States will make it to round two, I believe that this is a very achievable possibility. At the very least, I think we have a reason to watch and hope. Hope will be high Monday, as the United States will finally defeat Ghana after suffering two painful losses in a row (2006, 2010 tournament) versus the black stars.






Great Versus Great at Their Best



Louis vs. Schmeling 2.

On June 22, 1938, Joe Louis stepped into the ring at Yankee Stadium to defend his title against Max Schmeling. Two years earlier, in the same ring, Schmeling had defeated Joe in a bout where the Brown Bomber was decked twice, the second time for the count. Over the next two years Louis remained undefeated and was finally matched with Champion Jimmy Braddock for the title. What most people don't know is that Braddock had signed to defend his title against Schmeling and backed out when he was able to make a deal with Louis's handlers that would guarantee him a cut of Joe's purses for the next ten years, if Louis won the title. Schmeling ended up being paid for the Braddock bout even though it never happened. If Schmeling had beaten Braddock, the title would have gone to Nazi Germany and Joe would have had to challenge Max for it. As it was, Louis felt he was not truly the champion because he had not avenged his loss to the Black Uhlan of the Rhine.

After defeating Braddock for the title, Louis defended against Tommy Farr in a bout that went the distance and in which Joe gave a bit of a disappointing performance against the rugged Welshman. He also knocked out Nathan Mann and Harry Thomas, but his target was Schmeling. By the time the two entered the ring on that warm June night, world events had entered the picture. The Nazis were on the march in Europe and Max was seen as representing that evil regime. Joe was not only in a bout for his own honor but also for that of the nation.

When the bell rang for the first round Joe came out like a man possessed. He stalked Max and set him up for incredible combinations. In the two minutes and four seconds the bout lasted, Joe gave Max a fearful beating, even breaking two vertebrae in his back.

I bring this fight up as a backdrop for a discussion about who the greatest champion was. When boxing fans argue about who was the best, names are tossed around with styles, endurance, and punching power being compared. One thing that is missing however is how these greats would have fared against each other on their best night. In boxing, more than any other sport, emotion plays a huge role. When a boxer enters the ring and that bell sounds he is alone with his opponent. There is nowhere to hide and no bench to have a time out on. Thousands, and with TV, millions of people are watching. The boxer is participating in a sport that could end in death, and whose object is to inflict serious physical harm on

The Joe Louis of the Schmeling fight was unbeatable that night. But could he reach

that level of focus and intensity if he were fighting someone else? What if Max had not previously beaten him? What if the entire nation wasn't counting on him to pull this out for them? Joe was the perfect fighting machine that night.

When thinking about who would win in these dream matchups, I would say that you should take each great and imagine them fighting on their best day or night. Imagine the Jack Dempsey of the Willard fight going up against the Louis of the second Schmeling fight. It has been written that the Dempsey in the ring on that hot July 4, 1919 in Toledo, Ohio was as close to being a feral human being than anyone. He had grown up just about living in the wild, and he fought like that. Cagey and vicious with great speed and punching power, he destroyed the Pottawatomie Giant in three rounds. While Dempsey was certainly great in the fights that followed during his reign as champion, I don't know if he was ever as great as he was on that July afternoon. Could Gene Tunney have beaten that Dempsey? Could any man?

Being on edge, in great physical shape, and motivated by a desire to win that goes beyond the merely competitive is what makes these fighters perform at such a high level. Cus D'Amato told me before the Ali Wepner fight that it could be a tougher bout for Ali than many expected because Ali would not be psyched for the match and not in great shape, while Wepner would be fighting the fight of his life in his one chance at the title. Given this combination, the vast differences in skill and ability between the two would be just a bit less then it would normally be. Ali would be fighting below his best and Wepner would be at his best or better that night. Wepner did surprise by almost lasting the distance and finally collapsing more from exhaustion then any one punch. The Ali of the first Frazier fight would have destroyed him.

Some fighters get better after winning the championship. They now have a title to defend and an honor to uphold. Some, after losing a title shot, go into decline. Tommy Farr, after his incredible performance against Louis, lost four straight bouts.

When Joey Archer first challenged Emile Griffith for the Middleweight Title he fought a brilliant fight losing a majority decision that many thought he had won. In their rematch, Joey was not the same fighter. He appeared to just be going through the motions and lost a unanimous decision. He was not able to rise to the occasion the second time around.

When arguing about who the greatest of all time is, remember to include the human factor and how much a boxer's emotional state plays into his performance. The Ali of the Wepner fight going up against the Louis of the second Schmeling fight would be much different than the Ali of the first Liston bout fighting the Louis of the Farr matchup. How would these dream matchups turn out if the fighters were matched based on their performance in their best fight? This is what makes discussing boxing so much fun. There are so many variables that just can't be measured.
