# North End Nursing Home Closing Battle is Joined

On Monday night, David E. Storto, President of Partners Continuing Care and the Spaulding Rehabilitation Network, attended the North End/ Waterfront Neighborhood Council meeting "to do some 'splainin" about Partners' recently uncovered unilateral decision to close the North End Nursing Home. I will give Partners credit for sending the top guy, and not some powerless minion (although he seemed like one most of the evening). Storto stood up front and took everything the neighborhood had to throw at him. But he gave us nothing

in return.

The meeting, which had advertised the Partners agenda only days before, was packed to overflowing. Several people left because they could not get in. Our elected officials, alarmed by local media coverage and no doubt hundreds of irate phone calls, were represented by State Representative Aaron Michlewicz and State Senator Joe Boncore. Both spoke at the start of the meeting, expressing the requisite outrage, but offering nothing in the way of action as yet. City Councilor Sal LaMattina was unfortunately out of town and the City was holding its vigil for the victims of the Orlando massacre that night, hence the understandable absence of Mayor Marty Walsh. The North End's city liaison, Maria Lanza, was there, although she initially declined to speak,

Meanwhile, Storto's plan seemed to be to repeat all the corporate-speak excuses already communicated in an open letter from Partners to the neighborhood earlier that day, and then answer questions about how they plan to move forward with their done deal. But he can't possibly be that dumb. If he didn't expect the onslaught of fury that interrupted him before he could get a full sentence out, he would not be in the position he is in. From the specific question of whether the bathrooms are wheelchair accessible — his claim that they are not was quickly met with derision as people told him how they push wheelchairs through those bathroom doors every day — to the general question of whether the Wingate building Partners is buying in Brighton is in better condition than our Fulton Street building — quickly denounced by folks describing how often that facility had to close due to flooding on the first floor, Storto was shouted down. He had no answers.

Many people spoke eloquently during the evening, each mak-

ing another set of damning points and reinforcing one another's testimony. Key questions, in no particular order, included:

- Who actually owns the building and the land?
- Why was the property allowed to fall into such claimed disrepair while being operated by Partners?
- How much is it going to cost to renovate the Wingate facility in Brighton? How does that compare to the estimate to renovate the North End facility?
- Why can't our nursing home be renovated one floor or section at a time?
- Why has there not been a public hearing?
- Why was the North End community not part of a conversation on how to deal with the building's condition?
- Why did we find out what was happening through the press?
- What approvals are required for Partners to move forward with their plan?
- Is there any scenario where we can keep the nursing home, or is this meeting just a waste of our time?

#### • And my favorite — would you do this to YOUR mother?

No answers were forthcoming, even when moderator John Pregmon (newly elected Council president) quieted the crowd in order to give Storto a chance to respond. He claimed he was unfamiliar with the structural problems at the Wingate facility, he didn't know how much the renovations would cost, or why, specifically, the Fulton Street building couldn't be renovated one section at a time. He claimed there were no plans yet for selling the Fulton Street building (although he seemed sure that Partners owned it). He claimed that they were planning to contact the families of the patients to discuss the plans, but were blindsided by the social media and news articles. Hey, who's blindsiding whom here? Again, they can't be that stupid. And we aren't, either. They should have been way out ahead on this. They just didn't

I can't possibly do justice to the eloquent speeches made that night, so I hope that if you were not there, and you haven't seen the video yet, you will go to northendwaterfront.com and watch. Francine Gannon did a great job of summarizing the history of the North End Nursing Home and questioning the legality of Partners' current actions given recently passed laws concerning the closing of nursing homes. Joe Testa described

in detail the horrible conditions at Wingate during the two years he was visiting his son there. One woman described how exhausting it was to work full-time and take public transportation every day to Brighton to visit her mother. Daniel Passacantilli and his daughter Alissa Tizzano gave impassioned testimony on what moving her 93-year-old grandmother with Alzheimer's after eight years in what has become her home will do to her. Basically, it's a death sentence. John Graffeo spoke with equal passion about his 99-year-old mother, another patient at the North End Nursing Home. He read from Partners' website: "Partners Health-Care is a not-for-profit health care system that is committed to patient care, research, teaching, and service to the community locally and globally." "Well, this is locally. So, what is Partners doing? They are doing completely the opposite!" he exclaimed.

All these testimonials were met with loud applause. And the "peanut gallery," as my father would call them, were extremely vocal throughout. The comments were not kind, but they were legitimate.

One question that was eventually answered concerned the actual ownership of the property. Over and over again, people questioned whether Partners actually owns the property, including one gentleman who insisted that Storto return with a bill of sale! Several people remembered in some detail the promise that was made to the community by the City when the Nursing Home finally became a reality so many years ago — that the property would always be utilized for the benefit of our North End seniors, that they might grow old in familiar surroundings in the care and company of their families when they were no longer able to live at home. I finally asked the Mayor's liaison, silent until this point, how the mayor feels about all this and can the City get to the bottom of the provenance of the property? Lanza responded that Walsh feels this issue is very important, as evidenced by his sending her. She then went on to describe an existing LDA — Land Disposition Agreement — held by the BRA that does indeed specify that the parcel must be used as a nursing home for North End residents or revert to the City, and there must be "community process" if Partners leaves. [Really? Would she have mentioned this if I hadn't asked? Perhaps

# Stirpe Nostra

#### THE CHARACTER OF THE EARLY ROMANS

The character of the early Romans seems quite clearly defined when one examines the social aspect of their life. This is revealed in their architecture.

They built forums for their public meetings and political activity, pagan temples for their religion, basilicas for business and legal affairs, palatial public baths for pleasure and relaxation, theaters in the half round for their dramas, amphitheaters like the Colloseum for

their gladiatorial contests, oval race tracks (which they called circuses) for their chariot races, triumphal arches and giant pillars to honor their heroes, aqueducts by the mile to furnish the millions of gallons of water for their daily needs, bridges and fountains. Some of these structures were built in Rome and some in other parts of the Empire ... but the "Domus," or private home for their intimate family life, ... was everywhere.

Through all of their political activity, religious and business affairs, cultural and leisurely pursuits, and because of their strong family ties, there seems to be one consistent trait that was evident throughout all of Roman History, and this is the capacity for obedience to their family elders.

The "Patria Potestas," or the supreme authority of the father, was the basis of their family life. Because of their ability to accept and obey a higher authority, they developed their capacity as soldiers,

conquerors, lawmakers, statesmen, and most importantly,

world builders. Through this principal trait, their unquestioned respect for parental authority, they have left an indelible mark on the history of the world. I believe that this inherent

characteristic has been passed on and instinctively accepted by our present generation of Italian-Americans. It is reflected in their everyday attitude towards their jobs, their employers, their love and affection for their parents, and for the manner in which they accept their obligations to their family and community.

This seems to be what it's all about... "This is Stirpe Nostra." In future issues, we will briefly examine the great Roman period in history, the structures they built, the development of the early Christian Church, the inevitable progression into the Romanesque and Byzantine styles, the Gothic system and the Golden Renaissance.

#### Simple *TIMES*...

In journalism school at Utica College during the mid-1980s, I learned that when writing a story, the basic reuirements are Who, What, When, Where and Why, as I built my article. Those Ws were to be answered in the first — or, opening — paragraph. Those lessons in my first year in a course named Journalism 101 have proven useful 28 years later.

In this week's column, I wonder exactly the how, when, and where Father's Day originated. The day to honor dads has its roots in the state of Washington on July 19, 1910, by that state's governor. And after 362 men died in a coal mine in Monongah, West Virginia, on July 5, 1908, the national holiday seemed to be a lock. But that event became a one-time remembrance only for those deceased men.

Amazingly, the national holiday honoring fathers was shunned by most men in 1924 as President Calvin Coolidge attempted to recognize fathers with an annual event. They scoffed at "the holiday's sentimental attempts to domesticate manliness with flowers and giftgiving." Throughout the 1920s and 1930s, groups fought to institute Parents' Day to praise both mothers and fathers. That idea was quickly quashed by various groups determined to keep Mother's Day exclusively for women.

Then the Great Depression your life.

struck and attempts to establish a separate Father's Day never took hold as business owners and consumers alike struggled to justify such spending sprees, even though the day was intended to jumpstart the economy.

With the advent of World War II in 1940, the cause gained traction as an opportunity to praise America's soldiers. Again, the activities to begin a Father's Day fell apart. The war ended and the troops returned home. Yet the hope that a national collective focus on fathers for one day remained on the minds and in the hearts of millions of people determined to honor dear old dad.

That day to honor fathers came full circle 62 years after the initial attempt, in 1972, as President Richard M. Nixon set aside a bitter re-election race and penned a proclamation creating Father's Day. It is today a federal holiday that has Americans spending over \$1 billion annually on everything from neckties to cologne to cigars and sundry other commercial items.

For those of us whose fathers are deceased, and for others no longer in your lives for whatever reason, do know that everybody has a father. And it's okay to honor them or the coach, educator, neighbor, uncle, grandfather or any man who has become important in your life.



# Appointed to FY17 Budget Conference Committee



Senator Sal DiDomenico, Vice Chairman of the Senate Committee on Ways & Means, was recently appointed by Senate President Rosenberg to a six-member Fiscal Year 2017 (FY17) Budget Conference Committee. This committee will be working out the differences between the Senate budget passed in May and the version passed by the House of Representatives in April.

Senator DiDomenico will be joined by Senate Ways and Means Chairwoman Karen Spilka (D-Ashland) and Ranking Minority Member Vinny deMacedo (R-Plymouth), as well as House Ways & Means Chairman Brian Dempsey (D-Haverhill), House Ways & Means Vice Chairman Stephen Kulik (D-Worthington), and

Representative Todd Smola (R-Warren).

"Creating the state budget is one of the most important jobs that the Legislature is tasked with, and it is an honor to once again serve on the conference committee with my colleagues in the Senate and House," said DiDomenico. "I now look forward to getting to work to produce a final compromise budget that addresses the diverse needs of our communities and continues moving our entire Commonwealth forward."

Through this appointment, Senator DiDomenico will play a key role in crafting the state's upcoming fiscal year budget and will have the opportunity to advocate for the Commonwealth's most critical services and programs, as well as many of the innovative Kids First proposals laid out in the Senate budget. Earlier this year, DiDomenico was chosen to lead the Senate's Kids First Initiative, with the goal of identifying best practices and innovative ideas for investing in and supporting children across the Commonwealth.

The conference committee members held their first meeting on Friday, June 10<sup>th</sup>, beginning negotiations for a final FY17 budget. Fiscal Year 2017 begins on July 1, 2016

#### L'Anno Bello: A Year in Italian Folklore

Marvelous Midsummer

What is it about summer nights that make me think of magic, moonbeams, and fireflies and fairies flitting about a darkened forest? Perhaps the answer lies in the velvety hue of the evening sky, offset by the delicate diamond-like stars that peek out from the late sunset. Or perhaps the answer resides in the comforting sound of crickets and cicadas humming their melody from deep within bushes and trees. It could also be that people tend to congregate outside during the warm summer twilight, illuminating the atmosphere with candles and lanterns from barbecues and alfresco dinners. I always find that the most magical of these nights occurs around the summer solstice, the longest day and shortest night of the year. In olden times, the summer solstice was known as midsummer, which can confuse those of us who view the solstice as the beginning of summer rather than the middle. Ancient Europeans used agricultural rather than purely astronomical methods of gauging the seasons, and so the solstice was considered the height of summer rather than its commencement. As Christianity spread across the continent, Midsummer festivities became absorbed into the feast day of St. John the Baptist, creating an indelible mix of traditions. The result is one of my favorite holidays, a festival that embodies the magic and boldness of

Europeans in older times began the summer on May 1st, or May Day, the holiday that marked the time to let livestock out to graze in pastures. Summer ended on Lughnasadh, the festival of the grain harvest and the first fruits of the autumn,

which fell on August 1st. As a result, the summer solstice marked the midpoint of the season and as such was called as Midsummer. In Europe, Midsummer heralded not only the longest day of the year, but also the period after which the daylight hours would slowly shorten. For this reason, I like viewing the solstice as the middle rather than the beginning of summer as well — it makes little sense to celebrate the start of summer when the sun begins to diminish in the sky! Midsummer customs later attached themselves to June 24th, St. John the Baptist's Day, the feast commemorating the birthday of the important Biblical figure six months before Christmas. In Italy, St. John's Day customs symbolize both the decline of the sun after the solstice and the sense of magic which pervades the evening. All over the Italian countryside, gli fuochi di San Giovanni, or St. John's bonfires, blaze from the hilltops on the eve of the saint's festival. These fires both mimic the power of summer sun while also symbolically imploring the sun to stay longer in the sky. Young Italians may also spend the evening gathering herbs, which are supposedly imbued with mystical properties on this unusual and magical night. According to old superstitions, these herbs work especially well for romantic divination, and people slip them under their pillows to dream of their future spouse.

All across Europe, similar Midsummer and St. John the Baptist's Day traditions utilize the seasonal staples of water, fire and greenery. In Scandinavia, Midsummer is one of the most significant holidays of the year, on par with Easter and Christmas. Sporting wreaths of

flowers on their heads, Scandinavians celebrate this holiday by dancing around Maypoles bedecked with greenery, building bonfires near lakes and rivers, and sitting down to feasts featuring summer ingredients like strawberries and potatoes. Meanwhile, girls in Russia and Eastern Europe float flower garlands down rivers and attempt to foretell the future by interpreting the movement of the garlands. People in Spain and Portugal celebrate the Feast of St. John the Baptist with outdoor carnivals, bonfires, street fairs, and the exchange of potted herbs. Italians, of course, never pass up an opportunity for a festival, and party accordingly on St. John the Baptist's Day, especially in the cities of Florence and Turin, where he is the patron saint. Outdoor fairs and fireworks displays mark the occasion. Out in the countryside, people may enjoy St. John's apples, or le mele di San Giovanni. A favorite of my father, these are small green apples so named because they ripen extremely early, just around the time of the solstice. No matter where one goes in Europe, charming Midsummer revelries emphasize the importance of the summer sun and the blessings of the season. The United States even boasts its own festivals full of outdoor excursions, fireworks and water - the Fourth of July, of course!

Above all, Midsummer is a holiday tinged with bittersweet nostalgia. While it honors the height of the sun's power and the carefree days of summer, it also recognizes that the hours of sunlight will slowly start to diminish once this date is past. It is a poignant reminder that nothing lasts forever. Yet, Midsummer is celebrated with joy, not sadness. Its celebrations encourage people to enjoy the longest day of the year by living life in the present moment. We know that the year is a cycle, and that we should appreciate each season for what it offers. #### Honors Original West Ender Leonard Nimoy





#### Saint Leopold III

The memory of this holy man lived long after his death. Leopold was born at Babenberg castle in Gars, near Melk, in Lower Austria in 1073. The Babenbergs came to Austria from Bavaria where the family had risen to prominence in the 10th Century. In 1096, at age 23, Leopold succeeded his father as head of Austria. He married twice. His first wife, who may have been one of the von Perg family, died in 1105. In 1106, he married Agnes, daughter of Emperor Henry IV. She was the widow of Frederick of Hohenstaufen, with whom she already had two children. The couple would have another 17 children, of whom 11 would survive childhood. Many of these children married spouses from neighboring lands, encouraging peaceful relations.

Leopold is mainly remembered for the development of the country and, in particular, the founding of several monasteries. He established the Klosterneuburg Monastery, which he subsequently expanded to become his

Leopold also founded the monasteries of Heiligenkreuz, Kleinmariazell and Seitenstetten, developing a territory still largely covered by forest. He fostered the development of cities, such as Klosterneuburg, Vienna and Krems, as

A man of strong convictions, Leopold's stand in the investiture controversies made him the preferred candidate among the Bavarians for the position of Holy Roman Emperor in 1125. However, Leopold refused the nomination and the glory of the empire, in favor of governing Austria. Through wise governance and faith in God, he succeeded in securing peace and justice for his people. He was a much loved ruler, faithful husband, and generous father.

Leopoldo died during a hunting accident in 1136. In the years following his passing, he became known as "Leopold the Good." He was so popular as an intercessor in Austria that eventually his sanctity was officially recognized by the Catholic Church. Pope Innocent VIII canonized him in 1485, noting in his homily the juxtaposition between a Germany engulfed in blood, death and devastation, beside an Austria enjoying the God-given blessings of peace, justice and human kindness that lasted through his 20-year reign over the people of Austria.

In 1663, he was declared patron saint of Austria. His Feast Day is celebrated on November 15<sup>th</sup>.



The call went out to Danny Elfman, requesting his creativity to score Alice Through The Looking Glass, allowing him to expand on his original Alice theme. The result is a fresh and beautiful track, enhanced to be longer than the original, adding male choirs. The 28-slice soundtrack is highlighted by Pink's explosive song "Just Like Fire" which she penned for the film. Elfman is very much at the top of his game for this score, firing on all cylinders with the kind of music that celebrates the good times, while struggling through the dark times, with "Alice" stepping up as the opening track, along with the haunting "Saving the Ship," the pensive "Looking Glass," and the blaring horns of "To the Rescue." Second half continues to offer additional feelings in the form of "Time Is Up," the string-laden "Goodbye Alice," the brevity of "Seconds Song," the mystery of "Clock Shop," the celebrative "They're Alive," and the finale, the defining "Story

Femi Kuti has learned much from his father Fela Kuti, the founding father of Afrobeat, enough to be the chosen successor his father wished him to be. Delivering his own sound, Femi has managed to defy local authorities and his upbringing to break free musically and speak truth to power. Femi has created a balance to his father's ideas of music and political thoughts, with a commitment to his own work. There's no hesitance in his sound that features blaring, well-timed horns on eleven cuts

On this date, June 17, 1775, in the American Revolution, American troops won a victory at Bunker Hill, sustaining the siege of British-held Boston. Also on this date in 1928, U.S. aviator Amelia Earhart became the first woman to fly across the Atlantic, from Newfoundland to Burry Point, Wales. It was on June 17 in 1917, that singer and actor, Dean Martin came into this world.

In the news! A Home Depot employee in Staten Island, N.Y., sparked death threats by wearing an "America Was Never Great" hat to work. Krystal Lake, 22, says she wore the hat after several coworkers wore pro-Donald Trump pins. "The point of the hat was to say that America needs change and improvement," Lake said. A company spokesman said Lake has been told never to wear the hat again.

International relations, after the IOC announced that it would be handing out some 450,000 condoms to 10,500 athletes and staff during the 2016 Olympic Games in Rio de Janeiro, more than three times the number distributed at the London games four years ago.

Veterans Affairs Secretary Robert McDonald compared the months-long wait times that vets must endure to get health care at the VA to the lines at Disney World, saying it was the "experience" that counts. After an uproar, he apologized.

Growing up, after a new analysis of census data revealed that 32.1 percent of Americans between 18 and 34 live with their parents, a higher percentage than are living with a spouse or partner.

Wow! Taking deep breaths, after a woman in India gave birth to a 15-pound baby girl, believed to be the heaviest female infant ever born, "In my 25 years of experience, I have never seen such a big baby," said a local health official. "She is a miracle."

Bomb threats: Dozen of schools across Britain were closed right in the middle of high school exam season, after receiving bomb threats by phone. The shuttered schools included elementary, middle, and high schools in England, Scotland, Wales, and Northern Ireland. One school, Canterbury Academy in Kent, said it received repeated robocalls of a recorded voice with an American accent warning that "the shrapnel will take children's heads off." Police searched all the affected schools and found nothing suspicious, and said they are treating the threats as a "malicious hoax." Schools in 18 U.S. states and Ireland also reported threats; none were found credible.

Time for a break. A team of chefs in Italy set a Guinness World Record by baking a 1.15-milelong pizza, the longest ever. We did see a photo of the pizza.

News from London. London's newly elected Muslim mayor, Sadiq Khan, condemned Donald Trump's "ignorant" view of Islam, after the Republican presidential contender said he'd make Khan an "exception" to his proposed ban on Muslims entering the U.S. Khan, the son of a Pakistan bus driver, and the first Muslim to head a major Western capital, dismissed Trump's offer, saying the ban "isn't just about me--it's about my friends, my family, and everyone who comes from a back ground similar to mine." The mayor said he would not travel to the U.S. if Trump is elected president, adding that he hopes Hillary Clinton "trounces" the businessman in November.

From Munich: A German man killed one person and injured three others in a knife attack on a suburban commuter train platform outside of Munich. Witnesses said the attacker shouted "Allahu Akbar!" and "You infidels must die!" But police said the 27-year-old suspect, identified only as Paul H. in local media reports, had no known connections to Islamic extremism, and appeared to be mentally disturbed and on drugs. Like all Europeans, Germans have been on edge since the Paris and Brussels terrorist attacks, and the Islamic State of Iraq and Syria recently called on German Muslims to carry out attacks on Chancellor Angela Merkel's office in Berlin and at the Cologne Bonn Airport.

#### Recipes from the Homeland

#### **CAPONATA** Eggplant

1 medium eggplant diced 6 or 7 tablespoons olive oil

1 sliced onion

3 tablespoons prepared tomato sauce

2 stalks celery diced

 $2\ tablespoon\ wine\ vinegar$ 

1 tablespoon Capers

4 green pimento olives 1/4 teaspoon salt

1 tablespoon sugar

1/8 tablespoon ground pepper A sprinkle of cayenne pepper

(optional)

Wash whole eggplant (without removing outer skin), and dice. Heat five tablespoons of olive oil in a skillet and add diced eggplant to simmer until it softens. Add sliced onion to skillet and one or two teaspoons of additional olive oil, and fry until onion is lightly browned. Add tomato sauce and diced celery. Simmer mixture until celery is tender. If needed, add a tablespoon of water before adding capers and chopped green pimento olives. Stir frequently to prevent sticking.

Slightly heat wine vinegar separately. Add sugar and stir. Then pour vinegar gently over eggplant mixture in skillet. Simmer for ten to fifteen minutes. Add a sprinkle of cayenne pepper). (Optional) Salt to taste.

Serve this hot or cooled as a side dish with broiled lamb chops. breaded fried cutlets or roast beef. It is also delicious on crackers or toasted bread to serve as hors d'oeuvres.

Caponata can be refrigerated for future servings. It can also be frozen and reheated.

NOTE: My husband and I met Louis and Rose "Dolly" Sorrentino on Cape Cod in the 1980s. They were former North End neighbors of ours for many years. We renewed our friendships.

While having lunch at their Cape Cod home one day, Dolly served us some homemade Caponata. I mentioned how much I had enjoyed it when my mother served it. But my mother prepared Caponata only during the summer when eggplants were available. Like so many of her friends, Mama never had a written recipe. I was delighted that Dolly offered me a copy of her recipe. Because eggplants are now available year round, we can enjoy homemade Caponata throughout the year.

#### Nanna & Babbononno

A Nostalgic Remembrance

Before I resume my story about the trip to Italy back in the day, I want to let you know about an event that happened on Tuesday June 7th. Before I returned from Florida this spring, I was contacted by two ladies from the East Boston Museum and Historical Society. Theresa Malichek and Fran Ippolito Riley identified themselves and told me about the society and museum. When I returned home, we three met for coffee and they continued their explanation of who and what the organization is and asked if I would be their first guest speaker for a lecture series that was forthcoming. It seems that my 25-year storyline of Nanna and Babbononnno convinced them that I should be contacted and recruited for the kickoff.

I listened to the two ladies who were delightful in describing what has happened in East Boston since I lived there. What convinced me to say "Yes," was the fact that they gave me a picture of the front of the Seville Theater, something I've been hunting for over the years. I put together a series of things to talk about, reminiscing about my old home town in the '40s and '50s.

A couple of weeks ago, one of my best friends, John Silva, and I headed to Maverick Square to check out the museum on Liverpool Street. I hadn't seen the neighborhood in many years and had heard that most of it had been torn down and rebuilt. When we got there, the only thing that looked familiar was the Most Holy Redeemer Church. I remembered going there attending father and son Masses when Dad belonged to the Knights of Columbus. Other than the church, everything else had been rebuilt. We checked out the museum building at 31 Liverpool Street, and then headed to Javeli's for lunch.

My two new lady friends advertised the event in the Post-Gazette, the East Boston

Times and Free Press, as well as the Winthrop and Revere weeklies. When I told Dean Saluti about what was going to happen, he sent out notifications of the event to the Sons of Italy, October is Italian Heritage Month, the Pirandello Lyceum, the Dante Alighieri Society, and the Order of the First Corps of Cadets, all organizations we are affiliated with.

My wife, Loretta drove me to

the location on the afternoon of the 7<sup>th</sup>. We were soon joined by my two new lady friends Theresa and Fran, as well as John Silva and Stephanie Da-Rosa. Minutes later, my oldest son, John, walked in, followed by Dean Saluti, his wife Margie Cahn, and retired General Joseph Carter. A friend, Bill Strachman, had left his car at my house and rode the rest of the way with Loretta and me, and he was surprised that my inner circle of friends all showed up early. Just then, Ed Ligon and his wife Barbara entered the meeting room and my inner circle was just about complete. An hour or two earlier, my son, Michael, called to wish me luck. He was in New York filming a commercial and couldn't make it home. Within minutes, I spotted Sal and Jil Giuliano, Lino and Enza Rullo, Post-Gazette publisher Pam Donnaruma, Louie Graffeo, Attorney Diane Modica, and Buddy Mangini, all old friends from all things political and Italian.

I couldn't begin on time because of the way things evolved. I thought, maybe 20 or 30 people would show up above and beyond my closest friends, but I was wrong. The next thing I realized was that there wasn't even any standing room left. People came from all over and after I began and mentioned places long gone, heads were nodding in remembrance. Basically, I talked about growing up Italian in East Boston and most of the people identified with my stories because each typified their own experiences.

I was about half way through and stopped my story to introduce a late arrival, our newest state senator, Joseph Boncore, a young man I have known since he was a child, whose father, Phil, I've admired since our friendship began decades

ago. Just as I finished, my two new lady friends, Theresa and Fran, presented me with gifts they had put together, pictures and memorabilia from East Boston. Diane Modica and Dean Saluti presented me with citations from the state house and Boston City Hall.

For one of the few times in my adult life, I was speechless. I never realized that this column had the effect on people that was demonstrated by the folks who gave me a standing ovation. It also humbled me, almost to the point of tears. After 50 years, I had come home and received a loving welcome, and it made me feel like I had never left. Before we broke up and went separate ways, I announced that East Boston, was a state of mind for me and my successes in life were, in part, due to where I came from and what the neighborhood and my family taught me in those formative years.

It took me about an hour to exit the meeting room due to folks wanting to shake my hand or have a picture taken with me. There were many who remembered some of the long gone places I mentioned and some of the people I spoke about and they wanted me to know that all was not forgotten with time.

When we left, we didn't head

home. Dean Saluti had seen to that. We headed to the back room of Santarpio's, probably the best pizza restaurant ever, if my opinion counts.

#### Tragedy as a Weapon

The saddest trend to emerge in recent years behind the sheer number of tragedies is the way our responses have evolved. It is not necessarily that we have become desensitized or even the fault of the media. No, the leading cause is something much simpler — in one word, politics. I cannot recall a recent mass shooting in the last decade which has not been used as a political angle by both liberals or conservatives, Republicans or Democrats, the NRA or the anti-gun crowd, the Black Lives Matter crew or the anti-immigration bunch.

Of course, socio-political implications are hardly ever avoidable in the big picture, and it would be unwise not to analyze the underlying causes of massacres. But, if only out of respect for the victims and their families, can we simply look at national tragedies as just tragedies, at least as an initial response?

A mere fifteen years ago, on September 11, 2001, we went through our darkest hour. In the following days, our political affiliations were irrelevant in what was, by any standard, a terrible crime against humanity. What has happened since? Well, as much of a teaching moment as 9/11 was, it was also a turning point in how we respond to tragedies and not for the better. Ever since "remember 9/11" became an emotive clarion call to justify any sort of action, freeing it from critical analysis, politicians and lobbyists have discovered the rallying potential in a grieving nation.

Often, such knee-jerk responses (which is precisely the kind of responses lobbyists want when they give a kneejerk battle cry) miss not only a healthy dose of critical analysis, but also important aspects of what is happening and why. And the truth of what happened is sometimes far simpler than what the sensationalist media tries to paint. Take the Marathon bombers. Yes, they clearly had anti-American attitudes and had been holding a grudge for some time. But, looking at their criminal history before April of 2013, one thing emerges. They were hardened criminals before they had a cause or even needed one. As one editorial put it, in the days just after the bombing, maybe they were just losers. Banal, indeed, is the face of evil.

The point is, we seem to have forgotten that it is possible for a tragedy to happen without an underlying socio-political inclination that forces one right away is to see the victims as little more than pawns.

The mass shooting at the club Pulse in Orlando was a clear-cut attack on the gay community and Dylan Roof's shooting spree in Charleston South Carolina was motivated by racial hatred. Those are obvious facts that must be addressed. But that does not excuse lobbyists from jumping on the ashes of tragedies and fitting them into the narrative of their agenda. Or, to put it another way, why can't we simply observe these crimes as hate crimes without using them as a tool to forward an agenda?



At that point, I have to ask how much these lobbyists truly care about the victims if their deaths and the circumstances surrounding them seem so much like a timely convenience.

I get it, turning tragedies into a lesson is a way to mourn. There is nothing necessarily wrong with this attitude. After all, this is the best way to prevent them from happening in the future. In the past, I haven't practiced what I preached and took an "I told you so" approach to tragedies. In fact, in its original conception, this very article almost followed that pattern and was going to be a commentary on the absurdity of the PC police and their self-righteous categorizing of who or what is acceptable to criticize. In summation, my argument was that I side with the tolerant crowd 100% when they fight for acceptance within mainstream America, but I can't understand why when it comes to the misogyny, homophobia, and plain intolerance abroad or within certain communities, we have to "well, understand, that is part of their culture". Yes, I'm not proud to say it, but I was going to use the tragedy in Orlando to illustrate my point, thinking how crazy the PC crowd must be going when a representative of a demographic they defend blindly demonstrates a murderous intolerance for another demographic they like to claim to be champions for. Someday I may write that article, but not for a while. At least let the dead be buried before we turn them into ammunition for our own agendas.

The Padres gave Shields a four-year, \$75-million deal before the start of the 2015 season. Thus far this season with the Padres, he was 2-7 with a 4.28 ERA.

Cleveland Indians outfielder Marlon Byrd has been suspended for 162 games for violating MLB's policy on performance enhancement drugs for the second time. 

#### Some Thoughts On Muhammad Ali

Muhammad Ali, who passed away last week at the age of 74, is probably the most written about athlete in history. He is most likely the most photographed as well. I have been thinking a lot about him in the days since his death and thinking about what or if I should write about him. With so much being said, both fact and fiction, I have not been sure what to say.

My feelings towards this most interesting of sports heroes have been very mixed over the years and remain so. Being a person who misses the art that was once practiced in boxing, I still am in awe when I see footage of him in action. While he is amazing to watch in there against his opponents, I also can spend hours just watching him shadow boxing, hitting the heavy bag, speed bag, or doing roadwork. From a technical

standpoint, he did so many things incorrectly, but his superb athleticism coupled with uncanny reflexes along with his ability to keep his body totally relaxed would make him the envy of any dancer.

Watching him move and realizing he weighed well in excess of two hundred pounds makes what he was able to do even more remarkable. I got to meet him a couple of times. I was once standing next to him before he was about to enter the ring for an exhibition match at the old Boston Garden. What struck me about being right up by him was how big he was. Seeing Ali on TV put me in the mindset that I was watching a middleweight. The reality sunk in when I saw how he towered over me. I remembered reading how Angelo Dundee had told the young Cassius Clay right before he was about to meet Sonny Liston mid-ring for pre-fight instructions before their first fight, "Stand up straight kid, you're bigger than he is and let him know that." Dundee knew how important details were; any edge helped.

Clay, who would soon change his name to Muhammad Ali, went on to win the title from Liston. Many question whether Liston threw the bout. I have no doubt that Cassius legitimately won the title that night. The details for my opinion will be the subject of another column. I will just say that the world was witnessing an amazing performance by a phenomenal athlete that night in Miami.

The young Clay, who returned from winning a Gold Medal at the 1960 Rome Olympics, was a remarkable personality. He

had boundless energy, supreme self-confidence, good looks and charm. He also managed to get under some people's skin because of his braggadocio. No matter, he was a shot of much-needed adrenalin for a sport that was beginning to die. People who didn't know the difference between a boxing glove and a pair of winter gloves were now paying attention to boxing.

Cassius Clay made it all fun. When in England to fight Henry Cooper, he managed to rankle the British when he said American woman were prettier than the English girls. He was predicting the rounds in which he would stop his opponents and than do just what he said. His public relations campaign for getting a title shot against Liston was unlike anything ever seen before. Most people thought he must be insane just to want to fight Sonny; his antics only seemed to reinforce that view.

Cassius became friends with popular singer Sam Cooke and they spent some time singing together. Clay even cut a record album. While he was no Sam Cooke, he could sing. Again, he made everything he did look like fun.

Things would change. Cassius had also struck up a friendship with Malcolm X and started being influenced by the separatist Black Nationalist group the Nation of Islam. After winning the title, he announced he had joined the Nation and would now be known as Muhammad Ali. It was during this period that his persona began to change. He was still a master at promoting his fights, but the taunting and gimmicks were taking on an uglier edge. His remarks were taking on racial overtones and, oddly enough, these racial slurs were mostly directed at his darker skined black opponents. He was also calling for the races to be kept separate. In one interview, he stated his support for the segregationist views of George Wallace. He stated that blacks and whites should remain separate because they were actually two different species. He stated that a black woman who would go with a white man should be put to death. This was really ugly stuff. Some say he had this rage because he had been subjected to growing up in the South during "Jim Crow laws", and the resentment of having to sit at a different lunch counter and use different bathroom facilities fueled this anger. However, he

had no desire to change those policies. He, in fact, wanted to strengthen the laws of segregation. This put him at odds with Dr. Martin Luther King, Jr., who foresaw a nation where blacks and whites would learn to live and respect one another.

Did Ali truly believe what he was saying, or was he an impressionable young man taken in by a cultish hate group? I doubt even he knew the answer to this question.

Cus D'Amato, who knew and loved Clay/Ali very well and for years, once told me that after Ali got involved with the NOI he would carry that angry persona with him, but not all of the time. He said that Ali would be in a room talking with people of all races and truly enjoying himself until members of the Nation walked in. It was then that he would go into his angry mode.

Cus also told me that Ali really didn't know much about the Viet Nam War on the day he refused induction into the Army. He said he was told to do what he did and followed orders. This is not said to take away from his stand against the war, but I do wonder if he would have been as vehemently outspoken against it if not for the fact he was going to be drafted.

These are just some thoughts I have had about a very complicated and also simple man. I have many more and they continually change. Anyone who met him felt they knew him, yet I am not sure anyone could really know him.

#### HOOPS and HOCKEY in the HUB

THOSE PROUD PENS — Sometimes it's a long and winding road to reach a highly desired goal. That's what happened to at least two members of the Pittsburgh Penguins franchise with ties to Boston.

For that's what Pens' head coach Mike Sullivan and player Phil Kessel experienced in their lives as they gradually moved toward the fulfillment of their ultimate dream — winning the Stanley Cup.

It was back in the cold dark days of winter — December 12, 2015, to be exact — that Sullivan, then the head coach at Wilkes-Barre/Scranton, the Pens' American Hockey League affiliate, got the call to replace Mike Johnston as the head coach in Pittsburgh. Six months to the day later  $\overline{\phantom{a}}$  on June 12, 2016 - in a storybook ending, those Pens who had once floundered in the dark wound up clutching the Stanley Cup after a Game 6 victory over the San Jose Sharks in California.

"I don't know if there's a team in the league that, from the start of training camp, has been through more adversity," stated Sullivan in an ESPN article. "They went through a coaching change, there was a lot of noise and a number of critics out there suggesting these guys didn't have what it takes. I couldn't be happier for them right now because they proved everybody wrong."

It was a long time in coming for Sullivan, who grew up in Marshfield, went to Boston College High School, and was captain of the team at Boston University. He went on to play for several NHL franchises, including the Bruins, before ending his playing days and embarking on a coaching career.

He took to the switch in positions — from being on the bench as a player on the roster, to directing strategy from standing behind it — right away, leading the 2002-2003 Providence Bruins to 41-17-9-4 mark in his rookie coaching season.

That was good enough for the Bruins GM Mike O'Connell to promote him to the parent club. Up on Causeway Street, the B's flourished under Mike, going 41-19-15-7, accumulating 104 points, and finishing first in the Northeast Division. But things went right downhill in the playoffs as the Bruins were eliminated in the first round by the eighth-seeded Montreal Canadiens.

The lost season of the lockout followed and the Bruins just were not the same after that. A 29-37-16 record in the 2005-2006 season, coupled with a last place finish in the Northeast Division, meant Mike was gone when new GM Peter Chiarelli took the reins.

Then came the wandering years — assistant coaching positions with Tampa Bay, the New York Rangers, the Vancouver Canucks and finally a slot as a development coach with the Chicago Blackhawks.

Which brought Mike to June 18, 2015, when he accepted the head coaching job at Wilkes-Barre/Scranton. Six months later, he was back in the NHL, as the head coach of

an underachieving team that seemed headed for oblivion. Fast forward an additional six months and there was Mike Sullivan cherishing the Stanley Cup, the culmination of a lifelong dream that began nearly five decades ago in Marshfield and reached its pinnacle in an arena some 3,000 miles away on a warm June evening in San Jose.

And what of Phil Kessel, a man who, according to ESPN, was booed out of two towns (Boston and Toronto) before finally finding appreciation in Pittsburgh?

Well, at least with the Toronto fans, Phil got back at them in a way that only a player with an \$8 million annual salary could: he took out a full page ad in the Toronto Star and thanked them

Here's what he stated in the ad: "Thank you. A year ago I was facing the very real prospect of playing for the Toronto Maple Leafs through the 2021-2022 season, possibly to the end of my professional hockey career.

"Being stuck with a franchise without any understanding on how to build a winner or what to do with star players was crushing to my hopes and dreams. TODAY I AM A STANLEY CUP CHAMPION.

"And not just a champion, but the leading playoff goal scorer on the Cup-winning team. What happened?

"Well, you forced me out of town. No matter what I did on the ice, no matter how poorly constructed the roster was during my six years in town, you blamed me. I used to hate it, but now I know I never would have made it to Pittsburgh without you. Thank you. I will never forget you. I will never stop smiling."

But Phil did remember one Toronto fan in a very generous way. It seems there was a hot dog vendor in Toronto's downtown area that he used to visit. That person is somewhat wealthier now, thanks to receiving a \$50,000 anonymous gift that came with a note: "From a big fan and Stanley Cup champion."

"I don't know who else it could be from," the vendor was quoted as saying. "Obviously there are no Stanley Cup champions here in Toronto. Phil may have a bigger waistline than most hockey players, but he has an even bigger heart. I'm happy for him. I miss seeing his face every day — sometimes twice a day."

Kessel led the Pens in playoff scoring with 10 goals and 12 assists for a total of 22 points. "I'm not surprised, he's a special player," said Pens GM Jim Rutherford to ESPN. "Phil really was an impact player for us. I'm so happy for him because his years in the league haven't been easy. Now he's got his name on the Cup."

Both Sullivan and Kessel each had their own personal journeys in the NHL. Much like the classical tale of old, each experienced an odyssey that encompassed a good number of years. But in the end, it was all worth it. As Shakespeare once wrote: "All's Well That Ends Well."
