

# SIBYLS AND THE SIBYLLINE BOOKS

We are reminded that the female counterpart to a prophet is called a sibyl. Delving a bit further into the word "Sibyl", there appears to be a root expression, "the will of God" attached to it. Sibyl is also the name used during ancient times to identify those prophetesses who were inspired by some god, usually Apollo, and some were even described as Apollo's daughters or favorite wives. More often than not, they were considered to be maidens who lived near

springs that inspired a divine influence. This caused the sibyl to utter prophetic expressions while in a trance, daze, or frenzy.

Most confusion about sibyls seems to be in their exact numbers. Plato, for instance, identified only one, while others named any number up to ten or twelve. The important sibyls that I recall at this time were the Erythraean, Cumaean, Delphian, Libyan, Persian, Samian, Egyptian, Babylonian, Cimmerian, Hellespontine, Phrygian and the Tiburtine.

Michelangelo's Sistine Chapel ceiling frescoe is said to be the world's most powerful piece of painting. In addition to scenes which illustrate events from the Old Testament, he also enthroned seven prophets and five sibyls. The prophets are Jonah, Daniel, Isaiah, Zechariah, Joel, Ezekiel, and Jeremiah. The sibyls are Erythraea, who foretold the details of the passion of Christ and the Resurrection; Cumaea, who is credited with "God shall be born of a pure virgin and hold converse with sinners;" Delphica, or the Delphic Oracle, who, in addition to being consulted on national and personal matters, wrote many

about the poems Incarnation, the virgin birth, the passion, the crucifixion and the Resurrection; the Libyian sibyl who said, "The day shall come when all men will see the King of all living things. A virgin, the mistress of the nations shall hold him in her lap, and shall reign in mercy;" and lastly, the Persian sibyl who said, 'Satan shall be overcome by a true prophet. The Lord shall be brought forth in the orb (center) of the lands," and "The womb of a vir-

gin shall be the salvation of the people."

The Sibyline Books are quite often mentioned in Roman history. They are a collection of oracular savings or prophesies (nine books) in Greek hexameter verse. The books are attributed to the Hellespontic Sibyl, put together at the time of Solon (about 638 B.C.) and buried in the Temple of Apollo at Gergis, on Mount Ida. The collection found its way to Cumaea, who brought it to Rome during the reign of Tarquinius Superbus, the last king of regal Rome (about 500 B.C.). It is said that Cumaea offered the nine books to the king at an exorbitant price. He refused to pay the amount, so she burned six of the books. The king finally bought the remaining three books at the original price. These three books were preserved in a vault beneath the temple of Jupiter, but were destroyed when the capitol was burned in 83 B.C. The Roman Senate then sent out agents to acquire a new collection of similar oracular sayings, and this new collection was deposited in a restored temple. Sometime around 405 A.D. this second collection was also destroyed.

# The Last Hope of Mankind

first half of Daniel Webster's First Bunker Hill Oration; here is the rest.

After his brief summary of the history of America, from Christopher Columbus to the Battle of Bunker Hill. our guide, Daniel Webster, next surveys the 50 years since the battle and finds progress both in America and abroad, although not at the same pace, which he compares to "vessels on a common tide, propelled by the gales at different rates, according to their several structure and management, but all moved forward by one mighty current, strong enough to bear onward whatever does not sink beneath it." Knowledge, he says, has triumphed and mankind in 1825 are, "better fed and better clothed ... they are able also to enjoy more leisure; they possess more refinement and more self-respect. A superior tone of education, manners, and habits prevail." More importantly, he finds those past 50 years to have been given over to "the great question of politics and government."

"A great wheel of political revolution," says Webster, "began to move in America." He compares the guarded regularity and safety of that wheel's rotation in America with its irregular and violent impulses elsewhere and concludes that America was fortunate in the condition of the land and character of the populace at the time of our Revolution. Americans, while under the authority of the mother country, had,

Last week I discussed the nevertheless, many years' experience of self-government as regards internal matters and were accustomed to some of the basic elements of our Constitution: representative bodies, division of power, and checks and balances. He credits the character of the American people — sober, moral, and religious — for the restraint from plunder and spoil that might otherwise have attended our Revolution.

> Webster exhorts Americans to exult in the conviction that our Revolution was a beneficial example to the world. It is, however, an example that he would not necessarily apply as a template. "We are not propagandists," he says. "Wherever other systems are preferred ... we leave the preference to be enjoyed." However, given the favorable circumstances of America's experiment in democratic government, he concludes that if the representative system fails here, it is unlikely to ever succeed. With America, he asserts, rests "the last hope of mankind." This is a phrase that would be echoed by Abraham Lincoln in his December 1862 Annual Message to Congress ("the last best, hope of earth") and Ronald Reagan in his January 1974 "We Will Be a City on a Hill" speech ("the last best hope of man on earth").



# L'Anno Bello: A Year in Italian Folklore

Midsummer: A Magical Time

What is it about summer nights that make me think of magic, moonbeams, and fireflies and fairies flitting about a darkened forest? Perhaps the answer lies in the velvety hue of the evening sky, offset by the delicate diamond-like stars that peek out from the late sunset. Or perhaps the answer resides in the comforting sound of crickets and cicadas humming their melody from deep within bushes and trees. It could also be that people tend to congregate outside during the warm summer twilight, illuminating the atmosphere with candles and lanterns from barbecues and alfresco dinners. I always find that the most magical of these nights occurs around the summer solstice, the longest day and shortest night of the year. In olden times, the summer solstice was known as midsummer, which can confuse those of us who view the solstice as the beginning of summer rather than the middle. Ancient Europeans used agricultural rather than purely astronomical methods of gauging the seasons, and so the solstice was considered the height of summer rather than its commencement. As Christianity spread across the continent, Midsummer festivities became absorbed into the feast day of St. John the Baptist, creating an indelible mix of traditions. The result is one of my favorite holidays, a festival that embodies the magic and boldness of summer.

Europeans in older times began the summer on May 1<sup>st</sup>, or May Day, the holiday that marked the time to let livestock out to graze in pastures. Summer ended on Lughnasadh, which fell on August 1st, the festival of the grain harvest and the first fruits of the autumn. As a result, the summer solstice marked the midpoint of the season and as such was called as Midsummer. In Europe, Midsummer heralded not only the longest day of the year, but also the period after which the daylight hours would



summer as well — it makes little sense to celebrate the start of summer when the sun begins to deminish in the sky! Midsummer customs later attached themselves to June 24th, St. John the Baptist's Day, the feast commemorating the birthday of the important Biblical figure six months before Christmas. In Italy, St. John's Day customs symbolize both the decline of the sun after the solstice and the sense of magic which pervades the evening. All over the Italian countryside, gli fuochi di San Giovanni, or St. John's bonfires, blaze from the hilltops on the eve of the saint's festival. These fires both mimic the power of summer sun while also symbolically imploring the sun to stay longer in the sky. Young Italians may also spend the evening gathering herbs, which are supposedly imbued with mystical properties on this unusual and magical night. According to superstitions, these herbs work especially well for romantic divination, and people slip them under their pillows to dream of their future spouse.

All across Europe, similar Midsummer and St. John the Baptist's Day traditions utilize the seasonal staples of water, fire and greenery. In Scandinavia, Midsummer is one of the most significant holidays of the year, on par with Easter and Christmas. Sporting wreaths of flowers on their heads, Scandinavians celebrate this holiday by dancing around greeneryclad Maypoles, building bonfires near lakes and rivers, and sitting down to feasts featuring summer ingredients like strawberries and potatoes. Meanwhile, girls in Russia and Eastern Europe float flower garlands down rivers and attempt to divine the future by interpreting slowly shorten. For this the movement of the garreason, I like viewing lands. People in Spain and the solstice as the middle Portugal celebrate the Feast rather than the beginning of St. John the Baptist with

outdoor carnivals, bonfires, street fairs, and the exchange of potted herbs. Italians, of course, never pass up an opportunity for a festival and party accordingly on St. John the Baptist's Day, especially in cities of Florence and Turin, where he is the patron saint and outdoor fairs and fireworks displays mark the occasion. A favorite of my father, these are small green apples so named because they ripen extremely early, just around the time of the solstice. No matter where one goes in Europe, charming Midsummer revelries emphasize the importance of the summer sun and the blessings of the season. The United States even boasts its own festivals full of outdoor excursions, fireworks and water — the Fourth of July, of course!

Above all, Midsummer is a holiday tinged with bittersweet nostalgia. While it honors the height of the sun's power and the carefree days of summer, it also recognizes that the hours of sunlight will slowly start to diminish once this date is past. It is a poignant reminder that nothing lasts forever. Yet, Midsummer is celebrated with joy, not sadness. Its celebrations encourage people to enjoy the longest day of the year by living life in the present moment. We know that the year is a cycle, and that we should appreciate each season for what it offers. The darkness of autumn and winter reveals celebrations of the Earth's bounty and communal feasts where families gather together in joy and goodwill against the cold. And yes, the sun will be once more reborn in a bright blaze of glory on the winter solstice, immortalized in lightthemed holidays like Hanukkah and Christmas and New Year's Eve. # Put a Stake in Christopher Lee

Actor Christopher Lee was a great actor for my boomer generation who could play bad guys so well and with such aristocratic flair. He appeared in over 250 movies, playing bad guys in such screen hits as "The Lord of the Rings" and equally villain-esque as James Bond enemy Scaramanga and as Count Dooku in not one, but two "Star Wars" flicks.

While hating to be typecast, for boomers he will always be generation's Count Dracula and from a slew of gory horror movies in the 1950s and 1960s. My dad always thought no one could be "Dracula" better than actor Bella Lugosi, the definitive 1930s Dracula; even he eventually admitted that Christopher Lee was pretty good in that character. I loved all those British horror movies; they had so much class back in the day at places like the Puritan Theater near Northampton Station in my neighborhood growing up or at one of those grand movie places in Downtown Boston.

Lee was a six-foot-four Dracula, but before he hit fame he was a two-bit contract studio actor playing minor roles, launching his horror career in 1957 in

"The Curse of Frankenstein." In 1958, he played the famous vampire for the first time in "Dracula." He brought new life into the character and took the infamous bad guy in a new direction from where Bella Lugosi ended the evil doer.

Lee went on to play the vampire from Transylvania in "Dracula: The Prince of Darkness," "Dracula Has Risen from the Grave," "Scars of Dracula" and "Dracula A.D. 1972" (a bad attempt to bring the vampire into the 1970s).

Lee also thought he was a funny guy too, and back in 1978 he actually appeared in a sketch on "Saturday Night Live" and loved doing it.

His greatest regret, he said, was passing over the role that went to Leslie Nielsen in the "Airplane" comedy movie.

He lived a long life and was 93 years old at the time of his passing and his kind will not be seen again. Of course, that is if he doesn't survive that stake in his heart and rise again.

Final line, Christopher Lee was a class act with a great smile and devious look in his eyes. He will be missed by boomers everywhere.


# Chartres Cathedral

Chartres Cathedral, also known as Cathedral of Our Lady of Chartres, is considered one of the most beautiful of the Catholic Church. The cathedral bears the name of the town it is located in. which is about 50 miles southwest of Paris, and isthe last of at least five which have occupied the site since Chartres became a bishopric in the 4th century. It is considered one of the finest examples of French Gothic architecture and is a UNESCO World Heritage Site.

Chartres Cathedral has housed what is believed to be, the tunic of the Blessed Virgin Mary, said to have been worn by Mary at the birth of

Jesus, the Sancta Camisia. The relic was given to Charlemagne as a gift by the Byzantine Empress Irene of Constantinople during a trip to Jerusalem. It was given by his grandson, Charles the Bald, to the Cathedral in 876. Because of this relic, Chartres has been a very important Marian pilgrimage destination.



The previous cathedral that stood on this site survived a fire in 1134 that destroyed much of the town, but on the night of June 10, 1194, lightning ignited a great fire that destroyed all but the west towers, the façade and the crypt of the great Cathedral. It was believed that the Sancta Camisia had been destroyed

in the fire but three days later it was found unharmed in the treasury. The bishop proclaimed this was a sign from Mary that another, even more glorious cathedral should be built in Chartres. Donations came in from all over France and rebuilding began almost immediately in 1194. The people of Chartres volunteered to haul the necessary stone from quarries five miles away. A glorious new cathedral with a massive crypt was built under the direction of Bishop Fulbert and later Geoffroy de Lèves.

The cathedral is in an exceptional state of preservation. The majority of the original medieval stained glass windows

have survived intact, while the architecture has seen only minor changes since the early 13th century. The building's exterior is dominated by heavy flying buttresses, which allowed the architects to increase the window size significantly, while the west end is dominated by two contrasting spires - a 349 ft. plain pyramid completed around 1160 and a 377 ft. early 16th-century flamboyant spire on top of an older tower. Equally notable are the three great façades, each adorned with hundreds of sculpted figures illustrating key theological themes and narratives.

Chartres to this day continues to attract large numbers of Christian pilgrims, as well as large numbers of secular tourists who come to admire the cathedral's architecture and historical merit.

# BIG DIG SUIT A WINNER FOR JOE TECCE'S

Two weeks ago, a jury awarded \$8.5 million to the now defunct Joe Tecce's Restaurant for damages to the once North End landmark due to business disruptions during the Big Dig Project. A spokesperson for the Mass. Department of Transportation stated most likely the public agency will appeal the jury's verdict.

The Tecce family sued the state back in 2004, alleging that the Big Dig construction outside its doors restricted access to the North Washington Street restaurant for years and that the noise and vibrations from the heavy machinery drove customers away in droves.

While the construction ended in 2007, business never recovered. They filed for bankruptcy protection in 2011 and closed later for good that year. Sal Tecce, one of the owners, has stated that the restaurant saw sales drop by 50 percent during the Big Dig construction period.

# **CANNOLI**

Six to ten wooden or stainless steel Cannoli rollers will be needed.

### **CANNOLI SHELLS:**

3 tablespoons shortening
3 tablespoons sugar
2 tablespoons water
1/4 teaspoon salt
3 cups flour

2 teaspoons wine
2 tablespoons water
1 beaten egg
Canola oil for frying

### FILLING:

1 2-pound container ricotta 1 cup sugar cheese A pinch of cinnamon

**SHELLS:** Combine first four ingredients thoroughly. Add water, wine, and beaten egg. Knead dough into ball. Separate dough into small pieces (meatball size). Place in a bowl and cover. Roll each piece into a paper-thin round. Take one wooden or metal roller and gently wrap loosely around thin roller. To seal, dampen one edge of dough with a little water. It is best to prepare three or four cannoli before starting to fry.

**FRYING:** Heat oil in deep fryer or saucepan. Carefully slip the cannoli shell with roller into the deep fryer (or saucepan). With spatula or slotted spoon, turn item in oil to brown on all sides. **Use caution while removing hot cannoli from pan and from hot roller.** It is best to fry one at the time as they brown quickly. Cool thoroughly before storing in a covered container in a cool place. They remain fresh for two weeks.

**FILLING SHELLS:** Drain ricotta cheese in a colander. Then place in a bowl. Add sugar and a pinch of cinnamon before mixing thoroughly by hand. Do not whip. With teaspoon, fill shells with ricotta cheese mixture. Sprinkle confectionery sugar over the cannoli shell before serving.

NOTE: It is best to fill the cannoli shells just before serving. Leftover-filled shells should be refrigerated. Filled shells **will** soften somewhat in the refrigerator

# Nanna & Babbononno

A Nostalgic Remembrance



It was the 4th of July and Dad was playing with the Chet Nelson Band. Chet Nelson and Dad had been on the road together when both were young single men. They shared a trailer and pulled it with one of Dad's old 1930s cars. It was now 1950, and the trailer, the old 30s cars and living on the road just to play one-nighters were long gone. Chet had booked in several county fairs in the northeast and, seeing as Dad was free for the summer, he rejoined Chet's band to play each of the fairs.

I don't know if you are familiar with county fairs. The closest thing we have to an old-fashion county fair is the Topsfield Fair. In many rural areas of America, this once-a-year happening is what people wait for. They come from miles away to participate in the happenings or just to enjoy what takes place.

At most of the fair grounds, there was a race track where sulky races were held each day of the fair. Between races, Chet's band performed from a stage located directly across the track, opposite the middle of the grand stand. At night, the band backed several acts of entertainment, including many old-timers from vaudeville and some younger performers who had appeared on TV variety shows. Believe me, it was fun.

The July 4th fair we were heading for in 1950 was in Boonville, New York. Mom and I prepared things for about two weeks ahead of time. Dad had a surprise for Mom. He asked Nanna and Babbononno to come along and they said they would. As a result, this was going to be a tight squeeze. Fortunately, Dad's '49 Chevy had a big trunk. Mom packed her suitcase with her needs and I did the same. Dad packed both his casual clothes and a band uniform that was part of the image Chet Nelson wanted. But the first thing that we had to find a place in the trunk of the car was Dad's entertainment was invited tuba. Once this instrument to eat. The offerings were fitted in, it became surrounded by suitcases, a Coleman gas stove, a portable barbecue and a Coca Cola ice cooler. Most people might think that the cooler would be filled with cold beer. Mom and Nanna didn't know what kind of foreign food the people in up-state New York might have, so the Coke

cooler became filled with sausages, steaks, hamburgers, hot dogs, cold cuts, cheese, tomatoes, a head of lettuce, cucumbers, radishes and some hot peppers. A couple of loaves of bread and a bag of rolls were carefully placed next to the cooler.

When we picked up Nanna and Babbononno, all of their things were in two small suit cases which fit (just about) in the trunk. Babbononno also had three gallons of Zi'Antonio's best homemade red wine, and they had to go on the floor in the back seat.

When my grandparents discovered that the back seat had more room, Nanna brought out a pot for boiling water, packages of different shaped pastas, a frying pan, some flattened veal that Dad had to force into the cooler, and several other items from civilization that Nanna feared could not be found in the wilds of up-state New York.

With Nanna and Babbononno in the back seat separated by a mound of things in the middle, and Dad at the wheel, Mom as co-pilot and me between them, off we went. We headed west on whatever roads led from Boston to the Mass-New York border, and then out came the maps that brought us to up-state New York. I don't remember how long it took. I was just a kid, and anything longer than a half hour to a kid was, and is, an eternity. Late in the day, we found ourselves in downtown Boonville and Dad had to stop to ask directions for the motel we were going to be staying at. When we arrived, we dropped everything off in our cottages and then asked for directions to the fairgrounds where Dad and the rest of the band had an evening rehearsal with the acts of entertainment.

Knowing that some of the late arrivals hadn't eaten, the coordinator of the fair had a tent set up as a cafeteria. When the band was done with the rehearsal, everyone considered as the served buffet style, and after the first couple of bites, Babbononno leaned over to Nanna and said, "Queste cose di mangiare americane sono merda." (This American food is #@&\$) That was it. Nanna and my mother decided that the food we were going to eat had to be the food we brought from Bos-

ton, and the two of them were going to cook whenever we were hungry.

The next morning, we stopped at a place for breakfast, my folks and grandparents knowing it's almost impossible to kill bacon and eggs. Actually, the food was good, and this was the first time I had buck wheat pancakes made from fresh buckwheat.

After breakfast, we headed for the fairgrounds. Chet Nelson's band rehearsed what they were going to play between races. Most of it was Dixieland jazz with some oldies thrown in. When the rehearsal was over, it was time for the races to begin and the band to play between them. Nanna, Babbononno, my mother and I brought the cooler, barbecue and Coleman stove from the trunk of Dad's car and set everything up outside the tent provided for the entertainers. They made sandwiches using the Italian bread and cold cuts brought from home. Of course, Babbononno had to open a gallon of wine, and when Dad and the band finished the first set, we ate lunch.

Several entertainers and band members looked on wishing they could sample the food, but there wasn't enough to go around. Later in the day, Mom and Nanna began to make dinner. It was opening night and Dad didn't want to leave and come back, so the food was cooked outside that food tent. Nanna and my mother made pasta and veal parmigiana with a side of salad. Everyone came around to watch, especially the owners of a dog act. They introduced themselves and, as it turned out, they were from Foggia, where Babbononno came from.

They teamed up with us and Nanna, Babbononno and Babbononno's new paesano, Johnny Laddie, made cooking arrangements, with the Laddie family supplying future Italian specialties to be cooked. A couple of the other musicians were Italian and offered to go hunting for a store that might have Italian products, hoping to be included in the future feasts. One of them found an Italian grocery store in a distant town and told everyone with an Italian last name where, what and how much. The next thing I knew Nanna and Mom were feeding all of the entertainers and the band. It was like having the familiar extended family surrounding me, with one group speaking Italian and the rest winging their way in English. By the end of the Boonville County Fair, everyone had sampled the food and they became hooked on Mom and Nanna's cooking. This was just the first of many such episodes at county fairs, and it was one of the most exciting parts of my young life. GOD BLESS

Sam Langford fought Jack Johnson in a life and death battle in Chelsea, MA in 1906 losing a close decision to the future champion. Sam was never given a shot at the title, an injustice that is acknowledged by boxing fans till this day. It seems that Johnson, the first black heavyweight champ, decided to draw the color line in order to avoid his most dangerous challengers.

Sam Langford is buried in the Cambridge Cemetery and has a headstone that was placed there years ago by Ring 4. It has been writ-

ten that Langford was the only man Jack Dempsey feared. He was originally from Nova Scotia and made Boston his home.

Brendon Foster is so proud of his great-great-grandfather that he has an image of him tattooed on his arm. It is touching to know that the great Langford is still remembered by his family and by so many boxing fans. At a later date, I will do an interview with Carol along with a story on Langford. He should never be forgotten.
