

Back in 1998, there was a documentary about the tragic story of St. Patrick's Battalion, which fought shoulder to shoulder with the Mexican Army during the U.S.-Mexican War of 1846. These men were mostly Irish immigrants who deserted the U.S. Army to fight for Mexico. Were they traitors or heroes?

## "Honor Box" Payment System

at MBTA Parking Lots to be Eliminated

Effective July 6th, the socalled "honor box" payment system will no longer exist at MBTA parking lots. The MBTA is eliminating the much-maligned process of folding individual dollar bills and stuffing them into tiny slots. The easier, more convenient payment method is PayByPhone which allows customers to pay parking fees by using any phone or vice. PayByPhone is already used by more than 75% of MBTA customers parking in "honor box" lots throughout the transit system.

Another convenient option for customers is the monthly permit system, which includes a built-in discount. At "honor box" lots where the daily parking fee is commonly \$4.00, a \$70.00 monthly permit can save daily parking customers up to \$30.00 a month. In August, monthly permits will have another benefit when they become "universal." One permit will be ing facility with the same or lower daily parking fee. To learn more about the monthly permit, further information is available at www.mbta.com/riding\_the\_t.

For customers who choose not to sign up for PayByPhone, the MBTA will mail a monthly invoice to the address listed on the vehicle owner's registration. Customers choosing the invoice method of payment will pay 50 cents more than PayByPhone customers. If invoices remain unpaid for more than 30 days, subsequent reminder invoices and notices of non-payment will be accompanied by a fine. Similar to All Electronic Tolling used on the Tobin Bridge, this payment system is licensed plate based and eliminates the need to pay for MBTA parking using

accepted at any MBTA park- using the PayByPhone app. Customers are encouraged to sign up for PayByPhone at www.paybyphone.com.

#### PARKING PRICES:

PayByPhone customers pay \$4 to \$7 depending on parking lot.

Invoice customers pay \$4.50 to \$7.50 depending on parking lot.

#### INVOICE SCHEDULE PLUS FINES AND PENALTIES:

## Stirpe Nostra

#### HERCULES, THE LEGENDARY STRONG MAN

Mythology identifies Primary Beings, Titans, gods, and demigods. They have all been discussed in previous issues, except the demigods. This last group is imagined to be the offspring from the union of a god with a mortal being. Dardanus, the founder of Troy, King Minos of Crete, Helen of Troy, Aeneas, the ancestor of the Romans, and Hercules are some of the better known demigods. Hercules (Heracles in Greek) is claimed to be one of the most ancient and most famous of all mythological heroes, and his legendary accomplishments are said to be the richest and most comprehensive of all myths.

Hercules was born in the ancient Greek city of Thebes, the son of the god Zeus and a mortal named Alcmene. The legend tells of Alcmene being visited by Zeus one evening, and by her husband on the following evening. Consequently, she gave birth to twin boys. One child was named Hercules and the other was named Iphicles. Visits of this nature were not uncommon in the many legends of Zeus (that little rascal.) Hera, the wife of Zeus, was not unaware of her husband's extramarital activities. Usually, her only recourse was to hate the illegitimate children with a passion, and to do all in her power to cause them misery and despair during their adult lives. As a test to determine which boy was the son of Zeus, two snakes were placed in the crib with the brothers. Iphicles screamed in terror, but Hercules grabbed the

snakes by the throat and strangled them.

As Hercules grew into young manhood, a number of famous athletes contributed to his education in the various sports. He was instructed in chariot racing, wrestling, archery, and fencing. Linus, the brother of Orpheus, also instructed the strong man in the use of the lyre.

By the time he reached the age of seventeen, Hercules was over six feet tall and an expert marksman with bow and spear. His amazing strength, coupled with his excellent training in wrestling, commanded the greatest respect from all who knew him. This notoriety soon came to the attention of King Thespius, whose flocks were being ravaged by a ferocious lion. When asked if he would stalk and kill the beast, Hercules refused. Some early writers, in a humorous report, indicate that the king's fifty daughters, plus great quantities of wine, convinced

Hercules to change his mind. Other writers insist that Hercules conserved his strength for the fight with the lion, and that his rewards came after he slew the beast.

The next phase in the story of this legendary strong man is most important as it identifies the series of events which led to the imposition of the celebrated 'Labors of Hercules." (The principal characters involved in those labors were sculpted in marble by Phidias on the frieze of the Parthenon in Athens, Greece. Some of these pieces are now in the British Museum as part of the Elgin Marbles that Lord Elgin stole from Greece about 1800 A.D.) Hercules aided King Creon of Thebes in a war against the Minyae (an ancient race in Thessaly.) As a reward for this service. Hercules received the Princess Megara for his wife. Later, in a period of madness brought on by the unrelenting hostility of the goddess Hera, Hercules killed his wife and children. When he regained his senses, he was horrified at what he had done. Upon seeking advice from a high priest, he was told that as punishment for his crime he was required to go to Tiryns, a small country on the plains of Argos and perform whatever ten labors their king Eurystheus would demand of him. Also, if he was successful in these tasks he would achieve immortality along with purification of the murders. **NEXT WEEK:**

## Five Congressional Democrats from Massachusetts Vote against Bay State Jobs

This month, the U.S. House voted to repeal the medical device tax, a job-killing impediment to growth and innovation in Massachusetts. The Commonwealth hosts over 400 medical device firms directly responsible for 25,000 jobs and impacting over 80,000 more in related industries. Yet five Massachusetts Democratic congressmen voted to stand against Massachusetts workers by maintaining the medical device tax, which costs these companies over \$400 million annually. MassGOP Chairman Kirsten Hughes released the following statement:

"Given the size and scope of the medical device industry in the Commonwealth, this tax is a direct attack on Massachusetts. The Massachusetts Democrats who voted to keep this job-killing impediment to growth have shown that they care less about the interests of the Commonwealth and more about their partisan Washington, D.C. agenda."

The five Massachusetts Democrats who voted against 400 Massachusetts companies and 100,000 Massachusetts workers are Michael Capuano, Joseph Kennedy, James McGovern, Richard Neal, and Niki Tsongas.

"Legislation repealing the 2.3 percent federal tax on medical devices cleared the U.S. House Thursday on a vote of 280-140, and an industry leader in Massachusetts predicted the proposal would pass the Senate if it emerges for a vote but faces a veto from President Barack Obama. Members of the Massachusetts delegation were split on the vote, with four voting for repeal and five voting against repeal." The costs of the medical device tax affect tens of thousands of Massachusetts jobs and hundreds of Massachusetts businesses in the health care sector, according to a recent study by the Pioneer Institute. "The new report, authored by Pioneer Health Care Policy Director, Josh Archambault and Xiaofei (Jackie) Zhou, examines the potential impacts on the over 400 medical device companies in Massachusetts, making the state the second highest concentration of employees in the nation, at 24,268. The law could also impact 82,000 additional jobs in related industries," ("New Report: Medical Device Tax Will Cost MA Employers \$422 Million+Per Year," Pioneer Institute, 4/18/13)



## THOUGHTS BY DAN ABOUT THIS & THAT

#### NAPOLEON BONAPARTE

(August 15, 1769-May 5, 1821)

More than Meets the History Books



What more can be said about Napoleon Bonaparte? Well, the main facts of his life are well known, but given how little room has been allowed for interpretation and how much has given way to myth, I would say still quite a bit.

First, let's get one thing straight, the term "Napoleon complex" is based on false information. Napoleon was not a short guy. At 5'7" he was of average height for his time. It's possible the false legend was started by his name, which translates to "The Little General," though in a figurative sense. But it likely had more to do with the British propaganda machine attempting to discredit their national enemy.

Be that as it may, there can be little doubt that Napoleon led France through many bloody battles before his defeat at Waterloo in 1815 and his second imprisonment in St. Helena, where he died in 1821. Thus he has gained the distinction of being responsible for more bloodshed in European his-



tory than any other military leader, though modern historians dispute the extent of his involvement in many of the battles and wars that bear his name.

However true this savage reputation, there is much, that Napoleon did that is to his credit. While thee things may not be as relevant to his legacy as his war tactics, they are worth noting for a full portrait of the man.

It's important to remember that Napoleon rose to power, as second lieutenant in France's La Fere Artillery, supporting the Jacobin fac-

tion during the French Revolution. This was a time of much confusion in France and hostilities were high, especially toward the establishment and everything it stood for, including religion. Over in the Vatican, Pope Pius VI tried to maintain a certain level of peace, but after the death of French Ambassador Mathurin-Léonard Duphot, who was killed at the embassy in Rome, General Berthier had reason to invade and demand the pope renounce power. When Pius VI refused, he was arrested and consequently executed.

Napoleon had been trying to restore the Catholic Church in France for some time, and this incident proved the perfect way in. One thing Napoleon always pushed for was religious tolerance. One of his first orders of business was signing the Concordat of 1801, allowing the Catholic Church back into France after church officials had been hounded out during the Revolution. In a surprising move, Napoleon began reaching out to the European Jewish population, dismantling the ghetto in Venice and granting Jews equal rights.

This was all part of the Napoleonic Code which, at its best, was based on enlightenment ideals. This granted all male citizens equal rights regardless of religion or economic status and devised programs to fund the maintenance of infrastructure and established public schools.

While there were many good points to Napoleon's early influence, there were many areas where he stepped directly backwards and showed telling signs of his ultimate downfall. The Napoleonic Code reduced the rights of women and reintroduced slavery in a lot of French colonies.

What happened to Napoleon around this time is an all too common trait among leaders. His power turned him into a megalomaniac with a loony idea of conquering the world. He got into the habit of censorship and imposed austere laws in the lands he conquered, such as banning the Venetian car-





nival. There was more than a hint of vanity in the way he fought wars, stealing artwork and jewelry from a lot of the lands he conquered.

The wars that bear his name proved very costly, both financially and in terms of casualties. A lot of European farmland was destroyed as well as infrastructure and, outside of Great Britain, the financial and structural devastation resulting from the Napoleonic Wars proved a major obstacle in the Industrial Age.

Even some of Napoleon's own men turned against him and deserted. The turning point was his invasion of Russia in 1812, where his stubbornness and pride led to the death of many of his men while many others deserted after suffering brutal battle conditions in a harsh environment.

Napoleon Bonaparte is one of the most talked about, ridiculed, and disdained military leaders in history. It is precisely that which has buried the more complicated man behind the legend. The blood ran high in his battles and so did his passions and motivations, which deserve a study themselves.

#### Fourth of July

The Fourth of July is not irritating to skin and, if in- produce stomach irritation far off, so here are some safety tips for my pooch friends and their human companions for ALL the pooches out there that don't like fireworks because they hurt our ears. For many people, nothing beats lounging in the backyard on the Fourth of July with good friends and family, including the four-legged members of the household. While it may seem like a great idea to reward Oliver with scraps from the grill and bring him along to watch the fireworks, in reality some festive foods and products can be potentially hazardous to your pets.

Never leave alcoholic drinks unattended where pets can reach them. Alcoholic beverages have the potential to poison pets. If ingested, the animal could become very intoxicated and weak, severely depressed or could go into a coma. Death from respiratory failure is also a possibility in severe

Do not apply any sunscreen or insect repellent product to your pet that is not labeled specifically for use on animals. Ingestion of sunscreen products can result in drooling, vomiting, diarrhea, excessive thirst and lethargy. The misuse of insect repellent that contains DEET can lead to neurological problems.

Always keep matches and lighter fluid out of your pets reach. Certain types of matches contain chlorates, which could potentially damage blood cells and result in difficulty breathing or even kidney disease in severe cases. Lighter fluid can be

gested can produce gastrointestinal irritation and central nervous system depression. If lighter fluid is inhaled, aspiration pneumonia and breathing problems

could develop.

Keep your pets on their normal diet. A change, even for one meal, can give your pets severe indigestion and diarrhea. This is particularly true for older animals who have more delicate digestive systems and nutritional requirements. And keep in mind that foods such as onions, chocolate, coffee, avocado, grapes, raisins, salt and yeast dough can all be potentially toxic to companion animals.

Do not put glow jewelry on your pets, or allow them to play with it. The luminescent substance contained in these products is not highly toxic, but excessive drooling and gastrointestinal irritation could still result from ingestion, and intestinal blockage could occur from swallowing large pieces of the plastic containers.

Keep citronella candles, insect coils and oil products out of reach. Ingestion can and possibly even central nervous system depression. If inhaled, the oils could cause aspiration pneumonia in pets.

Never fireworks use around pets! While exposure to lit fireworks can potentially result in severe burns and/or trauma to the face and paws of curious pets, even unused fireworks can pose a danger. Many types contain potentially toxic substances, including potassium nitrate, arsenic and other heavy metals.

Loud, crowded fireworks displays are no fun for pets, so please resist the urge to take them to Independence Day festivities. Instead, keep your little guys safe from the noise in a quiet, sheltered and escape-proof area at home.

All said and done, I hope ALL my readers and pooch friends and especially my friends at the Post-Gazette have a wonderful fun time and a safe Fourth of July.

Remember to PICK UP after your pet and keep our neighborhood streets and sidewalks clean.

**High Society Fashion** ... Boston's earliest high-fashion gown, an embroidery masterpiece, is now on view at the Old State House.

Do you ever dream of living in a different century and being able to dress the part? The Old State House in Boston is bringing you a chance to get a firsthand view of some of fashion's first looks. The prized handembroidered 18<sup>th</sup> century wedding gown on display was designed and embroidered by Elizabeth Bull, Boston's original fashionista.

In today's society, it's all about the dress on that special day, as even wedding planners in the colonial era were evidently already well aware. In fact, Boston Designer Elizabeth Bull took the precaution of designing her own colorful, hand-embroidered silk wedding gown several years before she even had a groom in mind.

"America's colonial era schoolgirls were remarkably fashion-forward designers," observed Patricia Gilrein, Collections Manager at the Bostonian Society. "They were keenly aware of European fashion trends, and adapted these styles to suit their purposes."

Elizabeth Bull started designing, sewing, and embroidering her China silk gown when she was only 14, while still in school. Embroidery was often undertaken by young women at the time to practice and perfect the art of needlework, but Bull proved to be one of the most extraordinary embroidery artists of her day. By 1734, she had already been at work on her gown for several years when she met a handsome stranger, Roger Price, the Rector of Trinity Church in Boston. At the time, Rev. Price was busily making preparations to make his escape from the uncivilized colonies to assume a more gracious lifestyle in England. Yet, he met Miss Bull and his ship sailed without him. Within a year, he accompanied Elizabeth Bull as she walked down the aisle wearing her embroidery masterpiece at their wedding in King's Chapel.

The Bostonian Society was established in 1881 to preserve Boston's historic past and explain the revolutionary ideas born here. For 134 years, it has managed the Old State House, the oldest and most important public building in American history prior to the Revolution. where, John Adams insisted, "Independence was born." It now serves as a museum and historic site, open to the public seven days a week, from 9:00 am until 5:00 pm. 



## Parla Come Mangi!

(Speak as You Eat!)

Benvenuti! This week's recipe, torta caprese, ends our viaggio in Campania. The name itself indicates that this particular cake comes from the gorgeous island of Capri, known for being, along with Ischia and Procida, one of the top tourist attractions of the region. With its famous Faraglioni and Grotta Azzurra (blue grotto), Capri was already known by the Greeks and the Romans and the ruins of the many villas left us a tangible sign of the Imperial Roman presence in the area. The Romans called Capri, Capreae (island of the goats) and Insula Sirenussae (island of the siren). Roman Emperor Tiberius named it Apragopolis: the land of leisure. What identifies Capri the most, besides its stunning landscape and blue water, is its summer atmosphere where the very Italian dolce far niente gets a convivial twist in the casual-chic frame of the charming piazzetta where tourists, jetsetters and locals meet and enjoy together a caffe', aperitivo or granita, or indulge with a slice of torta caprese. According to the legend, the origin of this dessert dates back to 1920 when Carmine Di Fiore, pastry chef from Capri, was called to prepare a cake with almonds and chocolate in honor of three of Al Capone's men visiting the island for "business." By accident, Di Fiore forgot to add flour to the recipe and the unintended result was very successful: a cake with a soft center and a firm crust that was named after the island of Capri where it originated.

Enjoy this delicious dessert with a glass of ice-cold Limoncello.

#### Torta Caprese

2 cups almonds, skinned
8 oz. melting dark chocolate
¾ cup + 1 tbsp butter (at room temperature)
1 cup sugar

1 cup sugar 6 eggs 2 ½ leveled tsp baking powder

2 tbsp "Strega" liquor (substitute with cocoa flavored liquor) powdered sugar

**Preparation:** chop the almonds and chocolate very finely. Beat the butter with the sugar in a bowl until creamy. Beat the eggs thoroughly in a separate bowl and add to the butter cream mixture. Add the almonds and chocolate then stir in the baking powder and liqueur. Place the mixture in an 11 in. diameter springform cake pan greased or lined with parchment or silicon paper. Bake in a pre-heated oven at 350 °F for about 50 minutes. Turn the cake out onto a wire rack to cool then dredge with powdered sugar and serve. Buon appetito!

#### Torta Caprese

300 g di mandorle pelate 200 g di cioccolato fondente 200 g di burro (a temperatura ambiente) 200 g di zuchero 2 ½ cucchiaini rasi di lievito per dolci 2 cucchiai di liguore

In un'altra terrina, sbatti bene le uova e aggiungile alla crema di burro. Aggiungi le mandorle, il cioccolato ed incorpora il lievito ed il liquore. Imburra o rivesti di carta-forno una tortiera con bordi rimovibili di 28 cm di diametro. Inforna in forno preriscaldato a 180 °C e cuoci per circa 50 minuti. Sforma la torta su una su una griglia per torte e fai raffreddare quindi spolverizza con abbondante zucchero a velo e servi.

## Nanna & Babbononno

A Nostalgic Remembrance

July 4th is just a week away. To most, this means a picnic of some type and fireworks. For Bostonians, it also includes the Boston Pops Esplanade Concert, a tradition started by Arthur Fiedler, continued by John Williams and kept alive by Keith Lockhart. Back in the day, I remember Uncles Paul, Nick and Dad playing for some event on the 4th. As a child, Mom and I attended concerts that Dad played, that included locations like the bandstands at Revere Beach, Nantasket Beach, Houghton's Pond, Wood Island Park, Salem Willows and Boston Common.

I wonder if events like this still happen. As I pass through small Massachusetts towns today, I still see bandstands in the centers of many of them, and wonder if they are relics of the past or whether they are still used to present free music to the public.

The Musicians' Union used to have a fund that paid the musicians for the music which was free to the public and just for the asking. Back in the day, every time a record was played on the radio, a few cents went into a fund called the Radio and Transcription Fund, or R and T Fund, for short. It later became the Music Performer's Trust Fund, or MPTF. Today it still exists, but is a shell of its former self. When the money was never ending, most of the bands were Sousa-style concert bands, large brass ensembles that played a bit of classical, lots of marches and a few popular selections. Years later, when they evolved into dance or swing type bands, I played either bass or bass guitar for the leaders that included Bill Harding, Bernie King, Tony Bruno, Jr., Johnny Shea and Baron Hugo. I even had my own Dixieland combo and played at Shea's Beach in East Boston a few times. (It's Constitution Beach for those of you who pass the sign on Bennington Street in Orient Heights, but didn't grow up in East Boston.)

When I was a child, Dad was hooked up with a conductor who specialized in this type of music. His name was Max Cruley and Dad was the tuba player. Back then, Dad owned both a tuba and a sousaphone. He had marched in many parades carrying these instruments, but he preferred the bandstand-type concerts. They were easier on the back muscles. My

favorite locations were the indoor bandstand at Nantasket Beach or the outdoor gazebo at Revere Beach. When the band was booked to play concerts at these locations, Dad would bring Nanna, Babbononno, Mom and me along. At times, a lunch would be packed ahead of time for the family to enjoy. I always wished that Mom would forget the food, because both beaches, Nantasket and Revere, had hotdog stands, pizza places, lots of cotton candy vendors, popcorn machines with hotsalted popcorn, and soft-serve ice cream shops that sold something called "frozen custard." The kick-off concert was always on the Fourth of July.

Days before the first concert, would take his sousaphone out of a hall closet and begin to shine it up. Seeing it was made of silver, it would have tarnished over the winter and he wanted it to be perfect. When I was old enough, he would pay me to shine the instrument. His only task was to make sure the valves were well-oiled and the mouth pieces were clean enough to blow through. If one of Max Cruley's concerts was to begin at noon on the 4th, Max, with baton in hand, would face the orchestra and give the downbeat just as the clock struck twelve. All of the musicians, Max included, would be dressed in band uniforms that included navy blue jackets and military hats. When the baton signaled the downbeat, all of the musicians would stand and begin to play the Star Spangled Banner. The audiences would stand at attention until the national anthem was over, applaud and then sit to listen to the rest

of the concert. I got to know most of the musicians as a child. Many of them were old-timers that Babbononno knew and he would greet them with handshakes and hugs during intermission. Babbononno would also have to acknowledge his sons, because more often than not, Uncles Paul and Nick were in the front line of musicians playing their clarinets. One of my favorite spots was the bandstand at Wood Island Park. This was a recreation center in the Day Square area of East Boston accessed by Neptune Road. Back in the 1960s, it became part of Logan Airport. But, by then, it

had deteriorated. The only part of it that was used was the parking lot which became a lover's lane at night ... but, that's another story.

When the band played at the Wood Island bandstand, I was just a young kid, but knew most of the other young kids who accompanied their parents there, and we played an assortment of games while the musicians serenaded the crowds.

Years later, I was asked if I could put together a Dixieland band to play on the 4<sup>th</sup> of July in back of the original bath house at Shea's Beach (Constitution Beach in East Boston). I assembled a group of musicians that I knew could play Dixieland music better than most. Among them was a tuba player I called, "Dad." They advertised the event in the East Boston Times and the Free Press, the two East Boston newspapers back then. The names they listed were mine, Dad's, Uncle Paul's and a couple of other East Bostonians that I included in the band. My ensemble included banjo, tuba, drums, clarinet, trombone, and two trumpets. I brought my bass violin along, but I was there basically to conduct. Evidently, many East Bostonians who remembered the name, decided to come to the beach on that Fourth of July. As we began to setup, we were greeted by throngs of well-wishers who remembered us from the old neighborhood.

Some were from Dad's generation and knew him and Uncle Nick. Others were my age, people I had grown up with who brought their young families with them to enjoy the day.

While preparing for the event, I decided to do something unorthodox. I used the melody of the song, Southie is My Hometown, and rewrote the title and words. Considering where I was, when I announced the song, it was called, Eastie is My Hometown. Throughout my career as a musician, I prided myself as being a good musician and a bad, a very bad singer. When I sang the substitute words, regardless of my lack of vocal qualities, the beach goers applauded and screamed as if I was a local hero, come home.

We played dozens of Dixieland favorites. I had assembled some of the best musicians I could dig up to be part of that band, and by the time intermission rolled around, they had proven themselves. One thing was missing. Dad whispered in my ear and I included his suggestion during part two of the concert ... Good old-fashioned Italian music. I even sang Oh Marie in Italian, ouch!

Those days are gone, but I wonder if those outdoor events still exist on the 4<sup>th</sup>, and MAY GOD BLESS AMERICA.



smart hitter that he made the defense even more defensive. They even created a shift for him, moving everyone over to right of home plate trying to make their odds better with him at bat. Williams (1918-2002) grew up in San Diego and made a big entry into the game at age 20. He was the last player to bat .400. He overcame poverty, two wars, injuries and was a relentless perfectionist. He once said. "A man has to have goals for a day, for a lifetime and that was mine, to have people say, 'There goes Ted Williams, the greatest hitter who ever lived." Certainly nobody worked harder at it. The summer of '41 was one

for the record books. In his third season, he hit .406, the last player to reach .400 over a full season. This was his first of six batting titles. In 1942, he won the Triple Crown, batting .356 with 36 homers and 137 RBI. He was a hitting machine with a lifetime .639 slugging average, second, to Babe Ruth. Fifteen years later in 1957, at age 39, he had the highest average in all of baseball at .388.

In his baseball career from 1939 through 1960, he hit .344 with 521 homers and 1,839 RBI. In his final season 1960 at age 42, Williams hit .316 with 29 homers. In the final game of that season at Fenway Park, I sat in the right field grandstands and watched him hit his 521st

and final career home run to end an amazing career like no other player. One of the greatest ballplayers ever to enter the Hall of Fame. No one has come close to him since.




