

# Stirpe Nostra

A weekly column highlighting some of the more interesting aspects of our ancestry . . . our lineage . . . our roots.



#### INTRARE JULIUS CAESAR

Gaius Julius Caesar was born July 12th, in the year 102 B.C. into a noble and aristocratic family that traced its ancestry back to the very beginning of Roman history. During a one-hundred-year period from 160 B.C. to 60 B.C., there were several Caesars who held public office and at least four of them were honored with the consulship (chief magistrate). Not too much is known about the youth and education of Julius except that his instruction was entrusted to a distinguished teacher of grammar and rhetoric.

He married Cornelia Cinna, daughter of an opposing party member in a civil war against the dictator Sulla. Caesar was ordered to divorce Cornelia but boldly refused, consequently, his property was confiscated, and he was forced into a short period of hiding.

A military experience was considered necessary for any young Roman of rank, so Julius joined a Roman legion and earned a civic crown for bravery. He returned to Rome in 78 B.C. and gained such popularity and reputation through his oratory that he decided to go to the Island of Rhodes to study under the great orator of the day, Molo. His trip was interrupted when he was captured by pirates and held for a fifty thousand dollar ransom. After being released, he made good on a promise to return and crucify his former captors. An interesting attempt to comment on his merciful nature is given in the story that he slit the throats of the pirates before crucifying them so that they wouldn't suffer too much.

After completing his study at Rhodes, he returned to Rome to fill a vacancy in the Supreme College of Priests and threw himself into politics with great energy. He was kind and generous to everyone; no applicant for aid went away empty handed and his popularity became unbounded.

Caesar obtained the governorship of a conquered portion of Gaul together with control of four legions. He became highly skilled in arms and horsemanship and he possessed incredible powers of endurance. When on the march, he was always at the head of his army, both on horseback and on foot, in sunshine or in rain. He traveled great distances with incredible speed, planned his battle strategy well in advance and struck when and where least expected. When victory was uncertain, he often sent away all of his horses in order to remove any temptation for retreat and to impress upon his troops the necessity for holding their ground.

He referred to his men as comrades and not as soldiers, he valued them for their gallantry and never attempted to curb them except in the presence of the enemy. He took no notice of conspiracies that were detected, other than to make it known that he was aware of them. He kept a watchful eye for deserters or mutineers and punished them more severely.

During the next several years, he continued with the conquest of Gaul in a series of campaigns which showed his skill and variety of tactics, as well as his energy of movement, which are said to be unsurpassed in the annals of warfare.

After a great victory he usually turned his men loose on the town, boasting that they could fight well even when reeking of perfumes.

# Blessed Giovanni Battista Scalabrini

Giovanni was born July 8, 1839, in Fino Mornasco in the diocese of Piacenza, the third of eight children to Luigi Scalabrini and Colomba Trombetta.

In his adolescence, he wrote a poem in praise of the life of Saint Aloysius Gonzaga and in his childhood often recited the Angelus while each October reciting it in the Como Cathedral. He had a devotion to Saint Joseph and Saint Francis de Sales as well as Saint Charles Borromeo which lasted his entire life.

Ordained on May 30, 1863. He was a professor and rector of Saint Abundius Seminary, and was made Bishop of Piacenza, Italy on January 30, 1876, at age 36.

Scalabrini conducted diocesan visitation five times, visiting all 365 parishes, half of which could only be reached by foot or mule. Celebrated three Synods, one of which was dedicated to the Eucharist. Encouraged frequent Communion and perpetual adoration. Reorganized seminaries and reformed their curricula. Preacher, teaching always to love the Pope and the Church

He worked with cholera victims, visited the sick and prisoners, and helped the poor. He saved many farmers and workers from famine, selling his horse, chalice, and the pectoral cross that Blessed Pope Pius IX had given him in order to buy food. Founded an institute to help hearing and speech-impaired women. Organized assistance for young single women employed in rice fields. Established mutual aid societies, workers' associations,



rural banks, cooperatives, and Catholic Action groups. Ordered that catechism be taught in all

He was convinced that devotion to religion and one's country could be reconciled in the hearts of Italians. Promoted reconciliation between Church and State, and helped solve a difficult moral dilemma for Italian Catholics. He aimed at preparing this religious reconciliation on a practical level, combining religious belief, and patriotic love in his work with migrants. Worked with millions of Italians forced to emigrate, often in dire conditions, always in danger of losing their faith and their attachment to religious practice.

With the approval of Pope Leo XIII, on November 28,1887 he founded the Congregation of the Missionaries of Saint Charles Borromeo (Scalabrinians) for religious, moral, social, and legal care of Italian migrants in America. He convinced Saint Frances Xavier Cabrini, the Mother of Migrants, to leave for America in 1889 to care for children, orphans, and sick Italian migrants. In 1895, founded the Congregation of the Missionary Sisters of Saint Charles for migrants.

He came to America in 1902 to make a thorough study of the missions under his auspices and the needs of his Countrymen in the United States. He was invited to the White House and met with President Theodore Roosevelt on October 10, 1901. In 1902 he was invited by Reverend Vittorio Gregori, pastor of Sacred Heart Church in Boston's North End where he visited, performing numerous Confirmations.

He passed away on June 1, 1905. He was beatified November 9, 1997, by Pope John Paul II.

#### WHY COLUMBUS MATTERS

Columbus was a hero to the people who founded America more than 200 years ago. They admired and respected him for his explorations that connected their brand-new nation to the history, culture, and achievements of Europe, giving it greater prestige and "standing" in the world.

Over the years, Columbus became a patriotic icon, included in the pantheon of the Founding Fathers of America. Our nation's capital was named for him. Our Pledge of Allegiance was written in 1892 during the celebration of the 400th anniversary of his first voyage, and over the past nearly two and a half centuries, many cities and states have honored him with statues and other tributes. In fact, the United States has more monuments to this 15th-century Italian than any other nation in the world, according to The Christopher Columbus Encyclopedia.

Columbus's reputation came under attack in 1992 on the 500th anniversary of the first of his four voyages. To further their own political and social agendas, special interest groups defamed Columbus, his character, and his legacy. They made him the poster boy for every injury indigenous people in North and South America experienced at the hands of the other Europeans, who followed him to the newly discovered continents.

Since then, the movement to erase Columbus from our history has gained momentum. Today, these activists would remove Columbus monuments and change the name of the federal holiday named for him as well. Sadly, many cities and states have joined this attempt to rewrite history and forget the man our nation has honored for more than 200 years.

Today Columbus is falsely charged with slavery and genocide. Largely ignored is evidence in Columbus's own logs stating he admired the Taino tribes and defended them against the warlike Caribs and Canibs, who captured, enslaved, and even ate their prisoners. Columbus was a blood brother to one of the Taino chiefs, Guacanagari. He never brought any slaves to the newly discovered continents or owned any himself. Instead, as a deeply religious man, he hoped to bring Christianity to the indigenous people he encountered.

People also have been led to believe that the land Columbus explored was a Garden of Eden. The truth is that long before Columbus's voyages, most indigenous people did not live past the age of 29 because of disease, poor nutrition, and warfare. They fought each other, practiced torture, slavery, and the ritual murder of their own women and children as well as their prisoners of war. The Aztecs, for example, slaughtered thousands of people in ritual sacrifice by cutting out the beating hearts of their prisoners of war.

So it is ironic that many American cities and states want to change the name of Columbus Day to Indigenous People's Day. To date, about 50 American cities have already done so. Elsewhere, statues of Columbus are being defaced and removed from the parks and city squares where they have stood for more than a century.

We realize it will be challenging to restore Columbus's reputation, but just as it has changed over the years, so has the meaning of his holiday. Today, Columbus Day is an opportunity for millions of Americans who share his Italian heritage to celebrate their traditions and contributions to the United States. Columbus Day has become Italian American Heritage Day.

It is the day that Italian Americans celebrate their presence in America. It is the day they remember their immigrant ancestors' early struggles here, which included poverty, discrimination, exploitation, and even lynching. It is the day that marks

# The Combat Zone Remembered

As author Stephanie Schorow stated in her book talk, Inside the Combat Zone, sponsored by the Friends of the North End Library, "You can cut off the supply but not the demand." With the demise of Scollay Square and its titillating attractions due to massive urban renewal in the late 1950s, salacious entertainment moved to the middle of the city in the Washington Street area. This area, historically important as the site of the Liberty Tree during the time of colonial uprising, became a new front for a different type of free speech in this five to six block area known as the Combat Zone. Inside the Combat Zone Striptease shows, dirty movies, Author Stephanie Schorow and pornographic bookstores abounded.

While some might assume that the name Combat Zone derived from the need for a strong police presence, the name came from the fact that servicemen on leave flocked to the area. Mixing alcohol and drugs with an almost lawless disregard for societal norms meant this den of exotic dancers, prostitutes, and organized pickpockets was aptly named.

The remarkable and almost unimaginable transformation of this area from corruption to a thriving neighborhood of college students and high-rise condo dwellers is attributed to



a number of factors: The city planners created zoning requirements, and standards for signage and storefront design were put in place and enforced. All of this may have been for naught except for the development of VCR technology. What previously could only be viewed in a public space moved to private space. Likewise, societal norms changed. Many banned books that had only been available in pornographic bookstores were now in the mainstream.

The rise and demise of the Combat Zone is part of Boston's history. The Zone is not completely eradicated. If you walk down a certain street, two "gentlemen's clubs" are still in business.

Festivities and Fun on the Fourth of July

No other holiday smells, tastes or feels like summer more than the Fourth of July. It is the scent of fired-up grills emanating from every American backyard, the light swirl of smoke rising up in the hazy heat. It is the taste of sweet buttered corn crunching between your teeth. The Fourth of July encompasses the sounds of families laughing as they share food and memories outside, and of fireworks exploding across a silky night sky. To this day, I still feel a mysterious shiver when I hear the faint sound of fireworks bursting from some far-off festival during a starlit evening. These distant fireworks instill in me the feeling of the unknown, the sensation that little feasts are sweeping the country before the big celebration of Independence Day. Because of these exciting and myriad feelings, the Fourth of July remains one of my favorite holidays, the quintessential celebration of summer. Therefore, the Fourth of July commemorates a tremendous event - a bold statement of independence, a desire to free oneself from oppression that would inspire revolutions the world over. As a patriotic holiday, the Fourth of July is also a perfect time to honor America's diversity, and during this holiday I often reflect on what it means to be Italian-American. Italians have been involved in America's quest for liberty and equality since the country's early days. The Tuscan physician Filippo Mazzei inspired the Declaration of Independence's statement that everyone has fundamental equality. Giuseppe Garibaldi, the hero of Italian independence, was recruited to fight in the Civil War and though he did not because of his commitment to Italy's freedom, his name inspired a Union Army regiment comprised of soldiers from both Europe and America. An Italian immigrant, Constantino Brumidi, painted the U.S. Capitol dome. I believe that America's diversity and blend of cultures is precisely what makes our country so great, and on the Fourth of July I celebrate my pride as both an American and an Italian-American.

Along with its history, the Fourth of July is also a revelry in the primordial pleasures of summer, of outdoor festivities and food and fire and the splash of water. In this way, it resembles European Midsummer celebrations, which mark the height of the season around the summer solstice. My family has several Fourth of July traditions which I hold especially dear, all of which epitomize the unbridled joy of summer. On the night of July 3rd, my hus-

#### Are We Creating A Second East Boston Here?

I wish I could say I was shocked at the plans for the Suffolk Downs property but I'm not. As I looked at the rendering of this future proposal to be called Belle Island Square, all I could see was yet another "high-rise Manhattan" and this time talking about 10,000 apartments and condominiums in a 161-acre development.

Most likely it will become yet the latest metastasized Seaport District. These little Manhattans appear to be popping up across the city. Look at the East Boston waterfront growth and its effect on the Jeffries Point neighborhood, look at the Fenway Park area, and look at the North Station area. Now 10,000 new residences in East Boston called Belle Island Park?

How much development is too much development? Developers keep seeing huge dollar signs in front of them and it appears city officials just keep going along with them. City Hall is even now saying it would build a new neighborhood but it would be a neighborhood that would only

negatively impact the housing needs of the ordinary residents of my East Boston community. Developers are proposing to set 13 percent of its housing as affordable, the bare minimum required by City Hall. Others have talked about more affordable housing off-site as if that is realistic. East Boston has seen an ongoing infusion of housing starts. Every vacant piece of land is going fast and it continues to hurt longtime residents having the possibility of staying here. Homes are constantly on the market and many for seven digit prices.

I don't see Belle Island Park becoming just another benign neighborhood. It will forever make East Boston that much more unaffordable to small home owners or working-class families. If this is the future, it will have a negative affect on the livability of the East Boston community.

We will need more meetings between developers and residents. It could be the ruin

At the height of the Great Depression Hollywood produced many feel good musicals that were a source of escape for people struggling through very difficult times. One of the most popular of these was the Busby Berkeley film 42<sup>nd</sup> Street that starred Dick Powell and Ruby Keeler, with music by Harry Warren and Al Dubin. In 1980 Gower Champion and David Merrick brought a stage version of it to Broadway. The play was a huge hit and has been revived repeatedly since then, most recently in London's West End where it was directed by Mark Bramble with choreography by Randy Skinner.

The latest revival has just opened at the Ogunquit Playhouse with original sets from the London production. Randy Skinner is directing and choreographing this production. Unfortunately, Mark Bramble passed away earlier this year.

The backstage musical about aspiring hoofer Peggy Sawyer having to step in when leading lady Dorothy Brock breaks her ankle during rehearsals for the play *Pretty Lady* is the standard "the show must go on" theme that was popular in the 1930s. What is so special about this piece is it has many great, if corny, lines, some of the greatest songs ever written for a musical, and stunning dance numbers.

It really is all about the dance, and who better to make that happen than Randy Skinner who worked on the original Broadway production in 1980. The dance numbers here are simply exquisite. This is one of the largest casts ever assembled on the Ogunquit Playhouse stage, and the sound of all those tapping feet is intoxicating.

Jessica Wockenfuss as Peggy Sawyer, the starry eyed kid from Allentown, PA whose golly gee demeanor belies her drive to make it in the city that never sleeps is outstanding. She puts it all together with her lovely singing voice, delivery, and amazing dancing feet. She is a Peggy Sawyer to remember.

Steve Blanchard is Julian Marsh, the hard driving director who gives more pep talks than the manager of a baseball team playing in the World Series. He delivers his lines in rapid fire without missing a beat; "You're going out there a youngster, but

coming back a star." His performance of Lullaby of Broadway is marvelous. You can just taste the theatre district of old New York as you listen to him sing the lyrics.

In Shadow Dance, Rachel York as the snooty and aging star Dorothy Brock dances in front of a large curtain on which her shadow is double cast. Ms York and Ms Wockenfuss perform a lovely duet on the classic About a Quarter To Nine. It is one of those great Broadway tunes and gets a bit of a modern arrange-

Tenor Billy Lawlor is played by Con O'Shea-Creal. He and Ms York perform another favorite in You're Getting To Be A Habit With Me. Mr. Con-Creal gives a convincing happy-go-lucky Lawlor filled with enthusiasm.

Sally Struthers is Maggie Jones and, as always, brings her wonderful comedic timing to the Playhouse stage. Along with Cliff Bemis as Abner Dillon, Dorothy Brock's sugar daddy, and Ryan K. Bailer as her not so secret paramour, there is a stage full of talent performing here.

While the story is fun and fast moving, if predictable, 42nd Street is all about the singing and dancing. The numbers are spectacular. We're In The Money is performed with giant dimes being rolled on stage (They are Mercury heads in keeping with the time frame). Shuffle Off To Buffalo with Kilty Reidy as Bert and Megan McLaughlin as Lorraine, a couple heading off on their honeymoon, is sweet

The best is saved for last when the stage is filled with dancers on rows of lit stairs tapping away to the title song. Signs with the names of theaters, shows, and performers hang above them while they sing and dance. It is an outstanding number that brought the audience to their feet. It has been said there is a broken heart for every light on Broadway, but these lights bring

Last month I got to experiinvestment that is paying great dividends. Of course, it takes more than lighting to make for great theatre, and those ingredients are in abundance at the Ogunquit Playhouse. Artistic Director Brad Kenney proves over and over again he knows how to choose great plays, find the best talent, and bring in the finest creative teams available. It is all on display in 42<sup>nd</sup> Street.

If you love a fast paced, toe tapping, Broadway musical filled with some of the best songs ever written, you will find it playing now in Ogunquit, Maine. I loved it and can't imagine anyone

# Nanna & Babbononno

A Nostalgic Remembrance



A few months ago, I attended a monthly English High Alumni luncheon at Jimmy's Steer House in Arlington. Each first Tuesday of the month, a group of EHS grads from various years get together for lunch. We never know how many are going to attend, we just show up. Anyway, as we sat waiting for our lunches to be served, we conversed about many topics, our days at English, the current news and people we attended classes with who were no longer among us. One of the guys, Joe Aurelio, a writer, educator and retired businessman offered a bit of information most of us found interesting. He had sent in a saliva sample to a company called 23 and Me. They research vour DNA from the samples of fluid they receive. The 23 in their title represents the 23 pairs of chromosomes in the human body and Joe, interested in his origins, sent in a sample and had received the results.

Joe's family is both from the north and south of Italy and the findings showed he had Mediterranean and northern European bloodlines. As I listened, I was fascinated with what he was relating about his origins and happened to mention the conversation to a neighbor, once I arrived home that afternoon. My neighbor, Harry Tse, was born in Hong Kong and has done similar research trying to determine his ancestral origins. Once back in my house, I Goggled 23 and Me and received all of the information necessary to try my luck at ancestral genealogy. I sent for the kit that would get me started, and when it arrived, followed the directions that would allow them to trace my ancestry.

I was familiar with the places my people came from. Babbononno was from Foggia, an east coast Italian city across from Rome. Nanna was from Avellino, a location just northeast of Naples, as was Grandpa Christoforo. Grandma Christoforo's ancestors came from both southern Italy and Spain. As far as I knew, this put all of them into the same subracial category, white southern European. In my creative imagination, I conjured up a group of Romans who, during the time is that so many people are of the Caesars, were my ancestors, and when I told this to my neighbor, Harry, he assured me that the DNA testing would help to determine my ancestry long before there was a Rome.

My curiosity continued to grow as I awaited the results from 23 and Me. I thought about the appearance of my grandparents and how the

what we are today. Babbononno had sandy brown hair, blue eyes and light skin. Nanna had dark red hair, not like Irish red hair, but a dark almost brownish red. She too, had light skin. Grandpa Christoforo had black curly hair, light skin and blue eyes. Grandma Christoforo had straight black hair, dark eves and dark skin. As a result of these characteristics and the fact that they all looked Mediterranean, I assumed that our ancestors came from South Western Europe. Mom's hair was brown, her eyes were brown and she had skin so white, she couldn't obtain a tan, she would just burn. Dad inherited the black curly hair from his father, the dark skin from his mother, but also, the blue eyes from his father, only Dad's eyes were more on the grey side. If I am allowed to brag a bit, I might say that my folks were a rather good-looking couple. Finally, the preliminary results arrived and I was able to learn about my ancestry. The tests put my father's side at a point of about 18,000 years ago, stating that the regions the ancestors came from were: Southern Europe, the Near East and Northern Africa. This means that if the results are accurate, there are traces of Phoenician (today's Lebanese), Arab, and Turkish blood lines as well as those from Sephardic or North African Jews. The maternal side shows a backward look of 13,000 years and states that Nanna's side came from Central Europe, the Near East, Central Asia, Northwestern Africa, and would include people that are today called Spanish, Moroccans, Lebanese and Scandinavians. The company intimated that the results were not complete and I would receive a complete breakdown within two weeks. I could hardly wait. I figure that with all of this information and \$1.50, I could buy myself a cup of coffee ... that's all it's worth to most people, but where Italy has been the crossroads of western civilization for at least 3 to 5 thousand years, I had to know what my origins were.

The problem with this type of research in the United States mixed. Having traveled around the world with East Boston's Sal Meli when we were both young and single, one thing that I noticed was that most of the people of a particular country had roots in that part of the world that went back to who knows when. We in the U.S. are living in a young country. If you go back to the results translated into who and Mayflower, you are only looking

at 399 years of civilization. First came the English and Scottish. Then, in the early 1800s, in came the Germans, and later, in the 1840s, the Irish. Our people didn't arrive until the 1880s and were accompanied by the Slavs, Jews and Greeks. Coming in from the other coast were the Chinese and Japanese to a lesser degree. Since the end of World War II, people from Latin America and war ravaged countries from all over the world have stopped by and not left. This means that we are a pluralistic society, and rapidly

becoming a melting pot. Let's look at this phenomenon locally. When Dad and my uncles spoke about some of the people they knew growing up they referred to them as so-and-so, the Irishman, or so-and-so, the Jewish guy, or so-and-so, who knows what. There wasn't any negative sentiment attached, no animosity to the way they referred to them. It was just a way of describing them. Yet, when I tell my boys about those references, they don't really understand because their generation is all mixed. First and foremost is the mix of Irish and Italian in this part of the country. According to a friend who is from Pittsburgh, the Italians and the Czechs that settled there intermarried beginning with the American born. In both cases, the one similarity was Catholicism. What is common in the U.S. today is that these, and many more mixes, are what my kids' generation takes for granted. Again, as Sal and I traveled around the world, this integration was missing to a great degree ... it only happened in the U.S. starting with my generation.

I had a close friend that taught with me when I was at Hyde Park High School. His father was Italian and mother Irish. His parents were denied a marriage request locally by the parishes they belonged to because theirs would be considered a mixed marriage. Finally, a Paulist priest in New York married them. Of course, a mixed marriage wasn't going to work. If my friend's mother had lived another month, she and her husband would have celebrated their 60th anniversary. That's the way it was then, and now, we are Heinz 57. Considering my origins, maybe I should learn how to ride a camel or tell people that my Roman ancestors sold used chariots near the Roman Forum, who

## Recipes from the Homeland

#### VEGETABLE MEDLEY

2 medium potatoes 1/2 pounds fresh, frozen or canned string or cut beans

1 large garlic clove

1 medium zucchini sliced

(1/2-inch pieces) not peeled

1 medium yellow squash sliced (1/2-inch pieces) not peeled (optional)

four-ounce portion crushed tomatoes 1/3 cup olive oil

1 medium onion chopped 1 tablespoon capers

2 large ripe tomatoes or a

3/4 tablespoon basil

In a saucepan, sauté onion and capers in oil until opaque. Add chopped ripened tomatoes or four ounces of crushed tomato. If you prefer a heavier sauce, use a four-ounce can of tomato sauce instead. Add fresh or dried basil. Stir, cover and simmer slowly. Meanwhile, peel and cube potatoes. Wash and set aside. If using fresh string beans, cut ends off, wash and set aside. Add potatoes and beans to saucepan. Stir, cover, and simmer slowly for ten minutes. Add sliced zucchini and yellow squash (optional). Salt to taste. Add water if more liquid is desired and bring to a boil. Cover and simmer slowly until all vegetables are tender. Serve with garlic bread.

Serves two.



their journey from impoverished immigrants to successful citizens of our nation.

At the turn of the last century, more than five million Italian immigrants came here, not to find a better life, but to earn it. They and their descendants have become one of our nation's greatest success stories — living proof of America's willingness to give people who want to work opportunities that their own countries deny them.

Today, the U.S. Census Bureau estimates that twothirds of the Italian Americans in the workforce are in white-collar positions as executives, doctors, lawyers, teachers, and entrepreneurs. Italian Americans are in classrooms and boardrooms; in police cruisers, fire stations, and the military; in state and federal governments; and in science, medicine, and the arts.

So let's be clear about what Columbus Day really stands for. In 21st-century America, it is no more only about Columbus than Thanksgiving is only about the Pilgrims, or the Fourth of July only honors Thomas Jefferson. Instead, these holidays are occasions for us to celebrate America, her history, her achievements, and her promise.

Columbus Day celebrates the successful immigrant experiment. It is the day that the nation's fifth largest ethnic group celebrates its heritage and says "Thank you" to the land of opportunity.

#### **REST IN PEACE**

#### Willie "The Worm" Monroe

Only Fighter to Hold an Undisputed Win Over Marvin Hagler

In the 1970s Philadelphia produced many great middleweights. Bennie Briscoe, Bobby "Boogaloo" Watts, Eugene "Cyclone" Hart, Stan "Kitten" Hayward, and a slick boxer by the name of Willie "The Worm" Monroe were a few of the names who put on exciting matches at the Blue Horizon and Spectrum where J. Russell Peltz was promoting fights.


Willie Monroe was a gifted boxer who came close to earning a title shot. He held wins over Eugene Hart, Carlos Marks, Stan

Hayward, Billy Douglas, and Angel Robinson Garcia. He also is the only man to have beaten Marvelous Marvin Hagler decisively. On June  $22^{\rm nd}$  Willie Monroe passed away at the age of 73.

When the talk turns to great Philadelphia middleweights the names mentioned above all come to mind, but there is one more that can be included as he was in the mix with all of them; Marvin Hagler. Hagler had first traveled down to the City of Brotherly Love on January 13, 1976 to fight Bobby Watts. Hagler was bringing a 25-0- record into the bout and hoped a victory would catapult him into contention for a world title fight. After ten rounds he had handily beaten Watts. Well, he had won in the eyes of all but the judges, who gave the win to Watts on a majority decision. It was a tough break for Hagler, but it did not slow him down.

Hagler returned to Boston and a month later stopped Matt Donovan. He then signed to fight Willie Monroe in Philadelphia. The fight would take place on March 9, 1976. Hagler was staying busy and wanted to gain his first win over a Philly middleweight. Monroe had a record of 31-3-1 going into the fight and a little over a year before had dropped a decision to Watts.

On the night of the fight the city was hit by a huge snowstorm. Russell Peltz always had a film crew on hand to record the fights, but they were unable to make it that night because of the weather, so the fight was not taped. The bad weather dampened attendance, but 3,459 fans still managed to make it for what would turn out to be a great fight.

In a masterful performance Monroe won handily over Hagler. He had Hagler bleeding from the nose in the second round and the bleeding continued throughout the fight hampering Hagler's breathing. Hagler's eyes were swollen as well by the end of the fight. The judges awarded the decision to Monroe by scores of 48-42, 47-44, and 49-41. It was a decisive win for Monroe and the only time in Hagler's career when he would clearly lose a fight. The only other losses on his record were the robbery to Watts and the highly disputed decision loss to Ray Leonard. Willie Monroe is the only fighter to have truly beaten Marvin Hagler, and that is something that can never be taken away from him.

Hagler was back in action three months later when he defeated Bob Smith in Taunton. He then beat George Davis before return again to Philadelphia. His third fight there proved to be the charm when he dominated the hard punching Cyclone Hart forcing Hart to quit after the 8<sup>th</sup> round. Hagler finally had a win over a tough Philly fighter.

Monroe had also remained active after his win over Hagler. He scored three wins and had one loss, being stopped by David Love, in the months

leading un to a rematch with Hagler. This time the fight would take place in Boston. Monroe was confident he could repeat his victory over Hagler. After all, It was only 11 months earlier when he had given him a boxing lesson.

The fight, held at the Hynes Auditorium on February 15, 1977 turned out to be a classic. It was much closer than the first as Hagler fought aggressively and stayed close to Monroe who was moving and using beautiful left hooks to counter Hagler's right

jab (Hagler fought out of a southpaw stand for the entire fight.) I remember seeing Monroe rock Hagler with a left hook that had his eyes rolling. It is the only time I ever saw him even close to being hurt, but he recovered quickly.

Going into the 12<sup>th</sup> and final round the fight was very close. It was here that Hagler showed how much he had learned since their first fight. Not wanting to take any chances, Hagler really cranked up the pressure. Less then a minute into

the round he landed a right and then a solid left on Monroe's chin dropping him. Monroe staggered to his feet and the action continued. Hagler was all over him battering Monroe along the ropes when referee Tommy Rawson stepped in and stopped the fight. It was the most exciting match I have ever witnessed in person. Monroe fought brilliantly but Hagler showed he was made of championship material that night.

The two would meet again in Philadelphia in August of that year, and Hagler would stop Monroe in the second round. Monroe would continue on with his career for a couple more years but had more losses than wins and he decided to retire in 1981. Hagler would go on to win the title and go down as one of the greatest fighters of all time. Hagler's final record was 62-3-2, but it really should have been 64-1-2, with that one loss being to Willie Monroe.

Monroe was also involved in another historic boxing event and very well may have changed history had he been heard. He was with the Frazier camp in Manilla for the third Ali fight. At the end of the 14<sup>th</sup> round Eddie Futch decided not to allow Frazier to come out for the last round because Frazier was unable to see. Willie Monroe was stationed over by Ali's corner where he heard the champ tell Angelo Dundee he could not come out for the last round. Monroe was frantically yelling over to Futch that Ali was going to quit, but Futch did not hear him and waved to the referee that he was ending the fight.

When Ali heard the fight was over and he had been declared the victor, he stood up and then collapsed. What if Monroe had been heard and Futch allowed Frazier to stand up at the bell? Would Ali have remained on his stool? Most likely, Dundee would have pushed him out to continue fighting, but maybe Ali really was all done. We'll never know, but Monroe was convinced Ali was not going to answer the bell.

I got to meet Willie Monroe while he was in Boston training for the Hagler fight. He was up here with his trainers Eddie Futch and George Benton. I remember him as a very nice guy who was low key and modest. He was also one heck of a boxer who just couldn't quite make it to the top. He did have his moment of greatness on March 9, 1976 when he beat an all time great and did it magnificently.

#### HOOPS and HOCKEY in the HUB

He picked up that big heavy hockey bag, the one that contains the implements of his profession—his tools of the trade, if you will — and walked toward an exit.

Perhaps it would be for the last time in the Hub or perhaps it would be for just an interval — until the team regroups in the fall.

That was the last time we saw David Backes, as he moved away from the Bruins locker room at Warrior Arena, the B's practice facility in Brighton.

As with everyone associated with the team, it was a downcast time, a season where the Black and Gold had come so very close to realizing the ultimate goal — winning the Stanley Cup.

But, there were also additional dimensions for the veteran forward. At age 35, it would have been an achievement of a lifetime, in a sport where playing careers often don't last for an extended period of time.

However, the handwriting had been placed on the wall, so to speak. Of the 24 postseason games the Bruins played in their Stanley Cup playoff run, Backes had not played in nine of them, including the last three games of the Stanley Cup Final series against the St. Louis Blues.

So, there he was at his final meeting with the media for the 2018-2019 season, looking backward a bit, looking forward to a certain extent, but essentially staying in neutral in this interval before his future in hockey on Causeway Street is sorted out.

"I'm not naïve," stated Backes.
"If you've got a chance to win the
Stanley Cup you put your best
lineup out there and try to win
the game. I wasn't one of those
guys."

Thus, Backes said, when the end came it was different for him. "I didn't experience the loss first hand. I can't say I should have done more in Game 7. Those are the things I can't control."

There will be discussions, of course with management. His future with the B's remains uncertain. But one thing is certain. Backes would like to return.

"I hope I'm not going somewhere else," said Backes, who played 10 seasons for the St. Louis Blues before coming to the Hub. "This is a great group of guys here and a great group of wives. There's a reason we got so far in the playoffs. We care about each other, we lean on each other and you want to do it for the guy next to you."

He also believes that Boston offers him his best shot at winning the Cup before he retires. "I believe there's a winning pedigree and winning culture here. We were only one game away from winning the Stanley Cup — one of the goals on my list before my career is over. I think this is a good place to accomplish that."

The recent loss in the Stanley Cup Final was the closest Backes

has come in his NHL career to reaching hockey's summit. It was also the most recent in a series of disappointments since he had also come close in the Olympics.

As a member of Team USA in both the 2010 and 2014 Winter Games, he also experienced setbacks. In 2010, the U.S. team was defeated by Canada 3-2 in the gold medal game in Vancouver, while in 2014 the U.S. lost 4-2 to Sweden in the bronze medal game in Sochi, Russia.

And yet, Backes was also a central figure in one of the more significant moments in the history of the Bruins. It was on November 22, 2016, that the Bruins reached the 20,000th goal mark in their storied history, a scoring path that had begun over nine decades earlier when the B's recorded their first tally back on December 1, 1924, in a 2-1 victory over the Montreal Maroons.

Fast forward to contemporary times and it was Backes, skating on a power play, who scored the 20,000th goal in Bruins history, against (you can't make this up) his former team, the St. Louis Blues.

The score came at the Garden, but victory that day did not as the Blues left town with a 4-2 win.

Unfortunately, things have not gone as well as they might have for Backes since he joined the Bruins. During the 2017-2018 season, he was diagnosed with a diverticulitis infection, resulting in surgery followed by a considerable rehabilitation period. That, plus an injury later in the season, meant that he played in only 57 games that year.

The 2018-2019 season just concluded was his lowest point production on the ice since he joined the NHL in the 2006-2007 campaign as he finished with seven goals and 13 assists for a total of 20 points across 70 games played. He went 2-3-5 in 15 playoff games.

So, as the summer season of wheeling and dealing commences in front offices across the NHL, it will be interesting to see what the future has in store for Backes.

He remains under contract through June, 2021, having signed a five-year, \$30 million deal with the B's on July 1, 2016 as a free agent. But he could be traded or bought out.

An indication of just how much that level of income means came this past December when Backes was assessed a penalty for a hit to the head of New Jersey forward Blake Coleman.

The league suspended Backes for three games and ordered him to forfeit his salary for the three contests — an amount just under \$220,000.

That level of compensation may make a trade more challenging. The positive is that if he remains, he is another veteran presence both on the ice and in the locker room. How it will work out only time will tell.
