THE ROOTS OF YOUR SALAMI

Destructive forces of nature usually include earthquakes, volcanoes, storms, floods, etc. It might seem strange for some of us to discover that these destructive forces often leave benefits for mankind and that these benefits accrue and become obvious in strange ways. In order to get to the roots of your salami we must go back to an earlier issue when I wrote that there was a time when Rome and its suburbs were covered with the quiet blue waters of the Tyrrhenian Sea. It all started when nature combined its forces in a series of volcanic eruptions which formed a cosmic spectacle, so long ago, that no human eye could have possibly seen

One of these eruptions formed the stony "tufa," a rock substance without which, many of those Roman walls, sewers, temples, and even the catacombs could not have been constructed. Another eruption left the "Pozzolana," an ingredient

structive agencies of time and weather, better than much of the stone. Still another volcano left that indestructible granite which enabled them to make those Roman paving stones that have no equal anywhere else in the world. The volcanic eruption that is of most concern at this particular time is the one which caused hot ashes and debris to completely bury a growing forest like a giant coal bin, while at the same time shaping the Palatine Hill. In time, this buried forest was converted into a gigantic charcoal reservoir. Nature was kind in providing the fuel for those hundreds of thousands of braziers which provided the necessary heat for warmth and cooking during later eras.

For hundreds of years during the growth of development of ancient Rome, her tenament houses had none of the simple conveniences of today; no lighting, no heating system, no sinks, which enabled the Roman toilets or bathrooms as we

concrete to resist the de- know them. The use of the braziers added the risk of noxious fumes and were serious fire hazards. People often spoke of the good fortune of the homeless beggars who had nothing to fear from charcoal fumes or burning houses.

> These early Romans were a frugal people, the poorest classes subsisted on a basic diet of coarse bread, a porridge made from millet or polenta meal, and their usual drink was water. The high fire risk and the lack of refrigeration kept cooking methods down to a primitive minimum and caused even the great middle-class to concentrate on low spoilage foods. Figs, cheese, olives, and dried foods were popular but the greatest demand was for the salt preserved foods. This demand soon caused the production of a kind of salami and prosciutto ... that's the truth ... so help me! The only thing I don't know is the price per pound at that time.

Independence Day 2012

addressing the English House of Commons, March 22, 1775.

At ten o'clock on the morning of Wednesday, July 4th, the Declaration of Independence will be read out to the assembled people from the balcony of the Old State House just as it first was in Boston on July 18, 1776.

The document is tripartite. The preamble contains a general justification of self-government. It ends with the formal declaration of severance of ties to Great Britain and the establishment of a new sovereign entity, the United States of America. Between these lies an enumeration of the outrages of King George III which justify this revolutionary act.

They are - or ought to be - familiar to us. They would have sounded familiar to hearers in 1776 as well, for the Americans' bill of indictment of King George echoes in many ways the 1689 English Bill of Rights - an indictment of King James II after he abdicated the throne. The English Bill of Rights declared that the king had subverted the laws and liberties of his kingdom:

- By assuming and exercising a power of dispensing with and suspending of laws and the execution of laws without consent of Parliament;
- By committing and prosecuting divers worthy prelates for humbly petitioning to be excused from concurring to the said assumed power;
- By levying money for and to the use of the Crown by pretence of prerogative for other time and in other manner than the same was granted by Parliament;
- By raising and keeping a standing army within this kingdom in time of peace without consent of Parliament, and quartering soldiers contrary to law;
- By causing several good subjects being Protestants to be disarmed at the same time when papists were both armed and employed contrary to law;
- By violating the freedom of election of members to serve in Parliament;
- By prosecutions in the Court of King's Bench for matters and causes cognizable only in Parliament, and by divers other arbitrary and illegal courses;

The American patriots quoted with slight modifications many of those phrases. And they improved on the English precedent by dropping the anti-Catholic language which to this day mars the British constitution.

CELEBRATING 100 YEARS OF MASS. MENTAL HEALTH CENTER IN BOSTON

The Massachusetts Mental Health Center was the very first community mental health center in America when it opened its door on June 24, 1912. Most folks remember 1912 for two reasons, the sinking of the Titanic and the opening of Fenway Park but it also opened up modern psychiatry to people living in their own communities. It was a major first step from the old state hospital mode that locked up people often in places worse than Dante's Inferno. Mass. Mental as a brand name began in 1956 when it replaced its old Boston Psychopathic Hospital nick-named "the Psycho" with a much more benignsounding name.

I began my now almost 40 year career for the State Department of Mental Health in June 1972. I was there to celebrate the 75th anniversary back in June 1987 and can't believe how the last

quarter century went by so quickly. All toll I was directly employed by Mass. Mental for most of my career and for one-third of the life of this institution located once again at 74 Fenwood Road. I was the last employee on the books at the old Fenwood Road site when it closed on that morning in November of 2003. Last year, the institution returned to the Fenwood Road area with two new modern buildings and hopes to be around serving folks through both research, training and direct care for the next 100 years.

To celebrate the 100^{th} anniversary a gala dinner was held on June 23 at the Kennedy Library and Museum in Dorchester. Close to 200 folks showed up to both remember the past and celebrate the future. It was like a homecoming and reunion all rolled up into one. As one person said, we all looked

the same but only different. Our youthful faces changed into more experienced ones. Age is just a number for both the history of this mental health center and the people who work(ed) in it.

Massachusetts Health Center was never just a building with walls but a place that nurtured life and the ability to live it. I have seen so many clients walk out of that place much better than when they entered it which is the true hallmark of success. The place has worked for over 100 years now because of the people who worked or still work there and the care folks in need receive there. The two new buildings that replaced the old one look great but what is always greater is what transpires inside the place. The kind of treatment that saved many lost souls over the past century.

The true mark of a place is its reputation and Mass. Mental Health Center's reputation is second to none since its founding in June of 1912.



Summer Heat Precautions

As summer is upon us and temperatures rise, Mayor Thomas M. Menino reminds residents to stay safe and healthy during the hot summer weather. Mayor Menino and the Boston Public Health Commission are urging residents to stay hydrated and in shaded or air conditioned areas whenever possible. Residents can cool off at several Boston Parks Department water spray featured throughout the city, beaches and pools or in air conditioned community centers.

"Summer has arrived, and as we prepare for heat waves there are a few important things to keep in mind," Mayor Menino said. "In these conditions we must remember to stay cool and hydrated and keep an eye on our vulnerable neighbors."

Children and the elderly are particularly susceptible to heat-related illnesses and injuries, but everyone should remember to limit their activities during very hot weather, drink plenty of fluids and avoid beverages that contain caffeine or alcohol. When outdoors, limit strenuous activity, wear sunscreen and loose, light-colored clothing and rest often in cool, shady areas. Additional measures to beat the heat include avoiding cooking, taking cool showers or baths and staying in air conditioned areas whenever possible.

"Summer is a time of year we all look forward to in Boston, and we can make sure everyone has fun and stays healthy by following a few easy tips," said Dr. Huy Nguyen, Medical Director for the Boston Public Health Commission. "Make sure to drink plenty of water and find a cool, shady spot to rest if you find yourself getting too hot."

Heat related illness such as heat exhaustion and heat stroke can be fatal if untreated and needs to be taken seriously, particularly for elderly and younger populations. Residents should follow heat safety precautions and pay attention to the warning signs such as nausea, dizziness and headaches. If symptoms persist, call 9-1-1 immediately. Family, friends and neighbors are also urged to check in frequently with elderly residents who may need assistance during the hot weather.

Freddie has been out of office since January 1984 but hardly retired from public life. He remained the street smart pol he always was. Many called him the, "Mayor of the North End." Even out of office he remained a voice for working families and the elderly. For many years he had been one of the most prolific writers for the Post-Gazette. As much as I thought I wrote, he out wrote me too.

Freddie and I weren't just writers of the Post-Gazette. We were friends just as he and my father were friends going back to their younger days. He always reminded me of my father and I also reminded him of my father.

Freddie was a man of action who once said, "People want action. They don't want gray flannel politicians with white papers and surveys.'

Freddie may be gone but he will live on in the collective memories of the North End he so loved. I will never forget him. He was like family to me.

Simple TIMES...

"Women's libbers, that's all they are," shouted four foul mouth guys at a front yard meet-up as I pedaled my hometown's morning newspaper in upstate New York on a sultry late-June in 1972.

That disparaging antiwomen's movement slur I still vividly recall four decades later because I've four sisters - the two oldest came of age during the mid to late 1960s — while the two younger entered teen angst in the early '70s.

As I arrived home in time for breakfast before heading off to school, I told my mom that so-and-so spoke ill of a new federal law that favored equal rights for females. She responded: "Their ignorance only shows their true colors."

President Richard M. Nixon signed Title IX into law on June 23, 1972. Title IX took an act by the United States Congress before heading to Nixon's desk for his historic signature that disallowed discrimination of women and girls to participate in any public program - such as sports and academics — and funded by the federal government.

While the emphasis of Title IX was education and employment, athletics peculiarly took center stage. Senator Birch Bayh of Indiana brought Title IX to Congress. Bayh also was the law's principal advocate in the Senate. As he rose in the Senate well to seek support for passage of Title IX, he bellowed: "We are all familiar with the stereotype of women as pretty things who go to college to find a husband and finally marry, have children and never work again. But the facts absolutely contradict these myths about the 'weaker sex' and it is time to change our operating assumptions."

I began reading Sports Illustrated at age nine and sifted through books about football, baseball, hockey and basketball to see my heroes in colorful action. Covers of Sports Illustrated graced the walls of my bedroom. Conspicuously missing were women athletes at the college level and never on the professional stage as Sports Illustrated and its chief monthly sports magazine competitor during those days Sport hadn't covered women's or girls' athletics. But all that changed with the birth of Title IX.

I loved playing certain sports and thoroughly enjoy watching most sports. The Olympics is (and, was, in 1972) my most thrilling sports event to watch with its numerous athletic competitions that always surprise and never bore.

My first active rooting for women's sports on TV was for figure skater Dorothy Hamilton, who dazzled the world at the 1976 Winter Olympics in Innsbruck, Austria, capturing gold for the USA with her agile triple axles and effortless spinning atop the ice.

And, of course, my twin and I supported and attended with our friends our youngest sister's softball gal pals as they routed every girl's team in our hometown during the summer of 1974. We boys and girls played softball together. Competition proved

as fierce as any boys' baseball game. Despite the end results we stayed solid friends. After all, sports brought us together and heightened various interests as we moved along our unique life's paths.

Playing Wiffle ball, badminton, volley ball, kick ball, hockey and tag football alongside girls came naturally as my parents and aunts and uncles ensured that all us cousins' play together and "get along." They hailed from America's Greatest Generation, whereby the social mores and separation of the sexes was en vogue. Yet their innate wisdom nurtured a respect in us for others no matter their sex or social class. Our fondest and most fun family memories remain the summers of our youth gathering and competing endlessly!

Nowadays, I live and die with every shot by the Lady Irish of Notre Dame University sports lore as passionately as I do with the Fighting Irish men's basketball team. And I'm glued to the TV every spring as the College Women's World Series takes center stage alongside the College Men's Baseball World Series.

Through the years, I've chosen my favorite women's professional tennis stars — American and foreign since catching the tennis bug watching a five-set thriller at the U.S. Open in 1976. I was 16.

Title IX originated as the rite of teenage adolescence hit me in 1972. And the law's results have enriched the lives of generations of folks ever since. Exciting stuff that rightly lifted the athletic abilities of girls and women yearning to showcase their passion for sport and equally competitive spirits.

Wimbledon is in full swing today. America's Serena Williams will grunt and grind for her 15th Grand Slam and fifth Wimbledon title. I'll be on the edge of my seat rooting her onward and upward!

For some reason, my father never wore shorts in the summer. When he went to the beach, he took off his shirt and rolled up his pants to get some sun. I never asked why he never wore shorts. It was just the way it

Saint Maria Goretti

Maria Goretti was born on a small farm near Ancona, Italy on October 16, 1890; her parents were Luigi Goretti and Assunta Carlini. Maria was the third of six mother as being a happy good child, openhearted with a sense of seri-

children; she was described by her ousness far beyond her years. Maria's family fell on hard times and lost their farm, her father then became

a farm laborer. When she was nine the family moved to Ferriere di Conca near Anzio where shortly after, her father, died of malaria leaving Maria's mother struggling to feed her children.

Maria's family moved into a house that they shared with the Serenelli Family. Maria, who was 12, attracted the attention of the Serenelli son, Alessandro who was 18. Alessandro made several advances toward the child that she rebuffed, but did not report, for he threatened to kill her if she told of his actions. It was at 3:00 pm on July 5, 1902, while Maria was taking care of her infant sister, that Allesandro once again approached her, she refused him, crying out repeatedly, "No, it's a sin, God does not want this!" Enraged Alessandro stabbed the girl fourteen times, Maria was discovered by her mother, still alive, She was rushed to the nearest hospital where she underwent surgery without anesthesia,



she passed away of her injuries the following day, twenty hours after the attack, having forgiven her attacker and expressing that she would pray for his repentance and that she would like to see him in heaven. Maria died of her injuries clutching a cross to her chest.

Alessandro was captured and imprisoned for 30 years. While in

prison, he remained unrepentant of his crime, until, in a dream, Maria Goretti appeared to him in a garden and gave him lilies; he experienced a complete change of heart and was released for good behavior after serving 27 years.

After his release, Alessandro visited Maria's mother, Assunta and begged her forgiveness. She forgave him, saying that if Maria had forgiven him on her deathbed then she could not do less and they attended Mass together the next day, receiving Holy Communion side by side. It is said that Alessandro prayed every day to Maria Goretti and referred to her as "my little saint." He attended her canonization by Pope Pius XII which took place on July 25, 1950.

Serenelli later became a Capuchin laybrother, living in a monastery and working as a gardener until death peacefully in

Saint Maria Goretti's Feast Day is July 6. She is the patroness of youth.



Individual citizens are doing remarkable things for them all across this country. There are hundreds of groups sending care packages and raising money for military families here at home.

But most major retail stores and manufacturers are doing nothing and need to start doing a great deal. After all, their prosperity is a direct result of the domestic tranquility secured by the troops.

Retailers and manufacturers can do a great deal, because they are in a unique structural position to aggregate major financial support, given the volume of people daily coming through their doors to shop. Gosh knows they wrap themselves in every other cause to make a sale and look like they are doing well.

For the Fourth of July retailers in America ought to be doing more than just decking themselves out in American colors to make a few extra bucks — wrapping themselves in the flag so to speak.

For the Fourth of July every retailer, large corporation, and manufacturer across America ought to be prodigiously using the holiday to raise as much money and product as they can for the many troop support charities which do good things for America's troops and their families.

Yet as it stands, most military charities and troop support groups can tell you retailers do little or nothing.

Therefore, to fulfill the first step of properly celebrating the Fourth of July, each good American doing business with any retailer during the Fourth of July holiday, should look around and see if the store is engaged in any type of commercial co-venture or fundraiser collecting donations for the troops. Are there \$1 donation slips at the cash register? Are there products donating a percentage? If not, politely ask for the manager and ask why not, given that the Fourth of July is about the troops who are protecting their business prosperity and independence. Tell them that you had expected there would be, just like for all the other causes.

So this Fourth of July take a quiet oath to begin standing up for those who are standing up for you. They're risking life and limb. You're risking a polite discussion. On balance it's not really large grocery store chain in much of a risk as it? The

simple asking of a question. The simple exercise of the freedom of expression they are said to protect. The troops and their families at home have tremendous needs. And you can enter into a quiet moral covenant with them to simply politely ask the manager of each grocery store and department store in which you shop, "are you doing something this holiday season to raise money for the troops and their families?"

The second step to properly celebrating the Fourth of July is to keep this house in order if we're asking them to protect it.

It is really quite simple. If we are going to ask our neighbors to deploy as troops and risk themselves to protect us, then we ought to keep the place in order.

This place is a mess. It's as though they are being asked to protect a stricken party ship. And while they are nobly doing so they are likely wondering if we are going to let it sink or going to get it in proper order and back underway.

Each person, and each business, has an absolute fundamental moral obligation to do their part in keeping our national house in order in exchange for what we ask the troops to do for us every day. It is the troops, not the politicians or courts, that secure and protect our way of life, at far greater risk.

Therefore, in respect of what George Washington and his troops did for us under great duress many years ago, and in respect for what the troops do for us around the globe today, let's each celebrate the 4th of July this year by undertaking to do our part in getting get our national house in proper order and reinvigorating our National Family which we have asked them to protect. They do not protect it so that we can squander it.

Let's get focused again and make ourselves more worthy of the burden we ask our neighbors bear for us. Let's start behaving like real men and real women. Who can make serious decisions and do serious things. Let's show them we are worthy. Let's take the domestic freedom they preserve for us and something yet grander of this National American Family.

America is unique in the world. Nothing else is organized like it. Nothing else has its history of setting people free within and without. Nothing else produces and projects such goodness. Cherished, nourished, protected and properly operated, all things are possible for her citizens and for the world. Other countries are drawn to her example, improving the world and us. If her goodness is polished to shine like silver, America cannot help but enjoy a bright and happy future.

So have a great Independence Day, go have some fun and may God bless our amazing troops and their families who have made it possible!

FINDING AN ANIMAL LAW ATTORNEY

Well, consider this scenario: You're in the park with your dog. Perhaps on this particular day he's more rambunctious than usual, tugging at his leash and trying to socialize a bit too aggressively with a passerby. When someone tries to pet him, he reacts defensively and bites him/her and it's more than a little nip. The injured party sues you for significant damages, medical expenses and pain and suffering. Whom do you turn to for help?

The circumstances in which you may need legal advice and representation in connection with your pet are not limited to dog bite cases. Pet custody issues in divorces, landlord-tenant dis-

putes involving pets and veterinary malpractice are examples of other situations in which sound legal advice and representation are crucial. But just how do you go about finding an attorney knowledgeable in the rapidly expanding and ever more complex area of animal law?

Fortunately, finding a lawyer with the expertise you need is a manageable task provided you know where to look. A good place to start is the web site of the Animal Legal Defense Fund (ALDF). Although the ALDF does not itself provide a lawyer referral service, it is an excellent source of information about a broad range of legal issues pertaining to pets and contains many links with practical, up to date information. The more informed you are about the legal issues involved in your particular situation, the better able you will be to evaluate the qualifications of attorneys to

whom you may be referred.

Two organizations that do provide lawyer referral services are: the American Bar Association (ABA) and the legal publisher Martindale-Hubbell, which maintains the lawyers.com web site where you will find a list of animal law attorneys listed by state and city. Once you have done some research and located a qualified attorney don't hesitate to ask some pointed questions: Have you handled these sorts of cases before? How much is this going to cost? Keep in mind too, the important but often overlooked element of "chemistry" the lawyer-client relationship is a special kind of relationship. It has to feel right, so in short: Do your research, ask questions and trust your instincts.



Few artists can put us on a musical roller coaster of emotion, like country singer Alan Jackson can. His new album 'Thirty Miles West' is a 'baker's dozen' of mostly heartwrenching tracks. The initial cut "Gonna Come Back as a Country Song" sets the pace, plus the suggestive "You Go Your Way," the mellow, angelic "Everything But the Wings," the repetitive "Talk Is Cheap" and his current single, climbing the charts nicely, "So You Don't Have to Love Me Anymore" is Jackson at his finest. The Jackson-penned, incriminating tune shines with "Look Her In the Eye and Lie" followed by a Zac Brown collaboration, the lengthy "Dixie Highway," plus the downer "She Don't Get High," finding a cure via "Her Life's a Song," and the romantic "Nothin' Fancy." Alan stirs his romantic woes in a glass on "Long Way To Go," the surprisingly energetic "Life Keeps Bringin' Me Down" and the closing track is a heartfelt song he wrote about his wife of 30 years, Denise, when they learned she had cancer. Titled "When I Saw You Leaving," it reminds us how fragile life really is. Outstanding album!

CAROL SABOYA - BELEZAS/AAM Music

'Belezas' is the music of Brazilian composers Ivan Lins and Milton Nascimento, resulting in great harmonies and beautiful melodies. Sabova is a well-known recording artist in her native Brazil and in Japan. Singing in both Portuguese and English, Carol starts out her dozen delights with, "Bola de Meia, Bola de Gude" (Sock Ball and Marbles), the Brazilian pop ballad "Who Is In Love Here," the political statement "Abre Alas," the song "Tristesse" features tight harmonies with the legendary Dave Liebman's sax solo. "Beauty and Song" contains a bass and percussion groove that is to die for, the silky "Anima" glows nicely with a lovely, simple melody, the brilliant Brenda Russell lyrics make "Soberana Rosa" sparkle like the sun and "Doce Presenca" has Saboya singing in English and the bridge in Portuguese. Another Liebman sax solo illuminates "Tarde," a wonderful ballad, trailed by the energetic "Tres Pontas" done in true Brazilian spirit, a song that translates as "Hoisted Sails," takes the wind and soars like life, with Carol finishing off her masterpiece with "Estrela Guia" (Oh, Shining Star), a tribute by composer Ivan Lins to Milton Nascimento. This solo debut by Saboya will surely win her fans in the U.S. and round the world!

SALMON STEAKS - Broiled or Grilled

- 4 salmon steaks 2 medium onions ½ cup olive, canola or
- vegetable oil
- 2 tablespoons mayonnaise
- 1/4 cup lemon juice
- 1 teaspoon cider vinegar (optional)
- 2 tablespoons of butter or margarine

SALMON STEAK: Spread some oil or mayonnaise on the bottom of a broiling pan. Then spread a little oil or mayonnaise over the top and bottom of each salmon steak before placing in the broiling pan. Place in preheated oven about two inches from broiling unit. Turn steaks to broil on both sides slowly. Steaks will turn whitish in color when they are cooked. Depending on size, broiling time will be about fifteen to twenty minutes. Then set broiling pan with steaks aside.

ONIONS: Remove outer skin from onions. Cut onions in half, lengthwise, and then into $\frac{1}{4}$ -inch slices lengthwise. Set aside in a bowl.


Heat oil in a skillet. Add butter or margarine and onion slices to the skillet. Stir and simmer until onions are about to brown *slightly*. Remove from burner and add lemon juice. Add vinegar (optional). Stir and return to burner. Simmer slowly a few seconds. Remove from burner.

Spoon onions and liquids from skillet over each salmon steak in the broiling pan. Cover with aluminum foil and return to heated broiler for about a minute. To slightly brown tops, remove cover and broil for a few seconds longer.

Serve each steak topped with onions and liquids from broiling pan. Serve with rice pilaf and vegetable or salad of choice. Serves four.

NOTE: My mother-in-law, Mary Sinopoli, told me often about how she loved to grill her fish or beefsteaks over the hot coals of her Glenwood kitchen stove. From her I learned to try salmon steaks grilled during the summer over our gas-burning grill. I spread a little oil over each steak before grilling both sides of the salmon.

I use my mother's old heavy aluminum skillet over our grill to prepare my onions, oil, and butter and lemon juice mixture. We do experience a different flavor by preparing this recipe in this manner. Either way, this is an enjoyable and easy meal to prepare.



DID YOU KNOW THAT ...?

Let's have a toast: Italy has reached the top spot in the world as the largest wine producer among the worldwide wine producers, pushing France to second place for the year 2011. The data recently made public by the European Commissions show that Italy produced 49.6 (hectoliters) of wine while the second-place France produced 46.9 (hectoliters). The European Commission gathered wineproduction data from around the world and determined that Italy was first. The European Commission noted that wine production has dropped not only in France (-1%), but also in Romania (-51%), in Hungary (-39%), in the Czech Republic (-36%), in Austria (-35%) and in Germany (-25%).

Italy's wine export has certainly increased, particularly to the United States (+31%), to European Countries (+6%), and to China (+146%). Of course, the value of the wine exported abroad has increased too, about 3.9 billion euro (@ 5.5 billion). Foreign consumers choose Italian wine because of quality, price and also, because it appears to be fashionable, more so than French wine.

The lower production in other countries was caused by adverse climatic conditions which, in some cases, even left some vineyards destroyed. According to available data the entire European production of wine has overall dropped by 3.7%.

Former Minnesota Twins pitcher Dave Boswell passed away he was 67. Back in 1969, Boswell won 20 games helping to lead the Twins to the AL Division Championship. That year, he went 20-12 with a 190 strikeouts. He broke in with the Twins during 1964 and pitched against the L.A. Dodgers in the 1965 World Series at only 20 years of age. Over his career, he went 68-56 for eight seasons, seven with the Twins and his last season split between the Tigers and Orioles.

The highlight of his career was off field at a bar in Detroit after the Twins had played the Tigers that afternoon. Boswell got into a discussion with his pitching coach Art Fowler, and then Manager Billy Martin stepped in apparently siding with his

World Middleweight Champ Julio Cesar **Chavez, Jr.** 46-0-1-1, 32 KO's, does it again. He defended his WBC World Middleweight title in front of 13,467 fans, at the Sun Bowl Stadium in El Paso. He won this fight in stylish fashion over top fighter, the 28-2, 20 KO Andy Lee, who represented Ireland in the 2004 Olympics. Chavez got stronger as the fight progressed. Referee Lawrence Cole stopped this fight at 2:21 of the seventh, due to the consistent Seek and **Destroy** tactics of Julio Cesar Chavez, Jr. Andy Lee was putting up a winning fight. At the time of stoppage, all three judges had Andy Lee ahead 58-56, on all three scorecards. In the Post fight press conference World Champion Julio Cesar Chavez, Jr., called out **Sergio Martinez**, for a possible September 15, 2012 Fight Date.

On June 22, 2012 I read here on Fightnews.com, "Valcarcel: WBO is sure Pacquiao won the fight." June 17, 2012 Manny Pacquiao vs. Timothy Bradley Results Raise Ire of Boxing Fans, Talk of Foul Play. Manny Pacquiao landed 253 of 751 punches and Timothy Bradley landed 159 of 839. Power Punch statistics recorded 190 for Manny Pacquiao to 108 for Timothy Bradley. CompuBox statistics prove Pacquiao also connected on more punches in 10 of 12 rounds. This was a Professional Fight. Wasn't it? The Associated Press had Pacquiao winning 117-111. Again with the Manny Pacquiao, Timothy Bradley Fight. Listen to the results. Judges for this fight voted Bradley 115-113 by Duane Ford and Timothy Bradley 115-113 by C.J. Ross. Judge Jerry **Roth** scored the fight **115-113** in favor of Pacquiao. The 14,206 Fight-fans
