#### Millennials Catch Up with Baby Boomers

A new analysis of census data shows that millennials are now tied with baby boomers for the largest share of eligible voters. The Pew Research Center says boomers hold a very slight edge, but each group comprises about 31 percent of the electorate. But Pew also shows that only 46 percent of millennials actually vote, while 69 percent of boomers vote.

#### **CARCER**

In Latin, "carcer" means prison, jail, or prisoner and is the origin of the English word incarceration. "Capitalis" relates to laws affecting a man's life or civil status. Capital punishment can be simply defined as the death penalty. History is history, facts are facts, and we shouldn't be led to believe that all was peaches and cream during "those good old days." Evidence of man's inhumanity to man probably goes back to the very beginning of time. One early account tells of "Tullus Hostilius," the third of the legendary kings of Rome who seized the Alban leader, Mettius, had him stretched between two four-horse chariots, and torn apart as the horses were driven in opposite directions. Such is the brutality that was commonplace among those ancients.

The oldest prison in Rome is said to be the one called "Mamertine," which in time became two dungeons, one above the other. The upper one is the original Mamertine, and was named after its builder, Ancus Marcius. He was the fourth of the legendary kings, supposedly a son of Mars, who was also called Mamercus. The lower dungeon was constructed by the Etruscan king, Servius Tullius, from whom the name "Tullianum" is derived. These are said to be the oldest prisons in the world and are seen in modern times in their original severe nakedness. They are underground, about sixteen feet by twenty feet in size, with stone walls and a

also of stone. The only means of entrance was through a hole in the roof.

Prisoners were tightly bound and lowered by ropes. Executioners descended by ladders, either to chain the prisoners to the walls, or to execute them in the lower chamber — the Tullianum. Church legend tells us that St. Peter and St. Paul were imprisoned here during the time of Nero, and that a spring miraculously started to flow in order that St. Peter might baptize the other prisoners.

"Cruciatus" or "cruciare" are the Latin expressions for torture, torment, or to put to the rack. "Crux" refers to the cross as an instrument of capital punishment during ancient times in eastern countries. Darius, an early king of Persia, boasted that he had crucified the leader of every rebellious group that opposed him. Persons who had been executed by other means were sometimes placed on a cross after death as an indication of dishonor from the deed which caused their demise. Tarquinius Priscus, the first Etruscan King of Rome, resorted to this kind of disgraceful display of deceased bodies in an attempt to stop the suicides of those persons who were driven to despair in forced labor camps. It is said that execution by crucifixion was very common with the Carthaginians who were noted for the cruelty of their methods, and through them it was introduced into Rome.

### Save Hanover Street

When is it all going to stop? Think of all the issues we have in the North End that need attention, and there are a chosen few that think **CLOSING DOWN HANOVER STREET** is the hottest??? Really?? Will that address any of problems that RESIDENTS have been asking to be addressed for years??

Cross-walks need to be repainted, cars DO NOT STOP. We have children and elderly in the North End that walk these streets while cars continue not to STOP, and race by without any consideration that they are in a residential area.

Traffic lights on Cross and Hanover Street: one sign says WALK and the light turns green at the same time. It has been reported time and time again. PLEASE do something about this corner! We have thousands of tourists that walk that area as well as the residents. It's a serious safety issue for every-

Trash containers are constantly filled and the trash is everywhere. We never have enough trash containers for dog owners and we wonder why the dog trash bags are all over the area?

What about the paper cups, spoons, napkins and wrappers that are thrown on the streets? Do any of the shops have containers near their place of business to dispose of this trash? We have no control over our trash as it is, can the business owners at least take some responsibility? They are the ones benefitting, not the residents. But we have to live with the mess their businesses cause. If the city won't step up, why can't they?

Traffic and valet parking--cars doubled parked to let customers out, blocking half of Hanover and other streets. The spaces in front of restaurants are supposed to be used for dropping customers off so they can pull off the street and not block traffic. They are not for valets to park vehicles in. This is the law. Why is it being not enforced? And where are these cars being parked? I hope not in residential spots if parking lots are filled.

Speaking of our streets, we also need more lighting or new lights on Prince Street and many other residential side

These are problems that cause confusion, consternation and inconvenience at best, unsafe conditions for residents and visitors alike at worst. Why can't the City of Boston work on these problems and at least alleviate them?

And how does closing down Hanover Street address any of these problems? Who benefits? NOT THE RESIDENTS, that's for sure. Driving around here is difficult enough, with traffic and one-way streets everywhere, not to mention waiting for people to parallel park on narrow streets in tight spots. I don't know if Italy has rodents, but we do and plenty of them. So let's make it easier for Mickey and his extended family. They don't have to go inside anymore; they can be just as happy sitting under the table waiting for the food to drop. Please, let's not make our rodent problem any worse than it already is!

I have lived here all my life. We never, ever had a rodent problem before the explosion of restaurants in our neighborhood. We have so many restaurants, they have taken over our streets. Again, closing Hanover Street is <u>not</u> for the residents. It is just another attack on our quality of life.



# L'Anno Bello: A Year in Italian Folklore

An Italian June

Ah, June! No other month brings as much joy to the heart of this schoolteacher. June is inextricably linked to summer in my mind. It means eightyplus degree days when I open every window, trying to catch a pleasant ruffle of a breeze. It is days spent walking by the seashore, inhaling the salty scent of the ocean and listening to the plaintive cries of the gulls. June means days of ice cream dripping down cones and strolls in the late-evening sunshine. Finally, June means the last school bell of the year, opening up a summer full of possibility and hope. Yes, I truly love June, and so did my ancestors over in Italy. For June in Italy boasts a number of holidays that revel in the summery nature and outdoorsy aspects of the month. In truth, June can be an overwhelming time to visit Italy, as that is when most of the tourists descend, combining crowds with hot temperatures. However, those who go outside of the well-beaten tourist path will greatly enjoy this beautiful month in Italy, especially because of one of these four traditional festivities.

1) Festa della Repu

the Republic," as Italy's independence day, a rough equivalent to our Fourth of July. This feast honors the date in 1946 when, after the turmoil of World War II, Italians voted on creating a republic rather than a monarchy. Nearly everything — banks, stores, tourist sites, museums - is closed or operates on holiday hours. Instead, Italians celebrate by watching parades and attending outdoor parties or concerts. Expect to see the Italian tricolor flag with its bright hues of red, white and green adorning landmarks and waving from people's homes. La Festa della Repubblica appropriately occurs in the summer, when people can take advantage of the lovely weather to go outdoors and show their communal pride in being Italian.

2) Festival of San Ranieri (June 16th-17th): The feast of St. Rainerius, or San Ranieri as he is known to Italians, encompasses two days of merriment in the Tuscan city of Pisa. On the eve of the feast day, Pisa celebrates its patron saint by lighting up the city's buildings with over 70,000 glass-encased candles. These *lumini* cast a (June 2<sup>nd</sup>): In the simplest warm, romantic glow against terms, one can think of la Festa the meandering Arno River. della Repubblica, or "Feast of A fireworks displays caps off

the night's festivities. The next day, people gather to watch a regatta, or boat race. I find it interesting that this quaint and local holiday includes the two biggest hallmarks of solstice celebrations — fire and water — giving Italians cause to honor the sweet delights of midsummer.

3) Saint John's Day (June 24th): This is one of my favorite holidays. It commemorates St. John the Baptist, the major religious figure who baptized Jesus, though many traditions originated from the pre-Christian festivities celebrating the summer solstice. In Northern Europe, St. John's Day is known as Midsummer since it falls so close to the summer solstice. People celebrate with rites honoring the sun (the summer solstice) and water (St. John the Baptist): building maypoles, floating garlands of flowers down streams, lighting bonfires. In Italy, this is la Festa di San Giovanni Battista. In the Lake Como region, people float hundreds of delicate lanterns on the lake and later continue the theme of light by enjoying a fireworks display. Florentines celebrate with a medieval tournament, while also holding a procession of rowboats carrying candles drifting serenely along the Arno River. These festivals perfectly capture the magic of the longest night of the year, harnessing the power of the sun and honoring the life-giving qualities of water.

4) Feast of Saints Peter and Paul (June 29th): Rome celebrates the feast day of two of the most important figures of early Christianity with great fanfare. The commemoration of St. Peter and St. Paul, or San Pietro e San Paolo, includes a special Mass from St. Peter's Basilica in the Vatican (St. Peter was the first Pope). Many businesses in Rome are closed for the day as people admire elaborate flower carpets — a summer symbol outside St. Peter's Square. Like many summer holidays, the day ends with a fireworks display.

Of course, there are plenty of other ways to enjoy June in Italy. Lots of little festivals, known as sagre, dot the Italian landscape. These small holidays frequently devote their attention to a specific crop, and during the summer that can mean anything from peaches to strawberries to herbs. One of the best aspects of Italian holidays is that they so connect to the rhythms of the Earth, and encourage reflection in the present moment. So no matter how you celebrate, make sure to give thanks for the wonderful month of June and all of the delights it offers! Happy June!

# Back to Basics — **Low Maintenance Flower Garden Care**

Grow a beautiful flower garden with minimal care by investing a bit of time at the start of the season to reduce on-going

Always match flowers to the growing conditions and the care you are willing to provide. Low maintenance plants need minimal or no deadheading and staking. This means you'll be growing good-looking plants with little effort on your part. And if the plants are suited to the growing conditions and resistant to common pests, you'll be doing less work managing insect and disease problems.

Further reduce your workload by selecting self-cleaning or free-flowering annuals and perennials and those bred for long bloom and compact growth. You'll enjoy more colorful flowers with less pruning and grooming.

Ageratum, angelonia, calibrochoa and many of the newer petunia cultivars are just a few of the annuals that do not need regular deadheading for continual bloom. Include perennials like willow amsonia, bugbane, Solomon seal, turtlehead and sedum autumn joy for lower maintenance and big results.

Prepare the soil and provide proper fertilization before planting. Work several inches of compost or other organic matter into the top 8 to 12 inches of soil to improve drainage and water

holding ability. Incorporate a low-nitrogen organic fertilizer like Milorganite (milorganite. com) at the same time. The slow release formulation provides needed nutrients throughout most, if not all, of the season. Plus, it promotes slow steady growth that won't interfere with flowering, is less susceptible to pests, and is more drought tolerant.

Properly space the plants, making sure they have sufficient room to reach their full size. Overcrowding means you will be thinning or dividing plants more often, or battling disease problems instead of enjoying the full beauty the plants provide.

Consider removing flowers on annuals at planting. This allows plants to focus energy on establishing roots instead of flowers. Can't bear to do this? Then remove the flowers on every other plant or every other row. Then a week or two later remove the flowers on the remaining plants. You will soon be rewarded with full compact plants that will produce more flowers throughout the season.

Pinch back long and leggy transplants. Use a hard pinch to remove the tip and several inches of stem. Use your pruners or fingers to remove stems just above a set of leaves. The remaining plant will still look good while you wait for new

leaves and stems to grow and produce new blooms.

Encourage branching on single-stemmed plants with a soft pinch. Remove just the uppermost portion of the stem where the leaves and tip are starting to develop. Soon you will have a well branched plant and more blossoms.

Improve plant posture and reduce the need for staking with early season pruning. Keep mums and asters compact by pinching them back to six inches throughout June to encourage compact growth. Eliminate floppy growth and the need for staking on late bloomers like Boltonia, Autumn Joy sedum, Russian sage and Heliopsis.

Revive catmint and perennial salvia that flop open in the center with pruning. Cut flopping plants back halfway once or twice a season as needed.

And don't forget to mulch. Covering the soil surface with an inch or two of shredded leaves, evergreen needles/pine straw or other organic material will conserve moisture, suppress weeds and improve the soil as they decompose.

Always water new plantings often enough to keep the top few inches of soil moist. Once established, water thoroughly and only as needed. This encourages drought-tolerant roots, so you'll need to do less watering in the

With proper planning, plant selection and soil preparation you, can keep your ongoing care to a minimum. That means more time to relax and enjoy your beautiful garden.



# Saint Josephine Margaret Bakhita

Josephine was born around the year 1869 in the western Sudanese region of Darfur. She belonged to the Daju people. Her well-respected and reasonably prosperous father was brother of the village chief. She was surrounded by a loving family of three brothers and three sisters, as she says in her autobiography: "I lived a very happy and carefree life, without knowing suffering."

Josephine was kidnapped by Arab slave traders sometime between the ages of seven to nine, probably in February 1877, who already had kidnapped her elder sister two years earlier. She was forced to walk barefoot about 600 miles to El Obeid and was already bought and sold twice before she arrived. Over the course of 12 years (1877–1889), she was resold three more times and then given away. It is said that the trauma of her abduction caused her to forget her own name; she took one given to her by the slavers, Bakhita, Arabic for fortunate. She was also forcibly converted to Islam. As a slave, she experienced cruelty and humiliation. In 1883, Bakhita was bought by the Italian Consul of Sudan, Callisto Legnani. In the Consul's residence, Bakhita experienced peace, warmth, and moments



Two years later, he took Josephine to Italy and offered her service to his friend Augusto Michieli. Bakhita became babysitter to Mimmina Michieli, whom she accompanied to Venice's Institute of the Catechumens, run by the Canossian Sisters. While Mimmina was being instructed, Josephine felt drawn to the Catholic Church. She was baptized and confirmed in 1890, taking the name Josephine.

When the Michielis returned from Africa and wanted to take Mimmina and Josephine back with them, the future saint refused to go. During the ensuing court case, the Canossian

sisters and the patriarch of Venice intervened on Josephine's behalf. The judge concluded that since slavery was illegal in Italy, she had actually been free since arrival. Bakhita remained in the catechumenate where she experienced the call to be religious and to give herself to the Lord in the Institute of St. Magdalene of Canossa. On December 8, 1896, Josephine Bakhita was consecrated forever to God, whom she called by the name of "the Master." For the next 50 years, this humble Daughter of Charity, a true witness to the love of God, lived in the Schio community, involved in various services, including cooking, sewing, embroidery. and attending to the door.

Mother Bakhita passed away on February 8, 1947, at the Canossian Convent in Schio, surrounded by the sisters. Knowing her reputation for sanctity, a crowd quickly gathered at the convent to ask for her protection from heaven.

Josephine Bakhita was canonized on October 1, 2000, by Pope John Paul II. The fame of her sanctity has spread to all the continents and many receive graces through her intercession.

Josephine Bakhita's Feast Day is February 8th.

# THOUGHTS BY DAN ABOUT THIS & THAT

#### The Lady in the Dunes

Among the most famous unsolved murders in America is that of Elizabeth Short, the young Hollywood hopeful from Hyde Park, Massachusetts, who met a gruesome death upon her arrival in Hollywood. Almost 30 years later, Short's home state got its own baffling murder mystery that authorities still can't find a tangible lead for.

On July 26, 1974, a nine-year-old girl named Sandra Lee and her sister made a discovery that continues to shock Provincetown to this day. The two girls were playing with their dog near Dune's Edge Campground, not far from Race Point Beach.

"The dog was ahead of me," Lee recalls. "My dog got excited about something. I heard a very strange noise. If you could imagine someone holding a string of pearls, I heard that sound. And then there was a horrible smell. She was face down. Her hair was a mess and I could see a gouge in the right side of her neck. Her arms were tucked down in the sand, so I didn't know anything was missing. I recognized the green blanket right away. The lower half of her body was covered with something. It wasn't until much later that I realized that the sound of someone playing with a pearl necklace was from the maggots. Her body was covered with maggots." I believe there were a few people who found the body, but there is only one who spoke to police in person about it."

Two days later, the case was reported to the local police and became a media sensation, the crime scene attracting more tourists that summer than the beach itself. The sight itself was horrific. Her head was nearly severed, and her hands had been cut off to prevent identification. Her mouth showed evidence of dental work, yet many teeth had been removed. Clearly, someone went to great lengths to conceal her identity. But who? That is a question that authorities are still asking more than 40 years later. And, despite

exhuming the body three times, authorities still cannot even agree on her exact age, much less who killed The Lady in the Dunes.

Not surprisingly, the most popular theory, and the one endorsed by Lee herself, places Whitey Bulger as a person of interest. Bulger was known to frequent Provincetown and was involved in human trafficking. A lot of the evidence found at the murder site was consistent with Bulger's confirmed murders. Bulger often removed his victim's teeth and dumped corpses at a different location from where the murder took place. Indeed, the green towel was neatly placed beneath the woman's head and her Wrangler jeans were neatly folded. Additionally, tire tracks and two sets of footprints were found leading to the crime scene, all suggesting the woman was killed at some distance from where she was found.

This theory has gained more traction since two initial suspects have been ruled out. Tony Costa, a local carpenter, had by then been convicted of murdering four women in 1969, but was serving time at Walpole's Correctional Institution where he died by suicide in May of 1974. Others came forward, including convicted murderer Hadden Clark, though his confession has not been taken seriously by police.

Equally tantalizing as who killed the Lady in the Dunes is the riddle of who she was. Former Provincetown Police Chief James J. Meads got several tips in the years after the case. In 1987, a woman from Canada called in reporting that she remembered her father strangling a woman in Provincetown in 1974, but this woman disappeared before police could question her. Another woman called in that same year stating that the forensic drawings of the Lady of the Dunes matched the appearance of her sister who had moved to Boston in 1974 and was never heard from again.

Hard as it was, Meads took both reports with a grain of salt. As to the latter case, Meads can't understand why the woman hadn't reported her sister as a missing person in the 13 years since the discovery and, as to the woman from Canada, Meads said, "From what I've been told, she said she saw her father strangle somebody. If that's true, then it's not our victim because she wasn't strangled. Then again, if she was a child, maybe her perception of what happened is off. But no matter what, when they find her, I'll go to Canada to talk to her."

Even after retiring, Meads spent the rest of hisw life haunted by the case. Who was this Lady of the Dunes, and who killed her? Until those questions are answered, the Jane Doe of Provincetown remains one of Massachusetts's most haunting mysteries.

# **Scopa Restaurant Opens on Hanover Street**

Longtime North End resident, **Gennaro Riccio**, has opened **Scopa**, a new Italian restaurant, at 319 Hanover Street. The 22-seat eatery is right in the center of Boston's North End. The name Scopa comes from one of the two major national card games in Italy, meaning "broom" as in taking a Scopa "to sweep" all the cards from the table.

The influence of family friend and **Chef Marisa Iocco** from Gennaro's 5 North Square is clear at Scopa. Iocco is Boston's only Italian-born female chef and recent author of *Ecco Perché Amore (Every Menu is a Love Story)*.

The menu is "refined Italian" with extensive starters including braised octopus, Venetian meatballs, chef creamed mozzarella and a calamari trio. Five pastas and entrees make up the core of the dinner selections highlighted by raffiche, agnollotti, pappardelle, pork baby ribs and Colorado lamb steak.

A brick pizza oven is the centerpiece of the open kitchen offering classic margherita and specialty pizzas, such as fried pepper and broccoli rabe. The bread is also made fresh in the oven.


A select offering of wines is available, including Rose & Frizzanti along with an Italian-heavy wine list of whites and reds available by the glass or bottle.

This is Gennaro's first eatery, but the young Riccio is no stranger to the business having grown up working in the various family establishments, including **Caffe Vittoria**, **Florentine**, **Gennaro's 5 North Square** and **Stanza dei Sigari**.

Leather-backed seating along the walls helps maximize the space that includes only 22 seats. The best seats in the house may be at the windows overlooking Hanover Street at the raised dining table.

#### MARTINA McBRIDE -RECKLESS Nash Icon + Big Machine Records

Martina McBride is happily "back in the saddle" with her first original album in five years, titled Reckless. The country music powerhouse stepped away from her 2014 album, Everlasting, a collection of covers songs in the genre of R&B and Soul. Martina powers out her trademark vocals on the lead single and title track "Reckless" to set the pace. With ten tracks at her command, she gives her country music fans a solid set of songs in the country pop sound that she describes as "songs about love, life, loss, hope, redemption, gratitude, leaving and coming home." McBride's success continues with, "It Ain't Pretty," asserts "woman power" with "Just Around the Corner," moves to the powerful "Everybody Wants to Be Loved," followed by a taste of the free-spirited "The Real Thing." The second half begins with Romance 101 via "That's the Thing About Love," then the pain of "Low All Afternoon," followed by the gem "Diamond" with Keith Urban, slows the pace for "We'll Pick Up Where We Left Off," and puts the final touches on her first album for Nash Icon, a label devoted to veteran country singers, with the "bare bones" honesty of "You and You Alone."

#### BEAR McCREARY – 10 CLOVERFIELD LANE Sparks & Shadows + Bad Robot + Paramount

When it comes to creativity and writing an incredible score, one can frequently find the name Bear McCreary attached. Producer J.J. Abrams summed up his thoughts with, "It is tense, emotional music that gives the film scope and heart, augments the surprise and horror. It's an homage to Herrmann, but wholly original at the same time. I'm deeply grateful to Bear for his contribution to this movie." Music from the motion picture includes 14 cuts to show the emotion and meaning of the film, utilizing four different ensembles and a traditional 90-piece orchestra. Sparing little to put together the sound he sought, McCreary explodes with cuts like the moving "Michelle," and the solitude of "The Concrete Cell." The heart-pounding, driving "At the Door" displays the urgency of the time, followed by the pensive "Message from Megan." The quiet bells of "A Happy Family" continues on the second half with the searing sound of "The Burn," and this exciting soundtrack winds down with the haunting "The New Michelle" and the explosive title track.

# CRIMINAL – ORIGINAL MOTION PICTURE SOUNDTRACK Lakeshore

Criminal is a film scored by Brian Tyler who has composed and conducted over 70 soundtracks. His track record is impressive, having earned three Emmy Award nominations. Tyler decided that he should create a primarily analog synth score, explaining, "We wanted this score to reflect two radically contrasting aspects of the film: grittiness and emotion. We utilized analog outboard synths to create a raw soundscape that could fulfill the entire range of music from grinding raw electronic score to melancholy heartbreak. The style of the score harkened to classic electronic scores of the past." In addition to writing the original score, Tyler wrote and recorded the main title song, "Drift and Fall Again," performed under his moniker of Madsonik and featuring Lola Marsh. In addition, he included the chaotic "Criminal" as a Madsonik Remix. In his earlier remarks, Tyler stated that he wanted this score to reflect the contrasting aspects of the film, grittiness and emotion - consider this score to be "mission accomplished!"

#### BOB DYLAN – FALLEN ANGELS Columbia

The ever-surprising Bob Dylan strikes once again. This time he makes his mark with Fallen Angels, a compilation of a dozen songs from the Great American Songbook. One of the many highlights is his interpretation of the songs, and how he saw them as a vocalist, arranger, and bandleader. Dylan chose to perform songs from a diverse array of writers, including Johnny Mercer, Harold Arlen, Sammy Cahn, and Carolyn Leigh, which he recorded with his touring band. Opening with "Young at Heart" to set the mood, Dylan's unique vocals roll out "Maybe You'll Be There," and the slick picks of "Polka Dots and Moonbeams," before hitting a home run with "All the Way." The bittersweet "Skylark" is delivered in a free, spirited mood, followed by the haunting "Nevertheless." Dylan picks up the pace with "All or Nothing at All," the jazzy "On a Little Street in Singapore," and the smooth as silk "It Had to Be You." Finishing the dozen delightful tracks is the simplicity of "Melancholy Mood," "That Old Black Magic," and "Come Rain or Come Shine." Dylan never disappoints!

#### KRISTIN KONTROL -X-COMMUNICATE Sub Pop Records

*X-Communicate* is Kristin Kontrol's newest project, and she uses the opportunity to express herself. Originally penning 62 songs, she was able to cut them down to a neat ten, thus her exciting debut album for Sub Pop Records. Opening with the soul-baring "Show Me," trailed by "White Street" describing her New Year's Eve past, along with her new track which was recently premiered on SPIN - "(Don't) Wannabe," plus a pair of dance-pop tracks, one being the title cut, and the other "Skin Shed." Kristin puts the pedal to the metal with "Drive the Night," slowing the pace for "What is Love," pounding the floor via "Face 2 Face," and puts the wraps on her effort with "Going Thru the Motions," and her finale "Smoke Rings." Without a doubt, Kristin is in Kontrol, and fans locally will have the chance to catch her live (Friday, June 17th @ Cambridge's Middle East).

### **Exhibit Explores History of Public Transportation in Boston;**

Reveals West End's Role as Early Transit Hub

Public transportation has shaped life in Boston and its neighborhoods since the first English settlers arrived in the early 17th century. Its evolution over the course of more than 200 years is a fascinating tale of continuously rising demand, financial and logistical challenges, and technological advancements. A new exhibit at the West End Museum recounts the phases of development since the 18th century through graphic panels and artifacts like trolley tickets, stock certificates, conductor buttons, tokens, photos and original articles.

From Stagecoach to Subway: The West End Street Railway runs now through September 17<sup>th</sup> in the Museum's Members Gallery. The show reception takes place on Tuesday, June 7<sup>th</sup> from 6:30-8:00 pm, when attendees can tour the exhibit and enjoy light refreshments. The exhibit and reception are free and open to the public.

Ferries provided the bulk of people-moving in early to mid-18th century Boston. Subsequent major growth in the city's population and commerce brought increased transportation needs. The ferries were supplemented with improved roads, new bridges, and new transportation technology. In 1793, the mile-long West Boston Bridge was built between Boston and Cambridge, making the West End a transit hub. In 1795, a public stagecoach began running across it.

The means of mass conveyance that followed included omnibuses, which were horse-drawn vehicles larger than stagecoaches, and horse railroads, or horsecars that ran over tracks. The West End Consolidation Act of 1887 established the West End Street Railway Company, uniting 20 different horse railroad companies under one

umbrella. This led to the creation of one of the largest street railway operations in the U.S. at the time. Among the West End Street Railway Company's first — and most lasting — reforms: painting railcars specific colors to designate their routes.

In 1889, the West End Street Railway Company introduced Boston's first electric train railway (or cable car) system, and within six years the city had electrified nearly all its railroads. System inefficiency and public dissatisfaction prompted the creation of the Boston Elevated Railway and, ultimately, the MTA and MBTA.

From Stagecoach to Subway: The West End Street Railway is free and open to the public during regular Museum hours.

# Ray Barron's 11 O'CLOCK NEWS

Ready for this! A North Carolina man has been convicted of a hate crime for ripping off a Muslim woman's hijab aboard a Southwest Airlines flight. Gill Parker Payne, 37, will serve two months home detention after admitting that he removed the head covering while shouting, "Take it off! This is America!" The incident happened just three days after Donald Trump called for a ban on all Muslims entering the U.S.

Law-abiding citizen! A Florida police chief issued himself a parking ticket when a neighbor alerted him that his vehicle was parked illegally. "I cannot hold anyone accountable until I hold myself accountable," Chief Melvin Tennyson said after paying the \$45 fine.

Fight fire with fire, after former Pennsylvania Governor Ed Rendell, a big Hillary Clinton supporter, said Donald Trump's comments about women will backfire because "there are probably more ugly women in America than attractive women.'

Bad news from Rome! Sopranos star robbed: An Italian paramedic is on trial for allegedly stealing a gold Rolex watch from American actor James Gandolfini as he lay dying. Stretcher-bearer Claudio Bevilacqua, 43, was part of the paramedic team called to a Rome hotel in 2013 after the Sopranos star collapsed there following a massive heart attack. Prosecutors said they weren't sure whether Bevilacqua swiped the \$3,000 Submariner watch from Gandolfini's wrist as other medics battled to revive the actor, or picked it up from his hotel room. Gandolfini, who was in Italy on a family vacation, was pronounced dead 20 minutes after arriving at the hospital. Bevilacqua's trial has been adjourned until November. Italian court cases move notoriously slowly.

Controversy swirled around Woody Allen at the Cannes Film Festival in France, amid renewed allegations that he molested his now 30-yearold daughter Dylan, when she was 7. "I think he sexually assaulted a child and I don't think that's right," actress Susan Sarandon said at the glitzy annual event, where the director appeared for the opening of his film Café Society. "I have nothing good to say about him." Her comments came in the wake of a scathing essay in the Hollywood Reporter by Allen's son Ronan Farrow, 28, who condemned the movie establishment for embracing his father and effectively condoning the alleged abuse — which Allen, 80, vehemently denies. "That kind of silence isn't just wrong, it's dangerous," Farrow said. "It sends a message to victims that it's not worth the anguish of coming forward."

Scornata? A Maryland woman has spent the past three years going bare-chested in public, in the hope of "normalizing" naked breasts. Chelsea Covington, 27, spends most of her time in places where it is legal to be topless in public, such as New York, New Hampshire, and Washington, D.C. The photos on her blog, Breasts Are Healthy, show her going about her life — enjoying a picnic in the park, riding her bike — while nude from the waist up. Going "bare-chested is still a powerful act for a woman," Covington said, "especially when done quietly, confidently, and peacefully."

Emma Morano, 116 years old, of Verbania, Italy, has become the oldest woman in the world after the death of Susannah Mushatt Jones of New York City, who was also 116. Morano attributes her long life span to her decision to leave an unhappy marriage to a dominating man in 1938. She may be the last living person on Earth born in the 19<sup>th</sup> century.

The adorable Barbara D'Amico says, "Few women admit their age. Few men act theirs."

For the first time since 2001, the volume of alcohol consumed in the world dropped last year. The drop was largest in countries suffering big economic slumps. In China, total consumption dropped by 3.5 percent and in Brazil by 2.5 percent.

Paul Waters of Swampscott says, "An alcoholic is not one who drinks too much, but one who can't drink enough."

We learned recently, Chinese nationals have become the largest foreign buyers of U. S. property, investing at least \$110 billion over the past

five years, according to a study by the Asia Society and the Rosen Consulting Group. The



report's authors say the total for the second half of this decade is likely to be double that: \$218 billion. Well, we wonder if the Chinese have purchased any properties here in Massachusetts.

"At stores across the country, Americans are spending more on home improvement than on clothes," said Max Lewontin in CSMoniter.com. Home Depot reported a strong start to 2016, with sales at existing stores ticking up 6.5 percent in the first quarter.

While celebrities hawk wrinkle creams and other anti-aging "miracles," the real action may be at MIT and Harvard, where chemical engineers have developed something they've dubbed "second skin." After nine years of work, the researchers came up with a virtually invisible, breathable film, applied like a lotion that restores the skin's elasticity. The silicone-based polymer, which is made from common chemicals deemed safe by the U.S. Food and Drug Administration, effectively smoothes out wrinkles and makes under eye bags disappear — albeit temporarily. The second skin dries in only minutes, withstands washing and sweat, and falls off the skin after a few days.

There are more consumer goods available today than at any time in history, said Christopher Mims. The average grocery store carries roughly 50 times as many products as it did 80 years ago. Gee, we wonder if they carry Baccala.

Colombia has become the fourth South American nation to legalize same-sex marriage, after a ruling by the country's constitutional court.

Rothbort's wife initially failed to pick the 6-foot-1 Gatling out of a lineup — even after officers directed her to focus on the "tall one." Facing a possible death sentence, Gatling was persuaded by his lawyer to plead guilty and was sentenced to 30 years to life. Maintaining his innocence, Gatling was freed under a 1973 commutation. The District Attorney's Conviction Review Unit recently took his appeal on the grounds he had

# Recipes from the Homeland

#### ALMOND-FLAVORED BUTTER COOKIES

3 eggs

½ cup sugar

2 sticks softened butter

 $(\frac{1}{2} pound)$ 3 cups flour

1½ cups flour - separate

2 teaspoons baking powder

Cookie cutters of choice \*1 teaspoon almond flavoring

**ICING:** 

1/3 cup melted butter 1 box confectioners sugar Candy sprinkles or nonpareils

\*½ teaspoon almond flavoring

(optional)

In a bowl, cream sugar and softened butter. Add beaten eggs and mix thoroughly. Measure out three cups flour and place in a separate bowl. Add baking powder to flour and stir. Gradually add this to the sugar, butter and egg batter. This will become soft dough. Spray two cookie sheets with vegetable or butter spray and set aside.

Spread some flour on a pastry board. Spoon a portion of pastry dough onto floured pastry board. Sprinkle some flour over dough. With your hand or rolling pin spread dough out to about 1/4 inch thickness. Before cutting each cookie, dip cookie cutter into flour. Then place cut out cookie onto greased baking sheet. Continue until all dough has been used. Bake in preheated 350°F oven. Baking time is about ten minutes. Bottoms will brown slightly. Remove from oven and place baked cookies on a tray to cool. Makes about four dozen.

ICING: Melt butter in top pot of a double boiler. Add almond flavoring. Gradually add confectioner's sugar to mixture until you have soft icing. Using a pastry brush, spread icing on one cookie at a time. Immediately sprinkle your choice of sprinkles or nonpareils over the icing. Set cookie aside on a tray. Continue icing in this manner.

\*Use you own favorite flavoring in the cookie dough and icing.


NOTE: This is an easy recipe to prepare for a holiday or birthday party. The colorful cookies are a favorite of my children and grandchildren. They store well in a canister.

# BEWARE of **IRS SCAMS**

### IRS-IMPERSONATION **TELEPHONE SCAM**

Con artists can sound convincing when they call. They use fake names and bogus IRS identification badge numbers. They may know a lot about their targets, and they usually alter the caller ID to make it look like the IRS is calling. Victims are told they owe money to the IRS and it must be paid promptly through a pre-loaded debit card or wire transfer. If the victim refuses to cooperate, they are then threatened with arrest, deportation, or suspension of a business or driver's license. Or, victims may be told they have a refund due to try to trick them into sharing private information.

NOTE THAT THE IRS WILL NEVER: 1) call to demand immediate payment, nor will the agency call about taxes owed without first having mailed you a bill; 2) demand that you pay taxes without giving you the opportunity to question or appeal the amount they say you owe; 3) require you to use a specific payment method for your taxes, such as a prepaid debit card; 4) ask for credit or debit card numbers over the phone; or 5) threaten to bring in local police or other law-enforcement groups to have you arrested for not paying.

# Nanna & Babbononno

by John Christoforo

A Nostalgic Remembrance



Last week, I ended the column with a conspiracy devised by Sal's mother and her aunt to try to get me married off to a Sicilian girl. After that episode, I knew that my days visiting with Sal's family had to be shortened. After dinner that night, we planned our escape; I mean continued tour of Sicily. There were a few more sites I wanted to see and a beach or two I wanted to head to, but I figured that we should be on the road east within two or three days.

One of the places I wanted to visit was the home of Luigi Pirandello, the famous writer who won the Nobel Prize for Literature in 1936. Sal's father, Carmelo, led the way with Uncle Gus in tow. When we headed to the beaches, I basked in the tropical sun of the Mediterranean and swam in the warm water that separated southern Sicily from Tunisia in North Africa, I was in paradise, but the older men seemed uncomfortable hanging out under the noonday sun. Later in the day, we headed for a beachside restaurant. Sal and I were still in our bathing suits, but the older men who were under a beach umbrella at the cabana we had rented sat on the shade side of the table we had chosen to sit at. I was curious about the older guys and their aversion to the sun. Uncle Gus offered an explanation, "The idea of being tanned seems to be a northern European and an American phenomenon. In the Mediterranean countries, tanned skin means that you were a field hand, a farmer, and were on the bottom-end of the social scale. I had seen the same reaction among Puerto Ricans, Cubans, and Dominicans who were middle-class or above. Being tanned was a stigma, not something gentler people aspired to obtain.

Two days later, Sal and I left Canicatti. I said my goodbyes to his parents with a promise that I would visit again. I was sorry that Uncle Gus decided to stay behind, as his stories were never-ending, but he was not young and was not willing to rough it traveling across Sicily in the summer heat. Sal's father outlined locations on a map, circling the places he thought we should see before heading to the mainland. Of course, Sal's mother packed a lunch for us when we left. Being a true Italian, the food was packed in a shopping bag, not a lunch bag. As we departed the parking lot at the condo, several neighbors came out to say goodbye. I didn't realize that we secretly had received celebrity status among the locals, and in such a short period of time.

I drove east, stopping at the cities of Caltanissetta and Enna, knowing that there is ancient history surrounding both places. Late in the day, we found a pensione, or let's say, a clean, inexpensive hotel to stay at. The next day, as I drove east, I saw a mountain in front of us, with black lines descending from the top downward. I was quite curious as I had never seen anything like it in my life. As we got closer, I discovered that the black lines were streams of hardened lava that had spilled out, not from the top of a mountain, but from the opening of an active volcano, Mt. Etna.

We stopped at a tourist area, as both of us wanted to find out more about what we saw.

It seems that the volcano usually never erupted in an explosion. Instead, the lava would rise to the top and spill out causing flow lines that ran down its sides. There had been a cable car in existence that brought tourists to the top, but after the last spill, which I was told happened about two weeks earlier, the whole mechanism was wiped out. Instead, we rode on the backs of donkeys as far upward as we could go, and then climbed the rest of the way to the top, leaving the donkeys behind.

Once we reached the top, 10,991 feet above sea level, the temperature was about 40 degrees. Sal and I leaned over the mouth of the volcano and looked inside at the round circle of molten material that moved back and forth a couple of thousand feet below us. As we peeked inside, our faces became covered with sweat. Another tourist who was doing the same thing, yelled out in Italian, "My face is numb from the heat and my butt is numb from the cold." We all laughed. At that point, I realized that it was cold at that elevation and we quickly headed back down to civilization. Once back at the bottom, I looked for water and was told that the water was not drinkable, and I had to buy bottled water. There would be only two instances when I would be told the water was not drinkable, here at Mt. Etna, and at food stands at the base of Mt. Vesuvius.

We decided to head southeast again, stopping for a while at Ragosa, Avola, and then Siracusa. It was getting late and we checked into a pensione in Siracusa. The dialect of Italian the locals spoke seemed to contain Greek words with Italian endings. After dinner, Sal and I sat at a sidewalk café to have a drink and watch the world go by. We struck up a conversation

Johnny Christy Orchestra with some people at the next table, and when I asked about the Greek words, we were told that the area was settled by the Greeks about 1000 B.C.

They added, that the entire area was called I piani di Grecchi. (The plains of the Greeks.) I then understood why there were ancient Greek words mixed in with Italian words spoken with a Sicilian dialect ... fascinating.

I was now on the east coast of Sicily and desirous of seeing Catania. I had heard of Bellini Park, and was told that it was one of the most beautiful on the island. The propaganda about the park was right on target. We spent several hours looking at the gardens, statues, and tourists wandering through the park, many of them Scandinavians from Norway and Sweden. (The tourists, that is.)

At 11:00 that night, I decided to call home (collect). It was 5:00 pm Boston time, and everyone would be home. I told Mom and Dad about Mt. Etna and Catania. When Babbononno got on the phone, he warned me about Sicilian women for the second time. When I asked why, he said that their fathers and brothers all carried lupari (Italian shotguns), and if I seemed like a threat, I might be on the wrong end of the gun. I told my grandfather not to worry, said goodbye to everyone and told them I would call from our next destination, Messina.

The next day, I pointed the car north and drove to Messina as planned. We arrived late in the afternoon and checked into the Jolly Hotel. I would have headed to a pensione which would have been cheaper, but I was out of gas and tired.

We would spend about a day or two traveling through Messina. The old section was constructed during the Middle Ages and fascinating. The newer part was even newer, having been wiped out during WWII and rebuilt in the 1950s. This was the busiest Sicilian city I had seen since landing in Palermo a week or so earlier. It was a commercial center and had a ferry that carried passengers, cars, trucks, and even trains to the Italian mainland. I bought a ticket for the ferry for the following night, and ... I'm out of space, so, see you next week.

Remember Dick McAuliffe and the Tigers



Dick McAuliffe, the hardnosed All-Star infielder for the Detroit Tigers, who played 14 seasons in Detroit and helped them beat the Cardinals and Bob Gibson back in the 1968 World Series and ended up with the Red Sox when he retired from baseball, passed away on May 13th at age 76.

His nickname was "Mad Dog" for the hard-hitting way he played the game. In 1968, he led the American League in runs with 95, had 50 extra base hits, and never once hit into a double play.

His career batting average was only .247, but he had 1,530 hits and 197 homers, including



#### **ROBERTO DURAN**

#### The Last of the Great Old School Fighters

On May 16<sup>th</sup>, *Hands of Stone*, the movie biographic of Roberto Duran, opened to mixed reviews at the Cannes Film Festival. The movie is scheduled to premiere in the United States in August. I am looking forward to seeing it. Duran is played by Edgar Ramirez, with Robert De Niro portraying trainer Ray Arcel. Former boxing champion turned actor John Duddy steps into the role of Ken Buchanan.

While anticipating this movie. I have been reflecting on the career of Roberto Duran. Not just his fights, but his attitude, training methods, and amazing skills. I believe Duran was the last of the great "Old School" boxers. Duran had a total of 119 bouts in a career lasting 34 years in which he fought in five different decades. In that time, he won five championships in four weight divisions. He began his career at 119 pounds and fought through the different classes going as high

as light-heavyweight. He was, of course, at his best while fighting lightweight, where he dominated the division and will always be considered an all-time great. He is ranked as the best ever by many boxing experts, and they certainly have a good argument for that view.

Duran won the Lightweight Championship from Ken Buchanan on January 26, 1972, and remained champion until 1979 when he vacated the throne in order to take on Sugar Ray Leonard for the Welterweight title in Montreal, Canada. In a superb fight, Duran out-boxed and outslugged Leonard over 15 rounds and came away with the belt. It was the highpoint of his career. The great lightweight champion had proven he could step up in weight and defeat the best.

Of course, the glory was short-lived as Duran foolishly agreed to a rematch just five months later. Roberto had not even finished celebrating his victory, and celebrating was something he did with as much passion as fighting, He had ballooned to 180 pounds and had to trim down very fast to make the weight for his title defense. He also was not mentally prepared for the fight. Many believe Leonard, along

with his very shrewd manager Angelo Dundee, pushed for the quick rematch knowing Duran would not be at his best in such a short time.

The rest is history as Duran would forever have to live with the words "No Mas" after quitting in the 8th round. To this day, there has never been a definitive explanation given as to why the fearless Duran just threw his hands up and relinquished the title. Duran has said different things at different times, but I don't think he is even sure why he did it. My belief is he just was not up for the fight, got frustrated by Leonard's brilliant boxing, and decided to call it a night. It was one of those crazy moments that were completely out of character for the great champion. As a side note, Duran never actually uttered the words "No mas!"

Now why do I call Duran the last of the great old school boxers? First off, unlike today's overly cautious so called champions, Duran fought often and against everyone. After winning the Lightweight Championship, he was back in the ring for a non-title bout just three





months later. He fought an additional two times that same year, including dropping a nontitle ten-round decision to top contender Esteban DeJesus. Instead of then avoiding DeJesus, Duran went on to give Esteban two shots at the title, stopping him both times.

From the time he won the Lightweight Crown until he gave it up in 1980, Duran fought 43 times in both title and non-title fights. He defended the championship twelve times. Over that period, he absolutely dominated the division and was, next to Muhammad Ali, the most followed fighter. Every time he stepped into the ring, there was excitement in the air.

Duran trained "Old School" and was taught "Old School" methods by Ray Arcel and Freddie Brown. He also had abundant natural talent, which made him reminiscent of Jack Dempsey. When you watch Duran in action, you are not just seeing a brutal punching slugger in there; you are also seeing an artist at work plying his craft. He had the moves of a cat, the punch of a mule, and the cunning of a fox.

Look at almost any Duran fight and you will see brilliance. While watching him at his peak is always a pleasure for any

boxing aficionado, I particularly enjoy viewing his 1983 match against Marvelous Marvin Hagler. Here was Duran long past his prime fighting way above his best weight against one of the greatest middleweight champions of all-time. On paper this should have been an easy win for Hagler, but Duran reached into his tool box, or perhaps I should say artist's palette, to come up with an array of boxing moves that have not been seen since. He used body and head feints to confound Hagler. He would work his way inside

> and appear to be about to go for a clinch when he would suddenly unleash a combination to the body. He was rolling with and slipping punches. He knew how to take breaks in order to catch his breath. Going into the 13th round, Duran was actually ahead on two of the judges' cards. Just amazing. Marvin, with his eye swollen, had to fight hard in the remaining rounds to secure the victory.

In my opinion, that loss made up ten times over for the "No Mas Fight". Duran continued fighting until 2001 and even managed to win the WBC Middleweight Title in 1989 by defeating Iran Barkley.

Duran was an all-time great Lightweight, an all-time great pound-for-pound fighter, and a true "Old School Boxer". It is doubtful the moves he executed in the ring will ever be seen again. For all the talk of him being a slugger, it must be remembered how difficult he was to hit. He had amazing defensive skills. Watching film of him gives you an idea of what great fighters used to do. For a special treat, go to YouTube and search for "Roberto Duran teaching boxing." There are some recent clips of him taken in gyms where he is showing young fighters boxing techniques. One in particular was taken in England and goes on for about 12 minutes. It is an absolute Master Class in boxing. You will learn more about the "Fine Art of Boxing" just watching that 12 or so minutes than you will from two or more years in most modern boxing gvms. "Old School Boxing" has become a lost art form. Carefully watching Roberto Duran in action will teach you a lot. Watching him giving pointers in a gym is pure gold.

He's come a long way from that first practice in Wilmington just after Labor Day in the fall of 1997, when a much anticipated wet-behind-the-ears teenager reported for duty at Bruins training camp.

It was 19 years before he would be playing in his first Stanley Cup Final against Pittsburgh as the veteran center for the San Jose Sharks. It was way back then that Boston had selected one Joe Thornton as the number one pick in the annual NHL Draft. And then, as now, there was a lot to like about him.

One look at his statistics would make a scout's eyes pop out. In his final year of junior hockey while playing for the Sault Ste. Marie Greyhounds of the Ontario Hockey League, the big center (6'-4", 220 lbs) put up big numbers — 41 goals and 81 assists, for a total of 122 points in 59 regular season games played.

And there was something else. Thornton also seemed to be in the center of things when encounters became physical—as in 123 minutes in penalties to go with that prodigious point production. Yes, there really was something jumbo about him—not only in size, but in numbers.

Or, as then Bruins GM Harry Sinden stated with some enthusiasm: "He doesn't take any guff from anybody."

So here he was on that bright sunny day in the suburbs north of Boston, in the same room with a Boston icon that was old enough to be his father. Yes, everybody still liked Raymond, but as they glanced to the side there was the hope that they were not just looking at Bourque's successor, but also at a potential savior of the franchise.

For a team based in the "Hub of Hockey," one that had not raised Lord Stanley's Cup since 1972, it seemed a lot to expect from an 18-year-old who had yet to experience the drop of a puck in an NHL game.

But as all the representatives from the top Boston media outlets clustered around him in their waning time of ultimate power — just before the advent of internet-based bloggers and social media — you knew that is what they were expecting.

But things didn't really work out that way in the Hub. Never really given a chance to develop into a star, but expected to be an instant one right out of the box, Joe couldn't fulfill that role.

Early on and perhaps quite properly, Thornton's mom insisted that he live with a family that also had teenagers, a residence where he would have home-cooked meals and engage in dinner table conversation every night. It was a caring action by a parent who realized her son was not quite an adult.

And then, over time, the super high numbers that he put up in junior hockey were not duplicated during his years in the Hub. Joe Thornton was not a failure. He was a very good NHL player.

But often he was treated as a failure by the media and an increasing number of fans. Why? Because he did not live up to the artificially high, externally imposed standards that they had set. Joe grew unhappy and finally, after a little more than seven seasons, it all came down to November 30, 2005. It was on that day that he was supposedly observed crying in his car in the North End shortly after learning he had been traded to San Jose.

What he really needed was a change of scenery, a place out of the 50,000-watt media glare of the Hub, a place where he could make significant contributions but not be expected to carry the entire load. He didn't know it then, but the B's were doing him a favor.

Once out in California, and thus in a somewhat less intense hockey setting, Thornton blossomed. Paired with Sharks wing Jonathan Cheechoo, the two clicked right away. Jumbo Joe amassed 92 points in 58 games after the trade and wound up at 29-96-125 for the season, winning both the Art Ross Trophy as the NHL's top scorer and the Hart Memorial Trophy as the league's MVP. He was the first player in history to win the awards while playing for two different teams in the same season.

The high number of assists also indicated that his role would shift over the years. Once thought of as a goal scorer as well as a player who contributed assists, he would now be thought of as primarily a player who could set up scorers — an assist man. Indeed, Thornton's last 30-goal season was back in the 2002-2003 campaign when he was with the Bruins.

To be sure, the Sharks (and thus Joe Thornton), are no strangers to the Stanley Cup Playoffs. The team has missed the NHL's second season only twice since 1998.

One of those times was in 2015, so it's been a big rebound year for the Sharks. From DNQ last year to reaching the final best-of-seven this season is a big leap.

In, addition, it is the Sharks' first trip to the Stanley Cup Final in their 25-year history. Their success over the Blues that enabled them to advance to the SCF was also the first time they had won the Western Conference Finals.

Joe Thornton has waited all his life for this moment, perhaps significantly longer than many others. He's waited 19 years; he's waited 1,356 career regular season games, and 150 career playoff games.

He'll turn 37 on July 2<sup>nd</sup>. And while there might be a few more seasons left in the tank and some additional years when the team qualifies for the playoffs, he may not have another chance to win it all.

To all the players (but especially veterans) participating in the Stanley Cup Final, the words of the late coach Herb Brooks' pre-game address to his 1980 Miracle on Ice Olympic Team that faced the Soviets are appropriate here: "Great moments are born from great opportunity. And that's what you have here ... This is your time! Now go out there and take it!"

It should be a great series as the players and coaches pursue their shared dream of a lifetime.
