"What Are We Doing?"

The funerals for the ten black community members who were murdered while grocery shopping in Buffalo on May 14 are not even over — but it happened again.

This time, children. Thursday should have been the last day of school and the start of summer vacation for teachers and students at Robb Elementary School in Uvalde, Texas. Instead, on Tuesday, May 24th, 19 fourth graders and two of their beloved teachers were shot to death in their classroom. They were murdered by a shooter who had legally purchased two AR-style rifles and 375 rounds of ammunition starting on May 17, the day after his 18th birthday. As our colleagues at the Children's Defense Fund-Texas put it, "The only thing extraordinary about yesterday's tragedy in Uvalde is how ordinary it is." What a shameful indictment of our nation's failure to act and protect children.

Senator Chris Murphy (D-CT) struck a chord with millions of Americans as he

spoke passionately on the Senate floor hours after the shooting. Senator Murphy was the Congressman representing Newtown, Connecticut when 20 first graders and six adults were shot to death at Newtown's Sandy Hook Elementary School in December 2012, so he is no stranger to responding to indescribable tragedies. He is also no stranger to watching many of his colleagues respond to gun tragedies by defiantly refusing to take action to protect children, not guns. On Tuesday, Senator Murphy asked all of them: "What are we doing?":

"Just days after a shooter walked into a grocery store to gun down African American patrons, we have another Sandy Hook on our hands. What are we doing? There were more mass shootings than days in the year. Our kids are living in fear every single time they set foot in the classroom because they think they're going to be next. What are we doing? Why do you spend all this time running

Memorial Day Flag Garden Honors Massachusetts Fallen Heroes

Massachusetts Military Heroes Fund (MMHF) and its volunteers placed over 37,000 American flags on Boston Common in preparation of Memorial Day. Each flag represents a local hero who sacrificed their life defending our country and freedom. Service members honored stretch back to the Revolutionary War.

The Memorial Day Flag Garden is planted at the Soldiers and Sailors Monument. MMHF worked with volunteers and staff from Home Base, a partnership of the Red Sox Foundation and Massachusetts General Hospital that helps veterans and their families as they heal from invisible wounds like traumatic brain injury and post-traumatic stress

Parkland Dad Rips Schumer

The dad of a student slain in Parkland, FL. school massacre slammed Senate Majority leader Chuck Schumer for blocking a school-safety bill, calling the move "heartbreaking."

Max Schachter, whose son Alex, 14, was among the 17 killed in the 2018 shooting at the Marjory Stoneman Douglas HS rejected Schumer's claim that the Republican - sponsored bill, which calls for a federal online clearing house of best practices for school safety "could see more guns in schools."

The dad told the media, "How does a website put guns in schools? It's ridiculous. It has nothing to do with guns." U.S. Sen. Ron Johnson, R-WI had pushed for the Luke and Alex School Safety Act named after both Alex and Luke Hoyer, 15 also slain in that 2018 massacre to be passed by unanimous consent the day after the Uvalde shooting spree, but Schumer barred the move.

Max Schachter said, "I was naive to think that a horrible mass shooting would make people do the right thing. It's heartbreaking."

McConaughey Visits Uvalde, Texas

Actor Matthew McConaughey returned to his grieving hometown of Uvalde, Texas where he grew up until he was 12 years old. After learning of the horror that unfolded there he decided to return in a bid to help the small town of Uvalde to help mourners and townsfolk "heal." He was accompanied by U.S. Rep. Tony Gonzales, R-TX as he talked with folks and offered some comfort to them as the town tries to make some sense out of this tragedy.

Fallen Heroes Memorial AT SEAPORT COMMON

An emotional homage was held at Seaport Common in the Seaport District to those who made the ultimate sacrifice for our nation. The first of its kind in the country, a 50-foot, 5-sided (representing the five branches of the armed services) transparent pillar memorial rises above the city inscribed with the names of the Commonwealth's heroic service members who lost their lives fighting for our freedoms since September 11, 2001.

In attendance were Gold Star Family members, Medal of Honor recipients, veterans, Mayor Charlie Baker and other dignitaries. Sadly, this year two more names of brave Bay Staters were added to the monument, Johanny Rosario Pichardo, Afghanistan and Capt. Ross Reynolds, NATA exercise in Norway). Hopefully, a time will come when we will not have to add another name to this monument or any other.

In 2010, a group of local veterans, firefighters, police officers, Gold Star families and citizens came together with the goal of honoring those who did not return home from conflict overseas. From this dedicated group,

LUDI PUBLICI

The public games or shows of ancient Rome were called "Ludi Publici" and were financed either by the government or the government officials. They took the form of athletic contests or other spectacles and were held in the theaters, amphitheaters, circus, or even in the local piazza. For hundreds of years, the ludi were the most prominent features of their religious and social life.

Augustus outdid all of his predecessors in the magnificence of his public shows. These were staged in all the wards and in all languages. He promoted athletic contests in the well-known area near the Tiber, which was called the Campus Martius. Roman Knights (the Equestrian Order) were featured in scenic, pageantry, and gladiatorial contests. These special gladiatorial contests were much like our wrestling matches of today; a lot of action but no blood.

He constructed an artificial lake near the Tiber and even staged a mock naval battle. There were so many people in attendance at these events that it was necessary to station guards at various parts of the city in order to prevent vandalism and looting.

Whenever anything rare or extraordinary was brought into the city, he ordered a special exhibit for those days which did not conflict with his scheduled spectacles. These special exhibits included a huge rhinoceros in a confined area of a central park, an especially large and ferocious tiger which was displayed in a large cage set on the stage of a theater, and a huge snake which was reported to have been seventy-five feet long and displayed in a central piazza.

During an overcrowded indoor theatrical production, there was concern and near panic, for fear that the structure might collapse. Augustus calmed the audience by taking a seat in a spot which appeared to be the most dangerous. We know now of course that the structure stood for many years to come.

While in attendance at any event, Augustus gave his entire attention to the performance and did not permit the distractions of talking, reading, or writing as did other emperors to follow. He even offered special prizes or gifts from his own purse.

Many senators who were late arrivers were unable to find seats in many of the shows so Augustus was responsible for a decreereserving the first rows of seats at any theater or public event exclusively for senators. He also separated soldiers from civilians, assigned special seats to married males, and a special section to juvenile males. Sorry gals, but it is a fact of history that women were assigned the poorer uppermost seats, a special late admittance time, and were specifically excluded from athletic contests. I personally believe that this exclusion was due to the fact that early Roman athletic contests were patterned after the Greek Games where the male contestants participated in the nude and I shall pass over this item without making another comment except to repeat - sorry gals.

Voters must comply with the instructions provided in the electoral package to complete and return the ballots, that must be mailed **promptly** using the pre-paid envelope provided, in order to ensure delivery to the Consular Office **no later** than 4:00 PM (local time), on June 9, 2022.

Voters who have not received their electoral package may request a duplicate to the Consular Office competent for the jurisdiction they reside in, starting from May 29, 2022. Later in the day the neighborhood children and their families celebrated with food, games, a Corn Maze, face painting, arts and crafts, and many other fun things to do.





L'Anno Bello: A Year in Italian Folklore

Jubilant June!

Ah, June! No other month brings as much joy to the heart of this school teacher. June is inextricably linked to summer in my mind. It means eightyplus degree days when I open every window, trying to catch a pleasant ruffle of a breeze. It is days spent walking by the seashore, inhaling the salty scent of the ocean and listening to the plaintive cries of the gulls. June means days of ice cream dripping down cones and strolls in the late-evening sunshine. Finally, June means the last school bell of the year, opening up a summer full of possibility and hope. Yes, I truly love June, and so did my ancestors over in Italy. After all, June in Italy boasts a number of holidays that revel in the summery nature and outdoorsy aspects of the month. In truth, June can be an overwhelming time to visit Italy, as that is when most of the tourists descend, combining crowds with hot temperatures. However, those who go outside of the well-beaten tourist path will greatly enjoy this beautiful month in Italy, especially because of one of these four traditional festivities.

Festa della Repubblica (June 2nd): In the simplest terms, one can think of la Festa della Repubblica, or "Feast of the Republic," as Italy's independence day, a rough equivalent to our Fourth of July. This feast honors the date in 1946 when, after the turmoil of World War II, Italians voted on creating a republic rather than a monarchy. Nearly everything — banks, stores, tourist sites, museums - is closed or operates on holiday hours. Instead, Italians celebrate by watching parades and attending outdoor parties or concerts. Expect to see the Italian tricolor flag, with its bright hues of red, white and green, adorning landmarks and waving from people's homes. La Festa della Repubblica appropriately occurs in the summer, when people can take advantage of the lovely weather to go outdoors and show their communal pride in being Italian.

Festival of San Ranieri (June 16th - 17th): The feast of St. Rainerius, or *San Ranieri* as he is known to Italians, encompasses two days of merriment in the Tuscan city of Pisa.



The eve of the feast day, Pisa celebrates its patron saint by lighting up the city's buildings with over 70,000 glass-encased candles. These lumini cast a warm, romantic glow against the meandering Arno River. A fireworks displays caps off the night's festivities. The next day, people gather to watch a regatta, or boat race. I find it interesting that this quaint and local holiday includes the two biggest hallmarks of solstice celebrations—fire and water—giving Italians cause to honor the sweet delights of midsummer.

Saint John's Day (June 24th): This is one of my favorite holidays. It commemorates St. John the Baptist, the major religious figure who baptized Jesus, though many traditions originated from the pre-Christian festivities celebrating the summer solstice. In Northern Europe, St. John's Day is known as Midsummer since it falls so close to the summer solstice. People celebrate with rites honoring the sun (the summer solstice) and water (St. John the Baptist): building maypoles, floating garlands of flowers down streams, lighting bonfires. In Italy, this is la Festa di San Giovanni Battista. In the Lake Como region, people float hundreds of delicate lanterns on the lake and later continue the theme of light by enjoying a fireworks display. Florentines celebrate with a medieval tournament, while also holding a procession of rowboats carrying candles drifting serenely along the Arno River. These festivals perfectly capture the magic of the longest night of the year, harnessing the power of the sun and honoring the life-giving qualities of water.

Feast of Saints Peter and Paul (June 29th): Rome celebrates the feast day of two of the most important figures of early Christianity with great fanfare. The commemoration of St. Peter and St. Paul, or San Pietro e San Paolo, includes a special Mass from St. Peter's Basilica in the Vatican (St. Peter was the first Pope). Many businesses in Rome are closed for the day as people admire elaborate flower carpets—a summer symbol outside St. Peter's Square. Like many summer holidays, the day ends with a fireworks display.

Of course, there are plenty of other ways to enjoy June in Italy. Lots of little festivals, known as sagre, dot the Italian landscape. These small holidays frequently devote their attention to a specific crop, and during the summer that can mean anything from peaches to strawberries to herbs. One of the best aspects of Italian holidays is that they connect to the rhythms of the Earth and encourage reflection in the present moment. So, no matter how you celebrate, make sure to give thanks for the wonderful month of June and all of the delights it offers!

As usual, the reaction to the latest mass shooting down in Texas from our elected officials is more of the same talk. Democrats immediately blame Republicans and Republicans return fire.

A young man bought two guns days after his 18th birthday and ended up carrying his two military-style weapons into an unlocked elementary school in the small town of Uvalde and opened fire killing 19 young children and two teachers before being taken down by law enforcement.

We apparently give lip service to this issue because the cost of addressing our dysfunctional mental health system is deemed far too expensive to fix. However, the longer we put off this national discussion, the toll of victims only grows greater. This is not a Democrat or Republican, or a liberal or conservative issue. All of us need to stop the nonsense. Mental health care is a national

Our elected officials for the most part are AWOL when it comes to gun violence in this country. It is time for real actions, real solutions, and less useless rhetoric to gain partisan support and raise campaign cash.

Finally, what about social media's role? These shooters are on social media with images of themselves with their firearms and commentary about killings. How does this go unnoticed by those who run platforms like Facebook, Twitter, etc.?

Saint William of Monte Virgine

Saint William of Monte Vergine is also known as Saint William of Vercelli. He was born in Vercelli, a city of Lombardy in the year 1085. He lost his father and mother in his infancy and was brought up by a very pious relative. At fifteen years of age, having an earnest desire to lead a penitential life and firmly believing God was calling him to a solitary life, William left his native region and made a long and austere pilgrimage to Santiago de Compostella to the shrine of the Virgin founded by Saint James.

He would have made a pilgrimage to Jerusalem but when he reached Southern, Italy, he was beaten up and robbed by thieves. William considered this misfortune a sign of God's will for him to stay in Southern Italy and spread the message of Christ. He firmly believed God was calling him to a solitary life, and he retired to



the kingdom of Naples. He went to live on the summit of Monte Virgine (then know as Monte Virgiliana) between Nola and Benevento, where he lived as a hermit and lived in perpetual contemplation.

He attracted a number of followers and founded the Monastery of Monte Virgine, which he headed. By 1119, his followers were united in the Benedictine congregation, the Hermits of Monte Vergine also known as (Williamite) which he headed. The austerity of his rule led to dissension among his

monks; to restore peace he left and was taken under the protection of Roger I of Naples who built a monastery for him in Salerno. William founded monasteries through out Naples, and died at the Guglielmo monastery near Nusco, Italy on June 25, 1142. The Feast Day of William of Monte Virgine is celebrated on June 25th.

A Nostalgic Remembrance



For over 20 years, I have taken part in a Memorial Day tradition. Needless to say, the full scope of it may not be operational this year, and we will still be in Florida. I belong to a retired military organization called The First Corps of Cadets, and each Memorial Day before Covid, we gathered at the Mt. Auburn Cemetery, place flowers at the base of our Civil War memorial, listen to a few works from our chaplain, a few words from our president and salute as a bugler plays taps. Following the ceremony, we head to a pub and enjoy a bit of liquid refreshment, a slice of pizza and the company of good friends.

I always enjoyed things military, and even had the nickname of "GI Joe" when I was in elementary and junior high school. I would head to the war surplus stores on Atlantic Ave. and buy things I could use as a cub scout and later, as a boy scout. If I combined what I bought with what Uncles Nick and Gino gave me after they were discharged from the Navy and Army Air Corps, respectively, I might say that I had quite a collection of military memorabilia. I have to add in things that Dad let me borrow. During the day, he was a member of the Department of Audio-Visual Education of the Boston Public Schools, and after WWII, he was given a lot of war surplus hardware, tank radios, telescopes, binoculars, sextants, bomb sights, etc ... and I loved using them to play soldier.

Babbononno was proud, because, as a young man, had been a member of the Royal Italian Marines, and he was prouder still that two out of three of his sons had fought for his adopted country in WWII, and also that he and his son-inlaw (Dad) were chosen to interrogate Italian war prisoners that were housed in the old forts and buildings located on Boston Harbor islands. He knew that he and Dad had been doing something right, as after Italy surrendered to the allies and switched sides, the prisoners were free to go home, and many didn't. They wanted to stay in Boston, and Babbononno and Dad helped them find employment and living accommodations.

When Babbononno saw that I loved things military, he thought I might head in that direction once I was out of school. He was so proud of the first time I stood in front of him standing at attention with my army uniform neatly pressed. I had joined the Joseph H. Barnes Drum

and Bugle Corps, and marched with them as a bugler. Later, at English High School, I marched with a rifle over my shoulder. Unfortunately, everything I tried to get involved in militarily after high school, didn't pan out.

When I began college, I took the exams to become a member of something called PLC, standing for Platoon Leader Class. It was similar to the ROTC offered at some colleges and I was interested in flying for the marines. I figured that, if Ted Williams could fly for the marines, so could I. I washed out because, when I flew, if we went into a dive, my nose would hemorrhage. After examining my nose, a navy physician told me that it had been broken several times and the change in air pressure on my nose caused the problem. I was then told that I could be a mud marine, which meant I would be in the infantry carrying a rifle. I was only seventeen, and Dad had signed for me to join the PLC. When I told him I could be a mud marine, he ripped up the papers and I was a civilian again.

Babbononno was sad that his first born grandson was not going to be the 3rd generation in a row to serve in the military, but a few years later, I was recruited by the CIA to become part of an invasion group heading to free Cuba. I spoke Spanish, could pass for Cuban and could have been part of a reconnaissance group that led the way. But, they threw me out when I commented on a couple of things I thought they were doing wrong. I was familiar with the Cuban dialect of Spanish and the Cuban culture, and when the leaders gave us instructions on what to say to partisans when we landed, I commented on the CIA usage of European Spanish pronunciations rather than Cuban. I was chastised and actually thrown out. Again, Babbononno was unhappy. I knew that Mom was saying a Novena behind my back, and what she asked for must have worked, I was a civilian again.

I headed back to the East Boston Draft Board, which in those days, was housed underneath the library on Meridian Street. I knew that I would have to be reclassified as 1A and be eligible for the army, which in the early '60s, was the only military organization involved in the draft. When I told the head of the draft board that I was teaching drafting and engineering subjects, she told me that they were classified as sciences, and as a result, I would be reclassified 2A, and receive a deferment. It seems that after

the USSR sent Sputnik, into space, we had a lot of catching up to do, and anyone teaching a science would be deferred. As a result, I never made it into the military. By the time the war in Vietnam was in full swing, I was a bit too old for military service. I lost a lot of friends and many students who headed for south-east Asia and never made it back home. I felt guilty that I had not participated, and still feel strange when some of my friends talk about their exploits in that war.

When I talk about my attempts at flying for the marines, I add in that someone up there (and I point to the sky) must have been watching over me, because of all of the friends I would have flown with who went to Vietnam, none of them survived. So, when Dean Saluti, John Silva and the late Bill Hurley spoke to me about joining the First Corps of Cadets, I didn't hesitate to join. It today, represents the older generation and includes men and women who have served from WWII to the present. Our active component is the 211th Military Police, a unit that has served in Afghanistan in recent

When we meet, our uniform is a navy blue blazer with the organizational emblem on the breast pocket, gray slacks and a blue and white striped regimental tie. Of course, my shoes are always spit-shined thanks to Babbononno's early training on how to shine shoes.

On Memorial Day, I brought up a picture of the American flag on my computer, saluted it and said a silent prayer for those that I knew back in the day who never made it home. I guess my family was very lucky. from Babbononno's day to the present, every one of my relatives who was in the military, regardless of which war it was, made it home in one piece. At this point in time, I sit on my Florida patio, unable to help out with what's going on between Russian and Ukraine, the latest clash on the planet. But, I can't complain. My family is all OK; my closest friends at home and down here are all OK.

I guess we're the ones who are blessed.

A Crostata is an Italian dessert you'll usually find made with a short crust or pasta frolla that can be converted into various different tarts. In the pastaccieras in Italy, these delicious tarts are found filled with jams, custards, ricotta, and chocolate, as well as apples, peaches or other seasonal fruits. I cannot begin to name all of the amazing crostatas my Nonna has made. However, I can tell you that regardless of the flavor, one was always more delicious than the other! Nonna usually made them based on the ingredients she had available as well as what fruits were in season. During the warmer months, using a pasta frolla crust, custard filling and fresh seasonal fruit, she would make her traditional "Italian Fruit Tart" or "Crostata di Frutta". She also made an "Americanized" version of this that used a graham cracker crust, sweet cream cheese filling and fresh strawberries, blueberries, or whatever other seasonal fruit she had on hand. This "Easy Italian Fruit Tart" or "Facile Crostata di Frutta Italiana" is a dessert that is quick and simple to make and was always enjoyed by everyone that tasted it. It's an absolutely perfect dessert that I am positive your friends and family are going to love!

Graham Cracker Crust 2 cups graham crackers, finely ground

1/3 cup granulated sugar 10 tablespoons butter, melted

Grease a 8 to 9-inch tart pan or pie plate, set aside. Preheat the oven to 350°.

In a small bowl, add graham cracker crumbs, sugar, and melted butter; mix together well.

Pour crumb mixture into the prepared pan and using the back of a spoon, press firmly in the bottom and about an inch and a half to two inches up the sides of the pan.

Bake for 10 minutes (just to set the mixture) and cool.

***Note: This crust can be made without baking by making it a day ahead and refrigerating overnight to set.

Filling and Fruit Topping

cheese, softened ½ cup whipping cream 1/3 cup confectioners' sugar 1 teaspoon pure vanilla extract ½ organic lemon, zested and iuiced

- 3 cups of fresh fruit, washed blueberries, grapes, kiwis, pineapples, bananas, any preference or combination is fine)
- 4 tablespoons of apricot or strawberry jam

In a large bowl, add the softened cream cheese, confectioners' sugar, vanilla and lemon zest and juice. Beat on a low speed until creamy, set aside.

In a medium mixing bowl, beat the whipping cream until soft peaks form. Using a spatula, gently fold this into the cream cheese

Spread this mixture into the prepared graham cracker crust and set aside.

Slice the fresh fruit (I used fresh sliced strawberries) and place into a medium sized bowl, set aside.

In a small saucepan, warm the jam until it liquefies (do not make it to hot). Cool slightly and add this to the bowl of fresh fruit and toss together well. Gently spoon the fruit mixture on top of the filling and refrigerate 4 hours before serving.

Refrigerate leftovers.

Saving the Green Monster

Were it not for it Hollywood, the Perfect Storm of 1991, that shook the New England and Canadian coastlines, would have become a faded memory. And yet, on October 27th of that year, the "Halloween Storm" was making waves.

Hurricane Grace had just formed over Bermuda and began its track northwards. Waves, some as tall as 60 feet, were causing damage and coastal flooding from Newfoundland to Jamaica. By Halloween the storm had transitioned into a hurricane and began making its way into the interior, wreaking havoc on Nova Scotia.

Caught in this storm was the 72-foot fishing vessel Andrea Gail and its crew of six fishermen. The Andrea Gail had left Gloucester Harbor on September 20th heading for the Grand Banks of Newfoundland in search of swordfish. On October 26th, Captain Frank W. "Billy" Tyne Jr., turned the vessel homeward.

The last radio transmissions from the Andrea Gail came



on the evening of the 28^{th} , when Tyne said, "She's comin' on, boys, and she's comin' on strong."

On the 30th the vessel was reported overdue. Both the United States and Canadian Coast Guard, along with the New York Air National Guard launched an air and land rescue mission but nothing was found of the ship or its crew.

On November 6th, the boat's emergency position-indicating radio beacon was discovered washed ashore on Sable Island. Nonetheless, the search was called off on the 9th when the Andrea Gail and its crew were declared lost at sea.

for the United States Senate? Why do you go through all the hassle of getting this job, of putting yourself in a position of authority, if your answer is that as the slaughter increases, as our kids run for their lives, we do nothing. What are we doing? Why are you here if not to solve a problem as existential as this? This isn't inevitable. These kids weren't unlucky. This only happens in this country. And nowhere else. Nowhere else do little kids go to school, thinking that they might be shot that day. Nowhere else do parents have to talk to their kids as I have had to do about why they got locked into a bathroom and told to be quiet for five minutes just in case a bad man entered that building. Nowhere else does that happen except here in the United States of America. And it is a choice. It is our choice to let it continue . . .

"What are we doing? Why are we here? What are we doing?"

What are we doing? Politicians who immediately say things like "now is not the time to politicize this" almost inevitably actually mean "it will never be the time." Too many of these leaders have no intention of taking any steps to prevent this. They do not want to act. They are not going to stand up to the gun lobby. They are not willing to protect children instead of guns.

Texas Senator Ted Cruz joined former President Donald Trump among the featured speakers for the National Rifle Association (NRA)'s national convention in Houston on May 27th. Texas Governor Greg Abbott did not attend the convention, but did provide a pre-recorded message. In 2015, Governor Abbott said on Twitter: "I'm EMBARRASSED: TEXAS #2 in nation for new gun purchases, behind CALIFORNIA. Let's pick up the pace Texans." Following the mass shootings at a Texas church in 2017, a Texas high school in 2018, and the back-toback mass shootings in El Paso and the Midland-Odessa area in

August 2019, Texas lawmakers responded by making it easier rather than harder to buy and carry guns in their state. Texas has now been the site of four of the nation's ten deadliest mass shootings, including the deadliest mass shooting at a place of worship, the deadliest mass shooting at a military institution, and, after the murders of these 19 children and their teachers, the second deadliest school shooting. Does this make Governor Abbott proud? Or will this shooting finally be enough to lead some of our elected politicians to new choices?


Gun violence is now the leading cause of death for children and teens in our nation. A child or teen is killed with a gun every two hours in America. More preschoolers under 5 are killed with guns than police officers in the line of duty each year. In a nation where nearly all voters support common sense gun safety legislation like universal background checks and two-thirds of voters support a nationwide ban on the sale of assault weapons, it doesn't have to be this way.

What are we doing?

O God, forgive our rich nation where toddlers and school children die from guns sold quite legally.

O God, help us never to confuse what is quite legal with what is just and right in Your sight.

Orel broke the previous record by 1/3 of an inning over fellow Dodgers star Don Drysdale who held the previous record set in 1968.

Personally, I am not that excited about Hader's 35 innings thus far in 37 games. Hershiser and Drysdale did it in consecutive starts. That means much more to me.





HOOPS and HOCKEY in the HUB

CELTICS -- WARRIORS LAST TIME — It was 58 years ago (the spring of 1964) that the Celtics and the Warriors last met in the NBA Finals. The Warriors were only two years removed from their original franchise city (Philadelphia). At the time, they were named the San Francisco Warriors, not the Golden State Warriors.

In the Finals it would be a battle between the NBA's two big men of the era — Bill Russell of the Celtics and Wilt Chamberlain of the Warriors. Bob Cousy had retired but John Havlicek was filling in nicely while playing with Russell, Sam Jones and Tom Heinsohn. Indeed, Havlicek averaged 20 points a game during the regular season while coming off the bench.

It was a season when the Celtics dominated the Eastern Division. The C's had started the campaign with a seven-game winning streak and celebrated Christmas as the owners of a 23-4 record. They finished at 59-21 with an excellent .739 winning percentage.

The first two games were at Boston Garden and the C's quickly jumped out to a 2-0 lead in the series, winning the first game 108-96 and taking the second, 124-101. Jones and Havlicek had both hit for 25 points in the first game while Russell had grabbed 25 rebounds. Jones led the C's in the second game with 31 tallies while Russell captured 24 rebounds.

On the San Francisco side, Chamberlain was dominant getting 22 points and 23 rebounds in the series opener and then adding 32 points and 24 rebounds in game two.

Game three was the only one of the series that the Celtics lost as the Warriors came away with a 116-91 victory on the West Coast. Havlicek had 22 points to pace the Celtics while Russell had 32 rebounds. Chamberlain continued to be the whole story for the Warriors (35 points and 25 rebounds).

The important fourth game, which would determine whether the series would be tied at 2-2 or whether the Celtics would claim a commanding 3-1 lead, was close but Boston came away with a 98-95 victory. Heinsohn had 23 points and Jones contributed 23 while Russell had 19 boards. Chamberlain had 27 points and 38 rebounds.

The series shifted back to the Garden for the fifth game, a contest that resulted in a 108-99 victory for the Celtics as they claimed their sixth consecutive (and seventh overall) NBA Championship.

Heinsohn led the way with 19 points while Jones and Frank Ramsey each had 18. Russell had 14 points to go with his 26 rebounds. Chamberlain had 30 points and 27 rebounds to lead the Warriors.

In sum, the series was won by a Celtics team that featured balanced scoring across its roster as opposed to San Francisco that was led by a single dominant player.

COUSY CLASHES WITH COM-MENTATOR'S COMMENTS

— He may be 93 years old but former Celtics star Bob Cousy can still hold his own in the court of public opinion.

The comments that got a rise out of Cousy came from ESPN commentator J.J. Redick, who played for seven franchises during his career.

Recently, while on one of the network's shows, Redick took a shot at not only Cousy but all the players from "the pre-1980 era of the NBA," particularly the earlier decades of that era.

Some items he mentioned the players had no control over: early on the NBA was indeed an eight-team league and thus the playoffs were shorter, consisting of two rounds in the early years.

But you can say that about any of the four major pro sports. Once the MLB postseason consisted solely of the best-of seven-World Series in an era when there were just 16 teams. In hockey, there was the Original Six era with much shorter seasons and playoffs. Before the Super Bowl era the NFL championship game was played in December.

No one today would look down upon Montreal's Maurice Richard or the B's beloved Johnny Bucyk for playing in an earlier era. No one would think less of Babe Ruth or Lou Gehrig because they played baseball in the 1920s and the 1930s.

To be fair, Redick did say that Cousy should be celebrated. But a few sentences later came this response when host Chris Russo noted that Cousy had 29 assists in an NBA game. "Well, said Redick, "he was guarded by plumbers and firemen."

That represents a failure to recognize the economics of that era. Back then, a number of players may have worked in the offseason to supplement their incomes.

Eventually, the Cooz responded on SiriusXM NBA Radio, not really for himself, but on behalf of the players he competed with and against in his era — many of whom are deceased.

"People with less talent will always try to make a name for themselves by criticizing other people and hopefully getting some attention and perhaps increasing their credibility," said the all-star point guard. "So when you respond to something like this, you play into their hands. I won't do that."

But he did go on to offer another point of view in defense of the players from that earlier era.

"I will defend the firemen and the plumbers that he mentioned," he began, "and I'll give you just a few of the names of these firemen that I played with and against during those years."

Cousy went on to make his points: "How about Bill Russell. Not too bad a player. Wilt Chamberlain. Remember that guy. He wasn't bad." He noted that Elgin Baylor is "still the best small forward, in my judgment, that ever played the game."

The Cooz recalled "Oscar Robertson who was, pound for pound, the best player in the game. And Jerry West, he wasn't too shabby." He also listed George Mikan and Bob Pettit plus fellow Celtics teammates Sam Jones, K.C, Jones, John Havlicek, Tom Heinsohn and Frank Ramsey.

"I could go on and on," he said
"We must have had the best firemen and plumbers on the planet
at the time. And I was very proud
to play with all of them."
