D-Day Exhibit at Museum of World War II in Natick

On June 6, 1944, 160,000 Allied troops landed along a 50-mile stretch of heavilyfortified French coastline to fight Nazi Germany on the beaches of Normandy, France. General Dwight D. Eisenhower called the operation a crusade in which "we will accept nothing less than full victory." More than 5,000 Ships and 13,000 aircraft supported the D-Day invasion, and by day's end on June 6, the Allies gained a foothold in Normandy. The D-Day cost was high more than 9,000 Allied Soldiers were killed or wounded — but more than 100,000 Soldiers began the march across Europe to defeat Hitler.

No description, whether in print, spoken word, live theatre, or teleplay, can fully convey what it was like to be a young soldier perhaps just 19 years old — weighed down with 75 pounds of gear, sea-sick and soaked from the amphibious landing, crossing a land-mined strewn beach to walk into German gunfire 70 years ago today, in the invasion of Normandy.

Each year, as we commemorate D-Day fewer and fewer of the participants are with us. The youngest D-Day veterans are about 90 years old. In a few more years the battles of World War II will, like the battles of earlier wars, be the subject only of history, not living memory. When that day comes, the closest we'll be able to get to the experience of the Normandy invasion will be by examining the artifacts

and primary source documents.

We are fortunate here in Boston that one of the best places in the world to learn about that great conflict is at the Museum of World War II in Natick. Through August 30th the museum is featuring a special 70th Anniversary of D-Day exhibit.

Their D-Day collections are only rivaled, in artifacts, by the Bayeux Museum in Normandy. They have the only known complete original set of the D-Day invasion plans along with thousands of other archival documents, photographs, plans and maps. A substantial part of the holdings are from the original Omaha Beach Museum in Villeneuve, France, which sold its collection to the Natick museum in 1994, after the 50th anniversary of D-Day. All of the artifacts in the special exhibit — including uniforms, parachutes, weapons, and much more — were used on the day of the D-Day invasion.

Visiting the museum is a unique experience. In addition to being the most comprehensive collection of original World War II artifacts anywhere in the world, the exhibition — nearly 7,000 pieces — integrates the human, political and military stories. It is an intense experience made more so by the fact most artifacts are not behind or under glass. Most can be touched.

Rising Medicaid Costs Concern States

From California to Maine, states are being confronted by their Medicaid costs rising as a result of Obamacare provisions.

The debate is on over what can be done about federal law that saddles states with unanticipated expenses. Before President Obama's Affordable Health Care Act expanded Medicaid eligibility, millions who were entitled were not enrolled. These folks are now signing up in huge numbers somewhat because of the publicity surrounding the safety net's expansion by Obama.

Red states and Blue states must now use more of their own money to cover this group. In California, Gov. Jerry Brown's state budget projects an additional \$1.2 billion in spending on MediCal, the Golden State's version of Medicaid. More than 300,000 enrolled, much more than the state had expected to sign up.


Stirpe Nostra

MARTIAL



An epigram can be defined as a short poem with a witty point or ending. The term "epigram" was no doubt derived from the Latin "epigramma," which in turn means inscription or short poem. During ancient times these were carved on a tomb or tombstone, and put into some kind of rhyme or meter. The greatest master of epigrams was the Greek writer Simonides of Ceos. He was the author of many inscriptions that were placed on the tombs of the soldiers who perished in the Persian Wars. The epigram was also a favorite form of expression in all later ages. One collection of early Greek poems and stories shows at least 4,500 epigrams which were written by more than 300 poets. It is quite evident then, that the epigram was no frivolous or passing fad, and from the Greek writers, the style passed on to the Romans.

Our scholarly Roman for this week is probably the most famous of all Latin epigrammatists. His full name was Marcus Valerius Martialis, and history now refers to him as just plan Martial. He was born in Spain and then moved to Rome in 65 A.D. where he resided for about thirty-five years. He earned a living as a professional poet, writing verses that were commissioned by wealthy patrons, and was also high in the favor of Emperors Titus and Domitian. He prepared a book of spectacles in their honor called "Liber Spectaculorum" which celebrates the opening of the Coliseum in the year 80 A.D.

The inauguration lasted for one hundred days, during which time five thousand animals and many gladiators were killed, therefore the term "spectacle" is not improper.

The extant (still existing) works of Martial include:

(a) 1,500 epigrams in 14 books. These are called "Epigrammata".

(b) "Liber Spectaculorum" as noted above, which totaled 33 epigrams in a single book.

The epigrams of Martial are distinguished by his great imagination, wit, and the pleasantness of his style. His work also furnishes a great source of information on national customs, morals, manners, and daily life in Roman society during the first century of the empire.

Tales of Olde

Delivers at Great Scott

Vocalist, Evelyn Cortazio, smiles, closes her eyes, and starts swaying from side to side as the music begins to play. Her husband, Lucas Cortazio is singing and playing the guitar next to her. This particular song, he explained to the audience, is sad. The atmosphere at Great Scott, the venue where they're playing, subtly changes and the crowd which a few minutes ago was dancing enthusiastically is now mostly nodding their heads and tapping their feet along to the beat. Evelyn opens her eyes and joins her husband, interweaving a higher register with his. Next to Lucas, Ellen Story's wrist shakes lightly on the strings of her fiddle, her gaze immersed on the cords as her other hand is busy with the bow. Drew Story, Ellen's husband, is right behind her playing the electric guitar. Sitting in the center is Al Cleveland, keeping rhythm with the drums and a wide smile that has been glued to his face ever since the show started, while Jeff Kinsey slowly strums the bass.

They are Tales of Olde, a local "indie rock/folk" band that is rapidly becoming more well known as they play in multiple stages around the city. It all started in 2011 when the Storys met the Cortazios at their church, Reunion Christian Church. The played shows in their church for two years before Kinsey and Cleveland tagged along adding to their already diverse musical spectrum. Thus, they came up with the name "Tales of Olde" which is what their music is all about, "the stories that happen all around us," said Cortazio. In keeping with this is their new EP which has just been released. Cortazio explained it's a very personal compilation in which the band explores relationships, he said his own marriage inspired a lot of the songs, "relationships shape who we are," he said.

All the members of the band contribute something different; four of them attended Berklee College of Music which is why they came to Boston in the first place. The Cortazios are originally from Brazil, but have been in Boston since 1998. Kinsey is from California, Cleveland is from Chicago, Drew is from Texas, and Ellen is from Tennessee. This is apparent in their music which makes for an original blend. "We all come from different backgrounds, but we kind of appreciate similar stuff. I'm really into indie pop and rock stuff and I know you're more the folk side [points to Lucas] like when we started, at least, Lucas was really into Mumford and Sons and that kind of stuff," said Kinsey. "That's changed," interjects Cortazio. "Our style has definitely changed since then, but he was into that; our drummer is kind of like his favorite style metal and hard rock so he likes different stuff," Kinsey explained. Meanwhile the

L'Anno Bello: A Year in Italian Folklore

Reclaiming My Roots, One Holiday at a Time

This Sunday, the 8th of assimilate into the cool and historical origins of the June, many Italians will spend the day outdoors celebrating the important Christian feast of Pentecost. Pentecost, which occurs on the seventh Sunday after Easter, honors the descent of the Holy Spirit upon Jesus's disciples and marks the close of the Easter festivities. The fifty-day Easter period is traditionally a time for reveling in the beauty and regrowth of nature, and Pentecost encompasses many of these customs. In England, Pentecost is known as Whitsunday, a day which hosts Whitsun Ales, or outdoor fairs that include folk dancing, parades, feasts, decorations of flowers and garlands, and charitable contributions to the local parish and less fortunate families. In Italy, people refer to Pentecost as Pasqua Rossa, or Red Easter, named after the red vestments worn by priests on this day. Many Italian churches commemorate this holy occasion by scattering rose petals upon the congregation, symbolizing the descent of the Holy Spirit upon the disciples and incorporating the lovely flowers which bloom so brightly during the spring and summer into the celebration. This holiday reminds me that Easter time in Italy abounds with beautiful traditions that blend spirituality, community and the love of nature, creating unique customs that define the Italian culture and lingering like a pleasant memory in all those who experience it.

Indeed, it is the very study of these holidays and all their rich symbolism that made me appreciate my Italian roots more. Though I now blush with embarrassment about this, I used to attempt to downplay my Italian heritage, squashing it in the back of my pocket like a mediocre test grade. As a young child, trying to crowd of school the way all young children are wont to do, my Italian-ness represented the other, the strange. No one else I knew opened their presents on Christmas Eve — I received a lot of puzzled looks whenever I explained that by midnight, all the presents were unwrapped and I was sitting around the Christmas tree with my family. No one else had the odd little inflections in their voices like the one that developed in mine after speaking so much Italian at home. However, as I got older, I realized how foolish I had been, and that most people thought my Italian customs were fascinating. I largely have my parents to thank for this momentous shift, as they always related the importance and deep significance of our Italian traditions to me. Because of them, I learned how truly complex Italian culture is, and more importantly, that it is not monolithic — every region of Italy has its own unique foods, customs, celebrations and even languages. I had a whole big heritage to explore! Now, I am immensely proud of my Italian roots, recognizing the history and practices of the home country and the sacrifices of my ancestors. I want to give my future children the same sort of tradition-based childhood I had, and my husband and I are on the same page about exposing our children to the symbolic and significant customs of their Italian heritage, as well as the French and Eastern European roots on their father's side.

Exploring holidays has also gone a long way in helping me appreciate my Italian self. The very customs I once viewed as so alien now resonate with a profound meaning. Italian holiday traditions developed as ways to commemorate and remember the spiritual, folkloristic

celebrations, and each custom, particularly those relating to food, remains laden with weighty symbolism. The seafood-based Christmas Eve dinner, la Vigilia, hearkens back to the days when Advent was considered a fast period in preparation for the birth of Jesus. The fried strips of dough coated with powdered sugar that appear in Italian shops around the Carnival season reflect the creative ways Italians used up their butter and oil before the austerity of Lent. Big chocolate eggs, an Italian Easter staple, serve as a metaphor for the regrowth of nature during the springtime. The spice cookies eaten on All Souls' Day, known not-so-delicately as the Bones of the Dead, reminded Italians of the transience of life, a lesson well-known to many in harsh historical epochs like the Middle Ages. Whenever people ask about my Italian holiday customs now, I no longer mumble my answer and look away but explain their history with pride. Similarly, I love to research the holiday traditions of cultures all around the world because they too brim with beautiful practices and symbolic importance. Writing this column has taught me not only to take heart in my own heritage but also to appreciate the diversity of our Earth. Though we live in a fast-paced, modernized world, being aware of our roots and our traditions will always keep the past and the wisdom of our ancestors in our

So when Italians celebrate the special and significant holiday of Pentecost this Sunday, they are continuing the time-honored practice of imbuing holidays with the love of community and rich symbolism that highlights their importance. Studying these very holidays has not only bequeathed me a powerful tapestry of traditions and customs, but it has also shown me the beauty of honoring your heritage, no matter what it is, for it is an indelible part of who we are as people. Whenever you are celebrating a holiday, a rite of passage, or even a family dinner, pay attention to why you are doing what you are doing. As you commemorate these traditions, remember that your ancestors once were going through similar motions, becoming part of the ever-changing, always enduring dance of time.



Saint Robert of Newminster

Saint Robert was born at Gargrave, Yorkshire, England in the year, 1100. He was a serious child not interested in the usual amusements of that age but preferred spending time in prayer, reading and useful employment. Robert studied at the University of Paris and was ordained priest serving as a parish priest at Gargrave. Later he joined the Benedictine monastery of Our Lady in York.

In time, desiring to live a more ascetic life, Richard, Prior of the Abbey and 12 others that included Robert, with the permission of the Abbot, left the Abbey to establish a community of their own. It was only after extreme hardship that Thurstan, Archbishop of York, gave them property in the town of Sutton where they founded the celebrated Abbey of Fountains (named for the many natural springs in its area) which in 1132 was received into the Cistercian Order. The Abbey, as a result of the religious fervor of its monks, quickly became a model for the Order.

Ranulph of Merley, baron of Morpeth, visited Fountains, struck by the piety of the monks and desiring to have a monastery in his region, obtained from their abbot Richard, several of their members who, in 1138, with Robert appointed as their abbot, founded the monastery of Newminster at Morpeth, Nortumberland, which became a place of pilgrimage.

As abbot, Robert founded several new monasteries at Pipewell (1143) Roche (1147) and Sawley(1148) and provided in his person, a fine example leading his monks to sanctity. He recited the entire Psalter of 150 psalms daily and ate sparingly to maintain his spirit of selfdenial. Saint Robert was a close friend of the holy hermit Saint Godric and often visited him in his hermitage at Finchale. Robert was in correspondence with the great Saint Bernard, founder of the Cistercians. Robert passed away on June 7, 1159. Saint Robert's Feast Day is celebrated on June 7th.

PASTA CON BROCCOLI

10 ounces cut-up broccoli — frozen or fresh

6 cups water

- 2 tablespoons olive, canola, or vegetable oil
- 2 tablespoons butter or margarine (optional)
- 1 cup cut up spaghetti *or short pasta of choice 2 small minced garlic cloves (optional) Salt to taste
- *Break up spaghetti or thin spaghetti into two-inch

Bring six cups of water to a boil in a saucepan. Add cut-up broccoli to saucepan, cover and cook at a slow boil for about five minutes. Add cut up spaghetti or pasta of choice to broccoli. Stir and cook until pasta is to your liking. *Add oil, butter or margarine, and salt to taste. Stir and continue to cook for a few seconds before removing from burner.

*Variation: Place oil in a small bowl. Add two small minced garlic cloves to oil. Stir and add to broccoli/pasta mixture. Place saucepan on burner, bring to a boil and then remove from burner. Salt to taste. Serves two.

NOTE: When Mama was needed in the bakery, she prepared this simple meal on a two-burner gas unit that Papa had installed in a back room of the bakery. Those evenings, we ate on a makeshift table created by turning over one of the $3' \times 6'$ wooden bread boxes that my brother Peter or Papa rested on a few milk crates or wooden horses. We had family discussions during the meal just as we did in our apartment. Papa insisted on the family having our meals together.

Meat did not have to be served for supper when Mama prepared pasta with broccoli because our family preferred having a second helping of pasta in place of meat.





History of the Italian National Soccer Team — Part II

By 1974, the Italians were a collection of experienced veterans and promising young players. The team was celebrated as a favorite to win the tournament being held in West Germany in large part to victories over England and Brazil in friendly

However, the team will be remembered as an unequivocal failure. Dino Zoff, the Italian goalkeeper saw his international goalless streak broken by Haiti and ultimately their tournament ended in the first round, leaving many to wonder if the 1970 Mexican expedition had been a fluke. Searching for an answer to this question, the Italian federation turned to coach Enzo Bearzot to lead the team.

The 1978 World Cup was hosted by Argentina, which at the time was in the midst of a tumultuous military dictatorship led by General Jorge Rafael Videla. During the period between 1976 and 1983, somewhere between 10,000-30,000 citizens "disappeared" at the hands of the Argentine military. Despite calls for FIFA to withdraw the tournament from the South American country, the tournament went on as planned. For Italy it would be the coming out party for a new breed of Italian footballers, Marco Tardelli, Antonio Cabrini and Paolo Rossi. Three straight wins to start the tournament, one of which was a defeat of the host nation, had Italy on the path to greatness. The Second round was divided into 2 groups, consisting of four teams each. In the final group game to determine who would advance to the final, the Netherlands defeated Italy 2-1. The Italians settled for a fourth place finish in a tournament they could have

Spain was awarded the 12th World Cup tournament in 1982. The moment had arrived for the Azzurri to go from being a promising team to Champions. Following three ties in the group stage, not much was expected. Further prognostications of doom came when the team was pitted in the "group of death" with defending champion Argentina and a Brazilian side considered one of, if not the greatest squad ever assembled. With negativity mounting around the team, the Italians began a boycott of the media. In their first game, Italy defeated Diego Maradona's Argentina 2-1. However, following Brazil's 3-1 domination of Argentina, Italy would have to defeat the Brazilians or go home based on goal differential. In a game considered to be one of the greatest in Cup history, Italy twice took the lead on Paolo Rossi goals only to have Brazil level. With 16 minutes to play, Brazil was on its way to the semi-finals until a poor clear of a corner put the ball at the magical feet of Rossi who completed his hat trick and sent Brazil home. In the semi-final, Italy defeated Poland and now was one match from greatness. In the final versus West Germany, Italy missed a first half penalty kick (a sign of future cup disappointments?) but in the second half would not be denied, scoring three times before West Germany got a consolation goal with seven minutes to play. After 44 years, Italy was once again Champion of the world.

The magic of 1982 never arrived in Mexico four years later as they lost to France in the Argentina and Spain cup teams remained,

but the national team was in flux. A new generation was coming to the forefront and their presence would lead Italy to a third place finish in the 1990 Cup hosted by Italy, a second place in USA 1994 and a quarterfinal knockout to host France in 1998. In 1990, they were eliminated by Argentina on penalty kicks. The team had not allowed a goal in their first five matches and looked destined to continue that streak before a miscalculation by goalkeeper Walter Zenga allowed the Argentines to tie the semi-final match. In 1994, led by Roberto Baggio, the team reached the final at the Rose Bowl. After a dull 120 minutes, Italy and Brazil were deadlocked at 0-0. The game would be the first final decided by penalties. Trailing 3-2 in the shootout, Baggio sent his penalty errantly over the crossbar and Brazil was Champion.

The 1998 squad reached the quarterfinals before once again coming undone in the shootout, losing to the eventual champion France.

The 2002 tournament will be remembered for poor officiating, which ultimately had a hand in Italy's 2-1 golden-goal defeat versus co-host South Korea.

In Germany 2006, Italy was not given much of a chance mainly due to the matchfixing scandal that had erupted in Series A, the top domestic league in the country. Defending champion Brazil was the prohibitive favorite to add to their five titles. Thanks to the steady leadership of coach Marcello Lippi and captain Fabio Cannavaro, Italy methodically advanced from group play and survived a nail biter with Australia winning in the 90th minute on Francesco Totti's penalty kick. After dispatching Ukraine, the team faced host Germany in an epic semi-final match bringing back memories of 1970 in Mexico. With a minute left in overtime and penalties a near certainty, defender Fabio Grosso scored, shocking the hosts. A minute later, Alessandro DelPiero officially ended any German chance with a goal of his own. In the final, Italy faced France in their all-time great Zinedine Zidane's last game. Italy fell behind 1-0 after a controversial 7th minute penalty kick. Italy tied the match on a Marco Materazzi header off a perfectly placed corner by midfielder Andrea Pirlo. The game remained level after two overtime periods and would be settled on penalties, the Italian shootout curse would either continue or be lifted. Up 4-3, Fabio Grosso calmly put his shot in the back of the French goal giving Italy its fourth Cup

Similar to the Cup winning hangover experienced in 1986, the 2010 South African campaign never started as Italy failed to advance out of the first round.

The Italian National Soccer team, which has proudly delivered four World Cup tournament titles in 1934, 1938, 1982 and 2006, will contend in 2014. Anything short of a title will disappoint many fans, however the future continues to look promising for the



equipment has changed quite work I see. I believe the reaa bit. Gloves used to be stuffed with horse hair and now are filled with foam. A medicine ball used to be used as a tool for working on particular punches when teaching a boxer. Yes, its only use wasn't to bounce it off a fighter's stomach in the hopes of somehow toughening up his stomach muscles. I always thought by using that train of thought they should take a hammer and hit them on the jaw to better enable them to take a head punch. The silly punch pads have now replaced the medicine ball. The only purpose for these pads I can see is to give the impression some of these trainers - in name only — are actually doing something. I guess they missed out on playing patty cake when they were kids.

There have been many other changes as well, but the one that has had the most impact on the sport has been the evolution of the boxing shoe. For most of boxing history the shoes had smooth leather soles. Boxers would take a pair of scissors and rough up the bottoms of the shoes by scratching them with the scissors, and then, before getting into the ring, would step into a rosin box and rub the shoes in the rosin to give them a little bit and the sides of the shoes also of traction. They have way too much grip and make many of the important moves needed to be a good boxer very difficult, if not impossible to execute. Pivoting to the side, turning on the toes in order to get the hip into the punch, sliding smoothly side to side are very difficult to do when the shoes have the equivalent of chewing gum stuck to the bottom of them.

Watch Ray Robinson or Muhammad Ali as they glide around the ring. Now try to imagine them doing that with shoes that adhere to the canvas. In the gym I have seen boxers trying to do some of the classic moves with these new shoes. They hurt their ankles do not work with the rubbersoled shoes. 

Giving the boxers shoes that prevent them from being able to move smoothly, couple this with pad work that teaches them to punch only from the waist up and while using very little mobility, downplay the use of the jab, feints, and slipping punches, and you end up with two fighters just standing in front of each other tossing head shots. So many of today's matches are just copies of each other. You don't see the uniqueness of an Archie Moore or a Harold Johnson plying their art in the squared circle, or the beautiful movements of a Gaspar Ortega.

I don't blame today's gifted athletes who train hard and listen to what they are A great part of this lack of told, but with the shoes they are made to wear and the instruction they are given, it is impossible to know what to do in there.
