R.I. Health Insurers Seek Premium Hikes

Reportedly, health insurers down in Rhode Island are seeking double-digit increases in premiums that individuals and small businesses will pay for coverage next year, the largest reported increase in many years. It is all due as the federal health care law takes full effect. Obamacare is here and the bad news is just beginning. Blue Cross Blue Shield of Rhode Island, the largest state insurer wants an 18 percent hike for individuals and is seeking almost 15 percent from small business owners. MassDOT Kicks Off Plans to REVOLUTIONIZE TOLL COLLECTION

Cash Toll Collection to End on Tobin in 2014; Public Information Meetings Beginning



The Massachusetts Department of Transportation (MassDOT) announced plans are underway for the implementation of All Electronic Tolling (AET) on the Tobin Bridge, a form of toll collection that saves drivers from both stopping and slowing down to pay their toll. MassDOT has scheduled a series of informational meetings to inform North Shore commuters and answer questions about the upcoming transition.

"With the implementation of this innovative form of toll collection we are saying to our customers that their time is valuable," said MassDOT Secretary & CEO Richard A. Davey. "We are also increasing safety and reducing greenhouse gas emissions by cutting congestion and the time spent idling at the cash booth."

Beginning early in 2014, motorists will no longer have the option to stop at a toll booth $\frac{1}{2}$

and pay cash for their Tobin Bridge toll. Tolls will be collected electronically in one of two ways: either through the motorist's E-ZPass transponder or via a program in which a camera captures the license plate and the vehicle's registered owner is billed by mail. A contractor has been selected to install the gantry or overhead collection system and work is beginning to support the technical back-office operations.

The informational meeting series will acquaint residents with the logistics of the transition including the timeframes and the benefits of AET such as reduced congestion, increased safety and cutting greenhouse gas emissions. Prior to and following the brief presentation, motorists will be able to sign up for an E-ZPass transponder on-site.

Millions of Dollars in Questionable Benefits

According to the recently released report of the Auditor of the Commonwealth, the Department of Transitional Assistance has given out "Millions of Dollars in Questionable Benefits."

Auditor Suzanne M. Bump's office found over a thousand dead persons collecting benefits totaling \$2.4 million.

They found nearly a million dollars in double payments to persons with dual accounts due to the use of more than one social security number or variants in the spelling of the recipient's name.

Those numbers may sound big to you and me, but in an agency the size of DTA, where the cost of one program, SNAP (Supplemental Nutrition Assistance Program) is \$1.3 billion, the total waste and fraud is not staggering, as some have suggested. That is, unless the audit merely spotted the "tip of the iceberg" as many of us suspect.

The biggest concern ought to be not the magnitude of the mismanagement found at DTA, but the lack of concern for proper procedures and safeguards. The audit found that "DTA does not use any of the management reports provided by its EBT (Electronic Benefits Transfer) contractor to assist in the detection of potentially fraudulent activities."

Apparently DTA follows the Sergeant Shultz "I see nothing" school of management as far as fraud detection. This is troubling, for whatever the current rate of fraud is, you can be sure it will grow, as dishonest persons find out that one can get away with scamming the system.

Most of the public outrage at the exposure of waste, fraud and abuse at DTA has been directed at the harm done to the taxpayers of the Commonwealth. We work hard only to see the taxes on our wages and salaries wasted by a bureaucracy that can't even be bothered to

check whether assistance recipients are alive or dead. That outrage is justified, for such negligence on the part of a state agency is practically criminal.

However, I propose that the persons — persons who heretofore have been silent or even apologists for DTA who ought to be the most outraged, are the advocates for the truly needy in our Commonwealth. Every dollar wasted on benefits paid to someone dead or to someone receiving benefits under more than one name or social security number is a dollar not available to the poor for whom the program was created. That is not merely criminal, it is immoral. DTA's lack of effective controls to detect and prevent fraud allows crooks to steal from the taxpayer and from the poor. The prophets of the Old Testament had quite a lot to say about those who steal from the poor or stand by and do nothing while others plunder the poor.



stopping by the office of the Boston City Paper newspaper on Freeport Street in Dorchester, I was at my car in the parking lot when I noticed getting a long stare from three youths passing by the lot. I was nervous. It was late and no one else was around. Yes, they were three black boys in their late teens. I'm an older guy just retired. I was relieved when they disappeared out of view. However, moments later they returned. One walked directly toward me and asked if I had a cell phone. My blood pressure started rising. It was too late for flight, so I put on my best Charles Bronson face and told the kids, I had no phone. I stood my ground and at that point all I was armed with was my chutzpah. He looked at me and I at him and he blinked first and left the lot with his friends

I was a police officer for 27 years and have had these moments before but never alone. I always had someone at my back. However, not this evening! I can see why more and more citizens are seeking to become gun owners. The world keeps getting more dangerous and it gets closer and closer to us all the time. I am sure my hubris made the trio nervous that I might be armed. As they say, "Most criminals prefer unarmed victims.

Recently, Mothers for Justice and Equality held its 17th Annual Mother's Day Walk for Peace. It was preceded and followed by yet newer acts of violence. I keep hearing folks within the affected neighborhoods of the city living with constant violence demanding that the police do more. One minister inquired at a recent meeting at the Baker House about having the police lock-down crimeridden areas as was done following the Marathon bombings and manhunt for the

On a recent evening while killers. Most at the meeting rejected that idea but the fact it was even raised is concerning.

I have nothing but support for groups that organize this Annual Mother's Day Walk for Peace every May. However, actions speak louder than words or annual marches. People continue to be shot and killed in Mattapan, Dorchester and Roxbury and none of it will stop unless the communities involved stand up together and face down their collective fears together.

On May 12th, over 5,000 walkers, many who had lost loved ones to violence participated in the Mother's Day march. Some chanted slogans like, "One, two, three, four — no more violence at my door." Everyone is tired of the violence but yet it continues and too many seem to accept it as part of their daily living. Mothers for Justice and Equality was founded by a group of mothers who have lost children to violence. Their message is: The death of our children is not okay.

Monalisa Smith from Roxbury is the president of this mother's group and in a recent letter in the Boston Herald, she stated, "Urban mothers can no longer assure the safety of their children by making sure they are home before dark. Shootings take place as children are on their way home from school. The cumulative effect of the violence is whole neighborhoods suffer from trauma. There is little outrage among the wider public." I beg to differ with this point to a point. Where is the outrage from within these communities under siege of constant violence?

President Obama recently delivered a commencement speech at Morehouse College in Atlanta and told graduates

As we saluted, honored and remembered our veterans living and deceased this Memorial Day, I write the third column in as many years about my 92-year-old friend Armando, a veteran and hero of WWII.

Armando passed away Friday, May 24th at 5:00 p.m. in the safe and loving presence of his youngest daughter and wife Mary, whom he married 64 years ago after courting her during WWII.

And so it is a fitting tribute that Armando should peacefully leave her, their family and the nation he loved and safeguarded the month we honor our heroes and heroines of wars past.

Affectionately known by many friends — most he knew for decades — as the "Mayor of Auburndale," Armando could be seen every spring, summer and fall tidying up nearly every open-space of the village he and Mary adopted soon after the end of WWII.

Every fabric of community goings on pulsed with Armando's selfless giving. His patient perseverance proved infectious as he cultivated working relationships with Newton officials so he could get diseased trees cut down, a load of mulch dumped next to the fountain to spread around trees dotting the village business district and receive bread from the neighborhood bakery to bring to food banks in Waltham and Watertown.

He grew up with grandparents who came from Italy in the 1880s. His mother taught him to speak Italian so he could converse with his grandparents and neighbors from Italy. He spoke English as he and his five siblings went to school in their hometown of West Haven, Connecticut.

After WWII, Armando humbly took advantage of the G.I. Bill and earned a college education at Boston University. He educated young minds for four decades in Newton and Wayland public schools.

On numerous occasions, I witnessed students he taught long ago stop to chat whenever seeing Armando in the corner market or outdoors mowing the lawn at the village fountain or pruning trees along Commonwealth Avenue. Greatness never grows old nor fades

And with America's Greatest Generation, we Baby Boomers and ensuing generations, are blessed as for the past 70 years these givers provided gifts to a nation free from tyranny and in position to daily better the lives of its citizens and others across the planet.


Upon receiving recognition for his tireless efforts through the years, Armando graciously took time to thank community leaders and neighbors who honored him for serving others.

My final visit with Armando and Mary, four days before he passed, saw him true to cheery character sifting through poems he wrote. One favorite he read aloud. It brought special meaning of a tree's delicate beauty to him. He reminisced about learning the Act of Contrition and Our Father from nuns in Catholic school and from "my wonderful mother."

The one anecdote that Armando shared with me, which shall stay in my memory more vividly than the hundreds of stories he spoke, is this: "The happiest day of my mother's life arrived when me and my brother Joe walked up the sidewalk to hug her as she stood on the top step of our home's front porch, tears streaming down her tanned cheeks, after our call to duty in World War II was finished."

earthly Though his absence will be immensely missed by myself and the many folks who are blessed to have known him, Armando's spirit shall forever be with us. Again, he is happily reunited with his brother Joseph, mother, father and two other siblings who have gone before him.

The world is a better place because Armando helped make that way.

Freeway says here are 11 ways to protect my pooch friends from heat stroke.

As you already noticed the weather has been getting warm and humid and don't forget that dogs and cats face increased risk of heat stroke during the summer. Unlike people, they have few sweat glands, which are found primarily on their paws and noses. Though many people believe that dogs sweat through their tongues, panting is not an effective method of heat

If your pet exhibits frantic breathing, a bright red tongue, vomits or staggers, it is likely suffering from heat stroke. In severe cases you will notice your pet's lips begin to turn pale blue or gray. Pets most susceptible to heat stroke are animals with shortened muzzles such as Bulldogs, Pugs or Persian cats; old and overweight pets; and those with respiratory problems. The Humane Society advises that immediately after you notice symptoms of heat stroke, move the pet into the shade or indoors with air conditioning. Apply cool not (Continued on Page 12) cold water to your animal to

gradually lower their body temperature. Finally, seek veterinary care, which can best save your pet's life.

Here are 11 tips to cool your pet down in the heat:

- 1. Always supply your pet with water and make sure the dish is out of the sun. Put ice in to keep it cooler longer.
- 2. Take your dog swimming or hose them with water on hot days.
- 3. Walk dogs in the early morning or late hours of the day when the sun is least harsh. Carry water during these walks.
- 4. Check your pet for ticks and fleas. Look into purchasing a pet-safe bug spray if they spend a great deal of time outdoors.
- 5. Don't take your pets to crowded summer events. I can never comprehend why people insist on having their dogs with them at events such as parades and carnivals. Dogs don't care about arts and crafts, parades or carnivals. So why subject the animals to the heat and excitement of these human activities?
- 6. Walk your dog on grass or dirt to avoid burning their paws on hot pavement.

- 7. Groom your pet properly and ensure they are free of matted hair.
- 8. Provide access to shade at all times.
- 9. Sunscreen can be used on pets depending on the location of the sensitive skin. Use care in picking the product as cats and dogs are prone to licking themselves and should not ingest most lotions.
- 10. If you have a rabbit, keep the hutch in the shade. In the wild, rabbits spend the hottest part of the day in their underground burrows where it's cool.
- 11. Above all, never leave a dog in the car, even with the windows open. Despite massive exposure regarding this topic, the No.1 cause of heat stroke in dogs remains being left in a hot locked car. Always be conscious of the effects of heat buildup in a vehicle, because it takes only a few minutes for the internal heat to increase forty degrees or more above the outside air temperature especially in direct sunlight.

Summer weather can be extremely dangerous to your pets. It's your job to keep them safe and healthy!



QUICK VEAL OR CHICKEN SPECIAL

- 1 pound cubed veal stew meat or chicken breast
- 1 large ripe tomato
- 1 medium chopped onion 2 cloves chopped garlic
- 2 small sprigs bay leaf (optional)
- 1 fresh mint leaf (optional) 1 or 2 *julienne potatoes
- 1 or 2 *julienne carrots (optional)
- 3/4 cup frozen or canned green peas
- 2 tablespoons red wine 1 chicken bouillon cube
- 3 tablespoon olive oil

1 can sliced mushrooms or mushrooms of choice

Heat oil in skillet and add cut up veal or chicken breast. Stir and simmer to brown lightly. Remove only meat from skillet and set aside. Add cut up onion and garlic to oil in skillet and simmer until onion is opaque. Add cut up tomato. Stir and simmer over medium heat. Cover and continue to simmer for two or three minutes before adding one cup of water and a chicken bouillon to skillet. Stir, cover and continue to simmer mixture slowly for another two minutes. Then add veal or chicken breast to tomato mixture and bring to a slow boil. Add bay leaf and mint (optional) to skillet and stir. Continue to simmer at low heat for ten

Meanwhile, remove skin from carrots and potatoes and *cut into thin long strips (julienne). Set aside in water in separate bowls.

When meat has cooked about ten minutes in skillet, add carrots first. Cover and cook for about five minutes. Then add potato and mushroom slices. Stir and cover. Continue to simmer until potatoes and carrots are tender to your liking. Add wine, cover and bring to a slow boil and then remove from burner.

Serves two.

NOTE: It was meals like this that I remember Mama surprising us with at various times. I often wondered — Now where did she find this recipe? She loved creating meals that might be different. It was a great lesson for me that encouraged me to create meals with meats and vegetables that my family enjoyed.



the age of 25 and took the name of Anthony. After some time he obtained leave to go to Africa and preach to the Moors where he became severely ill and returned to Spain. At that time, Saint Francis was holding a chapter in Assisi, Friar Anthony attended the gathering and from there was sent to a monastery in Forli and later to Rimini. Nanna & Babbononno

A Nostalgic Remembrance



My folks: John and Ann Christoforo, summer of 1936, three months before they were married.

June 9 was my father's birthday. If he was alive, he would be 103, but he didn't make it beyond 81. Dad passed away in the fall of 1991 due to an abdominal aneurysm that burst. He had been in great shape all of his life, but developed an aortic aneurysm in his late 70s, was operated on to solve the problem, but slowed down dramatically after he recuperated. In the music world, he became a respected icon with the title of Papa Johnnie Christie, a term of endearment which he really enjoyed. With his playing days in the past, his bass violin, tuba and bass guitar all sat in the hall closet collecting cob webs with echoes of past performances lingering in the air. He kept his hand in music and union affairs, heading a committee that helped out musicians who were unable to play and were in need of the necessities of

My father was born Giovanni DeCristoforo on Chelsea Street in East Boston on June 9, 1910, the first child in the family headed by Nunzio DeCristoforo and Antoinette Paglia.

Grandpa Christoforo was a day laborer and swung a pick or shovel all of his working life. He could barely speak English and was not able to read or write in either Italian or English, but in spite of this handicap, he supported a family that included Dad and his sister, Aunt Mary.

Grandpa made sure that Dad learned a trade in school. At East Boston High School, he majored in machine shop to prepare for a career in the trades. Starting at a young age, he decided to study violin, but due to an incident in the neighborhood studying violin was short lived. When school let out, Grandpa would shave Dad's head to cut out the cost of a summer haircut. Can you imagine someone walking down Chelsea Street in East Boston with a shaved head and carrying a violin case? The comments were out there. One day, on the way to a music lesson, a he was called up by the draft

wise guy decided to give Dad a knuckle sandwich on his bald head. After it happened, he handed his violin to a friend who was walking along with him, approached the aggressor and cold cocked him knocking him out with one punch. I don't know the outcome of the altercation, but Grandpa never shaved his only son's head again and Dad gave up the violin. His love for music didn't change and he soon took up a much larger violin, a bass violin. By the time he graduated EBHS, he became a professional musician, but accepted a job with an iron works during the day. He only lasted a year or two working days as he soon developed a reputation as a good bass player who doubled on tuba and Sousaphone. From his 20s on, he traveled around the country playing music with various bands.

The depression of the 1930s was in full swing, but Dad worked constantly. He even joined a band that was part of a tent show established by the noted world traveler and newsman, Lowell Thomas. When he returned from his world travels, Thomas would put a show together for people in rural parts of the country and Dad was part of the music that entertained the country folks. Later in the 30s he began playing swing music and joined the big bands that were touring the country. When returning home, he recorded with Vaughn Monroe's orchestra.

On a given day, he was playing a double header with the Contini brothers, Nick and Paul. Between jobs, they brought him home for dinner and to meet their parents, Nanna and Babbononno. He also met their sister Anne. The chemistry was there from the beginning and they began dating with Babbononno's approval. Dad was a musician and that was enough for Babbononno to like him. The dating lasted 3 years because Dad was on the road much of the time. Finally, my mother gave him an ultimatum, now or never, and they were married at the Sacred Heart Parish in East Boston on October 25, 1936. I showed up 2 years later on October 21 and would be an only child.

My folks were living in Allston on the Brookline border, in a neighborhood that was called Musician's Row. After I was born, they moved back to East Boston so that Nanna could care for my mother and me when Dad was on the road. After December 7, 1941, things changed...war. My uncles all joined the military to fight our enemies and Dad accepted a job teaching machine shop and math at East Boston High School, his old alma mater. He was holding off in joining a service until

board. One day he was called out of class by the principal who was accompanied by two men who identified themselves as members of the OSS, today's CIA. They asked him to volunteer to interrogate Italian war prisoners that were being housed in what had been the East Boston Immigration Station back in the day. I don't know how they got his name, but when they checked him out, they gave him clearance to handle this responsibility. After Italy surrendered and switched sides in 1943, the prisoners were released, but some didn't want to go home. Dad used his influence obtaining jobs and apartments for the ones that stayed behind.

Once the war was over, Dad had a conversation with a band leader who was like his Godfather, Gordon Seabury. He assured Dad that times were going to change and with a growing family, it would be in his best interest to continue with his teaching job and play music at night locally. Dad listened and followed his friend's suggestions. He would teach at EBHS until 1948 and then go into administration in the Boston Public Schools. He had helped a candidate for the Boston School Committee get elected and was told that the school department was starting a new specialized program called the Department of Audio Visual Education. They would handle projectors, cameras, the latest in recording equipment and films that could be used at all of the schools. Dad became a pioneer in this field and programmed science experiments for the middle schools in Boston.

Through all of this, he stayed active with music playing locally with many different bands that specialized in weddings, engagement parties, baptisms, bar mitzvahs, and, you name it, he played it. During the summer months, he would book in county fairs in the northeastern states and bring Mom and me with him. As a child, to me, this was show business at its best.

Dad would retire from the school department in the 1970s, after over 30 years of service. This left a void in his life and he became involved in musicians' union politics.

Music is a young person's profession and when Dad began to slow down, he and Mom began to travel throughout the U.S. and take cruises to the islands. When I finally settled down and my wife produced two young athletes, Dad became the consummate grandfather being called Papa by both of my boys. The story doesn't end here, but I thought you might like to know a little about my father who I can say was responsible for the way I turned out in life. Happy Birthday Dad.

I always wondered where all the Black soldiers were in those World puzzled when I found out as a child during the '50s that our Armed Forces, the men and women who made up the ranks and risked their lives so that I might be free to grow up as an American boy had been a segregated force during our battles against Hitler and Nazism. WHAT IS SO RARE AS A DAY IN JUNE? — With apologies to 19th century poet James Russell Lowell, it certainly seems to be that the days of the sixth month of the calendar year are no longer solely the province of warm, languid, sunny afternoons.

No, now, as they have been for quite a number of years, they are also the culmination of the hockey season, featuring the Stanley Cup Finals. And while the final round of the Cup playoffs routinely ends in June the B's won the 2011 Stanley Cup on June 13 in Vancouver — the proceedings will continue even later in the month this time around because of the January start (and late April conclusion) to the regular season.

The last possible date for a game in the 2013 Stanley Cup Finals is June 28. That doesn't necessarily mean there will be a contest that day. To get to that date one of the Conference Finals series must go seven games and then the Final series must go seven games.

But they will almost surely be playing on the first day of summer — June 21. Is hockey still a winter sport? You would never know it by the length of the Stanley Cup Playoffs.

AS THE SERIES WITH PITTSBURGH CONTINUED The continued future of the B's looked bright as the Eastern Conference Finals came to the Garden after opening in Pittsburgh where the B's took a 2-0 series lead.

If, and of course that's an important two letter word, the Bruins downed the Pens and advanced to the finals, it looked like they might face Chicago, making the Stanley Cup Finals an historic matchup of original Six teams.

We say historic because the Bruins and the Blackhawks have never met in the Stanley Cup Finals over the course of their long histories — which date back to the 1920s for both teams. Chicago entered this year's playoff as the NHL's topseeded team. The Bruins were seeded fourth.

Of course, to set that up the Blackhawks have to do their part and defeat the defending Stanley Cup Champion L.A. Kings in the Western Conference Finals. Chicago led 2-1 at press time. But as we all know, anything is possible in the NHL playoffs.

Remember that the Maple Leafs were down 3-0 in games to the B's and came back to force a game seven before Boston's miracle finish (two goals in the final 82 seconds of regulation plus the winner in overtime) ended their quest.

The last time the Bruins and Chicago met in the playoffs was way back in 1975 when Chicago beat Boston 2-1 in a best-of-three preliminary series. A year earlier, in 1974, the Bruins downed the Blackhawks 4-2 in the Dakota and Bentley.

best-of-seven playoff semifinals but were defeated in the Stanley Cup Finals, 4-2, by Philadelphia.

Before that you have to go all the way back to 1942 when the B's downed Chicago 2-1 in the opening round and then lost to Detroit 2-0 in the best-of-three second round. And here's something interesting: the first time the Bruins made the playoffs (in 1927) the very first series they played was against the Blackhawks.

According to the Bruins media guide archives, the B's played the very first playoff game in their history on March 29, 1927, downing Chicago, 6-1 at Madison Square Garden in New York City because the Chicago Coliseum had already been booked for an event. How about that?

Here's some Bruins trivia. The Bruins first playoff goal in history was scored at the 3:24 mark of the first period in that game when Frank Frederickson found the range. The Bruins went on to win 6-1.

The B's advanced past Chicago in 1927, got by the Rangers but then were defeated by Ottawa in the Stanley Cup Finals. By the way, the final game of the Stanley Cup playoffs was played on April 13 in 1927. Something has been added since then — two months or more of action. We're not sure that's been a positive development.

Many in the media would probably prefer a Boston-Chicago series this year over one featuring the B's and L.A. It's a much shorter distance between the two cities and that would matter under the current 2-2-1-1-1 format of the Finals. Remember in 2011 when the B's had to fly all the way to Vancouver for Game Five, come all the way back to Boston for Game Six and then fly out to Vancouver again for Game Seven?

That comparable long distance haul to L. A. and back would be eliminated by a Boston-Chicago series. Also, the flights between the two cities are numerous, the rates are lower and thus more fans from Boston might be able to attend. Plus there's even a daily Amtrak train with a sleeper car for those that prefer land-based travel.

SPĒAKING OF ... A HAR-BINGER OF FALL — While the present season continues for the Bruins, those who follow hockey at Boston University were given an early heads up on the 2013-2014 campaign via a newspaper ad that noted the "history of passion, pride and tradition" of BU hockey.

The season will highlight the first head coaching change for BU hockey in 40 years as Dave Quinn takes over for the retired Jack Parker. BU will play 18 home games at Agganis Arena, featuring contests against Boston College, Wisconsin, North
