## Santa Maria Di Anzano Procession

Launches North End Italian Religious Processions

The first Sunday of June always brings the first Italian religious procession of the season to Boston's North End, honoring Santa Maria di Anzano.

After a Mass at Sacred Heart Church, the 112-year-old society kicked off their procession from North Square. Devotees walked the streets with the North End Marching Band for the entire day through the neighborhood.

In 1905, a group of ten immigrants from Anzano, Italy, founded the Madonna di Anzano Society that continues today. The image of the Madonna was discovered over 400 years ago in a small village now known as Anzano, Italy.

Restricted Vehicular Access and Enhanced Screening on Parade of Sail Day Will Help Ensure Public Safety and Enjoyment

In anticipation of thousands of spectators along Boston's waterfront, the City's Police and Transportation Departments, along with the Coast Guard, Massport, MBTA, and representatives from Sail Boston, recently completed a series of public briefings in those communities that will experience the greatest influx of attendees to watch the Parade

These security protocols are very similar to those employed in recent years by the organizers of the Boston Pops July 4th celebration on the Esplanade, as well as the Boston Marathon from Kenmore Square to the finish line in Copley Square. Measures include street closings, restricted vehicular access and parking, and screening entry points along the Boston waterfront from Castle Island in South Boston, to the Charlestown Navy Yard, and in East Boston as well.

# Stirpe Nostra

#### **CLAUDIUS' ROMAN PAYOLA**

Tiberius Claudius Drusus Nero Caesar Germanicus, 10 B.C. to 54 A.D., more commonly known by his historical name of Claudius, succeeded to the Roman Empire on the death of Caligula. He was the second son of Drusus and Antonia, the grand nephew of Augustus, and a cousin to Caligula. He was neglected, treated as a buffoon, and was constantly ridiculed during the reign of Caligula. It is said that he became emperor of Rome by a freak of fortune, or as we would say today, by the fickle finger of fate. As soon as Caligula was murdered, his assassins closed off the area and announced that the emperor did not wish to be disturbed. Claudius was among those who were excluded, so he went off to another part of the palace. When the assassination was made known, the guards attempted to massacre all who had participated in the murder. Several persons who exposed themselves became the first victims, while others sought refuge in any convenient hiding place. Claudius ran off to an obscure corner of the palace and hid behind some curtains or drapes, but didn't realize that his feet were exposed. When he was discovered by a member of the Praetorian Guard, he immediately threw himself at the guard's feet begging for his life to be spared. The soldier recognized Claudius and for some unexplainable reason hailed him as the new emperor. Claudius was then taken to the other soldiers who were present in the palace and because of uncertainties they took him off to their camp. The following



day, he permitted the Praetorian Guard to swear allegiance to him and promised each man a large sum of money. Consequently, Claudius became the first of the Caesars who resorted to bribery to obtain the support of the troops.

As soon as his power as emperor was firmly established, Claudius took steps to obliterate the memory of any objection to his ascent. His respectful attitude towards the populace won him the love and devotion of most Romans. An erroneous report of his murder while on a trip to Ostia almost started a civil war.

Claudius was not without his share of conspiracy and treachery. A man was apprehended near the royal bed-chamber in the middle of the night with a dagger in his hand. Members of the equestrian order were caught attempting an ambush at various times. Rebellious groups planned to overthrow him many times but were always stopped in time.

He was a conscientious administrator of justice but tended to modify the severity of the laws according to his own attitudes toward justice. He permitted new trials in cases where he felt that judges overstepped their bounds, but prisoners who were convicted of dreadful crimes were thrown to the wild beasts. His most common trait while judging cases was an inconsistency which ranged all the way from shrewd to downright silly or even nutty. One man desired jury duty even though he could claim exemption because of the number of his children. He was disqualified because it was felt that the man had a passion for jury duty. Whenever one party to a suit was absent, he usually found in favor of the one who was present regardless of the reason for absence. A woman refused to recognize a youth as her son and gave conflicting testimony until the truth was extracted from her when she was ordered to marry the young

An example of the severity or harshness of some sentences is noted in his order to amputate the hands of a man who was convicted of forgery. An example of his silly decisions was one which degraded some people because they left Italy without first consulting the emperor to obtain a leave of absence. There was also the trial of a man charged with stabbing himself. The man stripped off his clothes in court to show his body without a scar.

# Saint Anthony Mary Claret


Antoni Maria Claret i Clarà was born in Sallent, in the vicinity of Barcelona, Spain, on December 23, 1807. He was the fifth child of eleven children of Juan and Josefa Claret. Claret received an elementary education in his native village, and at the age of twelve became a weaver. At the age of eighteen, he went to Barcelona to specialize in his trade, and remained there until he was 20.

Recognizing a call to religious life, he left Barcelona. He wished to become a Carthusian monk, but finally entered the diocesan seminary at Vic in 1829 and was ordained on June 13, 1835.

Claret was sent as Apostolic Missionary throughout Catalonia, which had suffered from French invasions, traveling on foot from one mission to the next. An eloquent preacher fluent in the Catalan language, people came from miles around to hear him.

Claret's life was threatened in 1848 by anti-clerical enemies and he was sent to the Canary Islands where he gave retreats for 15 months. Returning to Spain, he established the Congregation of the Missionary Sons of the Immaculate Heart of Mary (The Claretians) on the feast of Our Lady of Mount Carmel (July 16, 1849), and founded the great religious library at Barcelona, which was called "Libreria Religiosa" (now "Llibreria Claret"). Pope Pius IX gave approval to the congregation on December 22, 1865.

Pope Pius IX also appointed Claret Archbishop of Santiago, Cuba, in 1849. In Cuba, he founded a hospital and numerous schools, vocational



schools for disadvantaged children, and credit unions for the use of the poor. He wrote books about rural spirituality and agricultural methods. In August 25, 1855, he founded the Religious of Mary Immaculate together with Venerable Mother Antonia Paris. The congregation was considered the first women's religious institute in Cuba. He also visited jails and hospitals, defended

the oppressed, and denounced racism. His work stirred up opposition and at Holguín he was attacked and wounded by a would-be assassin.

In February 1857, Claret was recalled to Spain by Queen Isabella II, who made him her confessor. He obtained permission to resign his Cuban see. For nine years he was rector of the Escorial monastic school, where he established a scientific laboratory, a museum of natural history, a library, college, and schools of music and languages. In 1868, a new revolution dethroned the queen and sent her with her family into exile. Claret's life was also in danger, so he accompanied her to France. This gave him the opportunity to preach the Gospel in Paris.

In 1869, he went to Rome to prepare for the First Vatican Council. Owing to failing health, he withdrew to Prada de Conflent in the French Pyrenees, where he was still harassed by his Spanish enemies. Shortly afterwards he retired to the Cistercian abbey at Fontfroide in southern France, where he passed away on October 24, 1870, at the age of 62.

Saint Claret was canonized on May 7, 1950, by Pope Pius XII. His Feast Day is October 24th.

#### President Trump's Trade Policy Agenda

On March 1, 2017, the Office of the U.S. Trade Representative released President Trump's 2017 Trade Policy Agenda. I quote from the document:

"In 2016, voters in both major parties called for a fundamental change in direction of U.S. trade policy. The American people grew frustrated with our prior trade policy not because they have ceased to believe in free trade and open markets, but because they did not all see clear benefits from international trade agreements. President Trump has called for a new approach, and the Trump Administration will deliver on that promise."

President Trump wasted no time in implementing that "fundamental change in direction." On the Monday after the Friday he took office for his first term, he reversed what was supposed to be one of President Obama's most significant foreign policy and trade achievements. On January 23, 2017, President Trump withdrew the U.S. from the Trans-Pacific Partnership ("TPP"), the largest free trade agreement ever signed.

Among the eleven countries other than the U.S. were six with whom we already had free trade agreements. Apparently, they were included just to make the deal bigger. Among the other five — Brunei, Japan, Malaysia, New Zealand, Vietnam — only two, Japan and New Zealand, are modern, Western-style democracies with a level of economic development comparable to the U.S. In other words, if a good bi-lateral free trade agreement can be negotiated with any nation, those two would be good candidates.


As for the rest of the lot to whom President Obama wanted to give preferential access to our market, according to the U.S. Department of State:

The Socialist Republic of Vietnam is an authoritarian state ruled by a single party, the Communist Party of Vietnam. There are severe government restrictions of citizens' political rights, particularly their right to change their government through free and fair elections; limits on citizens' civil liberties, including freedom of assembly, association, and expression; and inadequate protection of citizens' due process rights, including protection against arbitrary detention. The government maintains limits on workers' rights to form and join independent unions and does not enforce safe and healthy working conditions adequately. Child labor persists, especially in agricultural occupations.

The most significant human rights problems in Malaysia include government restrictions on freedoms of speech and expression, press and media, assembly, and association. Restrictions on freedom of religion are also a significant concern — including bans on religious groups, restrictions on proselytizing, and prohibitions on the freedom to change one's religion. Other human rights problems include deaths during police apprehension and while in custody; laws allowing detention without trial; caning as a form of punishment imposed by criminal and "sharia" (Islamic law) courts; restrictions on the rights of migrants, including migrant workers, refugees, and victims of human trafficking; official corruption; violence and discrimination against women; and discrimination against lesbian, gay, bisexual, transgender, and intersex persons. The government restricts union and collective bargaining activity, and government policies created vulnerabilities for child labor and forced labor problems, especially for migrant workers

**Brunei Darussalam** is a monarchy governed since 1967 by Sultan Haji Hassanal Bolkiah under emergency powers in place since 1962 that place few limits on his authority. The most serious human rights problems are the inability of citizens to choose their government through free and fair elections, restrictions on religious freedom, and exploitation of foreign workers. Other human rights problems include limitations on freedoms of speech, press, assembly, and association. The partial implementation of a shariabased penal code continues to raise significant human rights concerns. The country did not ratify the UN Convention Against Torture and Other Cruel, Inhuman, or Degrading Treatment or Punishment, which it signed in 2015.

Do these sound like the governments we should be doing favors for? Thank you President Trump for pulling us out of the swamp that is the TPP.

# L'Anno Bello: A Year in Italian Folklore Magic in Every Month

At the beginning of the month, I have a special ritual. I open to the new page on my desk calendar and look through the days of the month. decorating holidays or anniversaries with quirky doodles. Each new month is like an unwrapped gift, quivering with anticipation and a sense of mystery.

Indeed, I have always been fascinated by months and, more importantly, their essence. In my mind, every month of the year has a unique character, an underlying trait that sets its days apart from those of other months. Holidays, saints' days, superstitions, family occurrences — all of these events add up to a rich and particular tapestry that typifies any month. During the olden days, when society was primarily based on agriculture, people viewed months as separate entities, depending on the weather and cycles of the sun and moon to help them plant. This is a much more romantic view than the way we perceive months in the modern era, when calendars are synonymous with busy schedules and frozen fruits allow us to eat out of season. I believe that we should reclaim the aura of uniqueness that surrounds each month, enjoying them for their own properties and emotions. For a model on how to do this, we must turn to Italy.

The magic of each month is deeply ingrained in Italian folklore. No matter the season, one can be sure that any given month abounds with its own proverbs and superstitions. Take our current summery month of June. In Italy, the peasants of yore bequeathed a number of weather-related proverbs that looked ahead to the harvest of late summer, or simply commented on the climate that characterized the



month. One saying declares: "Giugno ventoso, porta presto il grano sull'aia," meaning that a windy June will soon bring the grain to the farmyard. Another proverb, which reads "In giugno, in bene o in male, c'é sempre un temporale," warns that in June, no matter how good or bad the weather has been, there will always be a rainstorm! Other proverbs relate to the feast days of the saints, which dot the Italian calendar and provide people with a focus for religious devotion and a reckoning system for determining important dates in the agricultural year. Italians may repeat the rhyme "Per San Barnabá, il piú lungo della 'sta." This roughly translates that the feast day of St. Barnabas, or June 11th, is the longest day of the summer, referring to the fact that this date actually coincided with the summer solstice in the years before the Gregorian calendar reform. A charming yet slightly foreboding dictum declares: "La notte di San Giovanni, ogni erba nasconde inganni." This means that on June 23rd, the eve of St. John the Baptist's feast day, every herb hides some form of deceit — a callback to the old tradition of gathering herbs on this night, when it was believed that the magic of the summer solstice imbued them with mystical healing properties. Finally, other proverbs simply relish the bounty of nature available in June, such as "Giugno ciliege a pugno," which means that cherries are plentiful in June. What a lovely month these proverbs reveal!

Now, whenever I think of the months of the year, I try to focus on the exceptional qualities of each. January means deep drifts of snow and sparkling ice under an ever-lightening sky. Febru-

ary brings an explosion of red hearts and lace, and eerie masks for Carnivale. March is the month of green, of brisk winds and shamrocks. April recalls daffodils peeking out from the ground and baskets laden with pastel eggs. May translates to an abundance of flowers and the first hints of summer heat from a brightly shining sun. June is the end of the school year, a month of outdoor excursions and mysterious evenings eating out under the pale twilight of late evening. July includes fireworks bursting across a starry dark sky, trips to the rolling ocean waves or the energetic city. August is golden, like ripening grain, with mornings that smell like the woodsy charm of autumn. September means harvest and rhythm, red and yellow leaves and the glorious crunch of apples. The Young Pope paints a portrait of a mysterious, complicated man fully aware of the contradictions and consequences of being the conservative leader of a billion followers in a changing world but unwilling to bend in the execution of his duties.

#### PASTA FAGIOLI Pasta with Beans

- 1 can cannellini beans (white beans)
- 1 medium onion chopped
- 2 garlic cloves chopped (optional)
- 1 minced fresh tomato (optional)

4 tablespoons olive, canola, or vegetable oil

1 can chicken broth (optional) ½ pound pasta of choice

grated cheese of choice (optional)

In saucepan, heat oil over medium heat. Add chopped onion and simmer until onion is lightly browned. If using chopped garlic, add to onion. Stir and cook for a few seconds. Garlic should not brown. Add minced tomato (optional), stir, and cover. Simmer for about five minutes. Then add can of cannellini beans and stir. Cover and cook over low heat for a few minutes. If sticking, add a little water or some chicken broth. Cover and simmer for about five minutes. Salt to taste. Remove from burner and set aside.

Cook pasta of choice according to directions on the package. After draining cooked pasta, place it in a larger serving bowl. Add beans to the pasta and stir before serving in individual bowls. Serves two.

NOTE: One of my favorite pasta with the beans is the small shell. However these healthy, hearty beans are delicious as well with Ditalini or elbows. I remember Mama sometimes cutting up spaghetti into one-or-two-inch portions and cooking that for serving with the beans.

This is a meal frequently called "pasta e fasulli." It seems every Italian dialect has its own pronunciation for this wholesome and frequently prepared meal during the depression years.



A Nostalgic Remembrance



Today, my father would have been 107. He was born on June the 9<sup>th</sup> in 1910.

Most all of my stories, and even the title of this column, are about my mother's side of the family. Due to circumstances, I didn't meet my father's side until I was about 9 or 10 years old. There was some bad blood between the two families, the Continis and the Christoforos. At this point in time, I don't know who was at fault, nor do I care. Things were eventually resolved, but not before my grandparents were senior citizens.

Before I met my father's parents, I never questioned that just my mother had parents and siblings, all with lots of stories about the old country, the North End, and East Boston. My awakening came one Sunday after Mass. Every month, the East Boston Knights of Columbus would have a Father and Son Mass at the Holy Redeemer Church located near Maverick Square. I used to attend these Masses with Dad, and afterward, we would head downstairs for their Father and Son Breakfast.

This one particular Sunday, I think it was either 1947 or '48, Dad told me we were going to my grandparents' house instead of heading to the lower level of the church. I didn't question what he said as this was my normal venture after the kids' Mass at the Sacred Heart Church, which was my parish. That Sunday ritual was to see my mother's parents, Nanna and Babbononno, not my father's parents. We left Maverick Square and headed north on Chelsea Street. But when Dad parked near Santarpio's Pizza, I wondered what he was up to. This was not Nanna and Babbononno's neighborhood.

We got out of the car and I followed my father into the doorway of a three-decker just to the left of the restaurant. As we walked into the hallway. I could smell bleach, a liquid used by Italian ladies to clean the front steps of their homes back then. I believe lavendina was purchased in gallon jugs just for this purpose. Anyway, we walked into the first floor hallway and stopped at a door at the end. Dad knocked on the door and then opened it. Standing on the other side was a man who looked like my father, same face, same curly black hair, and same blue eyes. Sitting at the kitchen table was an oliveskinned lady with long black and gray hair. Dad introduced me to both, saying in Italian, "This is my father and mother, your grandparents." Needless to say, I was shocked. My new

grandmother motioned me to her and looked me up and down. Just then another person entered the kitchen. She had a pretty face and jet black hair. In English, my father said, "This is my sister, Mary." Out of respect, I hugged each of them and received a kiss on each cheek. It was then I realized that this was my father's family, a family I didn't know existed.

Later in life, I began to ask my mother about the problems that separated the two families. I would hear stories from her and Nanna. My conclusion was, "There was the Contini side of the story and the Christoforo side of the story, and somewhere in between, the real truth." My father never talked about it, but I think he was happy that things got straightened out.

The one thing I regret was that I never really got to know my paternal grandmother.

When I met her that first time, she had a lot of things wrong with her. About a year or so later, she went into a hospital on Long Island in Boston Harbor and never came out. She died on Easter Sunday in 1950. On June the 9<sup>th</sup> of that year, Dad turned 40, but didn't feel much like celebrating. He did become closer to his father after that point in time, and he visited him every Sunday morning. From then on, when there was a family get together with my mother's side, Grandpa Christoforo was always included.

Once the two families were reunited, Dad began to tell me stories about growing up on Chelsea Street in East Boston. He had many stories, a few of which I have written about in this column. Grandpa could hardly speak English and was illiterate in both languages. He signed his name with an X, and Dad had to translate into Italian whatever document that needed his father's signature.

Dad began telling me stories about when he was a kid. His neighborhood, the end of Chelsea Street that was closest to Maverick Square, was a mix of Italian and Jewish back then. On the corner of Elbow and Chelsea Streets was a synagogue. One Saturday morning, Dad and several of his pals were sitting on the steps of the building all carrying baseball equipment. Saturday is the Jewish Sabbath and the Rabbi, seeing the boys on the steps, yelled at them for not being inside for his services. They told the Rabbi that they were not Jewish, and when the man asked what they were doing there, they told him that their pitcher was Jewish, was inside, and they were waiting for him.

Aunt Mary married Jim

Dello Russo, the man she waited for while he was in the Navy. After they settled down in East Boston, they and my folks became close. Uncle Jim and I really hit it off. He taught me how to take good pictures and develop my own film. He taught me how to set type and use a small printing press. He built a darkroom and a print shop in his cellar, and I was there as often as possible. I became closer to him than Mom's brothers at that point in time as Uncle Jim was free at night whereas Uncle Nick and Uncle Paul were musicians and worked almost every night.

Uncle Jim and Aunt Mary had only one son, my cousin Jim. Unfortunately, Uncle Jim came down with cancer and passed on at an early age. My aunt never married a second time. Uncle Jim had been the love of her life and no one could replace him. When it was time for college, Cousin Jim went to Boston College. When he graduated, Dad was as proud of him as he had been at my college graduation years earlier.

As my father aged, I would sometimes have surprise parties to celebrate his birthdays. Aunt Mary and Cousin Jim were always included, and somewhere I have pictures of all of us together. I just have to find them.

Dad was in great shape until his mid-70s. When he was around 75, he was operated on for an aortic aneurism. This took the wind out of his sails and he slowed down quite a bit. At age 80, he developed another aneurism near his left kidney that couldn't be operated on. At 81, he was gone. This happened in 1991, when my column was in its infancy and I wrote a short biography about his life called, "Here's to Our Fathers." I'm not much on visiting cemeteries. I show my love and respect by writing about my family. It's just my way. So, wherever you are, Dad, Happy Birthday from your loving son, John.

# The Wicked mart Investor

#### "So What Do You Call 'Em? The Story of a Summer Time Kerfuffle"

Bostonians are frequently razzed not only for our accents, but also our lingo. Words like "packie," "spuckie," and "tonic" elicit puzzled looks from visitors. In the summer, another local word becomes prominent: "jimmies." For those of you that don't know, "jimmies" is Boston's name for chocolate sprinkles, those bits of candy topping on ice cream cones for added flavor texture. I actually thought all locals used this word, but my research proved otherwise. To find out what local ice-cream makers were actually calling the confectionary delight, I did some supermarket research and sampled the local fare. Friendly Ice Cream uses "sprinkles" on its menu but Brigham's names a flavor "Just Jimmies." Richardson's in Middleton calls them "jimmies," but Bliss Brothers in Attleboro refers to "sprinkles." So far the score is even. Looking for a tie-breaker, I searched for an old Bailey's menu but to no avail. I settled on using Cabot's in Newton, which is very reminiscent of Bailey's and also a "sprinkles" shop.

It's no big Twinkie what you call them, jimmies or sprinkles. I'm sure most people know the names are interchangeable in Boston. Two words that are not interchangeable, despite what many people think, are gambling and investing. In actuality the terms are very different. When you hold stock in a company, you have an ownership interest in that company. You are the house and that math is skewed in your favor. The cherry on top is that collectively the shareholders have a lot of power. They can oust management that is not making profits for them. In the absolute worst case scenario, if the company goes out of business, the shareholders have a claim to the assets of the corporation after the creditors get paid.

If you are fearful of investing and consider it gambling, you should ask yourself how you learned this. Did you develop a bias when you learned a daytrading neighbor lost all his money in short-term stock market speculation? Or the nervous relative who panicked and sold at loss in contrary to professional advice? Then the market rebounded which it always has in the past? We all know people who can't admit mistakes, so they insist the odds are stacked against them.

The simple fact is that there are many people that get good returns in the market when they follow prudent advice. You can, too. In fact, order up a double dip of prudent advice on a waffle cone and your financial future could be Jim Dandy!





#### **JOHNNY COULON**

His Feet Were Firmly Planted

Johnny Coulon was one of those very interesting men who made a name for himself in the early 20th Century. It was an interesting and exciting time; a time when physical culture and feats of strength were very much in vogue. Men such as Benarr MacFadden were extolling the virtues of living the clean life and taking care of one's body through exercise and a good diet. There was Eugen Sandow, known as Sandow the Great, who would perform feats of strength such as lifting a barbell with baskets attached on each end. Each basket would contain a grown man. Sandow would not only lift the barbell over his head, but he would do it with one arm.

People were fascinated by these feats and exhibitions where these were performed drew large crowds. These shows would also contain "Living Sculptures." The sculptures were actual body builders who would cover themselves in white powder, flex their muscles, and stand still for long periods of time.

You might think very large men did all these acts, but that was not always the case. Athleta Van Huffelen was a Belgianborn woman who could lift two or three men over her head at one time. Also, not all the men were very big. Case in point:

Johnny Coulon was born in 1889 and not long after his parents settled in Chicago where Johnny would spend the rest of his life. At an early age, he took up boxing and was quite good at it. Weighing only 110 to 115 pounds, he went on to win the Paperweight Title, later named Bantamweight. Coulon went on

to have a career total of 91 fights with 67 wins, 31 coming via knockout, with only 11 losses, 12 draws, and 1 no contest. One of those victories came at the expense of a young Charley Goldman. Goldman would go on to become better known as the trainer and teacher of Rocky Marciano.

So, where does the connection between strong men and little Johnny Coulon come in? Well, it seems Johnny developed a skill early in life where he could make it impossible for anyone to lift him off his feet. He would take on all comers regardless of size and let them attempt to take him by the waist and pull him up off the ground. Men from Jack Johnson to Muhammad Ali tried and failed. Sonny Liston couldn't do it nor could Jack Dempsey. The macho Ernest Hemingway failed. Even the giant Primo Carnera tried and could not succeed.

How was a man so small able to defy the strength of such powerful men? It seems no one knows for sure how he did it, but he did have some rules before allowing attempts to be made

First, the person trying to lift him would have to stand a certain distance back from Johnny. Then he could only grab him at waist height with one hand on each side of his body. Coulon would then put two fingers from his right hand on the person's neck on or near the carotid artery. He would then place his left hand over the right hand of his challenger. Once that was done, he could not be budged.

Some thought Johnny possessed supernatural powers. Others thought he may have been cutting off blood flow, causing his challengers to lose their equilibrium. The Great Houdini called it hokum. Whatever it was, Johnny Coulon performed this feat until his final days.

### HOOPS and HOCKEY in the HUB

Is there anything left really? What could one do to even begin to paint a scenario where LeBron James would and could

say "wow" to something?
Would it be scoring? Would
it be rebounding? For fans it
could be the fluid motion that
propels him toward the basket
for another score. That might
make the fans say "wow," but
what would make James open
his mouth and utter that word?

In truth, there is such a setting — and it is now. It has been a lifetime in the making. Like a magnificent building in the Middle Ages that took decades to construct, this one also embraced a span of over 20 years to bring it to fruition.

LeBron James is partially a product of his era, growing up and coming of age when another player dominated the times in basketball — even perhaps extending his influence and persona beyond a specific sport and becoming part of Americana — the American experience.

That would be, of course, Michael Jordan, the dominant player in the NBA in the 1980's and throughout the 1990's — perhaps becoming the most famous person in the world during that time frame.

In an earlier era — the 1950's — millions of adults would wear buttons with the slogan "I like Ike", indicating their support for Dwight Eisenhower in the Presidential elections of 1952 and 1956. Indeed, there was a lot to like about the leader of the Allied Forces in World War II, a sentiment that led to his twice being elected to the most powerful political position in the world.

Fast forward several decades later and another person has come on the scene throughout the land, a person who transcends politics and appears to have all enthralled by his athletic dynamism. That person was Michael Jordan. And to millions of children and teenagers across America, there was only one desire. They all wanted "to be like Mike."

One of those millions was LeBron James, who grew up in Akron, Ohio, and starred a local Catholic high school before declaring for the NBA Draft.

To this day, James not only thinks of Jordan but wears a constant reminder of the NBA star on his uniform—number 23—the number that Jordan wore.

"I wear the number because of Mike," stated James in a postgame press conference during the Eastern Conference Finals with the Celtics at the TD Garden. "I think I fell in love with the game because of Mike, just seeing what he was able to accomplish. When you're growing up and seeing Michael Jordan, it's almost like a god."

Even today, James is somewhat humbled to be mentioned in the same conversation with the player he considers to be the greatest of all time.

"I think at the end of the day, for my name to come up in the discussion of the greatest basketball player of all time, it's like wow."

See, we told you there was a "wow" scenario for LeBron James — and this is it. To be in the same discussion as Michael Jordan — the dream of so many children growing up in that era — is enough to have his dream realized.

James acknowledges he wanted to be like Mike so much that he actually mimicked him in a number of ways.

"I did pretty much everything that MJ did when I was a kid," said James in a matter-of-fact tone. "I shot fadeaways before I should have. I wore a leg sleeve on my leg and folded it down so you saw the red part. I wore short shorts so you could see my undershorts underneath. I didn't go bald like Mike, but I'm getting there. [Actually, we thought Jordan shaved his head].

"But other than that, I did everything Mike did, even wore a wristband on my forearm. I didn't do the hoop earring thing, either. But I did everything else Mike did. I wanted to be Mike, so for my name to come up in any discussion with Michael Jordan, it's a 'wow' factor."

But — at least in childhood — James deep down felt he could not live up to his hero. And so he adjusted his game, his goals, his outlook on the future and matured into the player and performances one sees today.

"I didn't ever believe I could be Mike. So I started to focus on myself, on other players, and other people around my neighborhood, because I never thought I could get to the point where Mike was."

That realization brought about adjustments of mind and deed. "I think that helped me shape my game," said James. "I think the biggest thing for me sitting here is that it is just being me. I don't have to score the ball to make an impact on the game. That (scoring) was my mindset when I started playing the game. I was like, if I'm not scoring, how can I have an impact on the game? It's carried all the way to this point now and it's going to carry me for the rest of my career because scoring is not number one on my agenda."

And what about LeBron's legacy? "Because scoring is so heralded in our sport, I want the fundamentals of the game to be as great as they can be. If some kid can look at me and say I made the extra pass because LeBron made the extra pass, or I got a chase down block and I didn't give up on the play because LeBron didn't give up,' that would mean the world to me. Passing the ball is OK, making the extra pass is OK. No matter if you win or lose, making the right play is OK."

Two known facts about King James. Selected first overall by Cleveland in the 2003 NBA Draft, he actually made his pro debut in the Hub when he played in Shaw's Summer League at UMass Boston that year. His first practice as a pro was at Suffolk University's Regan Gymnasium.
