Political Violence in Oregon Gone Wild

USS Constitution Annual 4th of July Turnaround

On Thursday, July 4th, the USS Constitution made her annual July 4th voyage to Castle Island in South Boston to fire a 21-gun salute in honor of those who served, sacrificed, and fought for our nation's independence. The historic cannon salute celebrates the USS Constitution being the oldest fullycommissioned Naval vessel in the world and the birth of the U.S. Navy. Launched in 1797,

as Old Ironsides, was named by President George Washington after the United States Constitution. She is the world's oldest commissioned naval vessel still afloat. She was built at Edmund Hartt's shipyard in the North End of Boston, MA. Most noted for her actions during the War of 1812 against the United Kingdom, when she captured numerous merchant ships and defeated five British warships. USS Constitution, also known Her battle with the British frigate HMS Guerriere earned her the nickname "Old Ironsides" and public adoration. Constitution was retired from active service in 1881 and designated a museum ship in 1907. Constitution sailed under her own power for her 200th birthday in 1997, and again in August 2012 to commemorate the 200th anniversary of her victory over Guerriere. Constitution's stated mission today is to promote the Navy's role in war and peace.

IMPERATORE JULIUS CAESAR

The Roman calendar became quite hopelessly confused after much tampering by officials for various reasons, such as prolonging their terms in office, also, to hasten or delay elections. Caesar consulted with the Egyptian astronomer Sosigenes to fix the normal year at 365 days plus leap year. This we call the Julian calendar and it was in use until 158 when the Gregorian calendar corrected the error of eleven minutes and fourteen seconds per year.

He reduced a welfare list for grain handouts from 320,000 to 150,000 and established colonies for jobless Romans. Citizenship was conferred on all foreigners who practiced medicine in Rome, and this offer was also extended to teachers of the liberal arts. He placed new controls on the payment of debts, increased penalties for crimes,

the utmost conscientiousness and strictness.

He enforced laws against extravagance and had agents penetrate public markets and dining rooms for compliance. He also made available to the public, the great possible libraries of Greek and Roman books.

Among the honors bestowed upon Julius Caesar were dictatorship for life, the forename of Imperator, the surname of father of his country, his statue was placed among those of the early kings of Rome, he was given a raised couch in the orchestra at the theater and a golden throne in the Senate house, and lastly of course, naming the month of July after

He is said to have been quite tall with a fair complexion, shapely limbs, full face, keen black eyes, and excellent health.


care of his person, always welltrimmed and cleanly shaved. He combed his hair forward to hide a bald spot, and often used the privilege voted him to wear a laurel wreath at any time. He usually wore a senator's tunic with fringed sleeves.

He completed a country estate at great cost and then tore it down because he was not exactly satisfied with it in every particular. He was always a most enthusiastic collector of gems, carvings, paintings, and exceptionally well built slaves. His invasion of Britain was done in hopes of obtaining a fortune in pearls.

When in the provinces, he usually gave banquets in two dining rooms, one for his officers or Greek companions, and the other for Roman civilians and distinguished provincials. He managed his household very strictly, even putting his baker in irons for serving him one kind of bread while guests were served an inferior quality.

It is the general opinion that he had an eye for good looking women regardless of their marital or social status. It is particularly interesting to note that two of his close female friends were Servilia and Tertia, the mother and sister of Brutus. The top of his list was reserved for at least two queens — Eunde, a Moorish queen, and of course Cleopatra, with whom he often

At one time, there was consideration given to presenting a bill in the Senate making it lawful for Caesar to marry as many wives as he wished for the purpose of begetting children. The bill did not pass because it was felt that this would beget Caesar

Saint Lidwina

Lidwina was born on April 18, 1380. She was one of nine children born into a poor country family in Schiedam, Holland. Her father, Peter, was a laborer, and her mother Petronella, was a poor country girl. Very early in her life, Lidwina was drawn towards the Mother of God and prayed a great deal before the miraculous image of Our Lady of Schiedam.

During the winter of 1395, Lidwina went skating with her friends, one of whom caused her to fall upon some ice with such violence. She broke a rib

on her right side, from the fall; gangrene set in and continued to consume her body. No medical professional could diagnose and cure her injury, this began her martyrdom.

After her fall, Lidwina fasted continuously and acquired fame as a healer and holy woman. The town officials of Schiedam published a document (which has survived) that attests to her complete lack of food and sleep. At first she ate a little piece of apple, then a bit of date and watered wine, then river water contaminated with salt from the tides. The document also attests that Lidwina shed skin and bone which her parents kept in a vase and which gave off a sweet odor. These excited so much attention that Lidwina had her mother bury

Lidwina continued to experience great pain for the rest of her life, but she was rewarded with visions of faith from God. She died in 1433, at age 53. She was canonized by Pope Leo XIII in 1890. Today, she serves as an inspiration for chronically-ill patients and those with multiple sclerosis. She is known as the patron saint of ice skaters. The Feast Day of Saint Lidwina is April 14th.

Trenton Corner Market

I recently read a story about a shoemaker who, back in the early 20th century, lived and worked in a very poor multi ethnic neighborhood that might have been in New York or Boston. Quite often, he would approach a destitute family in his neighborhood with a pair of children's shoes claiming that there was a fault in the manufacture and he couldn't sell them. Also remembering that a particular family had a child that would fit into the shoes, he thought that instead of throwing them out, the parents would accept them for the child that they would fit. The way the shoemaker phrased his offer combined with the need, seemed to satisfy the parents and the shoes were accepted.

I began thinking about a similar approach to the people of my old East Boston neighborhood. Trenton Corner Market existed on the corner of Trenton and Marion Streets, just around the corner from Eutaw Street where I lived in the Eagle Hill section of Eastie. I had heard stories from Nanna and Babbononno about the Graziano family that owned the market, and how during the depression, they helped many a neighborhood family to survive.

My family was lucky during the depression. Babbononno worked as a furniture maker during the day and a musician at night. My three uncles, Paul, Nick and Gino, had day jobs and were also musicians at night. Mom worked days as a saleslady at Goldenberg's Department Store in Central Square. As a kid, I remember Babbononno telling the stories of how Trenton Corner Market extended credit to the folks in the neighborhood that needed food and didn't have the cash. He also mentioned that the owners knew what families were destitute and they would offer them what was called "extra meat and vegetables" that had to be cooked immediately or spoil. With these offerings, many a family did not go hungry during the worst depression ever experienced in America. And, the way the Grazianos phrased things, the families didn't look at the gifts as charity.

When I read Dr. Frank Mazzaglia's story about the shoemaker, I immediately thought of Trenton Corner Market. Above and beyond what Babbononno and Nanna used to say about how they treated the neighborhood people, I remember the stories about the Graziano family from an old college chum who was the son of one of the Graziano women. Paul Ciccharelli and I met at Boston State College and were in the same classes for four years straight. When I discovered his mother was a Graziano, and when Paul found out my grandparents shopped at Trenton Corner Market, he told me the stories of his family helping out folks in the neighborhood back in the '30s. Paul's stories were the same as what Nanna and Babbononno used to talk about at the dinner table.

I was touched by both the stories of the neighborhood shoemaker and Trenton Corner Market, but those were by-gone days when lots of people were new to America and people helped each other out. I wonder if any neighborhoods in America today have people with the same good intentions as in the decade of the 1930s.



L'Anno Bello: A Year in Italian Folklore

Wedding Bells, Evil Eyes, and Superstitions

A few days ago, a dress that I ordered for my friend's wedding arrived in the mail. As I unpacked it, I was immediately struck by its beautiful pastelflowered pattern, and I imagined how it would look like a garden in motion against a hot July sky. In addition, the dress, and the event to which it would be worn, reminded me of another fact. Summer is here, and for many people that means wedding season. There are many wonderful aspects that I love about weddings: the reunion of family and friends, delicious and intricately decorated cakes, pulsating dance floors, peals of laughter resounding through the room. However, in the midst of this joyous festivity, I am often reminded that Italian weddings carry a sinister side, enveloped in the world of superstition. Because marriage involves such a monumental life change, Italian society ascribes a number of superstitions to weddings, born of natural anxieties and the universal desire to prescribe good luck to the new couple. My family members still hand out confetti, or sugared almonds, as favors at showers and weddings. Supposedly, when wrapped in groups of five, they bestow fertility, health, longevity, happiness and wealth to the newlyweds. However, wedding confetti are merely a portion of the rich tapestry of Italian superstitions.

I love learning about superstitions because they are reminders of the values held dear by ancient societies. The superstitions that survived to this day tap deep into the fears and desires of the human subconscious: worries over our mortality, longing for a good harvest, a need for control in an unpreeveryday occurrences for both good and bad omens, and often black cat, for example, could be the harbinger of fortune or disaster (on a side note, I have a black cat, and I can attest that there is nothing bad about her!). Gathered below are some Italian superstitions repeated in my family, most from my grandmother. If you think that summer proves an odd time to talk about something as creepy as superstitions, keep in mind that Italian culture begs to differ. Ancient Romans celebrated many festivals honoring the dead during the spring and summer. Odd, perhaps, but in the harsh world of antiquity death was an ever-present companion — along with primal emotions of joy and hope-not matter what the season. So, in honor of wedding season, get ready to dive into the spooky side of Italian folklore:

The number 17 is bad luck: This is an oft-repeated nugget from my grandmother. In the United States, Friday the 13th serves as the quintessential bad-luck day. In Italy, it is the 17th of the month. The roots of this superstition extend to ancient Rome. Author Mirella Sichirollo Patzer theorizes that this belief originated from the fact that the Roman numeral for 17, XVII, can be rearranged to spell VIXI, a Latin word meaning "he lived" that is found carved in many ancient tombstones.

Malocchio: This translates to "evil eye" and is an extremely popular superstition not only in Italy, but in the entire Mediterranean world. Supposedly, looking at a person with jealousy or anger is enough to trigger a mountain of bad luck upon them. As such, Italians devised a plethora of charms to ward away malocchio. One of them is the cornicello, dictable world. People scoured a horn-shaped amulet found everywhere ranging from necklaces to home decorations, usuthe signs were contradictory: a ally colored bright red (when I

was little, I thought these were supposed to represent chili peppers). The cornicello is modeled after the cornucopia, a symbol of abundance and fertility in ancient Greek and Roman mythology.

Birds: My grandmother acquired a very ominous voice when she talks about birds, as they are generally harbingers of bad luck in Italy. A bird flying into the house is a death omen, perhaps because ancients viewed birds as being closer to the world of the dead due to their ability to fly. My grandmother mostly feared owls, which Italians also consider a death omen as a result to their intense stare and eerie cry. Conversely, however, owls also represent wisdom and knowledge.

Salt: Many readers will probably be familiar with the idea that spilling salt is bad luck, since this is a superstition that has reached all corners of the globe. It is also quite popular in Italy, and my grandmother swears by it. This superstition originates from the fact that salt was a very precious commodity in ancient times, and thus spilling it could really result in financial bad luck. Also related to the "precious commodity" line of superstitions are the Italian beliefs that it is bad luck to spill olive oil or throw away bread.

From birds and salt to numbers and amulets, Italian life is pepper with fascinating superstitions. Though most people do not take them as seriously as they did in the past, when uncertainty ruled the most basic interactions of daily existence, these superstitions are still followed out of appreciation of tradition or a sense of fun. Rite of passages and major life events, such as weddings, attract the bulk of these superstitions. As I enjoy my friend's summer wedding, I will also be thinking about the myriad superstitions that mark the Italian counterparts of these celebrations: the aforementioned confetti, the chiming of bells which originated as a way to ward off evil spirits, the belief that rain on a wedding day is paradoxically good luck, and the granting of the bomboniera, or wedding favor. No matter what occurrence life throws vour way, you can be sure that Italian society has some sort of interesting lore attached to it! So as you enjoy the warm summer weather, make sure to watch your saltshakers and guard your eyes, whether or not you are attending a wedding!

College Student Loan Scams

Congratulations to the Class of 2019! As students across the country look toward their future, two-thirds of all college graduates will also begin receiving their first bill to repay college their college loans.

Scammers may try to take advantage of recent college grads by offering services to help lift the burden of student loans, such as lowering your monthly loan amount, "cancelling" your debt immediately, and consolidating multiple federal student loans, but really just charge a staggering price for a service. Scammers may also tell you that you are eligible for loan forgiveness programs; you just need to pay a small fee to get things moving. In reality, the program is fake and the scammer takes your money or personal information (federal student ID) and disappears.

Remember, you will never be randomly selected for a student loan forgiveness program. Student loan forgiveness programs do exist, and it is possible to have your loans discharged, but there is an application and review process. Never believe someone who indicates you're eligible for loan forgiveness but you need to act quickly and pay right now!

If you do need assistance with repaying your loans, you have options:

studentaid.ed.gov/sa/repayloans/understand/servicers. A loan servicer is a company that handles the billing and other services on your federal student loan and they will work with you on repayment plans and loan consolidation — for free!

- Apply for an Income-Driven Repayment Plan
- · Consider refinancing or consolidating your loans
- · Options also exist for refinancing or consolidating your private loans.

Finally, it is that important students (and their parents) remember that there is no federal student tax. In 2018, many borrowers reported calls indicating that they owed a federal student tax and that if they didn't pay the IRS immediately they would be arrested. Not only does this tax NOT exist, but the IRS will never call you and demand immediate payment or threaten you with jail.

If you suspect you are a victim of a student loan scam, change your username and password immediately and stop making payments to the scammer. Contact your lender or servicers as soon as possible and make them aware of the situation. Report student loan scams to FTC.gov/complaint



Santiago tells Manolin that on the next day, he will venture far out into the Gulf Stream, north of Cuba in the Straits of Florida to fish, confident that his unlucky streak is near its end. On the eighty-fifth day of his unlucky streak, Santiago takes his skiff into the Gulf Stream, sets his lines and by noon, has his bait taken by a big fish that he is sure is a marlin. Unable to haul in the great marlin, Santiago is instead lulled by the marlin, and two days and nights pass with Santiago holding onto the line. Though wounded by the struggle and in pain, Santiago expresses a compassionate appreciation for his adversary, often referring to him as a brother. Worn out and almost delirious, Santiago uses all his remaining strength to pull the fish onto its side and stab the marlin with a harpoon. Santiago straps the marlin to the side of his skiff and heads home, thinking about the high price the fish will bring him at the market and how many people he will feed. But his journey turns into the fight of his life. Based on the Pulitzer Prize-winning novel by Ernest Hemingway.

FELIX AUSTRIA (DVD) IndiePix Films

Nanna & Babbononno

A Nostalgic Remembrance



Happy belated 4th of July! Summer has finally arrived and most folks I know celebrated the first summer holiday with back yard barbecues. Others headed to Cape Cod, New Hampshire, Maine, or the coastal area of northern Massachusetts to picnic and watch fireworks. On the 2nd, Loretta and I celebrated our 42nd anniversary and we headed north for a couple of days for a quiet get away.

On summer holidays, it was difficult to tear Nanna and Babbononno away from the back yard. This is where they felt most comfortable when they could be surrounded by the entire family. Several times, though, I remember Dad and my uncles preparing for a 4th of July picnic at Mystic Lake. The location was close enough for family members from the North End, East Boston, Medford, and Saugus. Back in the day, this is where most of the family lived, and Mystic Lake seemed to be dead center for one and all.

Dad would call the MDC and reserve a fireplace and picnic table way in advance. From there, he and my uncles would begin to put together a list of family members who should be invited. From my grandparents generation would be Nanna and Babbononno, Nanna's brother (Babbononno's closest friend) Zio Antonio Ceruolo and his wife Mariuccia. Next would be Nanna's youngest brother, Zio Luigi and his wife, and maybe Nanna's remaining sister, Zia Peppa and her husband, Zio Michele. From my folks generation would be Mom's cousin Louise Pepe and her husband Ralph with their kids, Lulu, Anthony, and Ralph. Another of my mother's cousins, Marie Beatrice and her husband, Al were always included, and from the immediate family Uncle Paul and Aunt Eleanor with their two daughters Paula and Ellie, Uncle Nick, who was divorced at that time, and Uncle Gino and Aunt Ninna with their infant twins, my cousins Richard and Donna.

In spite of this being a genuine American holiday, the women of the family would begin cooking their specialties that only had to be reheated before being served. With Dad's list in hand, Mom and Nanna would head to the local butcher shop and buy pounds of steak, pork chops, spare ribs, hot and sweet sausages, ground hamburger, and hot dogs. Mom and Nanna would head to a greengrocer and buy the ingredients for a garden salad and an assortment of summer fruits, especially peaches, cherries, and a

watermelon. Cut up peaches were great in wine, the Italian version of sangria.

Dad and my uncles would head for a liquor store and stock up on beer and hard stuff. God forbid, someone would buy a bottle of wine. My grandfather and great uncles made wine in their cellars. To purchase wine in a liquor store would be an "infamnia." Zi'Antonio would bring a few gallons of his best red wine (it was that good), and the old-timers would be happy about that. Once Dad picked up a couple of bags of charcoal, we were ready for the 4th.

Recreational equipment was on the minds of the men also. We kids would bring bathing suits so we could swim in Mystic Lake which had a public beach near the picnic area. We also brought baseball equipment, a bat, a ball and gloves. I had a badminton set and always brought that along for my female cousins. We wouldn't let them play baseball with us boys. The old-timers brought their sports equipment with them, too, a set of bocce balls, a deck of American playing cards and a deck of Italian playing cards for those that wanted to play scopa, briscola, and sette bella. An Italian deck doesn't have 8s, 9s, and 10s in the deck, and the jack is higher than the queen.

On the morning of the 4th, we would arrive at the lake early and locate the barbecue and picnic bench that Dad had rented. Everyone would help out bringing the food, liquids, and bags of charcoal to the table. Dad even brought a portable charcoal burner and a Coleman gas stove that we used when we traveled. As the morning wore on, the rest of the family would begin to appear, each section bringing something in the way of food and drink to add to the mix. When Dad saw that most of the family had arrived, he would get the charcoal going and the pre-cookout food would be set on the picnic table, cold cuts, several types of cheese, olives, sun dried tomatoes, and loads of other things to pick on before the meats were roasted over the

We kids would head for the lake and a before dinner swim. While we were in the lake under the supervision of an uncle or cousin Lulu, who was the oldest of my generation, the pasta courses would be laid out on the table. When the folks started on the lasagna, ravioli, or other macaroni with the accompanying meatballs and gravy meat, Dad would begin grilling. Sausages and steaks got the priority. We kids liked

the hot dogs and burgers. The old-timers wouldn't touch them.

After the salad that followed the meats were eaten, we kids would begin to play baseball, and the men bocce. Later when dessert was laid out on the table, Dad would have two pots of coffee brewing on the Coleman stove, one Italian and the other American. Dessert consisted of fruit and a potpourri of items brought by each family. Connoli usually won out as being the most plentiful. Throughout all of the courses, Zi' Antonio would pour his wine. Some of the men opted for a cold beer instead and we kids, who were allowed to take only one sip of wine, were relegated to helping ourselves to ginger ale, 7Up, or Saraford Orangeade.

After all the food was eaten, the ladies would clean up and repack whatever wasn't consumed. Dad would clean his charcoal grill and the old-timers would play Italian card games, or if they weren't too tired, bocce. Within a half hour or so, most of the men would be sitting in folding chairs sound asleep. The ladies would be at the table sipping a second cup of coffee talking about family and friends, and we kids would be arguing with our mothers who insisted that we couldn't go back into the lake. According to them, we had to wait an hour after eating before going swimming or we would get cramps and drown. Fifty-five minutes later, we were back in the water.

At sundown, everyone would say goodbye to one another. This was a process that would take at least a half hour to an hour. The cars would be repacked and by the time Dad was exiting the parking lot, I would be asleep in the back seat, accompanied by Babbononno who was snoring even before my eyes were closed.

That's the way we celebrated the 4th, a genuine American holiday ... celebrated Italian-style. Happy belated 4th for 2019, and may GOD BLESS AMERICA

Recipes from the Homeland

ASPARAGUS OMELET

2 cups cut-up fresh, frozen or canned asparagus

4 beaten eggs or equal quantity of egg substitute 1 medium onion (optional) 1/4 cup olive, canola or vegetable oil

Cut up fresh asparagus, wash and par boil or steam in a saucepan. Set aside and dry with paper towel. To prevent dangerous oil splattering, be sure asparagus are dry before placing in skillet with oil.


Remove skin from onion. Cut onion in half, and cut each half into 1/4-inch long slices. Set aside.

Heat oil in skillet before adding asparagus. Fry asparagus slowly for about five minutes, stirring frequently. Add onion to skillet (optional) and fry until onion is slightly browned. Stir frequently. Meantime beat eggs thoroughly in a bowl. Add salt to taste. Skillet should be well heated before gently pouring beaten eggs in a circular motion over the asparagus/onion mixture. Lower burner. Using spatula, lift mixture slightly. Tip skillet, allowing beaten eggs to slowly drain under the asparagus. Repeat this process on opposite side of skillet until only small portions of the eggs remain on top. Gently shake skillet over burner to keep mixture from sticking to bottom. Carefully slide the mixture onto a platter. Return the mixture face down into the skillet. Fry slowly until all of the eggs have cooked. Slide omelet carefully from skillet onto a platter for serving.

VARIATIONS: In place of asparagus, use cut-up green peppers, vinegar peppers, potato pieces, ham, or frankfurters. Cheese of choice and/or mushrooms can be added to the omelet. Another option is to scramble all the ingredients in the skillet after adding the beaten eggs. Stir until beaten eggs cook thoroughly.

NOTE: Omelets or "Frittati," as my mother called them, were frequently prepared during my childhood. My favorite high school lunch was a pepper and egg (omelet) sandwich. Now that I realize what a strong aroma the pepper and egg omelet has as a sandwich, I often wonder what my classmates thought when I opened my brown lunch bag.



Where are the Gloves from the Dempsey/Willard Fight?

Could the King Tut's Tomb of Boxing Be at 50th Street and Eighth Avenue?

One hundred years ago, on July 4, 1919, in Toledo, Ohio, Jack Dempsey won the Heavyweight Championship of the World from Jess Willard. The fight, which took place under a blazing sun, is remembered for many things. It ushered in the Dempsey era and the making of a legend. The footage of the fight, which is amazingly clear, shows Jack giving the champion a vicious beating. Though he was outweighed by nearly sixty pounds, Dempsey tore into Jess like a hungry lion. He decked Willard seven times in the first round and Jess was on the verge of being counted out when he was saved by the bell. Willard managed to stay on his feet for two more rounds and fought back gamely before retiring as the bell rang for round four.

In 1963, Jack Kearns, who had manage Dempsey at the time he won the title, wrote an article that was published in *Sports Illustrated* saying Jack's gloves were loaded when he fought Willard. Dempsey vehemently denied it and sued the magazine for publishing the article. They settled out of court.

There had been bad blood between Kearns and Dempsey for years, and Kearns died not long after he wrote the article. It was as if he wanted to get one last shot at the great champion before he shed his mortal coil. He certainly did that and the controversy has raged on for years.

Much has been written about whether or not Dempsey went into the fight having an unfair advantage, and I am not going to rehash those arguments now. I do want to bring up another mystery that is connected to that day.

In all of the arguments over whether or not Jack's gloves were loaded that day, one thing that was never done was to have an examination of those gloves. In fact, nobody seems to know for sure what happened to them.

Not long after the Kearn's story appeared, former Bantamweight Champion Babe Herman announced that he was in possession of the gloves. He said they were given to him years earlier by a seaman, though he said he couldn't remember the man's name. He claimed the man was a close friend of Dempsey's and also a friend of his. He didn't say how the man got them and didn't offer and convincing evidence of their authenticity. Babe said that Dempsey knew he was in possession of the gloves and even suggested they be put in a glass case at his restaurant in New York.

This doesn't add up, as there is a newspaper photo that was taken on December 10,1934, that shows Jack Dempsey placing what he claims are the gloves from the fight under the cornerstone of his soon to be built restaurant at the corner of 50th Street and Eight Avenue in New York City. This was directly across from the old Madison Square Garden. In the photo he is accompanied by his wife Hannah and Mayor LaGuardia along with a number of other


people. Did Jack forget about this when he was talking with Herman, if indeed such a conversation actually took place.

One of the reasons for examining the gloves would have been to see if there were traces of plaster of Paris in them. Kearns claimed he soaked Dempsey's taped hands in the substance before the fight. That claim has been pretty much debunked, but checking the gloves would completely rule out that possibility.

Of course, the gloves in the photo very well may not have been the ones Jack wore that hot July 4th afternoon. It is possible they were just an old pair of boxing gloves and the whole thing was staged for publicity for Jack's new restaurant. It does seem odd he would bury the gloves rather than put them on display. Perhaps, he was getting rid of the evidence, though that wouldn't have added up since this was almost thirty years before Kearns wrote the story that got things stirred up.

Still, it would be interesting to uncover the gloves. Jack eventually moved the popular restaurant to between 49th and 50th Streets. It doesn't appear the gloves went along for the ride.

Could they still be buried at that location? It's very likely. Are they the gloves Jack wore when he beat Willard? I doubt it, but it is possible. There is only one way to find out. Recovering them would be one of the great finds in the archeology of boxing. I say an archeological dig should be ordered for the site. It is time to recover this rare artifact from the reign of one of the greatest kings in the history of boxing. Can you dig it?

WILL OLD TIMES RESUME? — From February $25^{\rm th}$ to the middle of June, they were teammates, chasing the same dream and pursuing the same goal — to win the Stanley Cup.

But prior to their meshing of desires and deeds Marcus Johansson and Brad Marchand had a history, one might say. One need not go back too far — only to January 23, 2018, when Johannsson, then playing for the New Jersey Devils, took an elbow hit from Marchand that sidelined him for 28 games — a third of the regular season NHL schedule.

For his part in that on ice meeting, the NHL powers that be suspended Marchand for five games and fined him just under \$373,500 for his conduct.

Fast forward 13 months later and Bruins General Manager Don Sweeney swung a deal that brought Johansson to the Hub for the last few weeks of the regular season and what turned out to be a full four-round Stanley Cup playoff run.

So, when Johansson showed up at the Garden back in late February to be sized up for the Black and Gold attire that he would be wearing for the balance of the 2018-2019 regular season and beyond there were definitely some conversations that were warranted.

According to media reports at the time, Marchand and Johansson essentially buried the hatchet and agreed to move forward.

The winger from Sweden wound up with 13 goals and 17 assists for a total of 30 points over a 58-game span during the regular season (including 10 contests down the stretch for the B's) plus four goals (two on the power play) and seven assists in 22 playoff games as a third line forward.

Thus, it was interesting during the first week of NHL free agency when Johansson signed a two-year deal with the Buffalo Sabres for a total of \$9 million. The Bruins might have retained him, but not at that price. Money may not be everything, however.

Consider the move. Johansson just left a team that went all the way to the Stanley Cup Final. And the team he decided to sign with? The Sabres have not even qualified for a berth in the Stanley Cup playoffs for the past eight years. If his objective is to be on a Cup contending team that was not a move in the right direction.

And what about whether Marchand and Johansson will revert back to their old battling ways now that they are once again on separate teams? Well, we will have to wait a while to find out.

The two teams meet at the Garden on November $21^{\rm st}$, then essentially play two games in a row just after Christmas (December $27^{\rm th}$ in Buffalo and December $29^{\rm th}$ at the Garden). There is a final regular season matchup slated for March $13^{\rm th}$ in Buffalo.

By then we'll know whether hard feelings are really in the past or indeed are meant to last.

MIKE SIGNS UP FOR MORE — It's been more than a decade now since South Shore native Mike Sullivan presided over the team of his boyhood dreams from behind the bench on Causeway Street.

And now comes the recent news that the former Bruins mentor, who grew up in Marshfield, has signed a four-year contract extension with the Pittsburgh Penguins that will keep the two-time Stanley Cup winning coach employed through the 2022-2023 season.

It seemed that Sullivan grew up close enough to the Garden to feel the ice chips, playing first at Boston College High School and then a full four years for legendary coach Jack Parker at Boston University. As a plus, he had a moment of glory in the Garden, scoring a shorthanded goal for the Terriers in the 1989 Beanpot.

After that, he played 11 seasons in the NHL, scoring 54 goals and adding 82 assists for a total of 136 points over a span of 709 games. Sandwiched in was a single season (1997-1998) on Causeway Street where he saw action in 77 games as a center while recording 5-13-18 totals.

Although he would go on to finish his playing days with Phoenix, the B's never forgot Mike. Following his retirement in 2002, he was immediately assigned the head coaching job in Providence for the 2002-2003 season.

After only one year with the AHL affiliate, Sullivan was named the head coach of the Bruins. He was 35 years old, raring to go and he didn't disappoint — at least not in the regular season.

Come April, the Bruins had finished in second place in the Eastern Conference regular season standings with 104 points. Their first assignment in the opening round of the playoffs was to beat the seventh place team. There was one fly in the ointment so to speak — that seventh place team happened to be the archrival Montreal Canadiens.

The series went the full seven games and when it ended on Patriots Day night, there were celebrations in Montreal and dismal feelings in the Hub. The Canadiens had won Game 7 via a 2-0 shutout at the Garden.

The next year the NHL shut down for a season-long lockout. When things resumed for the 2005-2006 campaign things were not the same. The B's didn't qualify for the playoffs and new GM Peter Chiarelli went in a different direction. Sullivan was out in the spring of 2006 and Dave Lewis (remember him?) was in.

Over the course of the next eight years, Sullivan would serve as an assistant coach with several teams — Tampa Bay, the New York Rangers, and Vancouver.

Finally, in 2015, he was named the head coach at Wilkes-Barre/Scranton, the AHL affiliate of the Pittsburgh Penguins. He didn't stay there long. As the Pens languished, management made a move, firing head coach Mike Johnston in December 2015.

In came Mike Sullivan and the rest is history. Six months later (June 2016) the Pens were prancing with the Cup, having defeated the San Jose Sharks for the title (just like Craig Berube did with St. Louis this past season). And just to prove it wasn't a fluke, there was a repeat, with the Pens defeating Nashville for the Cup in 2017.

Mike Sullivan has reached hockey's summit twice. Can he do it again? Only time will tell.
