## Italian Navy Training Ship The Amerigo Vespucci to Visit Boston July 18th to 22nd



From the 18<sup>th</sup> to the 22<sup>nd</sup> of July, the Italian Navy Training Ship Amerigo Vespucci will be in Boston, the seventh port of call board the Amerigo Vespucci

of the Training Campaign 2017 for the Italian Navy.

The Training Campaign on

represents a key element in cadet professional development, passing on the Italian Navy's core values of love for the sea, ethics, loyalty and honor.

On the 19th of April, the "most beautiful ship in the world" set sail from the Italian Naval Base in La Spezia to start the Training Campaign 2017. So far, she has visited two ports in Portugal (Sines and Funchal), then, after 20 days of navigation across the Atlantic ocean, Hamilton, in the Bermuda islands, and three ports of call in Canada: Halifax, Montreal and Quebec City.

During the port visit in Montreal, the 79 one-term volunteers of the 24th Course, who had been on board since the unmooring from La Spezia, were replaced by the 125 Italian Naval Academy cadets of Livorno (including 11 foreign cadets).

Navy cadets learn the basics of seamanship, putting into practice what has been studied so far in the books by getting familiar with the marine equipment, climbing up the masts, and using the sextant to calculate the position of the ship with the stars. They all have been splendidly promoting Italian excellence and will go on upholding the prestige of the Italian Navy abroad through cultural and promotional events in collaboration with our diplomatic representations in host countries.

More than 22 000 visitors in the various ports have had the opportunity to appreciate the Amerigo Vespucci's style, which is one-of-a-kind, and her timeless beauty.

During her stay in Boston, the Italian Navy Tall Ship Amerigo Vespucci will be moored at the World Trade Center Pier and will be open to the public on the following dates/times:

Tuesday, July 18th, 4:30 - 6:30 pm Wednesday, July 19th, 3:30 - 4:30 pm Thursday, July 20th, 10:30 am - 1:00 pm Friday, July 21st, 10:30 am - 1:00 pm and 3:30 - 5:30 pm

After Boston, the Amerigo Vespucci will proceed to New York, continuing to represent our country in unusual ports of call for the Italian Navy.

#### About the Amerigo Vespucci

The Vespucci and her sister ship, Christopher Colombo, were designed by the Marine Engineer Major Francesco Rotundi, director of the shipyards of Castellammare di Stabia near Naples in Italy. The ship was launched on February 22, 1931. Since then, she has always performed her core training activity for the Italian Naval Academy cadets. The Amerigo Vespucci is a sailing vessel equipped with an auxiliary power plant, and is a full-rigged ship with three masts (fore, main and mizzen), all three equipped with yards and square sails; the bowsprit functions as a fourth mast.

From 2014 to 2016, the Vespucci underwent a major overhaul period, aimed at restoring operational effectiveness and upgrading accommodation areas and facilities. More efficient and eco-friendly electric power and propulsion systems were installed, reflecting the Italian Navy's commitment to environmental sustainability.

For the Vespucci's "rejuvenation" and "restyling," the shipyard workers cooperated in full synergy with the ship's crew under the coordination of the La Spezia Naval Shipyard technical direction, notably its Shipyard studies Department.

Since her entry into service, the ship has carried out training activities every year except for the year 1940, due to war events, and the years 1964, 1973, 1997 and 2014 to 2016 when she underwent major overhaul periods. The Vespucci provides training not only to the Naval Academy cadets, but also to on-term volunteers and students of the Francesco Morosini Naval Military School.

The crew consists of approximately 270 personnel, both men and women. This year, a number of on-term volunteers have been embarked for the first part of the Campaign to be replaced during the stopover in Montreal, Canada, by the Naval Academy cadets, who will start their summer training campaign. The crew will then total approximately 400 personnel on board.

The Amerigo Vespucci has been a UNICEF goodwill ambassador since September 2007.

#### Chicago Still Dodge City







possessed a God-given voice. The only thing that he didn't know was that God had scheduled it to be given to a man named Pavarotti about 1,900 years later. Nevertheless, he made his debut in a theater at Naples, and the performance was disrupted by a sudden earthquake shock, indicating that even God was displeased. During all of his later performances in Naples, the house was packed with persons who were paid to applaud. He also toured some of the singing contests in the Greek provinces. His performances were greeted with great applause in burlesque fashion. This caused him to declare that the Greeks were the only ones who had an ear for music and that they, alone, were worthy of his efforts.

When he was singing, no one was allowed to leave the theater

Nero always thought that he some women even gave birth there. The gates were closed and guarded. Consequently, those who were more athletically inclined leaped from the walls to escape, while others faked death and had to be carried out as if to be buried. In an effort to erase the memory of some of the great singers of that day, he had their statues or busts thrown down, dragged off with hooks, and cast into the public privies.

Nero also had visions of becoming an Olympic champion. He appeared at the 211th Olympiad with 5,000 attendants. The main purpose of the attendants was to cheer him on to victory in the chariot race. No one dared to oppose him, but even as the sole entry, he fell off his chariot, had to be assisted back on board, and still couldn't finish the race.

ner by a jury that wouldn't have voted any other way. Upon his departure, he presented the entire province with their freedom and conferred Roman citizenship on the judges along with a large sum of money. He returned from his Olympic fiasco by first entering Naples through a breach in the wall in the manner of returning Olympic champions in ancient Greece. He then entered Rome in like manner, except that he rode in the chariot that Augustus had used in his triumphs of bygone days. He wore a purple robe with gold stars, and on his head he wore the Olympic crown — a wreath of sacred olive leaves. A massive parade led through the Circus Maximus, then through the "Porta Triumphalis," and on through the Forum Magnum Romanum to the Temple of Apollo, where our great hero laid a wreath at the foot of the temple and gave thanks to his gods once again, exactly as it was done by the Olympic champions in ancient Greece. All along the route, prisoners were slain as human sacrifices to this champion of champions. The path of his triumphal parade was sprinkled with perfume, while applause and honors were showered upon him. It follows then, that the shame and the sham of Nero, one of the most pathetic fiascoes that the sports world has ever known, was honored by probably the greatest victory parade that this same world will ever see.

# The Wicked mart Investor

#### Make Mine a Treasure Chest

The outgoing governor, international press, and local mucky-mucks all sat silently as the historical time capsule was opened at the Museum of Fine Arts. Originally placed in a cornerstone of the Massachusetts statehouse by our forefathers, the contents could provide more clues to our colonial past. The crowd was transfixed; what was in the box? The possibilities seemed endless that January 2015 night.

Well, while historically significant, the artifacts left some people disappointed. Our colonial fathers did not make much, so they did not have much to leave us. Observers hoping for a miniature swan boat, a prototype Jordan Marsh blueberry muffin, or maybe a coveted invitation to Kathryn Whites' birthday party were in the wrong place at the wrong time. What the time capsule held were coins, old newspapers, and a silver plate. Only the history buffs were fascinated.

What does your time capsule hold? Before you say you don't have one, let me explain. Your time capsule is the box or desk drawer holding all your mutual fund statements that you never review. They may be IRAs, 401ks, 403Bs, etc., that you have not looked at because you think everything is just fine. But is that what you want to settle for, "just fine?" Take the advice of legendary money manager Peter Lynch: "You have to know what you own and why you own it" and you will likely do better than "just fine."

The Wicked Smart Investor has unearthed many surprises when reviewing people's dust-covered investment statements. I don't even have to lie on a wooden plank and chip away at stone like MFA conservator Pam Hatchfield did to remove the colonial time capsule. While some of the investment surprises I find come out of left field, most of my discoveries usually involve three critical issues.

First, a frequent discovery is the investments are not proper for the investor's risk tolerance. The investments might be too risky or not risky enough. The only way investors earn a return in the stock market is to take risks, but if the risk level is too high and causing lost sleep, it's not worthwhile. It's prudent for investors to assess their risk level first, and then select appropriate investments.

Next, a robust analysis often proves investors are not as diversified as they think. You may own several mutual funds with glitzy names from Greek mythology or space age buzz words and think you are diversified, but you're not. Managers at the larger funds frequently purchase the same stocks because the companies are deemed "hot stocks." Many times, the "hot stocks" don't live up to the hype. By not diversifying, you likely are missing out on the stocks that usually give the best performance over the long run.

Finally, a qualified advisor may point out that you are paying too much in expenses. Quick, without looking at anything, how much are you paying in expenses? Most investors have no idea, but the more you pay to the mutual fund company, the less goes into your time capsule. Over time, what seems like small dollars add up. I'm sure you agree that the money would look much better in your account.

It's all your choice. You can place your investment statements in a time vault and maybe do "just fine," or review your portfolio with a qualified advisor and maybe build a jampacked treasure chest. Getting your financial house in order doesn't take the effort of an archaeological dig and it may be the best gift you leave for your future self.

A Very Merry Birthday

Thursday, July 20th, and it has gotten me thinking about these unique celebrations in general. Birthdays fall under the category of rites of passage, or milestones, and, as a result, cultures around the world celebrate birthdays with special customs and traditions. While we think of birthdays as great opportunities for parties and food, in ancient times people viewed birthdays as dangerous occasions because of their liminality, being poised between one year and the next. As such, birthday parties included — and continue to include - loud noise and noisemakers to scare off the evil spirit believed to be lurking around during this period. Many vestiges of these ancient fetes remain. From

check, here are special birthday tra-

ditions from around the world.

My birthday is quickly approaching on

Our first stop, of course, is Italy, one of the original homes of the birthday cake. Though scholars are still unsure about the roots of the birthday cake, many theorize that these sweet treats originated in the Mediterranean world. Ancient Greeks baked round cakes to honor Artemis, the goddess of the moon and the hunt, and then illuminated the cakes with candles in order to better resemble the moon. The ancient Romans, on the other hand, made sweet honey cakes to serve at birthdays and weddings, where they were traditionally broken over the bride's head for good luck! However, the custom of placing candles on a birthday cake comes from Germany, where a large candle was often situated in the center of the cake to symbolize life. Modern Italian birthday traditions resemble those of America. People gather for a birthday cake, food, a party and gifts. There are some differences, however. Beware of people pulling on your earlobes if you celebrate your birthday in Italy — they will pull the corresponding number of years you are turning. Also, if a group of friends go out to dinner, it is the friend celebrating the birthday who is expected to pay for the meal. Finally, since saints are an important part of Italian society, children are often named for the saint whose day coincides with their birth day. Or they may celebrate on a smaller scale during the day belonging to the saint who shares their name. My father, for example, was born on August 16th, which is Saint Roch's day, and so my grandmother appropriately named him Rocco!

Foods are an important part of birthday celebrations around the world. Australian children can expect to be served the charmingly named Fairy Bread, or buttered bread covered with multicolored sprinkles, during their parties. Children in Brazil receive marzipan candies shaped like fruit. Can-

> dies feature in Mexican birthdays as well, where they are concealed in a piñata, which is later broken open by blindfolded guests. The Dutch, on the other hand, like to feast on pancakes sprinkled with powdered sugar. Many birthday

foods also reflect the theme of good luck for the upcoming year. A person celebrating their birthday in China will eat long noodles, which symbolize a long life. Russians have birthday pies instead of birthday cakes, and a message bestowing good fortune upon the birthday person is inscribed in the crust. Finally, Canadian chil-

dren can expect a more immediate form of luck at birthday parties. Whoever finds a coin hidden in his or her slice of birthday cake will have the first turn in all of the feast's games! In addition to food, sometimes the specific age a person is turning forms the focal point of birthday celebrations. Usually these special birthdays honor the entrance into adulthood. The United States has "sweet sixteen" celebrations, while Latin American countries hold elaborate quinceañeras when a girl turns fifteen. These parties can rival weddings and the girl often shares a special dance with her father. In the Jewish tradition, bar or bat mitzvah rituals on a teenager's thirteenth birthday welcome the boy or girl as adult members of the community.

Birthdays are a special time to honor both human joy and resilience. They indicate that we have once again made it through a year filled with myriad human emotions, from happiness to disillusionment, challenges to triumphs. They remind us that we have the strength to endure. Like holidays, birthdays are an indication that the year cycles on, and that is a good reason to celebrate. Whether we celebrate with cakes or dinners, when we honor a birthday, we honor the passage of time, but also all that is timeless — love and family and good food. That is the true meaning of the candles winking and blinking cheerfully on a birthday cake, a symbol that, like us, has come a long way.

#### A Short Comedy about Baseball



Baseball and Bloomers

In the eleven years it operated (1909 to 1920), New York's Thanhauser Film Corporation produced over a thousand films. Neither the studio nor the movies produced under its roof are well remembered today, though one, the socially conscious The Cry of the Children from 1912, was inducted into the National Film Registry.

The studio itself resulted from the labor of Edwin Thanhauser and, until 1912 when it sold to the Mutual Film Corporation, it was the leading independent film studio. By 1914, the Thanhauser Film Corporation had survived two major catastrophes. One was a fire which destroyed the main facility in New Rochelle along with many film prints, equipment, and costumes. Fortunately, the company had by then established subsidiary studios which accommodated film crews for current productions while the main studio was rebuilt. It even inspired

them to make a film about the disaster entitled When the Studio Burned.

However, though company stayed afloat for five more years, the 1914 death of studio manager Charles Hite in an automobile accident proved harder to recuperate from. Thanhauser took to managing the studio himself, but found revenue to be dropping and keeping up with the evolving industry difficult. He closed his creation in 1919 and liquidated it the following year.

A good number of the films produced at the Thanhauser studio survive, though a number, inevitably, have been lost. Among them is Baseball and Bloomers, a short comedy from 1911 about a female baseball team that takes revenge on a men's team that taunts them when they challenge on the

All that is known from the plot comes from a write-up in The Moving Picture World



describing it as follows: "Miss Street's Seminary for Girls has a very ambitious class of pupils. The young athletes, not content with basketball and tennis, aspire to shine in the great American game, and organize a baseball club. They are so satisfied with themselves that they finally send a challenge to Adair College, which has a crowd of husky young athletes in a club that thinks it amounts to something. When the challenge is received, the boys are first angry, then amused. They decide to accept it, to have fun with the girls. The young women, after some practice, realize that their team, while it may be pretty to look at, is of little real use on the diamond. And the prospect makes them weep. Fortunately for the girls, Jack, the brother of the president, arrives from Harvard. His chum, Jim, is with him. These two young men are baseball stars themselves, and when they are told of the predicament of the girls, they good naturedly offer to help them out. The university men disguise themselves as girls, act as battery for the young women, and the college boys, who had looked for a laughable victory, are mowed down, inning after inning, because of the work of pitcher Jack and catcher Jim. The other members of the 'girl' team have nothing to do except look pretty. When the boy athletes have retired from the field vanquished, the girls reward their battery with one kiss only one — from each of the other seven players."

Not much is known of the production or the credits. Even the director and writers remain unknown. What is known, though, is that Baseball and Bloomers was the debut of Marguerite Snow, who would go on to build a career at Thanhauser's studio. The film had a wide release ranging from Pennsylvania to Hawaii and garnered good enough reviews. Its loss follows a similar pattern of lost films from the first half of the twentieth century and was probably a casualty of the 1913 studio fire.





The Hitmen Have a Hit in Ogunquit **BULLETS OVER BROADWAY** 

Early in Bullets Over Broadway, now playing at the Ogun-Playhouse, playwright David Shayne and a group of artist friends are discussing a hypothetical situation. The situation was if a building was burning down and you had to choose between saving a person or the last remaining copy of the works of Shakespeare, what would you choose to do? Shane and most of his friends said they would save the Shakespeare, as art was more important than the life of just one person. Later in the play, he would be tested on this question, and find the decision to be a bit more complicated.

Bullets Over Broadway is adapted from the 1994 Woody Allen film of the same name. It has been turned into a musical, and after seeing both the movie and this fine production, I have concluded it should have been a musical from the outset.

It does not have an original score. The music consists of catchy tunes from the period between WWI and WWII. Some of the songs will be familiar to the audience and some are fairly obscure. The music adds an atmosphere that was missing in the movie; it works, and it works well.

David Shayne, Playwright played with just the right amount of angst and comedy by the very talented John Rochette, has reluctantly agreed to compromise some of his artistic integrity by allowing the girlfriend of mob boss Nick Valenti to have a role in his play in exchange for having the gangster bankroll the production. Vincent Pastore, reprising his role from the original Broadway version of Bullets, is ideal as the man who takes time between musical numbers such as "Gee Baby, Ain't I Good To You" (which is sung to his ditzy girlfriend Olive, played by Jemma Jane) to order hits on his enemies.


Ms. Jane is a hoot when she sings "The Hot Dog Song," a saucy piece filled with double entendres and some interesting moves on her part. She appears to relish her role as the not so bright Olive. It is all such fun.

Reed Campbell is positively outstanding as Cheech ("Not Mr. Cheech, it's just Cheech"), Valenti's top hit man, who has been charged with keeping an eye on Olive as she attends rehearsals for the play. Cheech still finds time to make a hit while tending to Olive. There is an interesting scene where he and an accomplice take a victim for a ride while singing "Up a Lazy River." Sure it's morbid, but it is also very funny.

Meanwhile, Shayne seems to be at peace with the deal he has made now that leading Lady Helen Sinclair (Michele Ragusa) has agreed to star in his play. That peace is soon dis-

rupted when he hears Olive rehearsing her lines with a voice that makes him cringe. He lights up the stage with "I'm Sitting on Top of the World." Mr. Rochette shows great chops as a singing and dancing man as he moves about the stage. He is very good.

Ms. Ragusa does a fabulous job as the aging diva with a touch of Sunset Boulevard mixed in. Using an overly dramatic theatrical voice, she is funny without becoming a caricature. She and Mr. Rochette are delightful as they sing "There's a Broken Heart for Every Light on Broadway."

One of the many high points of the play is when Cheech and his fellow gangsters perform the song and dance number, "Tain't Nobody's Bizness if I Do." Reed Campbell was absolutely fantastic in this highenergy number and had many audience members on their feet by the end. Campbell is an amazing talent who time and again wowed the crowd at the Playhouse.

In this interesting and comedic story, we see Cheech taking over authorship of the play as Shayne has to deal with having compromised his artistic integrity. Along the way we are treated to dancing hot dogs, an amazing set consisting of New York City rooftops, a train, a vintage car, an actor doubling as a compulsive eater who gives a new meaning to growing into a are also gifted with the amazing Sally Struthers as Eden Brent. She appears with her little dog, who also displays great acting ability. Ms. Struthers take the stage in Ogunquit each season and never disappoints. She is a

master of comedic timing.


This production is directed by Jeff Whiting, who worked closely with Susan Stroman on the original production. He has recreated that direction and choreography for this show.

I want to add that both John Rochette and Reed Campbell are extraordinarily talented young actors. Having them share the stage with such experienced actors as Vincent Pastore and Sally Struthers is great to see. Both of these men have promising careers ahead of them. I could also say this about the entire cast. Everyone was wonderful. You could feel the energy and excitement as it spilled into the audience. This is musical theatre at its best. It is the Ogunquit Playhouse at its best.

Although there are a few that would not see again, I am rarely disappointed by a show at the Playhouse. The vast majority are very enjoyable. Bullets Over Broadway ranks as one of the best I have ever seen there. I strongly recommend you get to Ogunquit and see this production. I have a feeling tickets will be selling fast, so I would not hesitate.

David Shayne ends up with a different answer to the question of whether or not to choose Shakespeare over the life of a human being when he is faced by the choice Cheech makes when dealing with Olive dragging the play down. It turns out Cheech has more artistic integpart, and wonderful lighting. We rity, but David has found his humanity.

The music from Master of None is a potpourri of songs, many with International flavor. While it is sad to see most anything come to an end, it is with a celebratory sound that Glen Campbell gets a chance to create his farewell studio album Adios, which puts an exclamation point on an extraordinary career that has covered over five decades with sales of 50 million albums. For his finale, Campbell recorded a dozen songs he loved but never got a chance to record before. Among those are Harry Nilsson's "Everybody's Talkin'," the love song "Just Like Always," and a duet with Willie Nelson on the haunting "Funny How Time Slips Away." Former band member Carl Jackson penned a tribute to Glen titled "Arkansas Farmboy," while an intro by Roger Miller begins "Am I All Alone (Or is it Only Me)" with Vince Gill singing harmony. The tears roll freely with "It Won't Bring Her Back," followed by Bob Dylan's classic "Don't Think Twice. It's All Right" and the heartwrenching "She Thinks I Still Care." Joined by sons Cal and Shannon and daughter Ashley, Campbell sings "Postcards from Paris," then adds another gem singing Jerry Reed's Johnny Cash hit "A Thing Called Love." Closing, Campbell offers up his touching finale, appropriately titled "Adios." For Campbell, making this album was a labor of love; for his loyal fans, this was the best gift they could receive! Reaching the final stages of Alzheimer's disease, the 81-year-old Campbell continues his life in Nashville surrounded by his loving family.

#### **COMMODORES** VINYL/Motown-UMe

A flashback to 1977 brings Commodores' self-titled fifth studio album. The album was able to hold the #1 spot for eight weeks, thanks to the up-tempo "Brick House," and Lionel Richie's super smooth ballad "Easy." The tune "Brick House" got to the #3 spot as a crossover hit, while "Easy' hit the #1 slot on Billboard's R&B chart. In addition to the two charted tracks, included are, "Squeeze the Fruit," "Funny Feeling," "Heaven Knows," and "Zoom," a joint effort from Richie and group bassist Ronald LaPread. The second side has "Won't You Come Dance with Me," "Funky Situation," and "Patch it Up." Many of the songs from the Commodores have endured as covers and samples. Add to that are her covers of Waylon Jennings' "The Chokin' Kind," plus John Sebastian's "I Had a Dream" and Willy "Sugar Billy" Garner's "Super Duper Love (Are You Diggin' on Me? Part 1)." Next, Stone takes on the Isley Brothers' "For the Love of You (Parts 1 & 2)," and the White Stripes' "Fell in Love With a Girl" (done as "Fell in Love With a Boy"), which was Joss' first single. #### **EIGHT ODs IN ONE WEEKEND** IN QUINCY

Six people overdosed on opioids within 48 hours two week-ends ago, including two who overdosed twice. The overdoses occurred between Friday night and Sunday morning. All six were taken to the former Quincy Medical Center ER, which is now run by the Carney Hospital as a satellite ER, where they were monitored and released.

The overdoses were spread all across the city. According to the head of Quincy's Drug Unit, it is taxing on EMS. Of course it is, but first responders just keep doing their best. Thank God for Narcan. It is keeping people alive. This is an epidemic and it shows little sign of easing.

We need to get more people into treatment. We need to make it a priority. We need better funding and better education.

#### **SPEAKING OF NARCAN**

Like Quincy, the opioid crisis has reached epic proportions in East Boston, too, and across the nation. Nearly 2,000 people died of these opioid related overdoses in Massachusetts last year with an average of 38 opioid deaths per day in 2016.

Recently, the Baker Administration announced it will provide \$100,000 of Narcan to the East Boston Neighborhood Health Center, which will be among 10 community health centers receiving the drug as part of an increasing public awareness about the role of Narcan.

From the Contini/Christoforo side were Nanna, Babbononno, my folks, me, Uncle Paul, Aunt Eleanor, their children, Paula and Ellie, Uncle Gino and Aunt Ninna, their twins, Richard and Donna, and Uncle Nick and Aunt Dorothy. From the Ceruolo side, attending would be Zi'Antonio, Nanna's oldest brother and Babbononno's best friend, his wife, Zi'Mariuccia, their daughter Louise Pepe and her husband, Ralph, along with their three children, Lulu, Anthony and Ralph Jr. Sometimes, several others of the Ceruolos would come with their families to join us, but I'm not playing baseball. We kids had our responsibilities, too. I brought baseball equipment. My cousins would bring bad-mitten racquets and a couple of shuttlecocks, a set of bocce balls, kites, and a ball to toss around when we were playing in the lake itself.

Finally the day would arrive, and not long after sunup, we would load the car up with Dad's Coleman gas stove, his portable barbecue, a Coca Cola ice chest, and the food that Mom had pre-cooked. Next, we would pick up Nanna and Babbononno, load the car with the stuff they were bringing along, double check everything and then head for the Mystic Lake picnic area. Dad would check in at the bathhouse to see which table and barbecue pit were reserved for us and then bring everything out of the car. Soon, other members of the family would arrive and unload their offerings to the event.

Once everyone had arrived, we kids were interested in only two things: having a swim and to what the girls were doing and they could have cared less start cooking early in the week about what our interests were. of the family picnic. When everything was ready, Babbononno would yell out, "Siam pronto a mangier!" (We are ready to eat!) After he yelled this to the adults a few times and threatened us kids repeatedly, we headed to the picnic table and enjoyed a typical American picnic composed of antipasti, lasagna, meatballs, sausages, cutlets, and the barbecued meats. Accompanying all the food were the cold beer, chilled homemade wine, and soda for us kids.

Once we kids had eaten, we were warned by all of the ladies, our mothers and grandmothers, not to go into the water for an hour or we would develop cramps and drown! So, it was baseball again for an hour or whatever the girls were doing ... who knew ... who cared?

Later in the afternoon, out came the desserts, and both Italian and American coffee.

Once everyone had eaten, the women would clean up and the men, as if on cue, would all fall asleep in the folding chairs that someone had thought to bring along. I think that their impromptu naps were caused by too much food. The beer, wine, and whiskey had nothing to do

Toward sundown, everyone would pack up the things they had brought and the remainder of the food would be distributed equally. We kids would put our sports equipment in our fathers' cars, and once we all said our goodbyes, we headed home. I would be fast asleep even before we left Medford and the Mystic Lake area. This was a genuine American picnic ... ITALIAN

## Saint Jane Frances de Chantal

Jane Frances de Chantal was born in Dijon, France, on January 28, 1572. Her father was president of the Parliament of Burgundy. As her mother died when she was 18 months old, her father became the main influence on her education. Jane grew into a woman of beauty and refinement, lively and cheerful in temperament.

She married the Baron de Chantal when she was 21, and lived in the feudal castle of Bourbilly. Baron de Chantal was accidentally killed while out shooting in 1601, leaving Jane a widow at 28 with four children. She gained a reputation as an excellent manager of her husband's estates as well as of her difficult father-in-law, while also providing alms and nursing care to needy neighbors.

During Lent in 1604, Jane met Saint Francis de Sales, the bishop of Geneva, who was preaching at Sainte Chapelle in Dijon. They became close friends and de Sales became her spiritual director. She wanted to become a nun, but he persuaded her to defer this decision. Later, with his support, and that of her father and brother, and after providing for her children, Jane left for Annecy to start the Congregation of the Visitation, which was canonically established at Annecy on Trinity Sunday, June 6, 1610. The order accepted



women who were rejected by other orders because of poor health or age.

When people criticized her for accepting women of poor health and old age, Chantal famously said, "What do you want me to do? I like sick people myself; I'm on their side."

St. Vincent de Paul served as her spiritual director after de Sales' death. Her favorite devotions involved the Sacred Heart of Jesus and the Heart of Mary.

The Order had 86 houses at the Visitation Convent in Moulins at the time of her death at the age of 69. She was buried in the Annecy convent next to de Sales.

Saint Jane was canonized on July 16, 1767, by Pope Clement XIII; her Order had by then expanded to 164 houses. The Feast of Saint Jane Frances de Chantal is celebrated on August 12th.



#### **DEMPSEY vs. SHARKEY**

Protect Yourself at All Times

On September 23, 1926, Jack Dempsey lost the Heavyweight Championship of the World to Gene Tunney. Dempsey had been inactive for three years before the bout while Tunney had been racking up wins and staying sharp. After the bout, there was a clamor for a rematch, but things were a bit different in those days. Even a former champion had to earn his right to a return title bout.

Dempsey, while champion, had agreed to fight Harry Wills, but that fight fell through when the promoters failed to come up with Dempsey's guarantee. Instead, Dempsey went on to face Tunney. Meanwhile, Boston heavy-weight Jack Sharkey was compiling a solid record of wins including beating Harry Wills by disqualification. Though Sharkey won by a foul, Wills was repeatedly backhanding the Boston Gob. Sharkey had administered a severe beating to Wills before the fight was called in the 13th round. This paved the way for a Dempsey vs. Sharkey bout with the winner to face Gene Tunney for the title.

Going into the fight, Sharkey had gone unbeaten in his last 13 bouts with wins over such men as George Godfrey, Jimmy Maloney, and Mike McTigue. "Sailor Jack" was brash, cocky, colorful, and a bit erratic. He was also supremely confident he would beat Dempsey. The odds-makers agreed with him, making Sharkey a 7-5 favorite.

The public was very enthused with this matchup and 82,000 fans showed up at Yankee Stadium on July 21, 1927, to witness the fight. Celebrities were there in abundance, including Admiral Richard Byrd, Composer Irving Berlin, Flo Ziegfeld, and theatrical producer David Belasco. The gate was an amazing \$1,083,530.00, the largest for a non-title fight. Dempsey received \$252,759.00 and Sharkey's share was \$208,803.00, huge money for the time.

Both fighters were in great shape, but Sharkey was seven years younger and hungry for a title shot. And though Dempsey had showed signs of slowing down, he was, well, he was still Jack Dempsey and not one to take lightly. The "Manassa Mauler" was in there to win.

After receiving instructions from referee Jack O'Sullivan, the bout began. Sharkey came out very strong in the first round and had Dempsey hurt before long. Sharkey was fighting beautifully, using a very effective right uppercut and a marvelous jab. He continued beating Dempsey to the punch for six rounds and it appeared to be only a question of whether or not Sharkey would win by kayo or decision. It did not look good for the former champ.

Though taking a beating, Dempsey was tenacious. He was also doing a very effective job of going to Sharkey's body. Jack Dempsey knew he couldn't stand up straight and trade headshots with Sharkey, so he did what he did best; he fought out of his famous crouch. While Dempsey was hurting Sharkey with those

body shots, he was paying a heavy price having to absorb Sharkey's uppercut and solid left jab.

As I have written, it just appeared to be a matter of time until the fight went to Jack Sharkey. However, if you watch closely, you can see that the body punches were starting to bother Sharkey. As a matter of fact, he came into the ring wearing his trunks quite high in anticipation of Dempsey banging away at his breadbasket. He could use the high waistline as a way to argue Dempsey's blows were low and hope the referee would warn him to keep his punches up. Sharkey had won three fights in addition to the Wills fight by disqualification. Was it possible he was using that as an ace in the hole in case things weren't going well? If he did, it certainly backfired on him.

At the bell for the seventh round, Dempsey stepped up his attack on Sharkey's body. If you look closely at the film, you can see Sharkey was being bothered by those blows. With about thirty seconds gone in the round, Dempsey landed lefts and rights to the body. He landed a right hand to Sharkey's body that appears to land just about at the belt line. Now remember, Sharkey wore his trunks high so this would be in legal territory. Even if his trunks were worn at normal height, the belt line is still fair game.

Here's my take on this controversial fight: Sharkey was being worn down by Dempsey's relentless body punching. He had hit the former champ with everything he had and Dempsey just would not slow down. Sharkey had thrown a lot of punches. That, combined with the brutal body punches he absorbed, was wearing him down even though he was way ahead in the bout. The final right hand Dempsey landed to the body hurt Sharkey a lot. That's when he made the fatal mistake of dropping his hands and turning to the referee to complain he had been hit low. The second Dempsey saw that opening, he fired off a left hook to the jaw that floored Sharkey. Referee O'Sullivan counted the Gob out.

Now, that punch may have felt low to Sharkey because it was a brutal shot, but I think Sharkey had had enough of getting hit to the body and was going to try for the disqualification win. The mistake he made was in complaining to the referee while still on his feet. If he had dropped to the canvas and grabbed his groin, he may have gotten somewhere with the complaint. Dropping his hands while within punching range of the great Jack Dempsey was about the dumbest thing he could have done. Sharkey broke the first rule of boxing: "Protect yourself at all times."

Jack Dempsey would go on to have a rematch with Gene Tunney in what would turn out to be another controversial fight that became known as "The Long Count." Sharkey would also be involved in a controversial fight when he took on Max Schmeling for the title vacated by the retirement of Gene Tunney. In this bout, Sharkey would lose by a disqualification when Schmeling claimed to be hit by a low blow. Schmeling was a little smarter than Sharkey as he dropped to the canvas before complaining to the referee. Things may have been different if Sharkey had done the same with Dempsey.

#### HOOPS and HOCKEY in the HUB

Summer is upon us and the days are long ... and hot. So hot, in fact, that over at Boston University the fans are already talking about the Red Hot Hockey game that's set for New York City in November.

That's when the Terriers will take on Cornell in the Big Apple on Saturday, November 25<sup>th</sup>, during Thanksgiving weekend. It will be the sixth contest in the renewed series, which restarted back in 2007.

BU, of course, is more than happy to oblige the Big Red since the Terriers remain undefeated in the five prior games, winning in 2007, 2011 and 2013 while skating to ties with Cornell in 2009 and 2015.

The game has reinvigorated one of college hockey's oldest rivalries. The teams met for the first time way back in 1925, but their meetings tailed off after BU joined Hockey East in 1984. The series was given a new life with the inaugural Red Hot Hockey game event 10 years ago.

"When I look back to ... Red Hot Hockey games in the past, I remember special nights for our team, our alumni and our fans," stated BU head coach David Quinn in a press release. "Playing on this stage is incredible. We are grateful that Madison Square Garden has invited our team and Cornell back once again."

The game will be one of the highlights of the regular season for BU, which has announced a slate of 18 home games for the upcoming 2017-2018 campaign. There will be 12 Hockey East contests, four non-conference games, and a pair of exhibition tilts.

BU will be coming off a fine 2016-2017 season that saw the Terriers compile a 24-12-3 (.654) overall record, a 13-6-3 (.591) Hockey East mark, and a 13-3-2 (.659) home record.

The season opener is the earliest in the 96-year history of BU Hockey—a September 30<sup>th</sup> faceoff against Union. It will be the first men's varsity regular season game ever played in September.

Minnesota State makes its first appearance in Boston when it comes for a pair of games on October 13-14 while the Hockey East portion of the schedule starts with a home matchup against UConn on October 20<sup>th</sup>. Denver comes to Agganis Arena for a non-conference game on October 27<sup>th</sup>.

Highlights of the November home slate include games with Providence (November 3<sup>rd</sup>), Northeastern (November 4<sup>th</sup>), and New Hampshire (November 11<sup>th</sup>).

Boston College and UMass-Lowell, which shared the regular season crown with BU last year, play at Agganis in December. The Terriers will play the Eagles on December 2<sup>nd</sup> and then face the River Hawks on December 9<sup>th</sup>.

Maine makes the long trip from Orono for a Hockey East clash on January 6<sup>th</sup> while Providence is back at Agganis on January 13<sup>th</sup>. Merrimack comes in on January 20<sup>th</sup> while UMass furnishes the opposition on February 9<sup>th</sup>. The final weekend of the regular season has BU hosting Vermont for two games on February 23<sup>rd</sup> and 24<sup>th</sup>.

MORE OF THE SAME?—The headline at the top of the *NHL*. *com* piece indicated that there

have been basically no significant changes with regards to the Bruins' roster as the summer free agency signing period neared the conclusion of its second week.

"Bruins staying mostly intact during quiet offseason" read the header to the story written by *NHL.com* staff writer Ben Zweiman. The piece goes on to state that the lineup entering the 2017-2018 regular season is expected to be fundamentally the same as the one last year.

The problem is that this is essentially the lineup that brought Bruins Nation three nail-biter regular season finishes over the past three seasons, with the final determination of whether the Black and Gold would make the playoffs coming down to literally the final day in two of them.

Last season, the Bs clinched their first playoff berth with the slimmest of margins, getting the nod on tiebreakers. If the Bs had lost one more game in regulation time over the course of the regular season, they would have been sitting on the sidelines for the third consecutive year.

And what of those two prior years? Well, the Bs were denied a playoff berth on the last day of the season in each of those two campaigns, having to depend on the outcome of games between other teams (outcomes they had no control over) to determine if they would get a playoff berth. Obviously, things didn't go their way.

So, one might think that a team with such a recent history might be somewhat more active in the summer months, when steps are taken to improve rosters for the coming season.

Instead, Zweiman noted that (as of July 11th) the Bruins have chosen "not to sign anyone so far in free agency." This means that head coach Bruce Cassidy, who took over the reins after Claude Julien was fired on February 7th, will be forced to make the Bs a contender "with almost the same lineup from last season."

It's true that the Bs were good down the stretch with Cassidy, going 18-8-1 before being bounced by Ottawa in the first round of the playoffs. But a full season is a different story and the scene being set is less than optimal.
