MBTA Advisory for Monday, July 20th

Updated Boarding Protocols for Buses, Mattapan Line, and Customers at Some Green Line Stations; Standard Fare Collection Procedures at Front Doors

The MBTA announces that, effective on Monday, July 20th, there will be updated boarding protocols for customers using buses, the Mattapan Line, and the Green Line at street-level stations. Standard fare collection processes will continue at the front doors of buses and trolleys. Protective barriers have been installed to support physical distancing between operators and passengers, allowing front-door boarding to resume and providing more space for customers than the previous temporary barriers.

"We're glad to be able to return to the normal boarding process, and as we continue through the reopening process, it is important that customers and employees remain vigilant in our efforts to stop the spread of COVID-19," said MBTA General Manager Steve Poftak. "By taking steps like wearing face coverings and social distancing, we're able to continue to make progress and keep customers safe and healthy.'

On July 20th, front-door boarding resumes for all buses, for the Mattapan Line, and for Green Line trolleys at streetlevel stops. It is required that all MBTA customers wear a face covering and riders should avoid sitting or standing in areas (designated with decals) closest to the bus or trolley operators. Customers should board vehicles via the front doors only and exit via the rear

The MBTA temporarily instituted rear-door boarding in March in an effort to encourage social distancing measures and protect the health of MBTA operators and riders. Temporary barriers were also installed on vehicles at that time. The MBTA has completed the installation of permanent protective barriers that allows more space for customers while continuing to support social distancing. If there is a substantial statewide increase in active COVID-19 cases, the MBTA may revisit the updated boarding procedures and reinstitute rear-door boarding on buses and trolleys at street-level stops with customers notified in advance of the change.

To avoid overcrowding on buses, operators also have the discretion to bypass a stop if the operator determines that the bus has reached its safe capacity. If a customer with a disability is able to be identified while waiting at a stop to be bypassed, the bus operator

alerts the Control Center, will notify that individual that the stop is being passed due to crowding, and will alert the customer to the approximate time of the next available bus that can accommodate

Customers should continue to make efforts to distance and are reminded that face coverings are required while onboard vehicles and within the MBTA system. The MBTA urges area employers to continue to allow telecommuting and to consider staggered work schedules to promote social distancing on public transit. The MBTA also encourages cities and towns to assist in this effort be expanding available space

Update on Phase 3 of Reopening in Boston

Phase 3, Step 1 of the state reopening plan launched in Boston on Monday, July 13th. On Friday, July 10th, the Mayor provided an overview of City programming and business guidelines in Phase 3. Those resources can be found at boston.gov/reopening.

The Mayor gave some national context about the coronavirus. Right now, the U.S. is in the worst place it has been since the pandemic began. He gave some examples: the California down indoor businesses for the second time, and Florida, Texas, Arizona, and other states are seeing dire situations in their hospitals.

He said Boston and Massachusetts don't have to go down that path. The Boston Public Health Commission and the City are monitoring the data every single day, including test results, positive test rates, hospital activity, and neighborhood and demographic differences.

The City is ready to make whatever adjustments are needed, should we see the numbers move in the wrong direction. But the Mayor stressed that every single person has the ability to influence what happens with the spread, and must accept that responsibility. Everyone must continue to follow the precautions put in place, or else we risk moving backward.

 For businesses and nonprofits, that means operating workplaces with caution and care; following all state requirements; listening to concerns of workers and customers; and consulting the city's sector guidelines at boston.gov/ reopening.

• For **individuals**, it means wearing a face covering whenever you are out; keeping six feet of distance and avoiding governor yesterday had to shut crowds; washing your hands frequently; and cleaning your surfaces.

The City is available for help and guidance. Since March, the City has kept essential city services available while protecting the health of workers and visitors. As many city services as possible are available online, and the City's 311 staff are ready to answer questions and provide assistance.

UPDATE ON CITY SERVICES AND PROCESSES:

Starting on July 23rd, City Hall will be open to the public on Thursdays: bringing in-person services to 3 days a week, on a Tuesday, Thursday, Friday schedule

Services will remain by appointment, so people must call ahead to the relevant department. A good starting place is to call 311.

The City will continue to screen everyone who enters the building for COVID-19 symptoms and elevated temperature.

The Mayor reiterated that, despite state guidelines allowing larger gatherings, the City will not be hosting public or private meetings in City Hall or other city buildings. The City will continue to provide online meetings and other ways to make residents' voices heard.

Already, the City and the Boston Planning and Development Agency have held virtual conversations on the planning studies moving forward in East Boston, Mattapan, and Newmarket.

POLICE REFORM LISTENING SESSIONS:

The City is also providing opportunities for robust public input and community leadership in our work to advance racial justice in Boston.

The Mayor noted that Boston has already instituted a number of reforms in public safety policy and budget reallocations. The City is also moving forward with equity investments to combat systemic racism in education, housing, and public health.

The Mayor pledged to continue this conversation as a city — not in a top-down manner, but by centering the voices

Stirpe Nostra

AESCULAPIUS & HIPPOCRATES

The ancient Greek god of Medicine was named Aesculapius. He was often portrayed clad in a cloak while carrying a staff that had a serpent (snake) coiled around it. Mythology identifies him as a son of Apollo who was taught the art of healing by Chiron, a centaur. For those readers who might have forgotten, a centaur was a mythological figure, half man and half horse. The ancients considered them to be symbols of the destructive forces of nature. Chiron the centaur is supposed to have possessed great knowledge in the arts and sciences, which he also taught to Hercules and Achilles.

The staff carried by Aesculapius was the origin of the "mace" that Greek ambassadors or heralds carried in time of war. Originally, it was an olive branch with garlands. Legend tells us that Mercury, messenger of the gods, often carried a similar short staff or wand, and that at one time he came upon two snakes that were fighting. Mercury separated the snakes with his wand and henceforth the staff became known as the symbol of peace. At a later date, the staff was surmounted with two wings (a symbol of Mercury's speed), entwined with two snakes, and named "The Caduceus." We know it as the official emblem of the U.S. Medical Corps, and of medicine in general.

Another popular legend tells us that Aesculapius went about the land curing the sick, and by some unexplainable power, was also able to recall the dead to life. Zeus feared that mankind might use this Samaritan as a means to escape death altogether, so he killed Aesculapius with a thunderbolt, but out



of respect for his good deeds, placed him among the stars.

Hippocrates was a direct descendant of Aesculapius. He also practiced the art of healing while traveling throughout Greece. He was born about 460 B.C., and died in his early 80's. The so-called "Hippocratic Oath" dates back to very early times. It was an oath taken by young men when they began their medical studies, and of course, the practice of taking such an oath has continued with graduating medical students' right up to modern times. The present oath was thought to be the work of Hippocrates but subsequent research fixes its origins at some time during the 3rd century A.D.

The contemporary version is

"I swear by Apollo, the physician, by Aesculapius, by Hygieia, Panacea, and all the gods and goddesses, that according to my ability and judgment I will keep this oath and stipulation. I will

look upon him who shall have taught me this art even as one of my parents. I will share my substance with him, and I will supply his necessities, if he be in need. I will regard his offspring even as my own brethren and I will teach them this art, if they would learn it, without fee or covenant. I will impart this art by precept, by lecture, and by every mode of teaching, not only to my own sons but also to the sons of him who has taught me, and to disciples bound by covenant and oath, according to the law of medicine. The regimen I adopt shall be for the benefit of my patients according to my ability and judgment, and not for their hurt or for any wrong. I will give no deadly drug to any, though it be asked of me, nor will I counsel such, and especially I will not aid a woman to procure an abortion. With purity and holiness will I pass my life and practice my art. I will not cut a person with stone, but will leave this to be done by those who are practitioners of such work. Whatsoever house I enter, there will I go for the benefit of the sick, refraining from all wrong-doing or corruption, and especially from any act of seduction, of male or female, of bond or free. Whatsoever things I see or hear concerning the life of men, in my attendance on the sick or even apart therefrom which ought not to be noised abroad. I will keep silent thereon, counting such things to be as sacred secrets. While I continue to keep this oath inviolate, may it be granted to me to enjoy life and the practice of my art, respected always by men; but should I break and violate this oath, may the reverse be my lot."

RMV Renews Over 21,300 Licenses & IDs Online Since June 12th REAL ID Promotional Opportunity Began

of Motor Vehicles (RMV) continues to encourage all eligible ing the COVID-19 pandemic to fee for obtaining a standard or customers to renew their stan- renew their license or ID card, REAL ID card is \$25. The typidard Massachusetts driver's license or Massachusetts ID card online at Mass.Gov/RMV any time between now and August 12, 2020, in order to qualify for a free upgrade to a REAL ID credential in 2021. This one-time, time limited offer is available to most customers who have an expired or expiring license or ID card dated between June 30, 2018 and August 2021, as customers are eligible to renew up to a year in advance of the expiration date printed on their license or ID, or up to two years after their expiration.

The Massachusetts Registry

Since the RMV launched this promotional opportunity on June 12th, over 21,300 Massachusetts' driver's licenses or ID's have been renewed online, compared to just 9,200 over the same time period in 2019.

"The RMV is encouraging all

of our customers to stay safe, save time, and go online durrather than attempting to come in to get a REAL ID," said RMV Registrar Jamey Tesler. "There are over 500,000 people with a license or ID that expires this summer that can be renewed online to take advantage of this one-time offer for a free, future upgrade to allow the RMV to prioritize 'social-distancing' and other essential transactions that may only be completed in-person."

Qualifying customers who complete their renewal online prior to August 12th and wish to upgrade to a REAL ID for free, will have to wait until at least February 2021 to visit an RMV Service Center. At this time, customers will not need a federally compliant REAL ID for the purposes of boarding domestic flights prior to October 1, 2021 because the federal government delayed the compliance effective date by one-year. The fee for obtaining a standard or REAL ID license is \$50, while the cal \$25 upgrade / amendment fee will be waived under these qualifying circumstances. Obtaining an initial federally compliant REAL ID requires all customers to visit a Service Center in-person to present verifying documents. The RMV has introduced this initiative and fee waiver pursuant to Executive Order 39 issued by Governor Baker on June 12, 2020, and in light of the COVID-19 public health emergency to encourage 'social-distancing' and limit unnecessary travel by reducing the need for many customers to visit a Service Center, and allowing for the

Old North Church & Historic Site Reopens

The Old North Church & Historic Site reopened on July 16th after rigorous planning to welcome visitors back to the iconic Freedom Trail site in the safest manner possible.

Hours of operation will be Thursday-Saturday, 10:00 a.m. to 4:00 p.m. and Sunday, 12:00 p.m. to 4:00 p.m.

"Our staff have worked diligently to develop protocol that is in full compliance with the Phase III guidelines for indoor historic site reopening provided by the city and state," said Executive Director Nikki Stewart. "Guests will utilize our unique and historic box pews to ensure social distancing, and timed entry will allow for cleaning between each session."

Admission includes a specialized group experience that invites visitors into the iconic church to learn more about the role Old North played launching the American Revolution and its deeper legacy as one of the nation's most revered historic sites. Visitors will be seated in the original box pews and learn about the founding of the church in 1723, the remarkable events of April 18, 1775, the Longfellow poem that cemented Old North in history, and the people and stories that have made Old North the icon it is today.

The Old North Church is Boston's oldest surviving church building and one of the Freedom Trail's most visited historical sites, known for "one if by land, two if by sea," and the midnight ride of Paul Revere. The enduring fame of the Old North began on the evening of April 18, 1775, when the church sexton Robert Newman and Vestryman Capt. John Pulling, Jr. climbed the steeple and held high two lanterns as

a signal from Paul Revere that the British were marching to Lexington and Concord by sea across the Charles River and not by land. This fateful event ignited the American Revolution.

"The legacy of the church's history and people is as relevant today as ever," said Stewart. "One of the most compelling reasons to engage with history is to learn the lessons that help us build a better present and future. The story of Old North tells us that active citizenship works. We hope that our visitors

will draw inspiration from the events of April 18, 1775 and think about what civic engagement and patriotism can look like for them in 2020."

Note that the Old North Congregation is following the guidance of the Episcopal Diocese of Massachusetts, and has suspended public worship and congregational gatherings at the Church until further

North Washington Street Bridge Update ...

Traffic Shifting onto Temporary Bridge

Starting Friday, July 17th, traffic will be shifted onto the new temporary North Washington Street Bridge. We will shift one travel direction at a time, in three stages over the weekend:

Inbound traffic to Keany Square will shift to the temporary bridge and inbound lanes on the existing bridge are closed.

Outbound traffic to City Square shifts to temporary bridge and outbound lanes on existing bridge closed

Sidewalk on temporary bridge opens and sidewalk on existing bridge closes. The Freedom Trail will be temporarily relocated to the temporary bridge along with its respective signage. Pedestrians will shift from the harbor-side sidewalk to the locks-side sidewalk.

On Monday morning, after Stage 3 is complete, we will begin demolition of the old bridge.

TRAVEL IMPACTS

N. WASHINGTON STREET INBOUND: Offpeak daytime lane reductions across the bridge and additional lane reductions at Keany Square will continue. One lane across the bridge and all turn movements will be available from 10:00 a.m.-2:00 p.m. on weekdays.

N. WASHINGTON STREET OUTBOUND: Off-peak daytime lane reductions will continue across the bridge to City Square. One lane across the bridge and all turn movements will be available from 7:00 a.m.-2:00 p.m. on weekdays.

Once the temporary bridge is opened, two inbound and one outbound travel lanes will always be available.

DESCRIPTION OF SCHEDULED WORK

In the week of July 19th, demolition of the old bridge including prep work, equipment staging, and barrier installments.

WORK HOURS

Daytime (6:00 a.m.-3:00 p.m.) for general work.



Starting on Monday, 7/20, during the daytime in continuous two shifts (6:00 a.m. – 1:00 a.m.) crews will work to demolish the current bridge.

WORK THAT HAS BEEN COMPLETED

Installation of the temporary pedestrian/ vehicle bridge, drainage work, and installation of the fender system.

TRAVEL TIPS

PEDESTRIANS AND CYCLISTS: The bridge's eastern sidewalk is open and available to all pedestrians and cyclists with crossings at both Keany and City Squares. By the end of the July 17th traffic shift onto the temporary bridge, pedestrians will shift from the harbor-side sidewalk to the locks-side sidewalk. Please be on the lookout for wayfinding signs that will direct pedestrians safely during the traffic shift and bridge demolition.

All users should take care to pay attention to all signage and police details and move carefully through the work zone. Police details, lane markings, temporary barriers, traffic cones, signage, and other tools will be used to control traffic and create safe work zones.

Housing Crisis, Gentrification, And Displacement What to Do

I recently read that the City of Boston has been named the third most "intensely gentrified" city behind only San Francisco and Denver. I would say from personal observation that this report by an economic justice non-profit in Washington, DC is right on target. I have seen huge swaths of the city over the past decade like Jamaica Plain, Mission Hill, Roxbury, and from Hyde Park on one end of the city to East Boston on the other end become gentrified.

With urban gentrification comes displacement for poor and working folk who get priced out in this new neighborhood growth. We all see it right here in East Boston when folks get priced out of this renewal and economic development.

What are, and what can our elected officials do besides using the bully pulpit? How do we sustain a neighborhood that is inclusive to all? How do we do it anywhere?

The housing issue we face today didn't start yesterday, last year, or even 10 years ago. This housing issue was recognized back in the late '70s to early '80s when condo conversions started changing demographics in places like the South End and then Charlestown back when I lived on Winthrop Street across from Engine 50. Back then, a two-bedroom apartment went for \$200 plus utilities per month.

If we don't find a way to actually deal with all these ramifications of the new housing markets, our cities will change forever and working families and middle-class homeowners will be on the outside looking in and feeling powerless which is never good to be.

Saint Teresa of the Andes

Juana Enriqueta Josefina de los Sagrados Corazones Fernández Solar, known as Juanita to her friends was the fourth of six children born to Miguel Fernández and Lucia Sola. Born in 1900, her family was part of Santiago, Chile's middle-class.

As a young girl growing up in the early 1900s in Santiago, Chile, Juana read an autobiography of a French-born saint — Thérèse, popularly known as the Little Flower. The experience deepened her desire to serve God and clarified the path she would follow.

Juana received her education in a college managed by French nuns from the Sacred Heart order, and she remained there from 1907 until 1918. In 1914, she decided to consecrate herself to the Lord. At age 19,



Juana became a Discalced Carmelite nun, taking the name of Teresa.

The convent offered the simple lifestyle Teresa desired and the joy of living in a community of women completely devoted

to God. She focused her days on prayer and sacrifice. "I am God's," she wrote in her diary. "He created me and is my beginning and my end."

Toward the end of her short life, Teresa began an apostolate of letter-writing, sharing her thoughts on the spiritual life with many people. At age 20, she contracted typhus and had six months to complete her canonical novitiate so as to make her religious vows. She nevertheless was allowed to profess her vows "in periculo mortis" ("in danger of death") on April 7, 1920. She passed away on April 12, 1920, during Holy Week.

Thérèse was Canonized in 1993 by Pope John Paul II; she is Chile's first saint. The Feast Day of Saint Teresa of the Andes is celebrated on July 13th.



CHAPTER 25 Pets, Pets, and more Pets North End families were still

large in the 1940s and '50s.

Kids tumbled out of the two and three-story brick buildings that lined our narrow streets, filling the neighborhood with the sounds of children at play. Mini neighborhoods within our tiny Italian enclave were formed by the residents of the narrow alleyways lacing our streets together, adding further complexity to the buzz of life that filled the streets. Despite the crowded conditions, many of us kept pets that were in every way part of the family. Favorites were Canaries and Parakeets that brightened flats with their chirps and color. Some of our neighbors raised Homing Pigeons. They were kept on roofs in ramshackle wooden coops. Some of the pigeons were pure white, others brown and white calico, and others simply looked like street pigeons. One species called the Nun was everyone's favorite. It was black and white with an outcrop on its neck, reminiscent of a veil, hence the name "Nun." The owners of the birds raced them once or twice a year against the pigeons of other neighborhoods; bets of all sizes were made on the outcome of the race. Our nextdoor neighbor, Mario, kept his bird coop on his roof adjacent to our roof. He had about 30 or 40 birds. We helped build the coop, therefore, had open access to it. The coop was filled with feathers, had a strong smell of bird crap, particularly smelly on hot



summer days.

Many dogs and cats in the North End were abandoned. The dogs ran in packs through the streets and often got into fights among themselves, while the cats moved like shadows from building to building, under cars and sometimes seen precariously walking along the parapet of a roof looking for mice, or anything they could sink their teeth into. There was one dog named Red, a Chow that had grown particularly vicious and terrorized the neighborhood, until he was killed by a car. He once fought a German Shepherd in the middle of North Square and was about to kill it, until the neighbors began pelting Red with stones, managing to drive him off.

Queenie was just one of the many pets we had. Others came in quick succession. There was Pudgy, a mixed breed with

little personality and not very friendly. She was gone within three months. We traded her for a huge sun turtle we kept on our roof in a big, black metal tub. When summer was over, our brother Anthony said it was smelly, he tossed it into the ocean at the end of our street, to set it free, never realizing the difference between a fresh and a salt water turtle. Then there were the six chicks given to us one Easter that we gave to a local farm after a month. They were followed by Donald, a yellow duckling, purchased by Dad from a local pet shop and brought home in a shoebox. The moment we opened the box, Donald made a beeline for Dad, from that day on, Donald was never more than three steps behind him. Donald was a lot more fun than the chickens because he was very playful. Mom loved the quacks and amusing sounds he made as he ran through the house. As he got bigger, Mom insisted we keep him on the roof where he took up residence in our former chicken coop. There was no way Donald was going to stay in that coop. He would hop down the roof stairs, wait at our door quacking, until one of us opened it to let him in. He was looking for



of the communities that have been most severely impacted by this history. That's the purpose of the Boston Police Reform Task Force, headed by former U.S. Attorney Wayne Budd and made up of Black and Brown community leaders, civil rights leaders, and activists. Their work is moving forward.

Starting next week, the Task Force will be holding online listening sessions on key issues, where residents will have the opportunity to share their experiences and beliefs. These sessions begin next week with the following schedule:

- The Body Worn Camera Program: Wednesday, July 22nd, 3:00 – 5:00 p.m.
- Implicit bias training: Thursday, July 23rd, 3:00 -5:00 p.m.
- Strengthening Boston's existing police review board, known as the Co-oP Board: Wednesday, July 29th, 3:00 -
- Reviewing the use of force policies: Thursday, July 30th, 3:00 - 5:00 p.m.

The City will be sharing information this week on how to sign up to testify or submit written testimony.

The Mayor thanked Wayne Budd and all the members of the Task Force for their service, and reaffirmed his pledge to act on the recommendations of this board, as informed by the community.

UPDATE ON YOUTH SUMMER JOBS:

The Mayor noted that, with fewer employers able to offer jobs in person this year, the City had to get creative in providing summer opportunities that are safe and meaningful. The City boosted funding for the program from **\$8 million** to **\$12 million** to increase outreach, increase support, and offer an opportunity to every young person who needs it.

The Mayor announced two new features of the City's youth summer jobs program that launched this week.

The first is a "Learn & Earn" Career Development Internship that pays young people to take college-level coursework, which started on Monday, July 13th. Students come away with real college credits as well as experience and financial earnings.

- This program will have more than 500 young people enrolled in 26 classes, in areas like Business, Communications, Early Childhood Education, Human Services, and Technology.

BRINGING FOOD TRUCKS TO OUR NEIGHBORHOODS:

This Friday, July 17th, is the launch of Boston's 2020 Summer Food Truck Initiative. For the first time ever, food trucks will be heading out into the neighborhoods.

This summer, the City is piloting temporary food truck sites across our neighborhoods, including at City parks, playgrounds, and public spaces. These sites are open to trucks that have already been approved by the City to operate.

Spots will be issued based on interest and availability and they will be open seven days a week from noon to 7:00 p.m. The City is offering 23 sites so far and working to add more as needed. More information on their locations will be posted on boston.gov/reopening this week.

The Mayor said food trucks are small businesses that bring fun and vibrancy wherever they go, as well as an outdoor dining experience that aligns with the City's public health precautions.

This program is led by the Office of Economic Development's Small Business Unit, in partnership with the Streets Cabinet and the Inspectional Services Department. Like outdoor dining and healthy streets, it's another way the City is innovating, in response to the pandemic, to support small business and bring new amenities to our neighborhoods.

EXTENSION OF PLASTIC BAG BAN AND **BAG FEE SUSPENSION:**

starting on October 1st, which gives stores a transition period to use the bags that they have

He noted that the City originally suspended the ban on plastic bags and the 5-cent fee for paper bags in March in order to give both stores and customers more flexibility during a difficult time.

He also made clear that the Boston Public Health Commission and the state Department of Public Health have said that reusable bags are safe and people should feel free to use them.

STANDING WITH BOSTON'S INTERNATIONAL STUDENTS:

The Mayor closed his remarks by addressing the **federal court hearing** that happened July 14th, on a plan by the Department of Homeland Security to deny visas to international students, if the college that is hosting them goes online for the fall. Harvard and M.I.T. are leading the lawsuit to stop that policy.

Yesterday, the Mayor joined Los Angeles Mayor Eric Garcetti in leading a group of cities to file an amicus brief in support of this lawsuit.

The Mayor said the following: • "My message is clear. This policy has no basis in public health or the national interest. It's an attempt to pressure colleges and universities to open up. It puts politics in place of public health. It's not fair to students who looked to Boston as a place of educational opportunity. And, it's a blow to our economy at a time when we can least afford it."

He noted that Massachusetts has over 70,000 international students, many of them either living or taking their classes in the City of Boston. They contribute roughly \$3.2 billion dollars to the state's economy and support 39,000 jobs.

He also said that, beyond the economic factor, this kind of move chips away at the goodwill that the City has built up around the world through academic leadership, and strikes at Boston's identity as a welcoming city and a global leader.

He reassured international students that they are not alone, and the City is going to fight this change. Boston values its international students and wants them here. He asked students to not make any decisions vet, and to reach out to their school for support. Boston's colleges and universities, and the City, have made it clear that they welcome inter-

BEWARE of SCAMS

DOOR-TO-DOOR SCAMS

Warm weather brings with it door-to-door solicitations. Be cautious anytime a stranger comes knocking, especially if the visitor is trying to sell you goods or services. Protect against bad actors by refusing to do business right on the spot. Always ask for credentials and check references of anyone seeking to do work for you. If you agree to the visitor's offer, pay by check or credit card, or arrange financing. Paying in cash can be dangerous — you may lose the cash and not get the promised goods or services. And always insist on a written contract before you pay anything and before work begins.

EXTORTION SCAMS

According to the FBI, 2020 has seen a spike in extortion scams. These are typically e-mail messages that include a password you've used in the past. The sender claims that they have installed malicious software on your computer, and have proof you've been frequenting adult websites. They warn they will share that proof with all of your email and social media contacts unless you send money — typically in the form of hundreds of dollars of Bitcoin.

True or not, this fear tactic works. But this is really just a phishing expedition using data obtained from a prior data breach. The hope is you'll see an old (or current) password and believe the message must be true and pay up. Don't click on any links or respond to the scam message. But do report it to authorities at: ftc.gov/complaint.

CITIES LACK RULES DEFINING HOMELESS CAMPS

at historically busy bus stops and working with the MBTA to implement dedicated-bus lanes.

While passenger volume continues to be just a fraction of pre-pandemic levels, the MBTA will continue to closely monitor ridership and, when possible, will make adjustments. Bus service in particular has been tailored to specifically allow for operational flexibility, giving dispatchers the ability to make adjustments in response to changing ridership demands and to alleviate crowding. The MBTA is operating a full complement of buses, including 30% reserved to be deployed where there is increased demand for service. Crowding will be closely monitored with these flexible buses deployed as needed. Full information regarding service levels can be found at: mbta. com/coronavirus.

ENHANCED DECONTAMINATION, CLEANING, DISINFECTING, SOCIAL DISTANCING, AND MORE:

In addition to encouraging good hygiene practices and social distancing, the MBTA is continuing its enhanced cleaning and disinfecting protocols. The public is encouraged to visit www.mbta.com/RideSafer for more information. Protocols include:

• Stations and facilities: disinfecting touch points in hightraffic facilities twice a day; disinfecting touch points on surfaces such as handrails, fare gates, and fare vending machines in subway stations once every four hours; and hiring additional vendors for disinfecting using chemical fogging, electrostatic sprayers, and manual disinfecting wipes/solutions.

• Bus and rail vehicles: decontaminating all vehicles nightly with disinfecting wipes; performing mid-day decontamination at layover locations daily by wiping down operator cabs and high-touch locations; wiping down cabs, fare boxes, and entrances for first/second shift bus pullbacks; performing electrostatic fogging for 100% decontamination every two weeks for all bus vehicles; isolating and electrostatic decontamination of any vehicle reported as operated by an employee who tested positive for COVID-19.

The MBTA has also deployed messaging through social media and within stations, bus terminals, and vehicles that encourages social distancing. Crowding threshold standards have also temporarily been lowered for each bus and subway fleet to accommodate social distancing measures. Customers can also find real-time crowding information for a number of bus routes with more information at: www.mbta.com/crowding.

Face coverings are required while onboard all MBTA vehicles, on shuttle buses, and at stations and stops. The Executive Order that went into effect on May 6th does include an exemption for individuals with certain medical conditions, but does not require a person who is so exempt to produce documentation of their condition. The MBTA has issued internal guidance to its operators consistent with the Executive Order, though the MBTA expects all customers will comply.

The MBTA continues to follow guidance from the Massachusetts Department of Public Health with the MBTA encouraging its riders and the public to:

- Practice social distancing at all times when leaving the home for essential trips;
- Stay home if sick and avoid close contact with others;
- Wash hands often with soap and water for at least twenty seconds;
- Use alcohol-based hand sanitizing gel with at least 60% alcohol if soap and water are not available;
- Avoid touching eyes, nose, and mouth;
- Clean areas that are frequently touched with sanitizing spray or wipes;
- Cover coughs and sneezes, and use a tissue or the inner elbow, not hands.

Nanna & Babbononno

A Nostalgic Remembrance



Something I am experiencing as of late, new acquaintances wanting to know my opinion on politics and religion. In either case, a conversation centered on either topic puts me in a no win situation. If I were to defend any side, regardless of what it is, I put myself at a disadvantage, so I make light of things with unorthodox answers that usually cause these potentially adversarial opponents to change the subject.

As an example, when anyone who is probing asks me about President Trump and I know where they are coming from, I answer, "Oh, I'm not a Trump supporter. He's way too liberal for me." This usually shuts them up. When I've been asked about religion, I tell them I'm a Six Day Buddhist. Many know what a Buddhist is and some know what a Seven Day Adventist is, but not my Six Day Buddhist religion. They will then ask me about the religion and my come back shuts them up, "We pray to Our Lady of the Heartbreak of Psoriasis, and we believe that when you die, your soul goes to a used car garage in Chelsea or Brooklyn, depending on whether you live in Boston or New York." Again, this shuts them up and I go on my merry way.

The ones I am afraid of are the revisionists, the people who are trying to change history by erasing what they feel was wrong with it. A perfect example of the attempt to change history is the destruction of the Christopher Columbus statue in the North End. Most of those activists who robbed us of our Italian admiral did this not knowing who Columbus really was and what he did and didn't do. They are reacting to a revisionist pandemic that is as bad for our future as the coronavirus is for our health.

The fears of one another are not new. I remember want ads from the Boston newspapers of old that indicated, "No Irish need apply." If it was good, (the Constitution) we kept it and lived up to the standards included within.

When I taught World History on a college level, I researched the three major western religions, Christianity, Judaism, and Islam. The practices differed dramatically, but the essence of each was the same; a belief in God, a set of laws to live by, and a concept of good and evil which affects us on Earth and beyond. When I looked at the Asian religions, Hindu and Buddhist, Shinto, etc., they were very different, but some of the same tenants I found in our western beliefs were the same; a belief in god(s), a set of laws to live by, and a concept of good and evil which affects us on Earth and beyond.

One of my more reflective students once asked why we humans don't look for what makes us similar rather than what makes us different. I wish I had had an answer for him. When I was young Sal Meli and I traveled around the world, would look for similarities between us and the people of the country we were in, and once they were established, we made friends. This includes people in Europe, Africa, Asia, and Latin America (I've never visited Australia).

Even then, the image of the "Ugly American" was out there. It was shown to us in Puerto Rico in the mid-sixties. I was playing with a band in San Juan, PR., and Sal had come to the island for a few weeks. After work one night, we decided to head into the hotel's casino and try our luck. We hit it big on a crap table, and the next morning headed to a local bank to deposit our winnings.

We headed for Old San Juan where the bank was located and were stopped by two tourists, a man and a woman who were trying to ask us something in Spanish using a Berlitz phrase book. We didn't understand and I was about to switch to English when the man said to his female companion, "Just like these Spics, they don't even know their own lingo." Sal continued speaking Spanish as the man flipped through his book looking for translations. Finally, he understood and thanked us by taking a quarter and placing it in the palm of my right hand while saying to his companion, "So they won't starve to death." I looked at the quarter, showed it to Sal, and in Spanish said, "Oh, look a quarter." I then dropped it in the man's shirt pocket and said in perfect Boston English, "Sir, you may need this more than we do." At that point, Sal removed a wad of hundreds from a carrying case and began to count the bills. The couple was fit to be tied and walked away as both Sal and I laughed. I later got mad saying to Sal, "What if we were local farmers coming to the big city for the first time and were exposed to this type of tourist?" I then understood where the term "Ugly American" came from.

If Babbononno and Dad were still alive, I would ask them where do we go from here. Do we let the revisionists change our history to coincide with their distorted concepts of the past, or do we learn from the realities of the past and hope not to make the same mistakes again? I wonder how they would respond to the way things are evolving in today's America.

My suggestion for our future is to forget our differences and team up to put together a more perfect union. Our Constitution isn't perfect, but we can amend what doesn't work. It is not perfect, but it is better than any other political document that now exists on this planet. It allows for democracy. It allows us to be all we can be without restrictions put in front of us. Why is it that most countries have to put up borders to keep their people in and we have to put up borders to keep their people out (illegals)? We must be doing something right if everyone wants to come here.

There is no country as diverse as the United States. I remember a conversation with Nanna about when she first arrived in New York. She had never seen a human that wasn't Italian where she came from, and saw a parade of people she called the League of Nations once she stepped foot on American soil. Before she left Ellis Island, she entered the gift shop and bought a copy of the Statue of Liberty and kept it in plain sight for the rest of her life. It represented America and freedom to her. I wonder if it still does.

The zucchini most of us are familiar with today were brought to California from Italy in the early 1920s by Italian immigrants. The name *zucchini* is considered the plural form of the Italian word *zucchino*, meaning a small marrow, gourd, pumpkin (*zucca*) or squash. After entering the states, this gourd like vegetable gained popularity and became an ingredient in which many delicious dishes and desserts were made from. At this time of year, *zucchini* can be found growing on farms as well as in many family gardens. While the vegetable continues to be a household favorite, what appears to be even more preferred are its long-stemmed yellow orange flowers. In Italy, these blossoms are referred to as *fiori di zucca*. In fact, *Fiori di Zucca Fritti* (fried courgette flowers) are among one of Rome's must eat dishes, and the flowers are also found prepared with different ingredients, in different regions of the country.

As far back as I can remember my family had a vegetable garden as well as many beautiful fruit bearing trees. During the growing seasons, my Nonna would take her basket into the yard early in the morning and pick what she considered to be "ready." One of the things she looked forward to most in her summer garden were the yellow orange blossoms that appeared on the zucchini plants. Nonna said that when she was a young girl she used to pick these back home, and her mom would make a delicious Frittata di Fiori di Zucca (Squash Flower Omelet) with them. The blossoms are so delicious that she believed if you added too many ingredients to them, you would take away from their unique and delicate flavor. I have to say that I agree with my Nonna and Frittata di Fiori di Zucca is a perfect balance of a few simple ingredients. It makes an excellent second course with a salad on the side, or served as my Nonna often did, sandwiched between two slices of warm homemade Italian bread!

SQUASH FLOWER OMELET Frittata di Fiori di Zucca



2 dozen squash flowers, stems removed, washed and dried ½ - ½ cup light olive oil 18 large fresh eggs, beaten ½ to ¾ cup freshly grated parmesan cheese Salt and pepper, to taste

In a large omelet or frittata pan, heat olive oil. Add squash flowers and sauté on low heat for about 4 minutes, turning the flowers at the halfway mark. Simultaneously, in a large mixing bowl add the beaten eggs, parmesan cheese (as much or as little as you prefer, being careful not to use too much as it will overpower the flavor of the squash flowers) and salt and pepper to taste; mix together well. Add the egg mixture to the squash flowers in the pan and let cook on low heat until ¾ of the way cooked, flip and cook until set. Do not overcook. Turn onto a platter, cut into wedges and serve.

Pearl Harbor



Japan was under the radar of the United States for some time before the day that would live in infamy. Franklin D. Roosevelt knew Japan would come to see American interest in the Philippines as an obstacle to its rising empire in the Pacific. Fearing an attack, Roosevelt, eager to avoid war, attempted to reach a diplomatic settlement with Japan but little was accomplished. Still, the Roosevelt administration hoped to maintain peace and to plan for an attack and, consequently, going to war.

Pearl Harbor was a particularly vulnerable base to attack, lying between the Rising Sun and the United States. At 7:02 on the morning of December 7, 1941, two radar operators observed an unusually high number of aircraft flying toward the base from the north. Despite the inconsistency in flight direction, the operators assumed these to be the expected fleet of B-17s entering from the United States and sounded no alarm.

It is unlikely that much could have been done to ward off the attack entirely, anyway. Many of the sailors were on leave to observe Mass and some were still asleep. The attack was a full on surprise.

By the end of the attack, Japan's 360 airplanes had destroyed five of the eight U.S. battleships, three destroyers, 200 aircraft, and seven ships, including the USS Arizona that took much of her crew to the watery grave with her.

In all, some 2,400 Americans were killed and another 1,200 injured. Survivors managed to down thirty of Japan's planes and five submarines. By a stroke of good luck, the three U.S. Pacific fleet carriers were off base that morning conducting training exercises. It would be these three carriers that would prove crucial in the United States victory against Japan at Midway.

For now, Roosevelt knew that the United States' entry into war was inevitable and no one feared this more than Japan's Emperor Hirohito, who warned from the start that provoking the United States into war would cost Japan its empire.



I remember when a kid from Haverhill High School became a Major League catcher for his hometown team the Boston Red Sox. He stated that, "Naturally, I wanted to play near home. So choosing (Boston) wasn't hard for me.'

Sadly, Mike Ryan, 78, passed away recently in Wolfeboro, New Hampshire.

He was 6 feet 2 inches and 205 pounds and had a long reach as a catcher. He could bare-hand the ball, too which

he did many times. His first game for the Sox was in October 1964, when Bob Tillman was having his best year offensively at the plate.

At different times with the home team, he roomed with either Jim Lonborg, then Tony Conigliaro. After the '67 season, he was traded to the Phillies where he played through 1973 before being traded to the Pirates.

He returned to Philly after retiring as their bullpen coach from 1980 to 1995, and was the team's only coach to make three trips to the World Series in 1980, '83, and '93.

EUGENE CRIQUIFrench WWI War Hero

Won World Title After Having Jaw Shattered by Sniper's Bullet



Eugene Criqui

Eugene Criqui was born in the Belleville neighborhood of Paris, France, on August 15, 1893. Belleville was a working-class village that was later used as the backdrop for a number of motion pictures including the Oscar winning short *The Red Balloon* in 1957.

Criqui worked as a pipe fitter before becoming a professional boxer in 1910 at the age of 17. From 1910 until 1914, he compiled a record of 68 fights with 45 wins, 9 losses, and 14 draws. Of his wins, 14 came via knockout.

In 1914, Eugene joined the French military and fought in WWI. While serving guard duty during the Battle of Verdun, he was shot by a German sniper. The bullet struck him in the face shattering his jaw. Criqui would spend two years in the hospital recovering from his wounds. During that time surgeons rebuilt his face using wires, plastic, and pieces of sheep's bone to repair the damage. Given this was in the early part of the 20th Century, it was amazing what the doctors were able to accomplish. After a long and painful recovery Criqui returned home.

His family and doctors were stunned when he told them he had decided to resume his boxing career. It seemed he must have gone a bit mad to be even considering returning to such a brutal profession after suffering such injuries. But return he did and what a second career he had.

In his first four years of boxing he had 68 fights, but scored just 14 knockouts. In his comeback after the war he had another 68 fights, but this time he scored 42 knockouts in 60 wins. Clearly he had changed his style. I have read that prewar Eugene had been a slick boxer who was content to go the distance. After the war his style turned much more aggressive and he developed a powerful right hand.


Why the change? Well, for one thing, he had grown from a flyweight to a featherweight. But I theorize he was greatly influenced by another great French champion who was also a war hero. If you watch films of Eugene Criqui in his fights after the war you can see his style is clearly patterned on that of Georges Carpentier. The way he holds his left and sets

up his opponents for his lethal right hand is right out of the Carpentier playbook.

Georges Carpentier was immensely popular in the United States after the war. He was handsome and a war hero. That fact was not lost on promoters when they matched him against Jack Dempsey who had been accused of evading the draft and sitting out the war. When the two met in 1921 they drew a gate of over a million dollars.

In 1923, promoter Tom O'Rourke brought Criqui to New York to fight Johnny Kilbane for the Word Featherweight Title. It could have been that O'Rourke saw some of the Carpentier magic in Criqui. The fight took place at the Polo Grounds. It would be the first time Eugene would fight in the United States, but as with Carpentier, he had a reputation as a war hero and was also known for his exciting knockout power. Because of this the fight generated excitement, though Kilbane was installed as the betting favorite.

Criqui exceeded expectations when he kayoed the champion in the 6th round with a solid right hand. Now the champion, Eugene was under contractual obligation to defend the title within 60 days against Johnny Dundee.

Dundee and Criqui met on July 26, 1923, just 54 days after the Kilbane fight. Dundee dropped Eugene four times on his way to winning a fifteen round decision and the title. This would be one of the

shortest reigns of any word champion.


It would be Eugene's last fight in the United States. He would fight just six more bouts. Losing four including one to Panama Al Brown in Paris. He retired in 1928 having complied a career record of 136 bouts with 105 wins, 16 losses, and 15 draws. 59 of his wins came via knockout.

It has been said he quit boxing because of injuries to his hands. His jaw certainly held up well as he was only stopped on five occasions.

Eugene went on to have a career as a boxing referee in France. He was the second French boxer to win a world championship, Carpentier being the first. It is unclear why he didn't fight more often in the United States or why he never got another title shot. It very well may have been because he had proven himself by coming back from his wounds and attaining the title.

Criqui was a courageous soldier and a fearless boxer who overcame a lot to become world champion. On July 7, 1977, he passed away in a nursing home in Noisy-le-Grand, France. He was 83 years old.

Not a lot has been written about this very interesting champion. In 2017 a biography of Criqui was published in France but has not been translated into English. The title of the book is *Gueule De Fer* which translated means Iron Mouth. It would be interesting to know more about his life. Just the little we do know is quite inspirational.

HOOPS and HOCKEY in the HUB

As the Boston Bruins and the additional 23 National Hockey League teams prepare to convene on the two designated sites that will lead to the resumption of play, we thought it might be interesting to take a look at how things have fared over the years for cities and franchises based in Canada.

The Bruins and 11 other Eastern Conference teams will proceed to Toronto while the 12 Western Conference franchises will gather in Edmonton later this month. The NHL powers that be have decided that seven teams in the 31-team league won't be participating when action resumes.

One of the more interesting facets of the resumption of play plan that will eventually culminate in the crowning of a Stanley Cup champion is that all of the games will take place north of the border. No games will be played in the United States.

Although the format of the tournament has been known for quite some time, the exact location of the two venues was only officially declared in the second week of July. We think that the NHL executives felt that it might be best to avoid the U.S. given that the virus was on the uptick throughout much of America after coming on strong throughout the spring in a number of cities in the Northeast.

In addition, we feel that the federal government of Canada might, how shall we phrase it, be more appreciative of the Stanley Cup playoffs being hosted in the major cities of two Canadian provinces than say lawmakers based in Washington or in various large communities throughout the U.S.

So, it is over the border that the players and coaches go for hockey in July, August, September and October. About the time that Tom Brady is throwing footballs in his fifth game or so as a member of the Tampa Bay Buccaneers is when the Cup should be hoisted by the eventual 2020 Stanley Cup champion.

One big disappointment for those intending to head to Toronto is the cancellation of the Canadian National Exposition — a nationwide fair that draws one million people to the city every year. Normally held between late August and Labor Day, the cancellation is the first since the World War II era.

But the scheduling of the Stanley Cup Playoffs may make up for it — even if fans are not allowed to attend. Canadian pride should come to the fore.

People may not realize it but there has been a dearth of participation on the part of the Canadian franchises late in the playoffs for quite some time.

Indeed, no team from Canada has captured the Stanley Cup Championship since 1993 and only four teams from that nation have made the Stanley Cup Final in the 21st century. Go through the records of the respective Conference Finals

and one finds there has never been an Eastern Conference Finals matchup featuring two teams from Canada. In the West there has been only one — in 1994 when Vancouver eliminated Toronto in five games to advance to the Stanley Cup Final. The Canucks then lost to the New York Rangers in seven games.

Which brings us to an interesting reality, no matter who advances in the Stanley Cup Playoffs, both the Eastern Conference Finals and the Western Conference Finals plus the Stanley Cup Final will all be played entirely in Canada. In fact, every single game of the entire tournament will be played there.

The last time the Stanley Cup Final was played entirely in Canada was way back in 1989 when the Calgary Flames, coached by Terry Crisp, defeated the Montreal Canadiens, coached by Pat Burns, in six games. The Flames, in a way, were getting even since Montreal had defeated Calgary for the 1986 title in a five-game series.

Prior to those two instances, one has to go back to the 1967 Final, the last one of the Original Six era, to find an SCF that was played entirely north of the border. Toronto turned out the lights on one of the most fascinating periods in athletics by defeating Montreal in six games.

That reality has been somewhat masked, of course, by the significant number of Canadian players who do make it to the SCF every year as members of U.S. base franchises. But when one considers the hold and heritage of hockey in Canada, we feel that the nation is very proud that the entire big show will be hosted there.

Few may realize it but the Stanley Cup was really not the original name for the trophy. It was first called the Dominion Hockey Challenge Cup — a title that harkened back to its early days as an award that went to the winning team in an amateur tournament.

Lord Frederick Arthur Stanley of Preston, the Governor General of Canada, donated the funds for the trophy in the early 1890s. Over time, by agreement, it became emblematic of the best team in professional hockey. The tradition of each member of the winning team getting his day with the Cup started much later -- in 1995.

It is an activity that has taken on a life of its own and enabled the National Hockey League to remain in the news every summer as the Cup travels to various communities, both large and small, generating media coverage along the way. For dedicated hockey fans, there is always another Stanley Cup story every day as the journey continues.
